DESCRIPTION

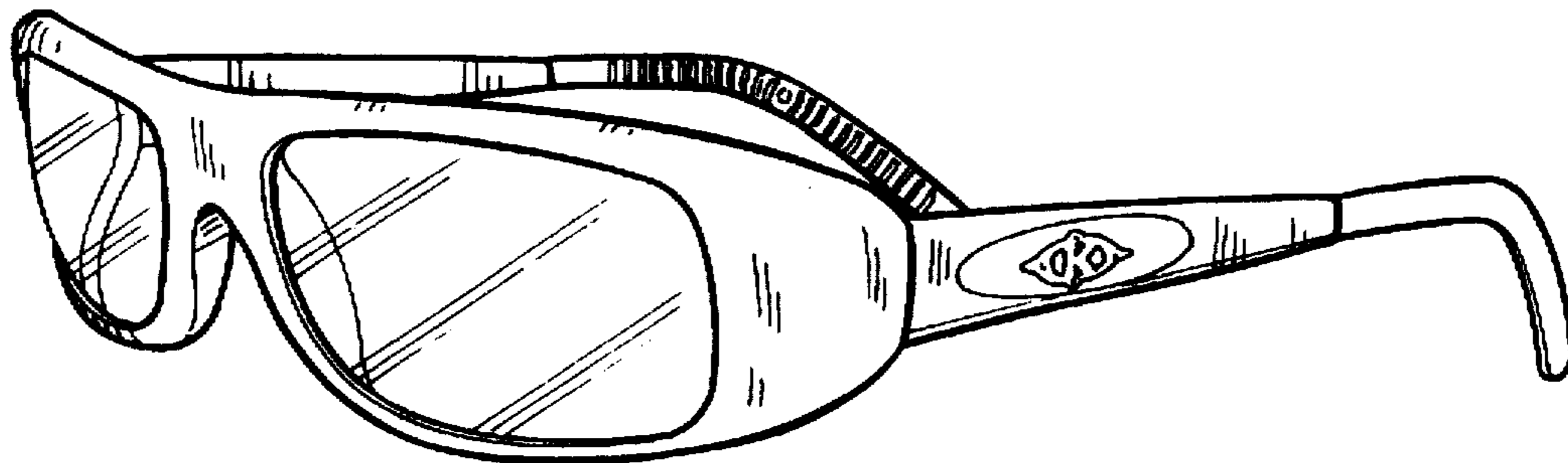
FIG. 1 is a perspective view of the sunglasses showing my new design;

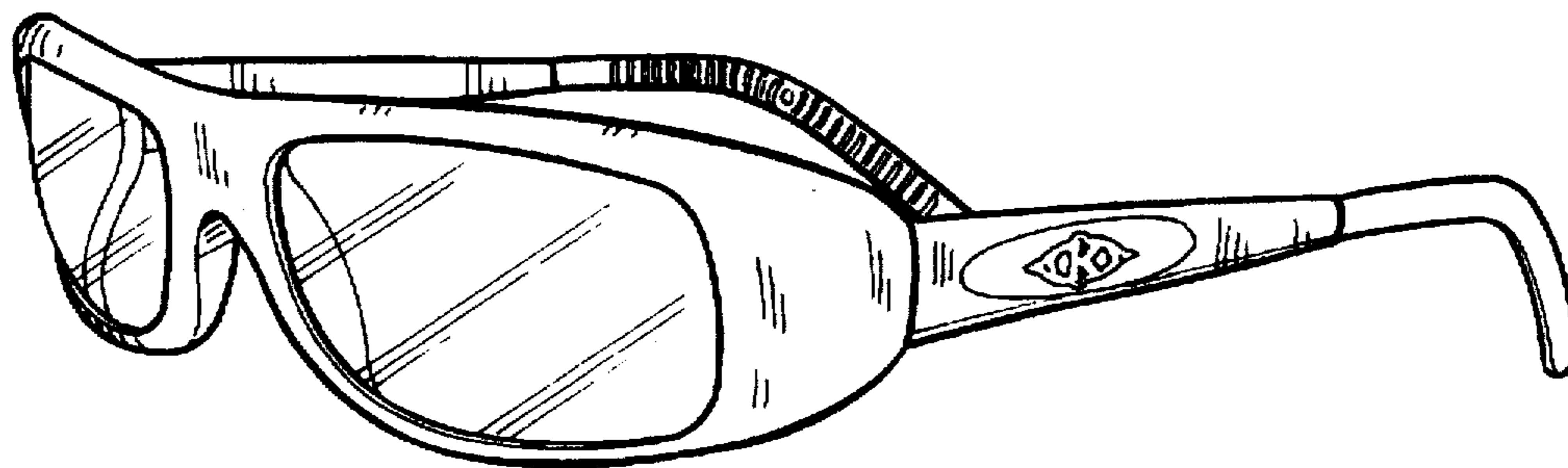

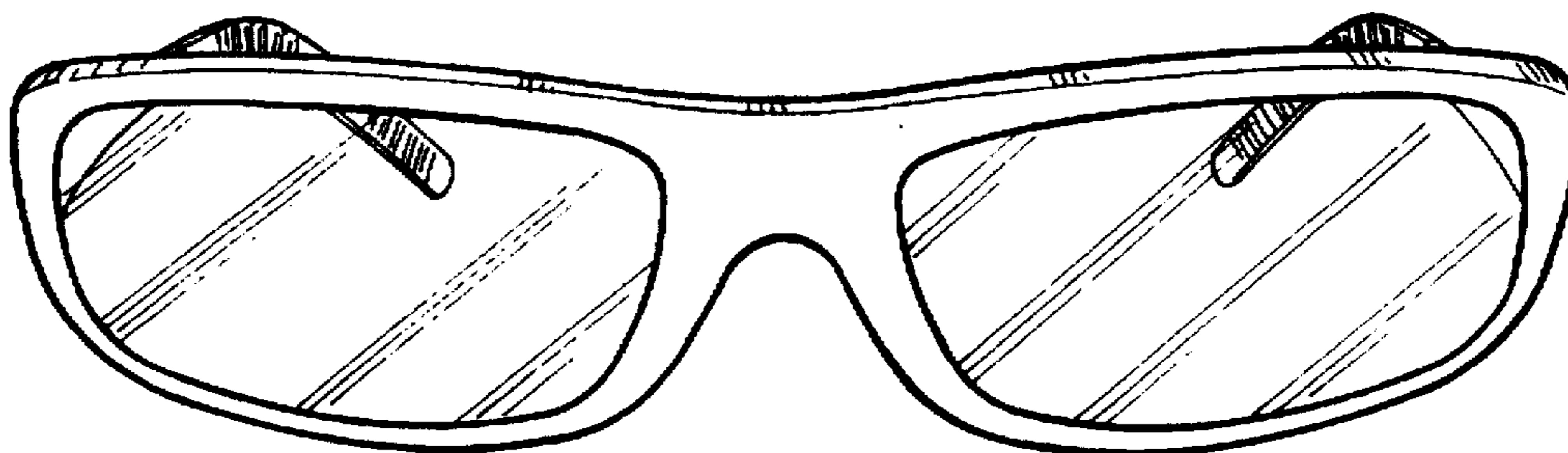

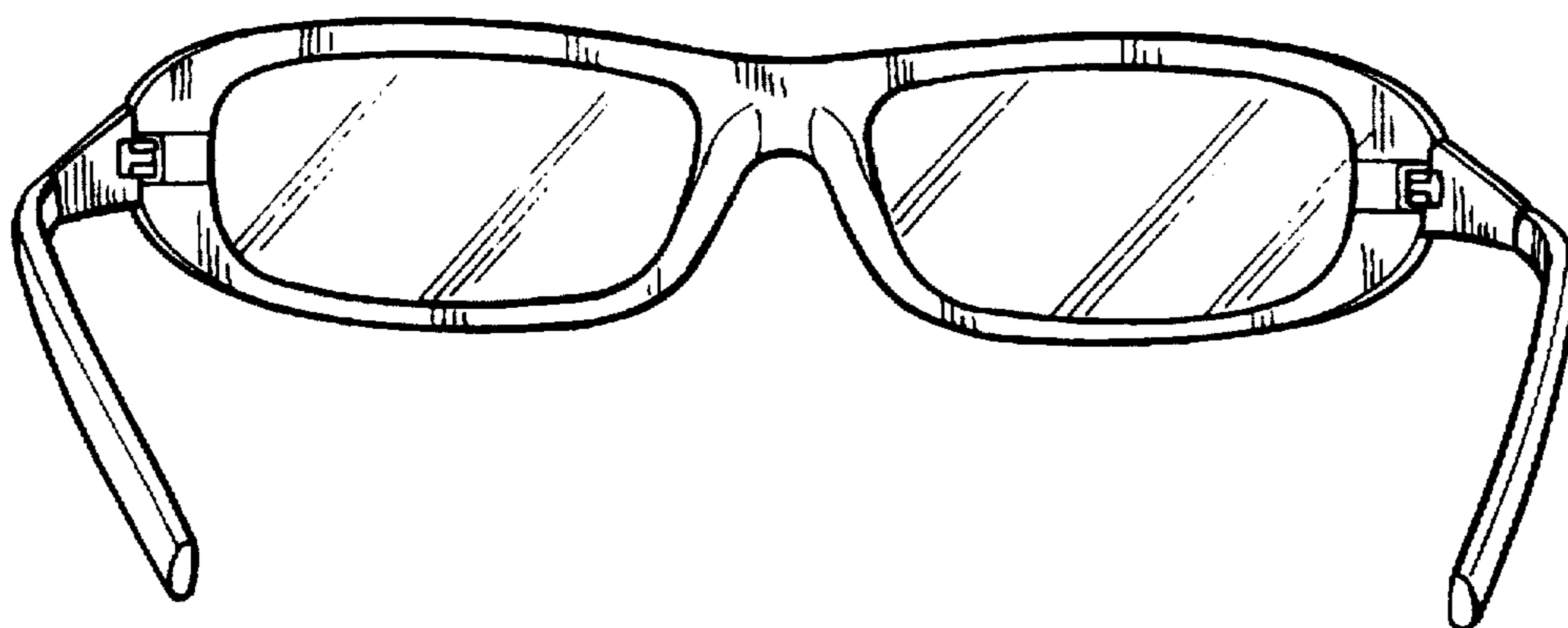

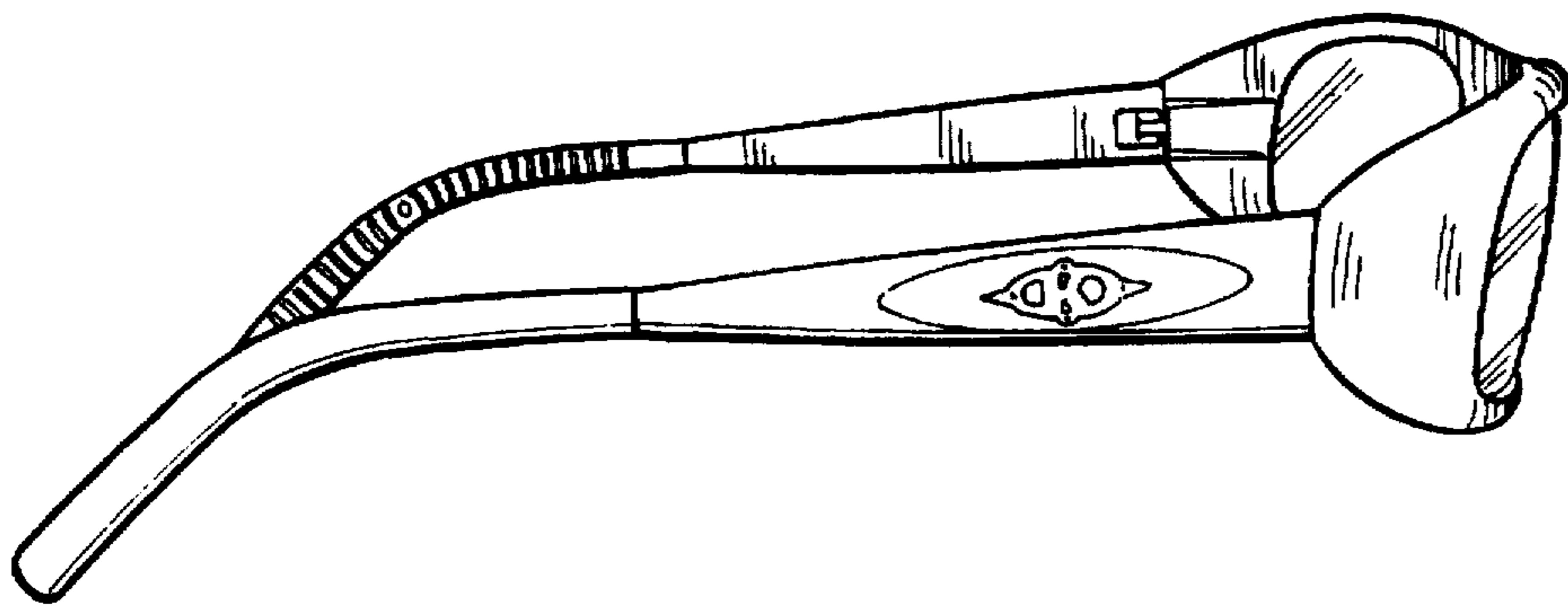

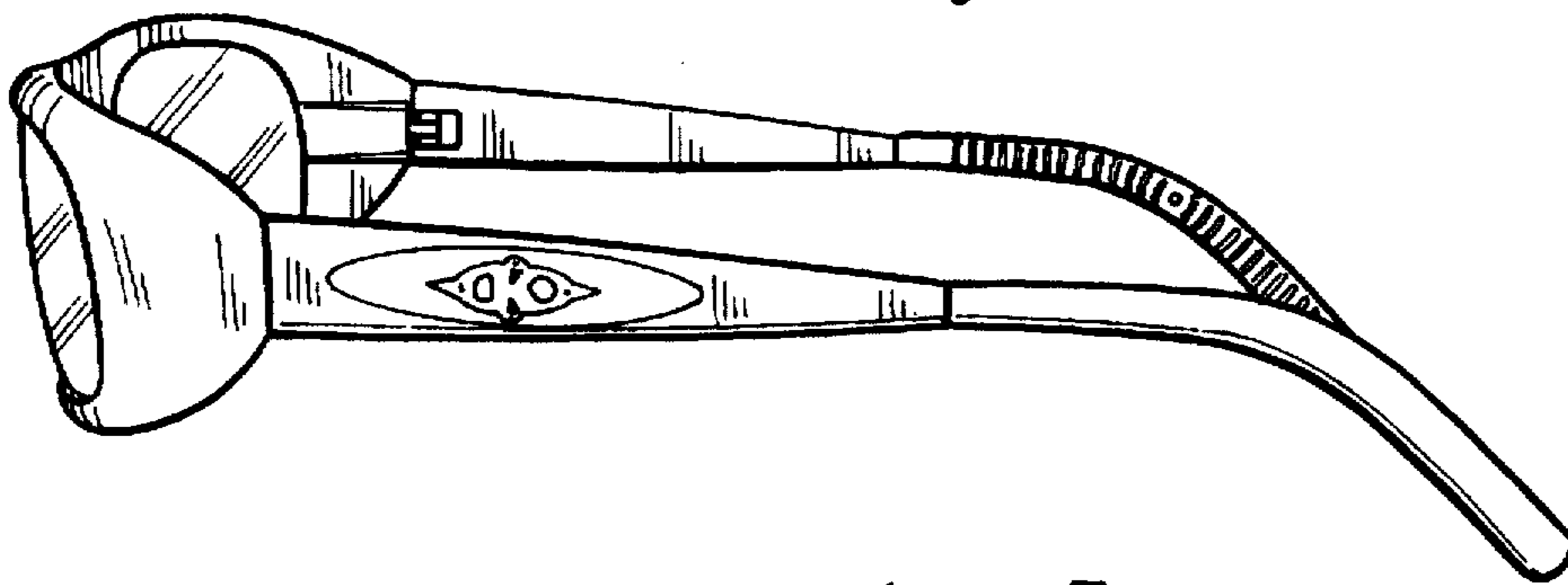

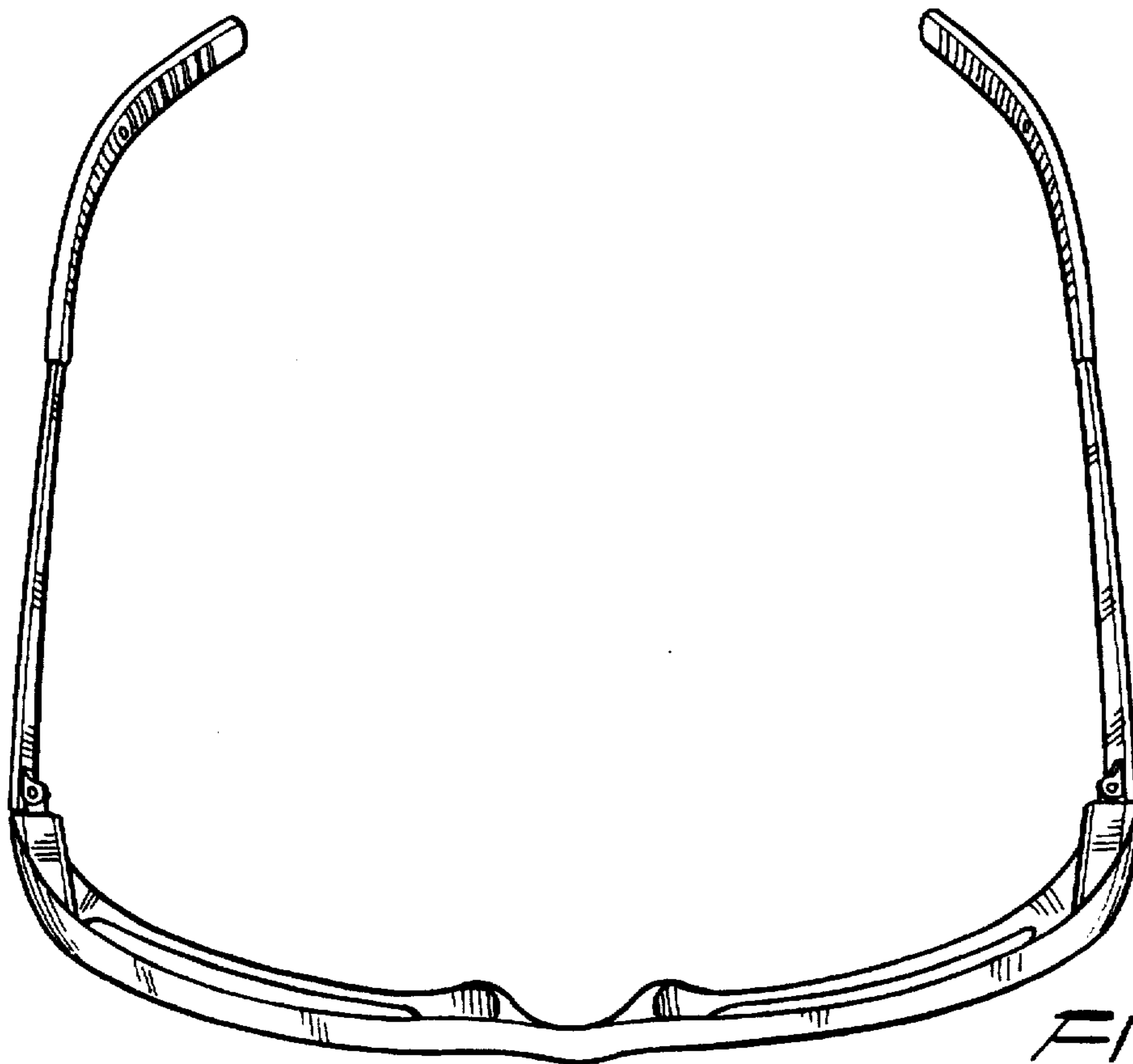

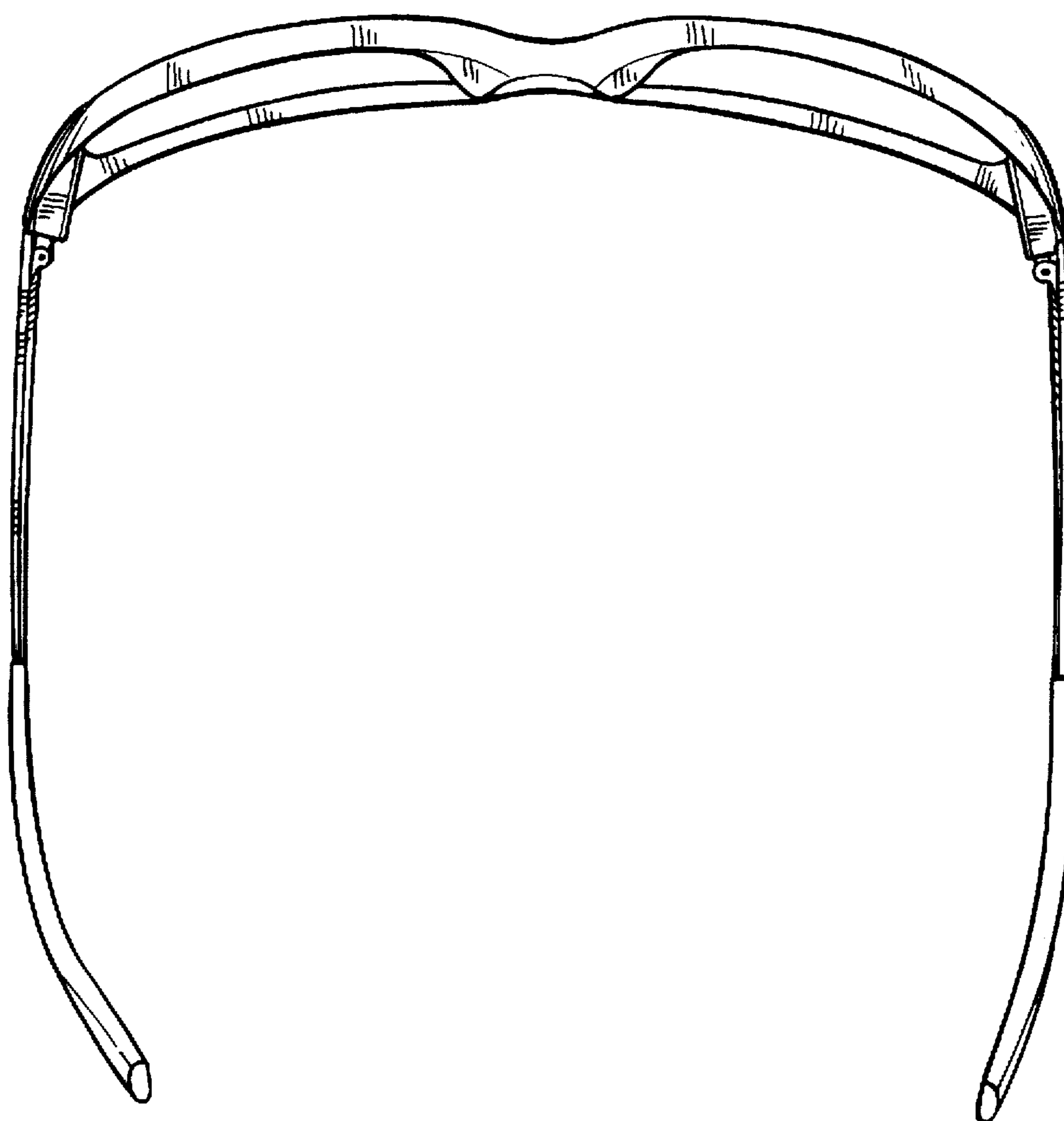
