[57] **CLAIM**

The ornamental design for a game controller cover, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a game controller cover showing my new design;

FIG. 2 is front perspective view thereof with game controllers and flaps shown in an alternate position;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a rear elevational view thereof;

FIG. 5 is a right side elevational view thereof the left side elevational being a mirror image thereof;

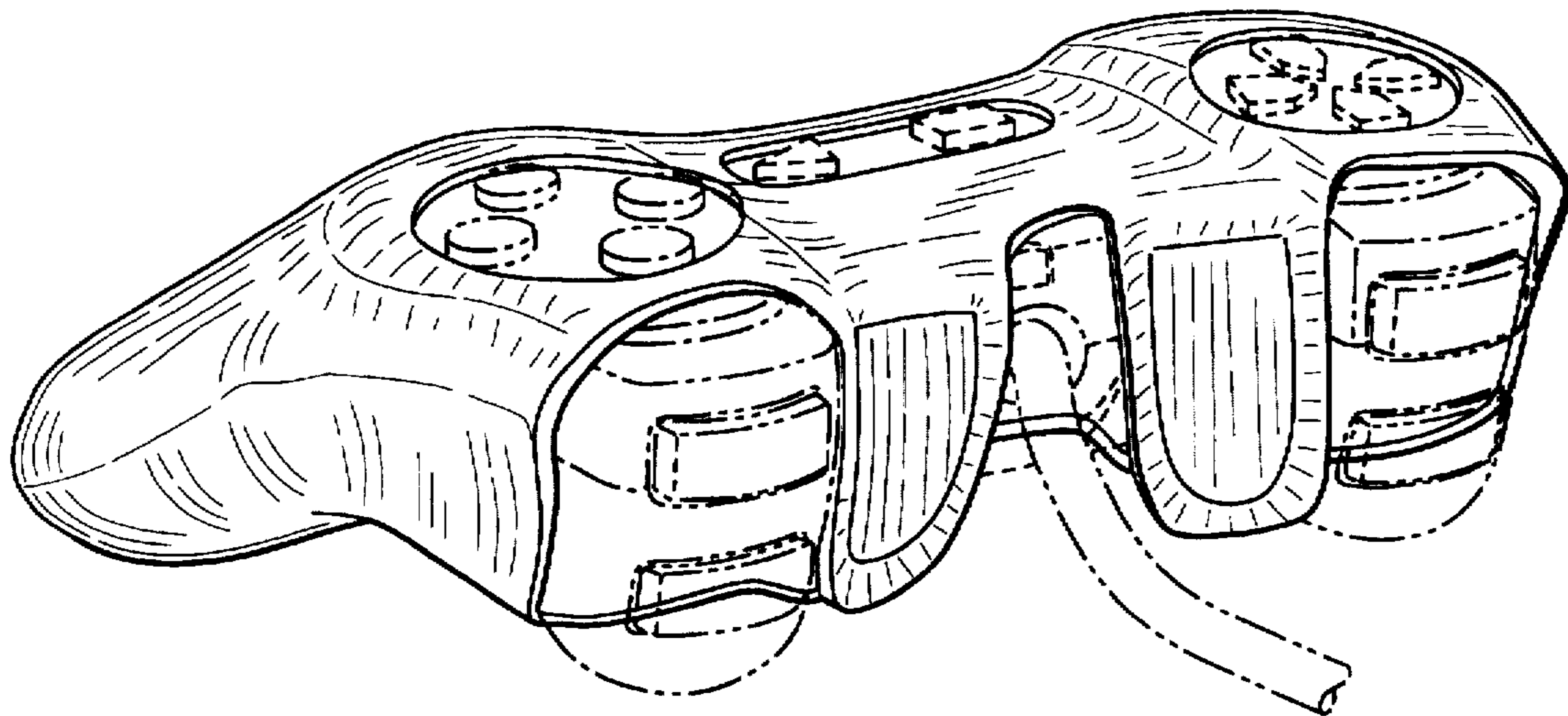
FIG. 6 is a bottom plan view thereof;

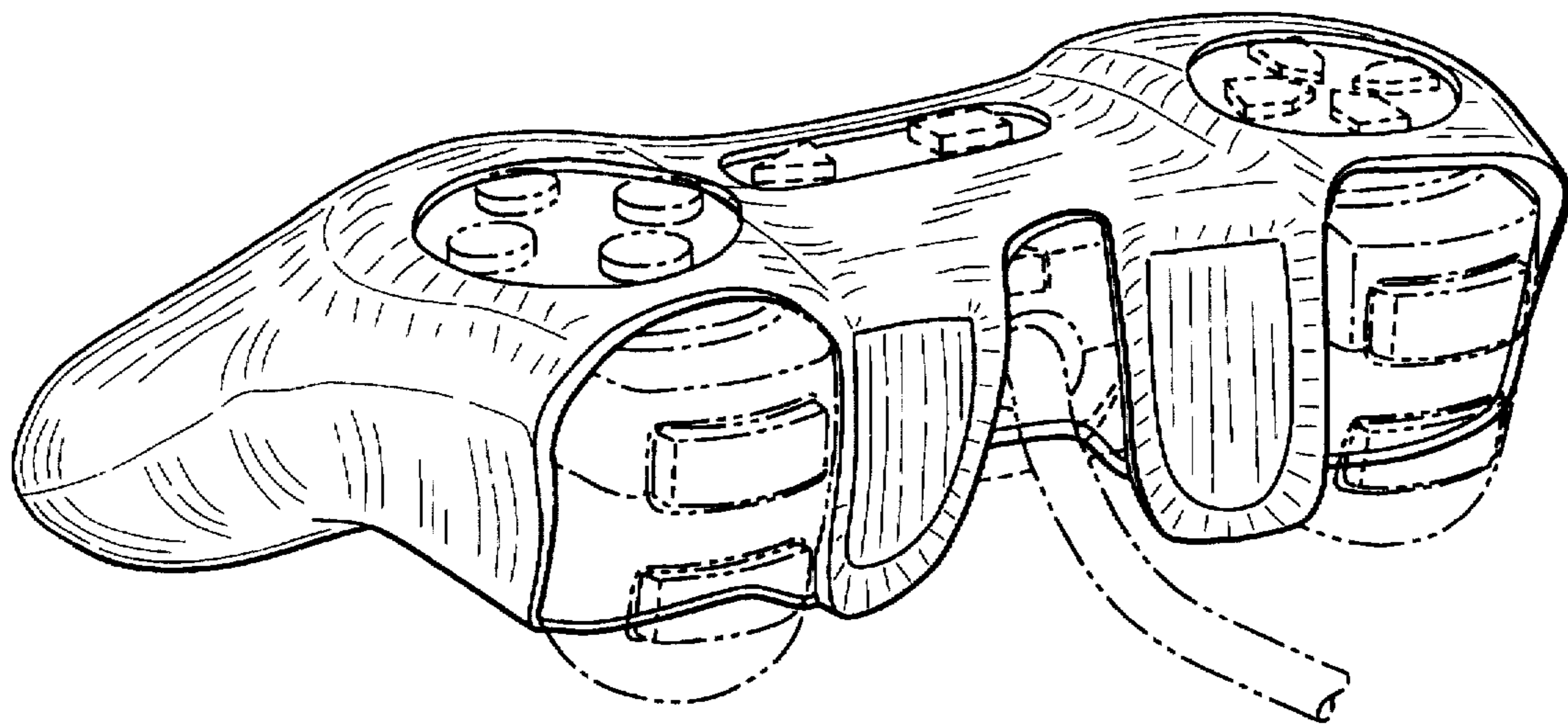
FIG. 7 is a top plan view thereof; and,

FIG. 8 is a second embodiment of FIG. 1.

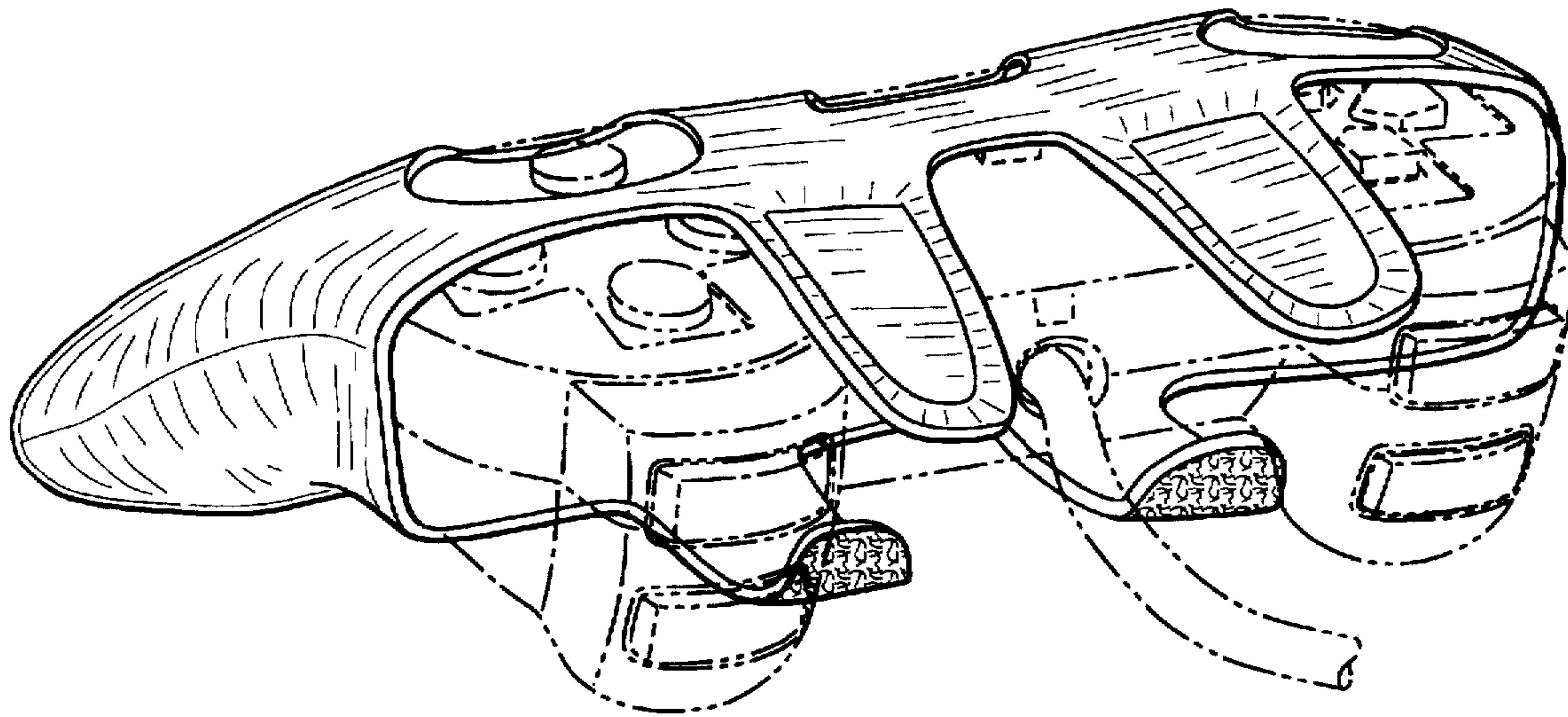

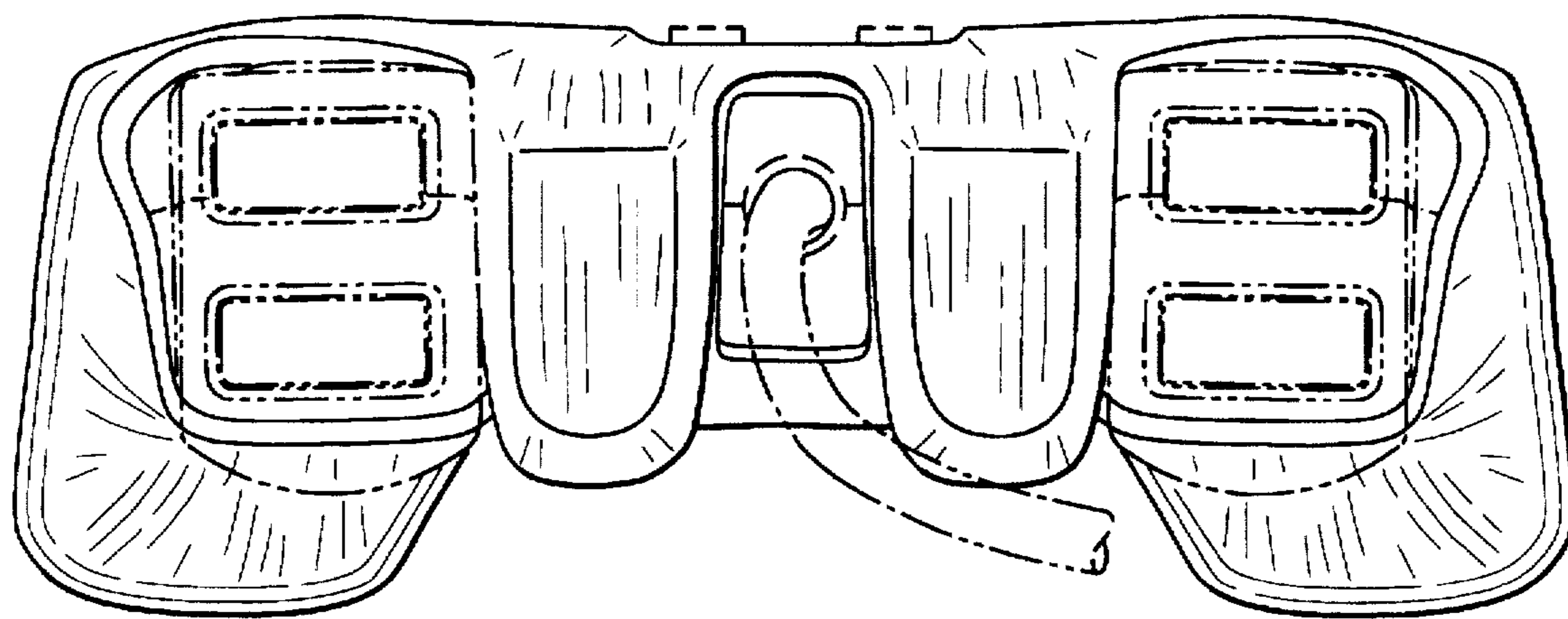




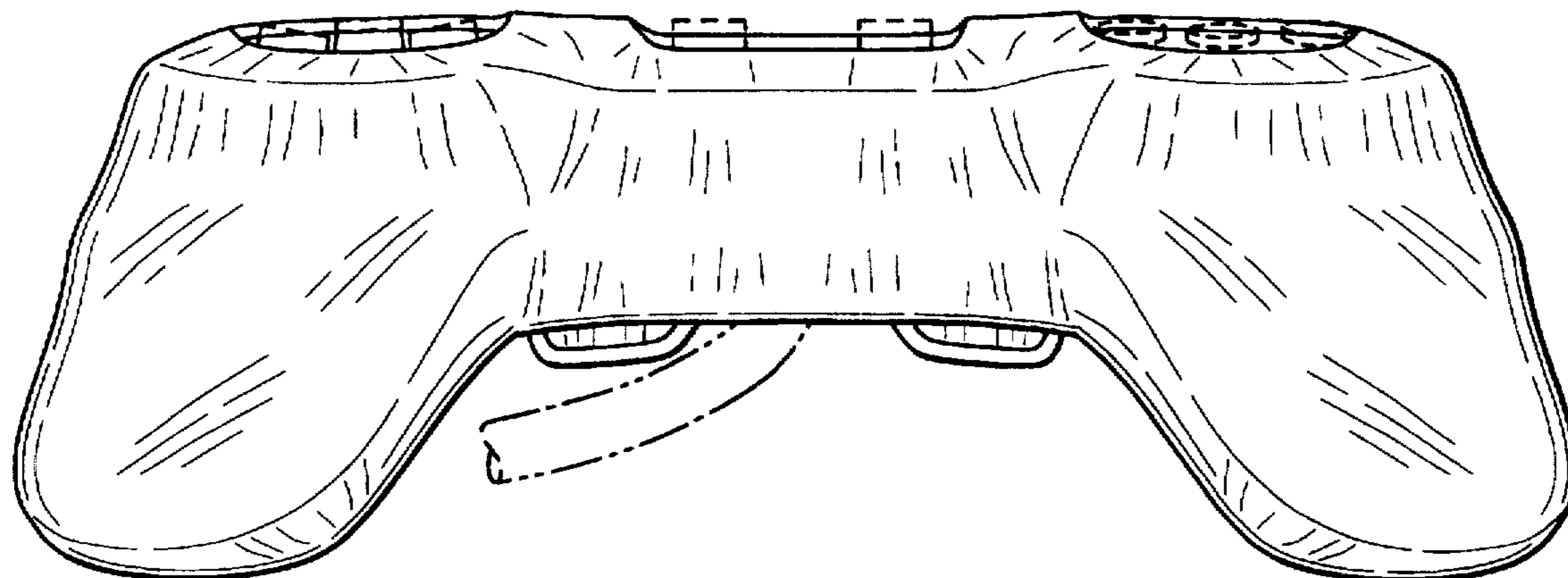

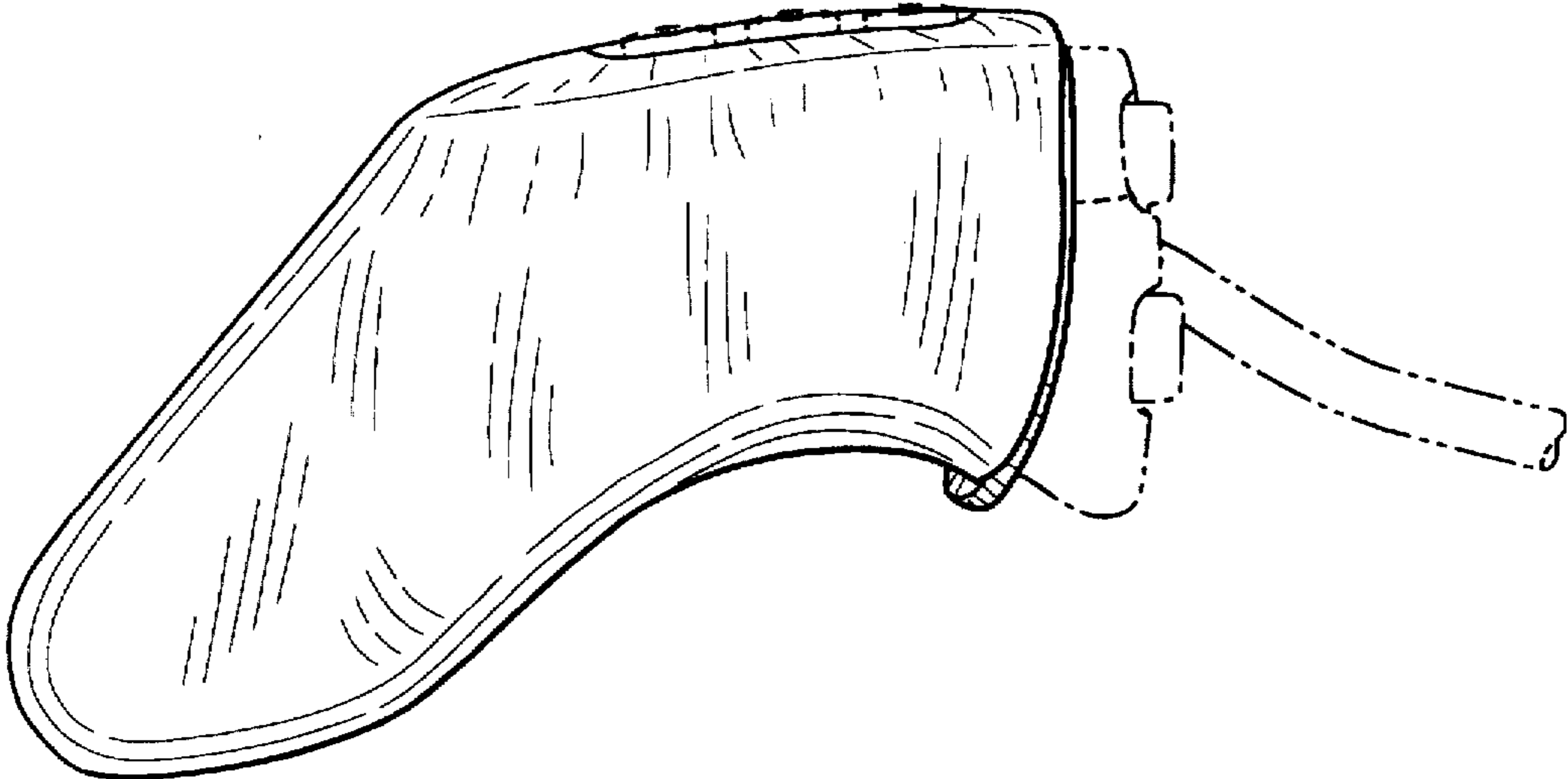

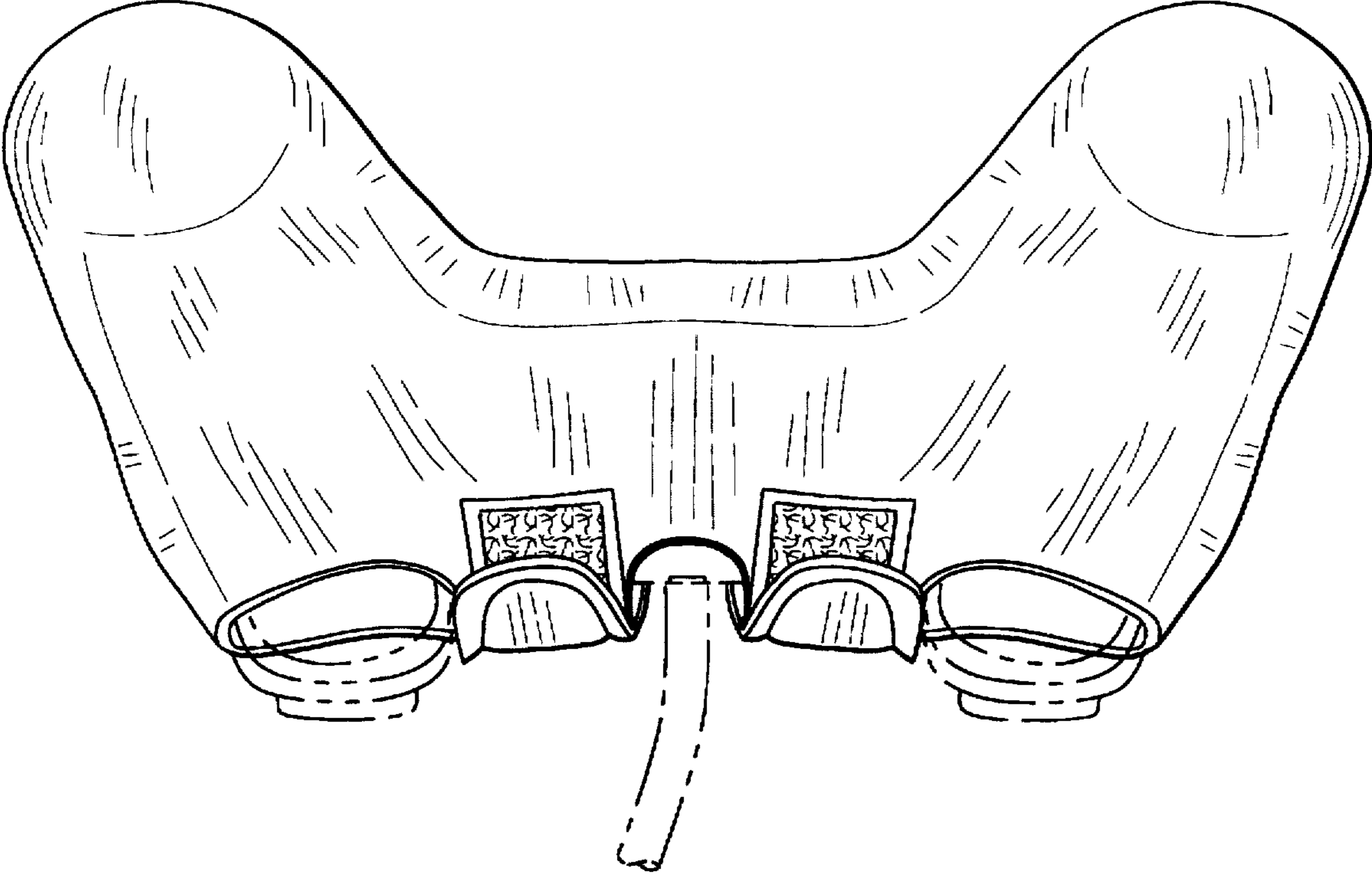

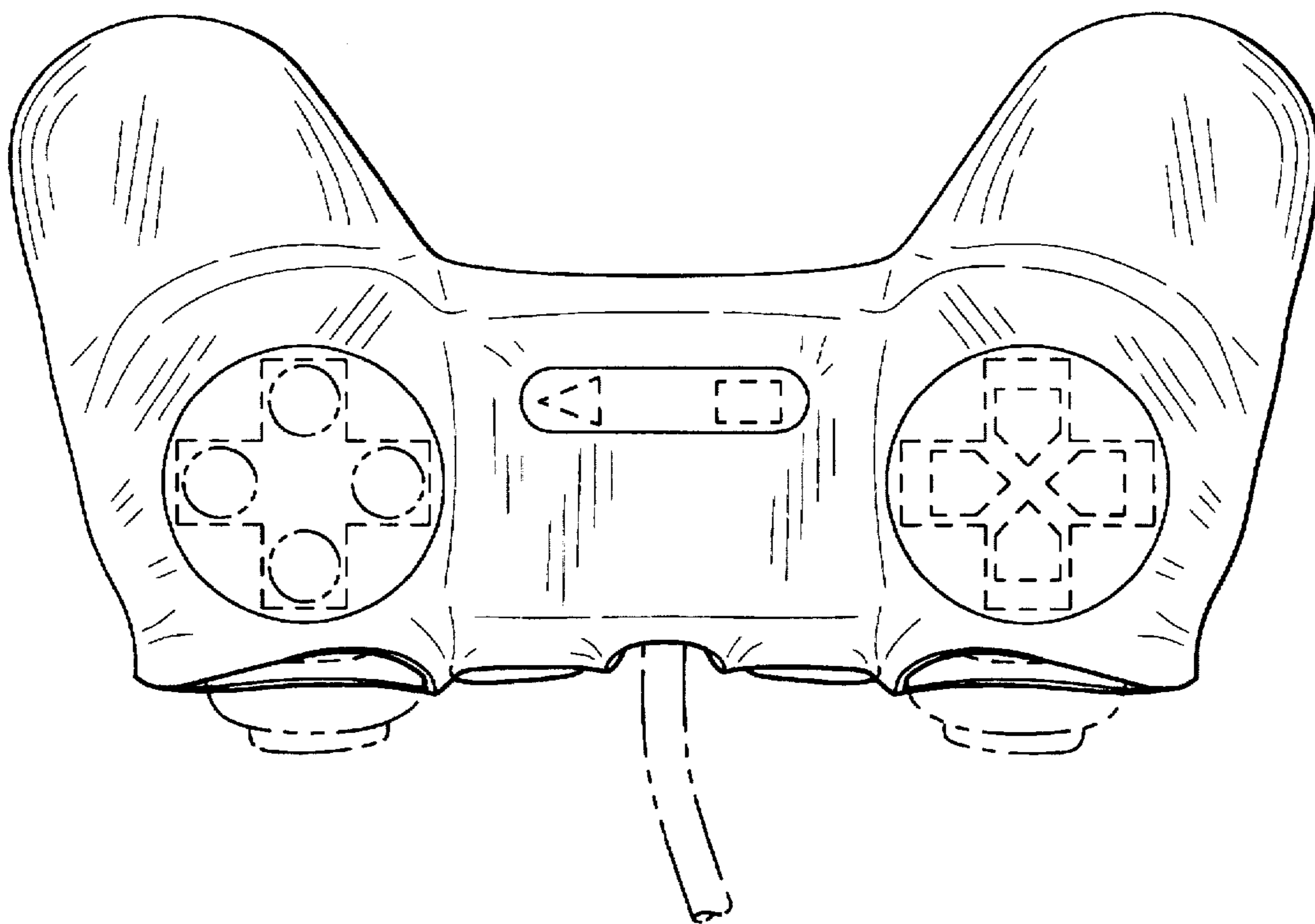

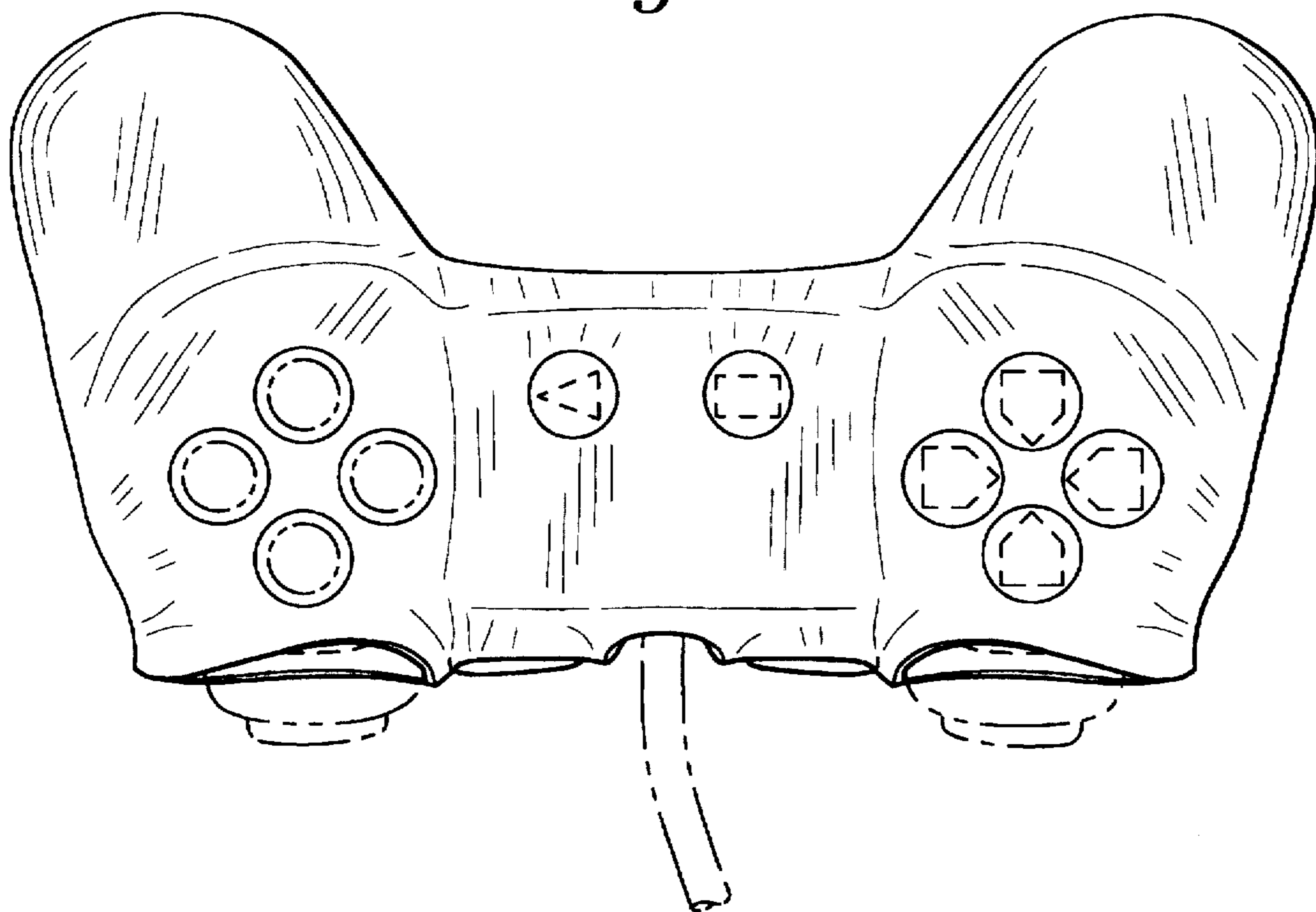
