FIG. 1 is a bottom plan view of a shoe sole showing our new design;

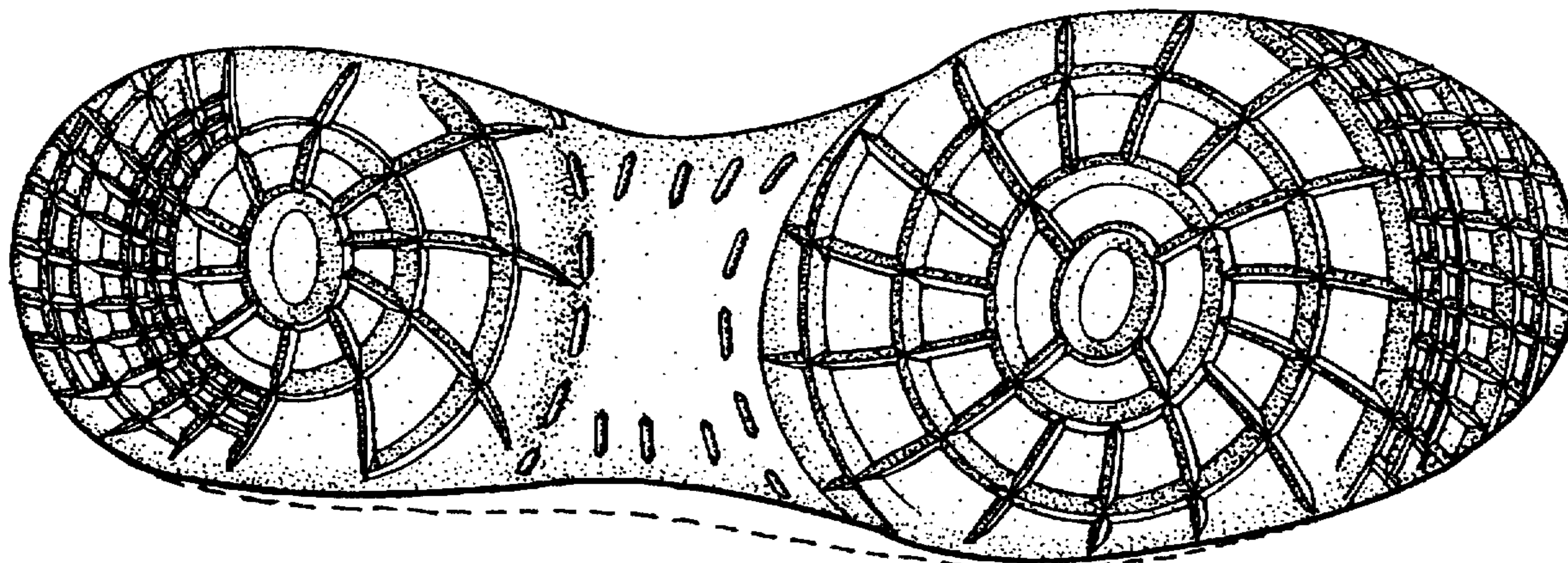
FIG. 2 is a left side elevational view thereof;

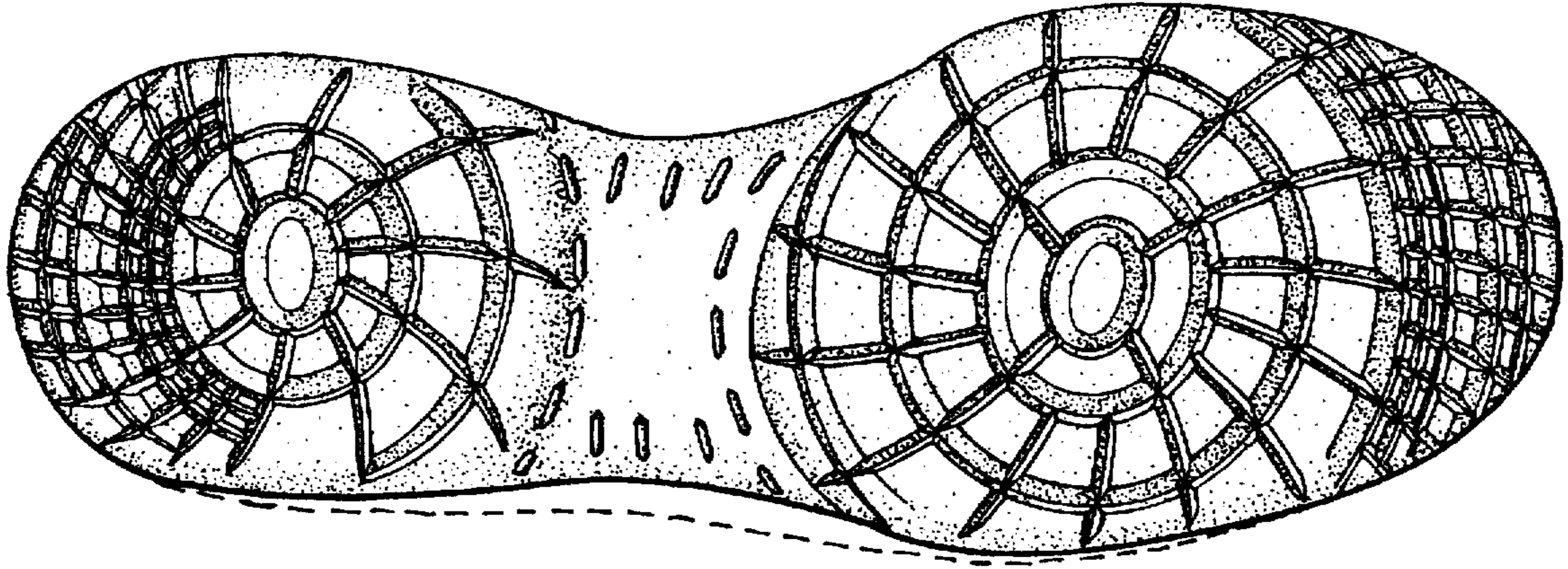

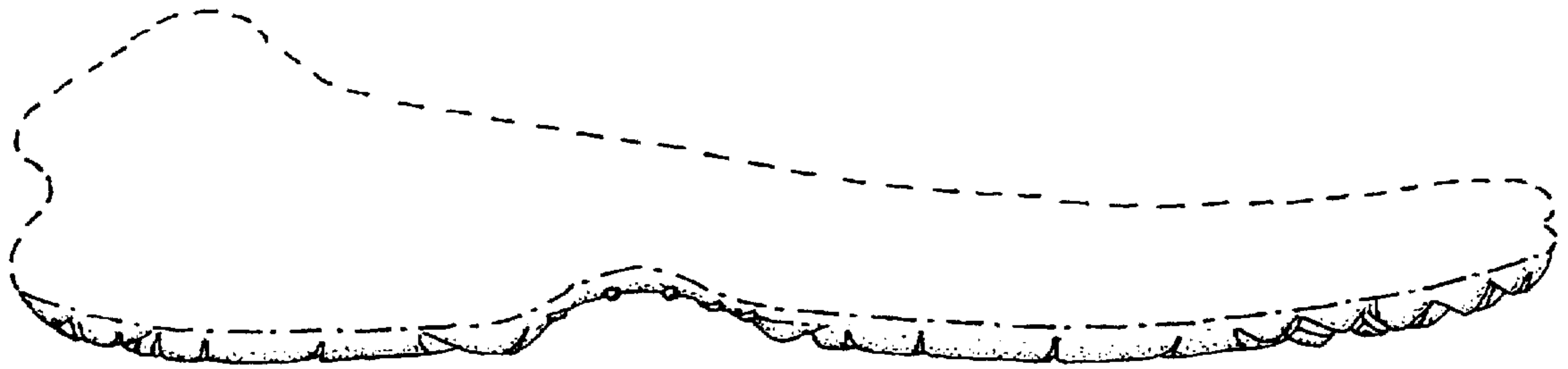

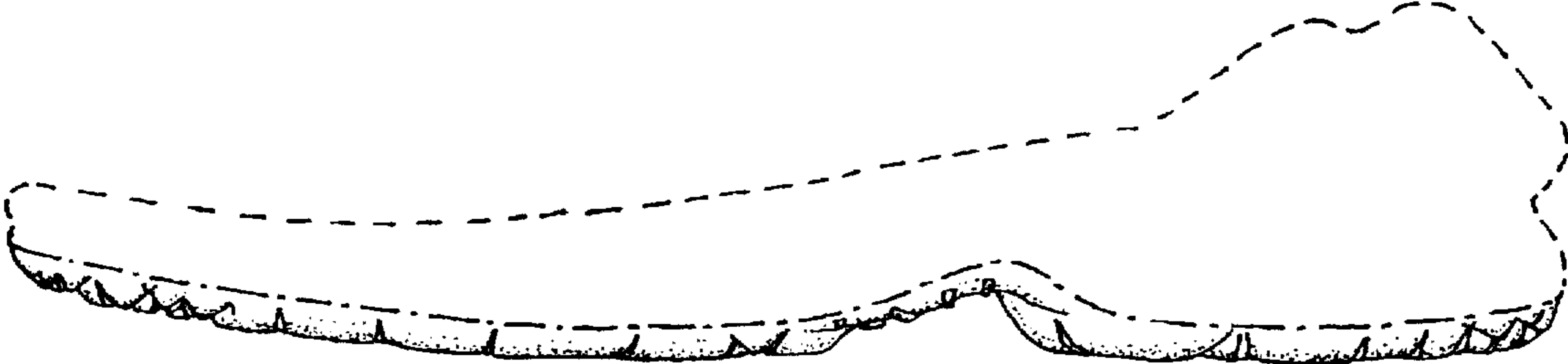

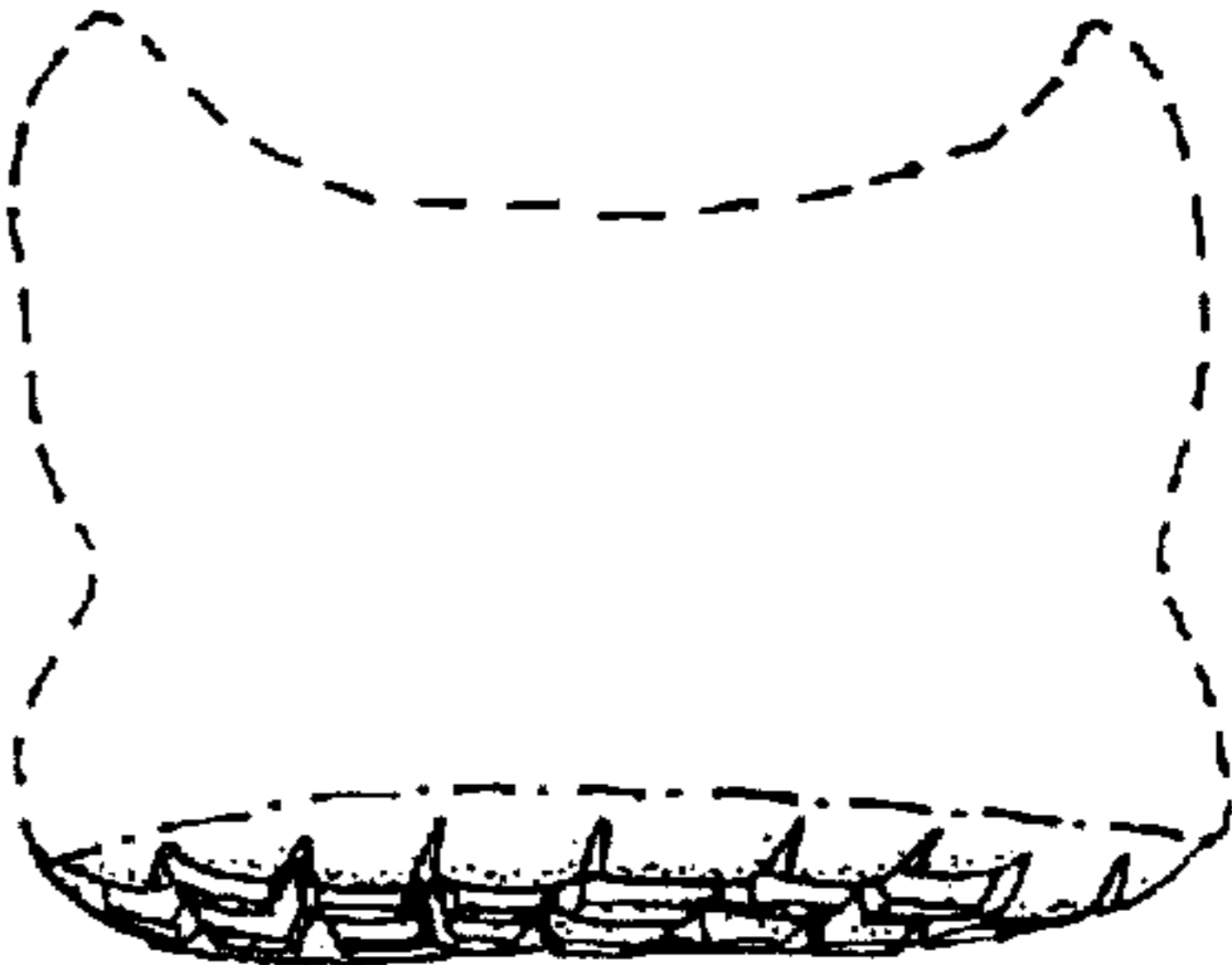
