[57] **CLAIM**

The ornamental design for a chair, as shown and described.

DESCRIPTION

FIG. 1 is a top view of my new chair in its basic design, without arm rests;

FIG. 2 is a front view of my new chair;

FIG. 3 is a view from one side, the opposite side being symmetrical;

FIG. 4 is a bottom view of my new chair;

FIG. 5 is a rear view of my new chair;

FIG. 6 is a perspective view of my new chair;

FIG. 7 is a top view of my new chair in an embodiment with arm rests connecting the rear legs and the sides of the seat; FIG. 8 is a front view of my new chair in the embodiment shown in FIG. 7;

FIG. 9 is a view from one side, the opposite side being symmetrical;

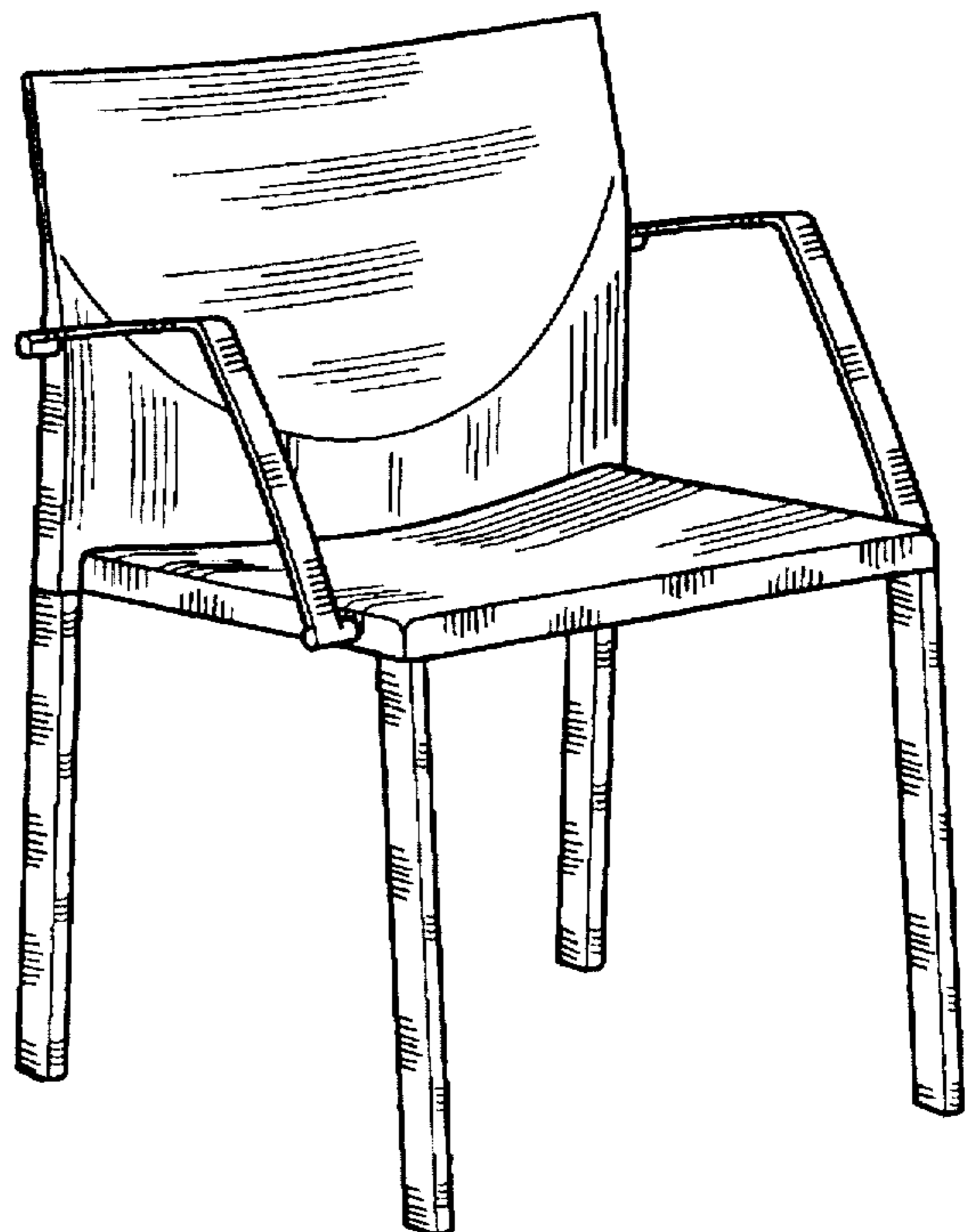
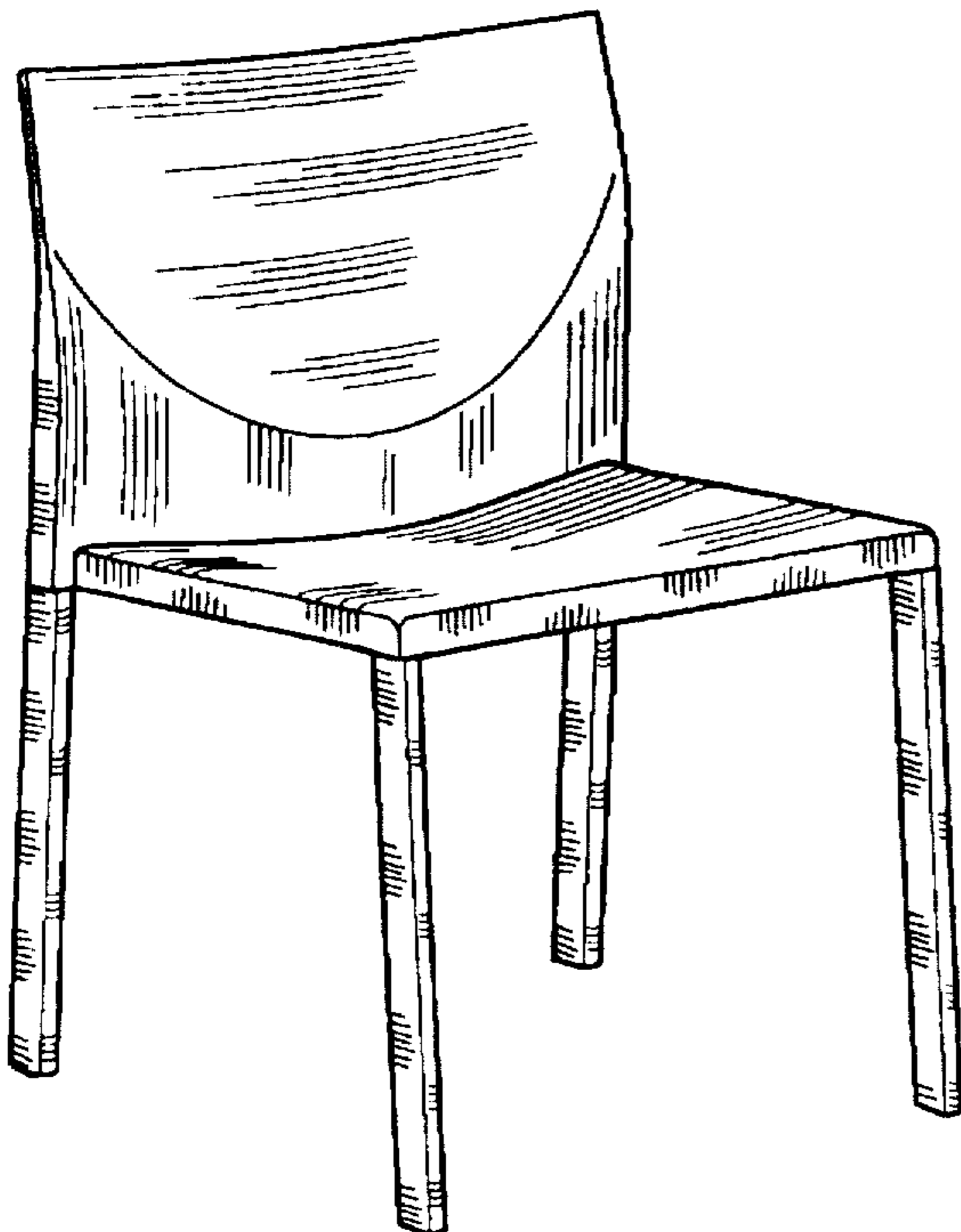
FIG. 10 is a bottom view;

FIG. 12 is a perspective view.

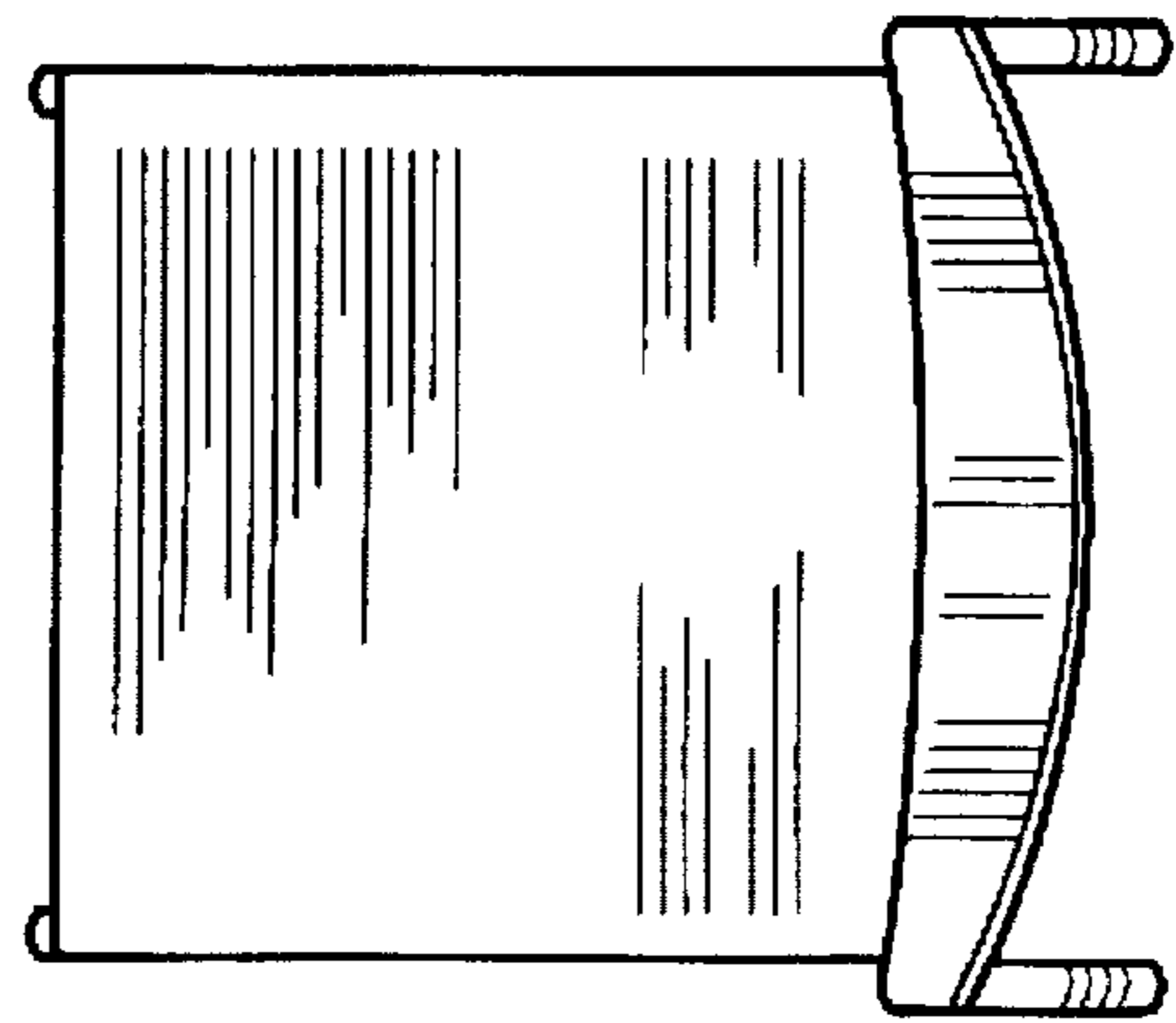

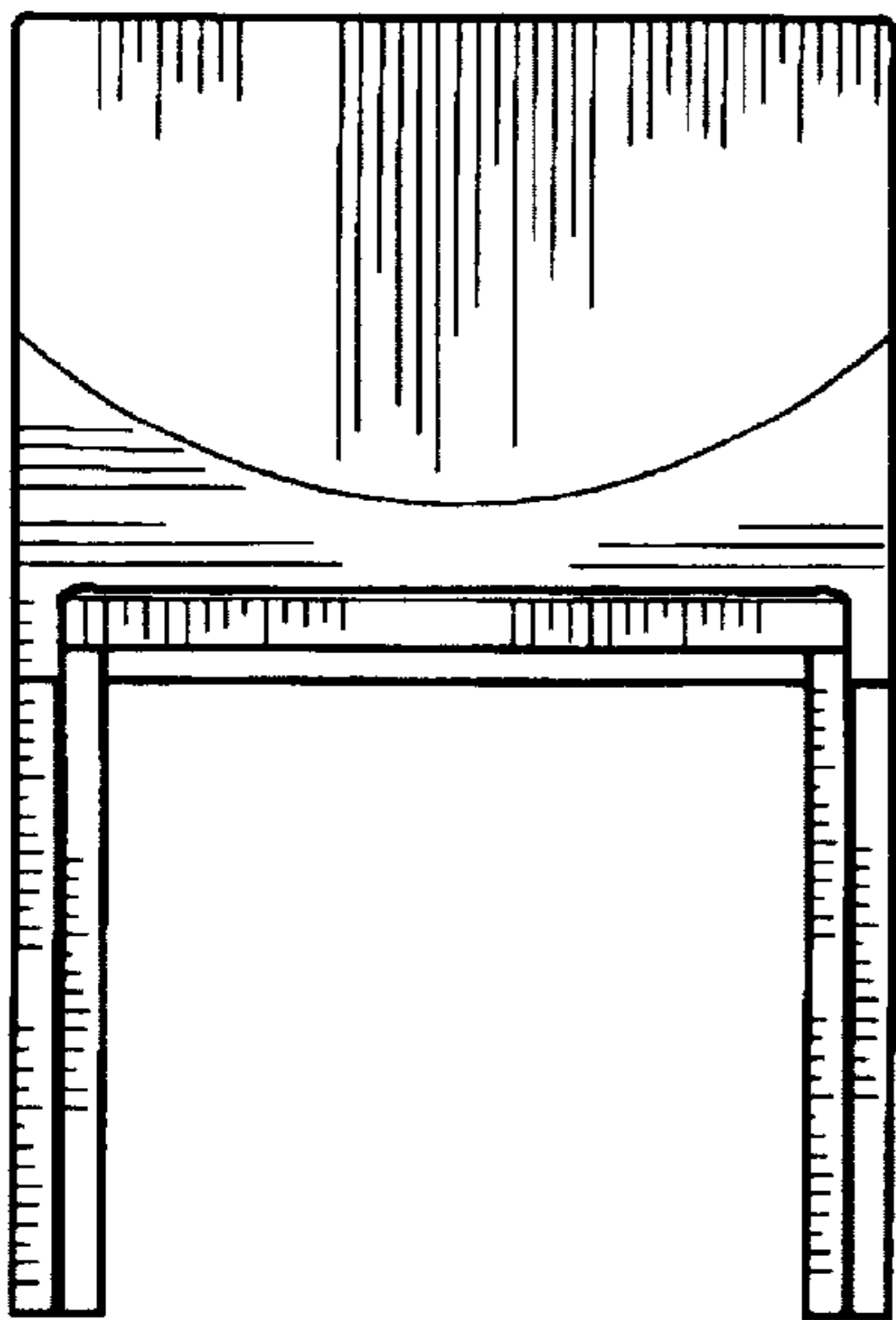

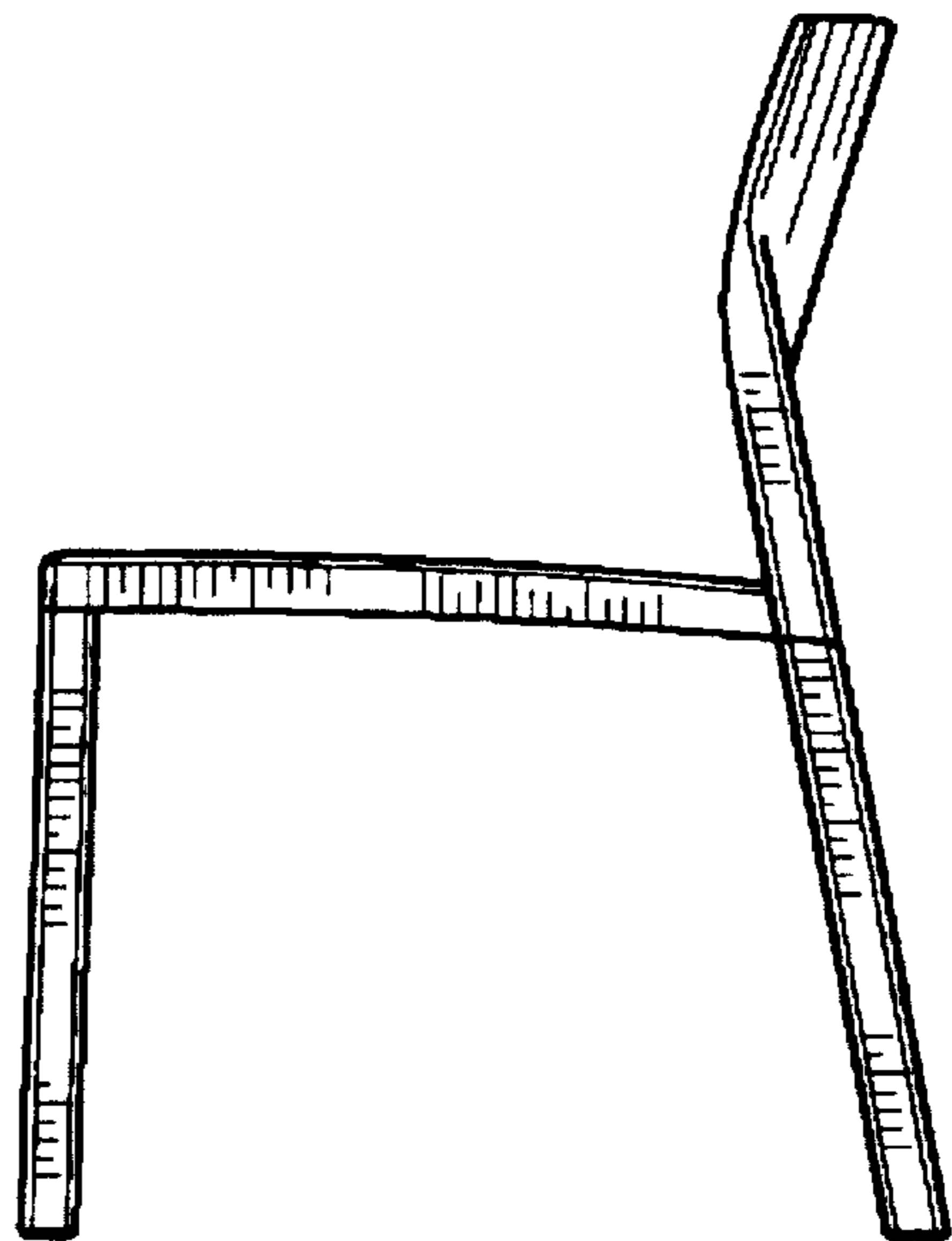

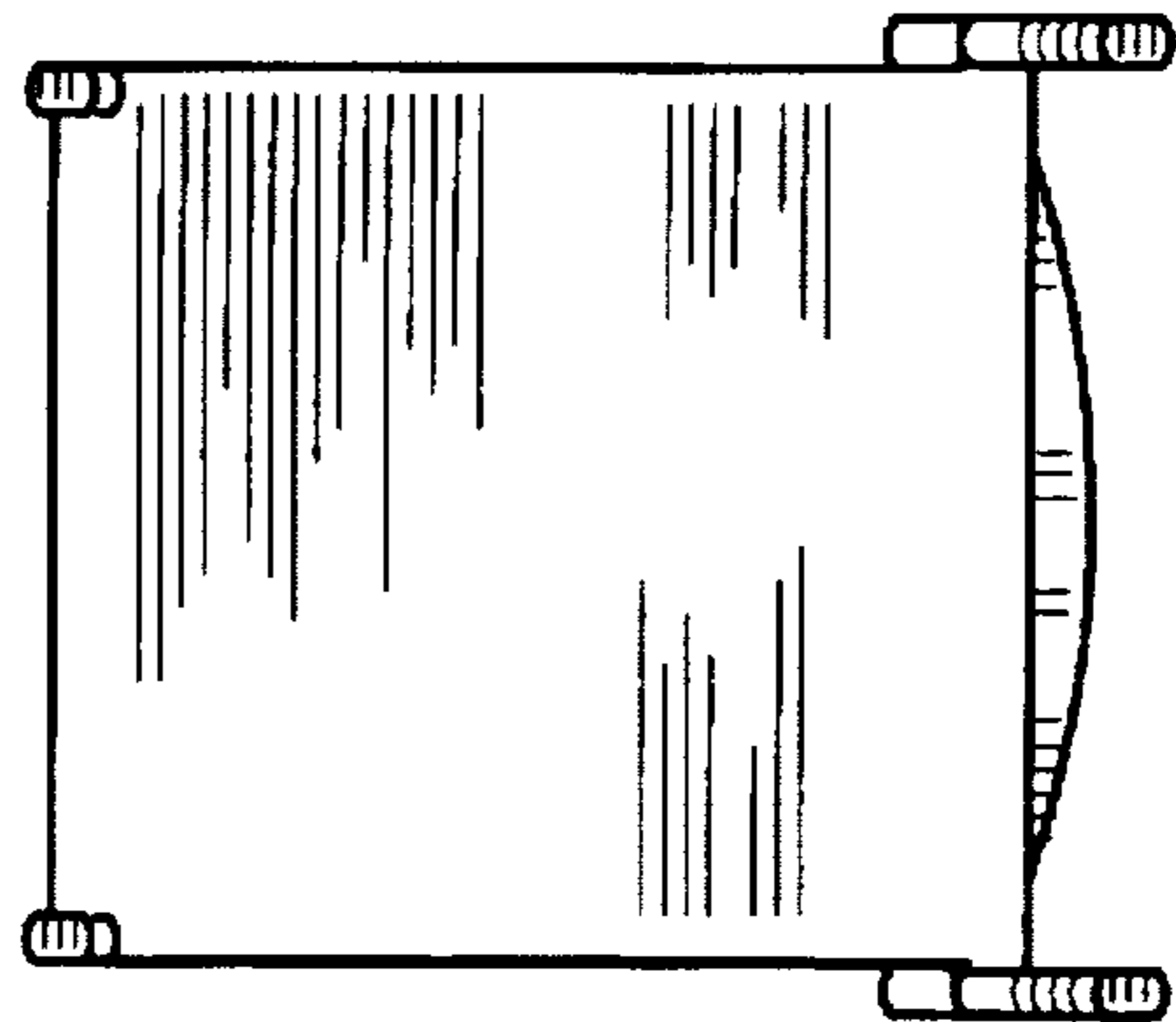

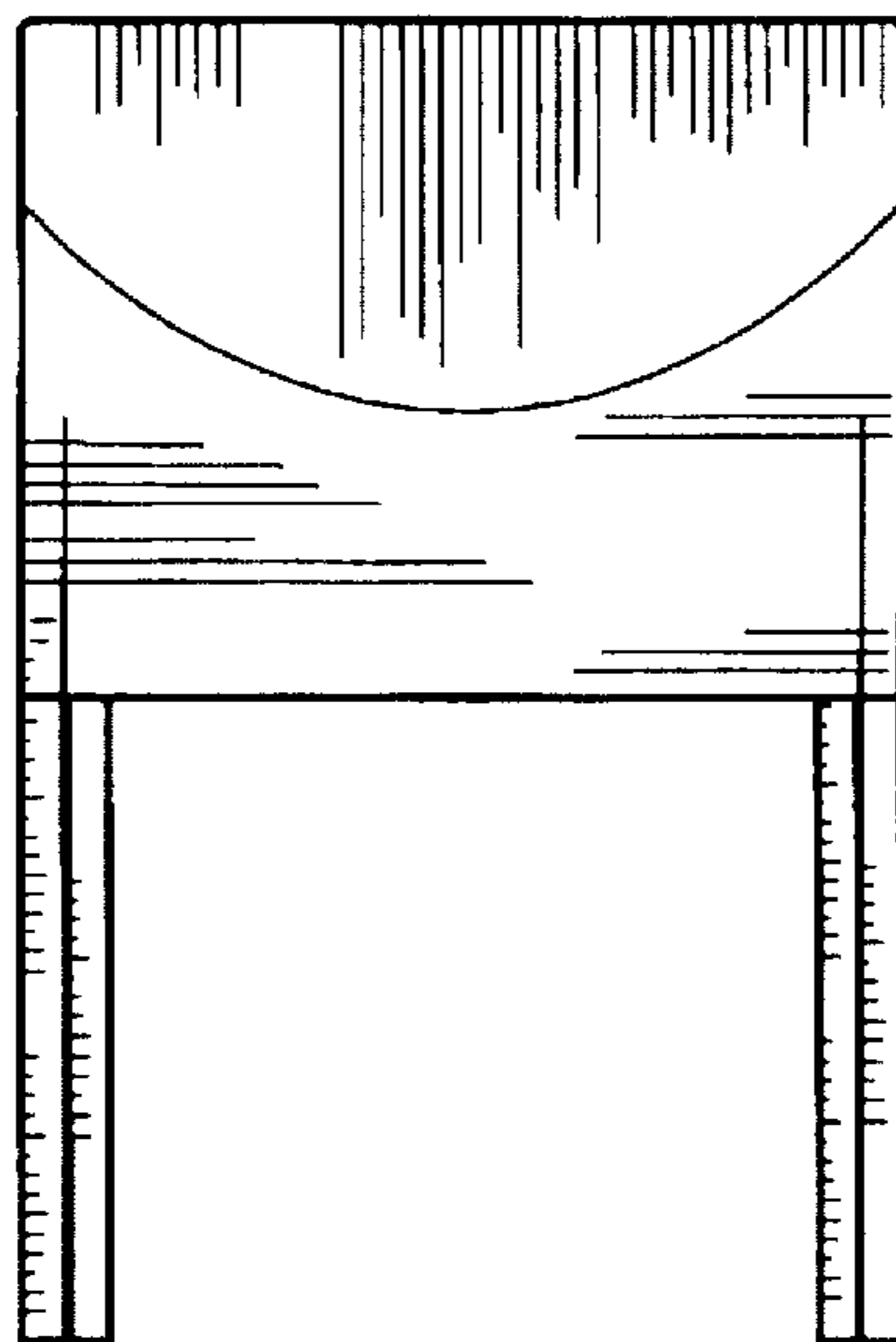

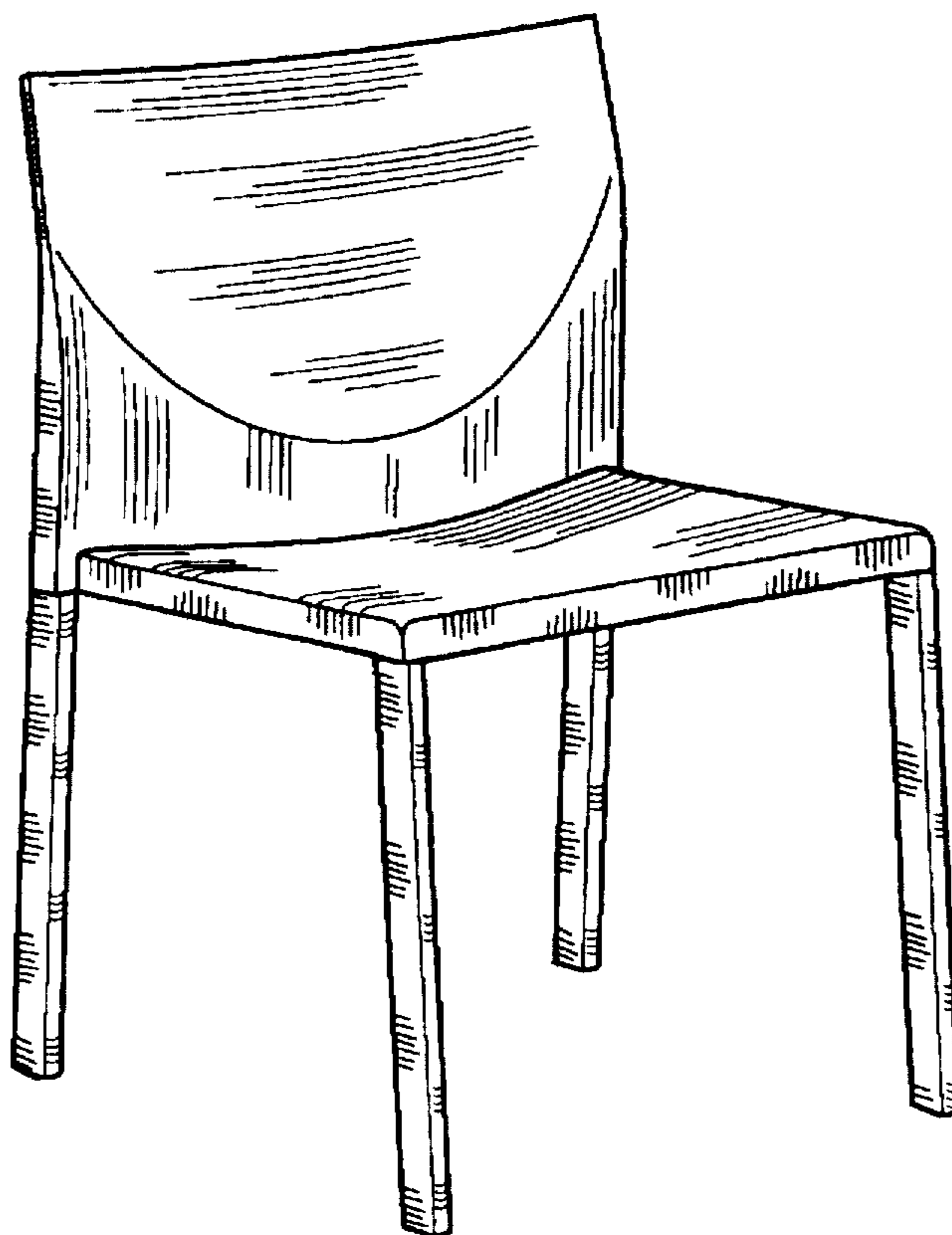

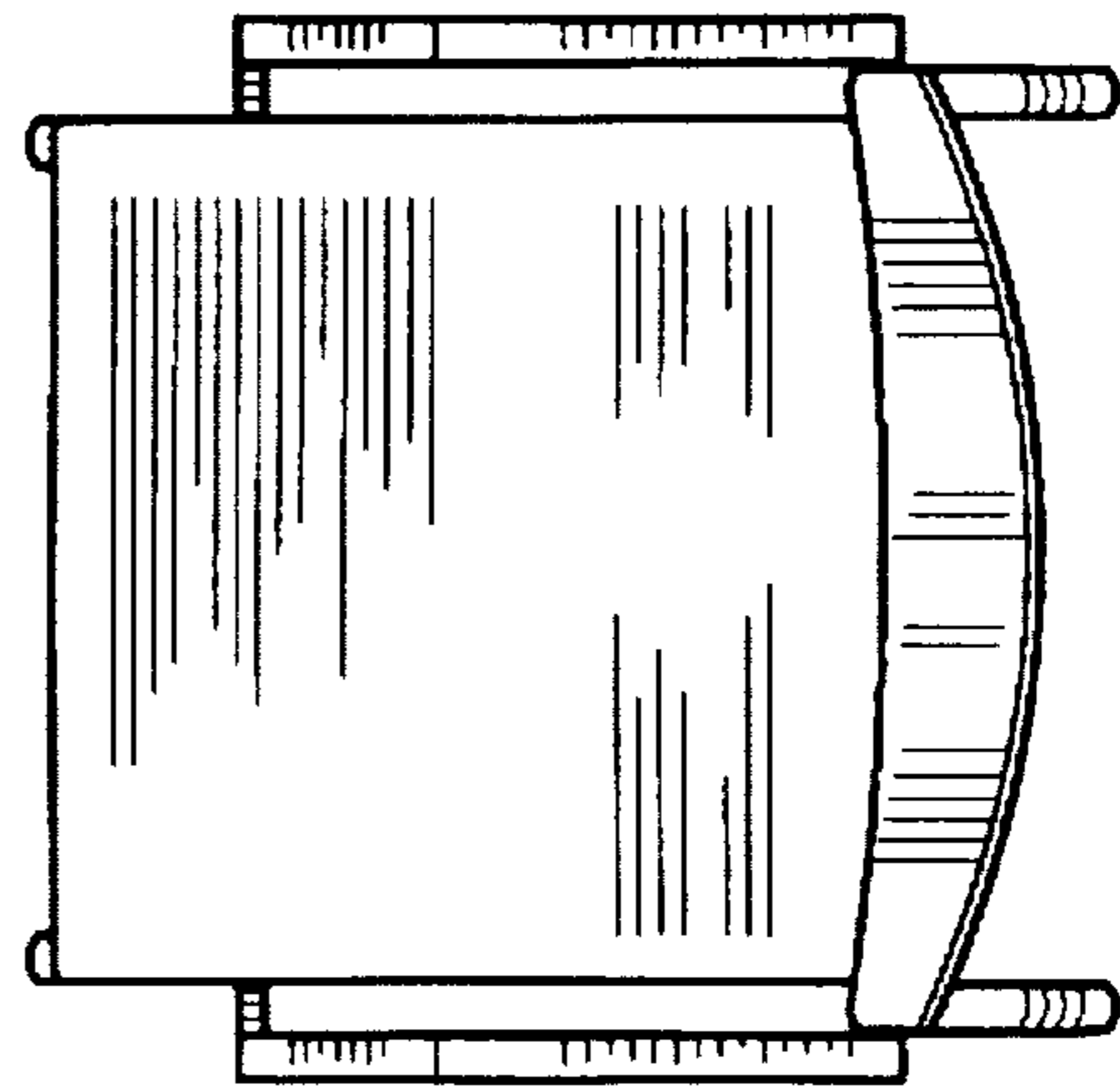

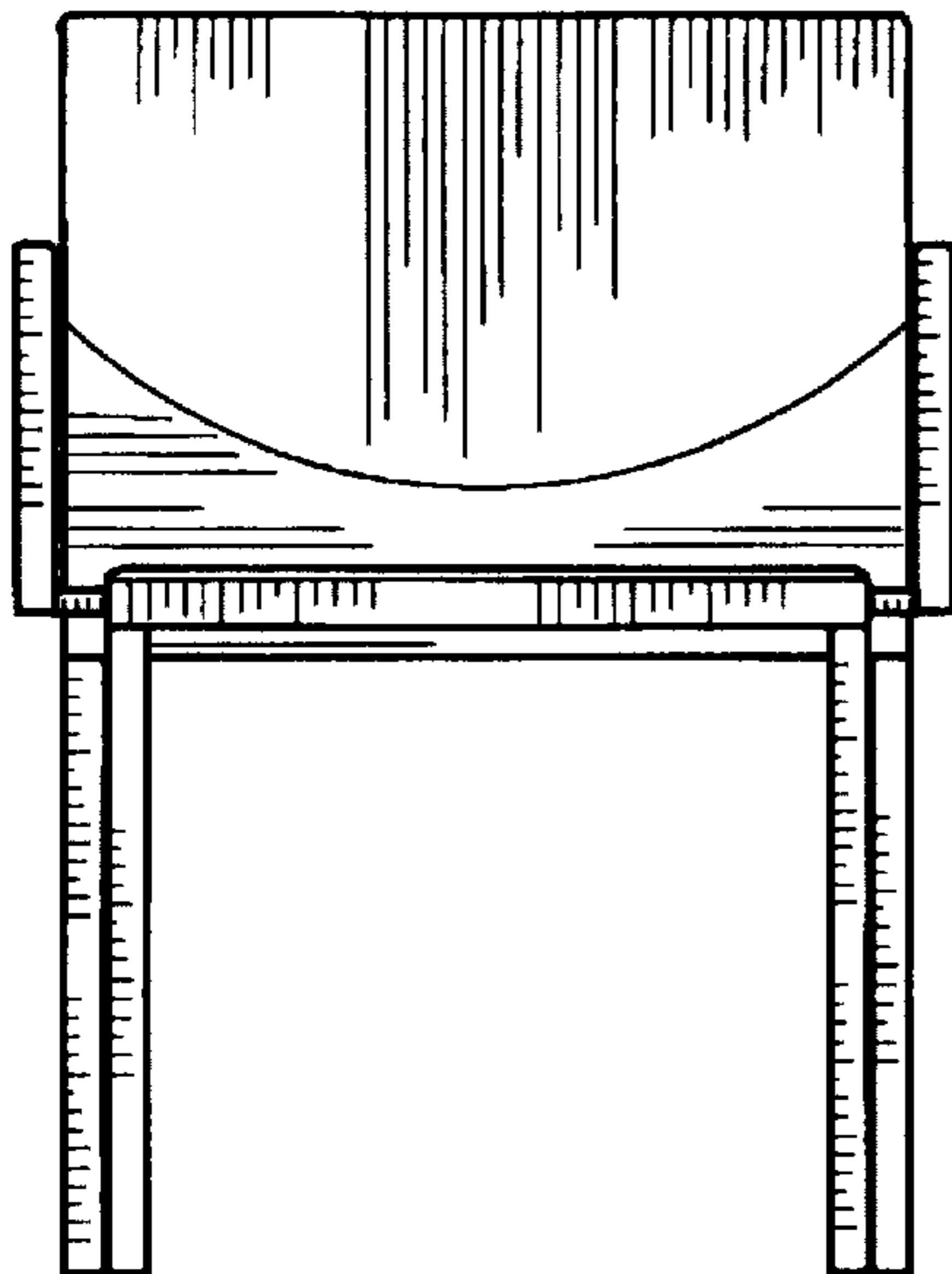

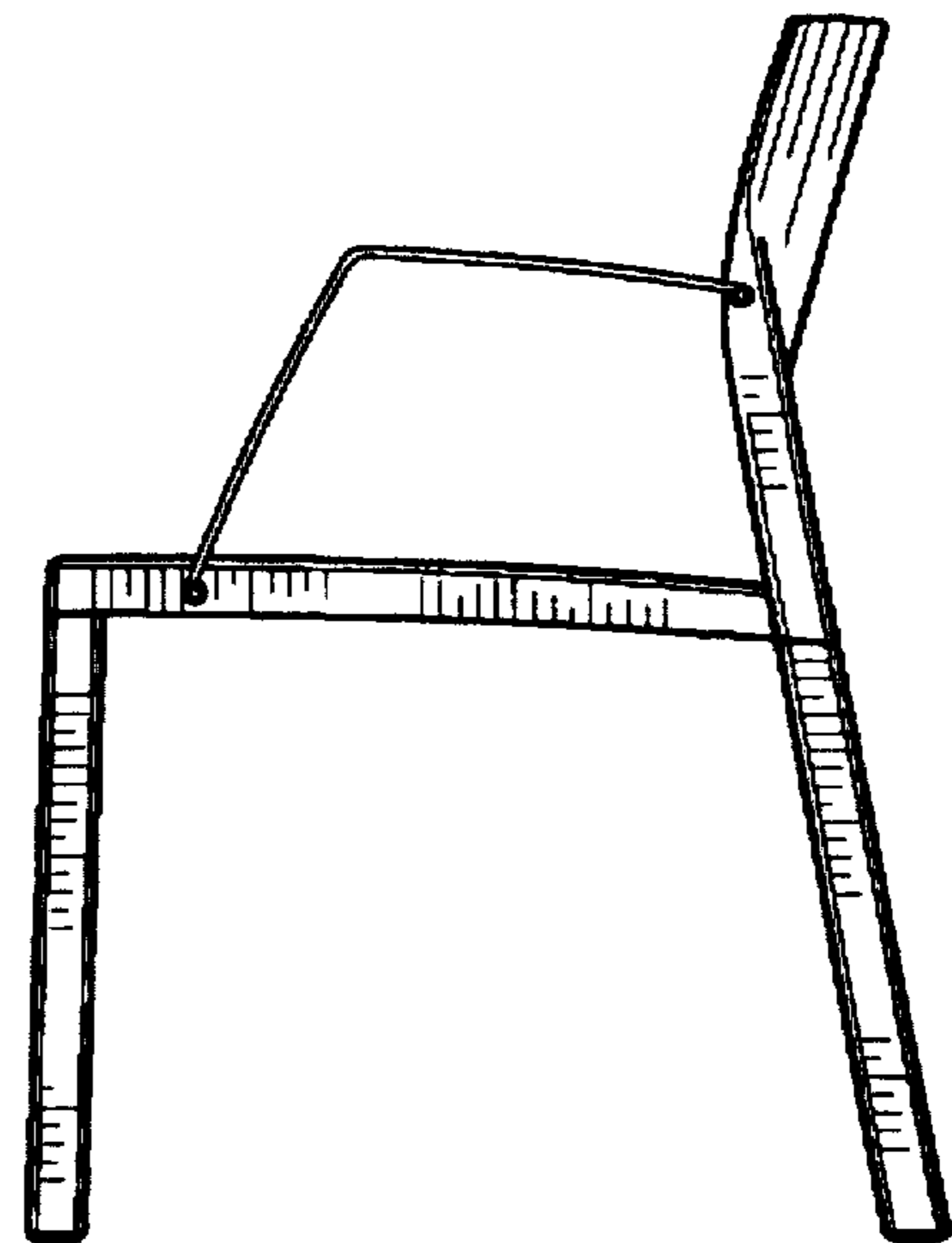

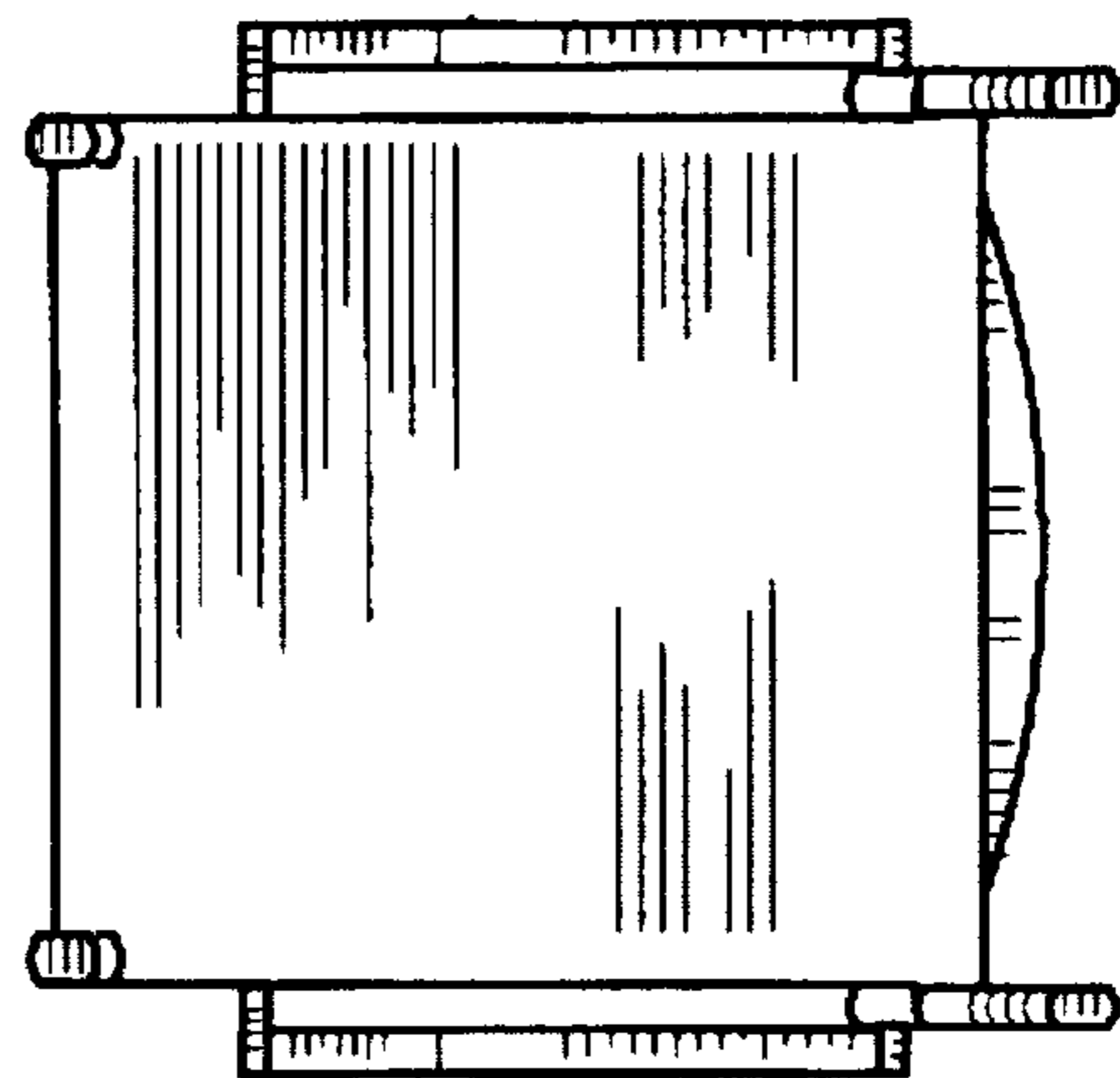

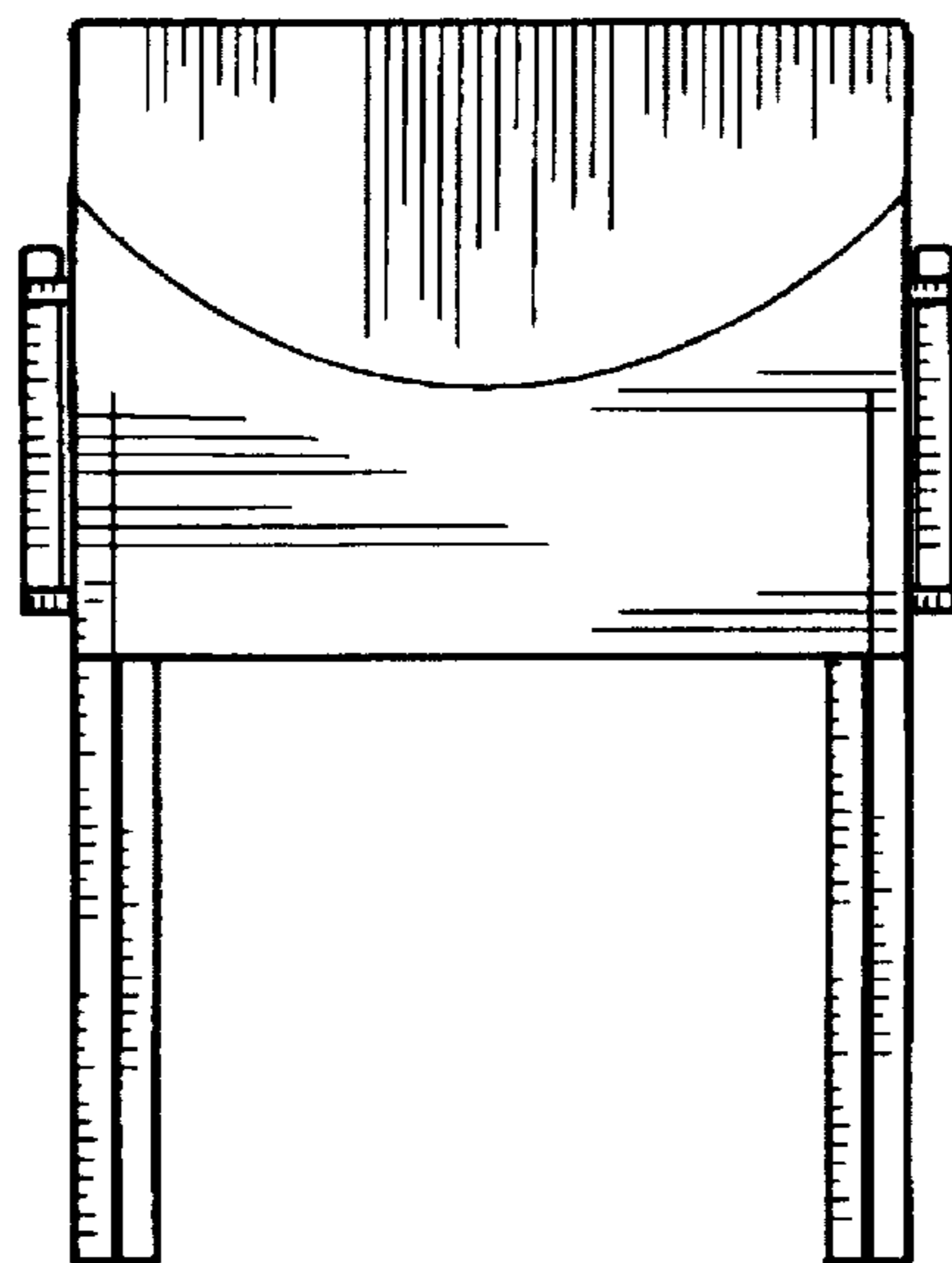

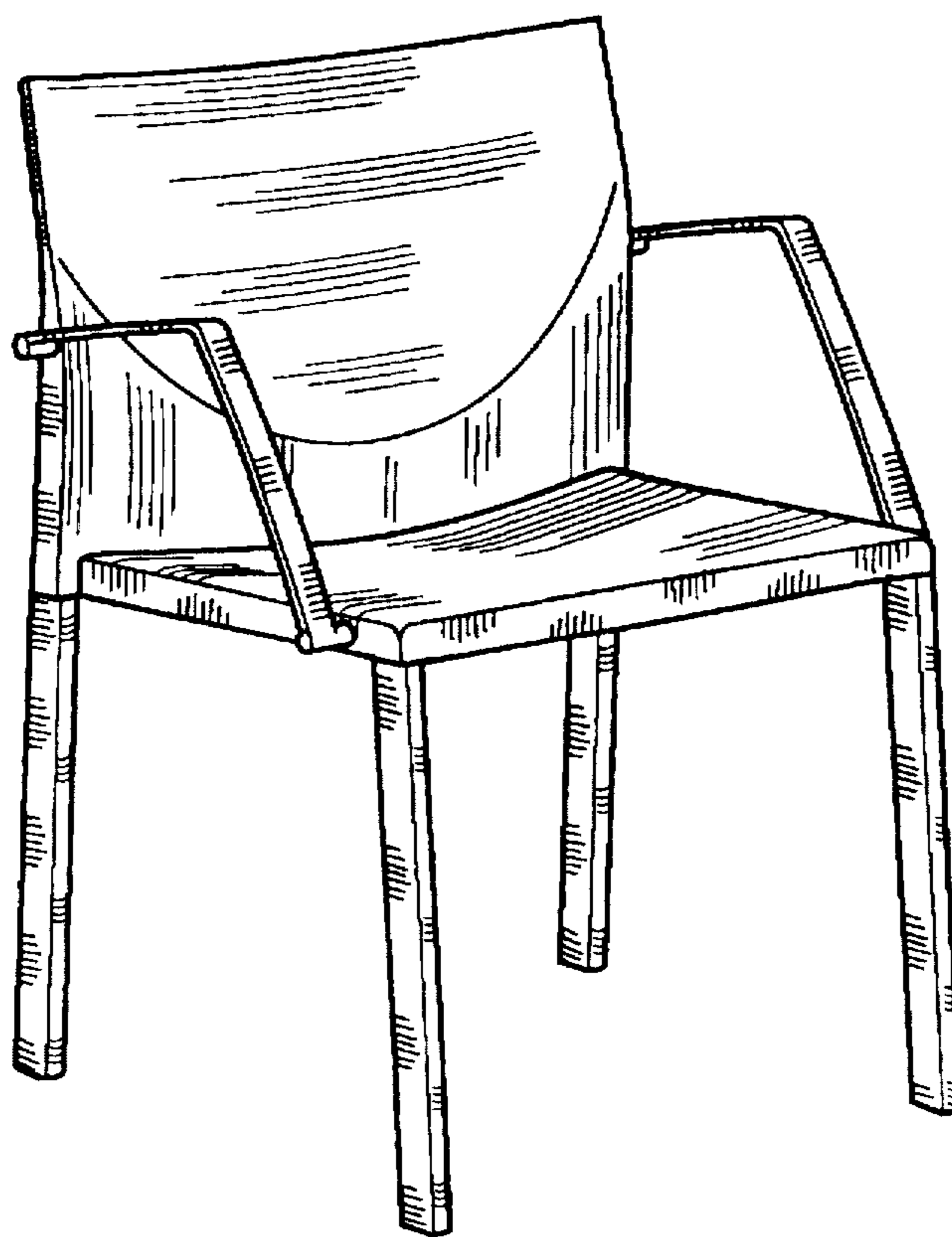
