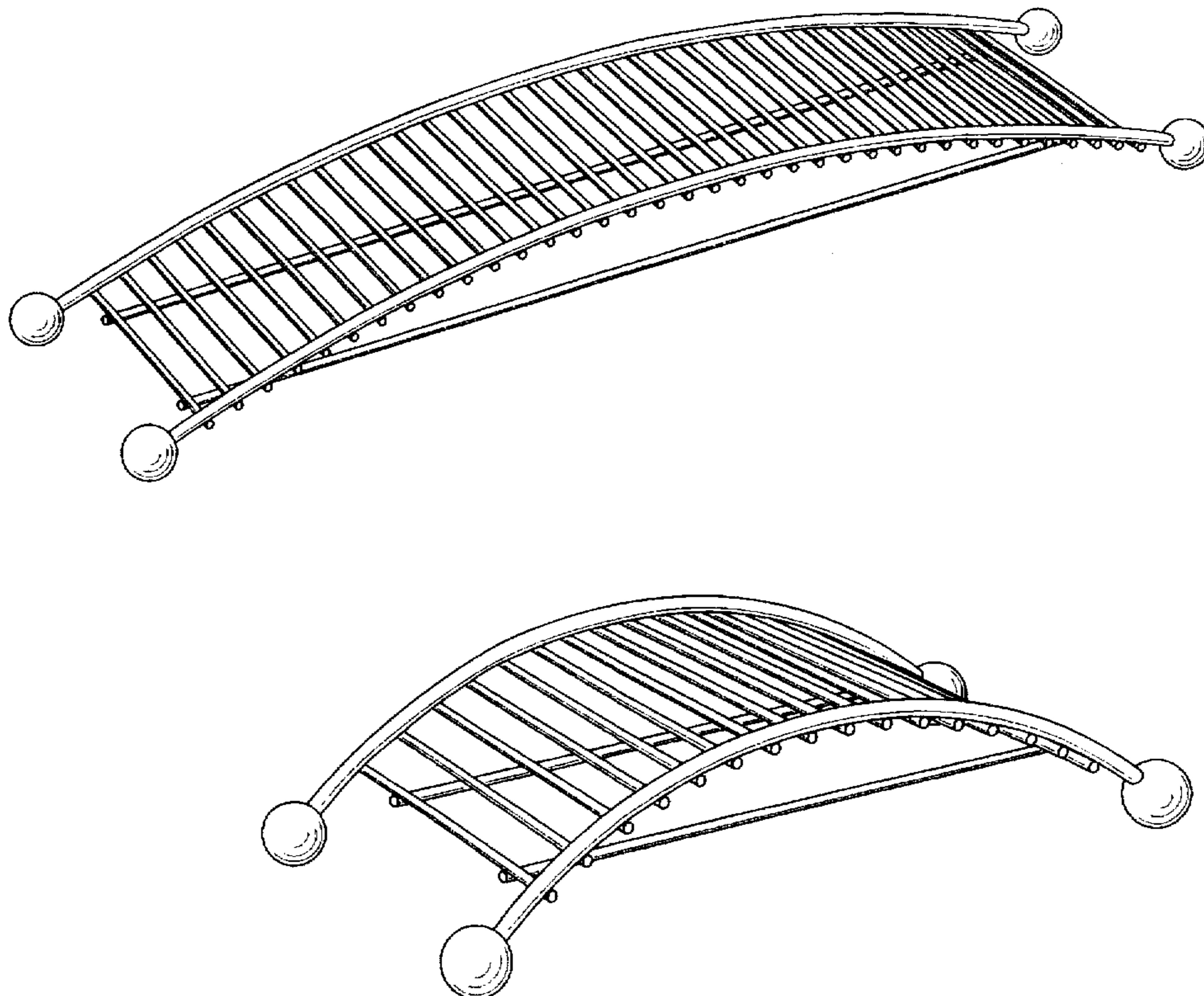
[57] **CLAIM**

The ornamental design for a compact disc rack, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a compact disc rack showing my new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a right side elevational thereof; the opposite side being identical;
FIG. 4 is a bottom view thereof;
FIG. 5 is front elevational view thereof;
FIG. 6 is a perspective view of a second embodiment of my invention for an ornamental design used for a compact disc rack;
FIG. 7 is a top plan view of FIG. 6;
FIG. 8 is a right side elevational thereof of FIG. 6; the opposite side being identical;
FIG. 9 is a bottom view of FIG. 6; and
FIG. 10 is front elevational view of FIG. 6.

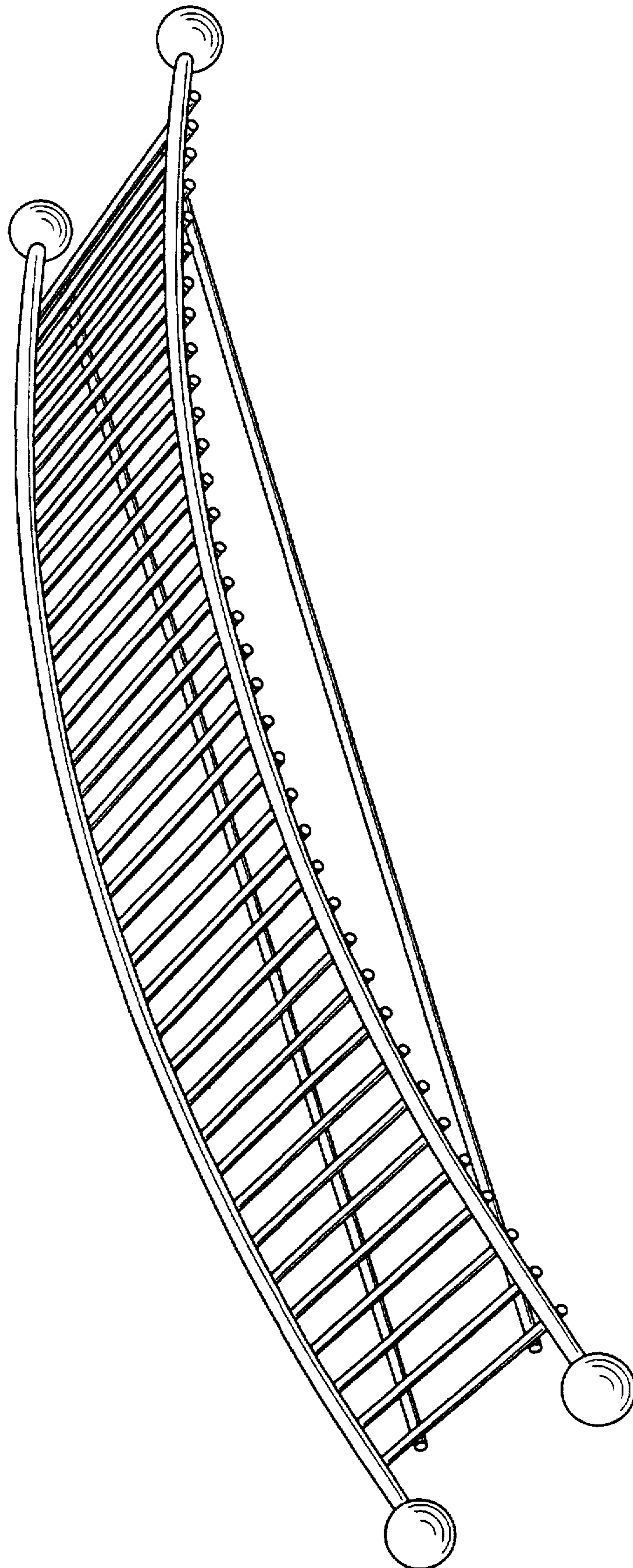

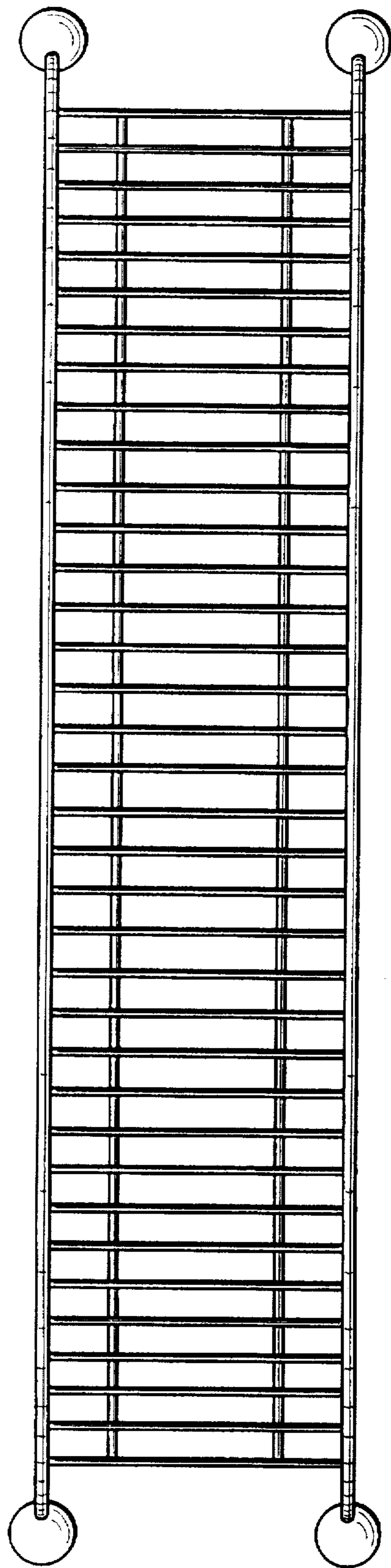

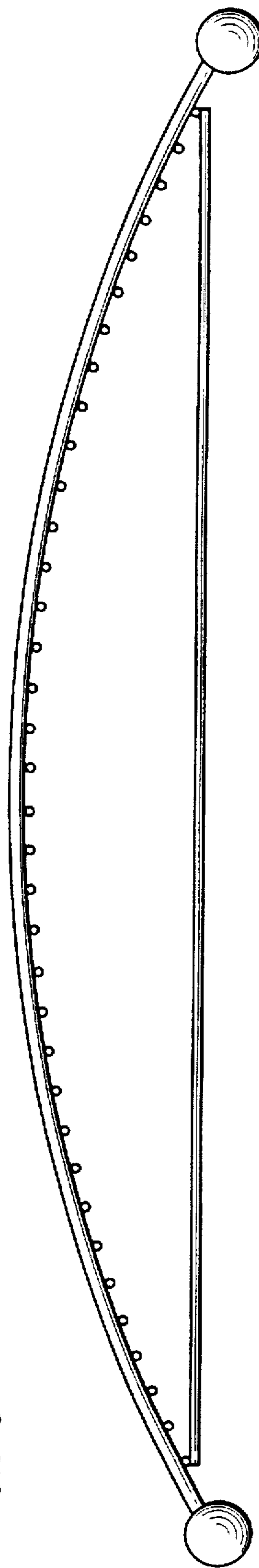

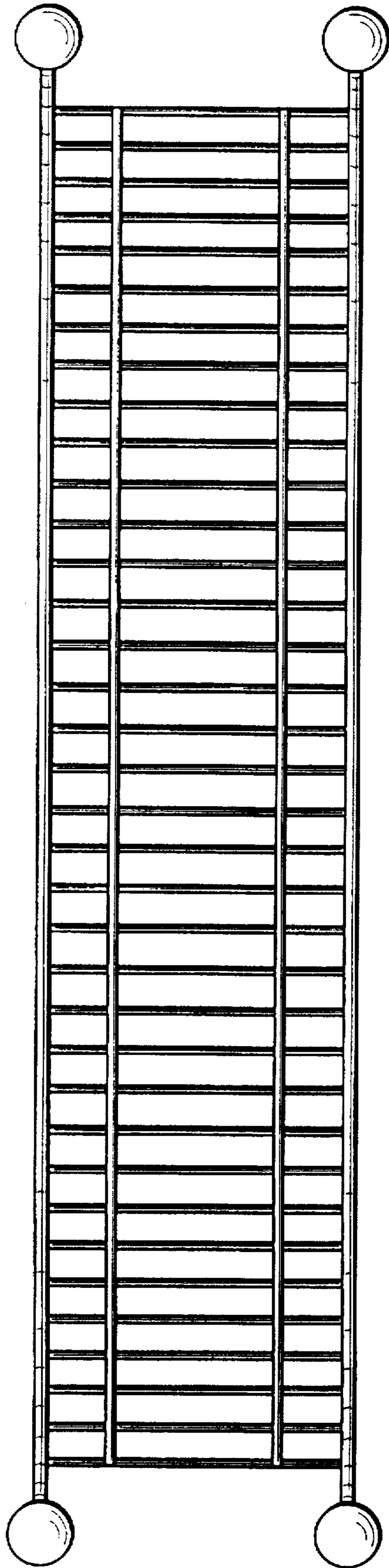
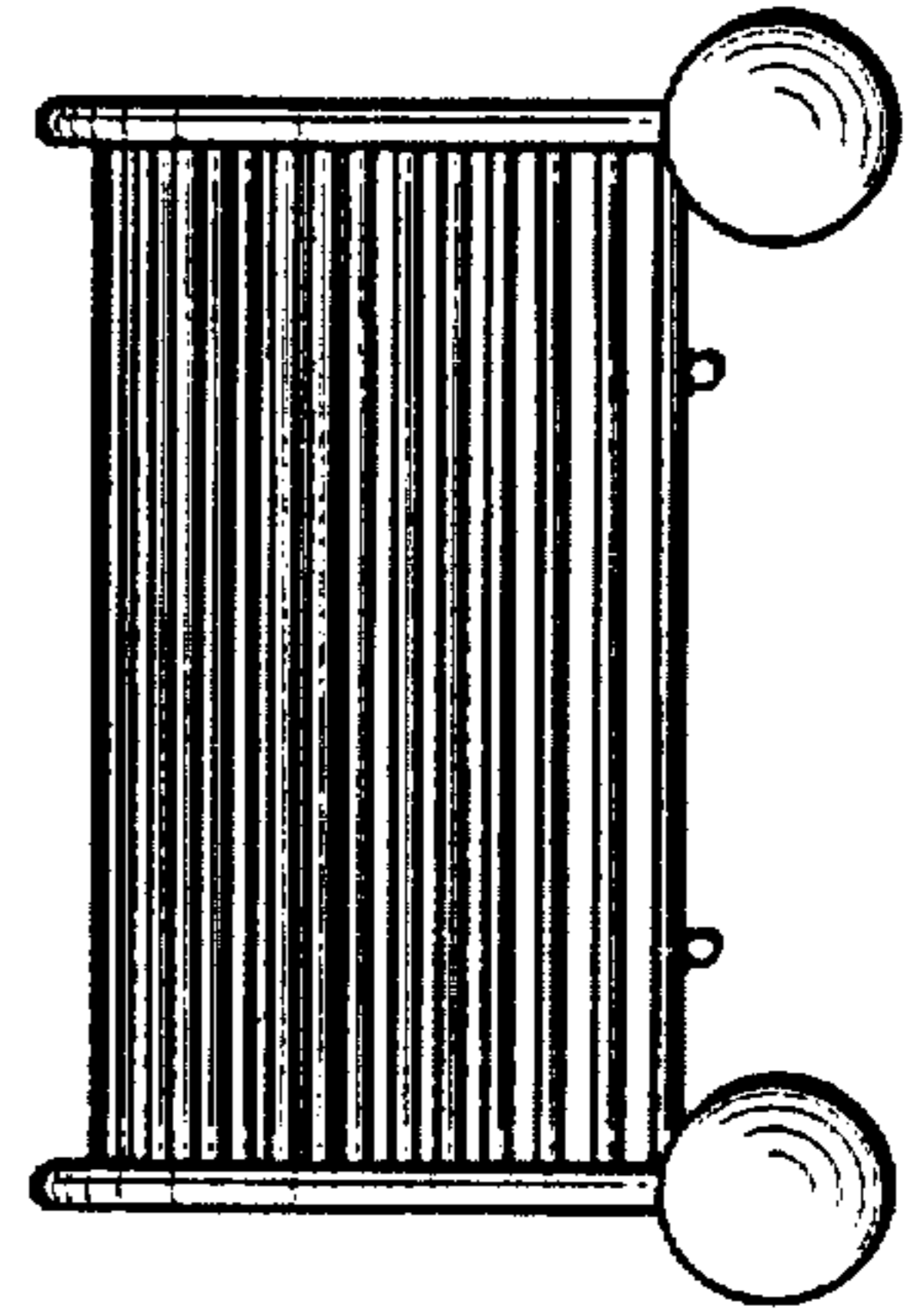

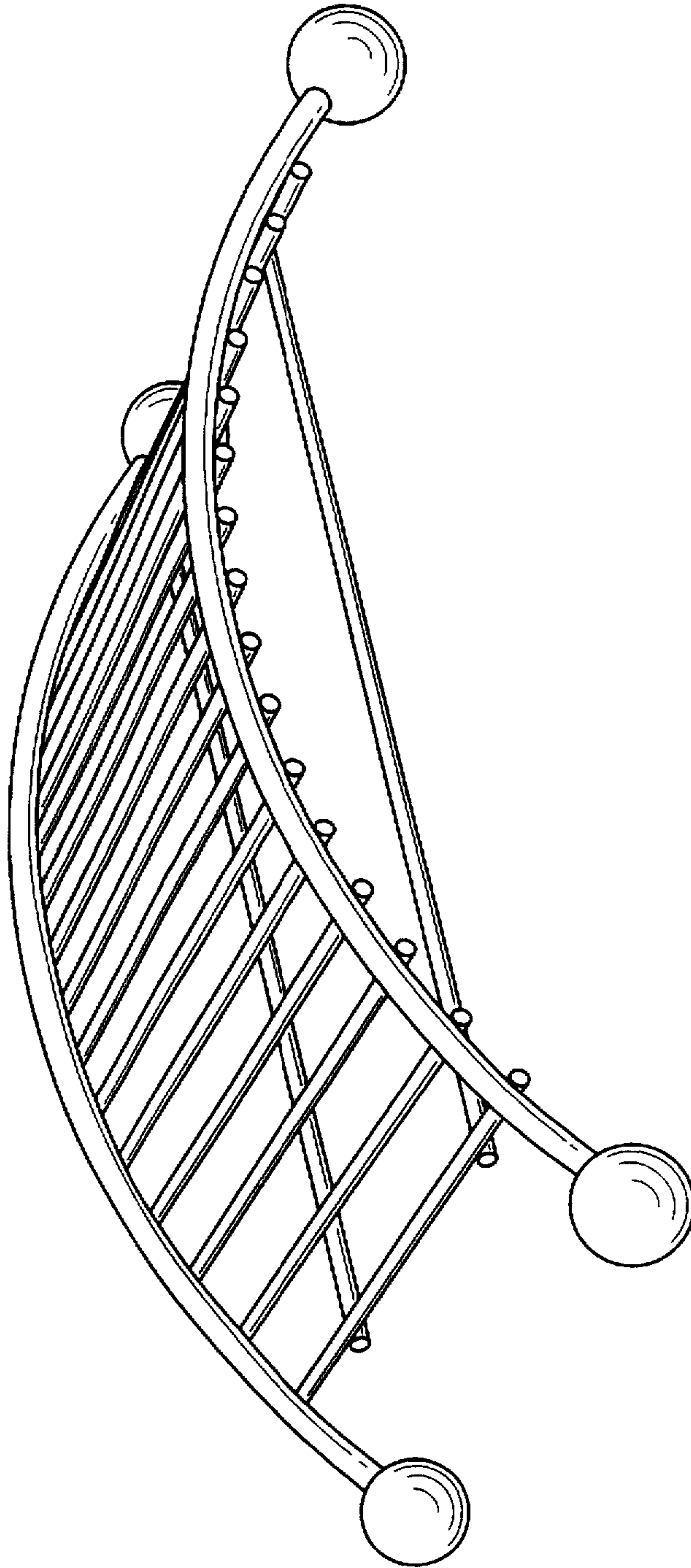

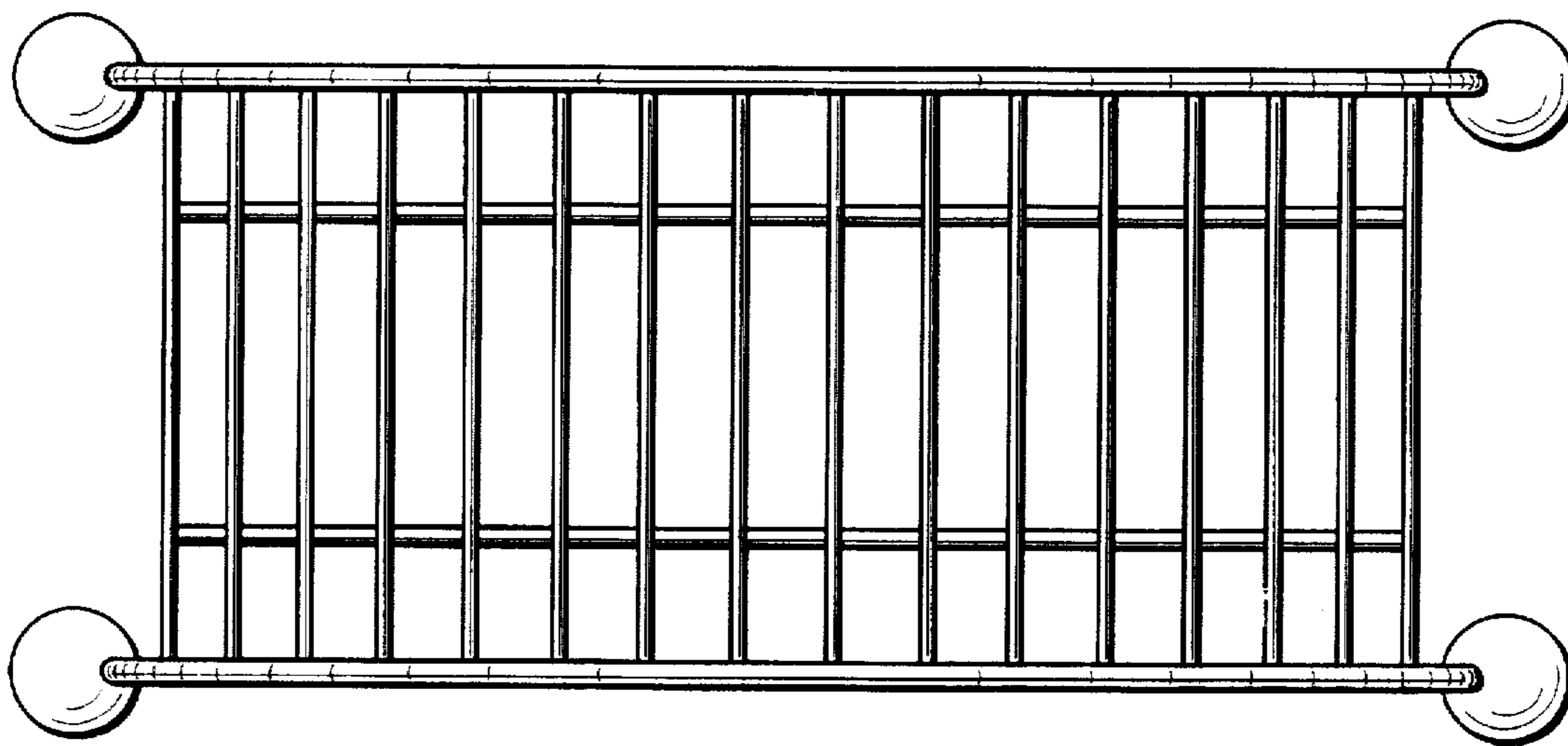

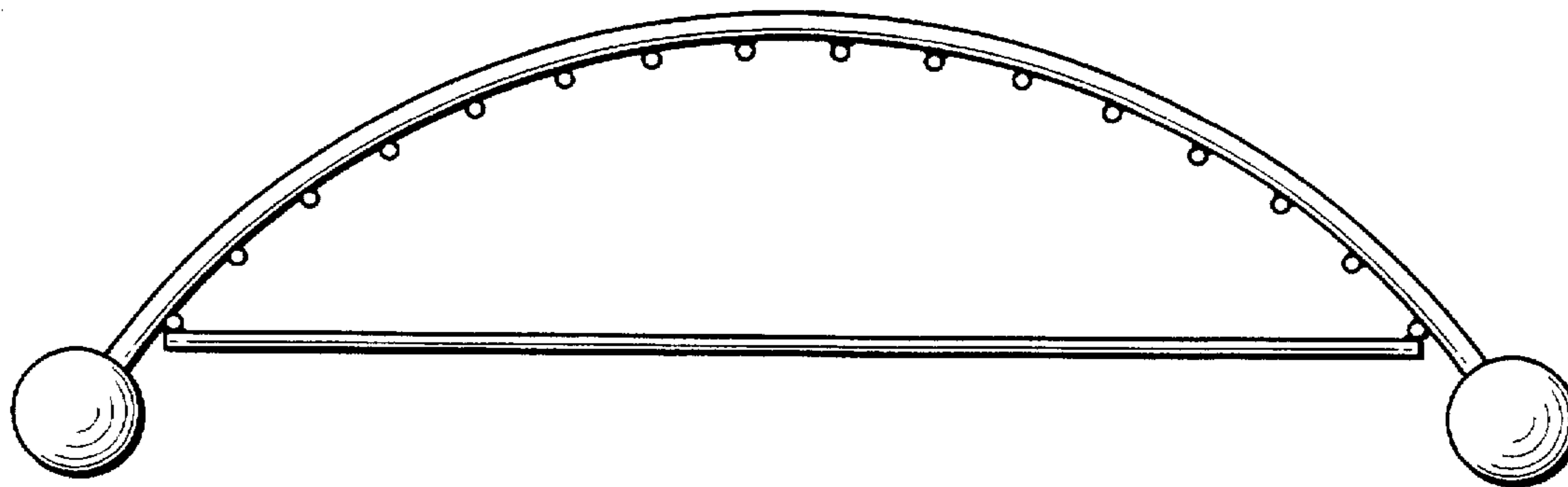

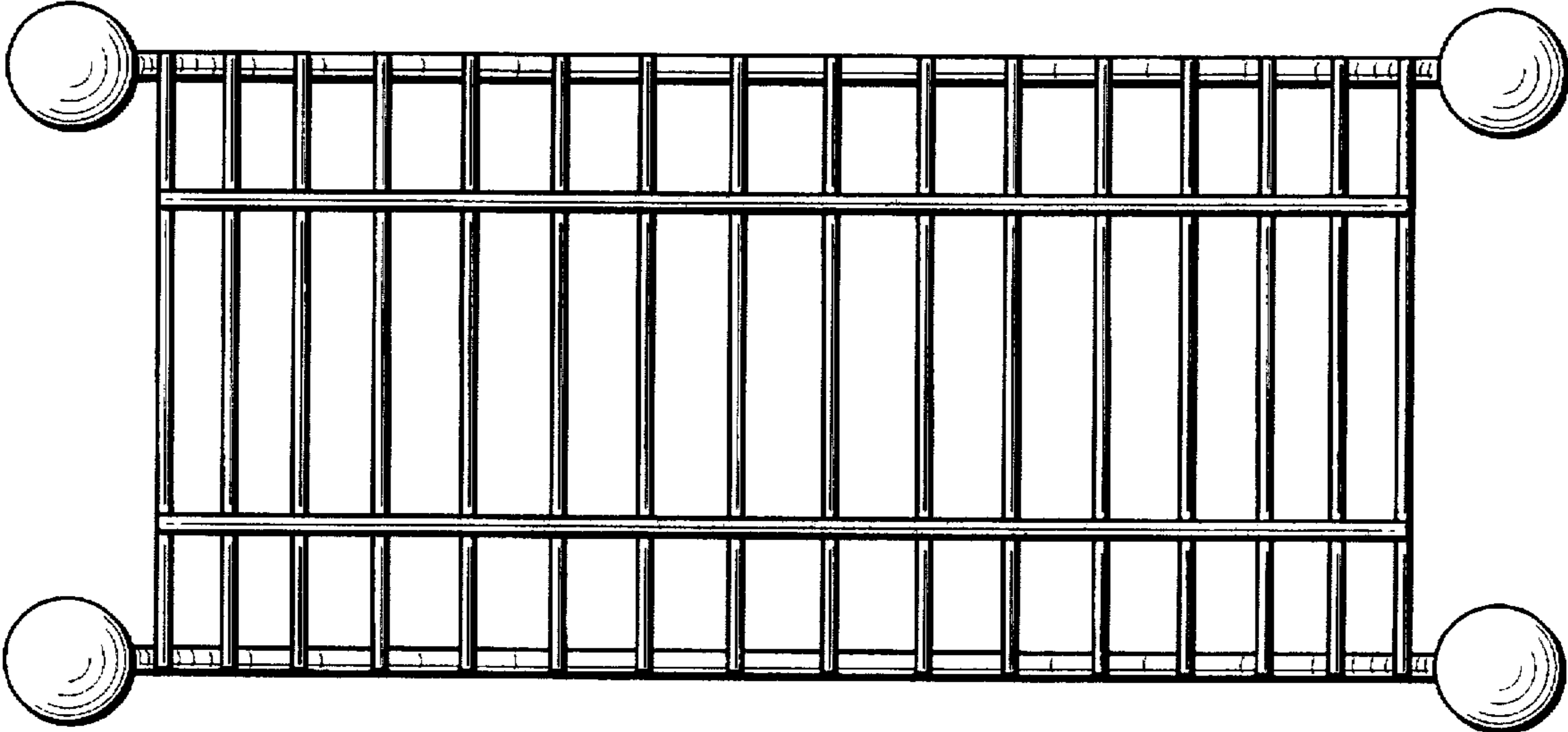
