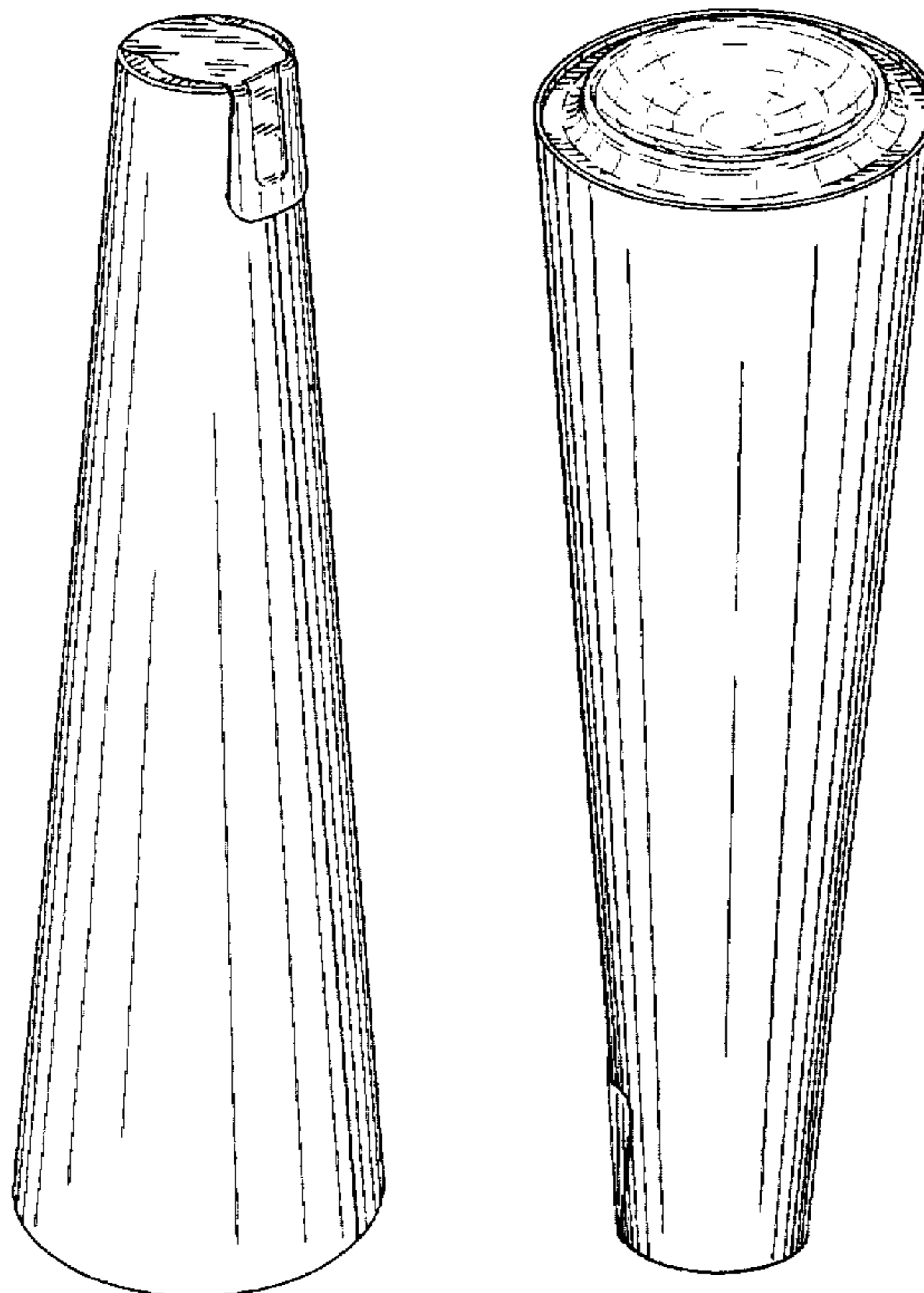
[57] **CLAIM**

DESCRIPTION

FIG. 1 is a top perspective view of a packaging container according to the invention;

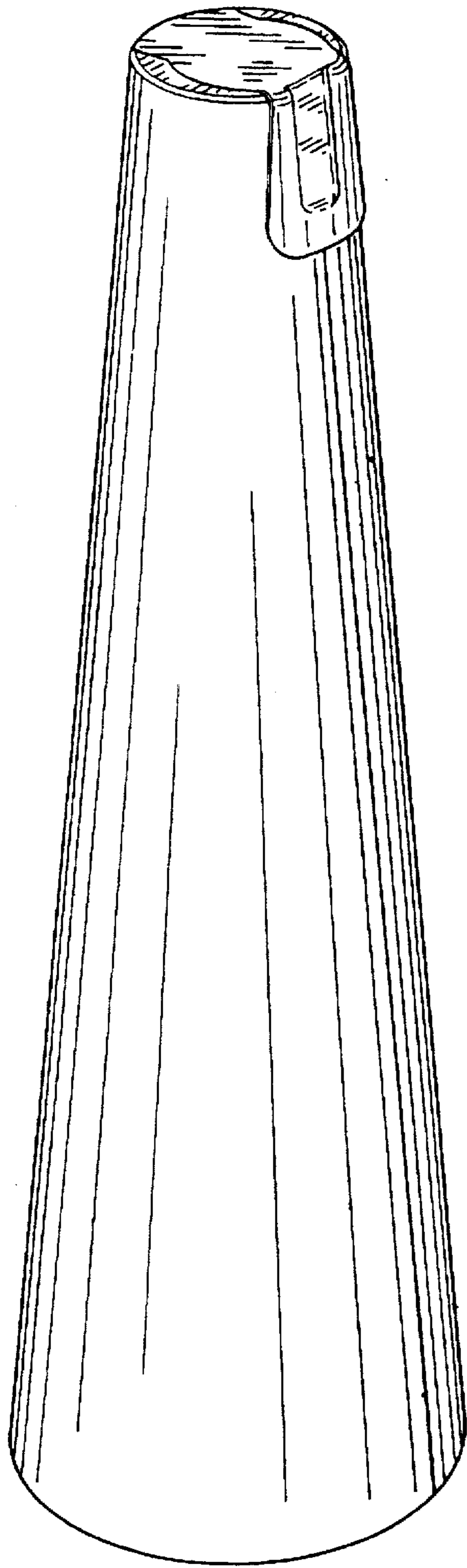

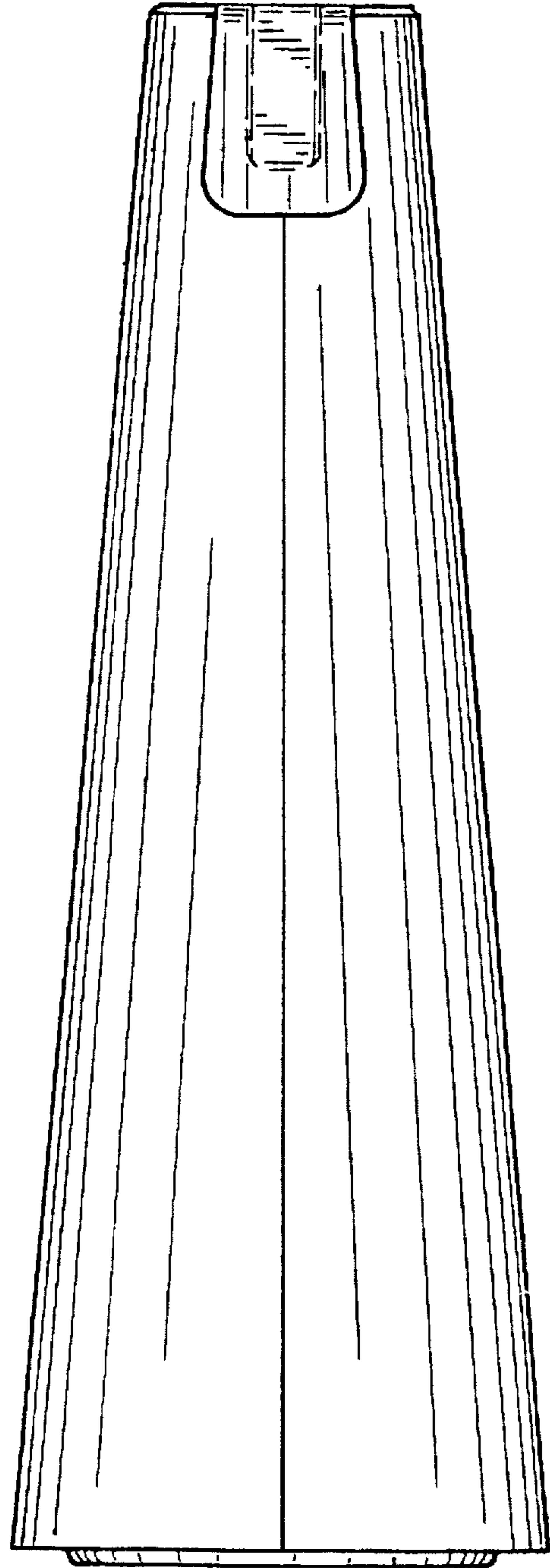

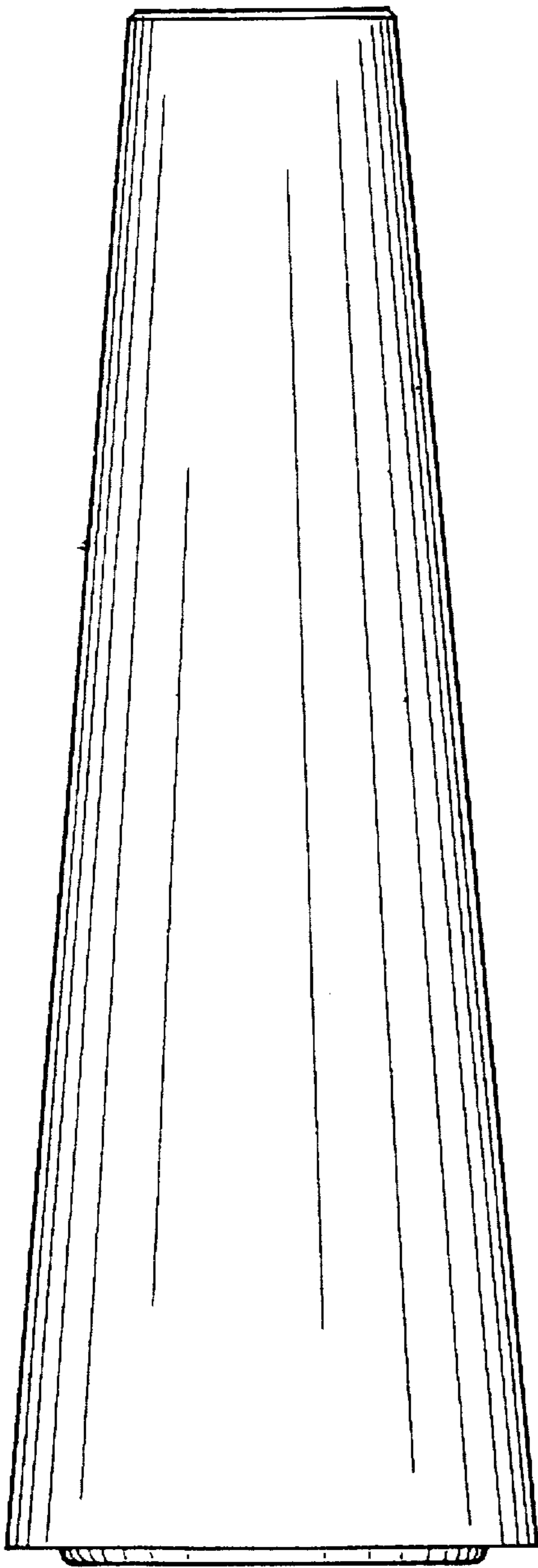

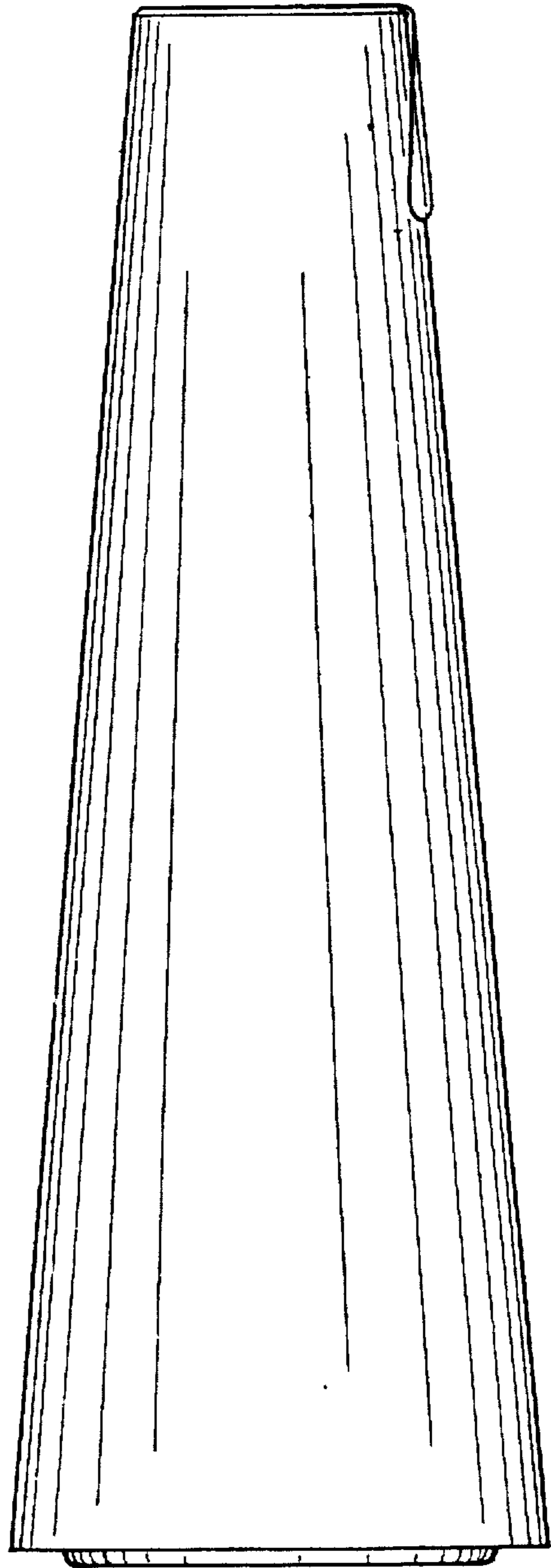

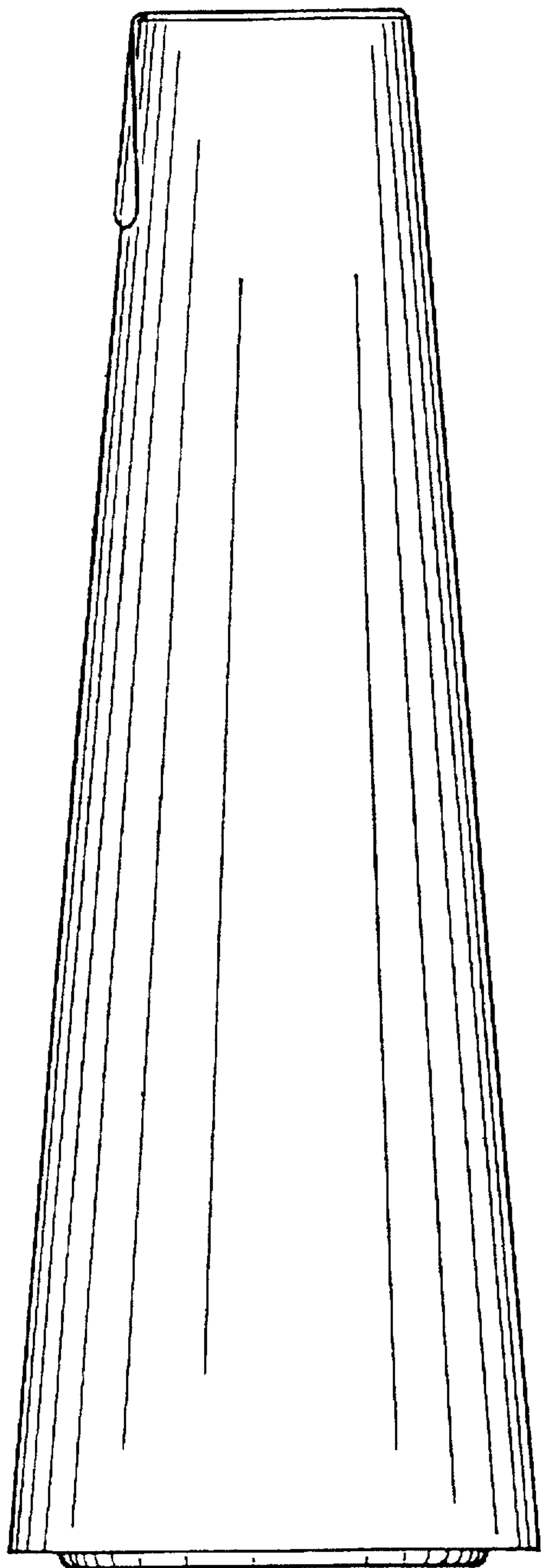

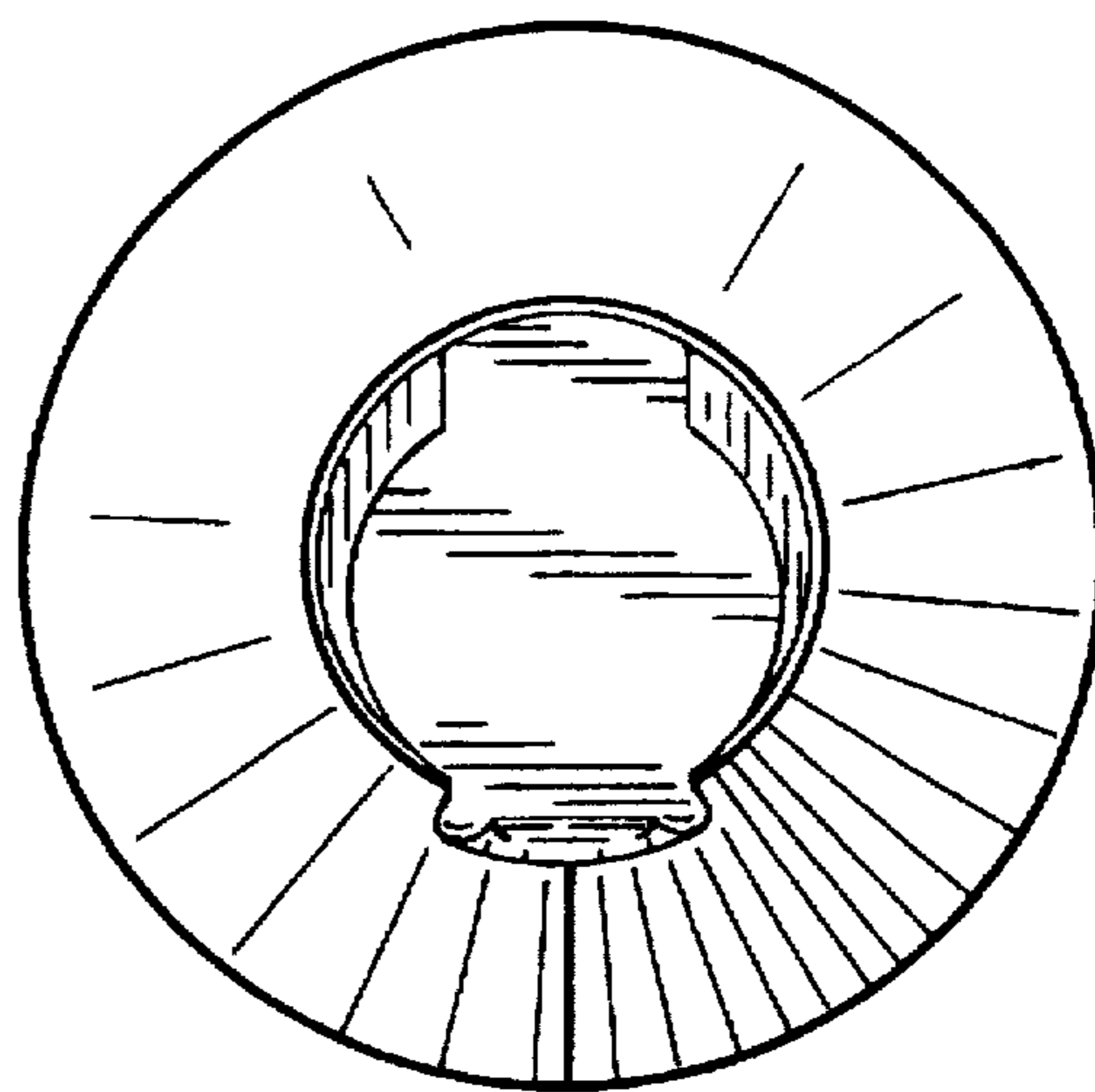

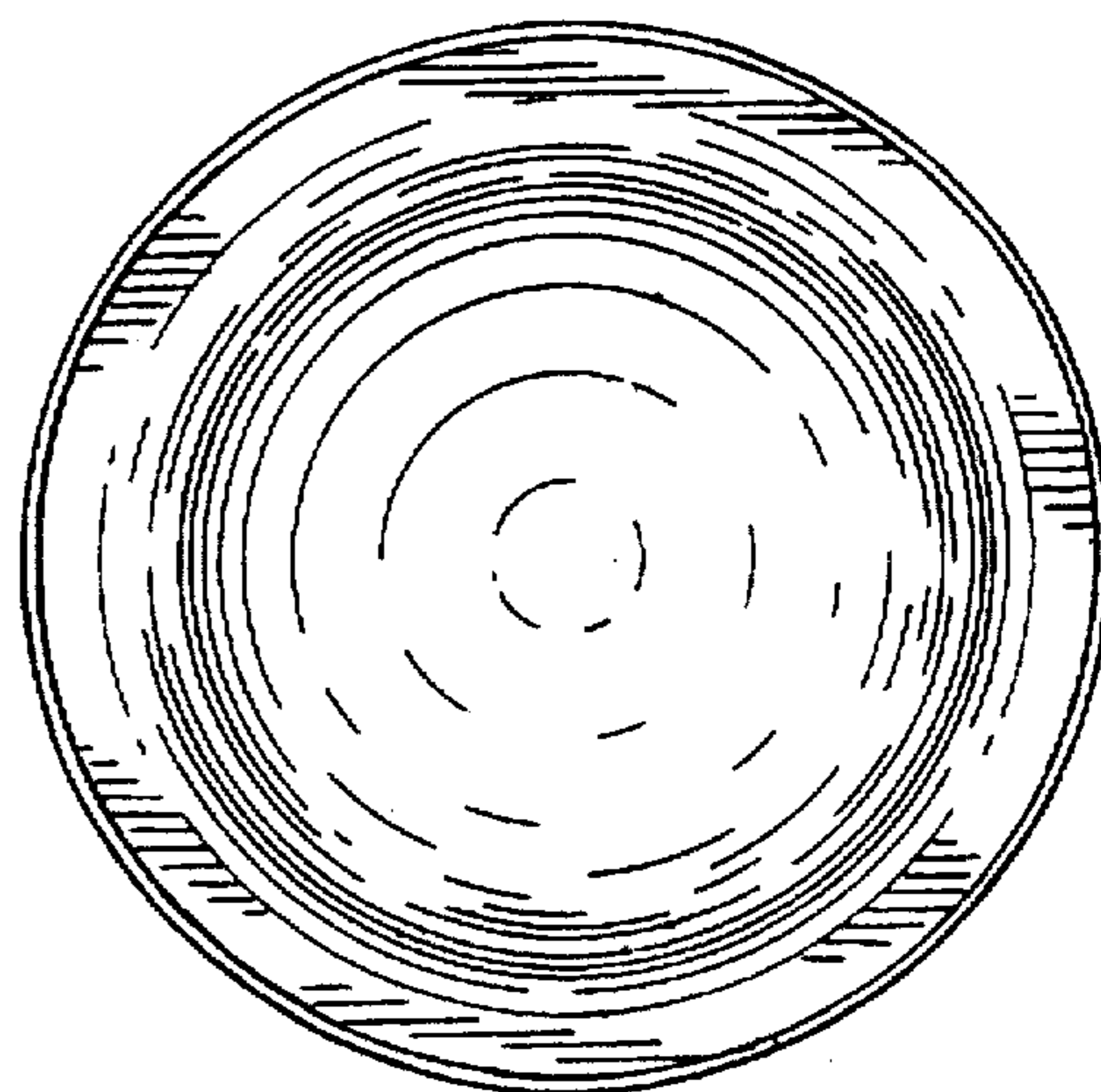

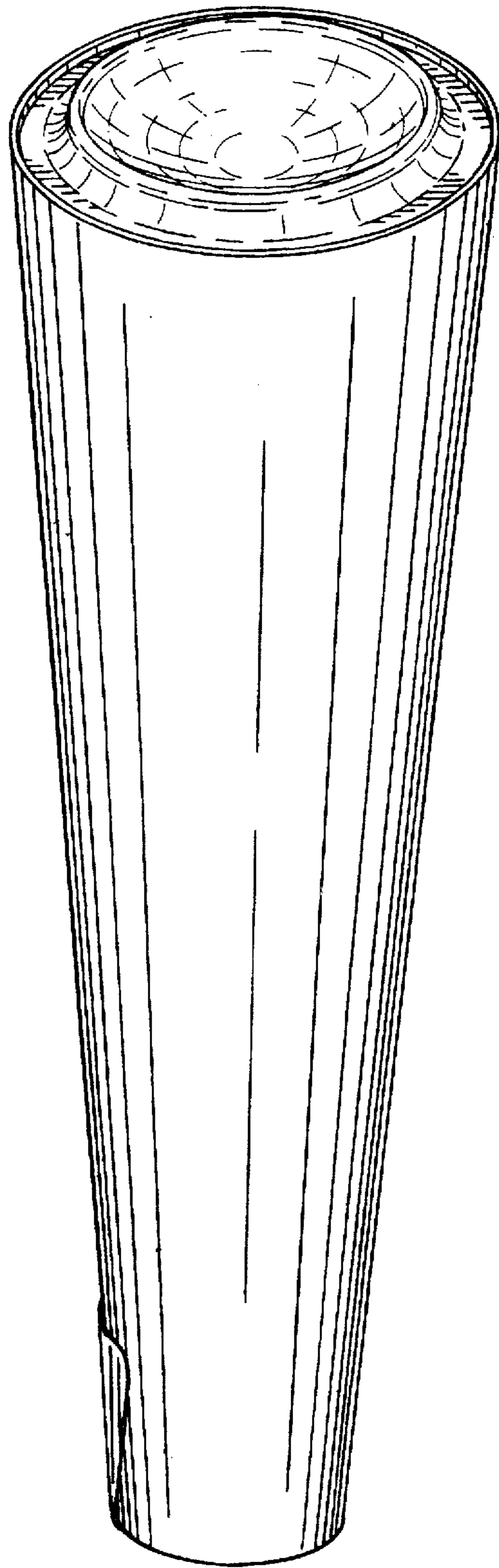
