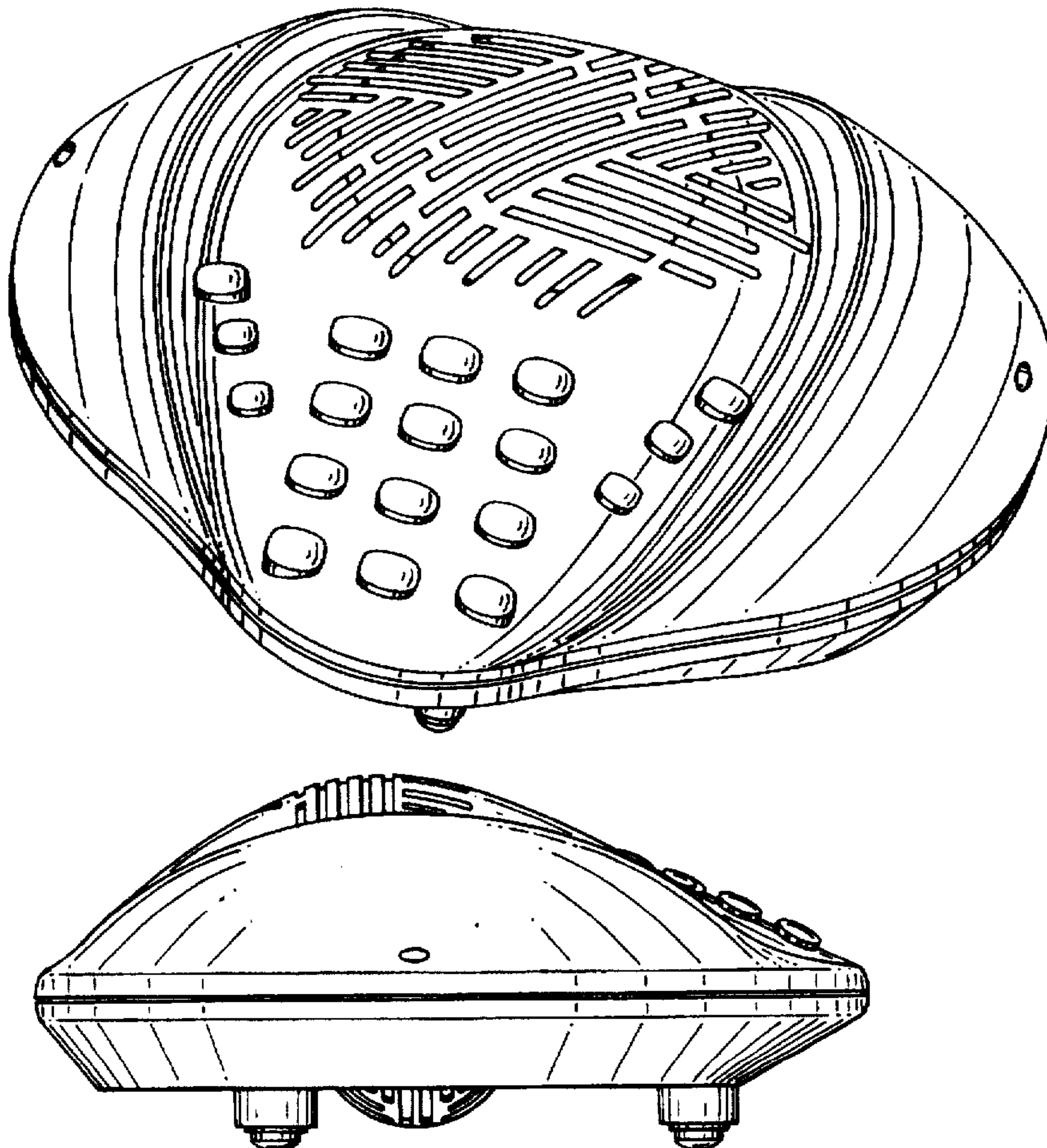
[57] **CLAIM**

The ornamental design for a speaker phone, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the speaker phone; FIG. 2 is a top plan view of the speaker phone; FIG. 3 is a bottom plan view of the speaker phone; FIG. 4 is a front elevational view of the speaker phone; FIG. 5 is a rear elevational view of the speaker phone; FIG. 6 is a side elevational view of the speaker phone, as seen from the right hand side of the machine; and, FIG. 7 is a side elevational view of the speakerphone, as seen from the left hand side of the machine.

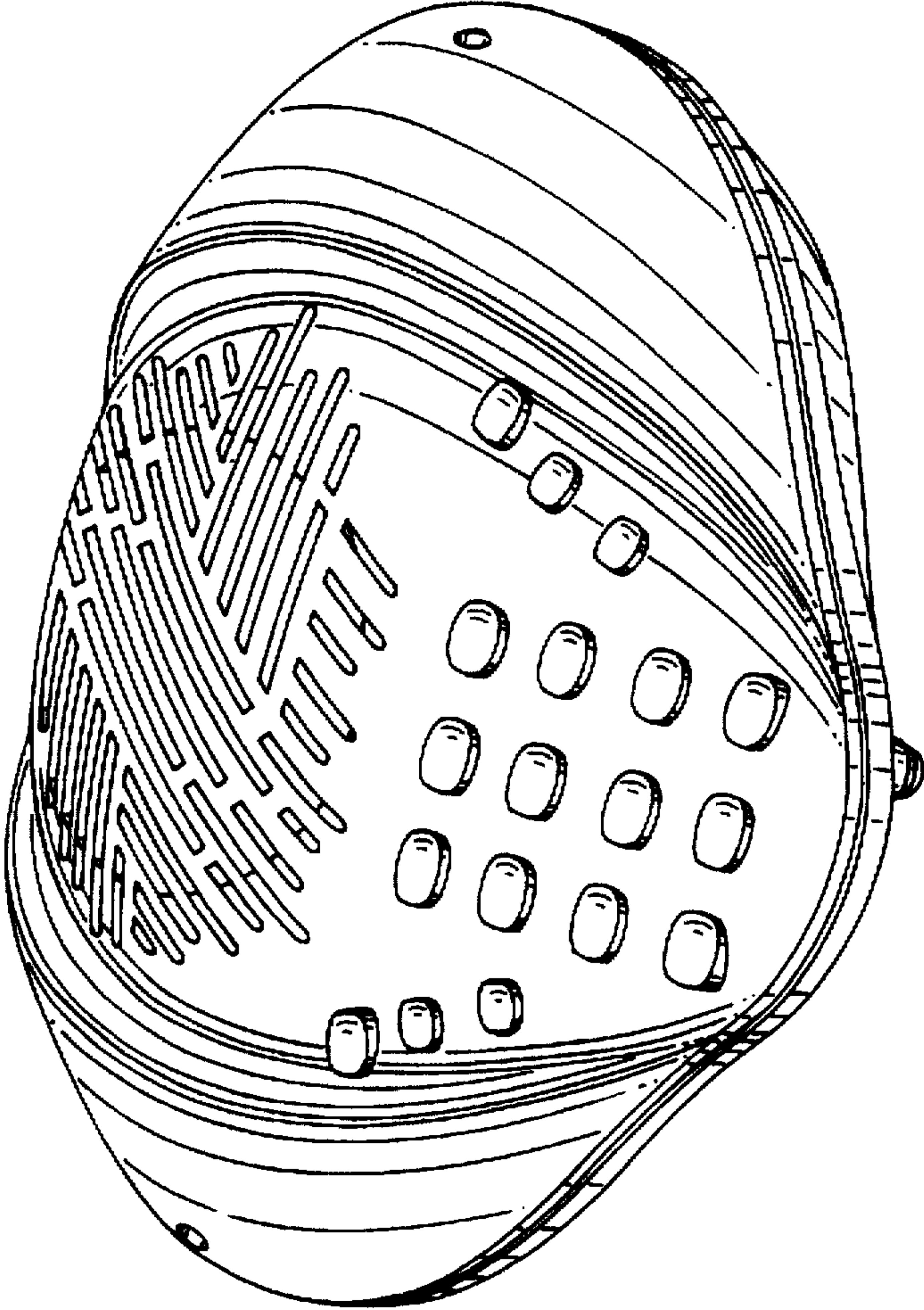

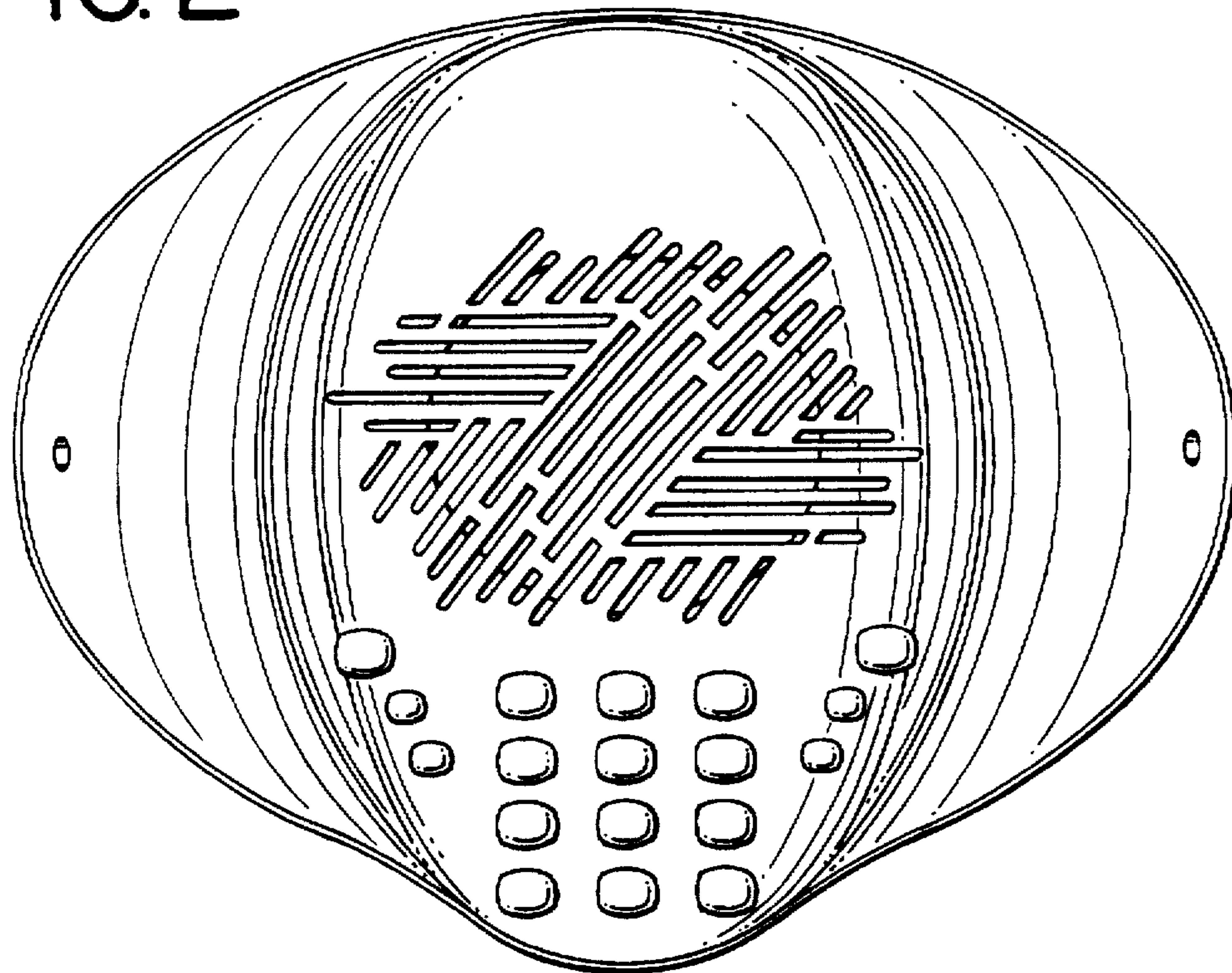

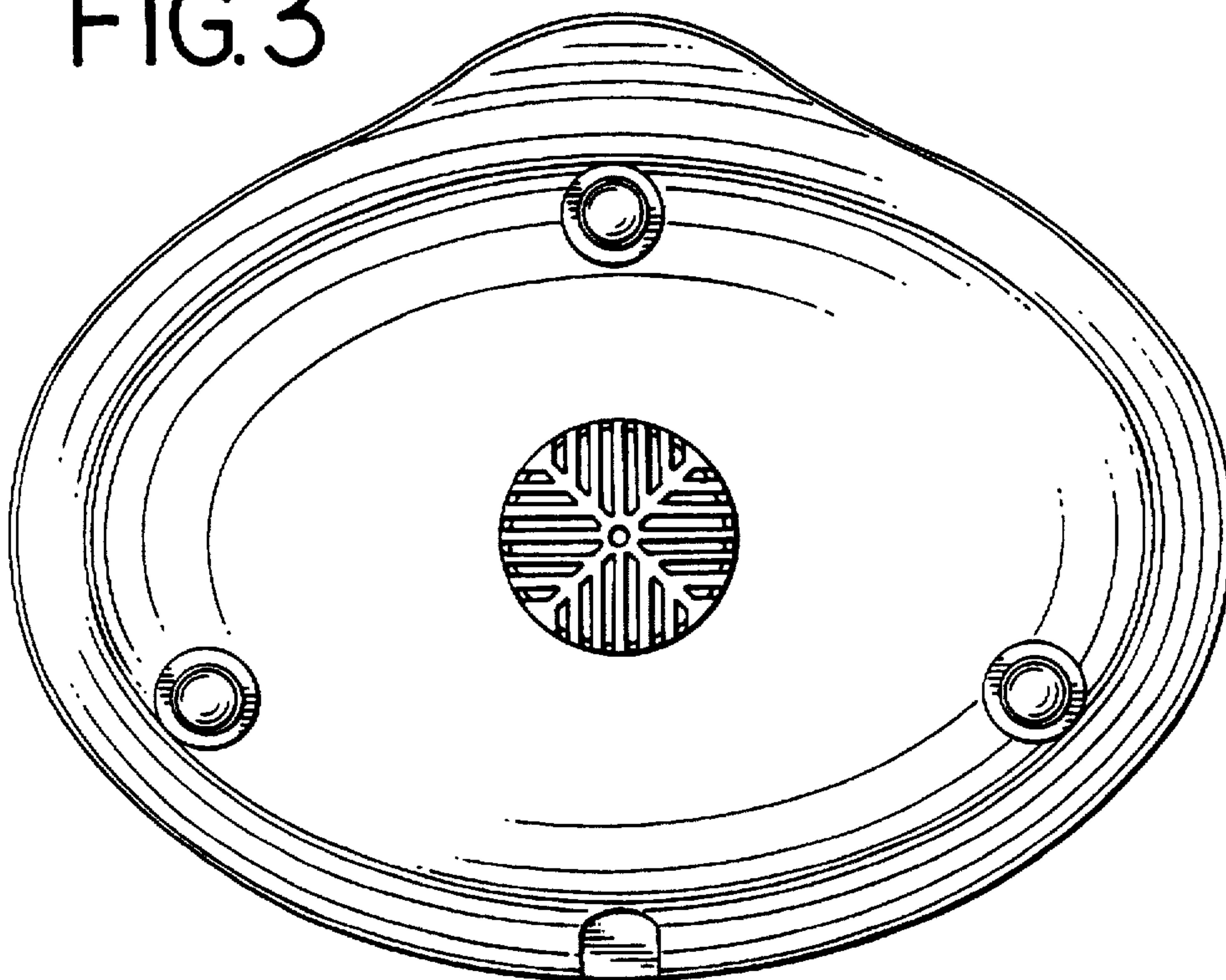

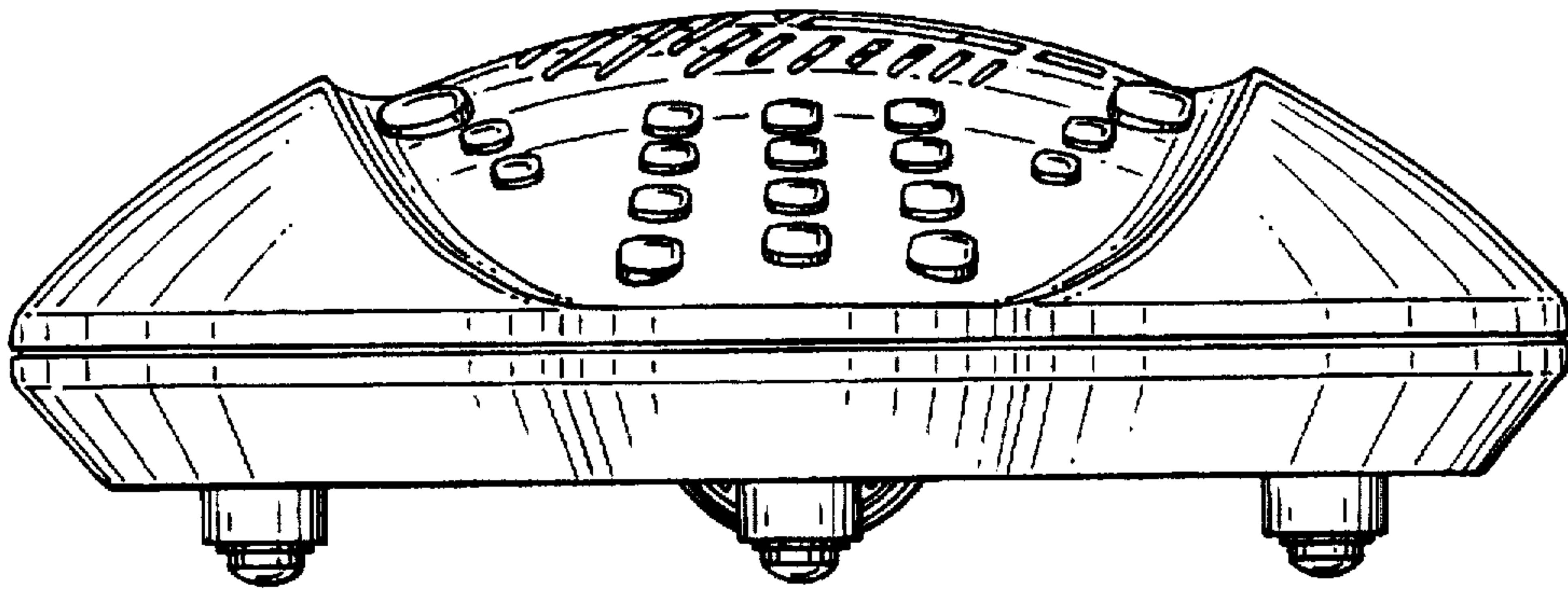

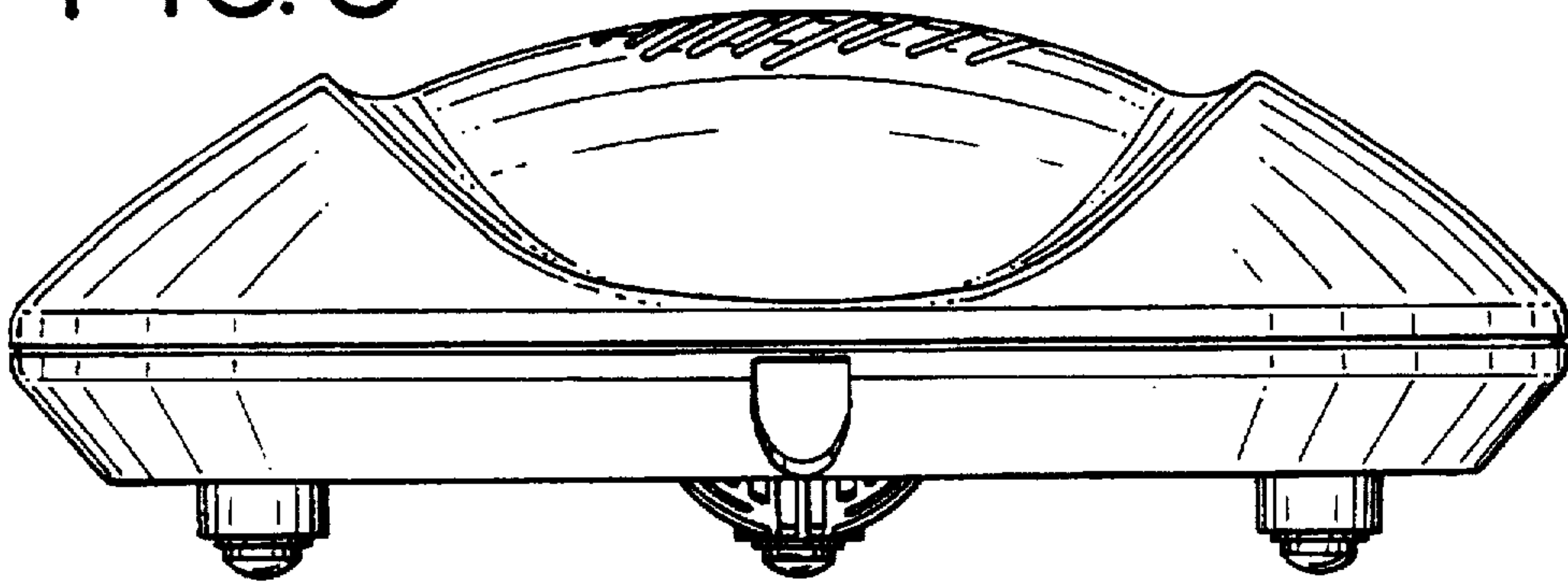

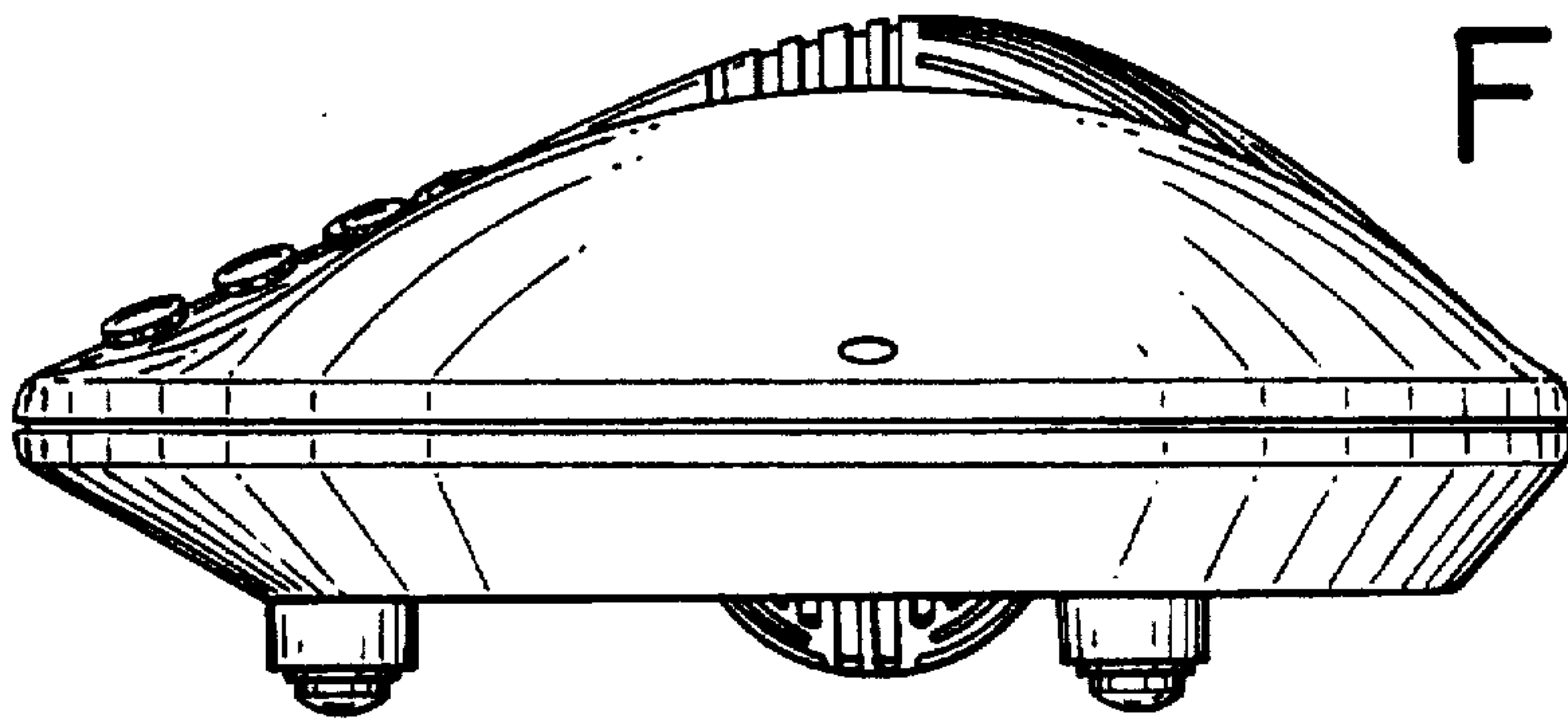
