[57] **CLAIM**

The ornamental design for a decorative basket with foam insert, as shown and described.

**DESCRIPTION**

FIG. 1 is an isometric view of a decorative basket with foam insert;

FIG. 2 is a front view thereof;

FIG. 3 is a rear view thereof;

FIG. 4 is a left side view thereof;

FIG. 5 is a right side view thereof;

FIG. 6 is a bottom view thereof;

FIG. 7 is a top plan view thereof;

FIG. 8 is an open top view showing foam insert;

FIG. 9 is a top view of foam insert removed from basket;

FIG. 10 is a bottom view of foam insert removed from basket;

FIG. 11 is a left side view of foam insert removed from basket, the right side being a mirror image of the side shown; and,

FIG. 12 is a front view of foam insert removed from basket, the back side being a mirror image of the side shown.

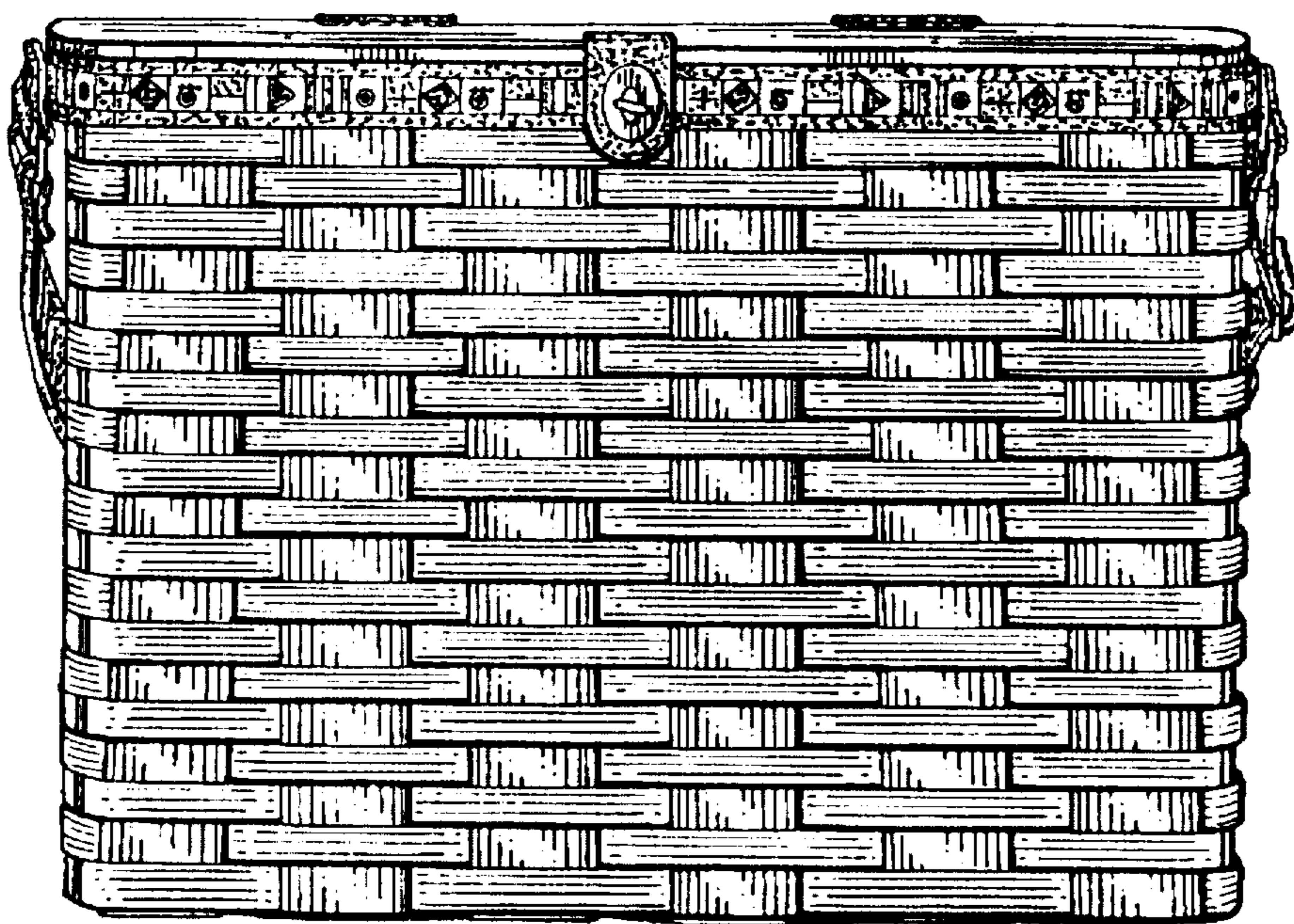

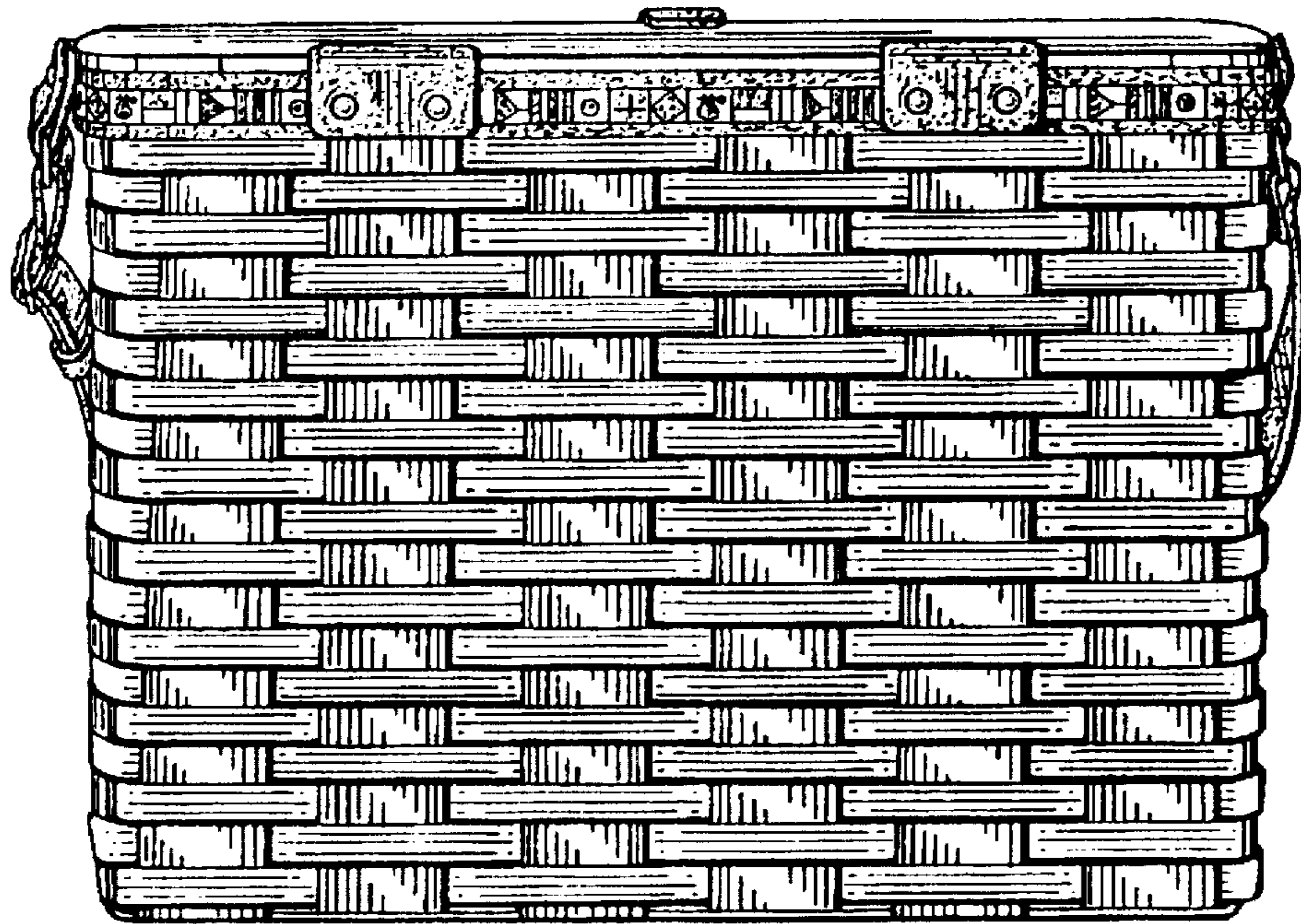

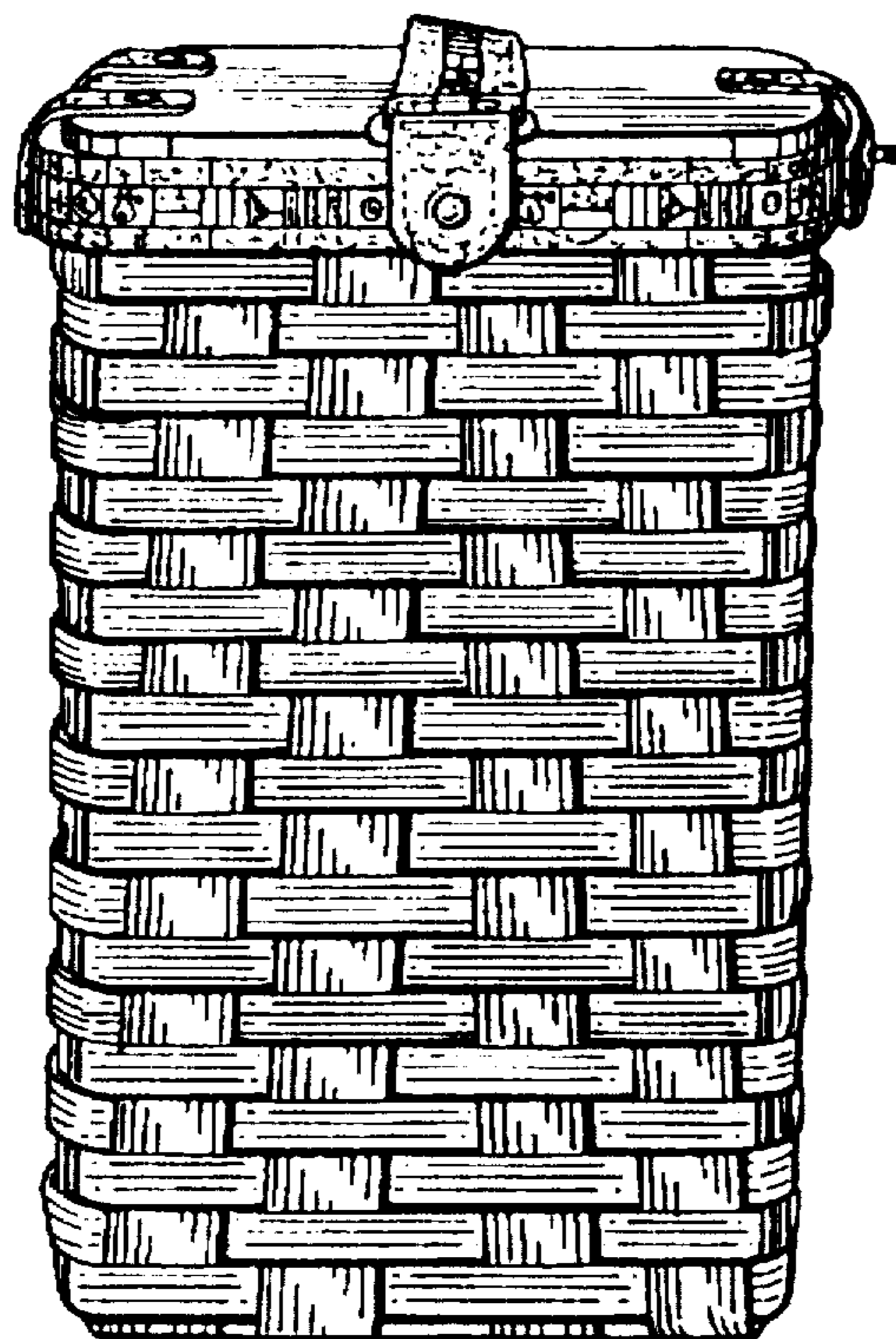

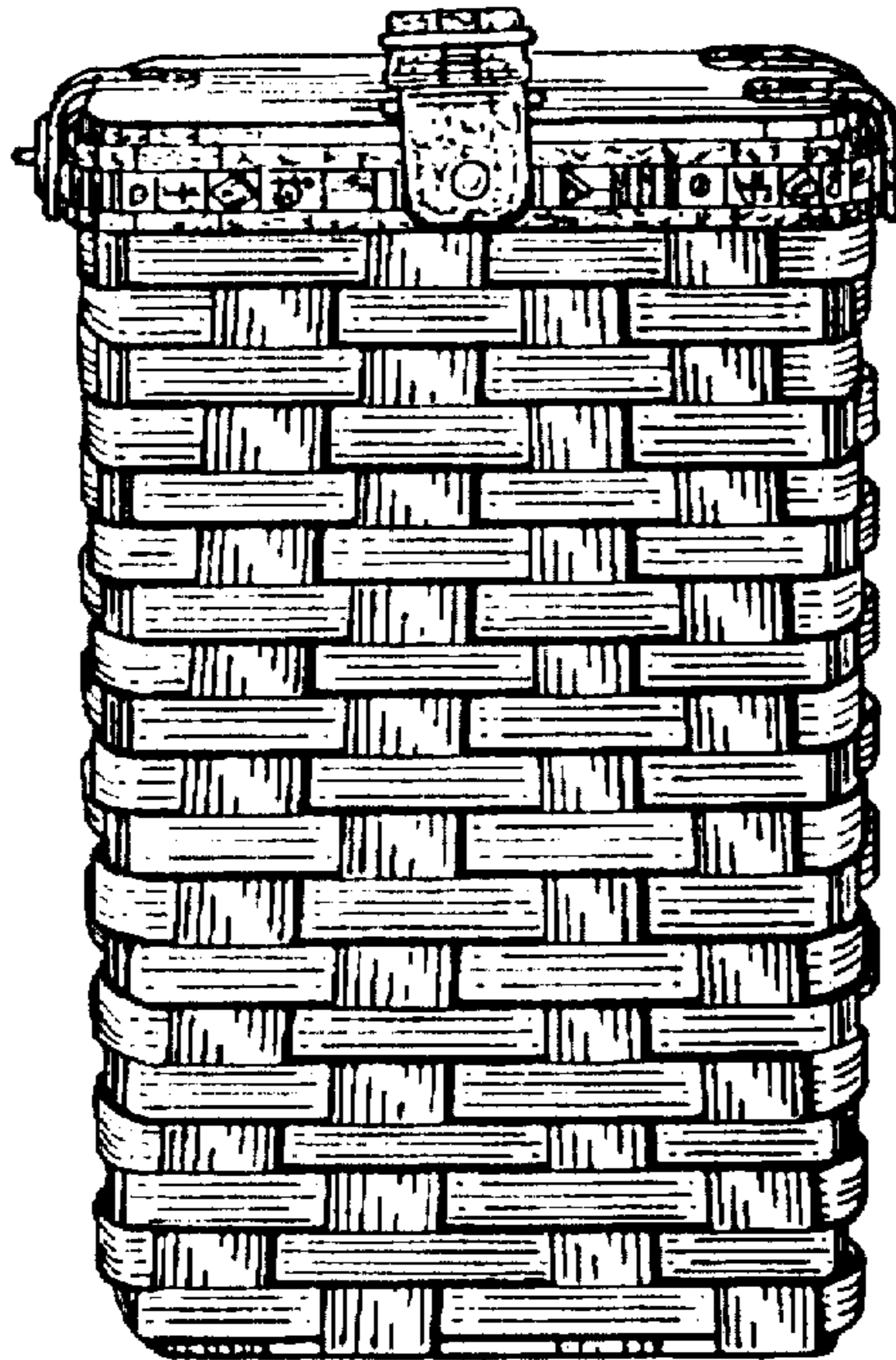

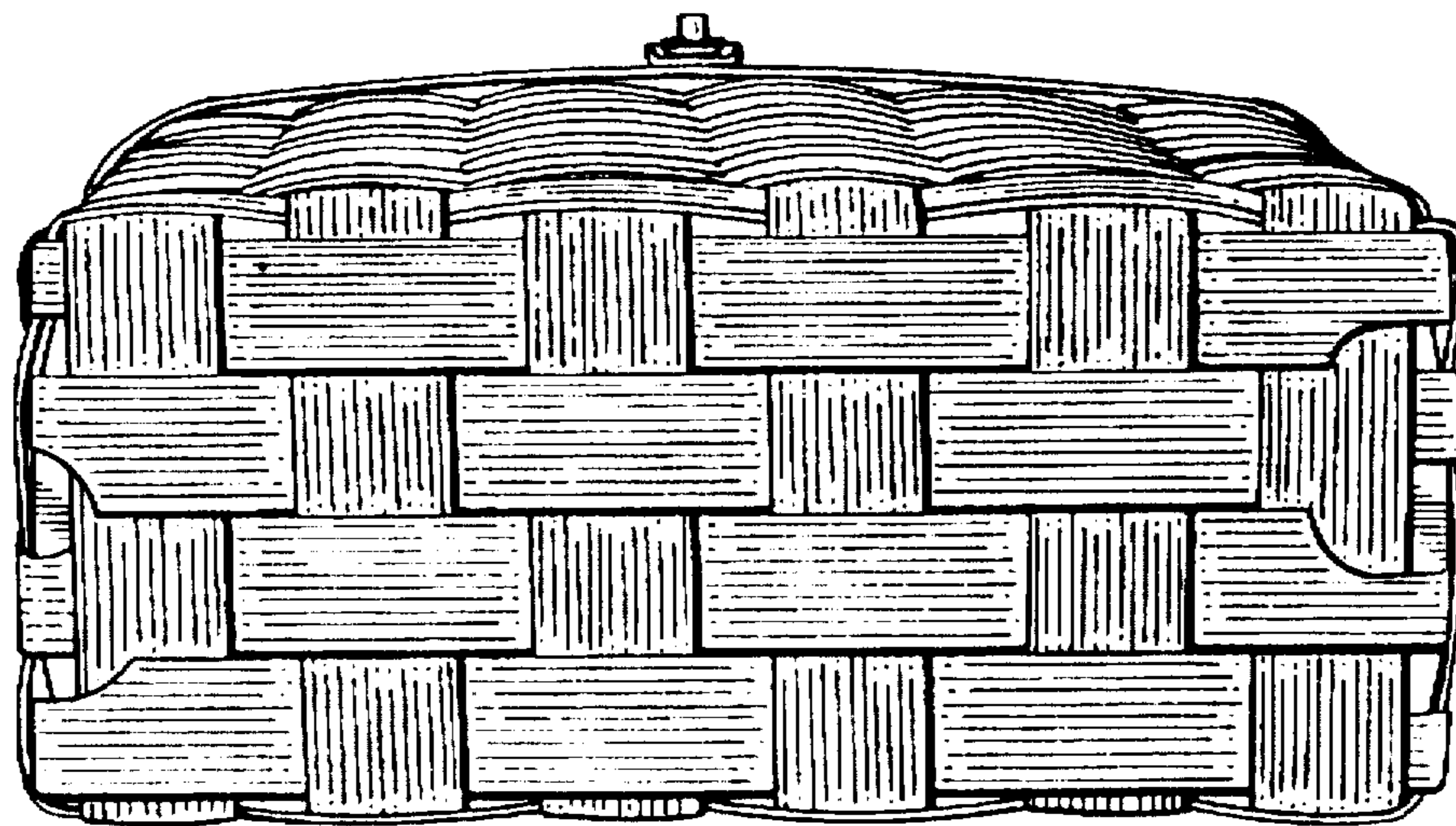

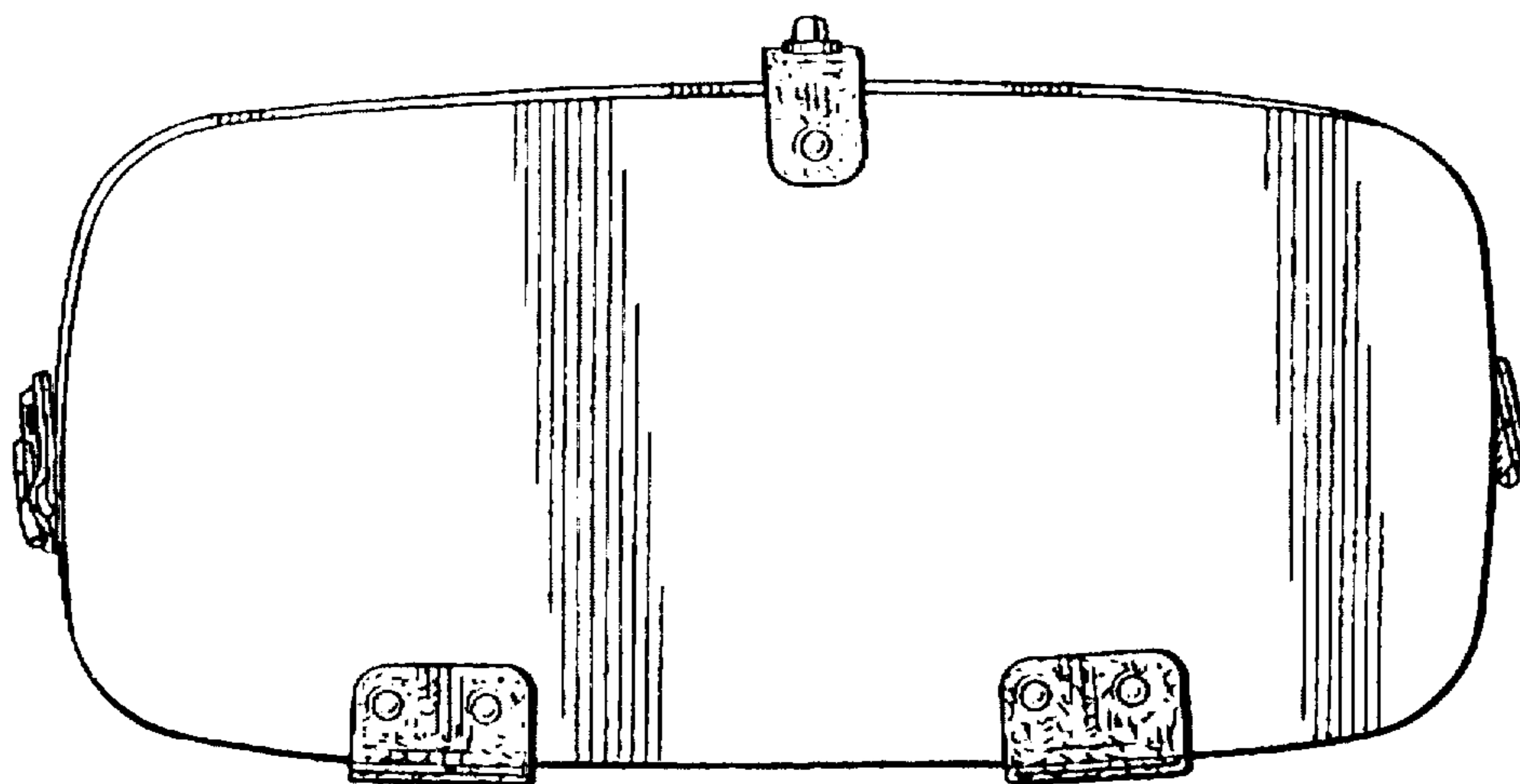

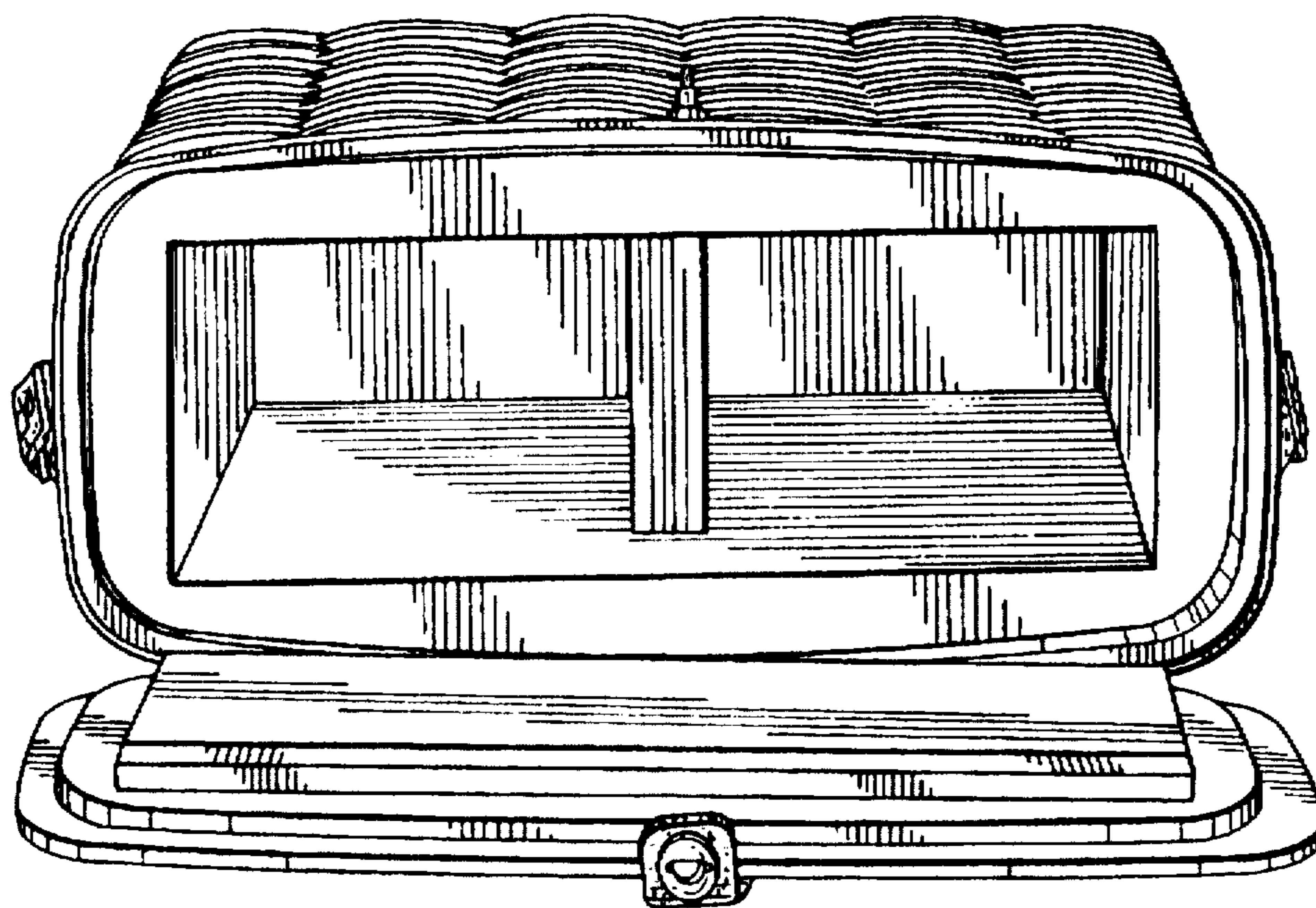

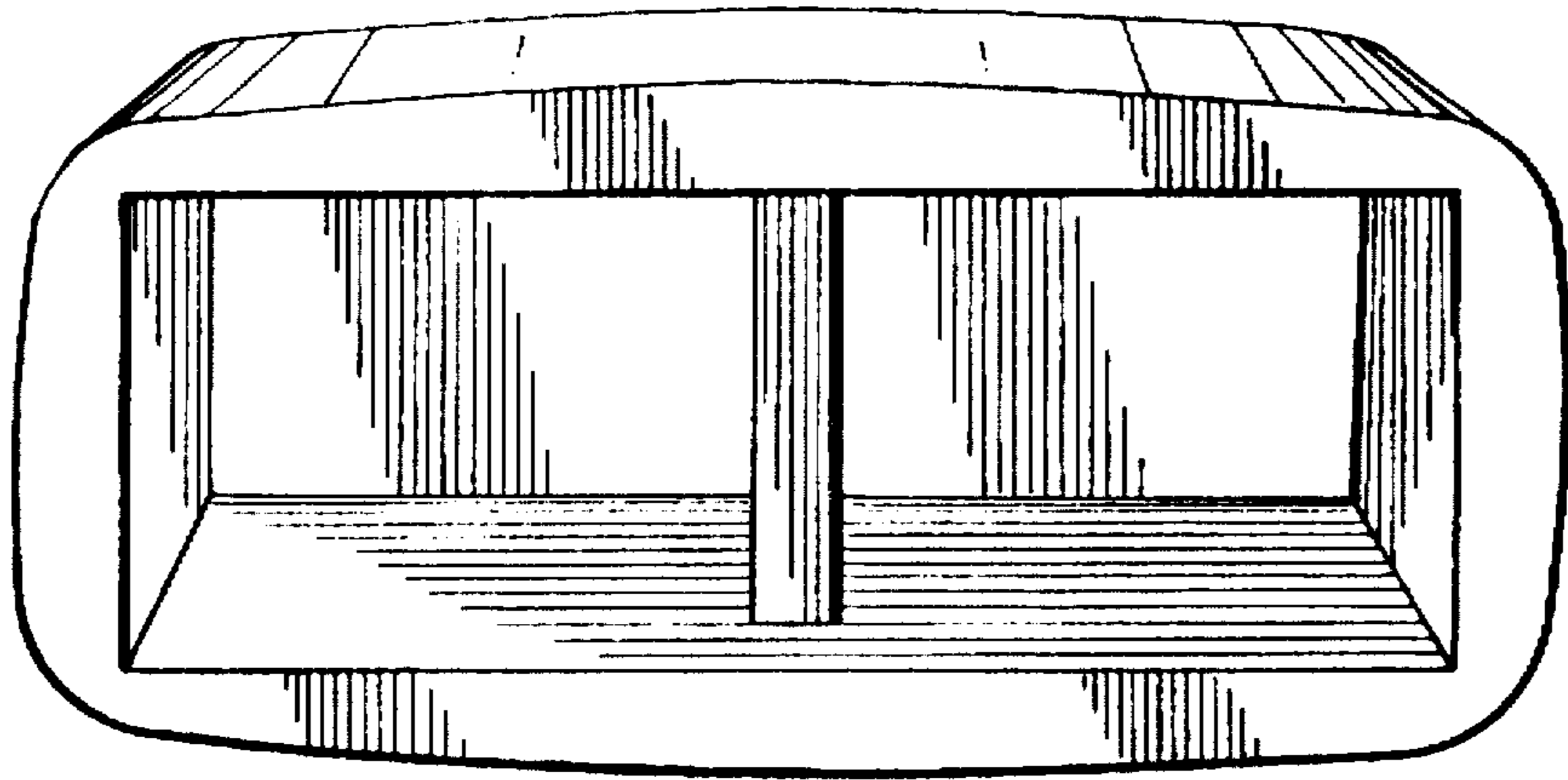

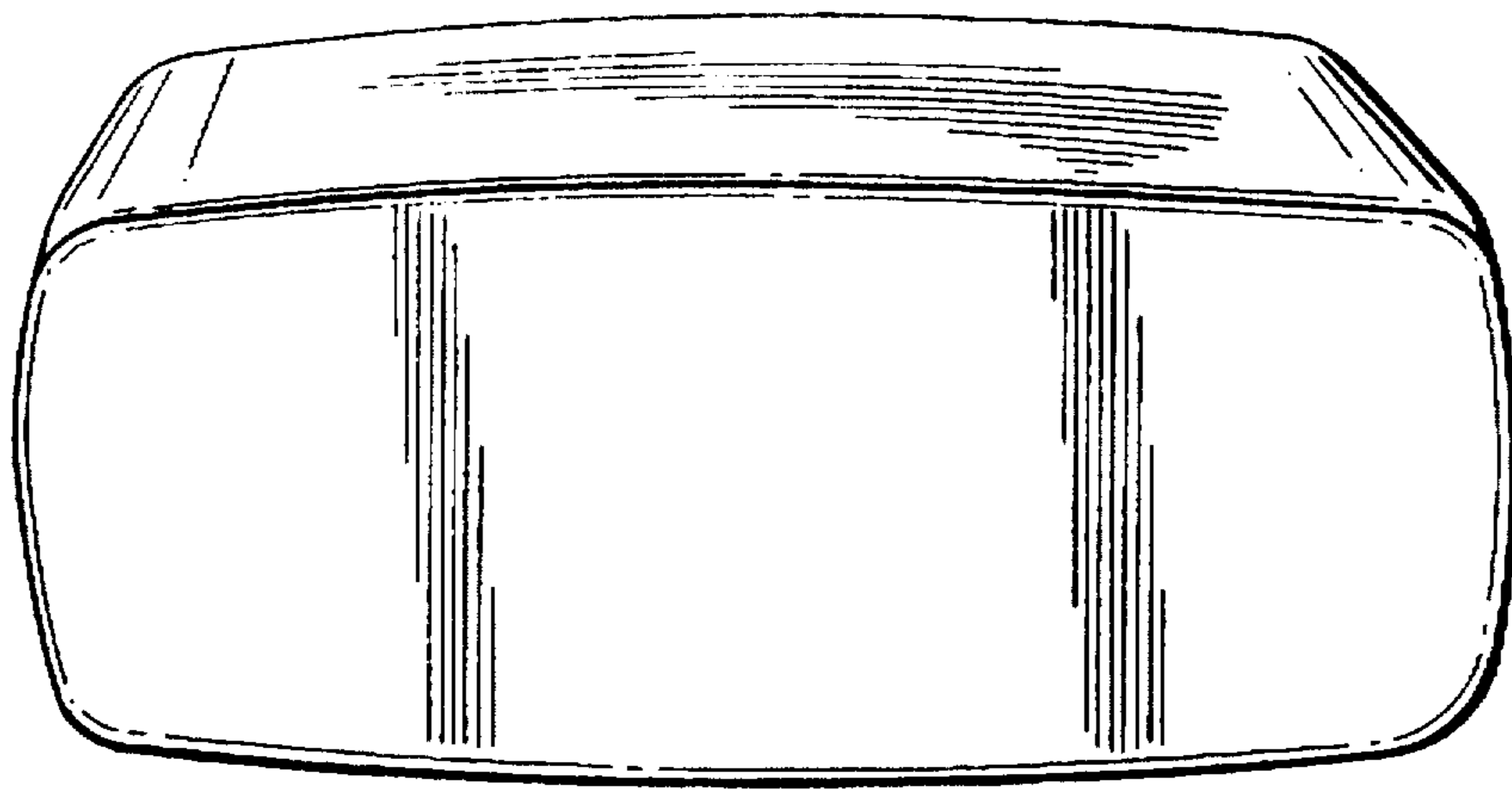

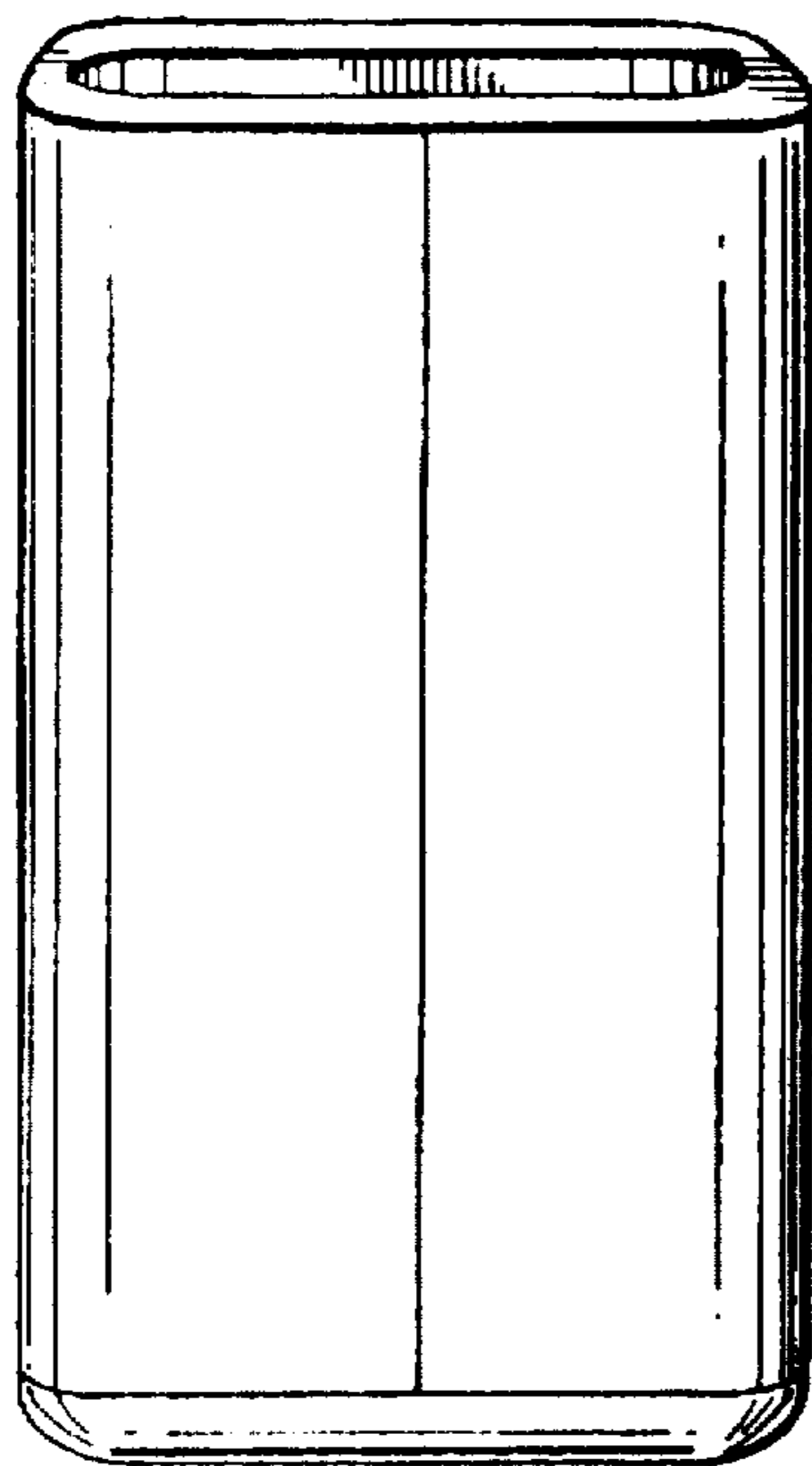

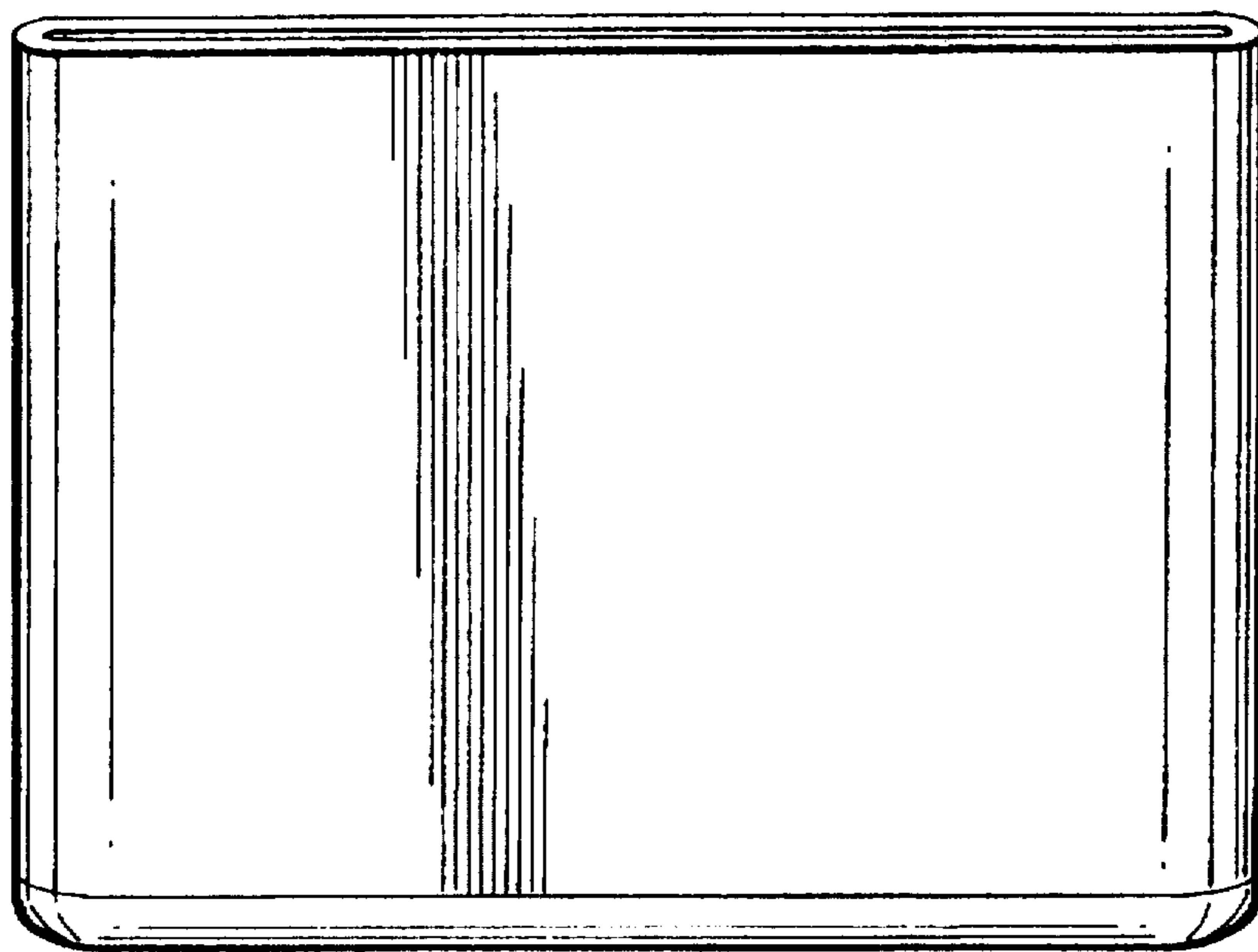
