[57] **CLAIM**

The ornamental design for a seat, as shown and described.

DESCRIPTION

FIG. 1 is a front left perspective view of a seat showing my
new design;

FIG. 2 is a rear partial perspective view looking at the rear
upper left corner thereof;

FIG. 3 is a front view thereof;

FIG. 4 is a top view thereof;

FIG. 5 is a side view, the opposite side being a mirror image
of the side shown;

FIG. 6 is a rear view thereof;

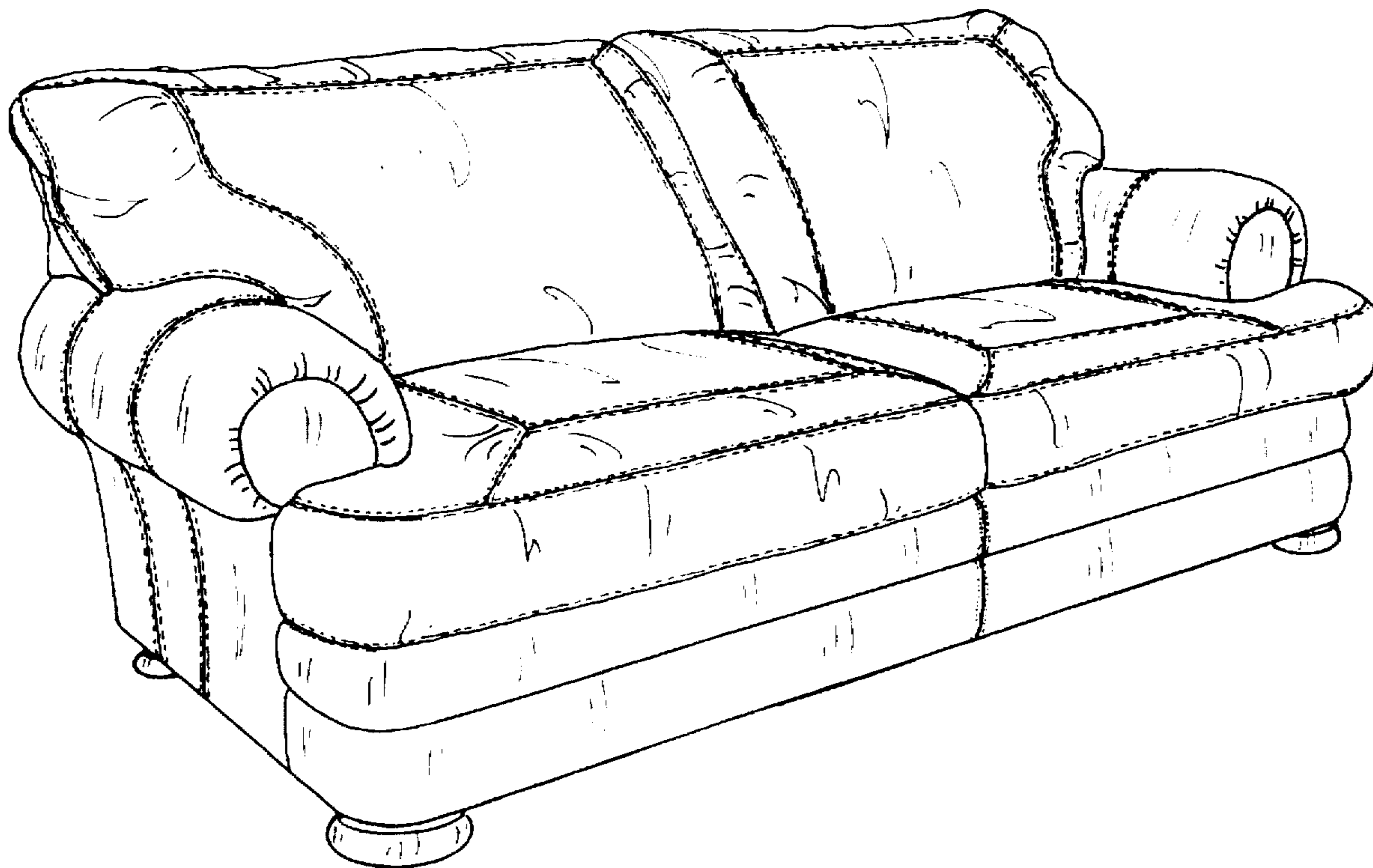
FIG. 7 is an enlarged partial front view of one end thereof,
the opposite end being a mirror image of the end shown;

FIG. 8 is an enlarged partial front view showing the upper
central portion of the rear cushions illustrating a stitching
pattern thereon; and,

FIG. 9 is a top/rear partial perspective view illustrating the
upper central portion of the rear cushions and rear wall.

The broken lines shown in the above views represent
stitching.

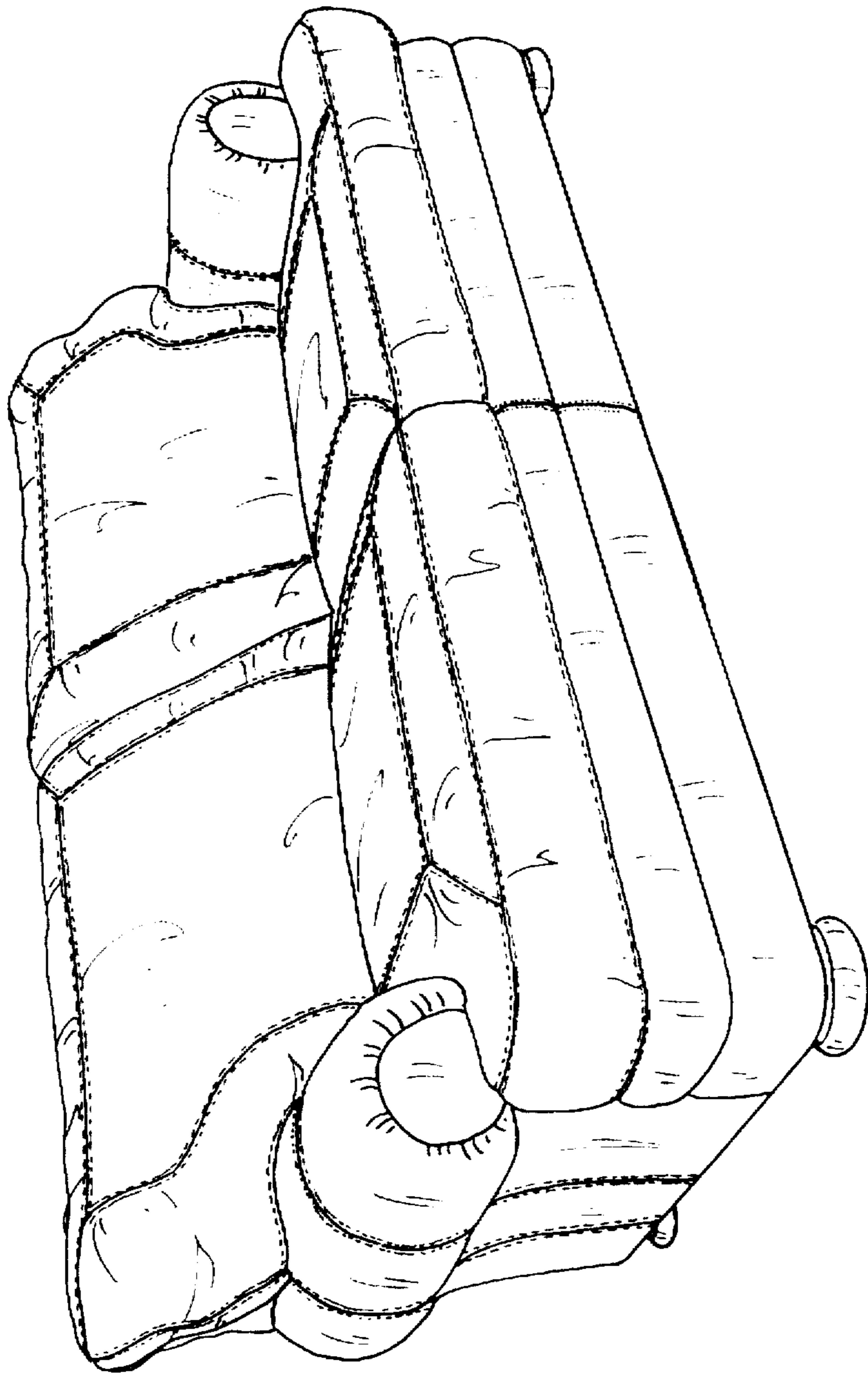

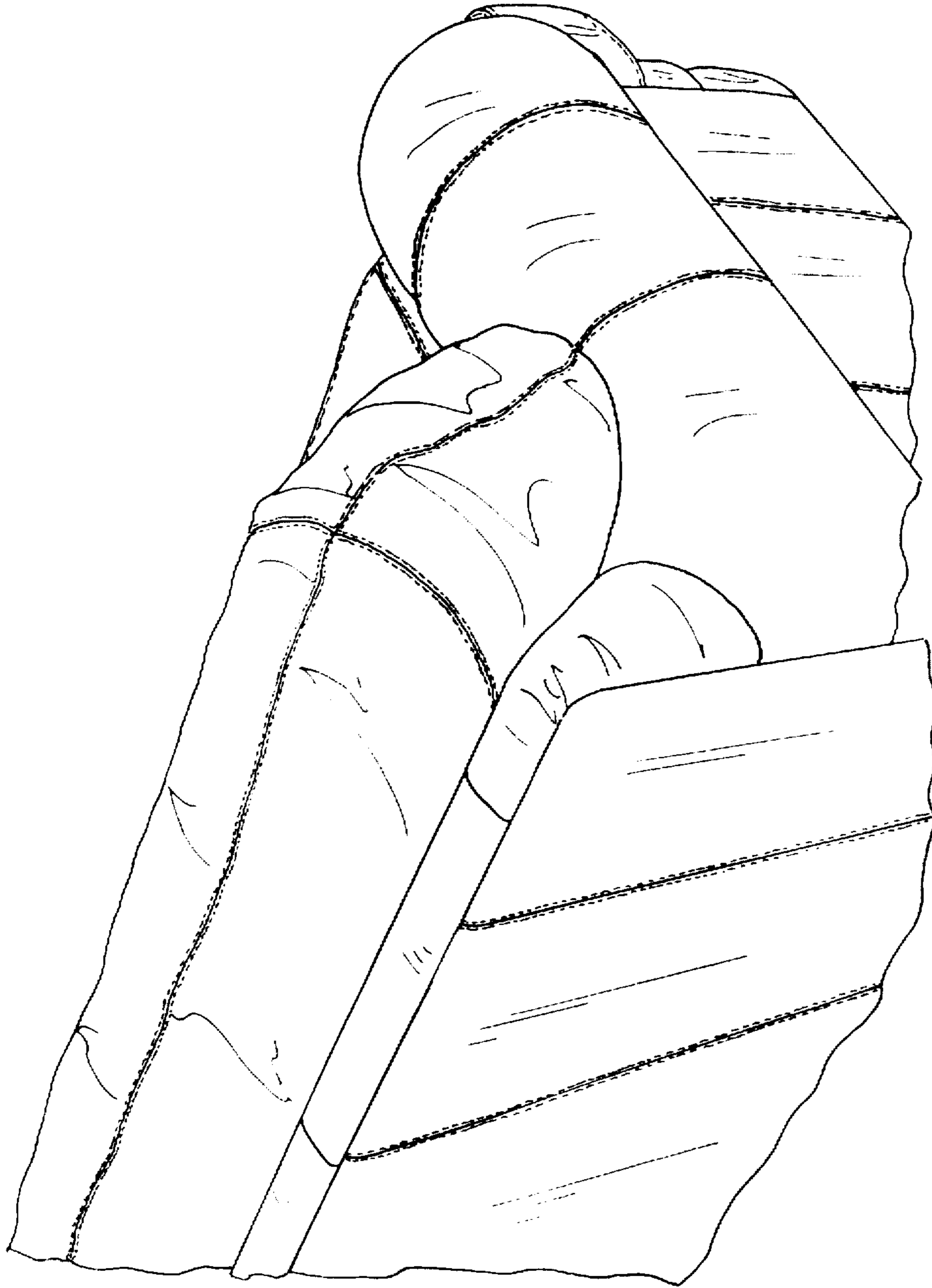

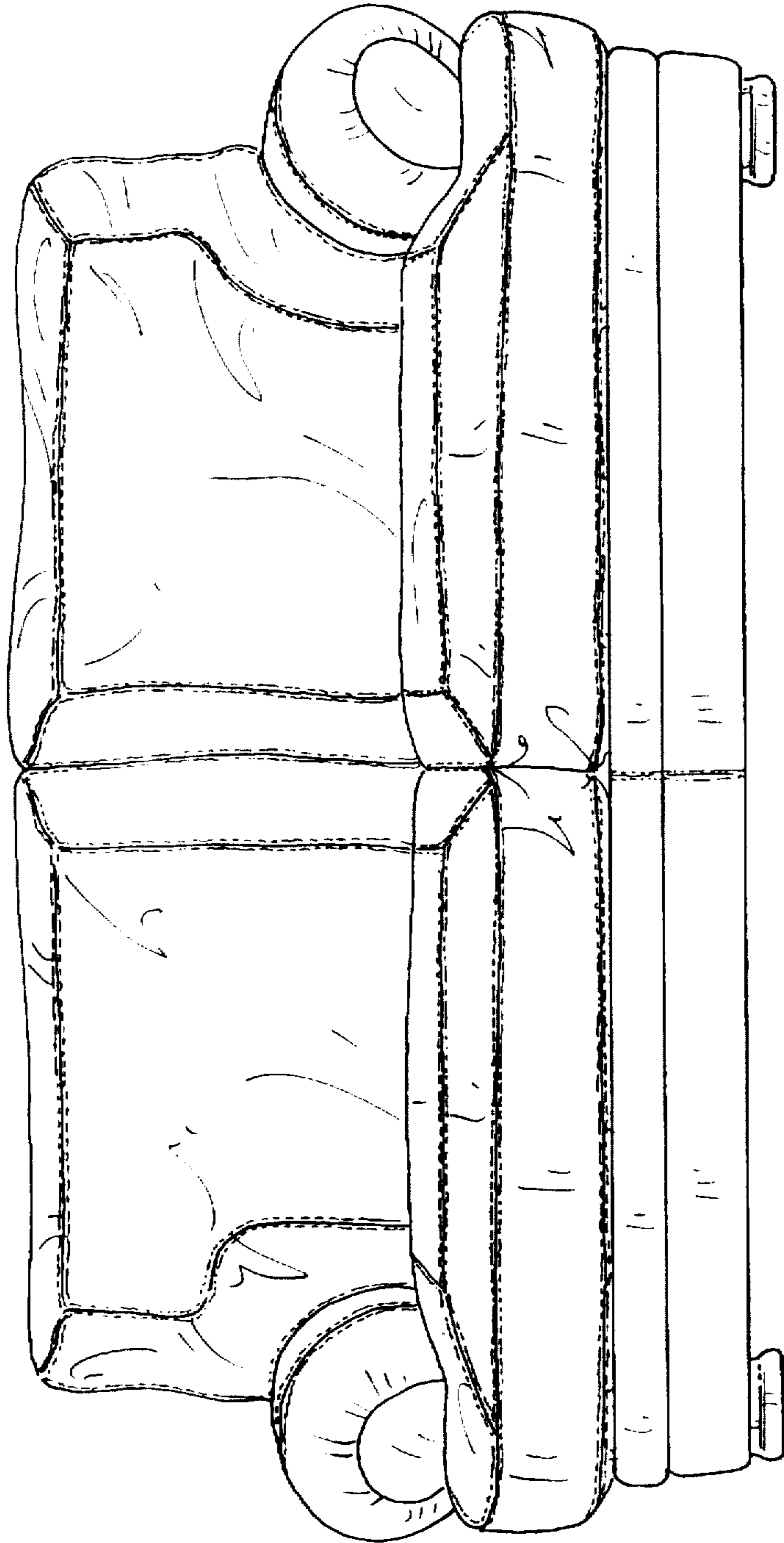

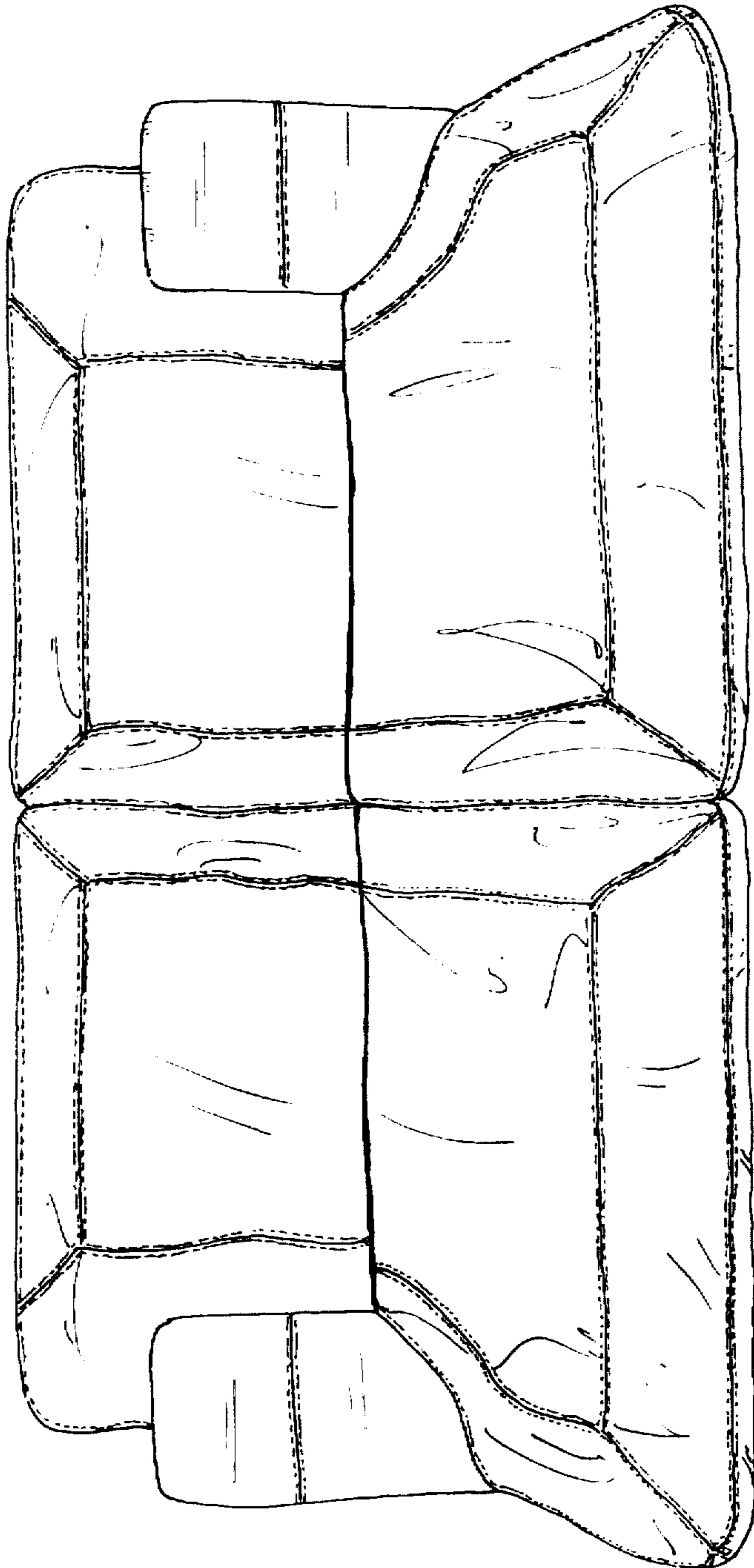

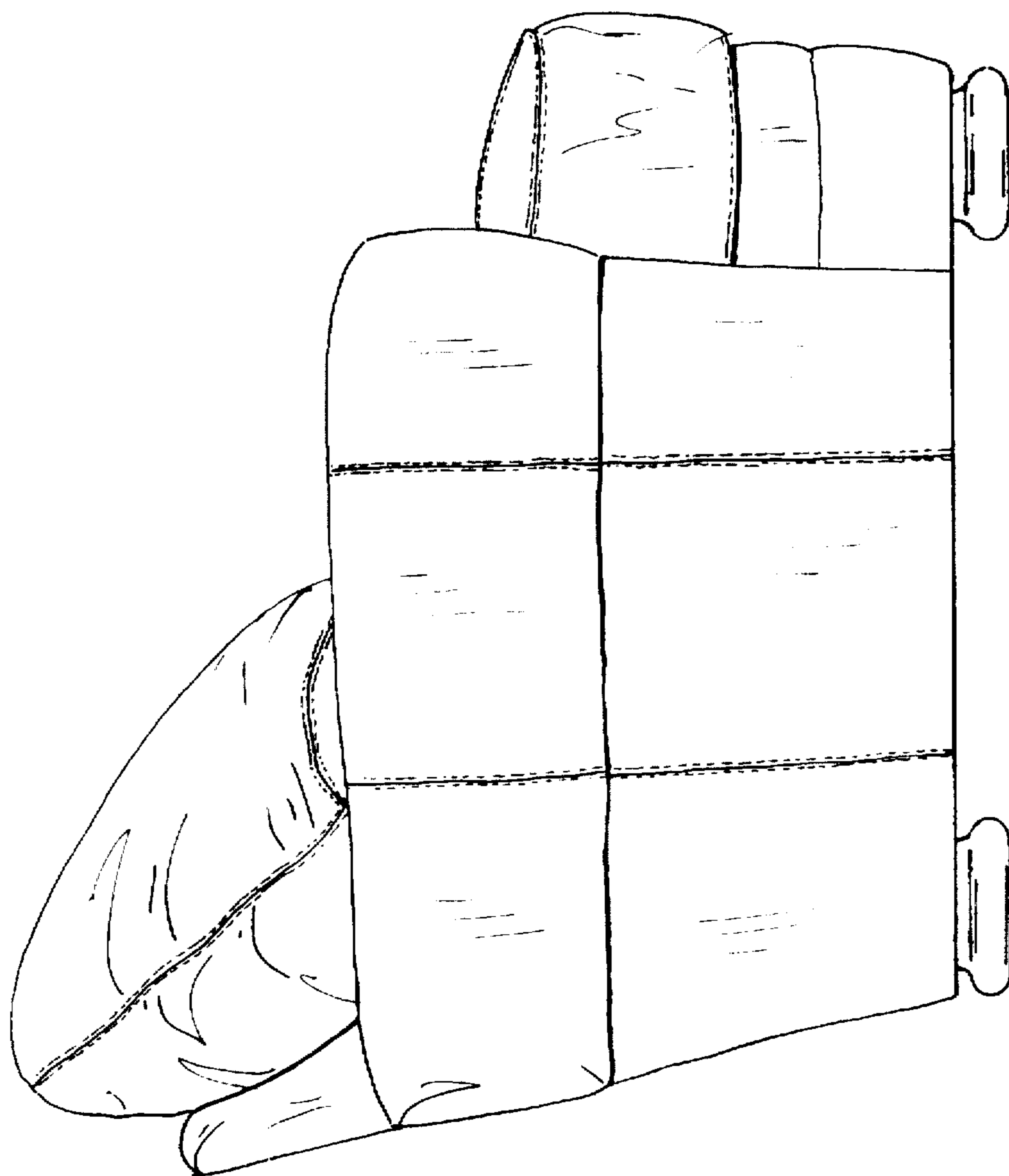

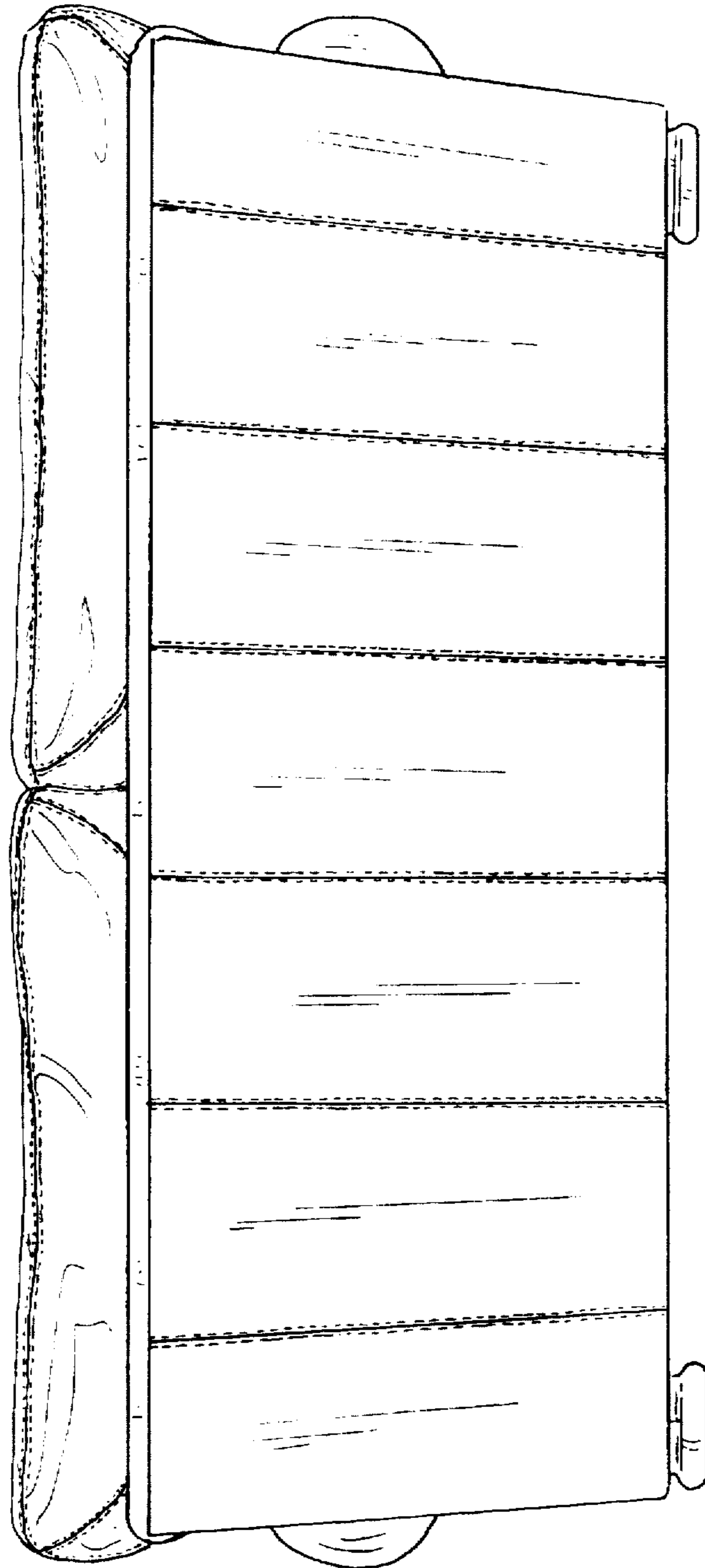

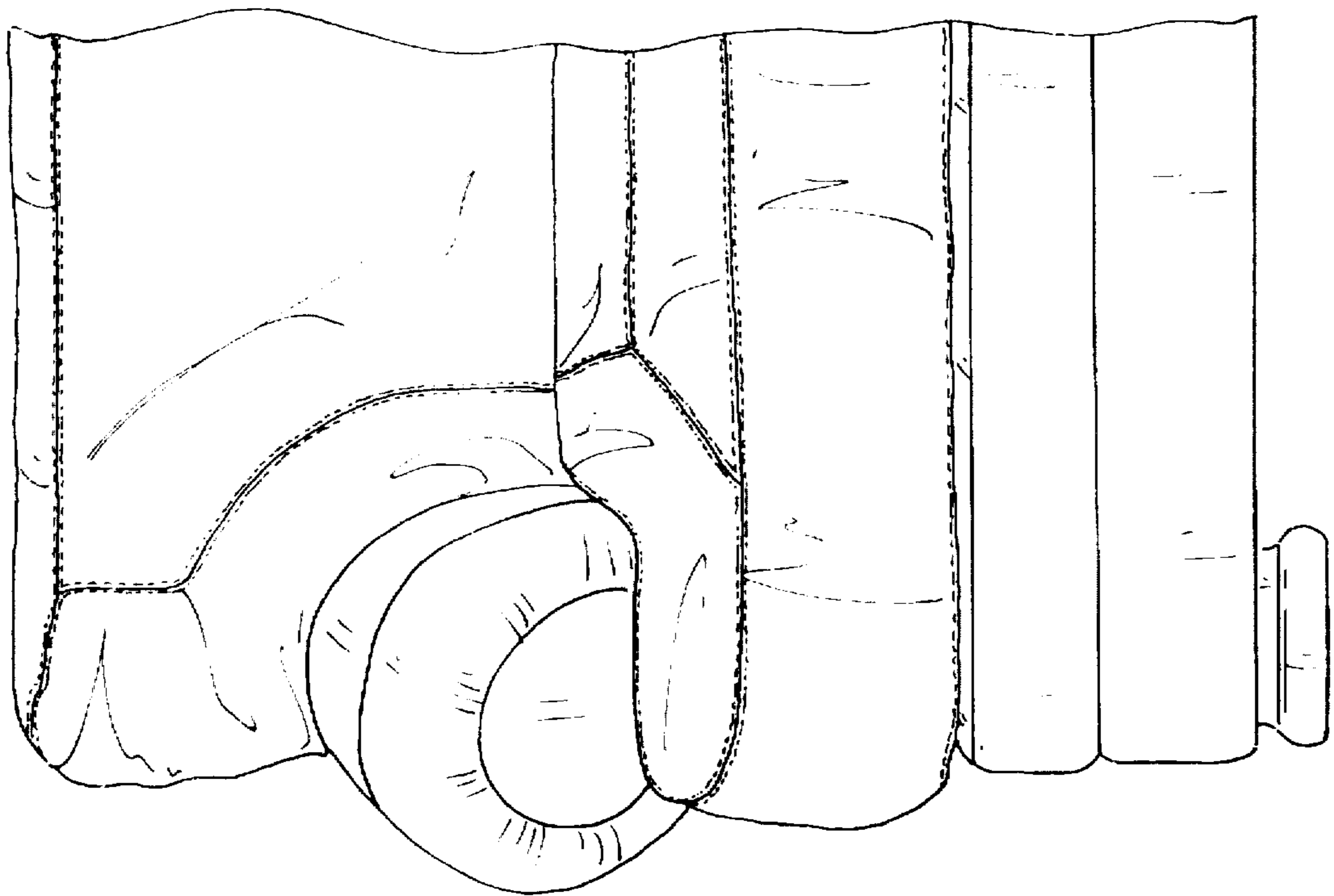

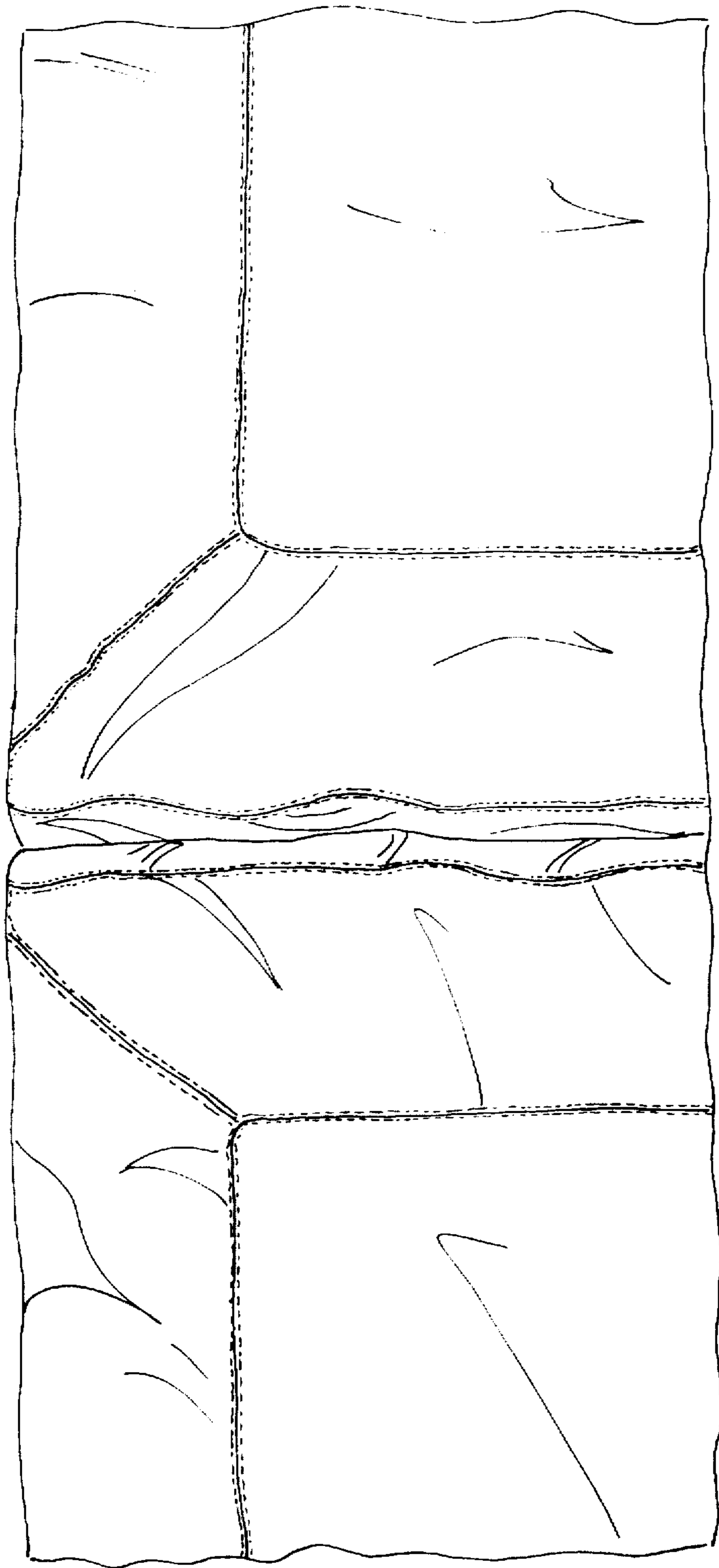

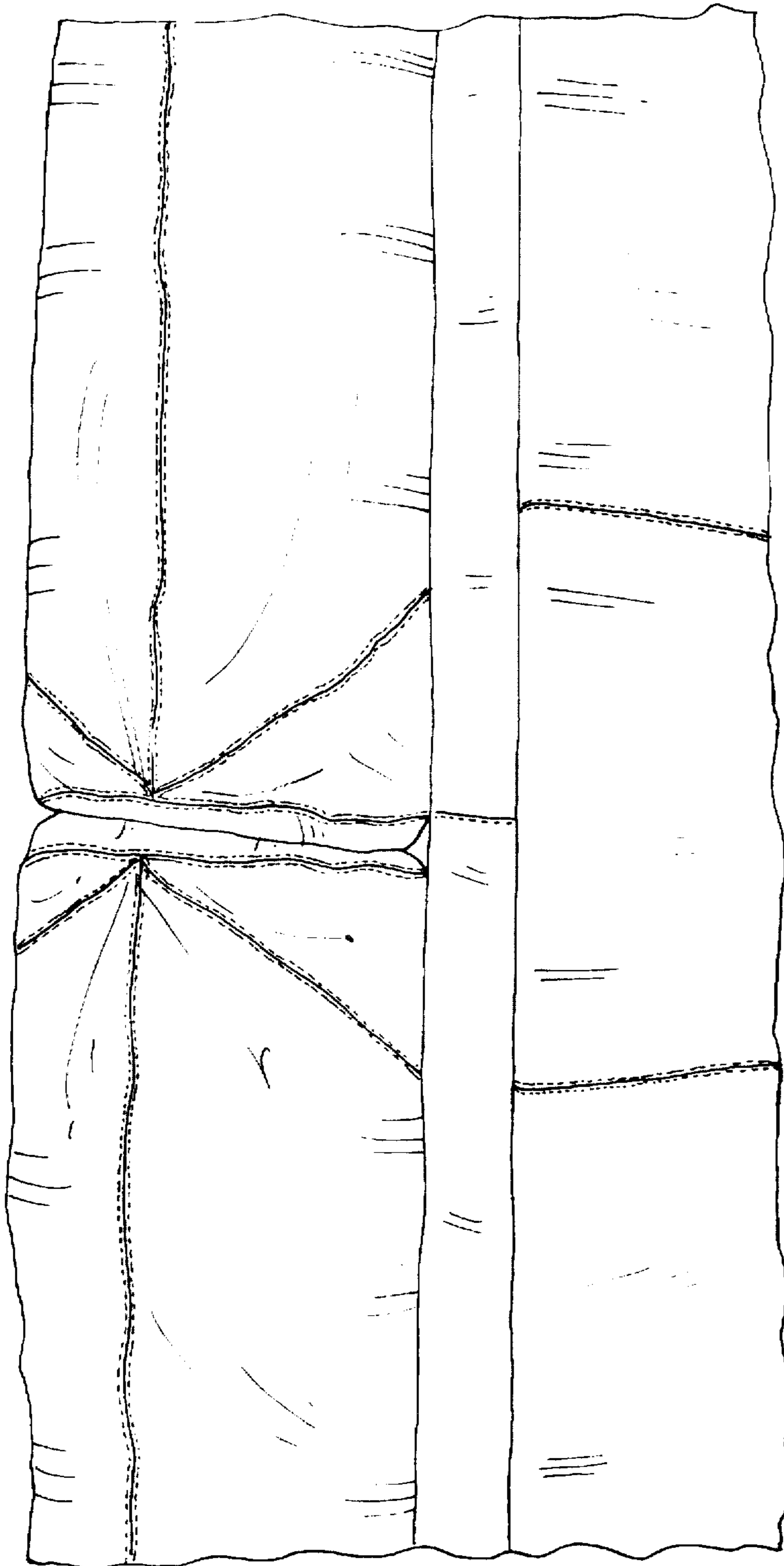
