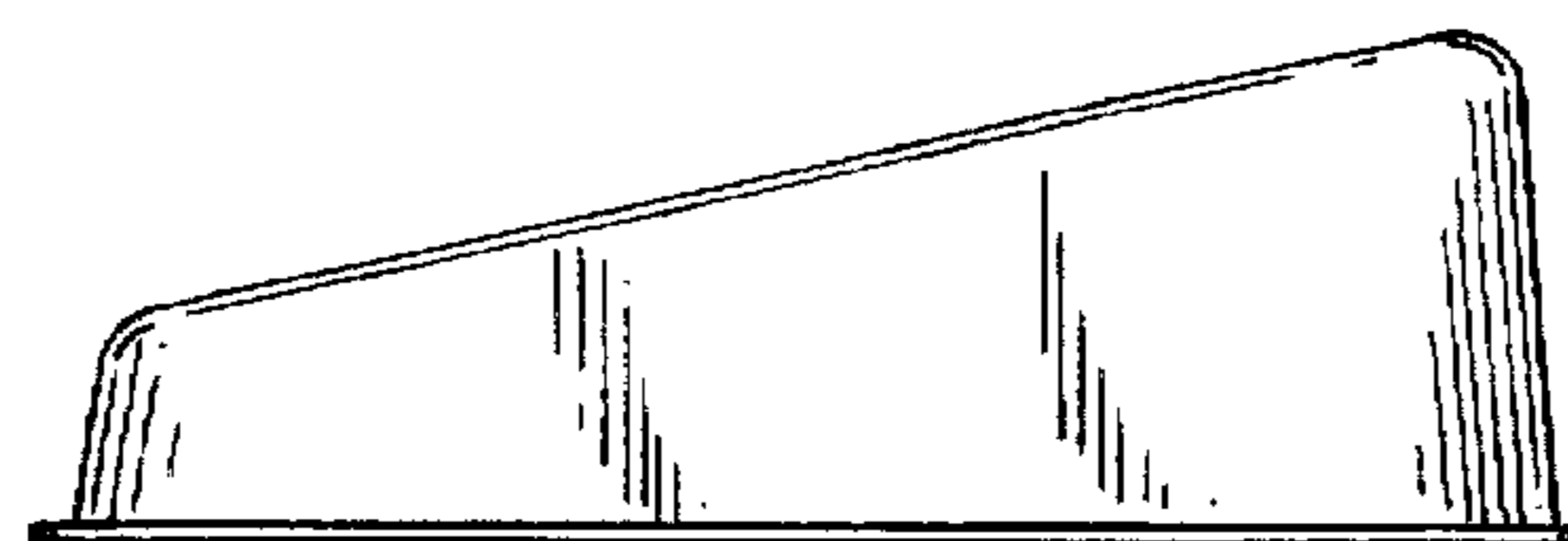
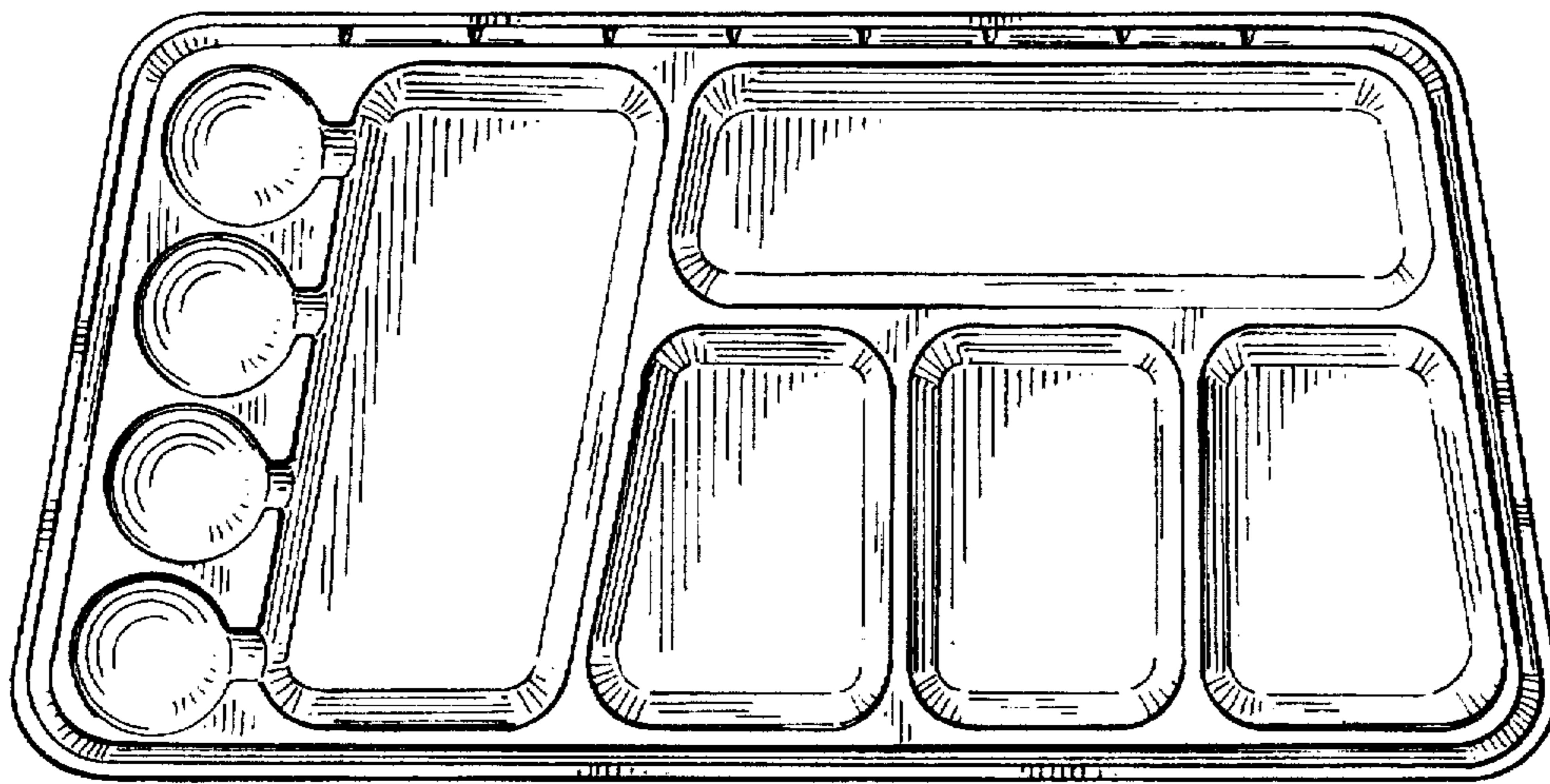
[57] **CLAIM**

The ornamental design for a golf cart organizer, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a golf cart organizer showing our new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a bottom plan view thereof;
FIG. 4 is a rear elevational view thereof; and,
FIG. 5 is a left side elevational view, the right side elevational view being a mirror image thereof.

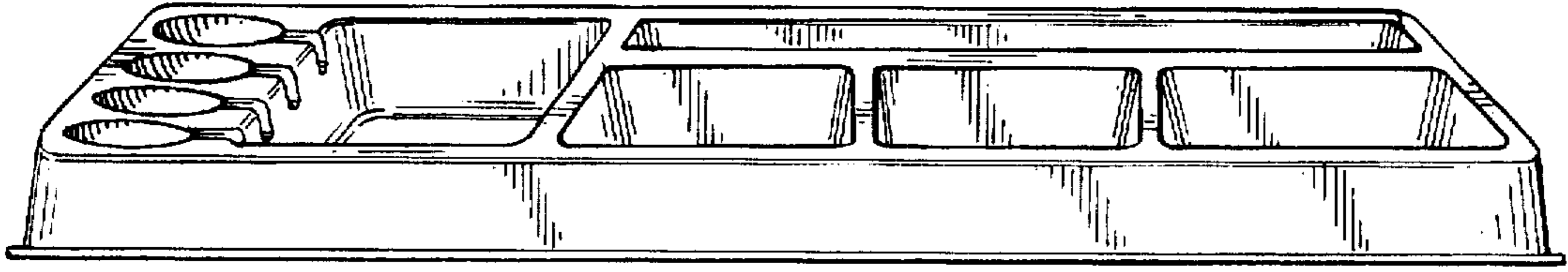

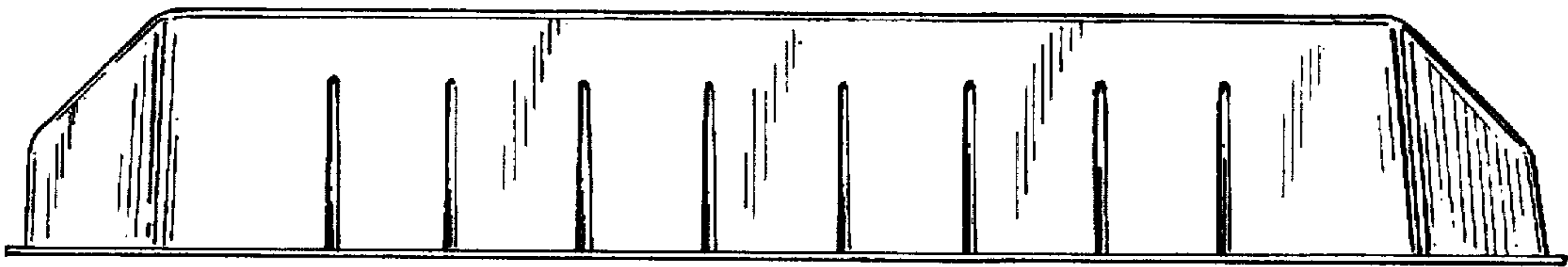

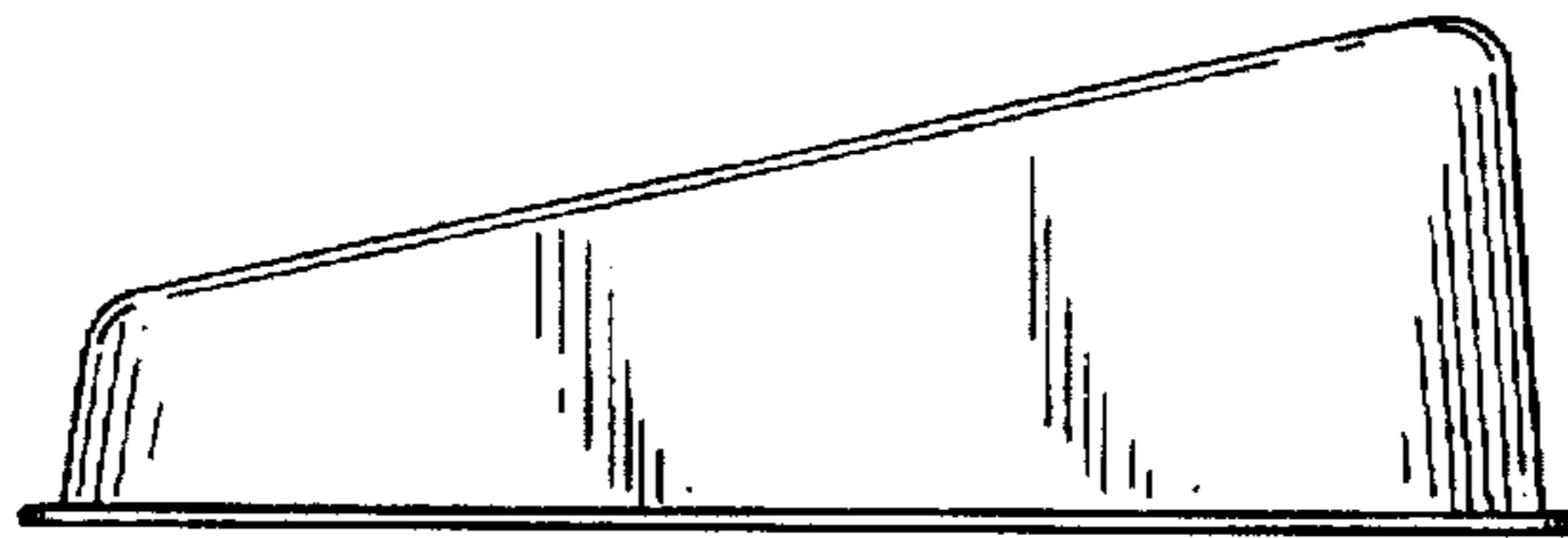

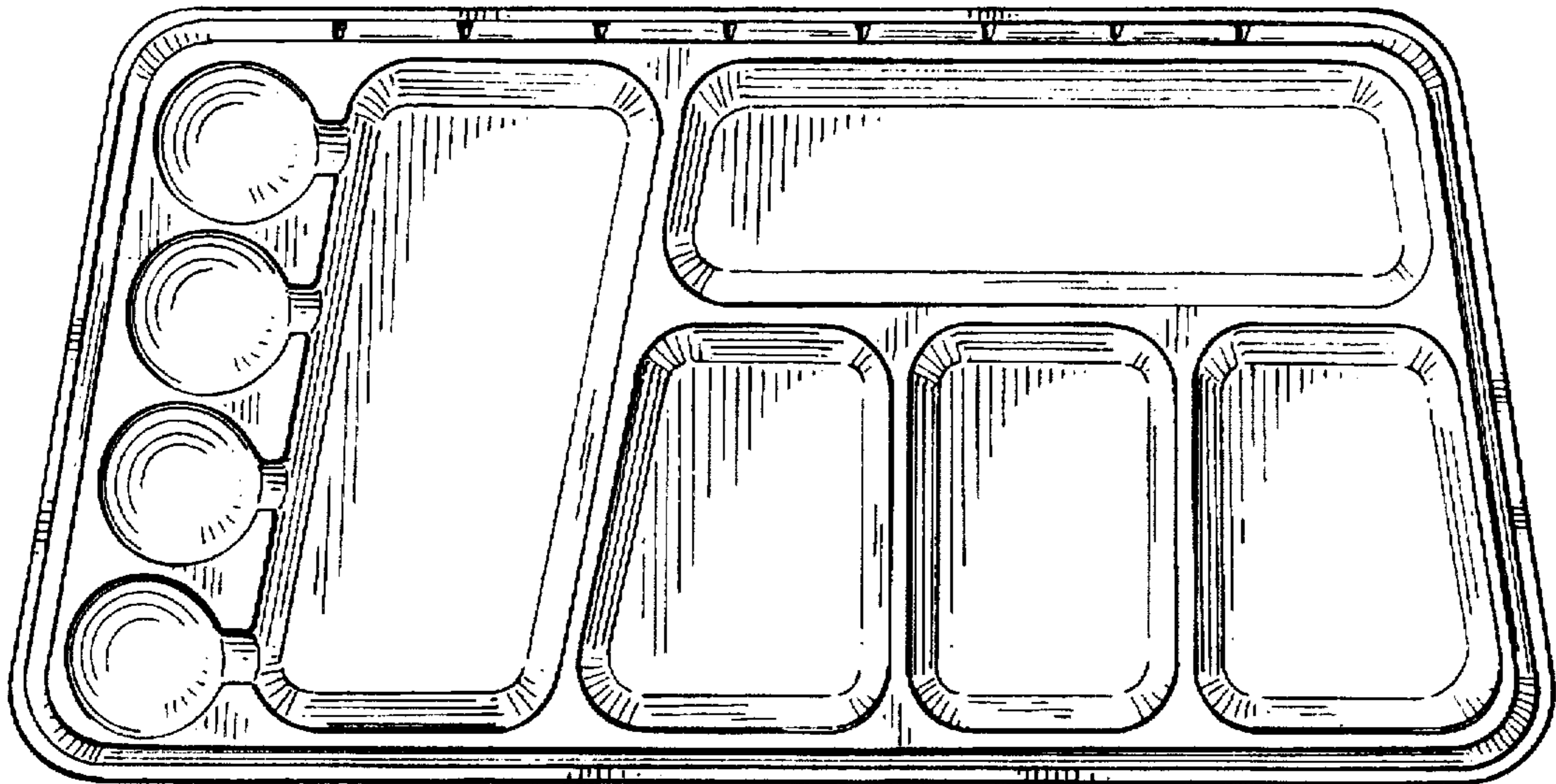

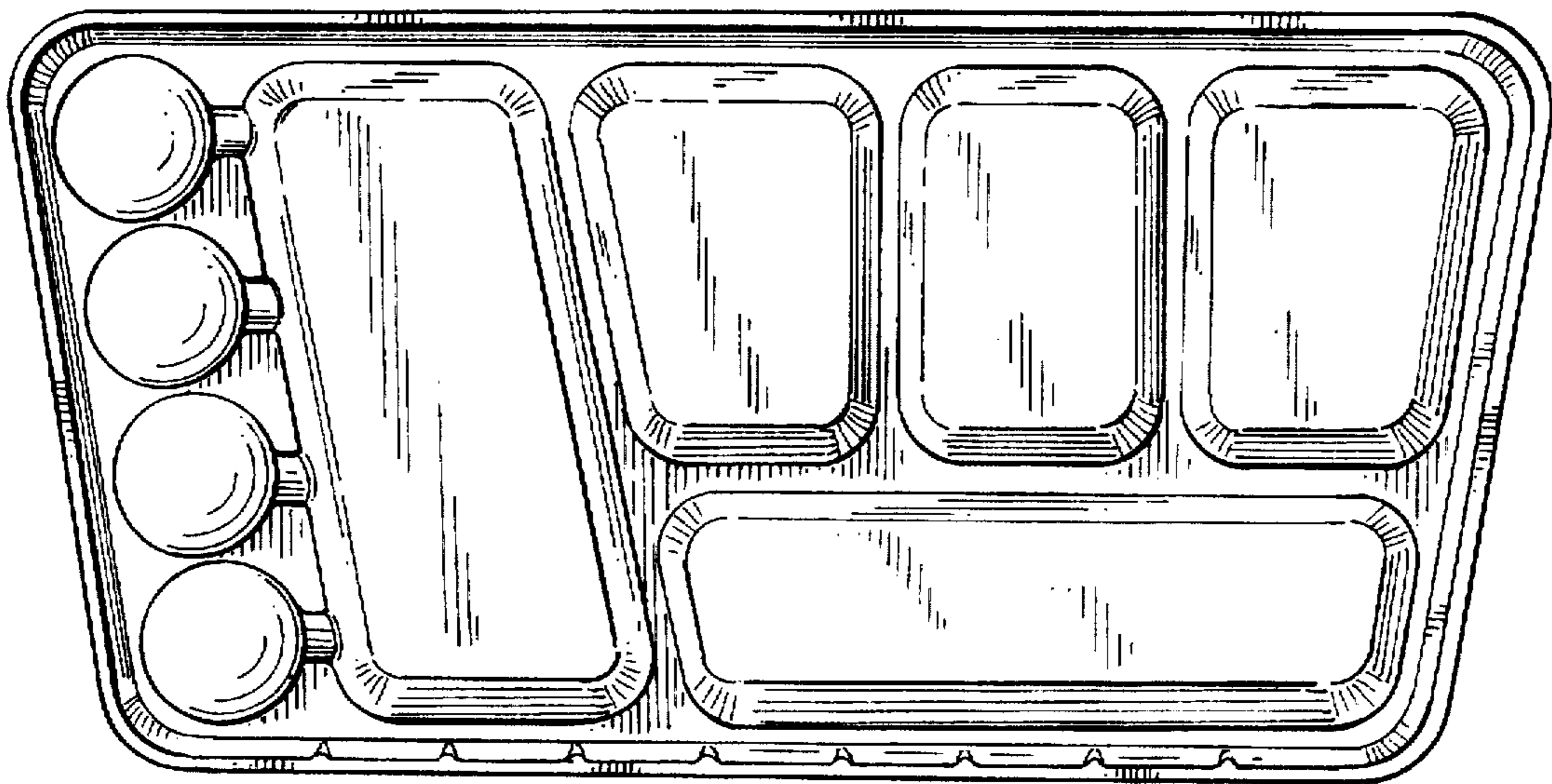
