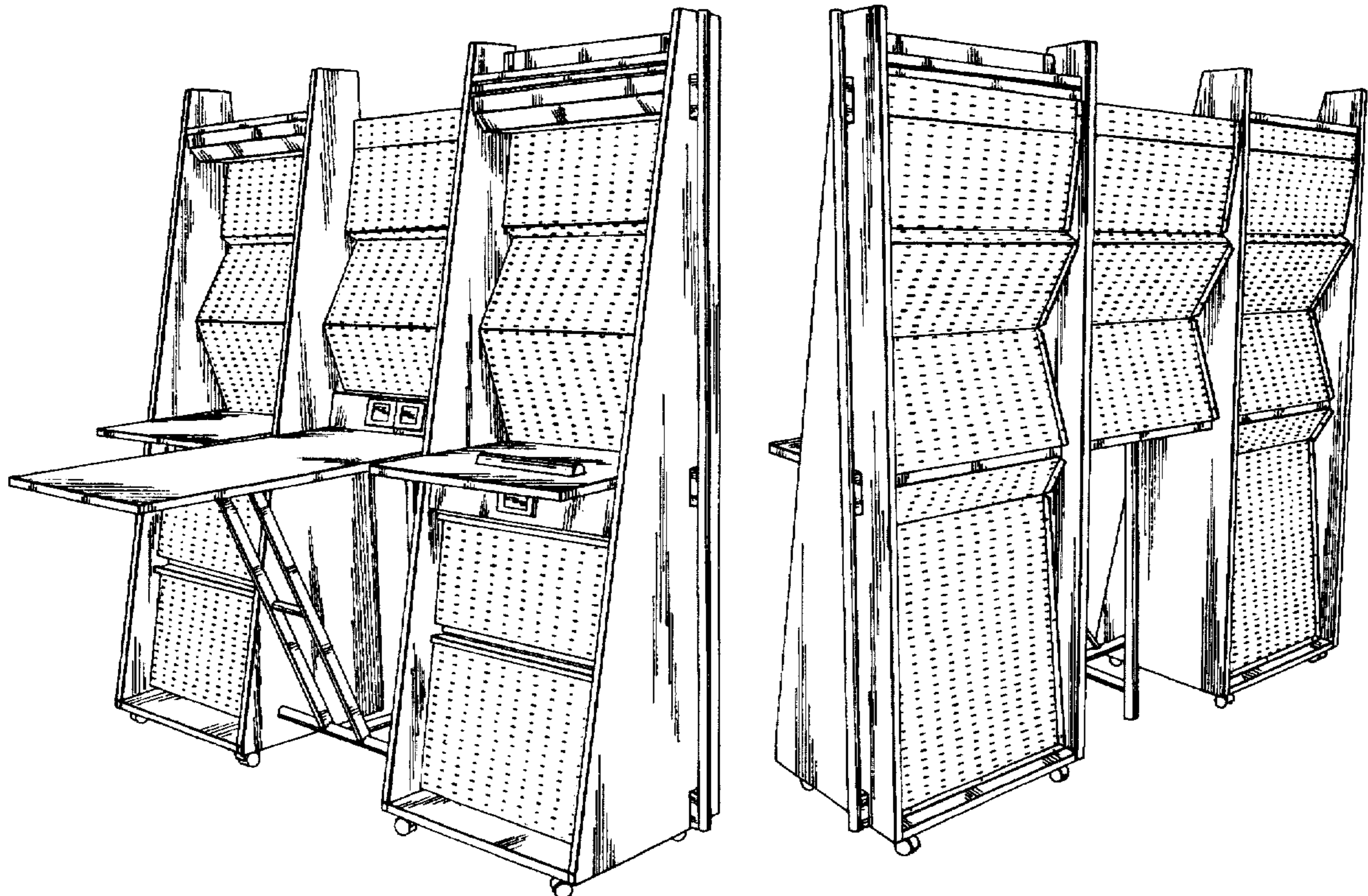
### [57] CLAIM

### DESCRIPTION

FIG. 1 is a front perspective view of a display stand embodying our new and ornamental design;

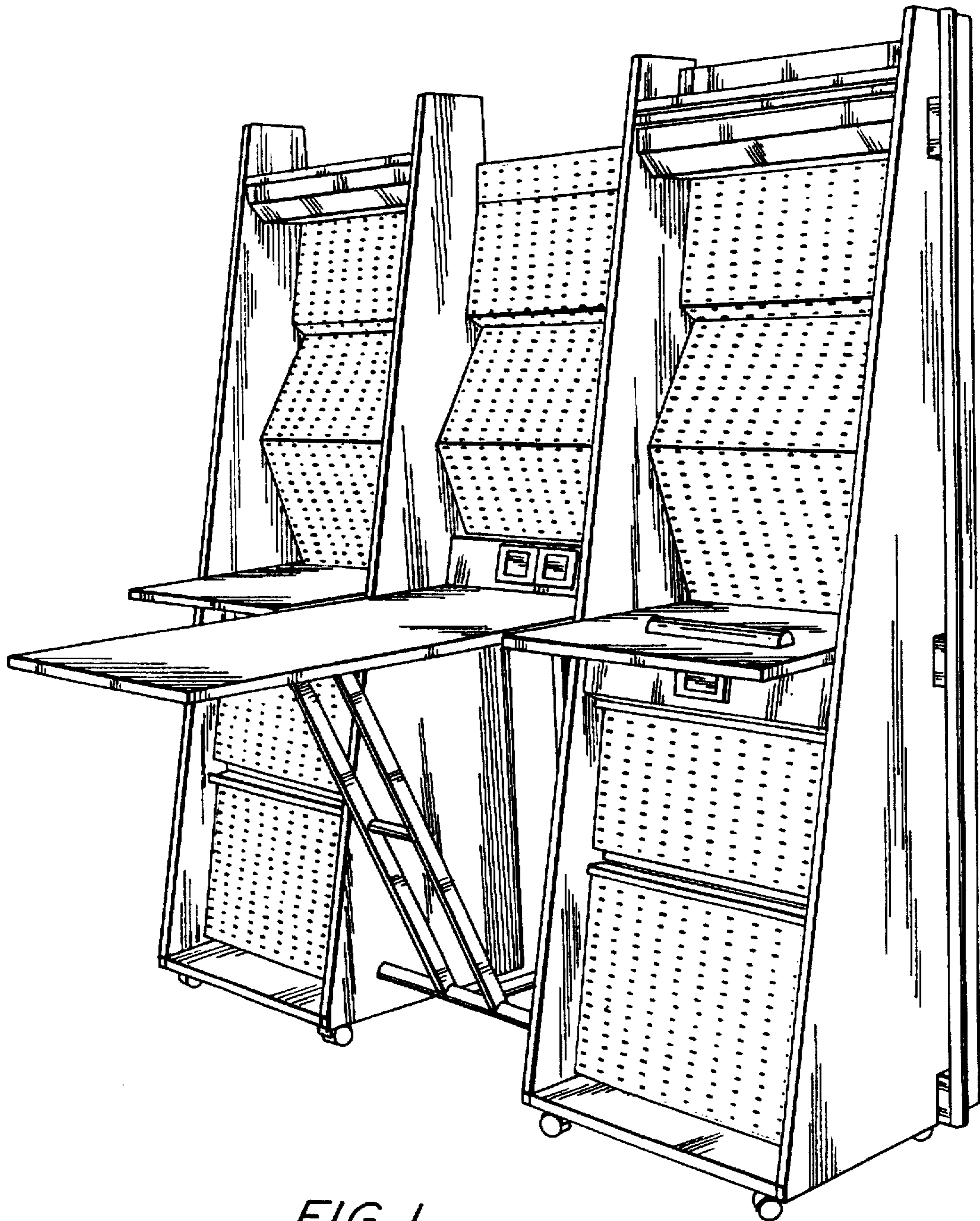

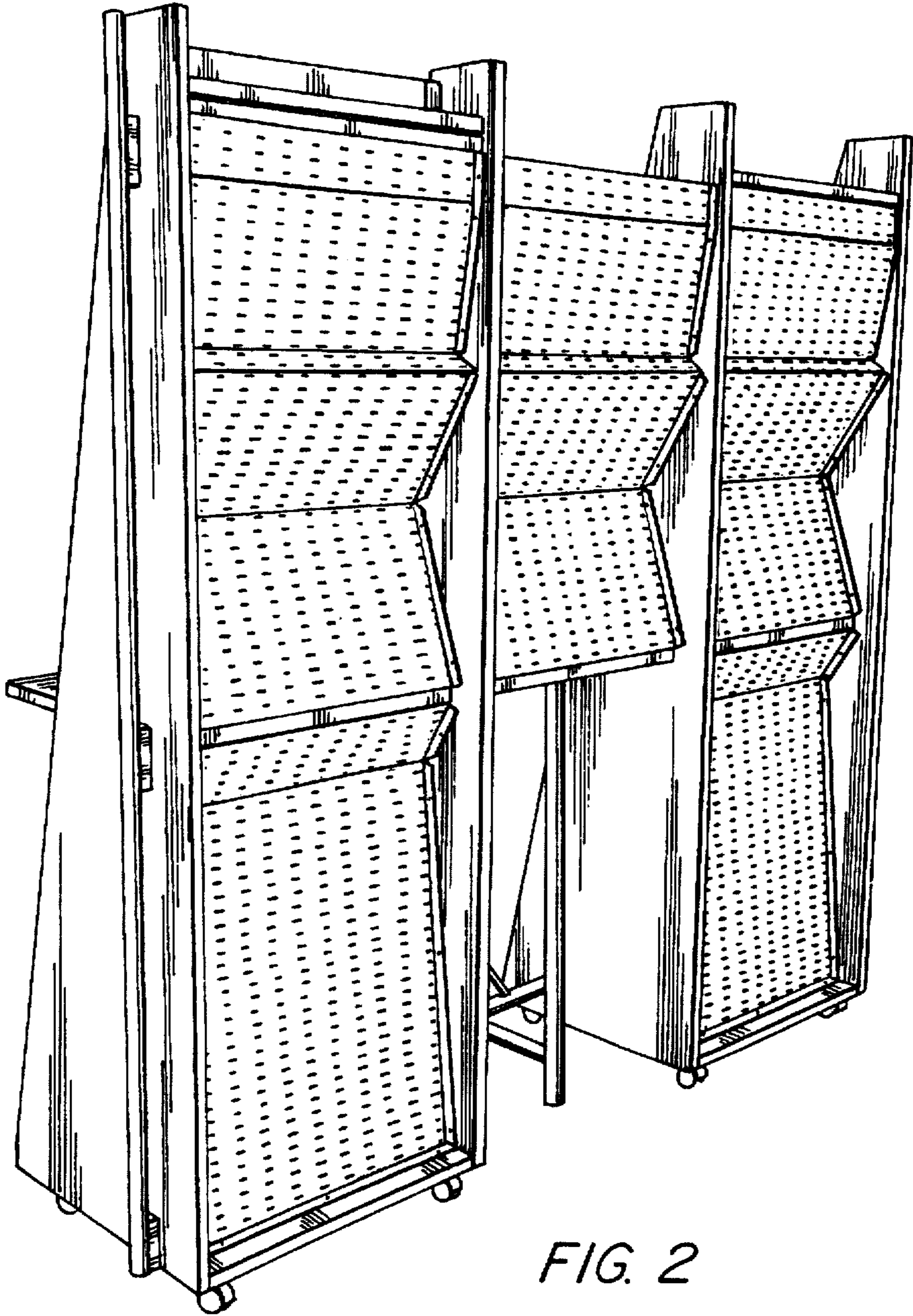

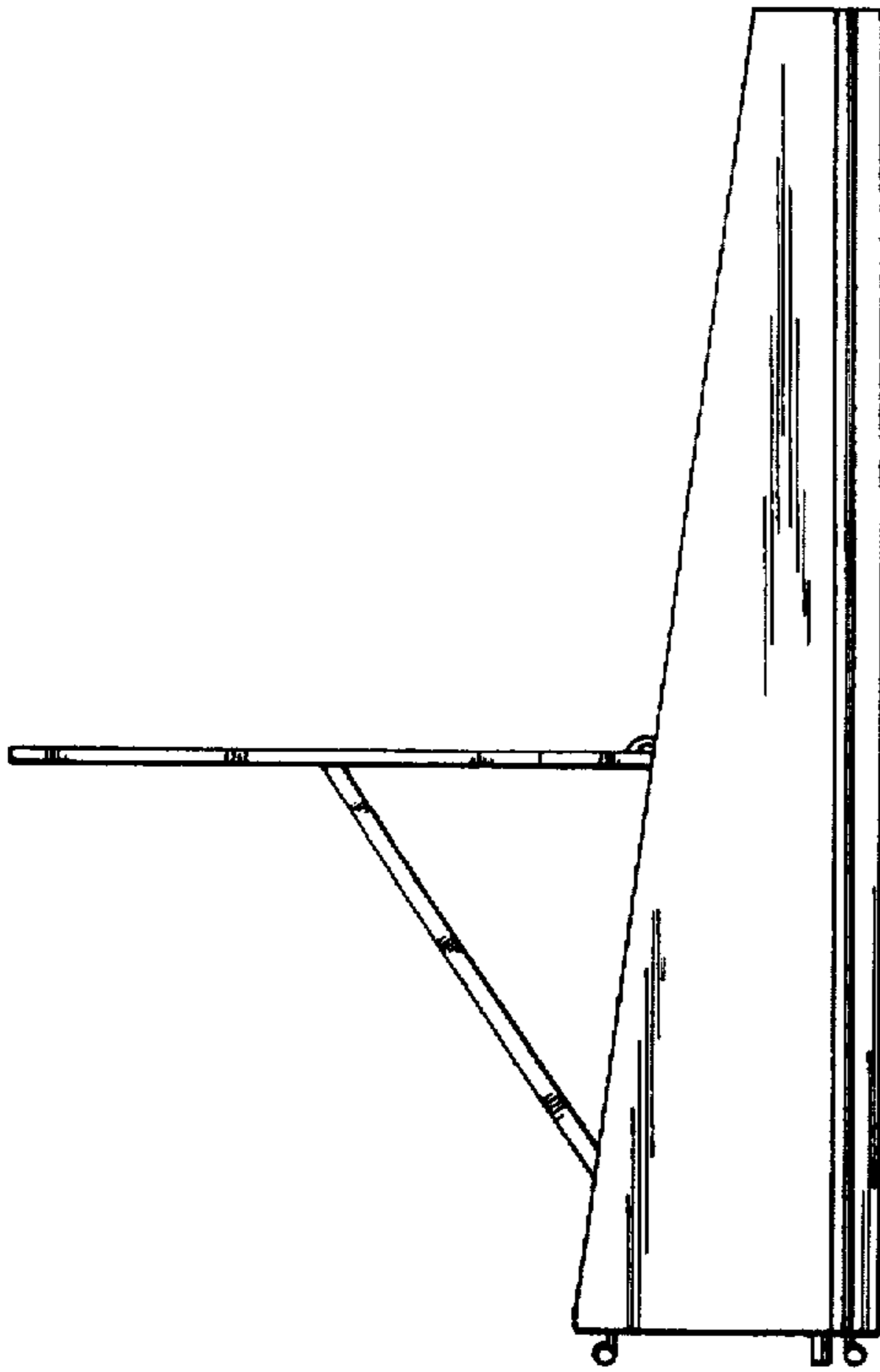

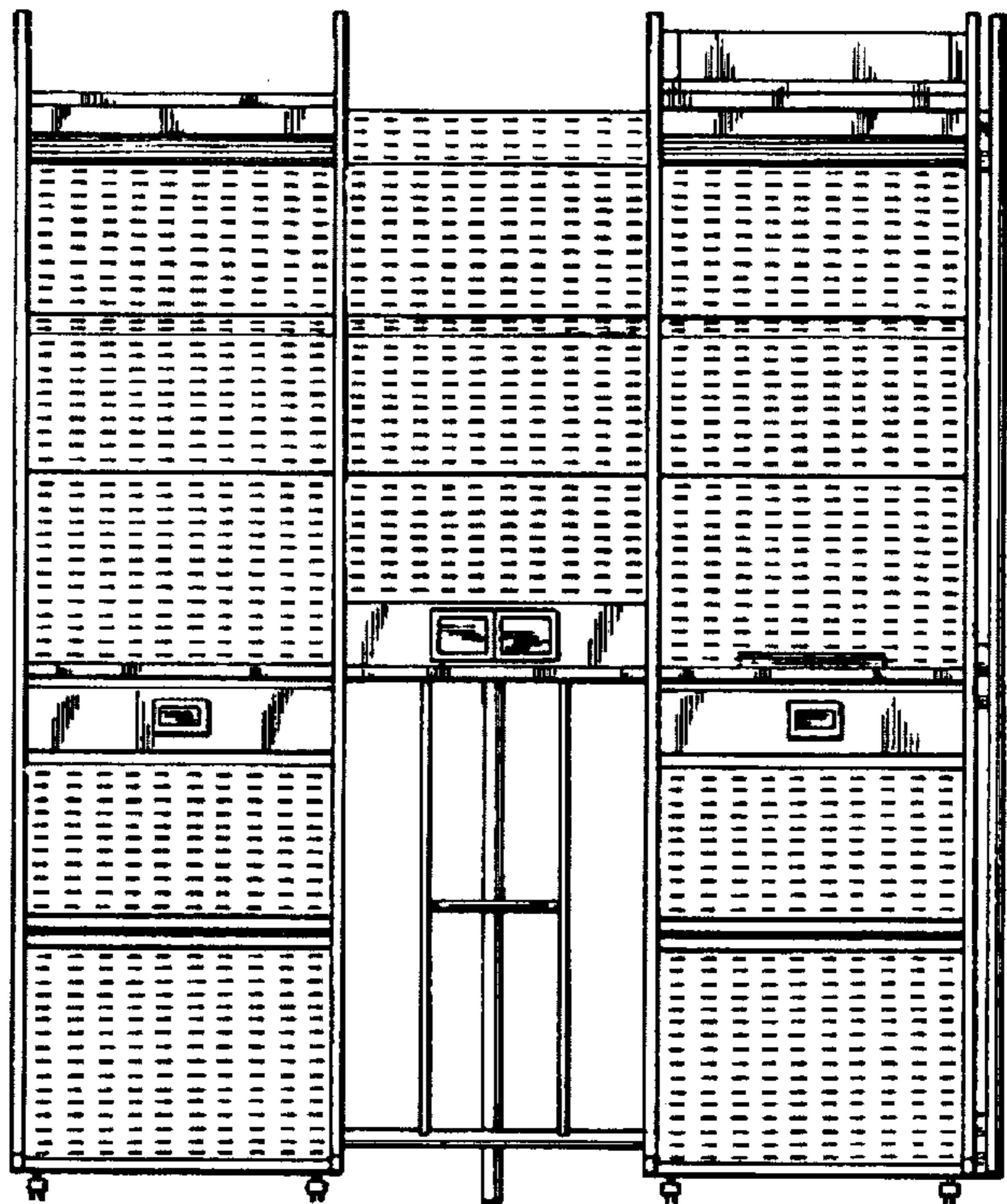

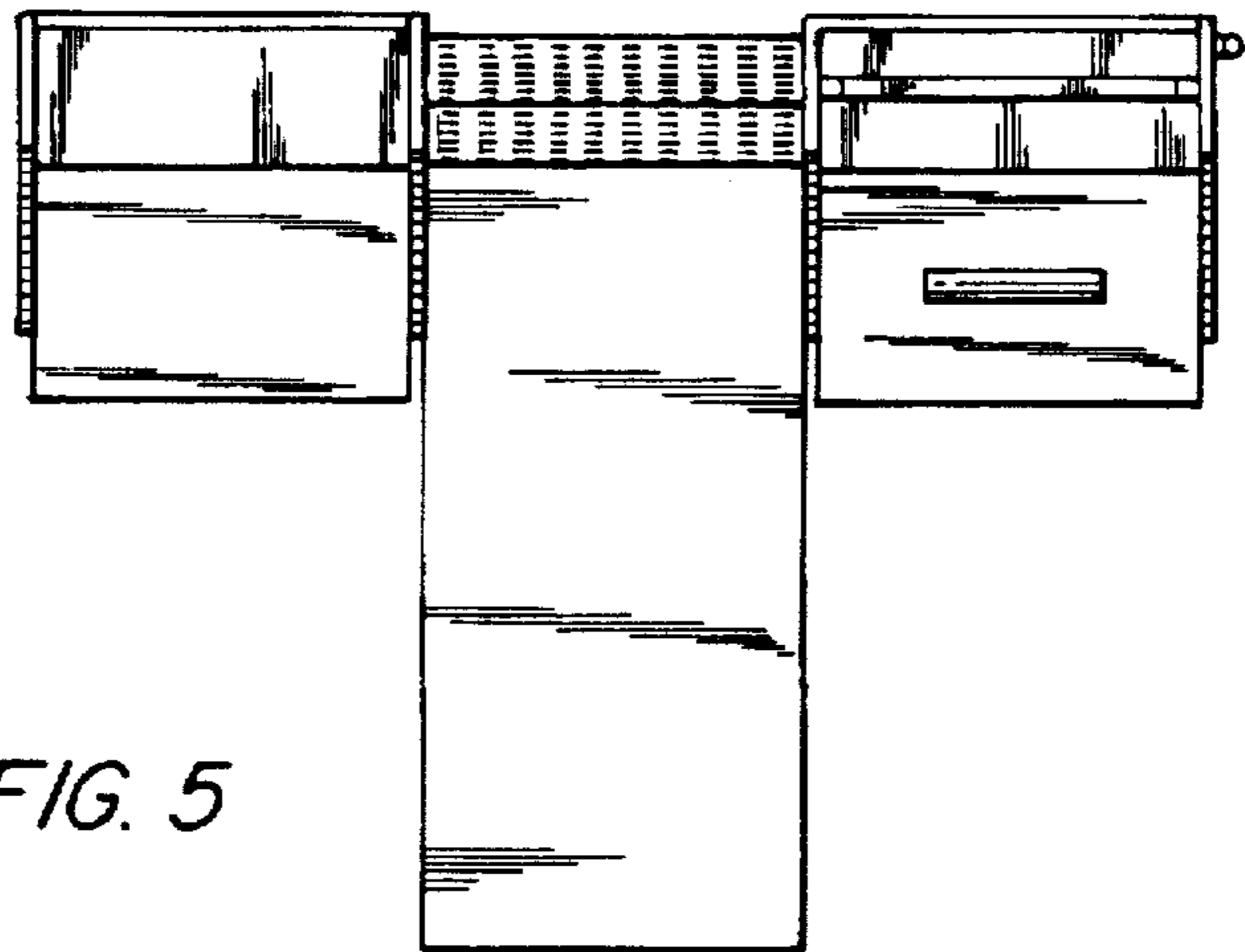

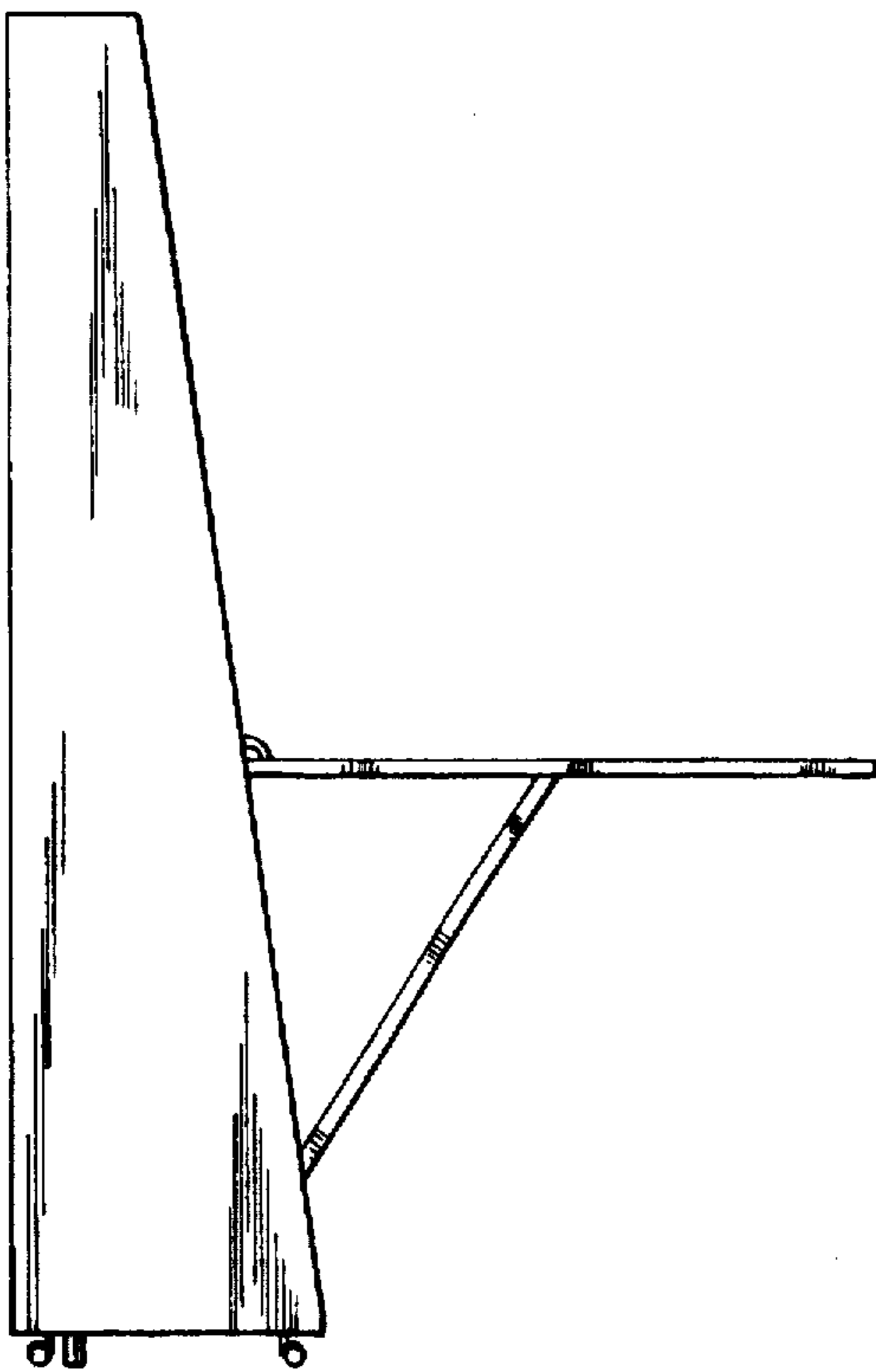
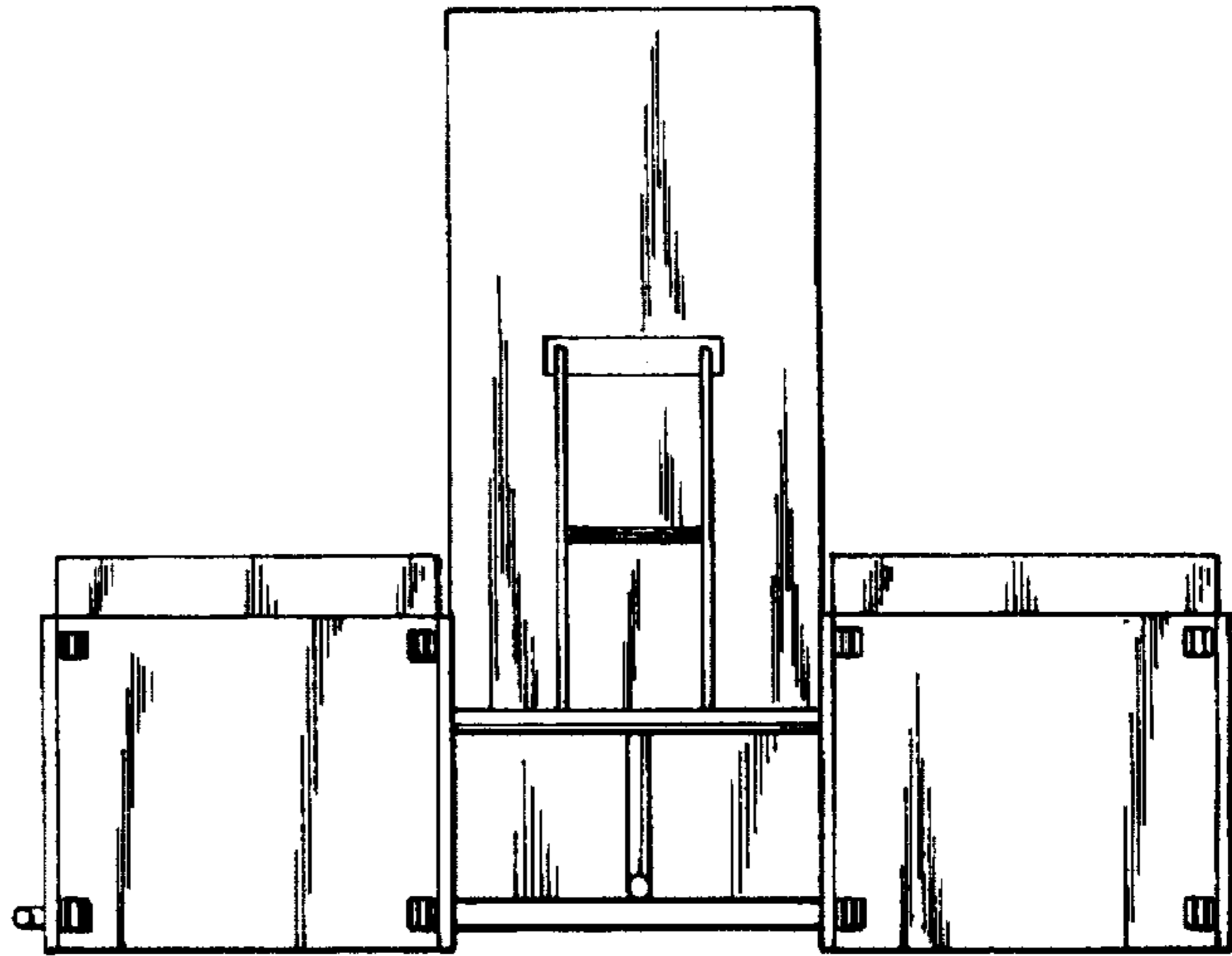

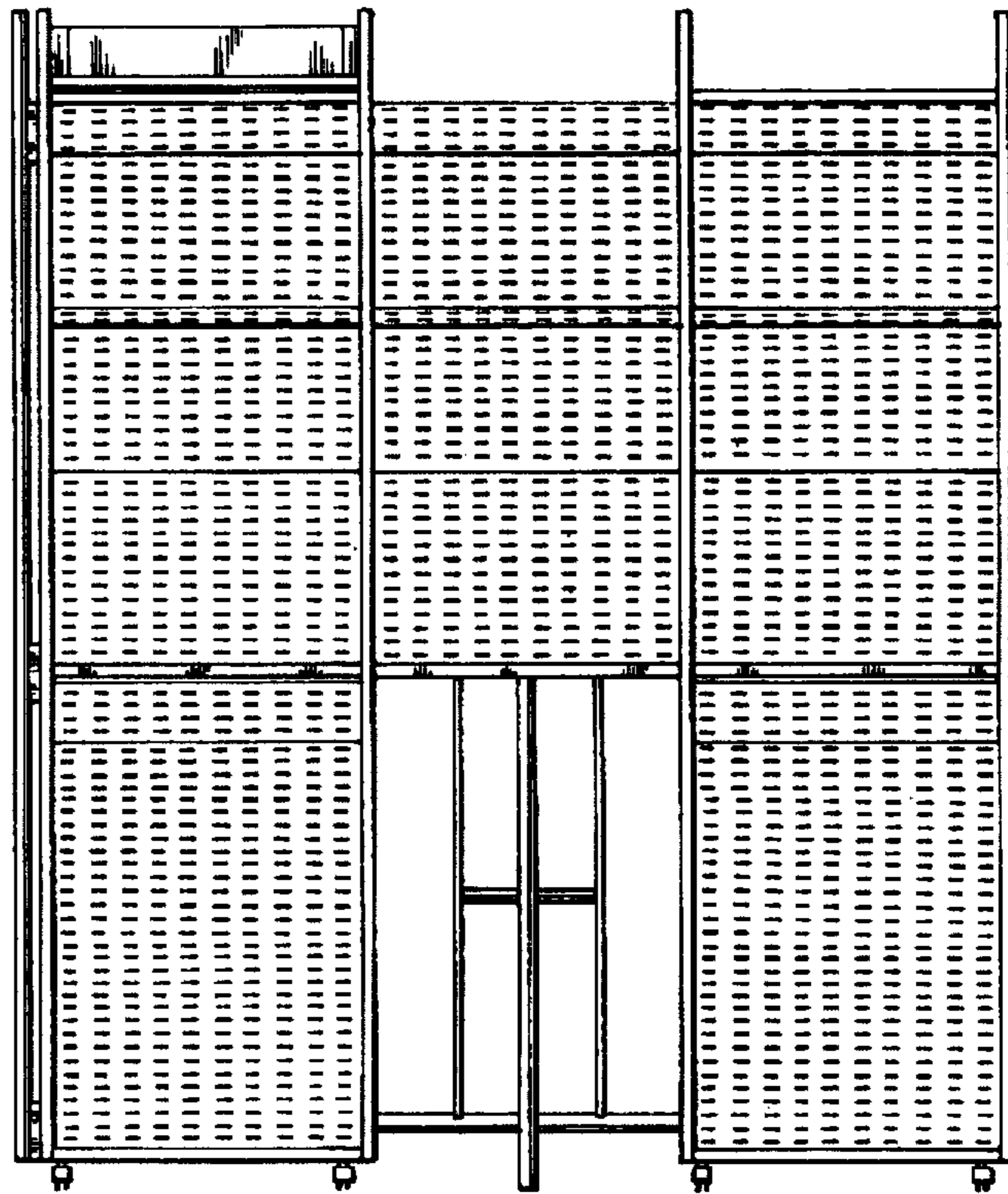
