**DESCRIPTION**

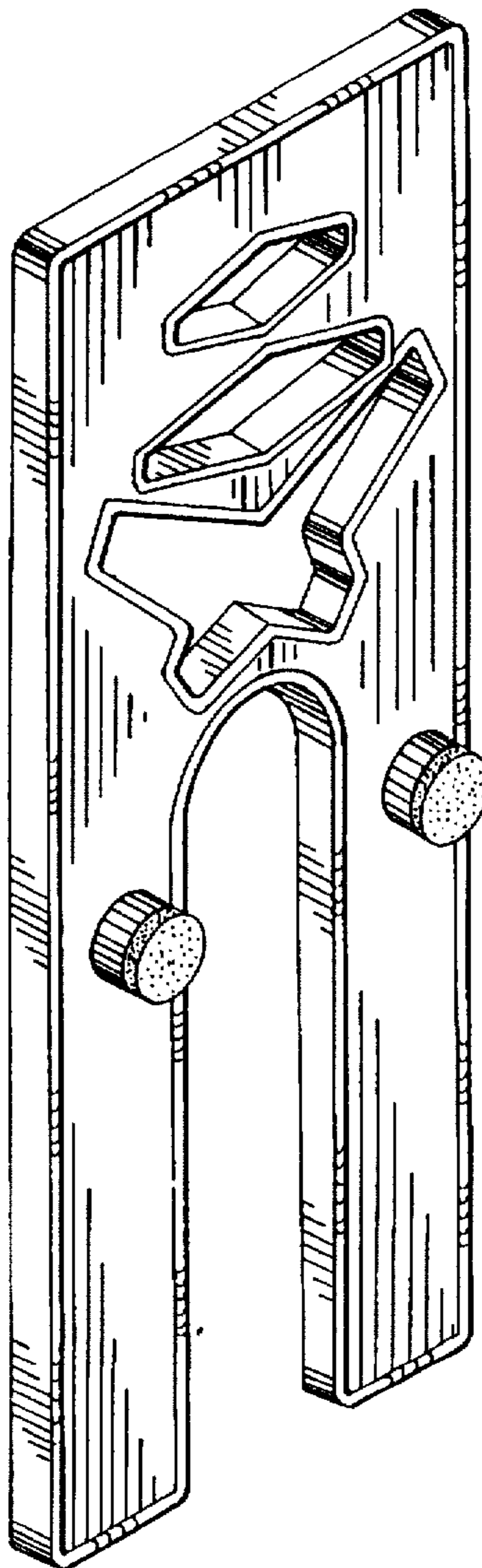
FIG. 1 is a top, front, and left side perspective view of a deadbolt locking plate showing my new design;

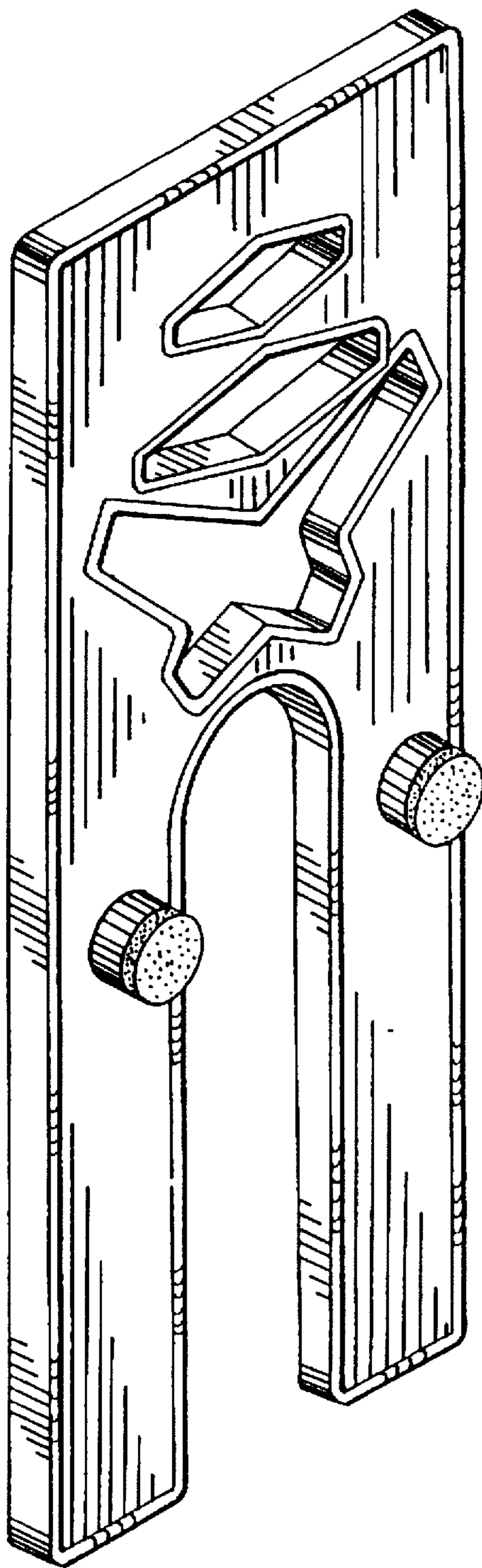

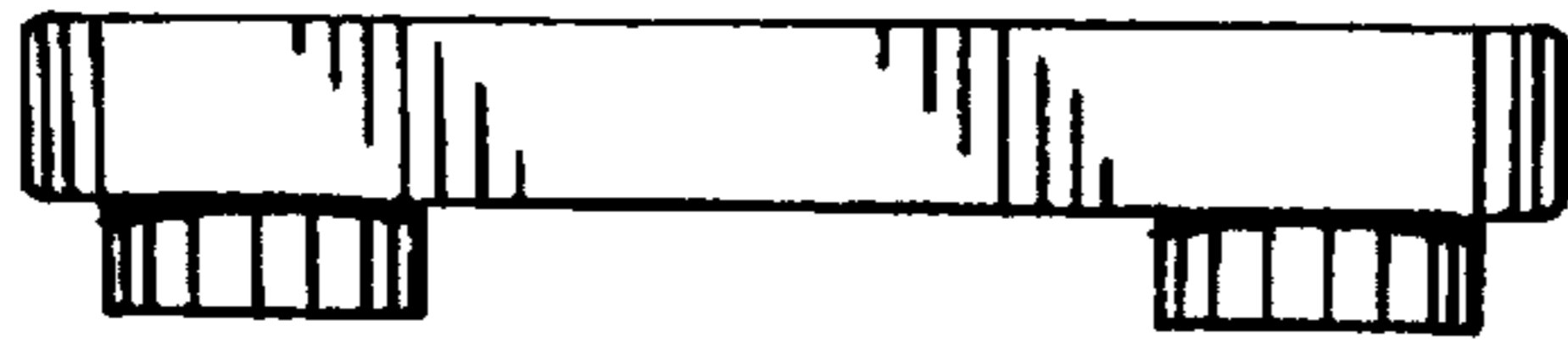

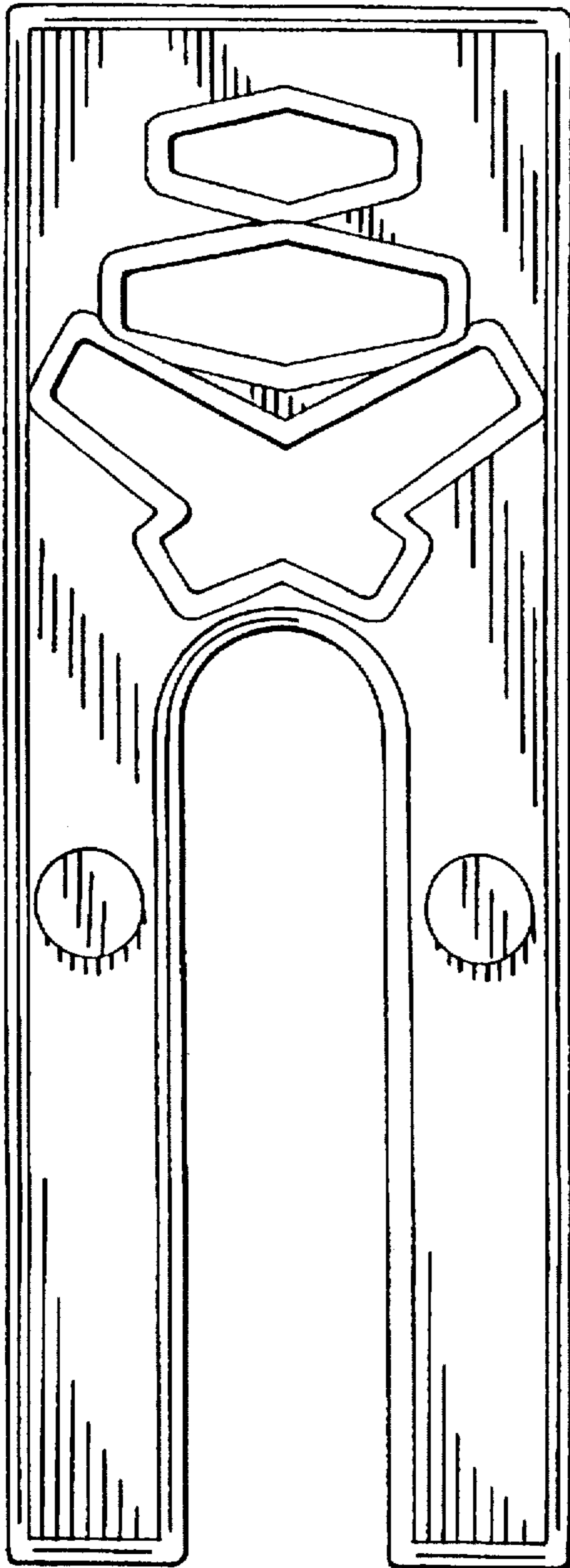

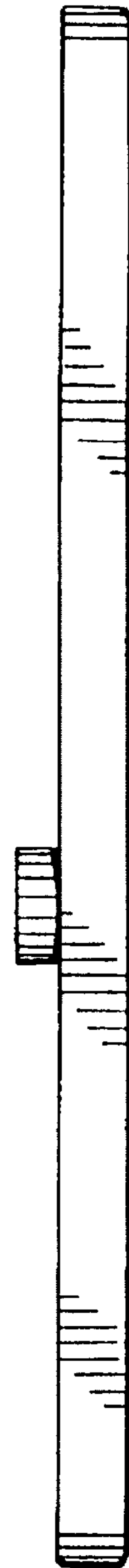

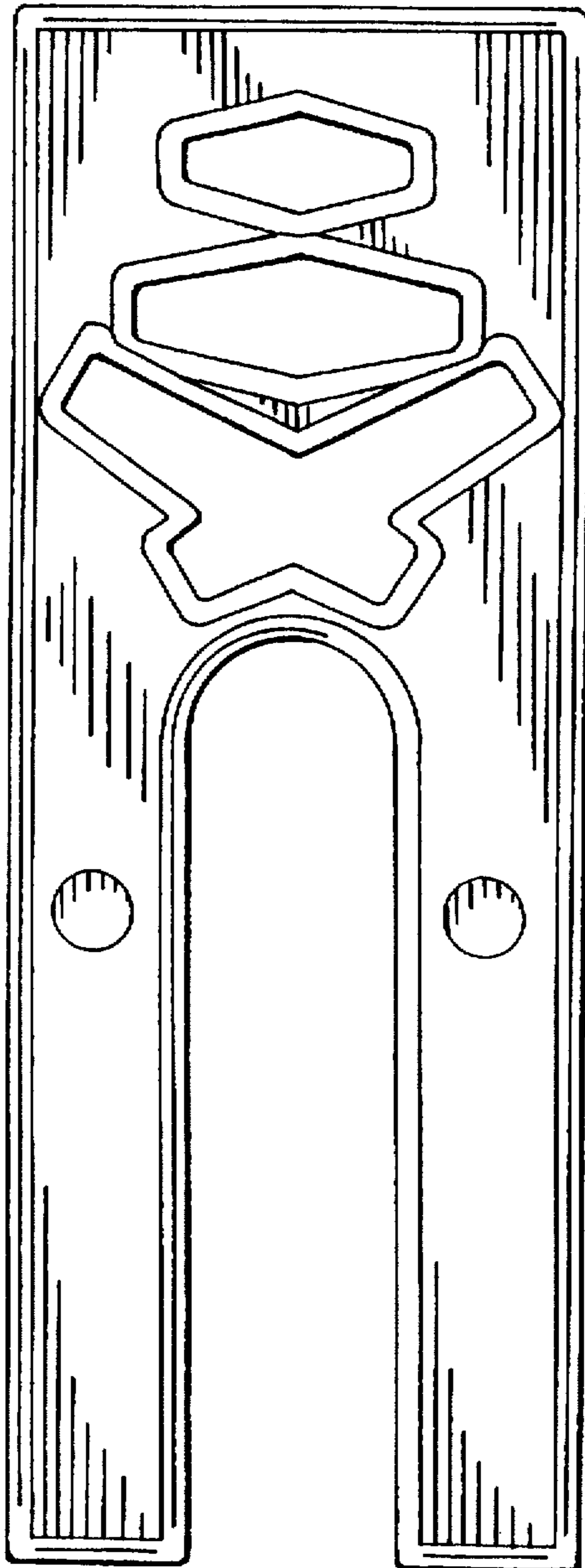

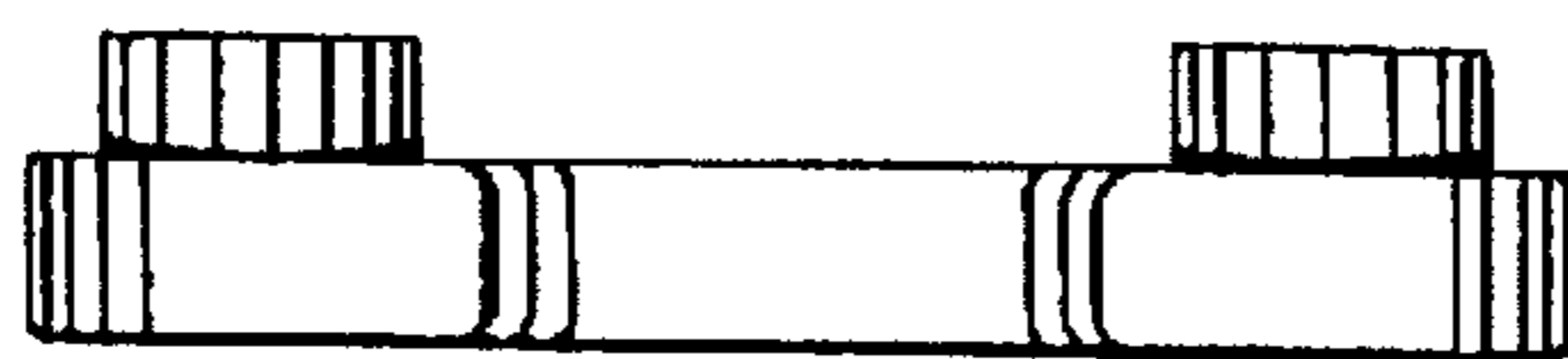
