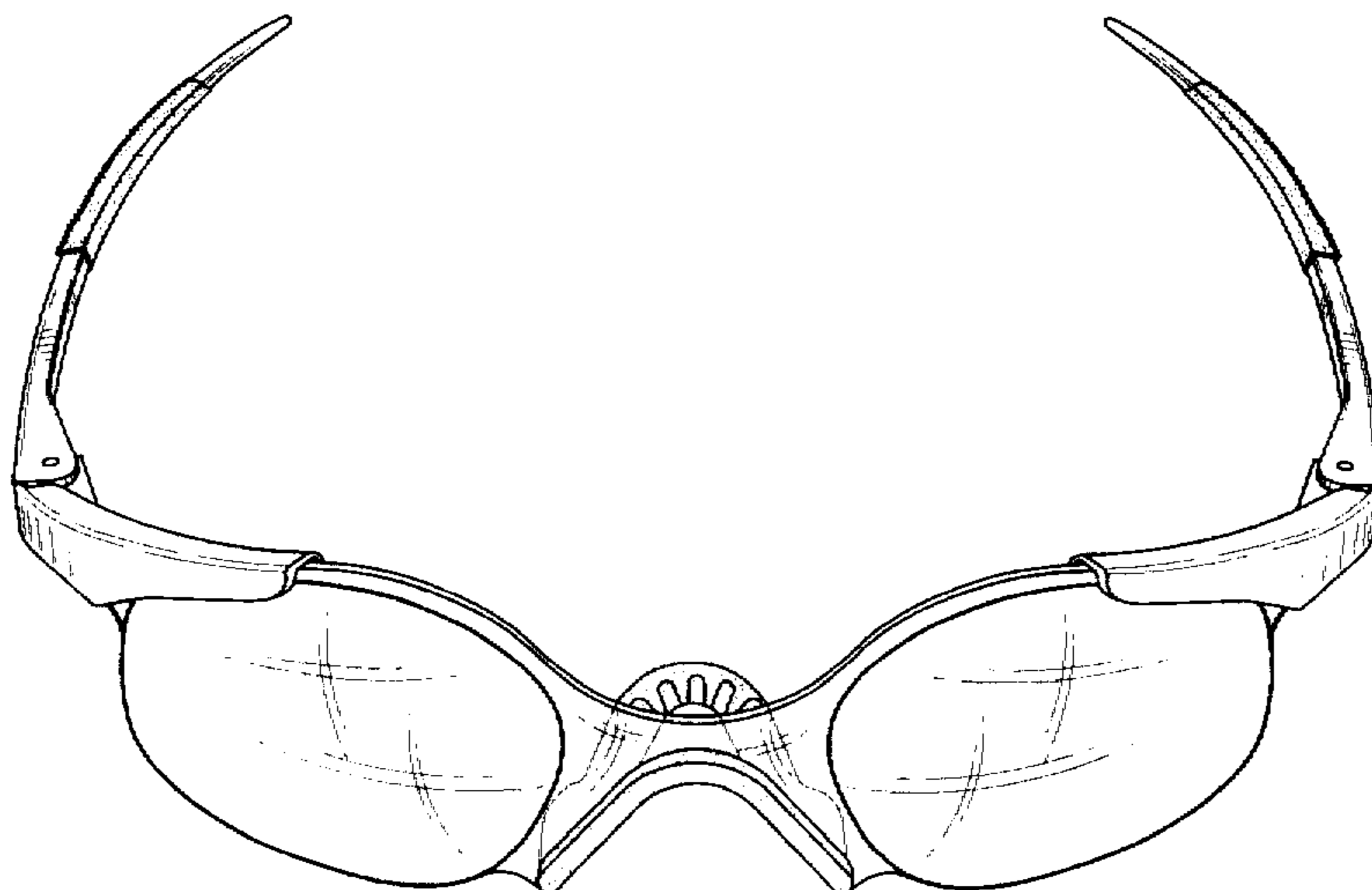
[57] **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of the eyeglasses of the present invention;
 FIG. 2 is a front elevational view thereof;
 FIG. 3 is a rear elevational view thereof;
 FIG. 4 is a right-side elevational view thereof, the left side elevational view being a mirror image thereof;
 FIG. 5 is a top plan view thereof; and
 FIG. 6 is a bottom plan view thereof.

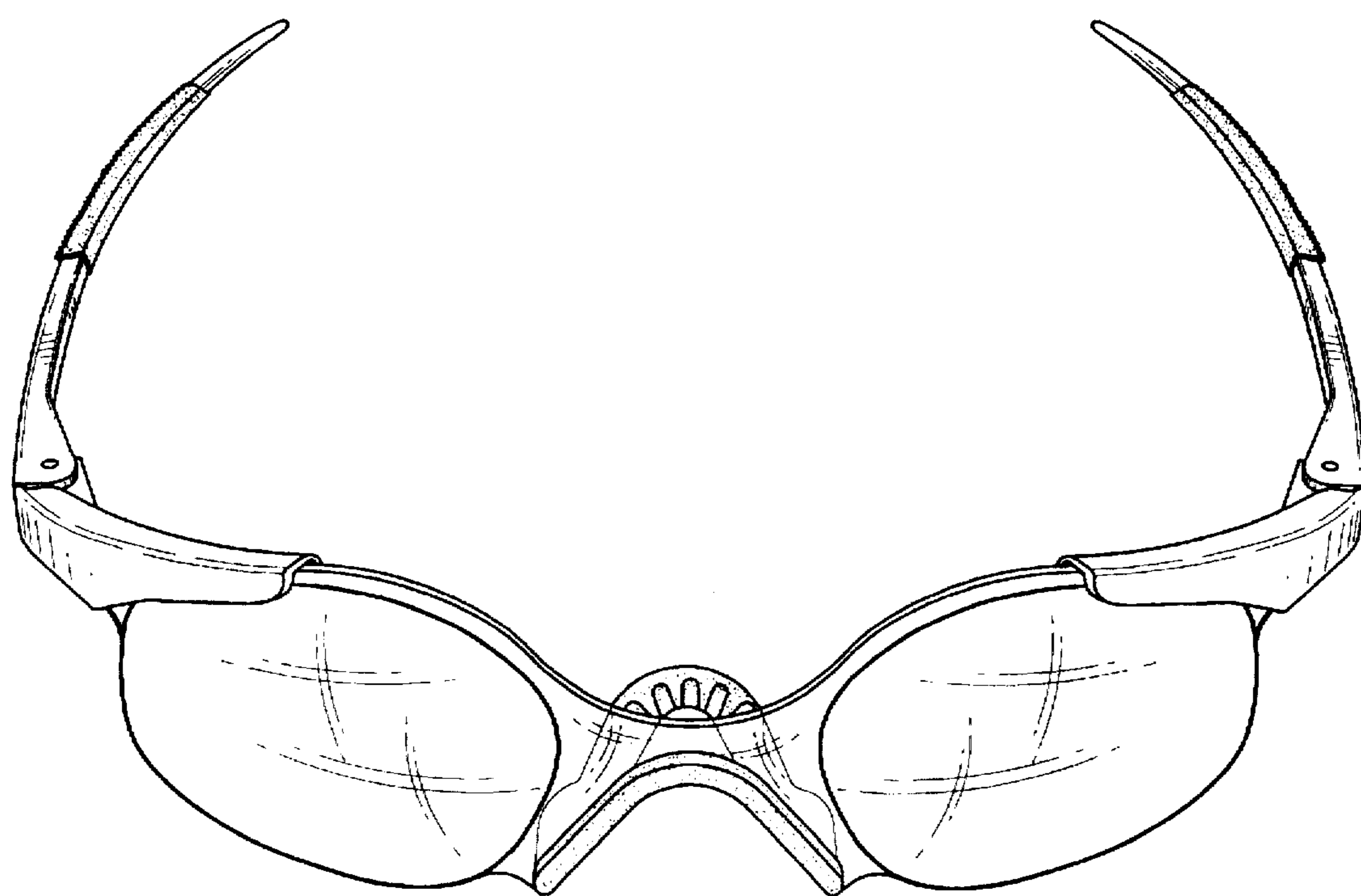

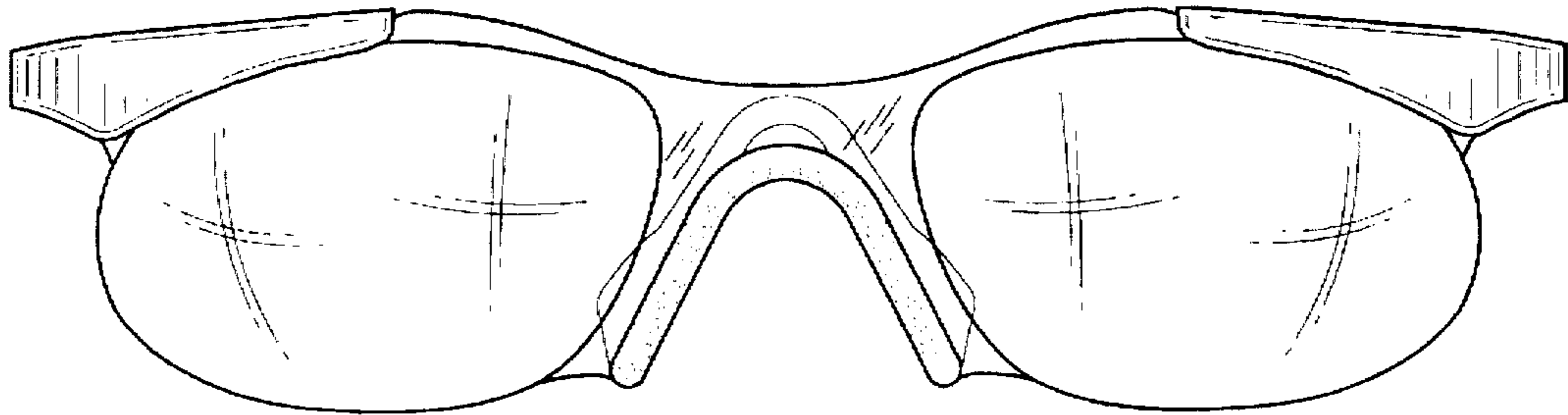

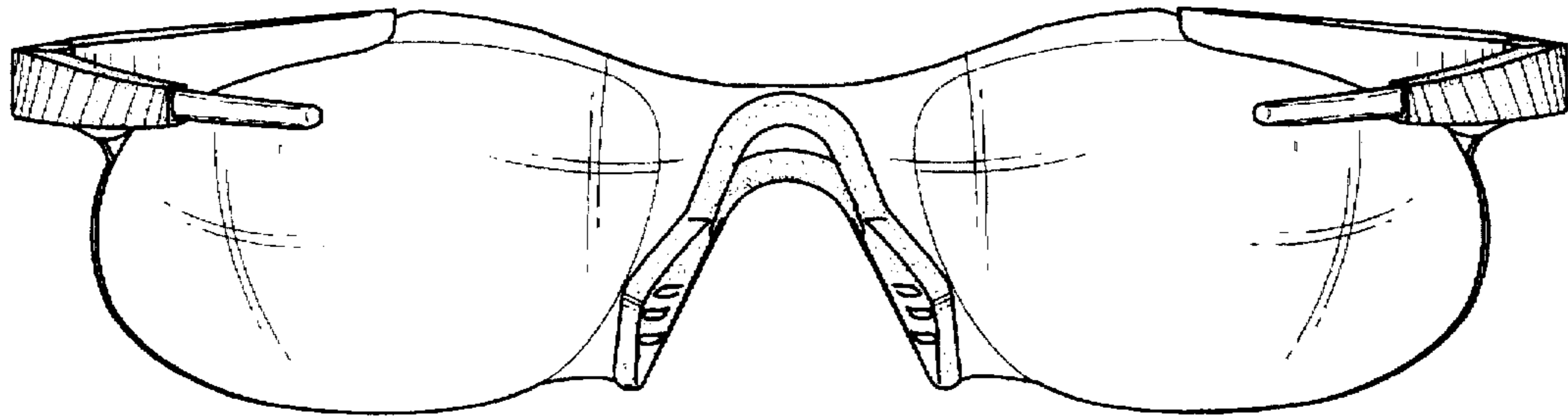

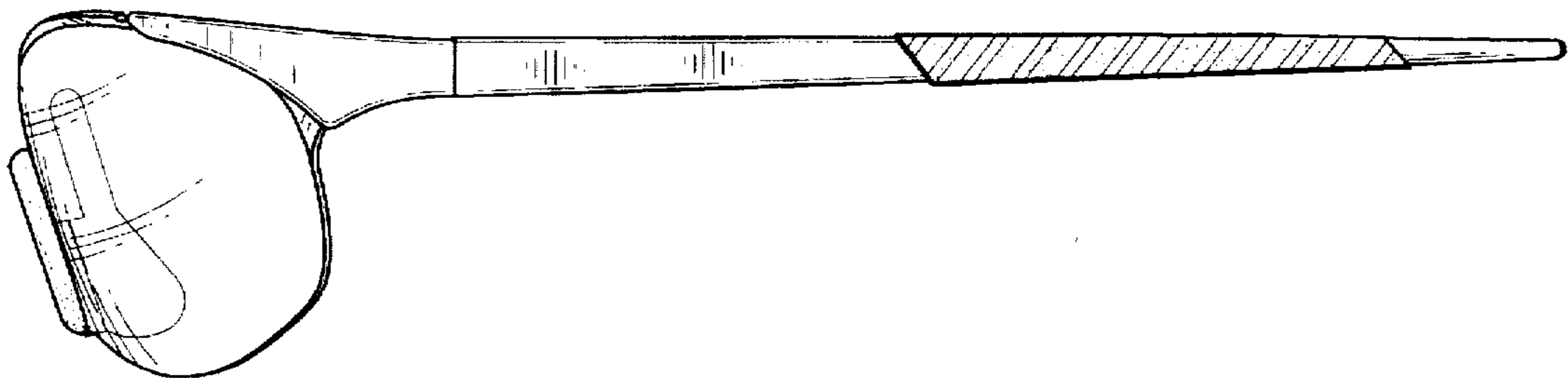

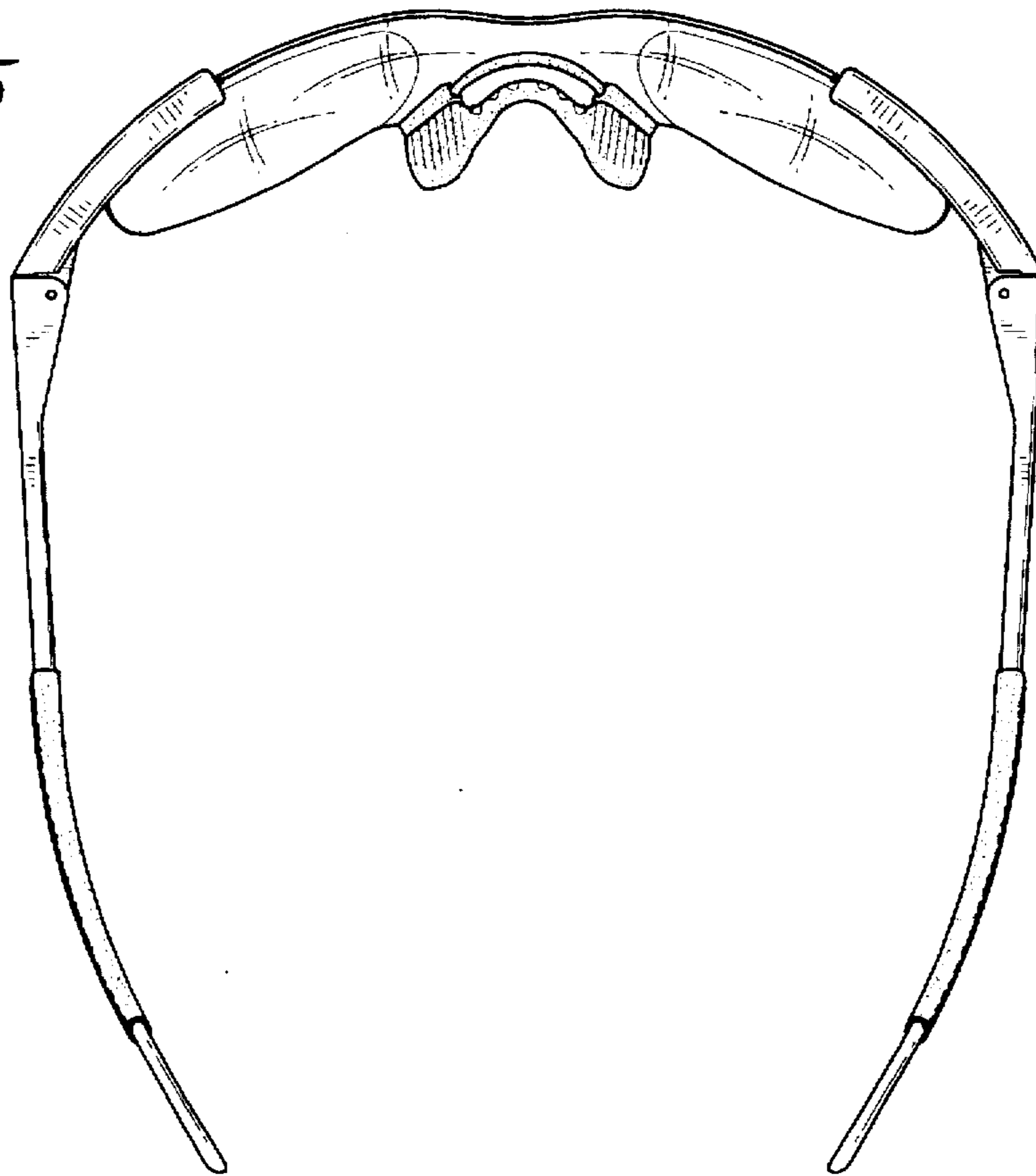
