The ornamental design for a pedestal lavatory, as shown and described.

DESCRIPTION

FIG. 1 is a right, top, front perspective view of a pedestal lavatory embodying my new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a right side elevational view thereof, the left side elevational view being a mirror image of the right side shown;

FIG. 5 is a cross-sectional view taken along line 5—5 of FIG. 2:

FIG. 6 is a cross-sectional view taken along line 6—6 of FIG. 2;

FIG. 7 is a right, top, front perspective view of a second embodiment;

FIG. 8 is a top plan view thereof;

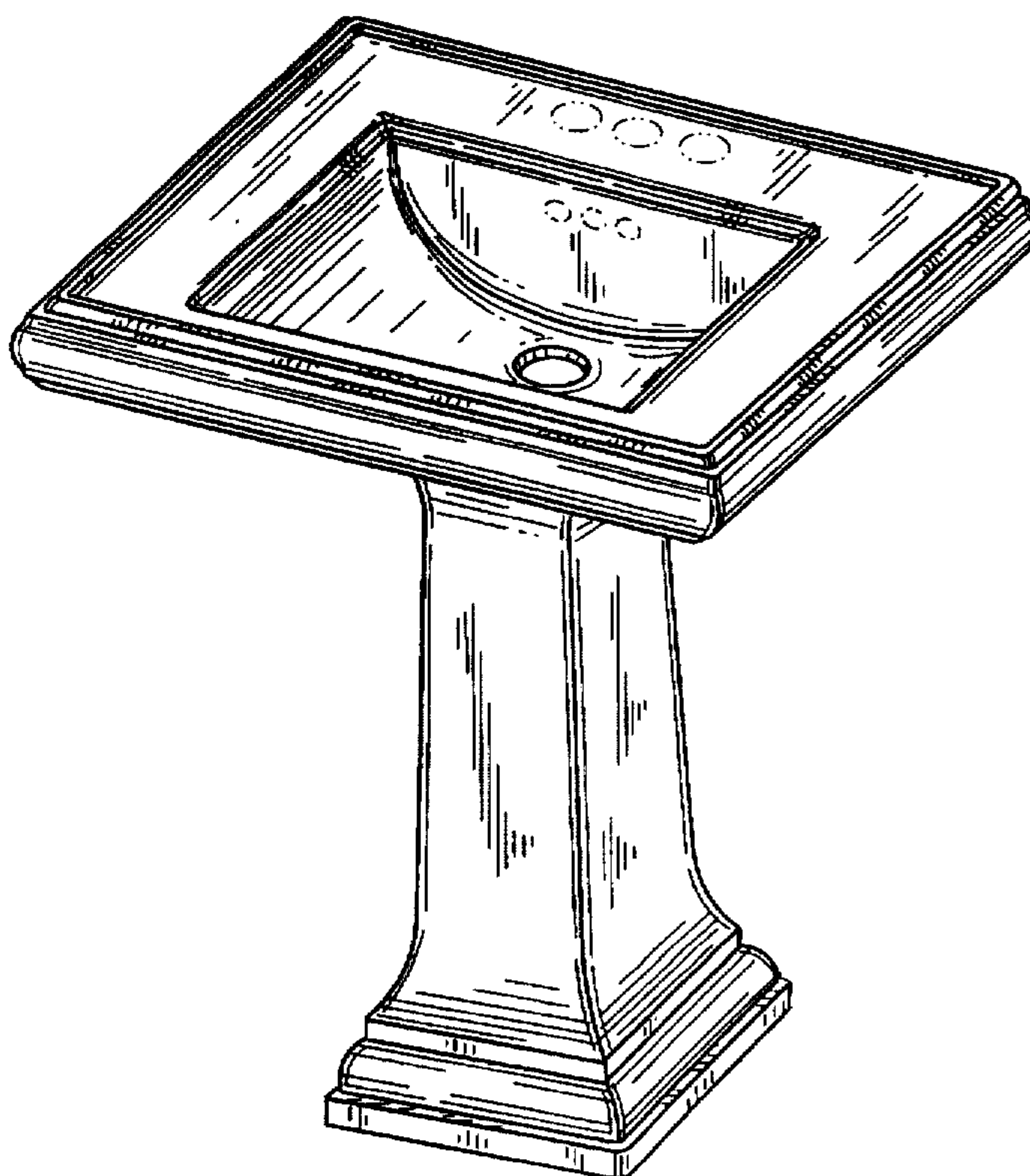
FIG. 9 is a front elevational view thereof;

FIG. 10 is a right side elevational view thereof, the left side elevational view being a mirror image of the right side shown:

FIG. 11 is a cross-sectional view taken along line 11—11 of FIG. 8; and,

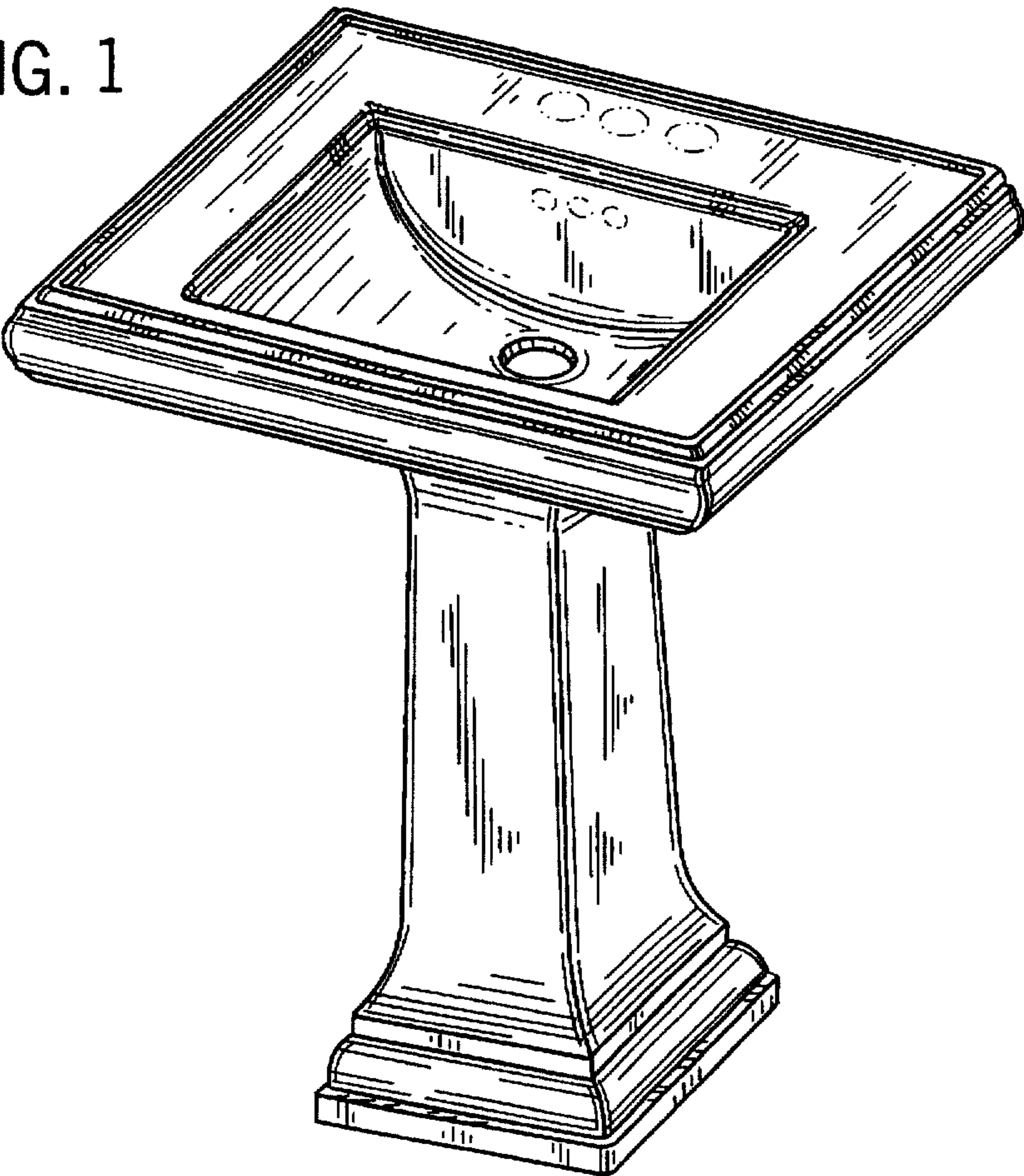

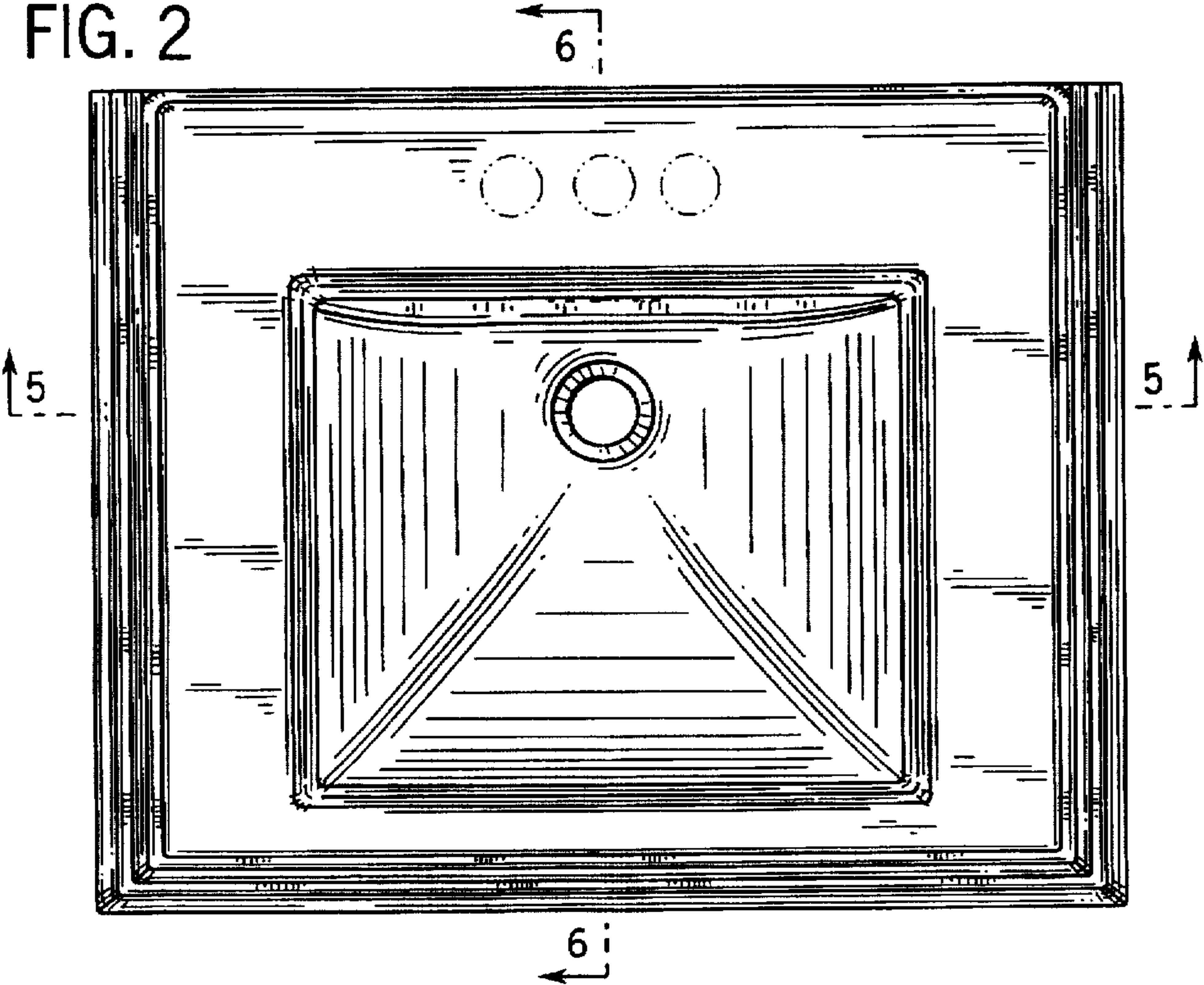

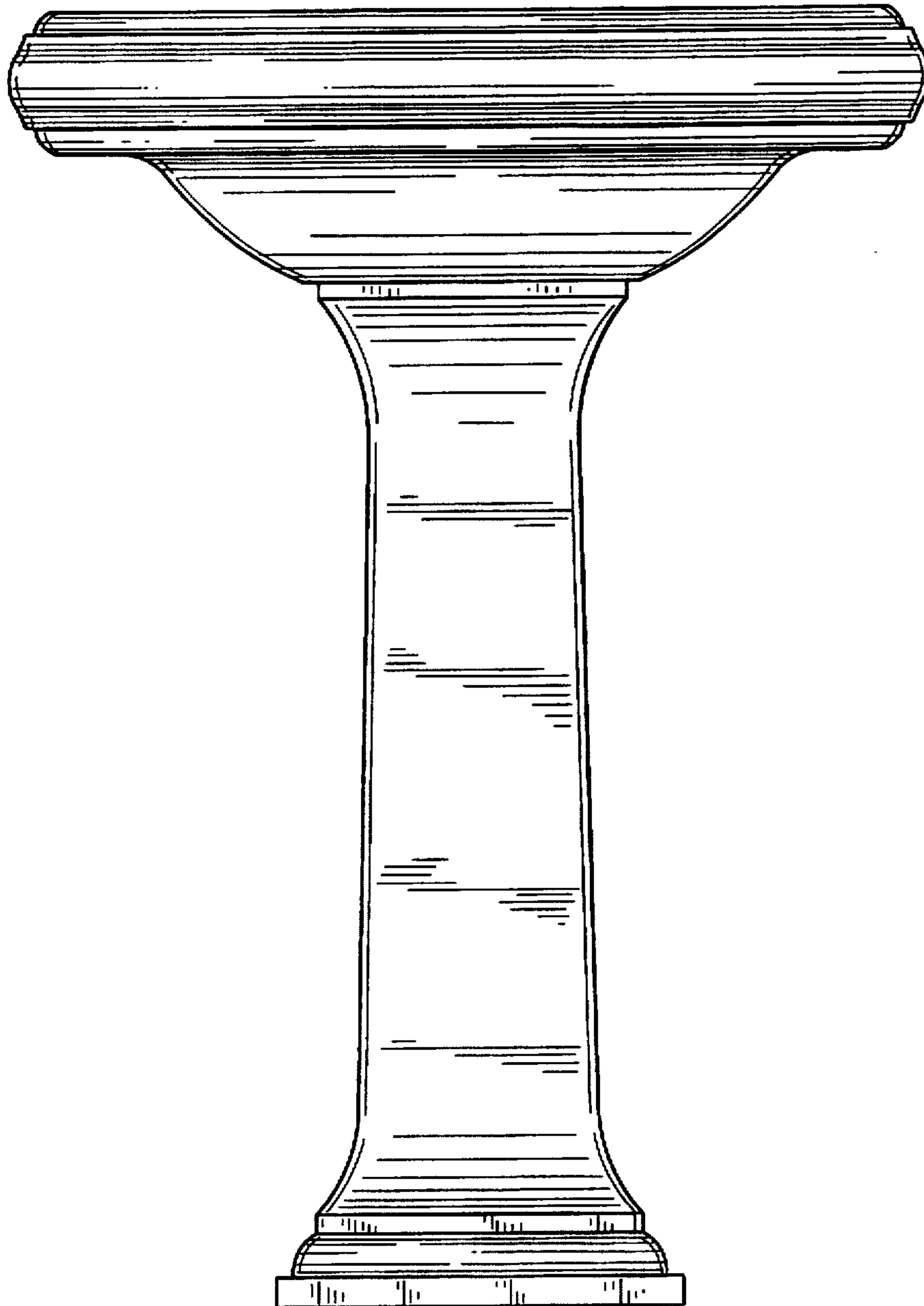

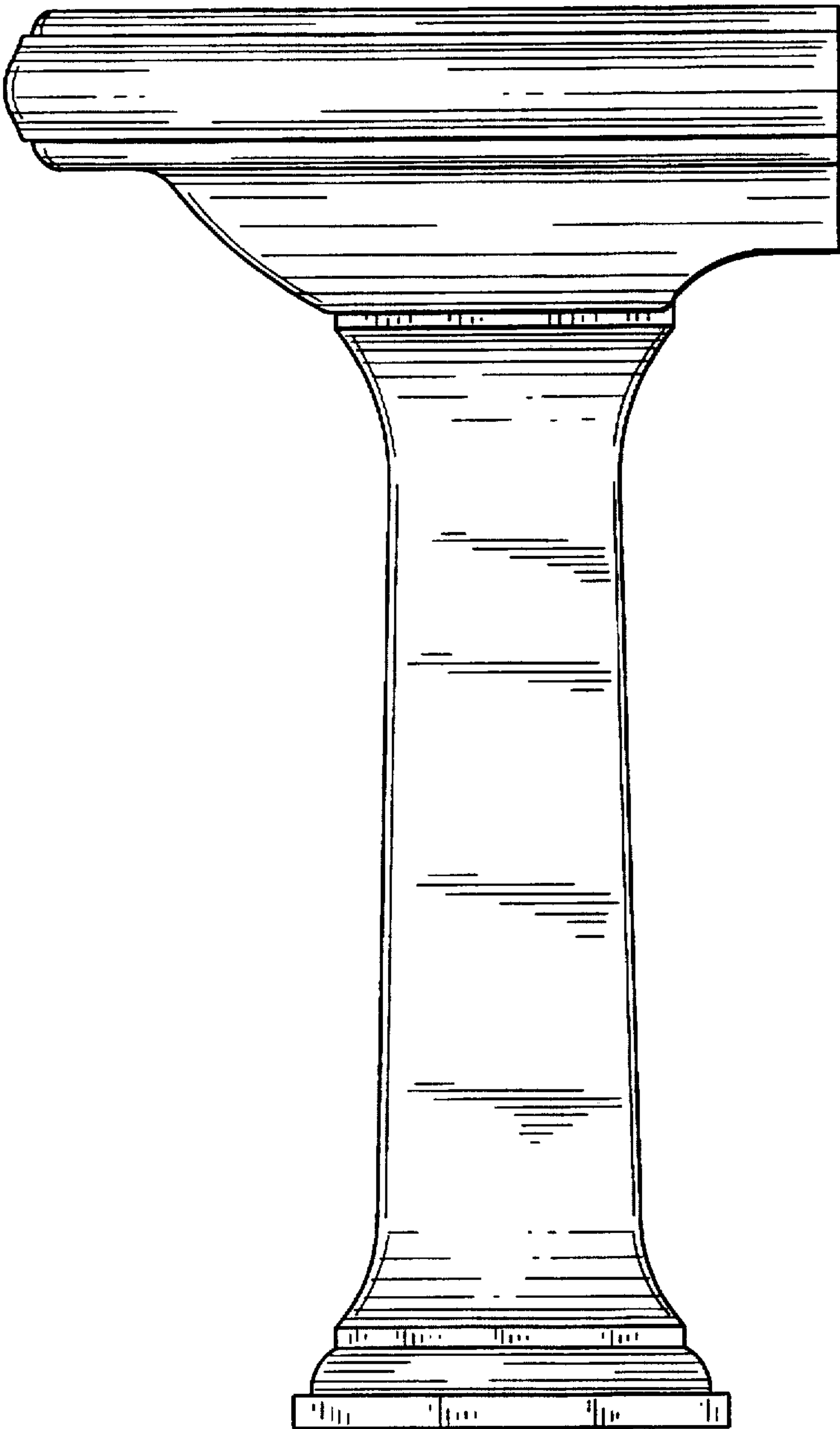

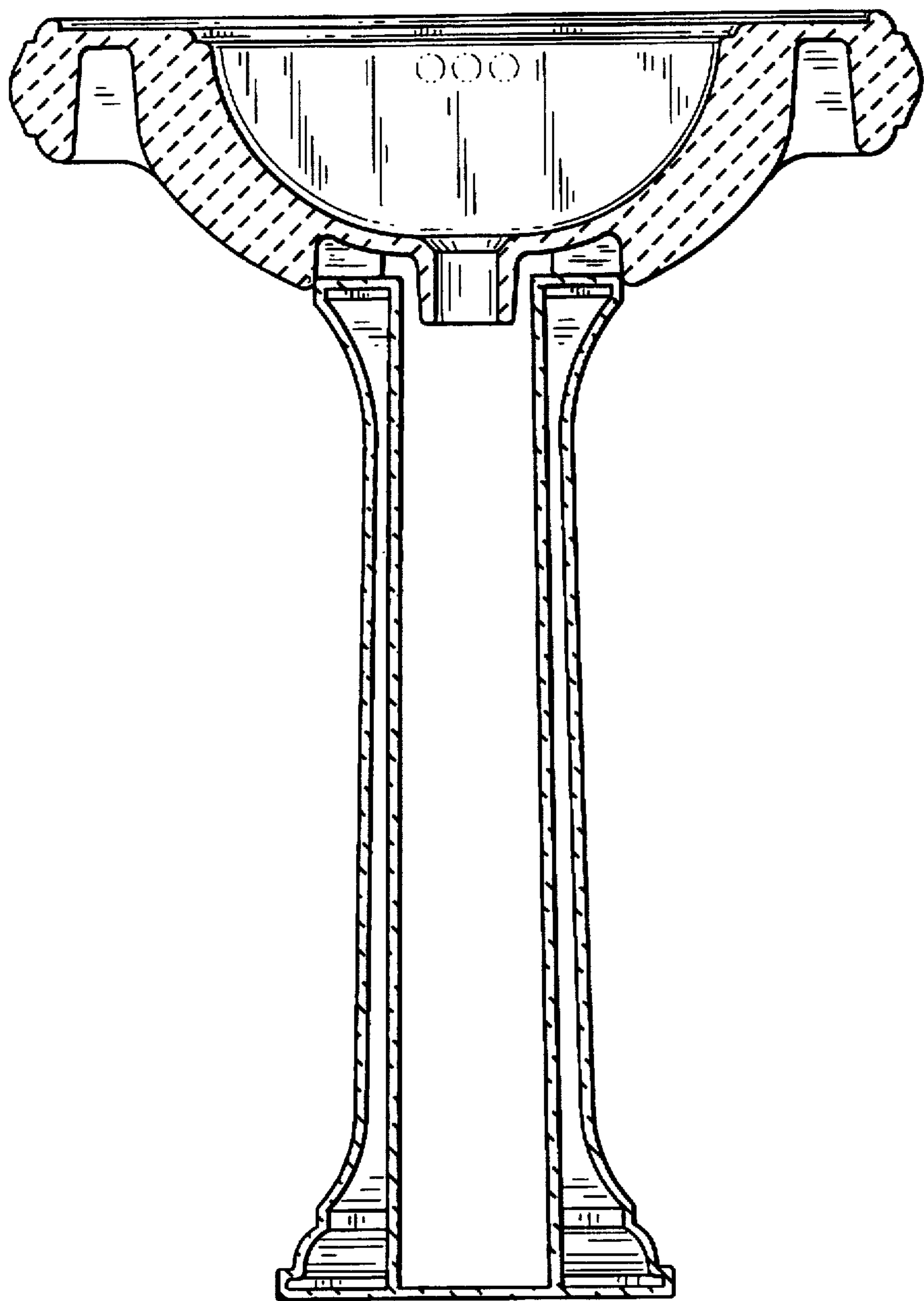
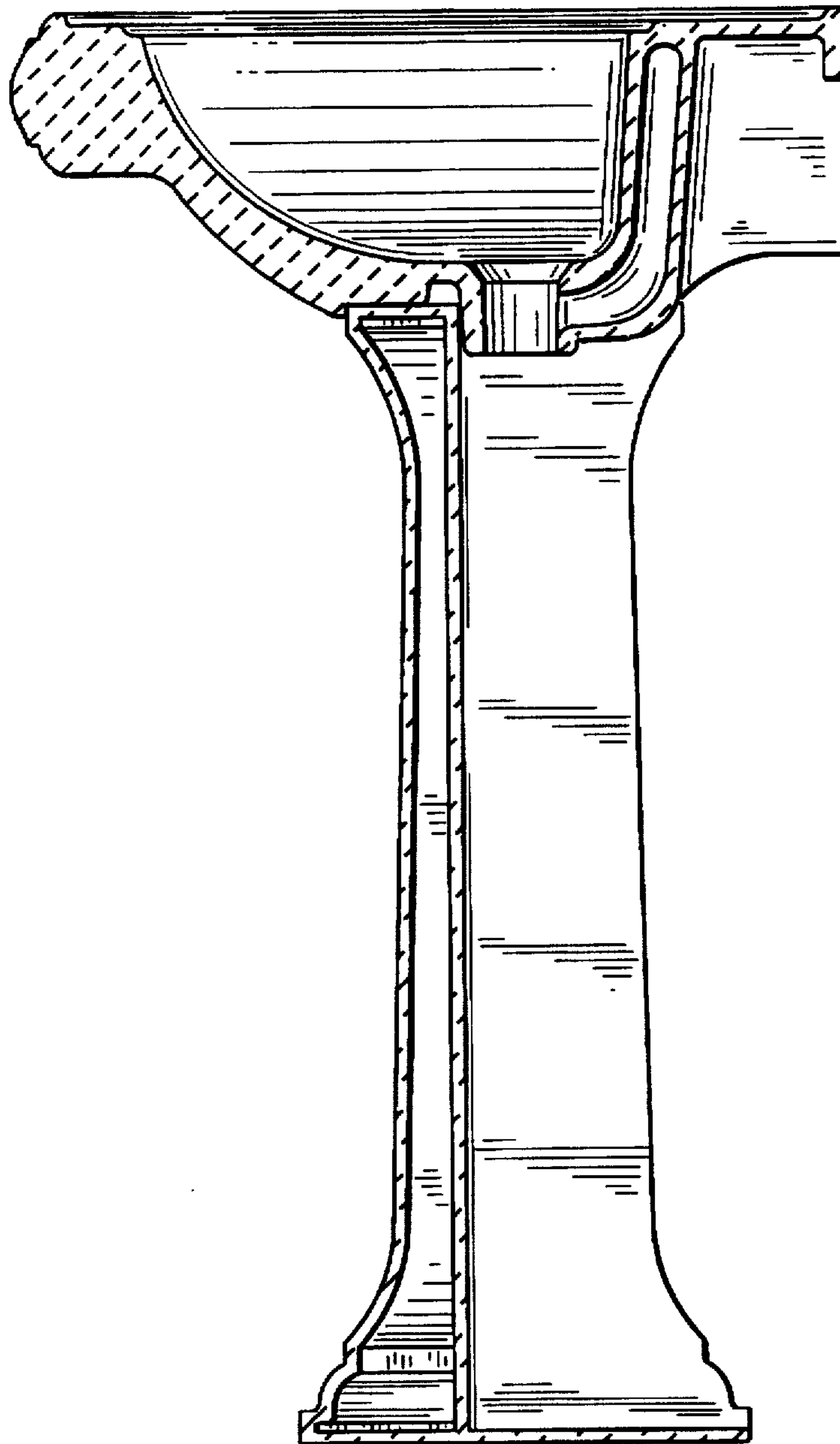

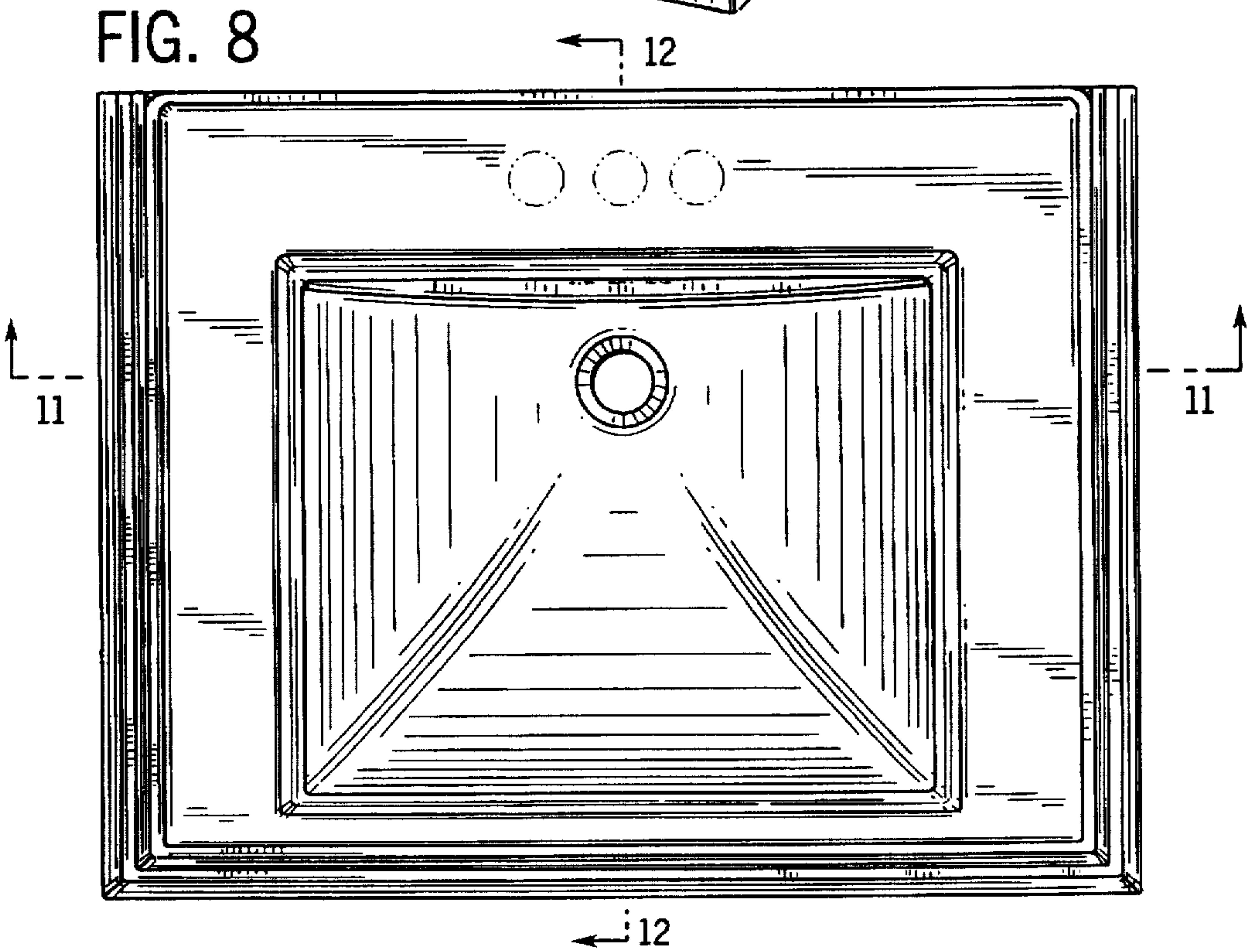
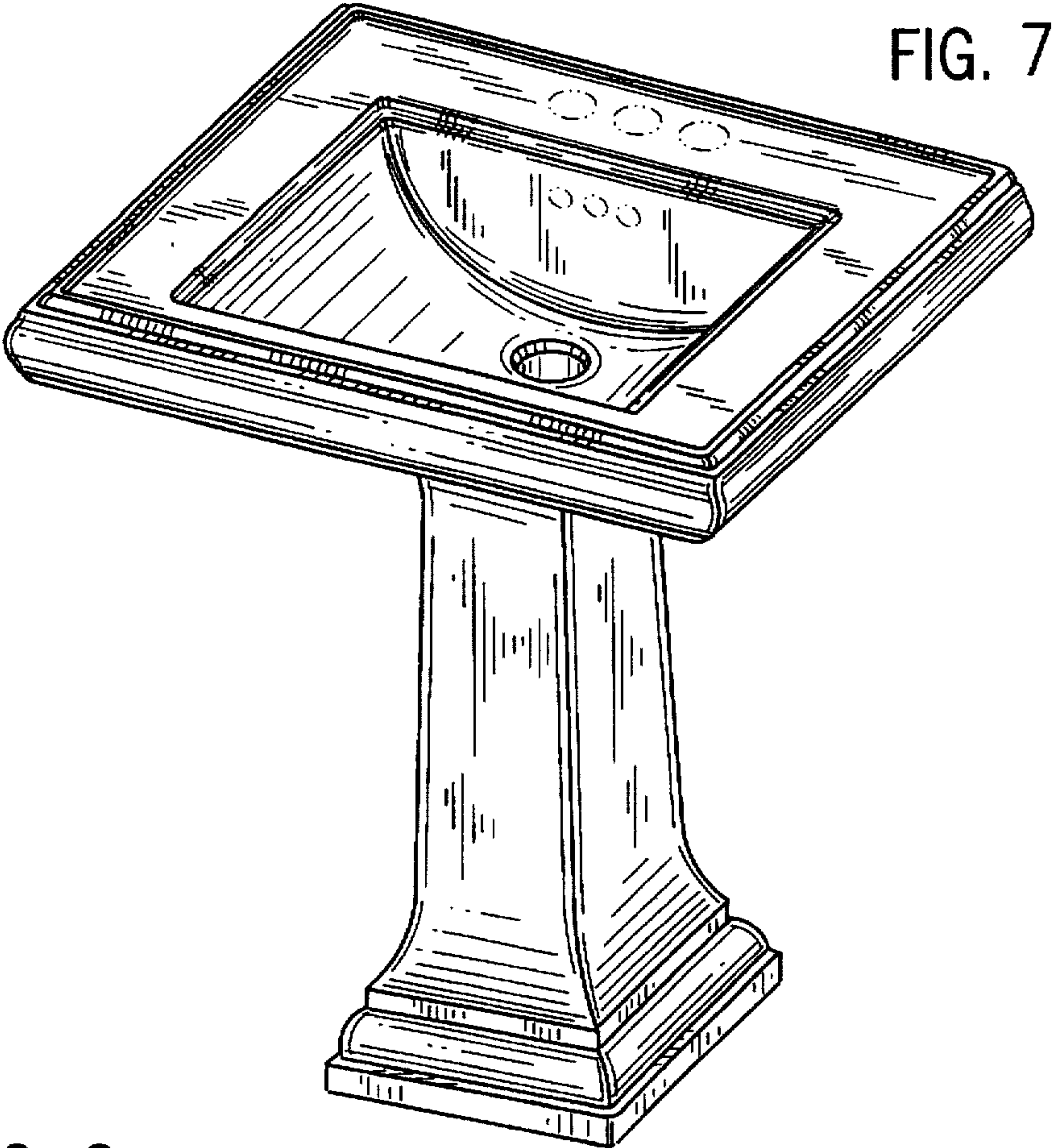

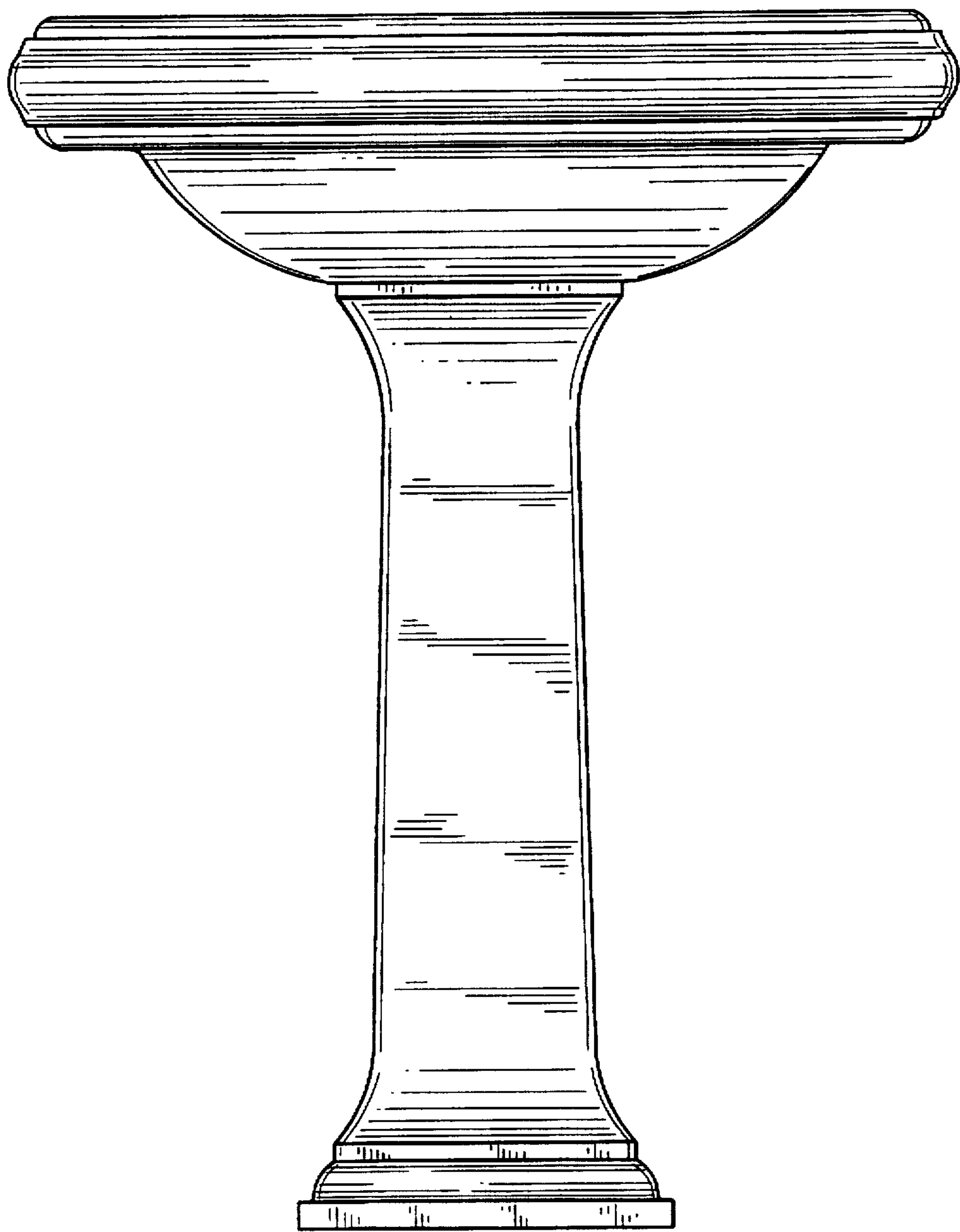

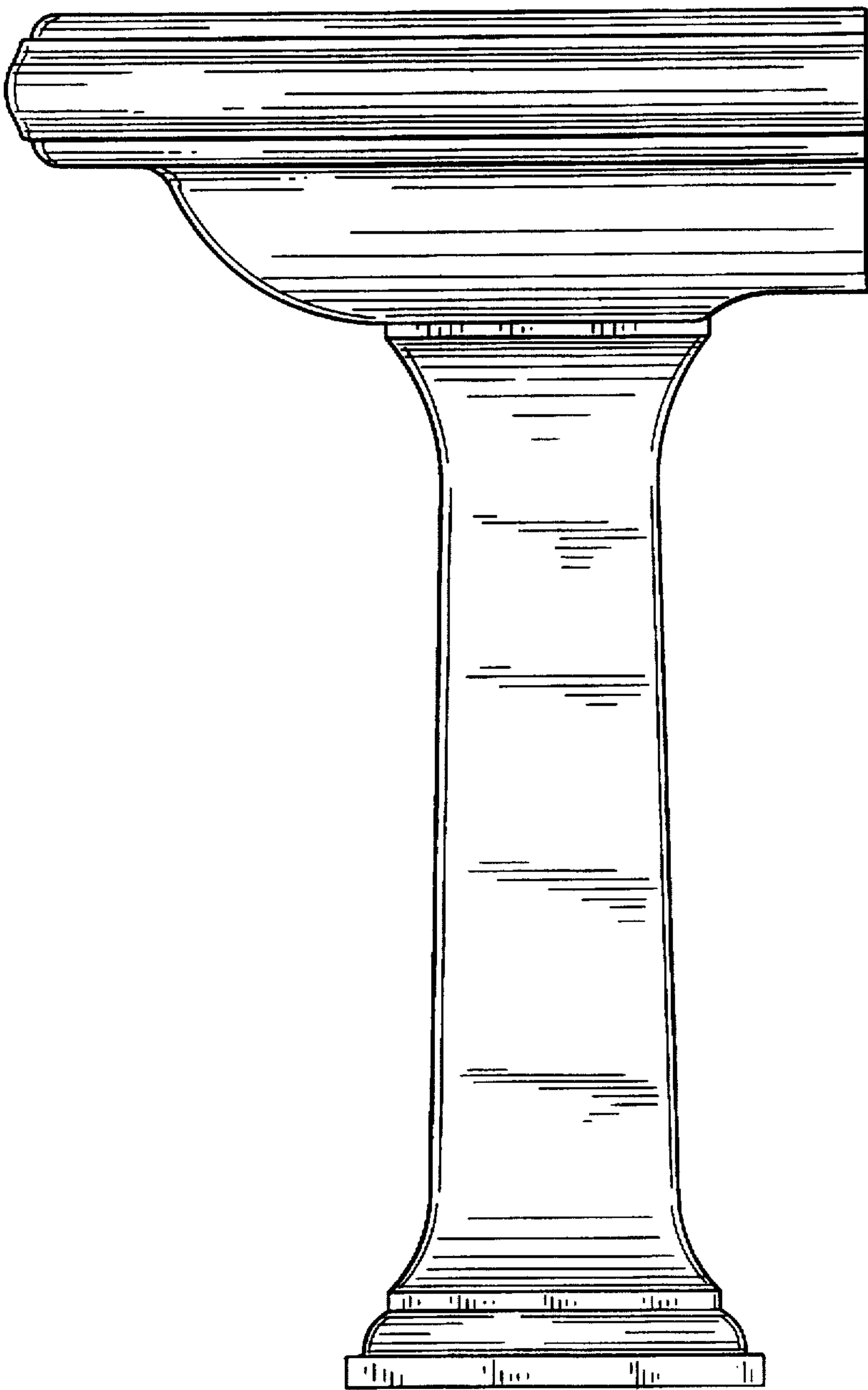

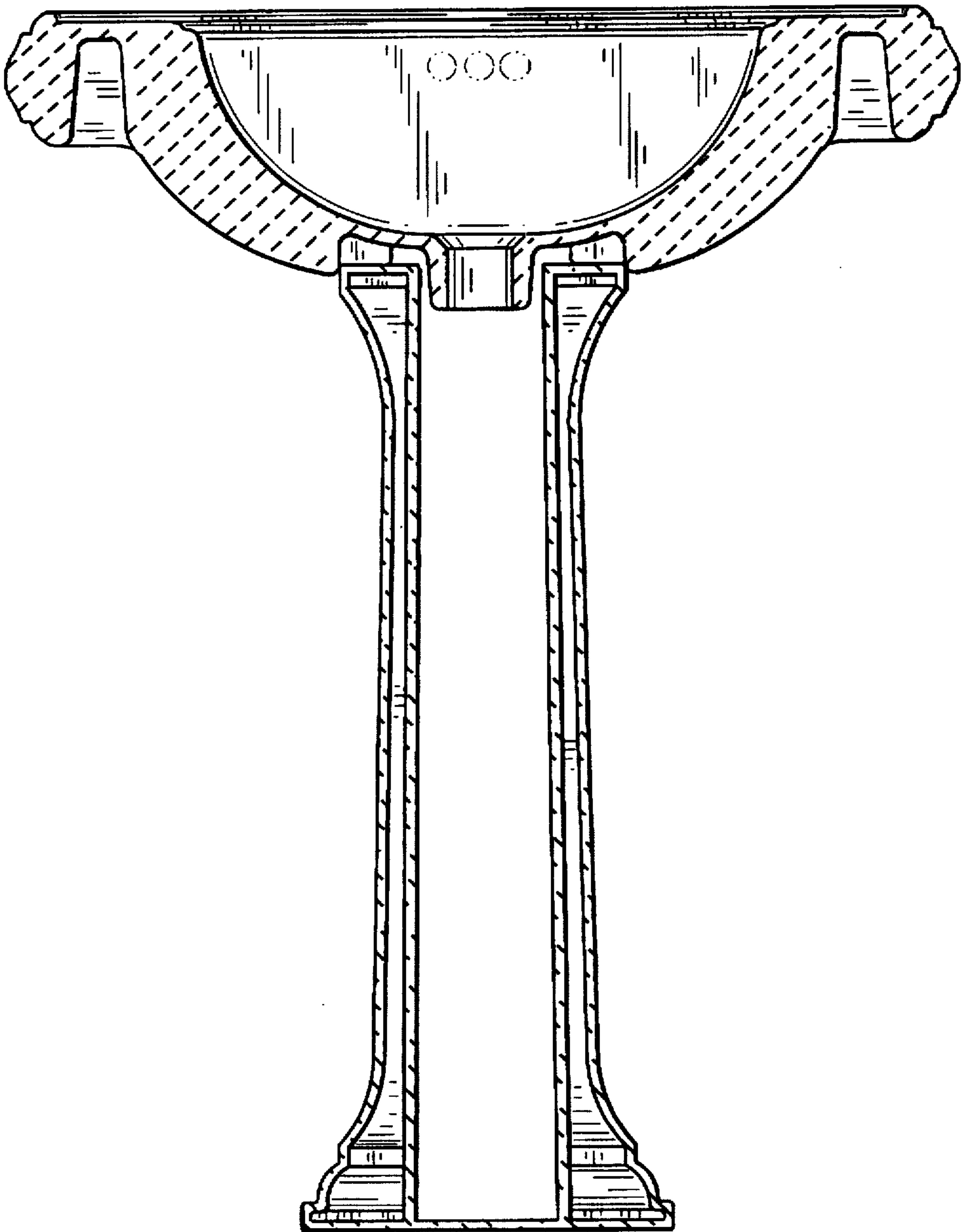
