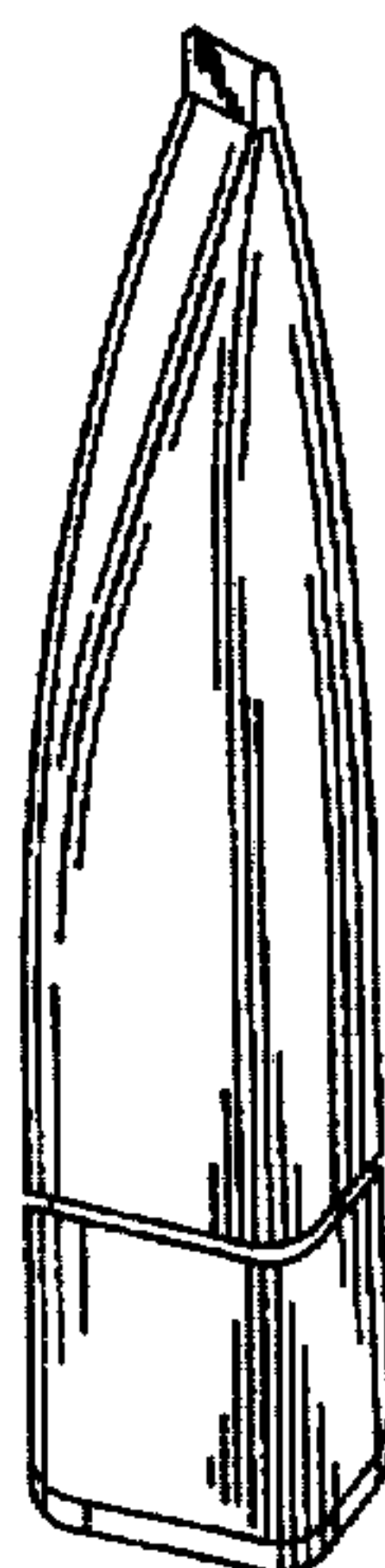
[57] **CLAIM**

DESCRIPTION

FIG. 1 is a front, elevational view of the flexible container design of my invention;
FIG. 2 is a bottom plan view thereof;
FIG. 3 is a left side view thereof, the right side of which is a mirror image thereto; and,
FIG. 4 is a top plan view thereof.

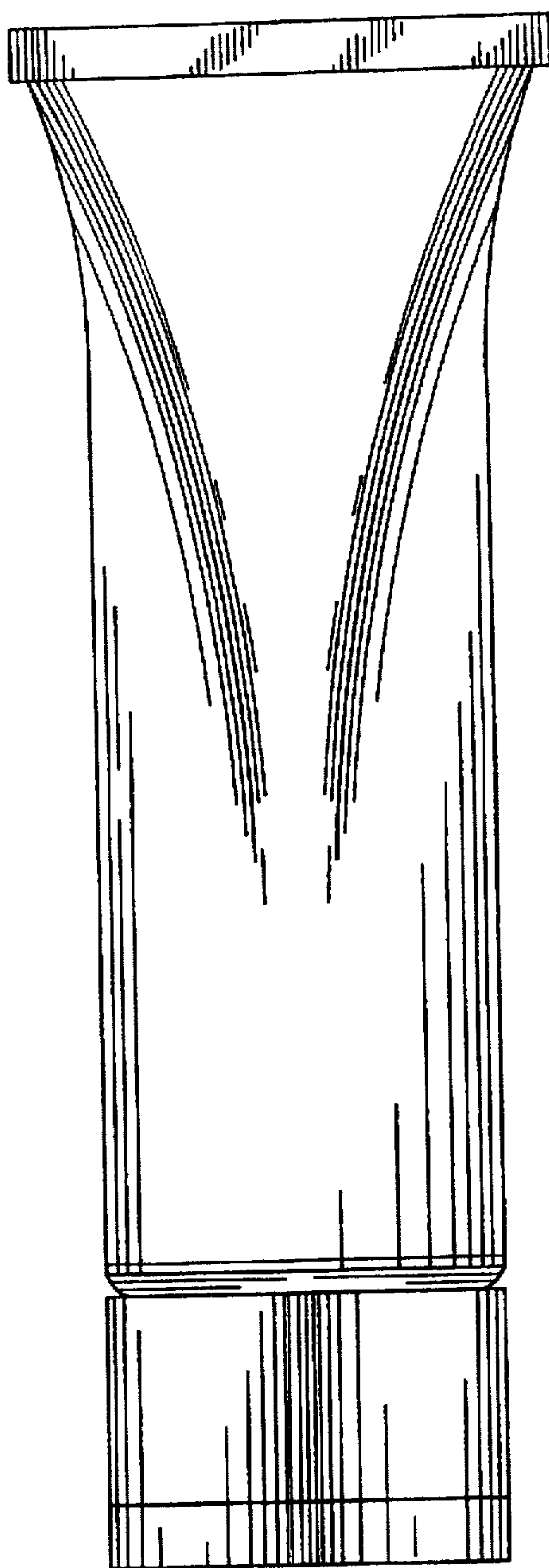

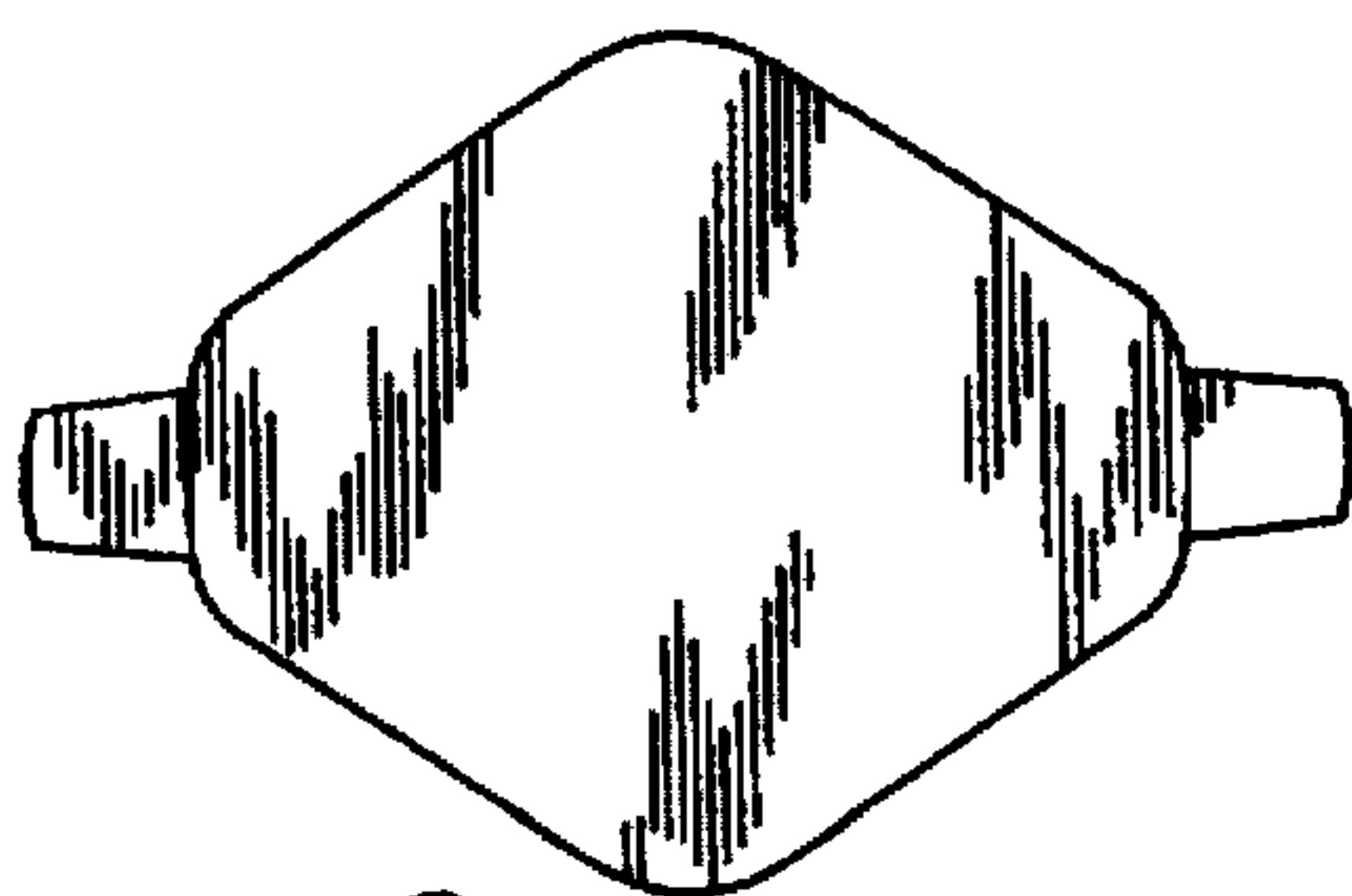

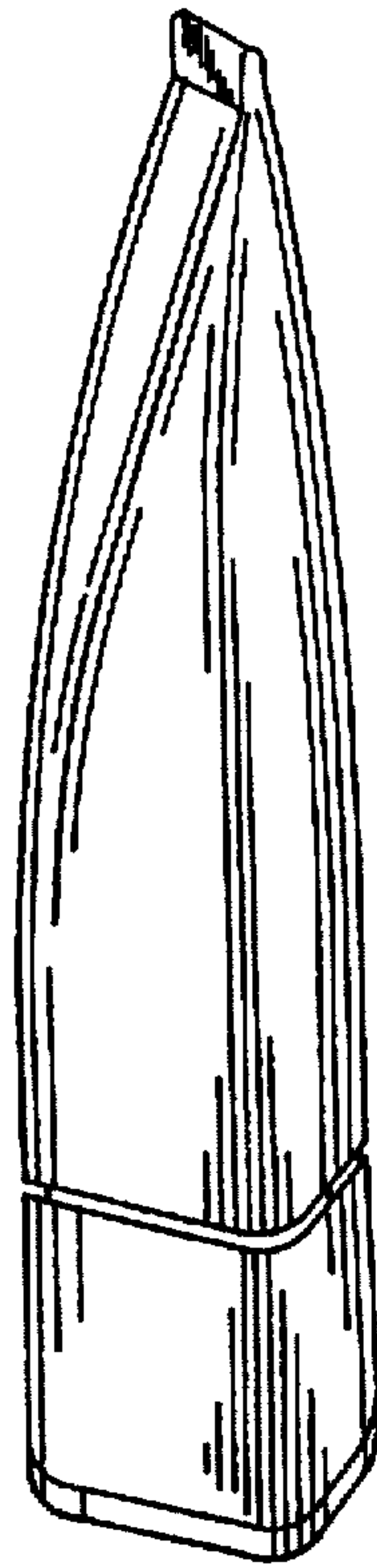

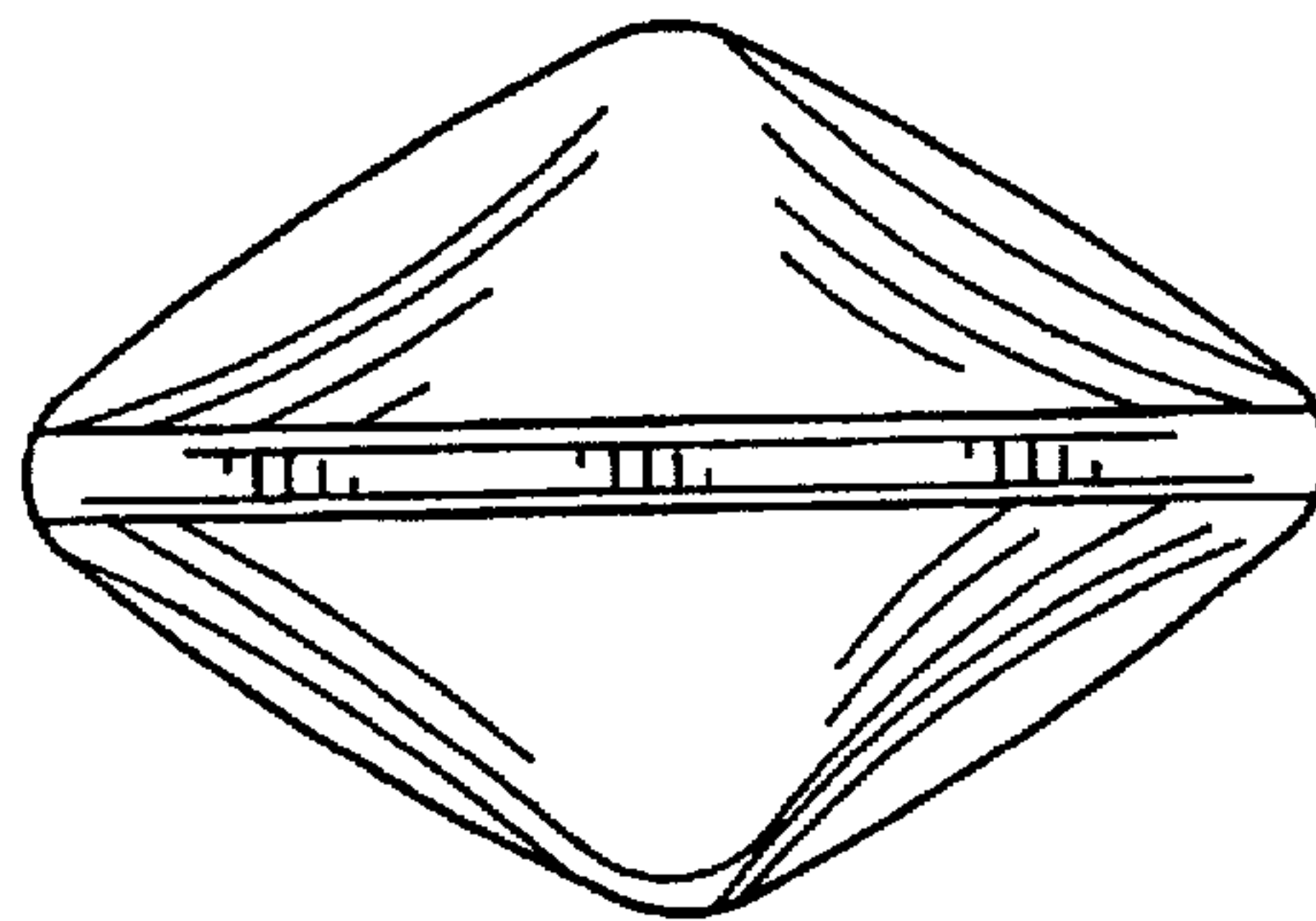
