[57] CLAIM

The ornamental design for a wheel, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view or the street side elevational view of the wheel;

FIG. 2 is a side elevational view of one side of the wheel;
FIG. 3 is a rear elevational view or brake drum side elevational view of the wheel;

FIG. 4 is a side elevational view of the wheel, opposite to the side elevational view in FIG. 2;

FIG. 5 is a reduced perspective view of the wheel from a front or street side perspective;

FIG. 6 is an end elevational view of the wheel;

FIG. 7 is another reduced perspective view of the wheel from a rear or brake drum side perspective;


FIG. 8 is an end elevational view of the wheel opposite to the end elevational view in FIG. 6;

FIG. 9 is a vertical sectional view taken in direction of the arrow and along the plane of line 9—9 in FIG. 1;

FIG. 10 is an enlarged vertical sectional view taken in direction of the arrows and along the plane of line 10—10 in FIG. 1;

FIG. 11 is an enlarged vertical sectional view taken in the direction of the arrows and along the plane of line 11—11 in FIG. 3.






















