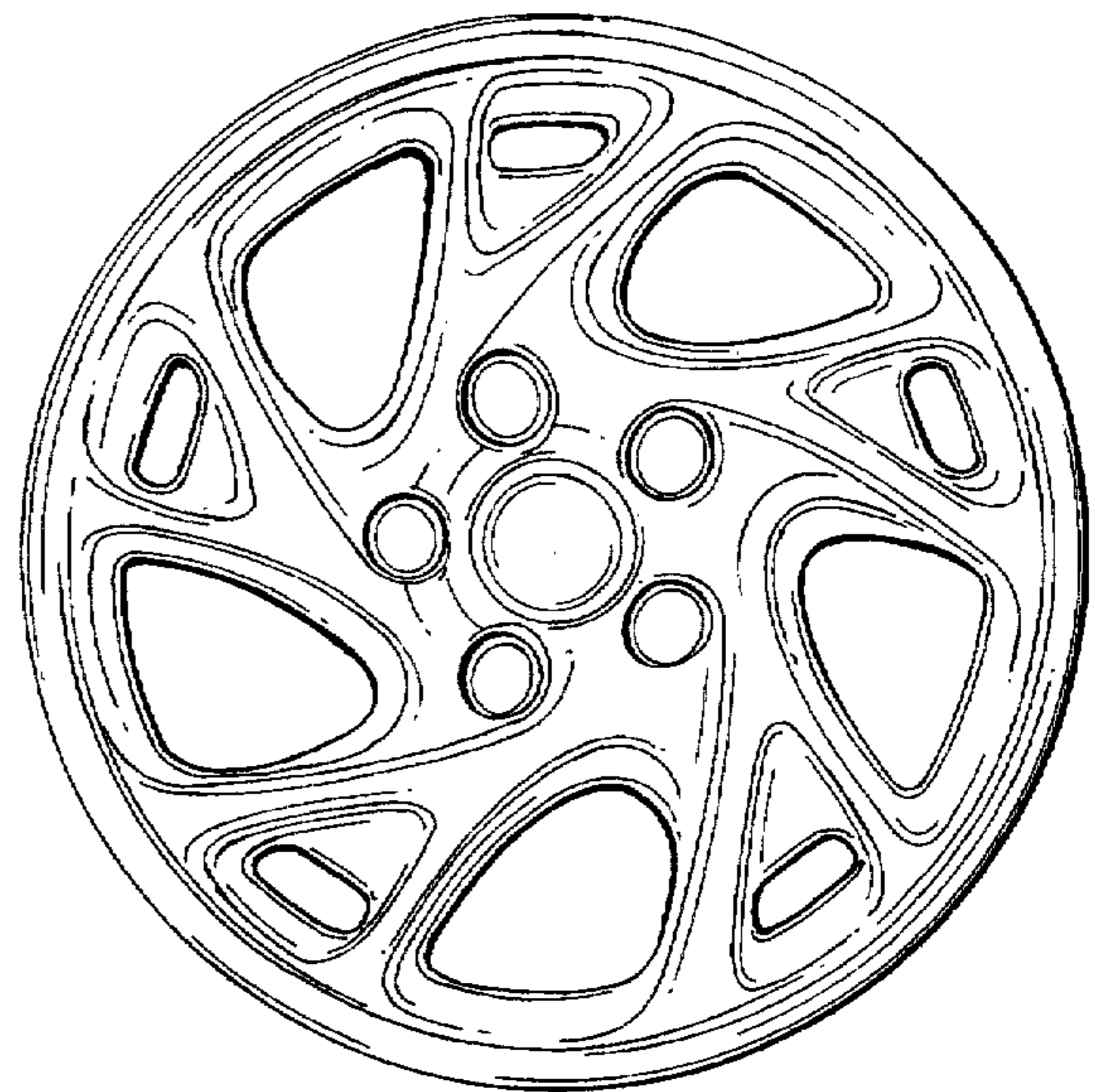
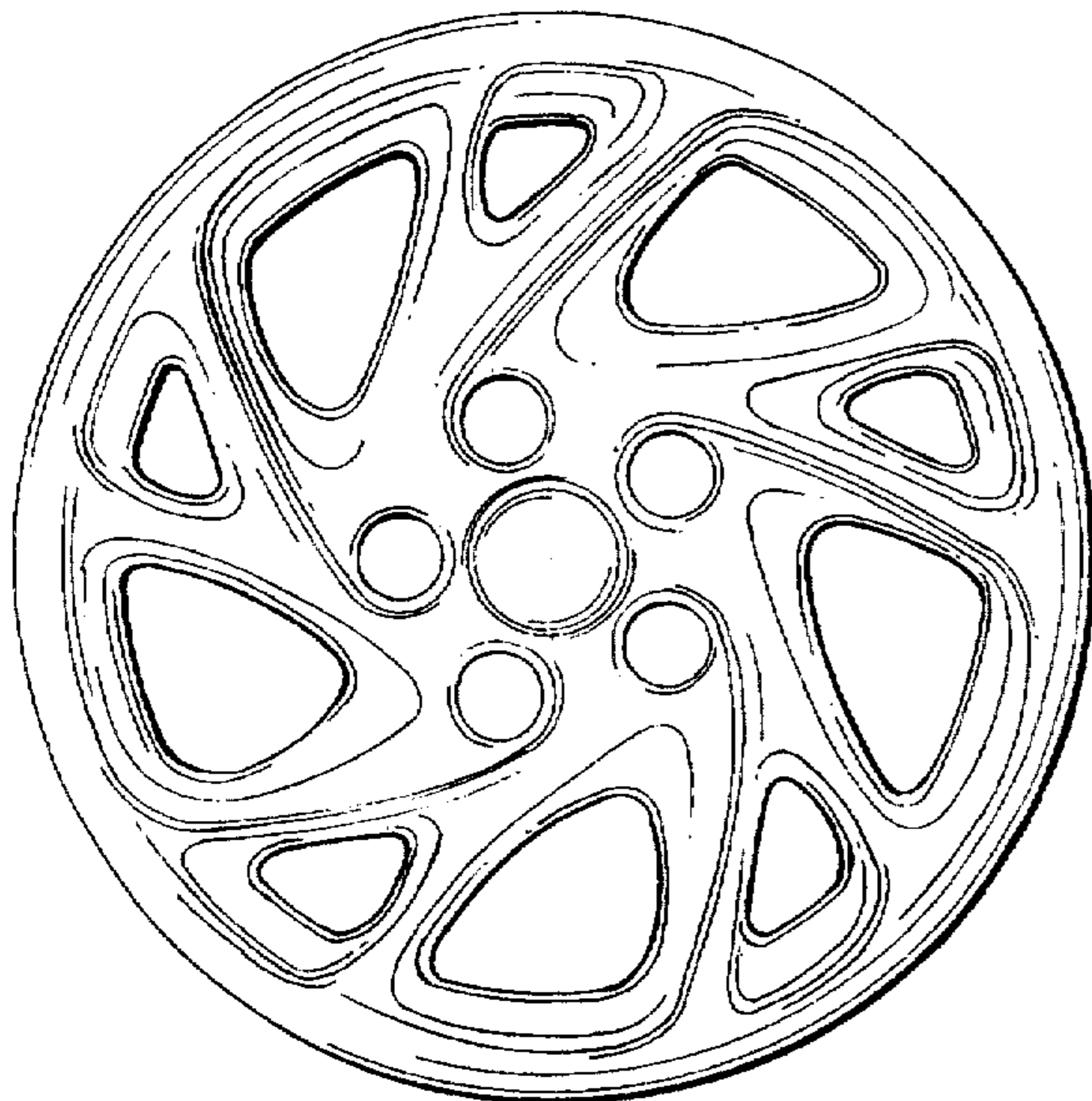
[57] **CLAIM**

The ornamental design for a front face of a vehicle wheel, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a front face of a vehicle wheel according to a first embodiment of my novel design;
FIG. 2 is a perspective view of a front face of a vehicle wheel according a first embodiment of my novel design;
FIG. 3 is a front view of a front face of a vehicle wheel according to a second embodiment of my novel design;
FIG. 4 is a perspective left side view of a front face of a vehicle wheel according to a second embodiment of my novel design; and,
FIG. 5 is a perspective right side view of a front face of a vehicle wheel according to a second embodiment fo my novel design.

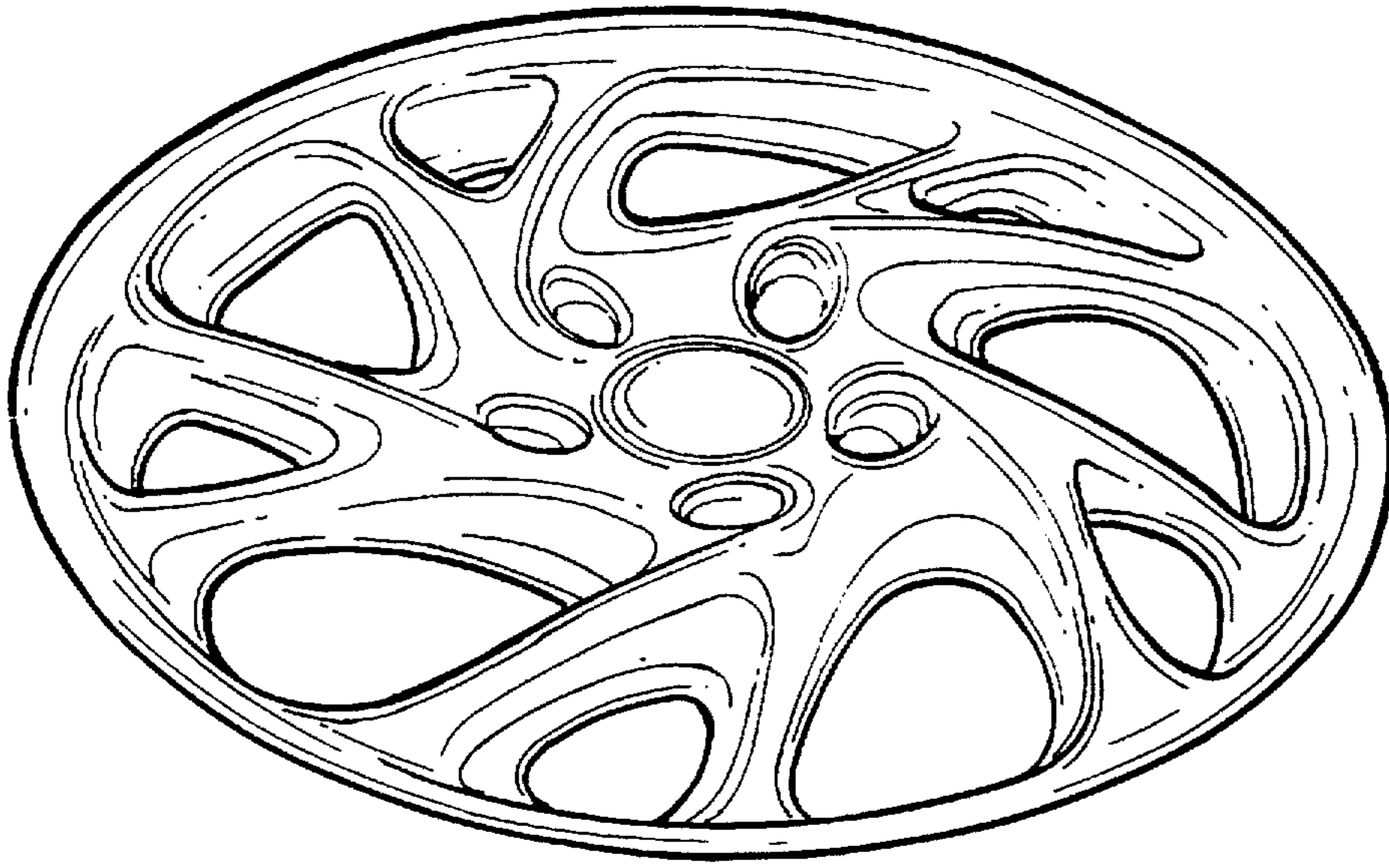

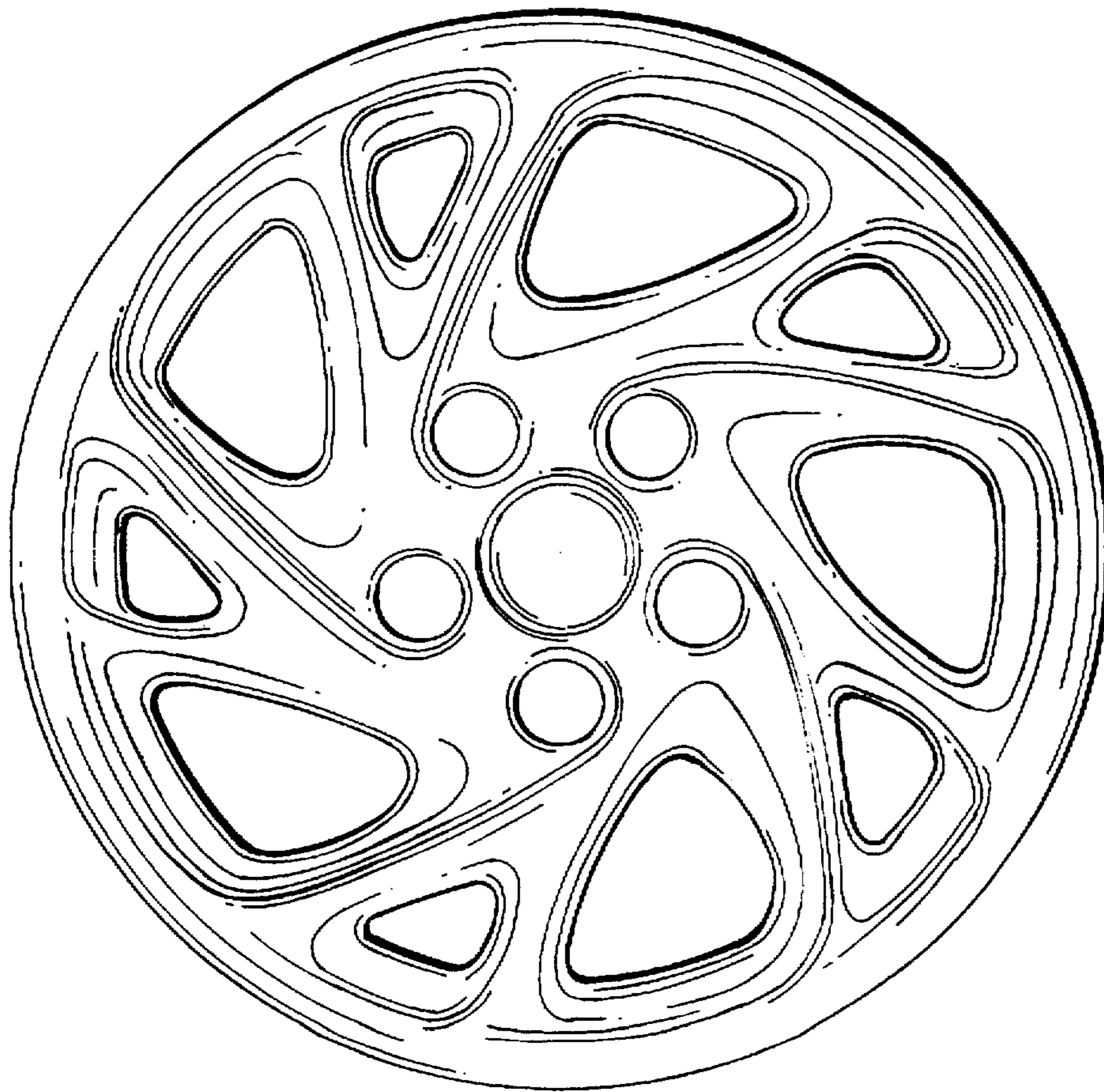

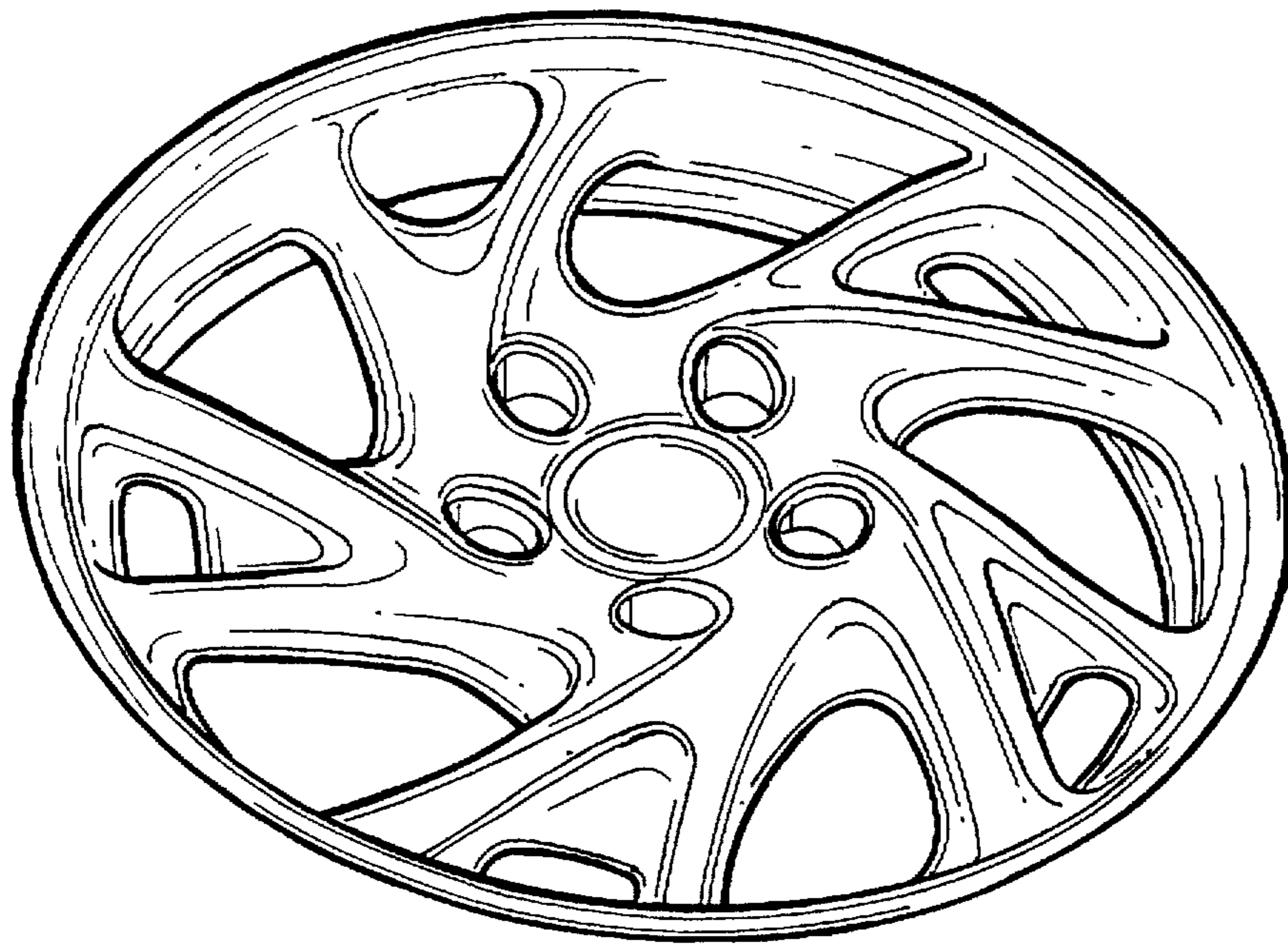

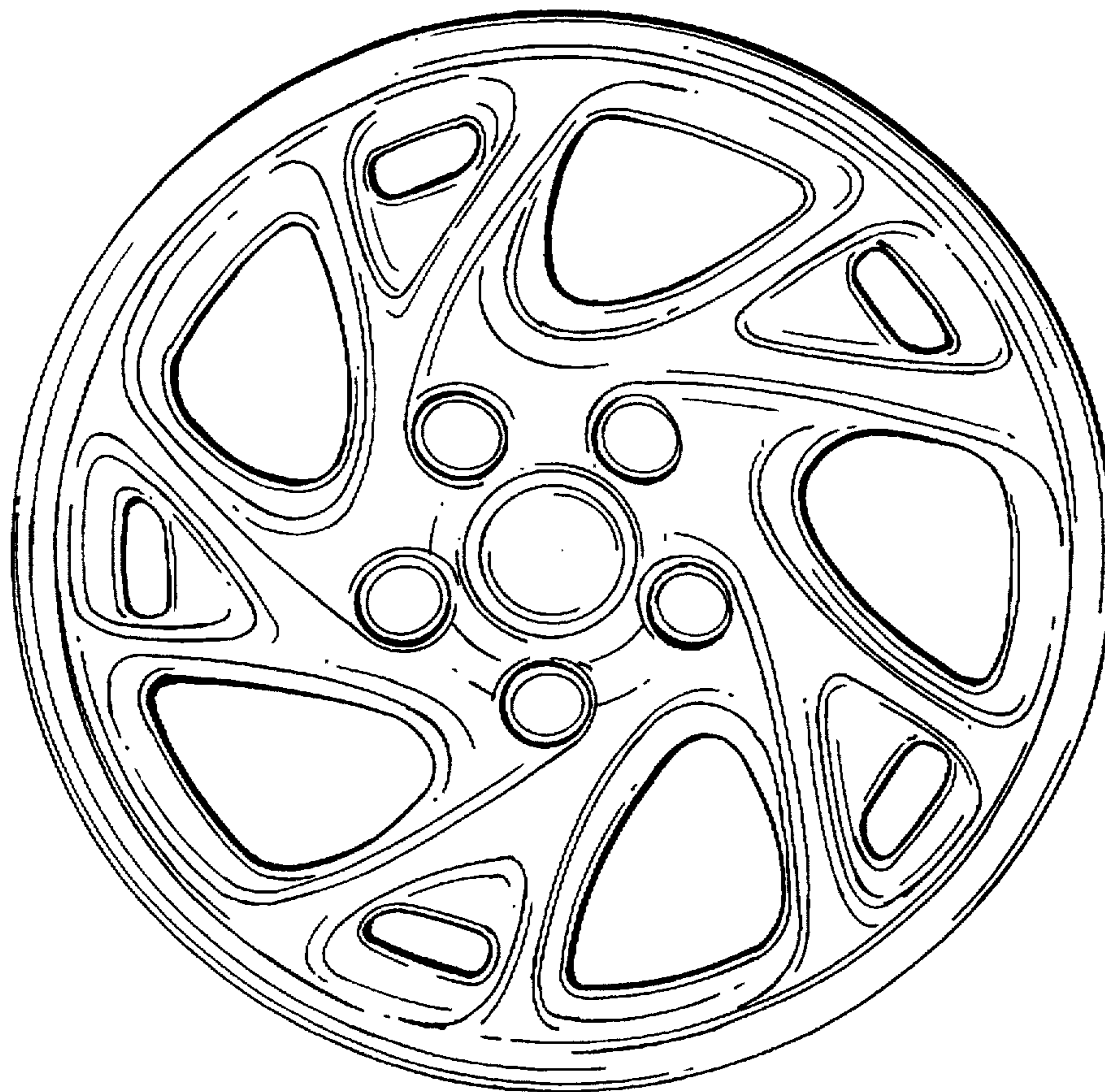

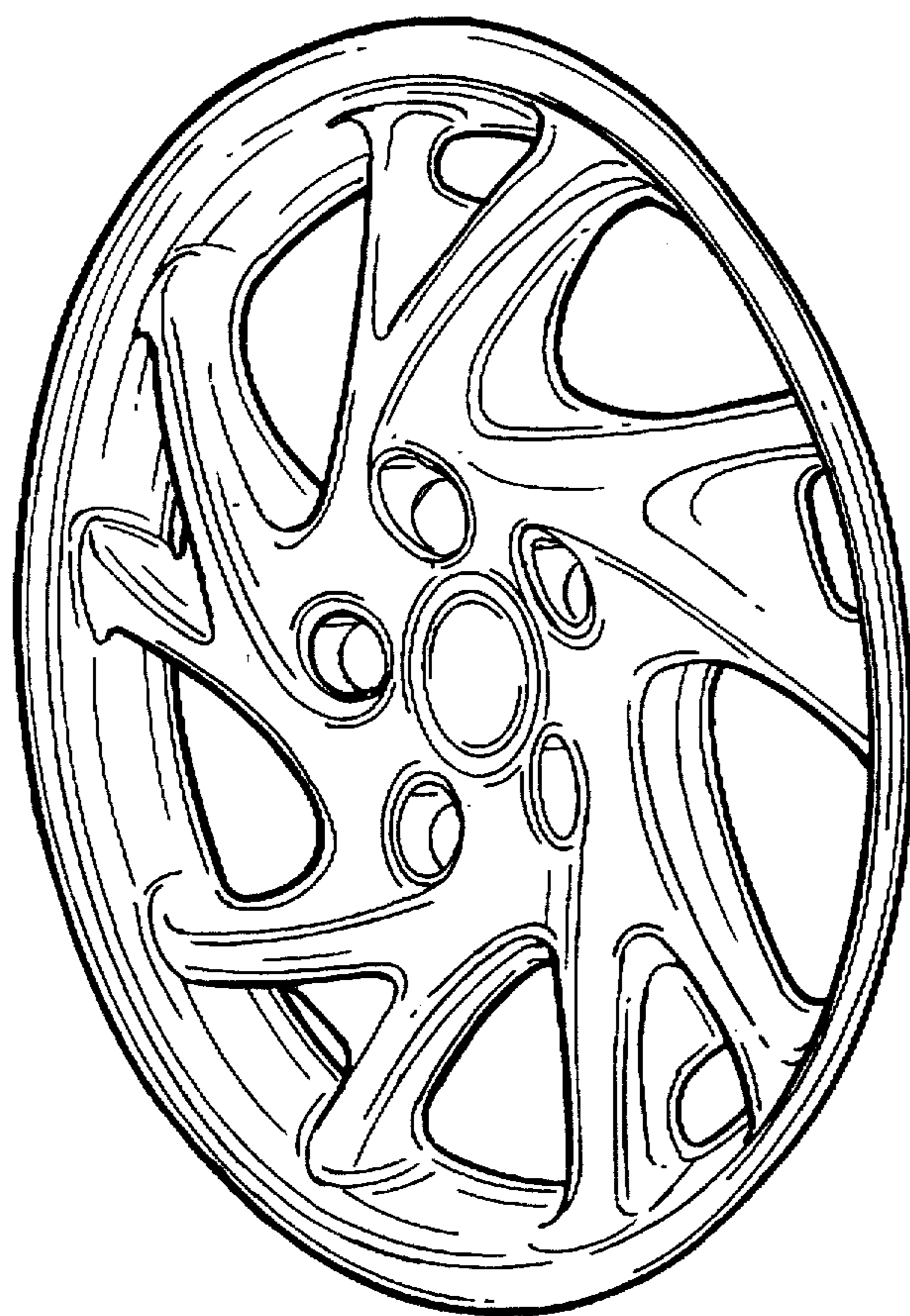
