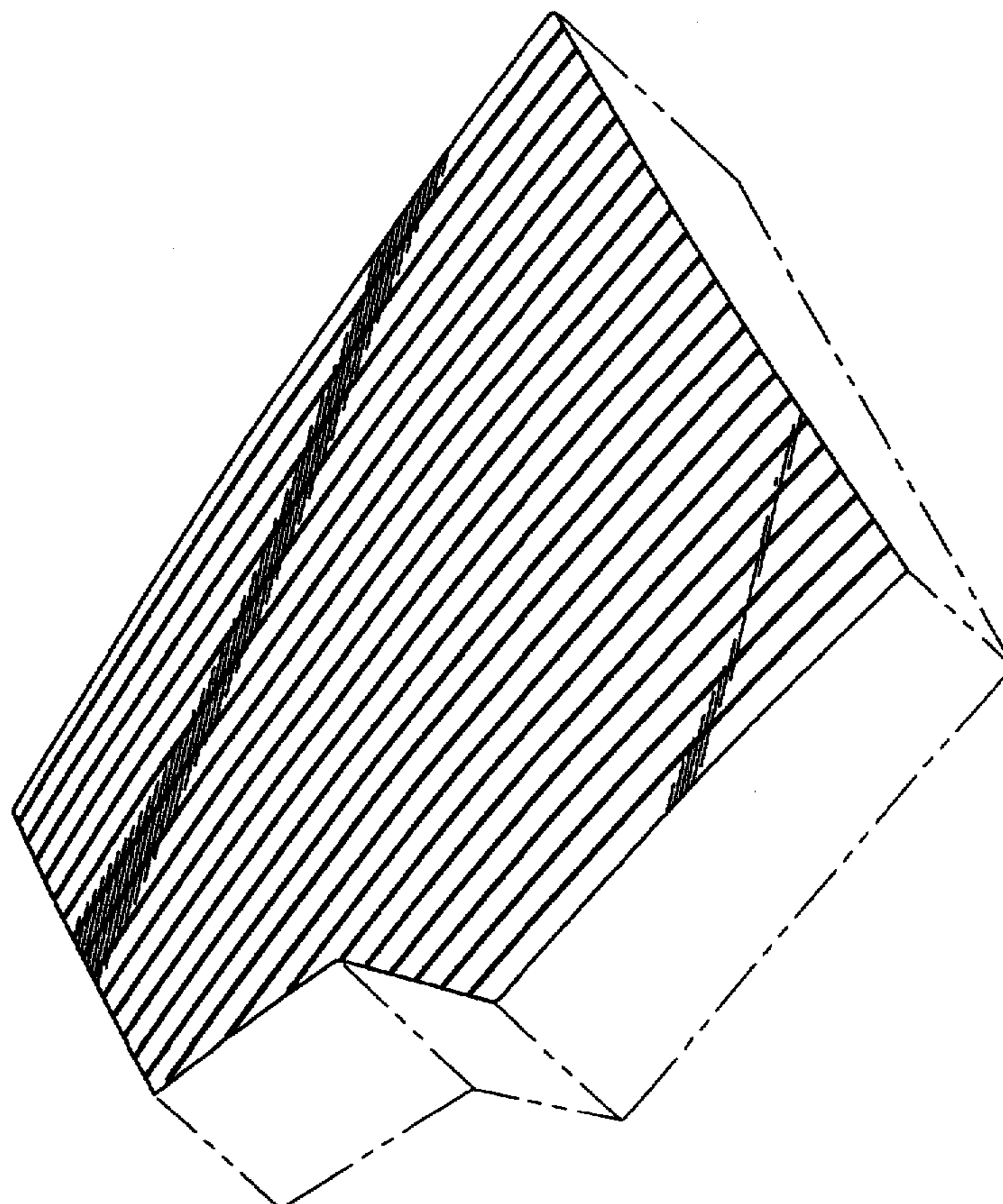
The ornamental design for a cellular base station, as shown and described.

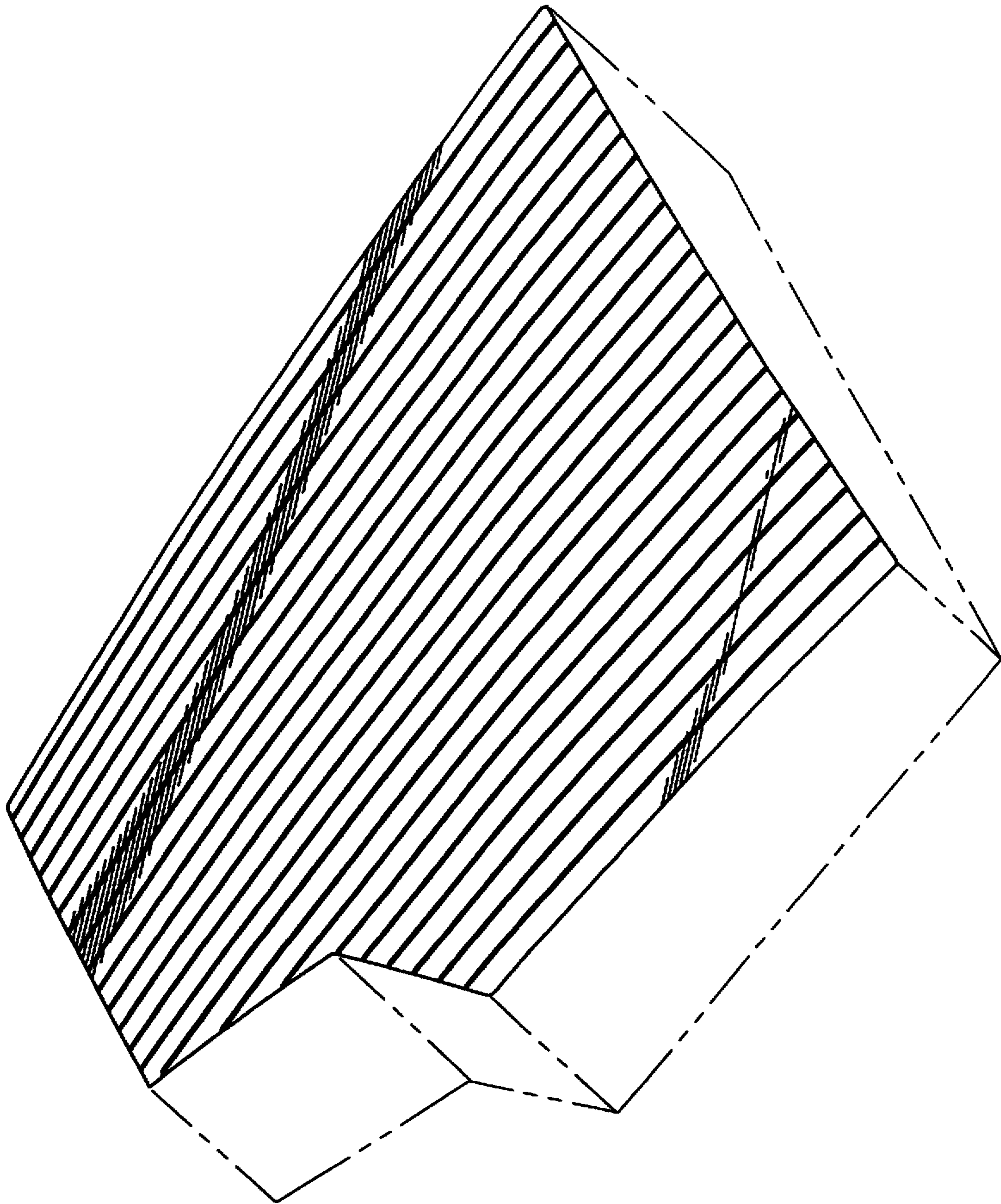

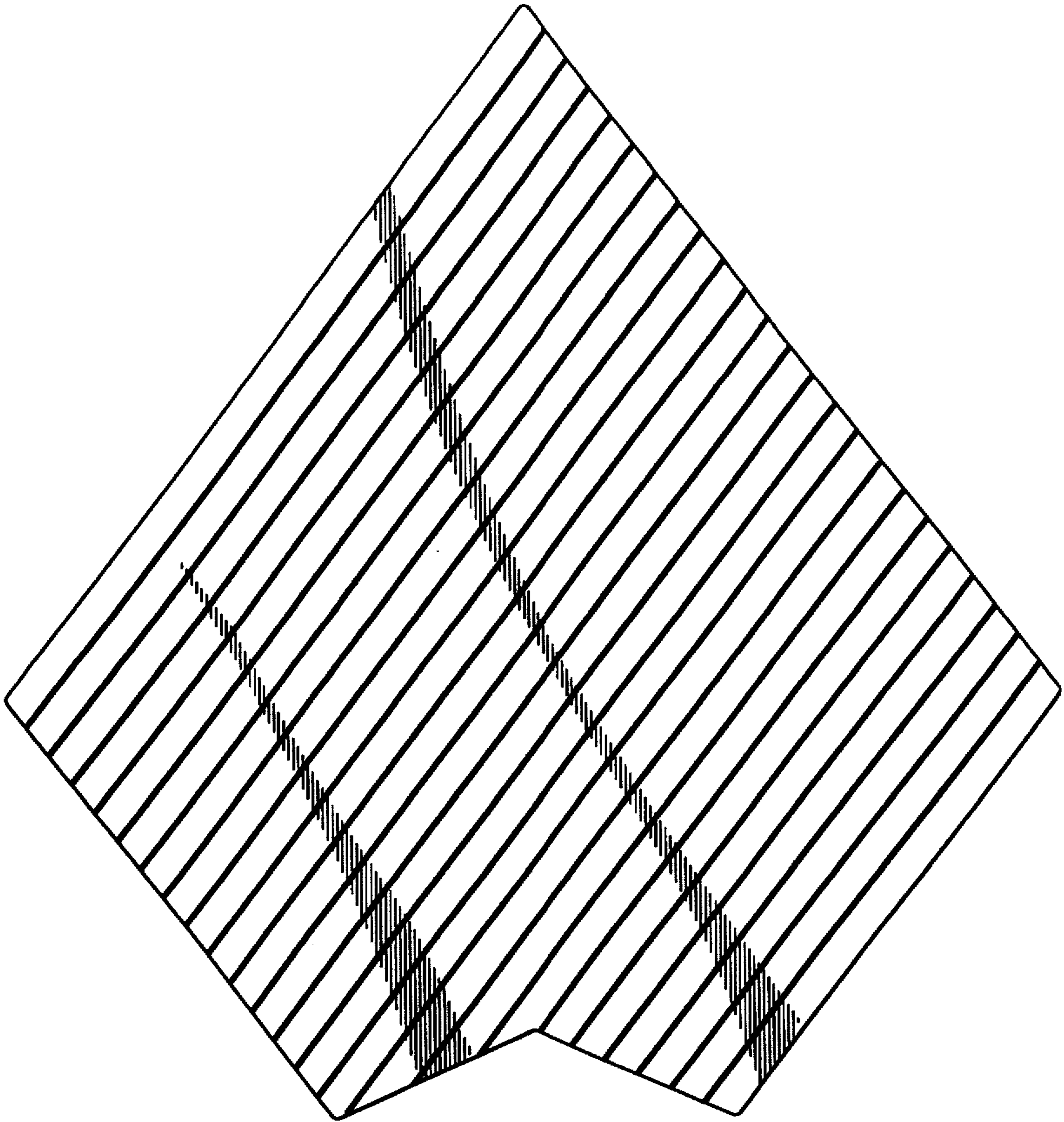

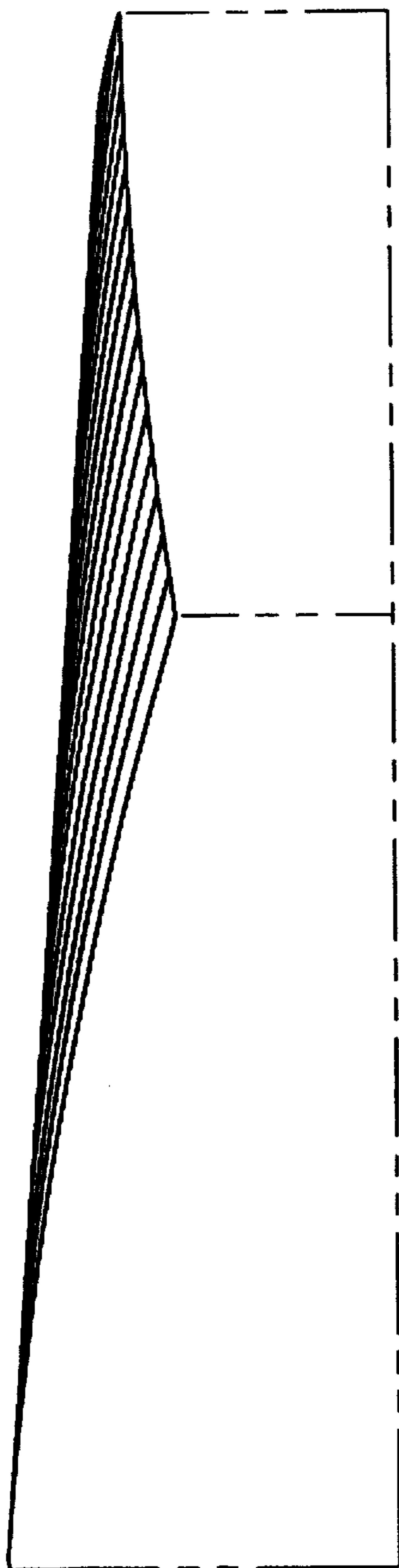

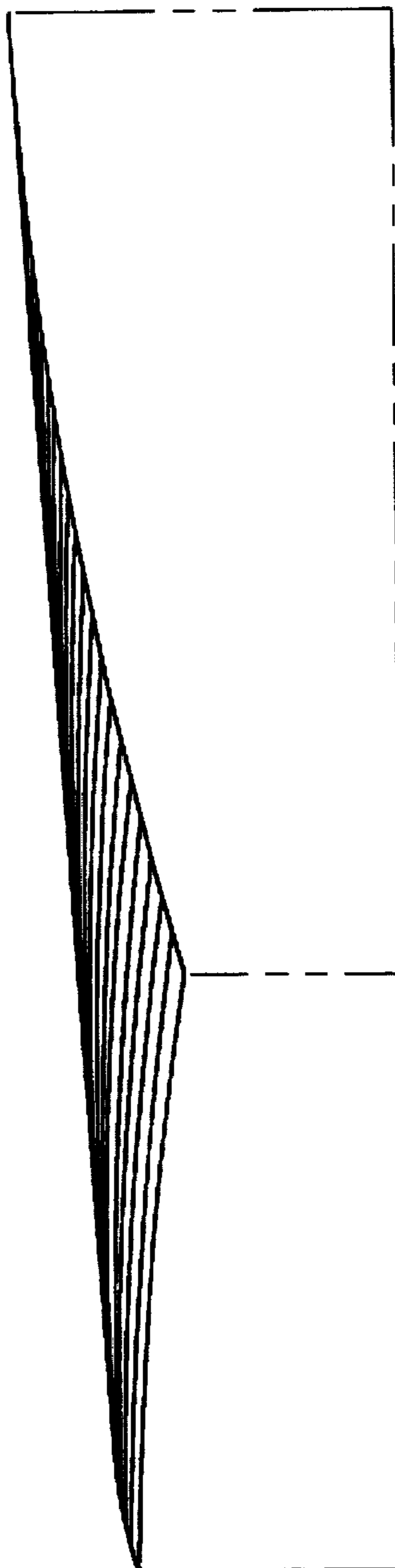

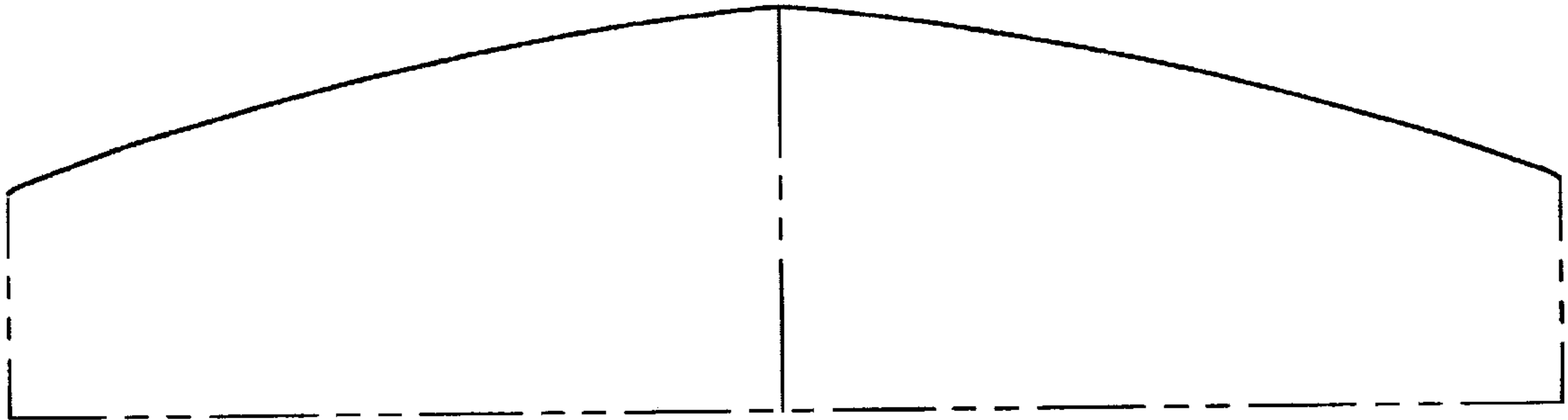

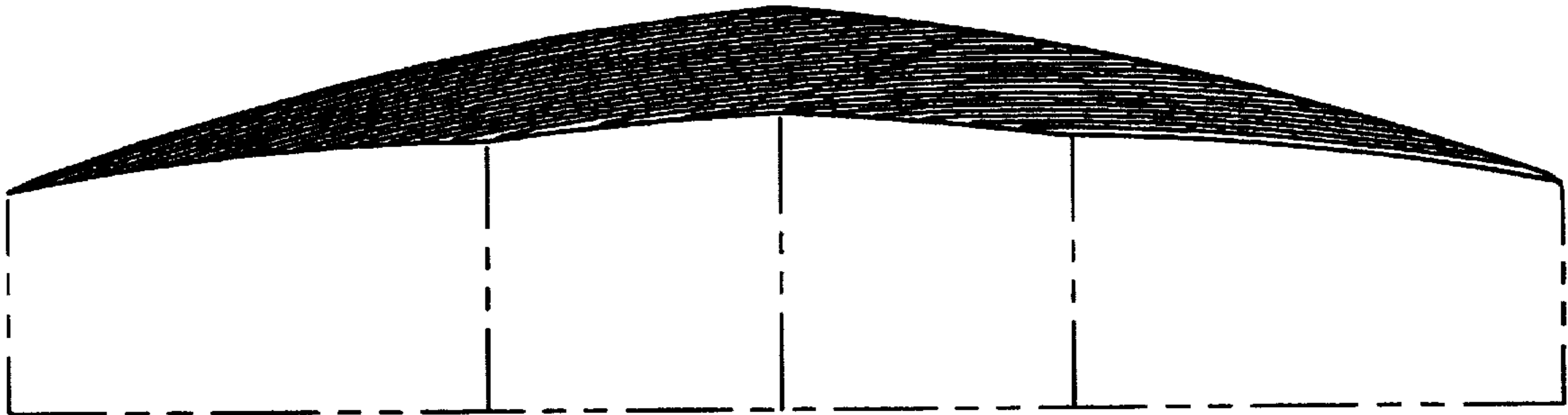
