## [57] CLAIM

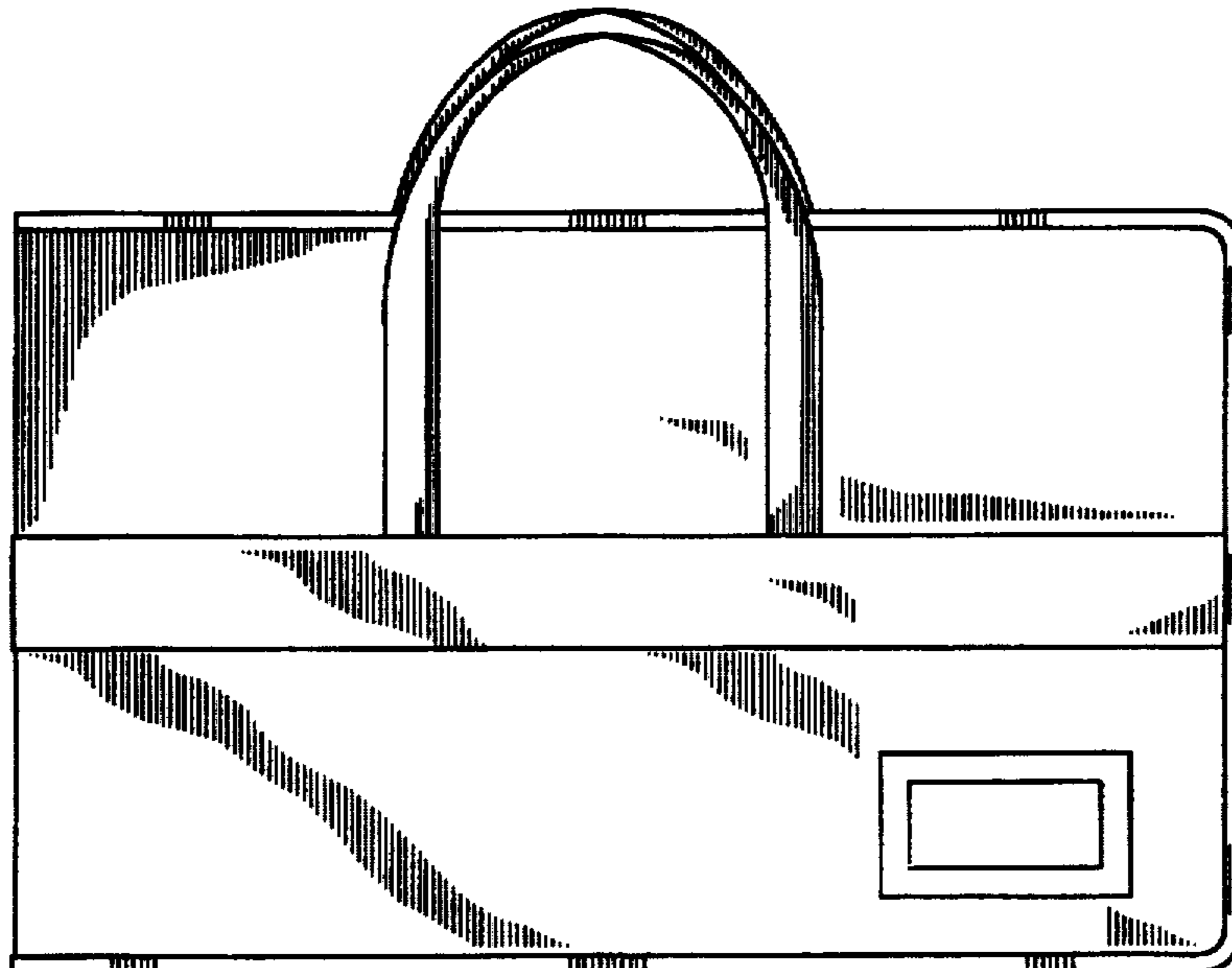
The ornamental design for a document case, as shown and described.

## DESCRIPTION

FIG. 1 is a front view of a document case showing our new design in a closed position;  
 FIG. 2 is a rear view thereof;  
 FIG. 3 is a right side view thereof;  
 FIG. 4 is a left side view thereof;  
 FIG. 5 is a top plan view thereof;  
 FIG. 6 is a bottom plan view thereof;  
 FIG. 7 is a fragmentary view of the front left side thereof, in an opened position;  
 FIG. 8 is a fragmentary view of the front right side thereof;  
 FIG. 9 is a fragmentary view of the rear left side thereof;  
 FIG. 10 is a fragmentary view of the rear right side thereof;  
 FIG. 11 is a left side elevational view thereof;  
 FIG. 12 is a right side elevational view thereof;  
 FIG. 13 is a fragmentary top plan view of the left side thereof;  
 FIG. 14 is a fragmentary bottom plan view of the left side thereof;  
 FIG. 15 is a fragmentary top plan view of the right side thereof; and,  
 FIG. 16 is a fragmentary bottom plan view of the right side thereof.

The cross-hatched surface shading on the left side of FIG. 7 represents netting.

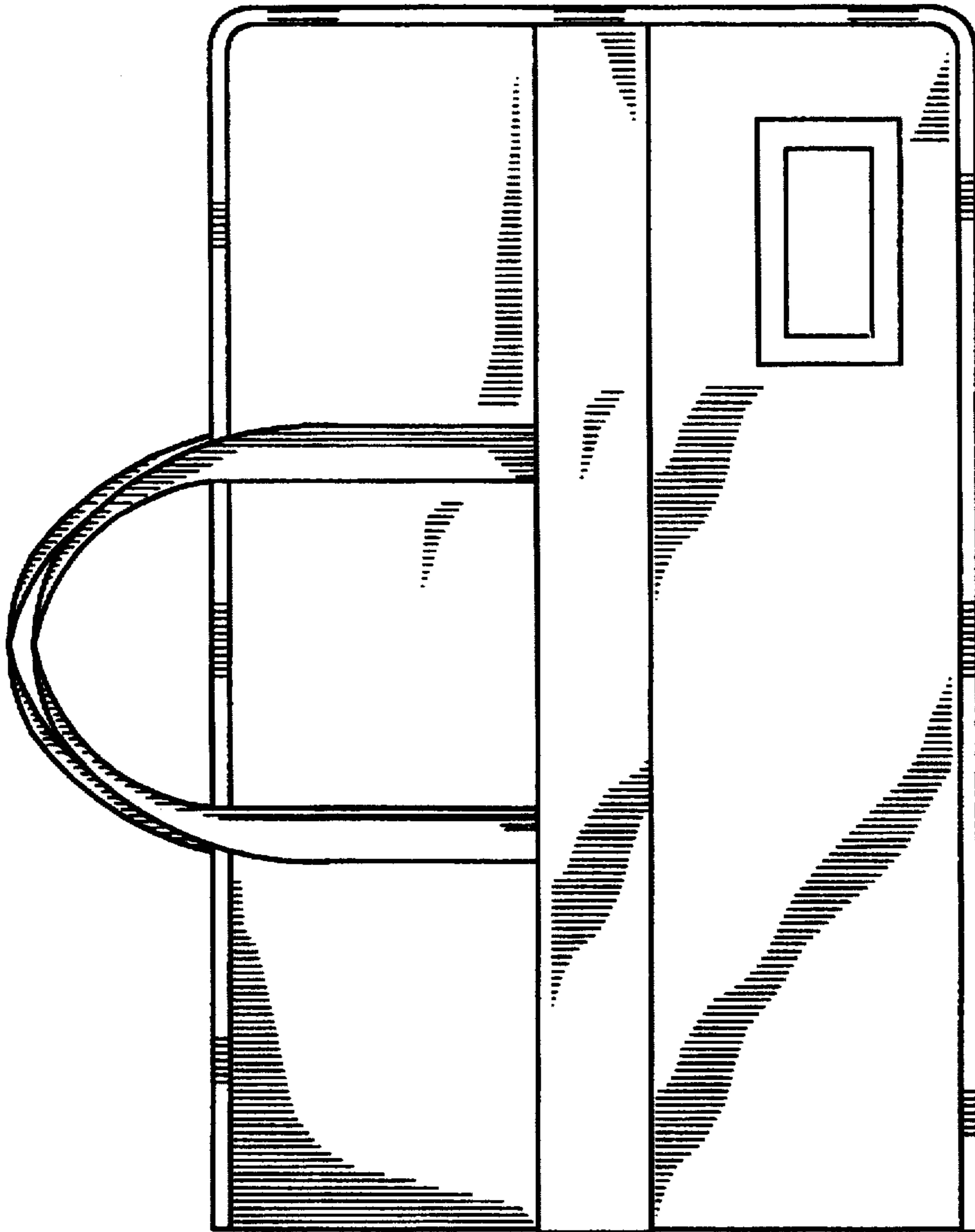

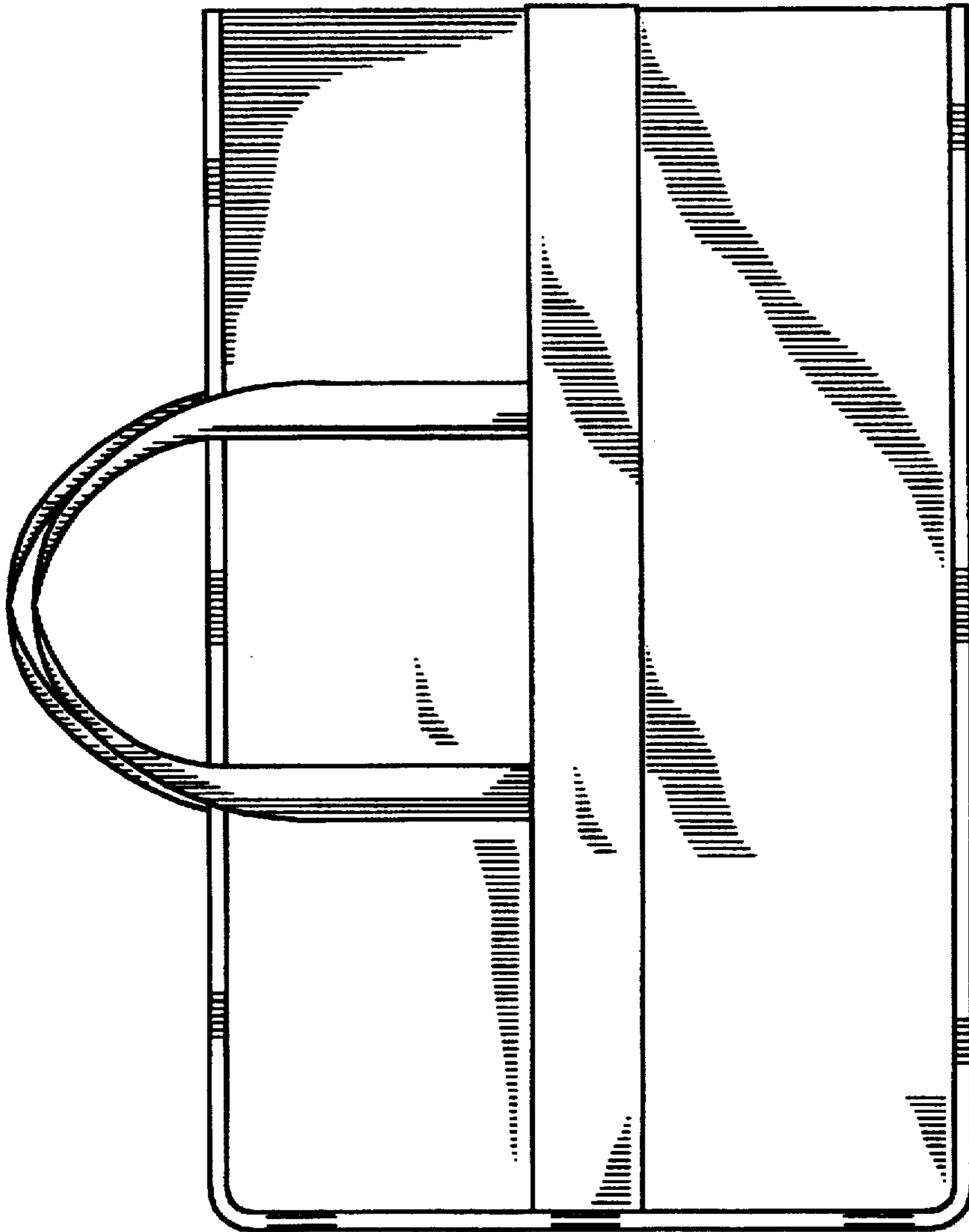

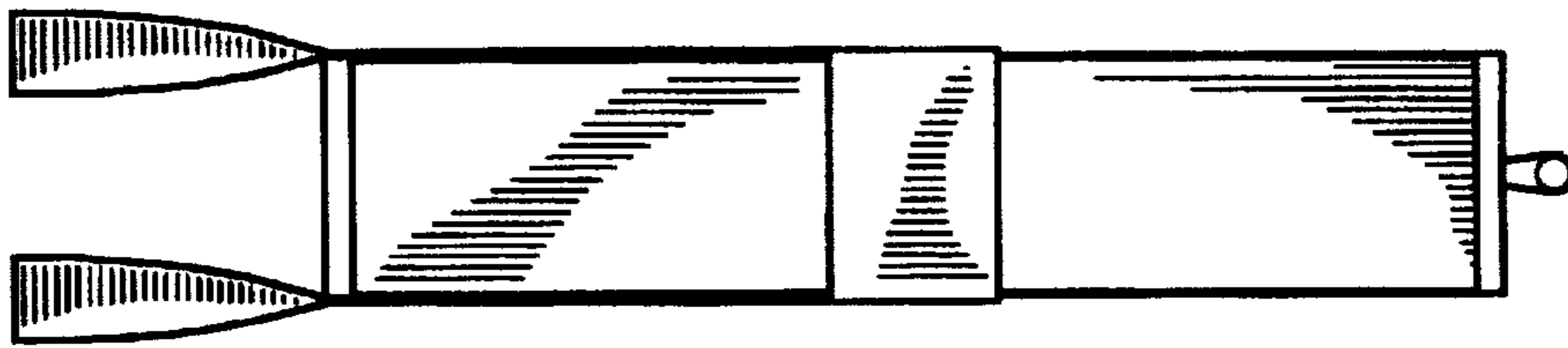

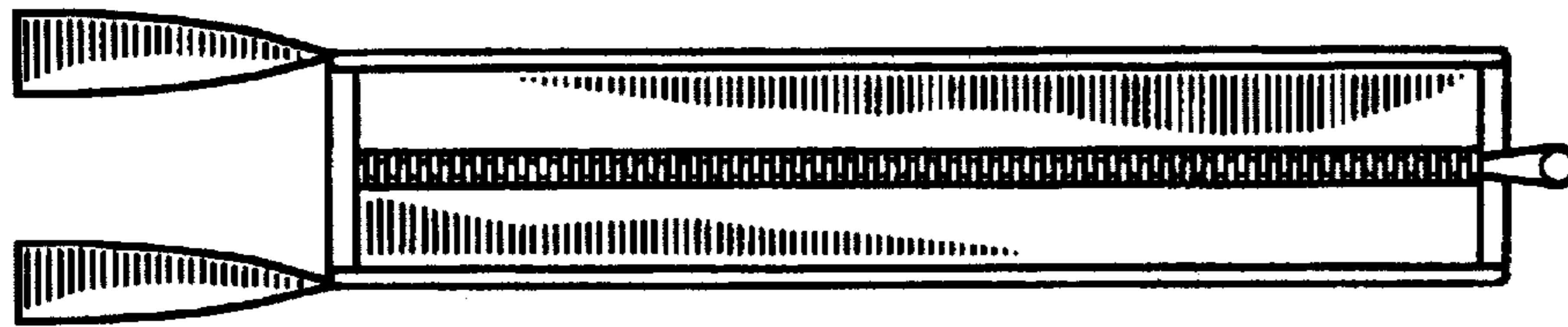

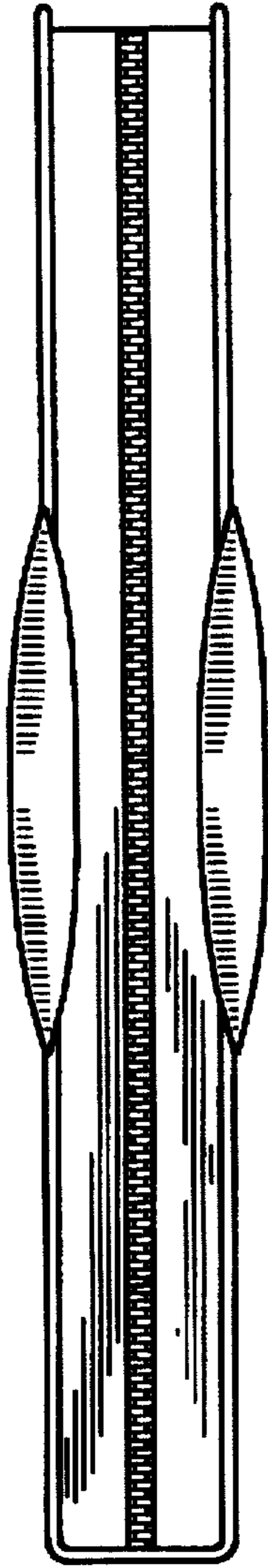

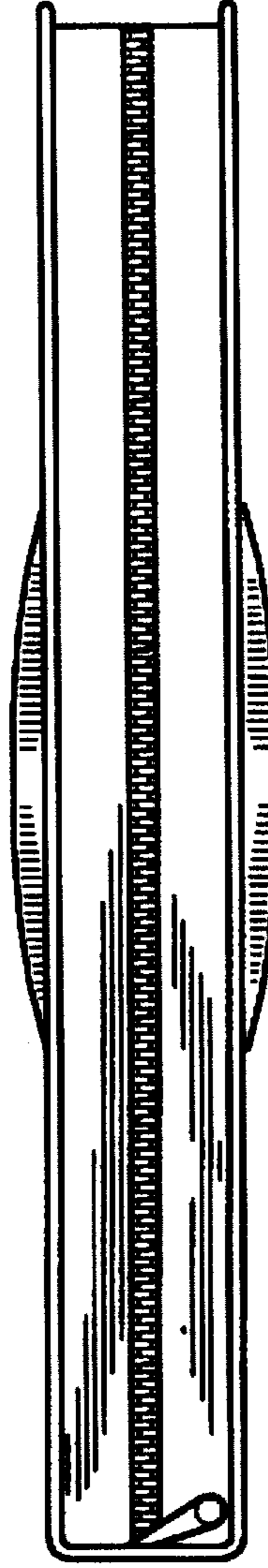

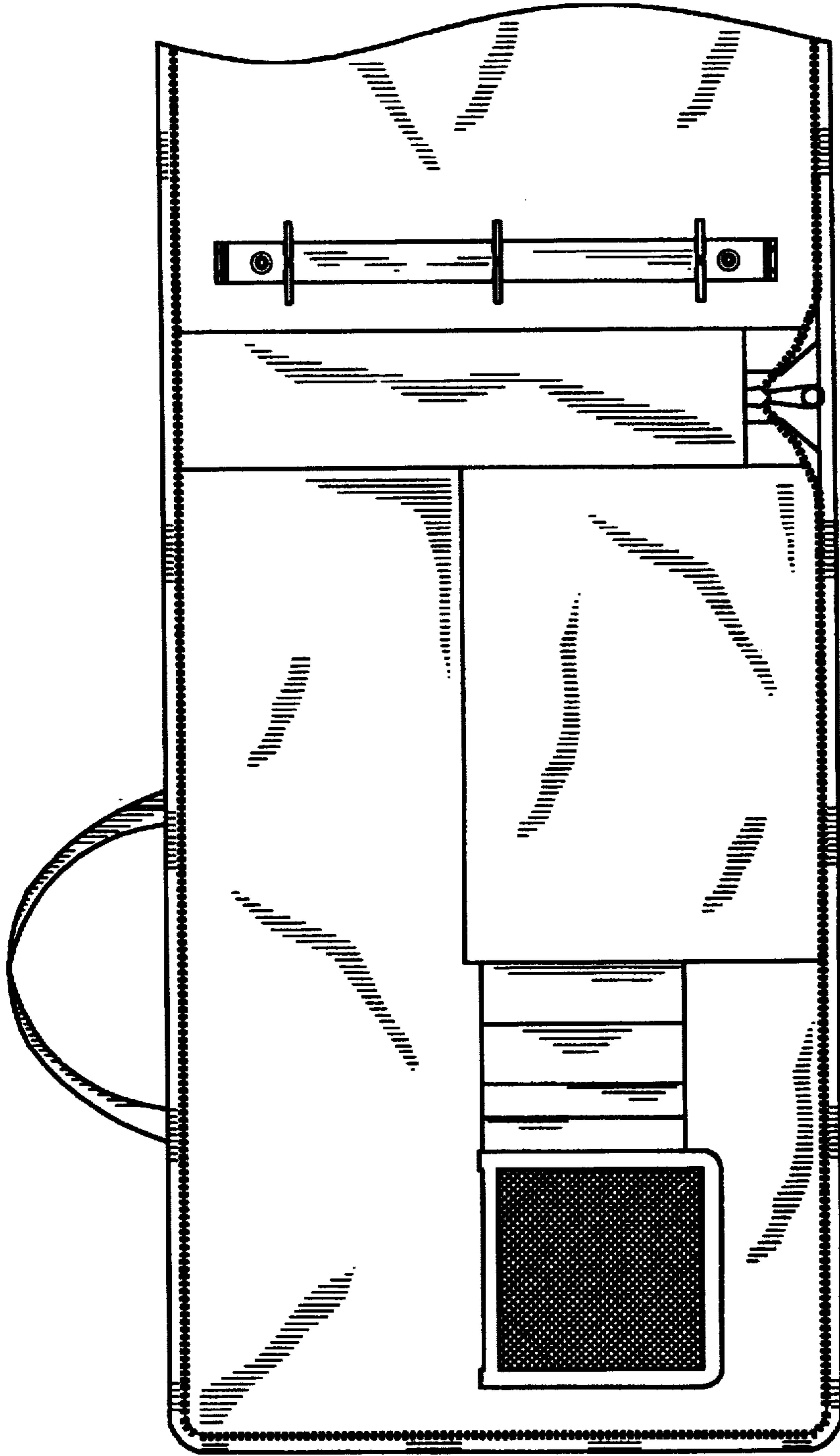

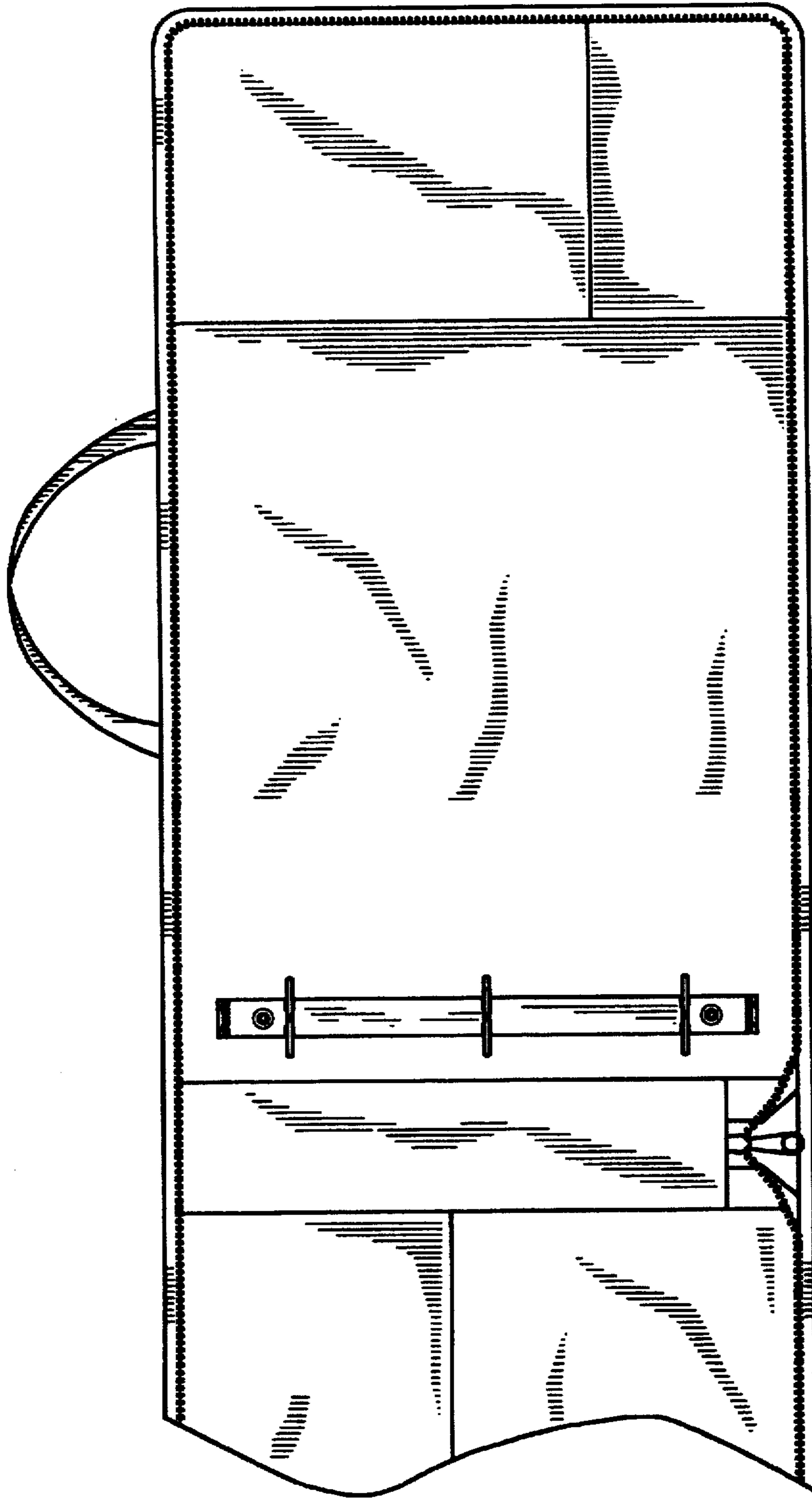

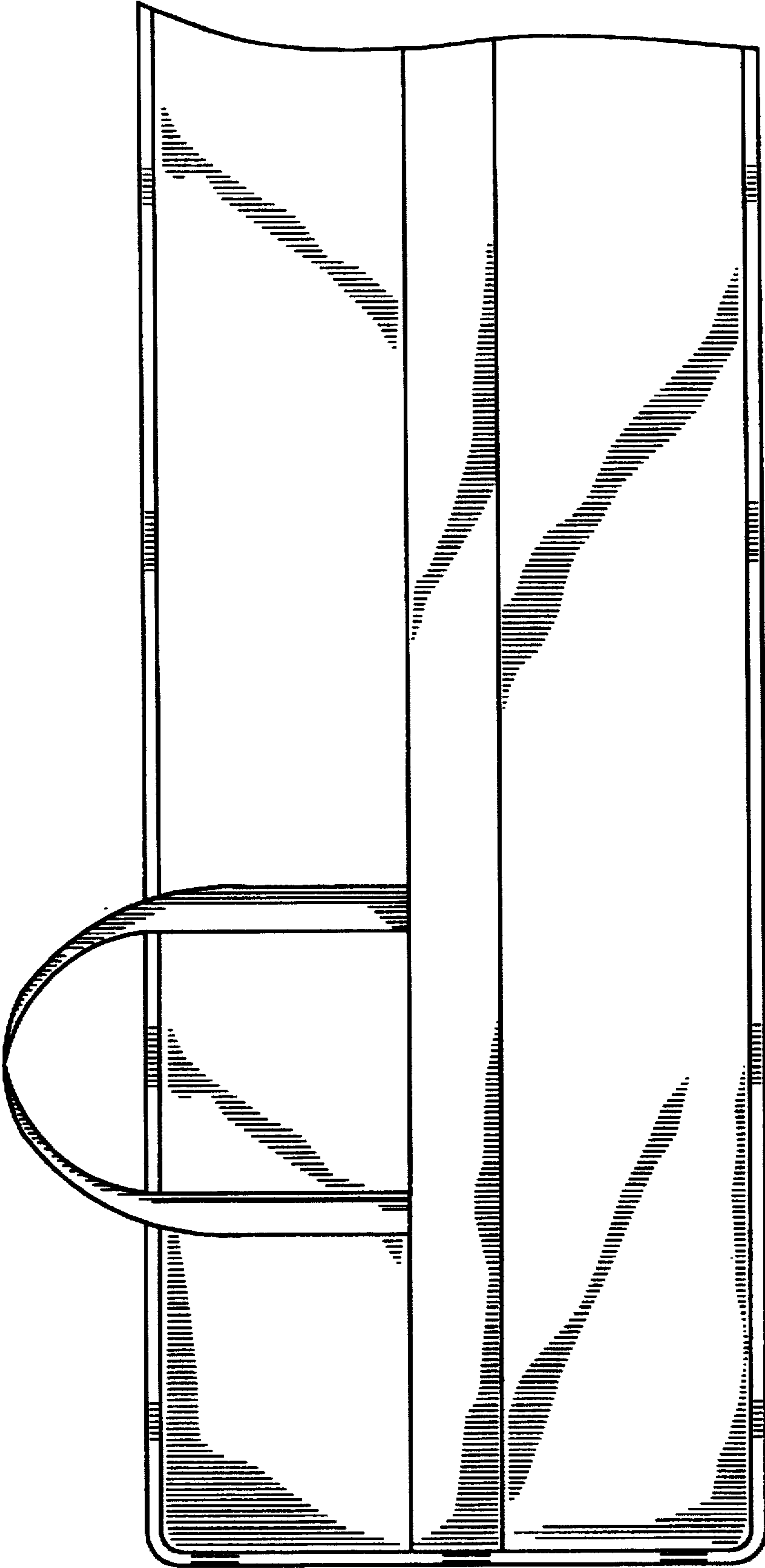

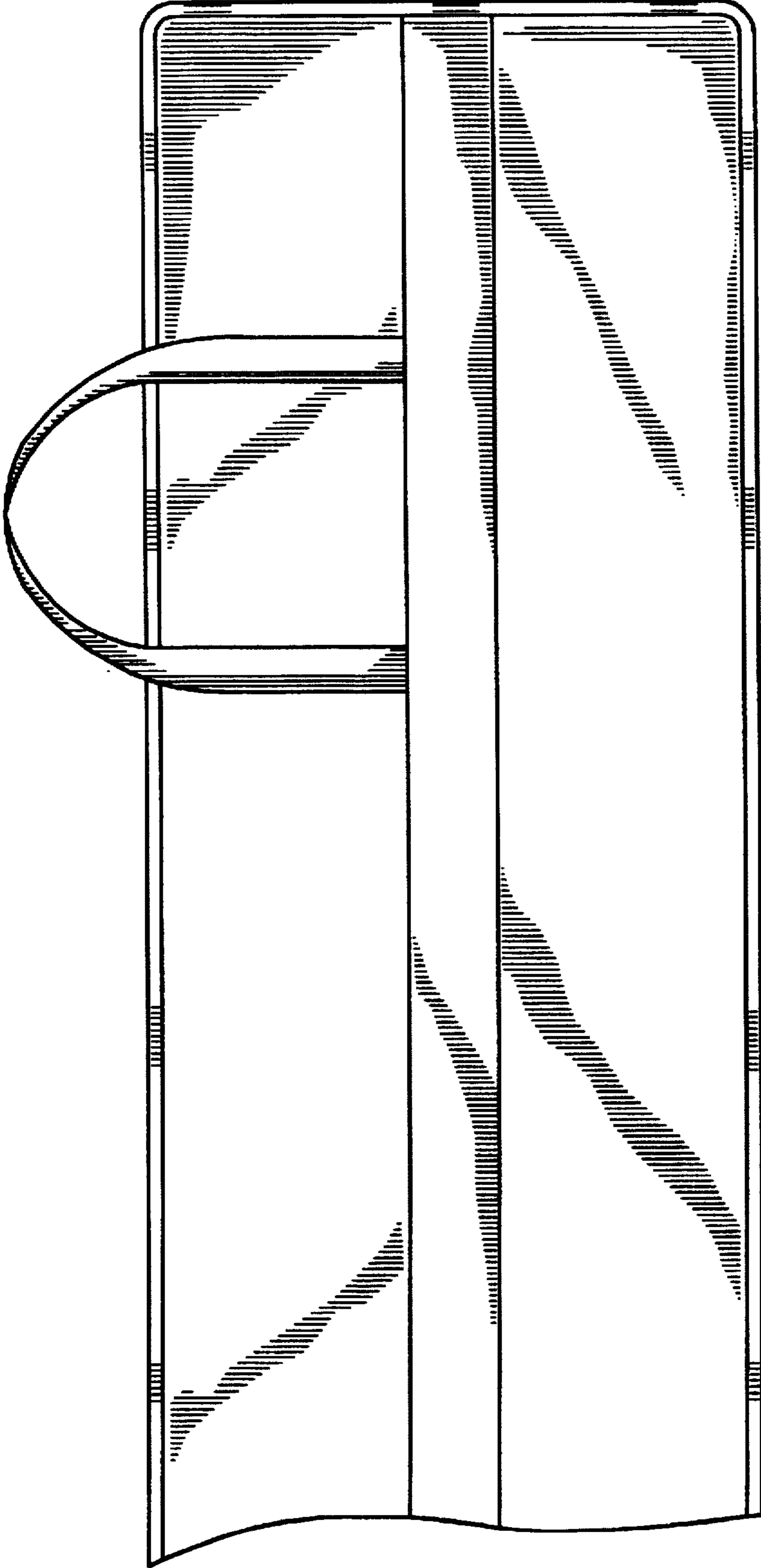

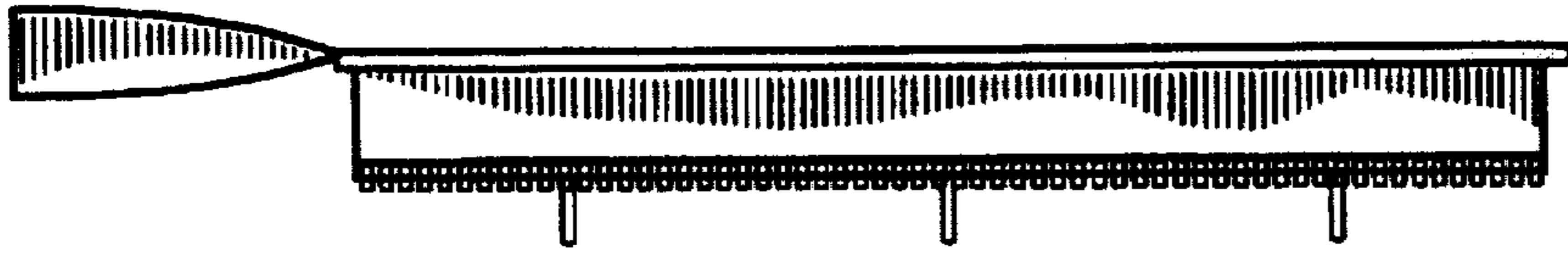

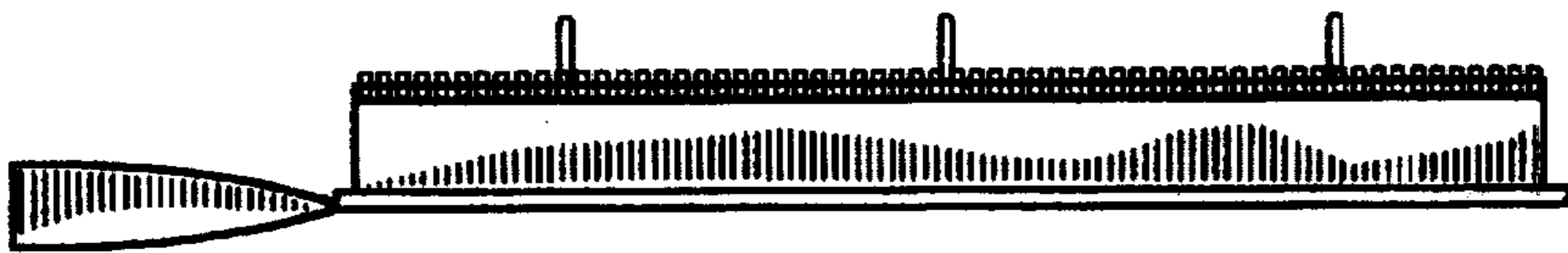

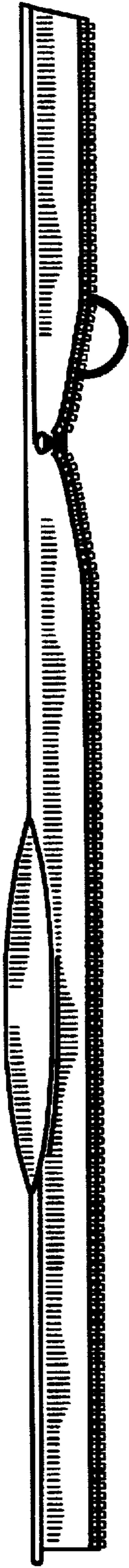

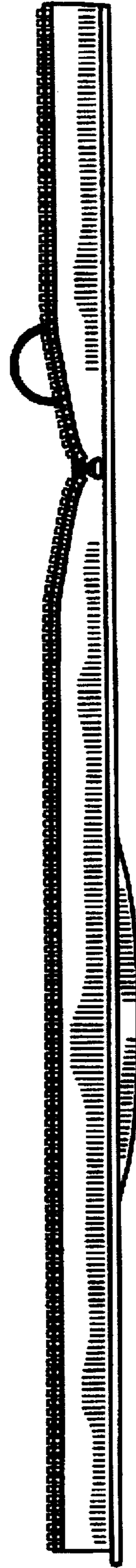

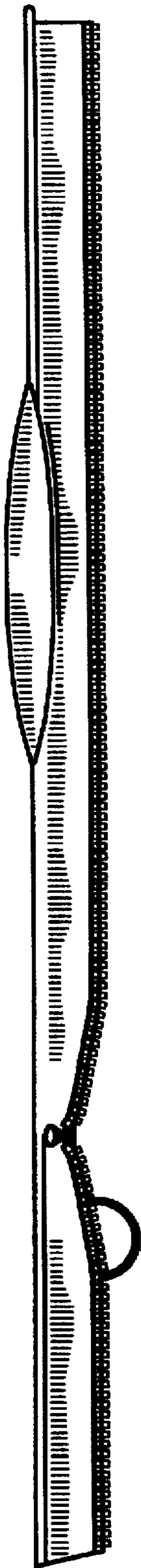

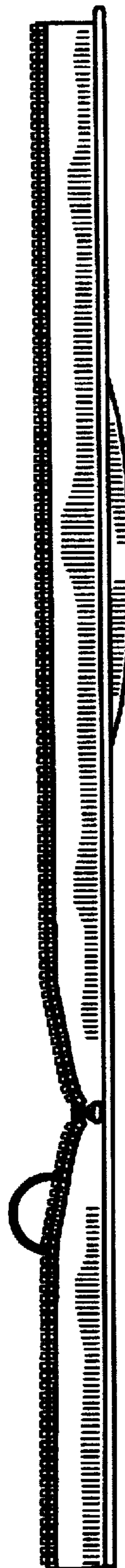
