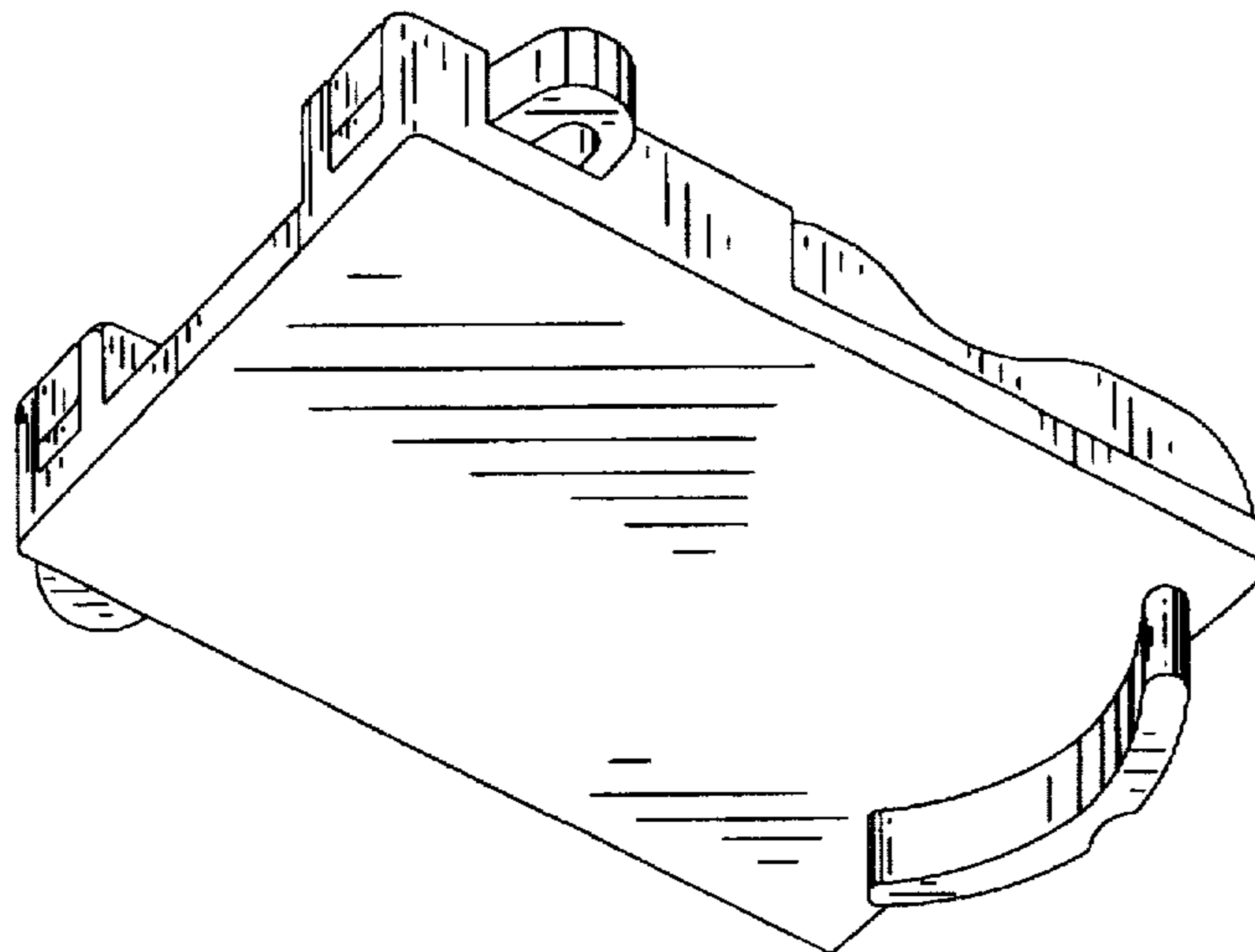
[57] **CLAIM**

The ornamental design for sealing valve, as shown and described.

DESCRIPTION

FIG. 1 is a right front perspective view of a sealing valve for use in connection with a milk pipeline valve, showing my new design;
FIG. 2 is a rear left perspective view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a right side elevational view thereof;
FIG. 5 is a bottom plan view thereof;
FIG. 6 is a rear elevational view thereof;
FIG. 7 is a left side elevational view thereof; and,
FIG. 8 is a top plan view thereof.

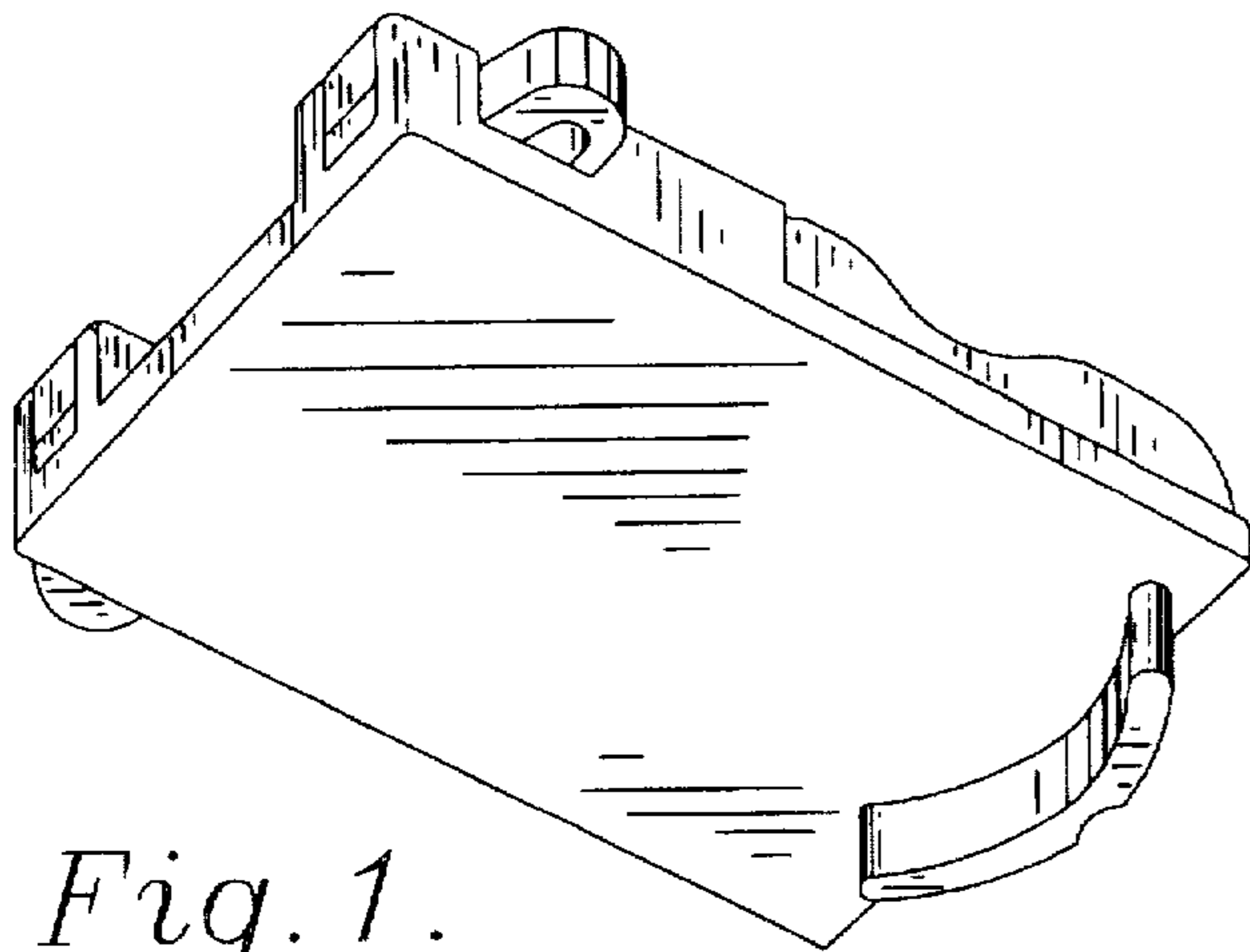

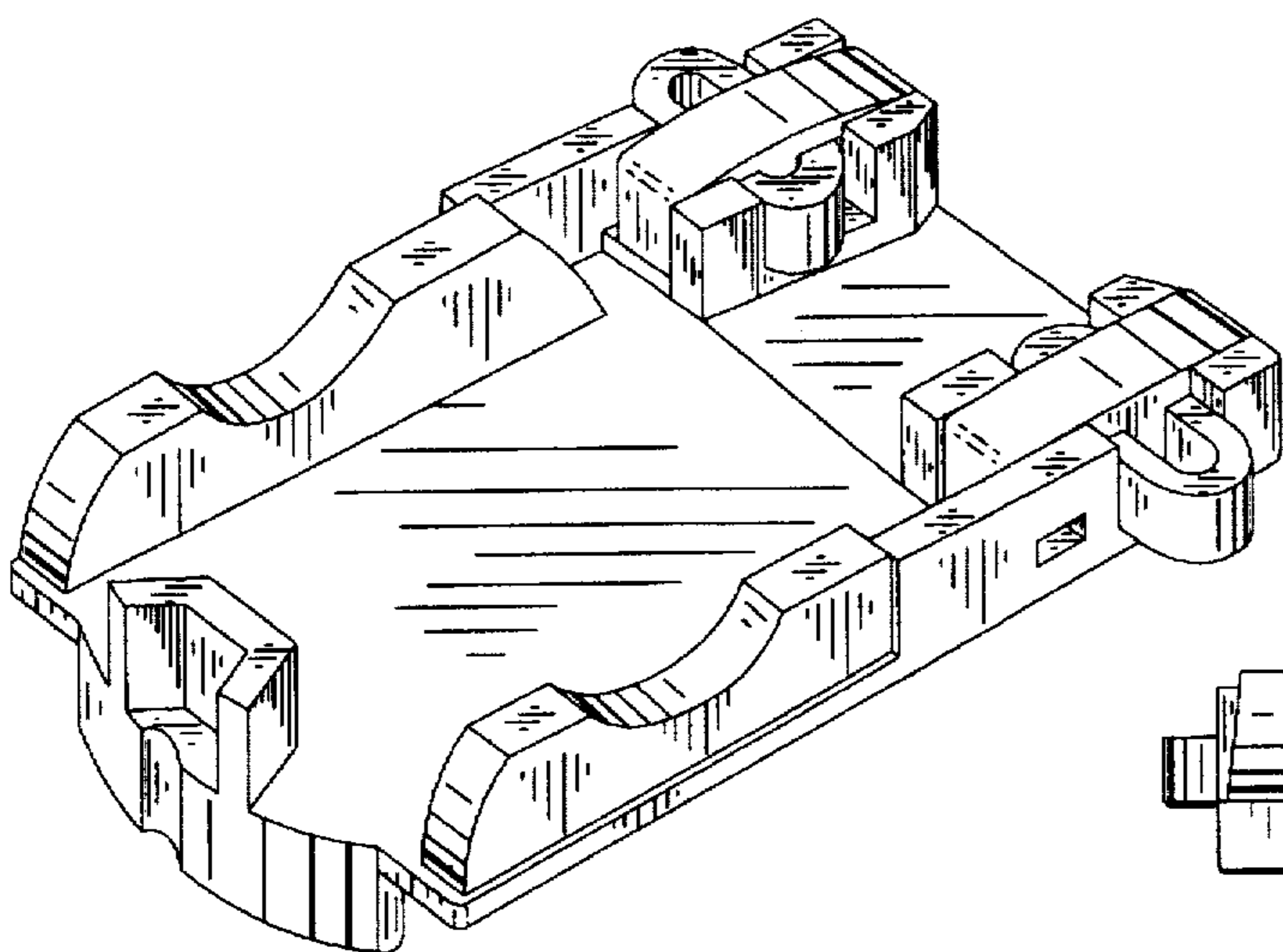

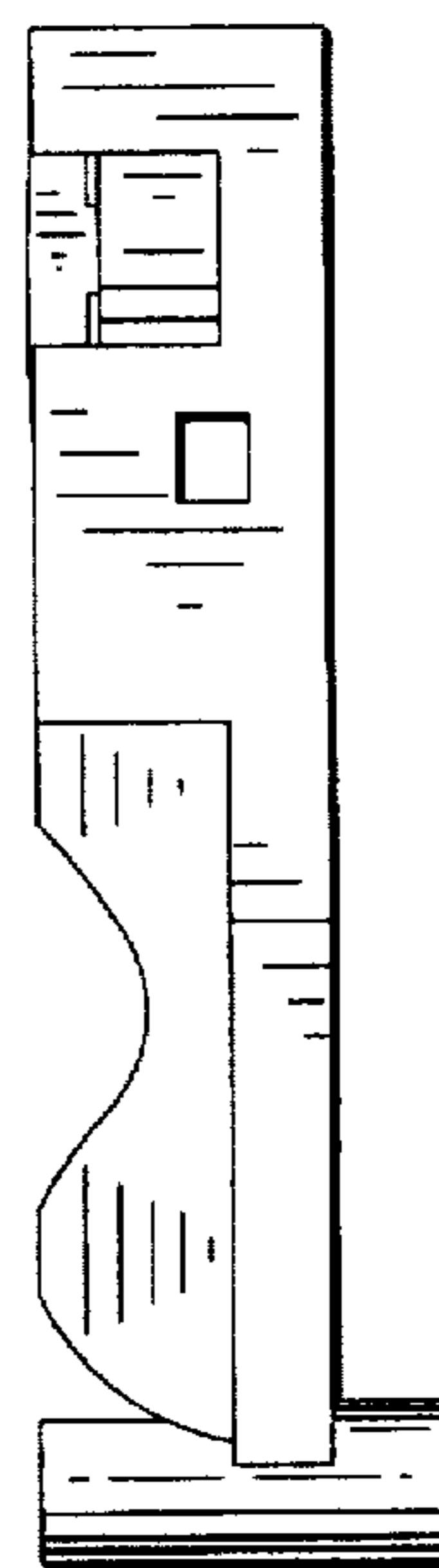

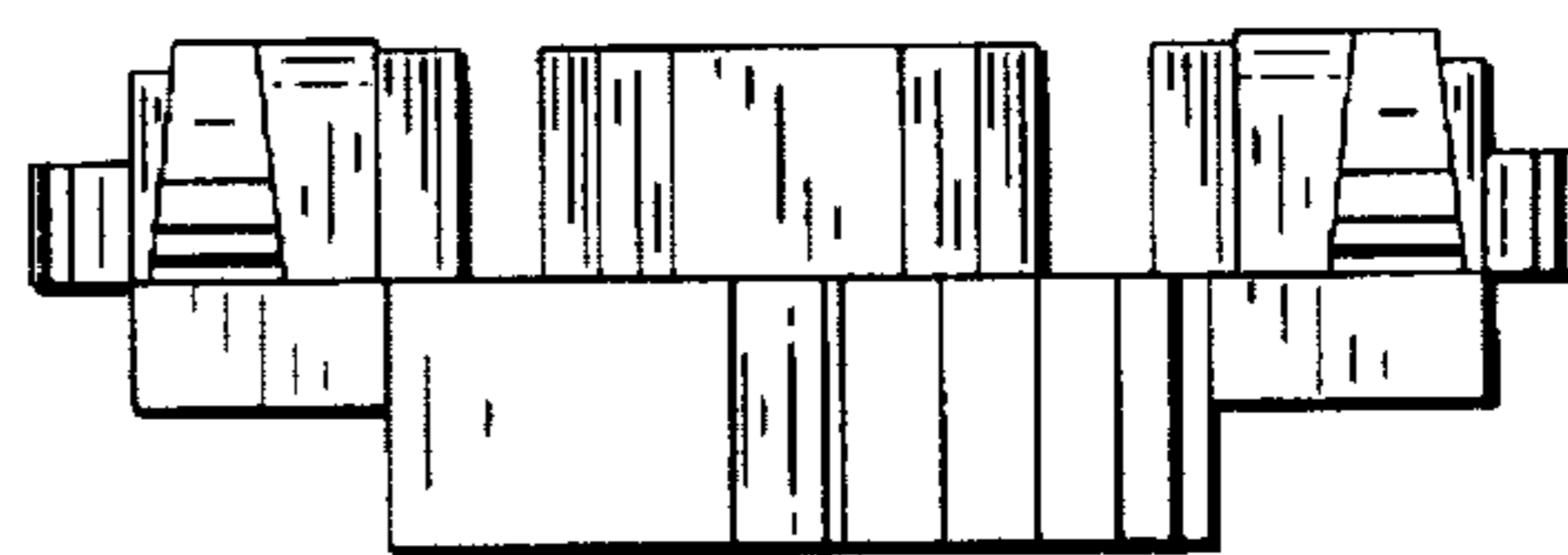

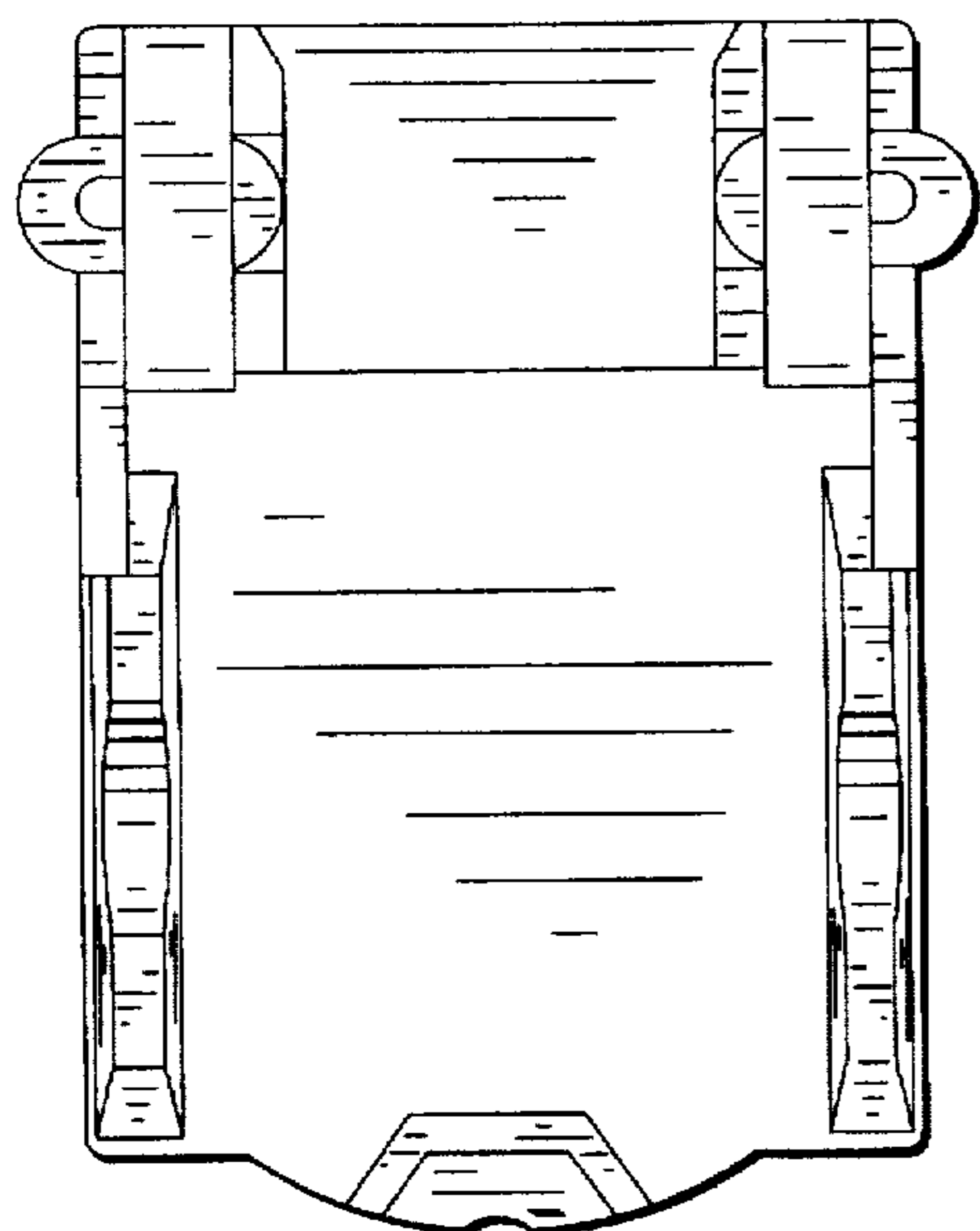

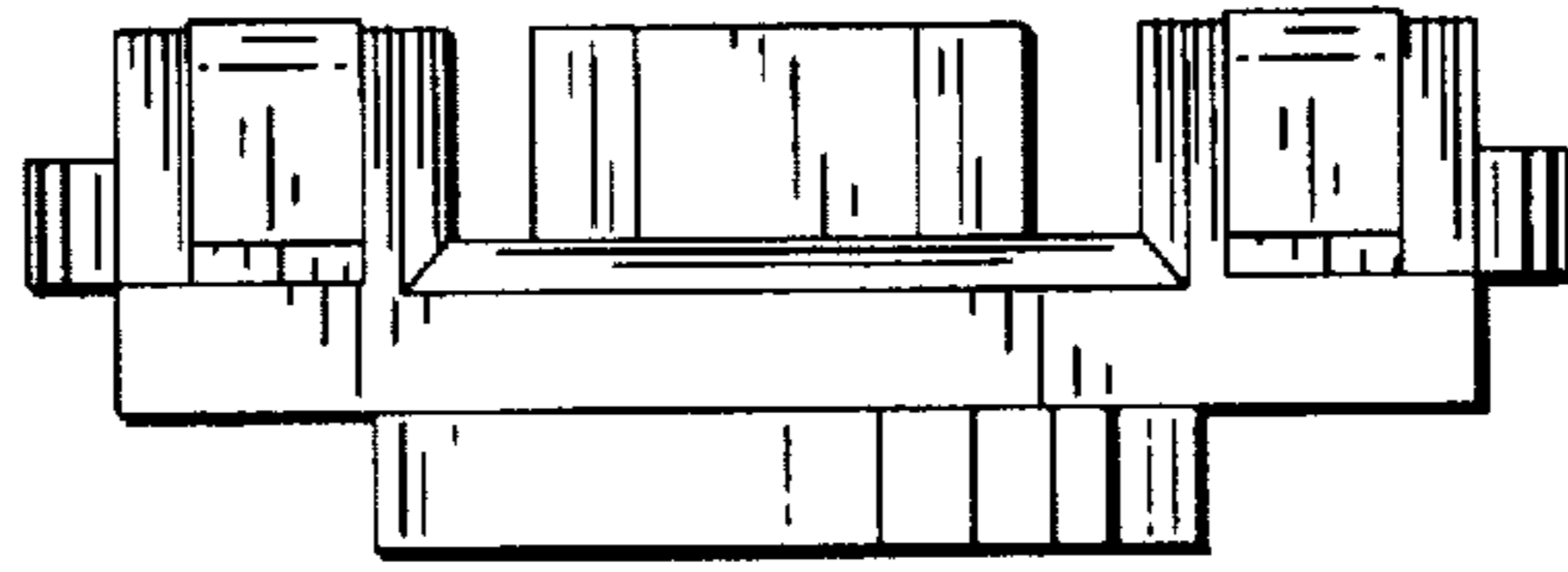

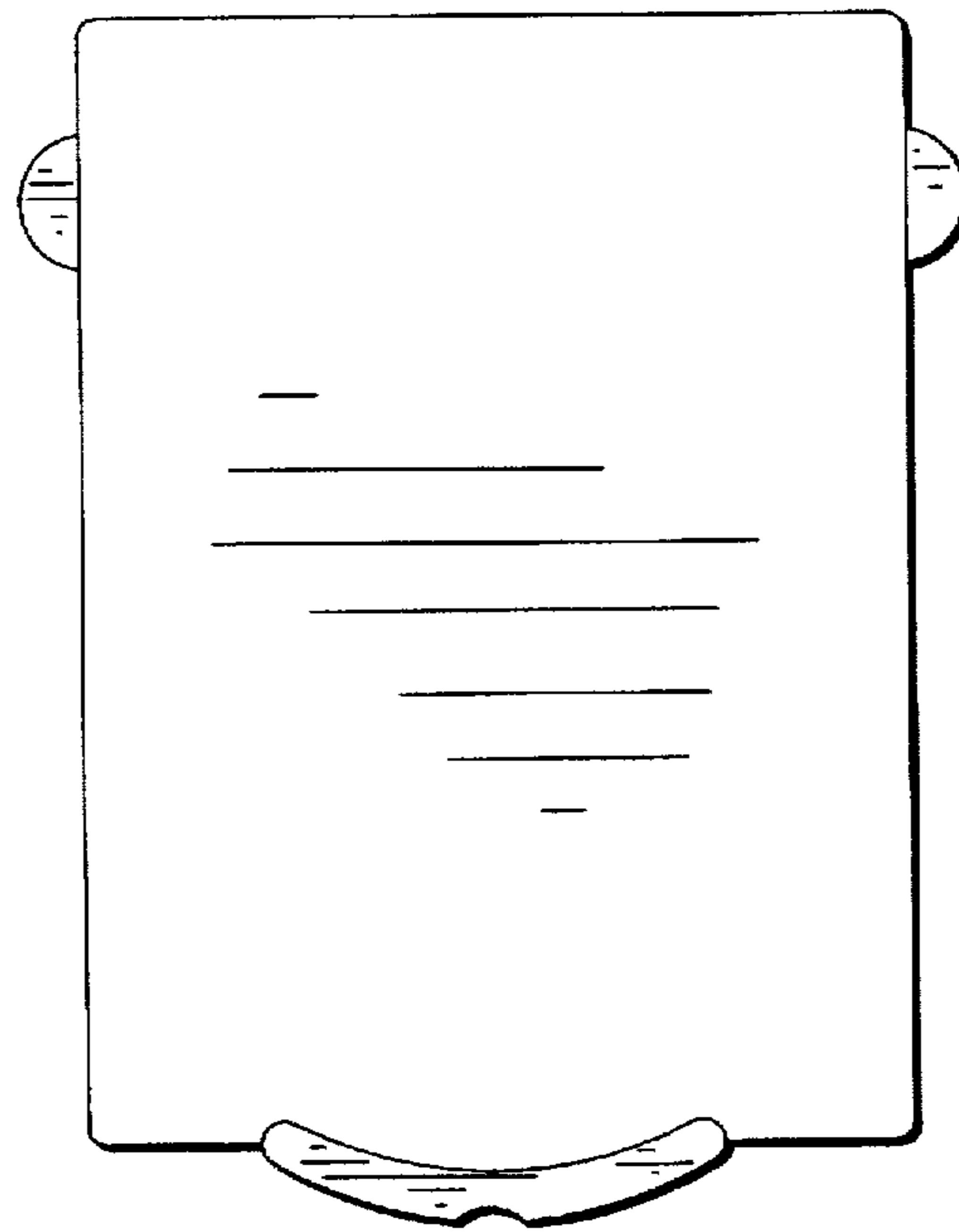
