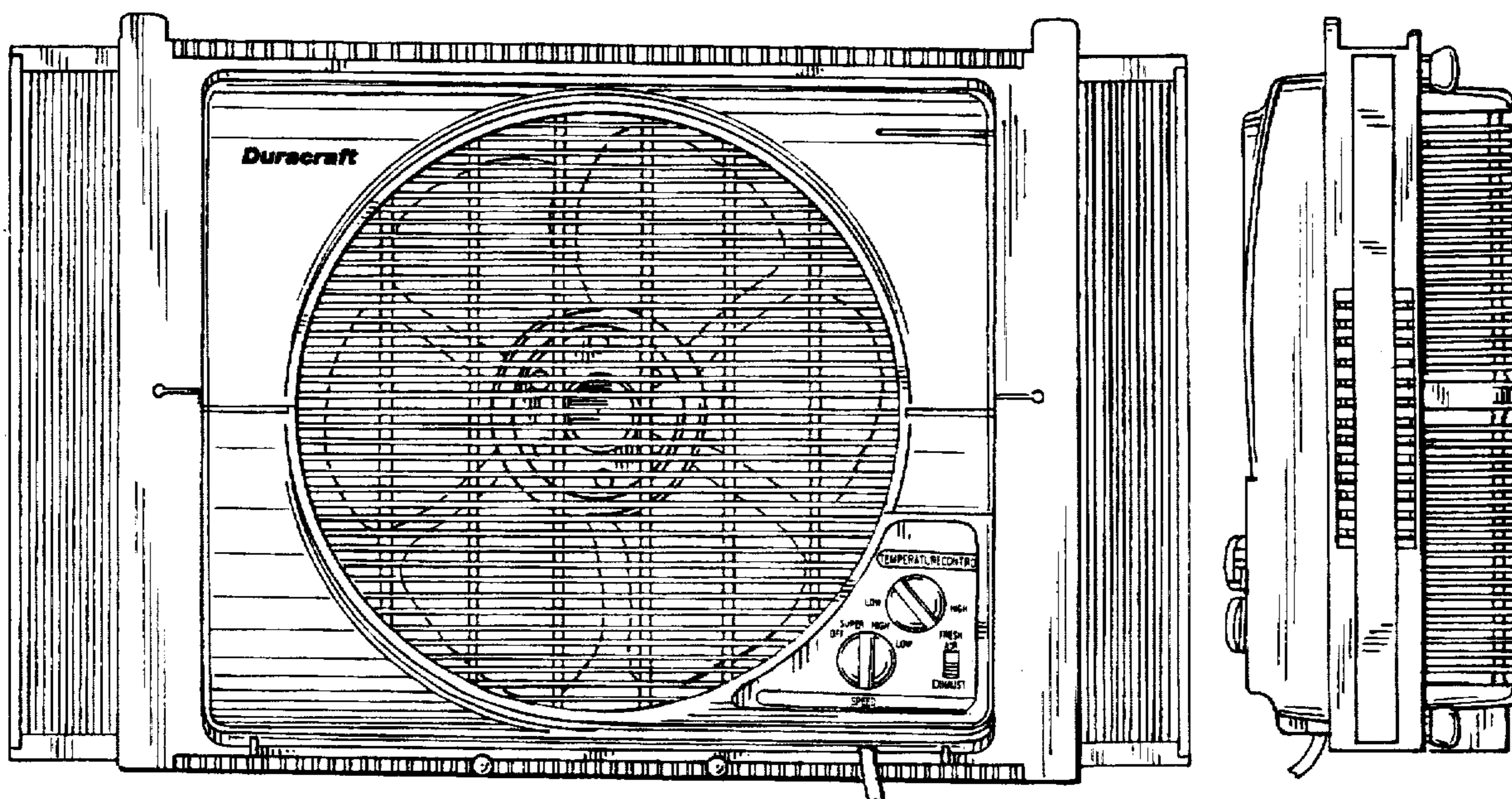
[57] CLAIM

FIG. 1 is a front view of the design for a window fan in accordance with the present invention;

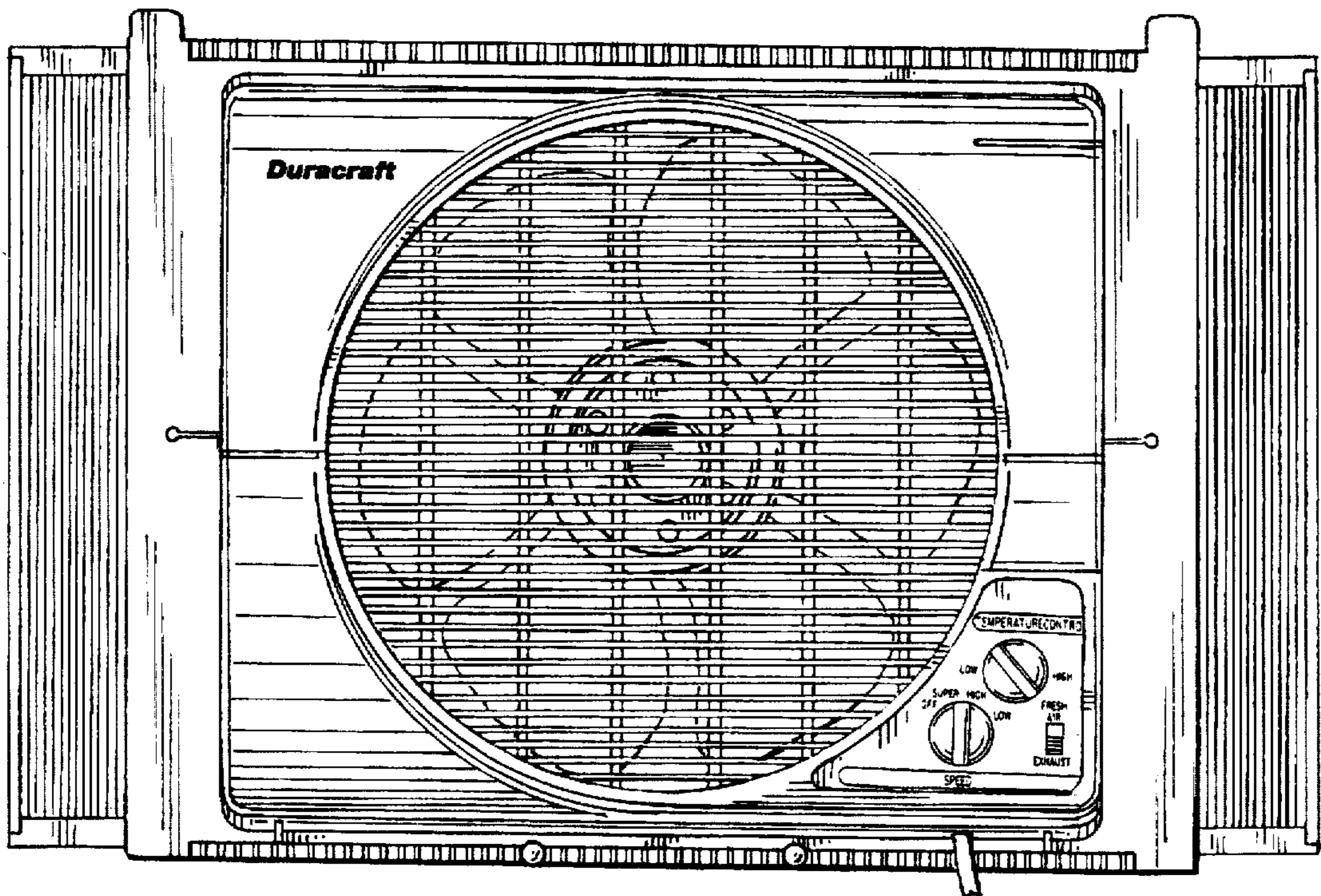

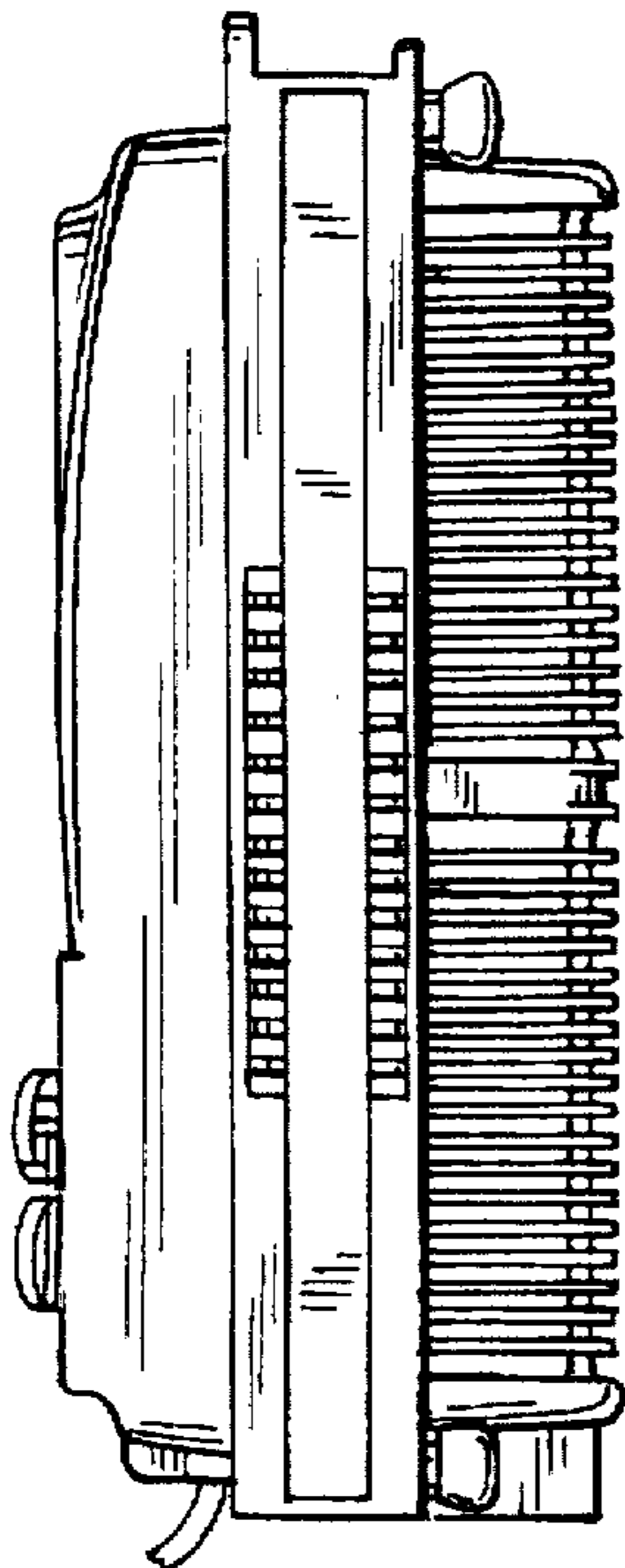

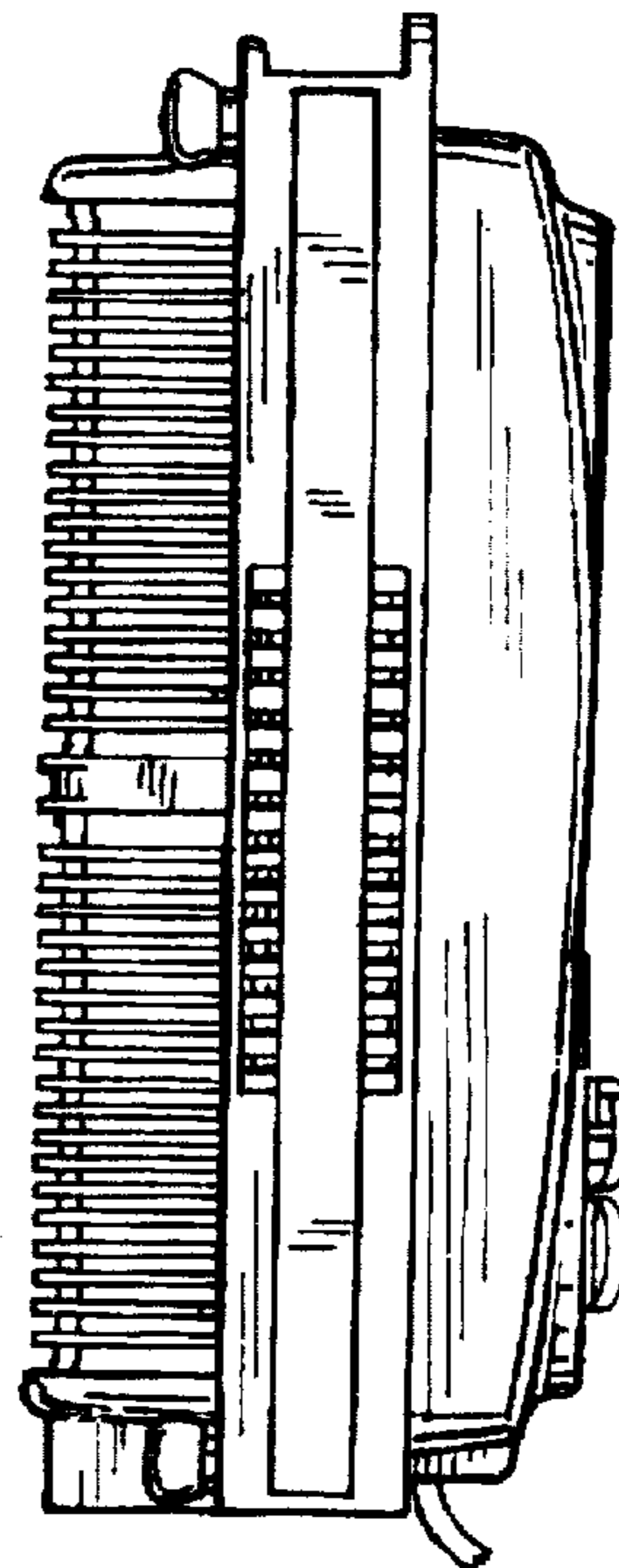

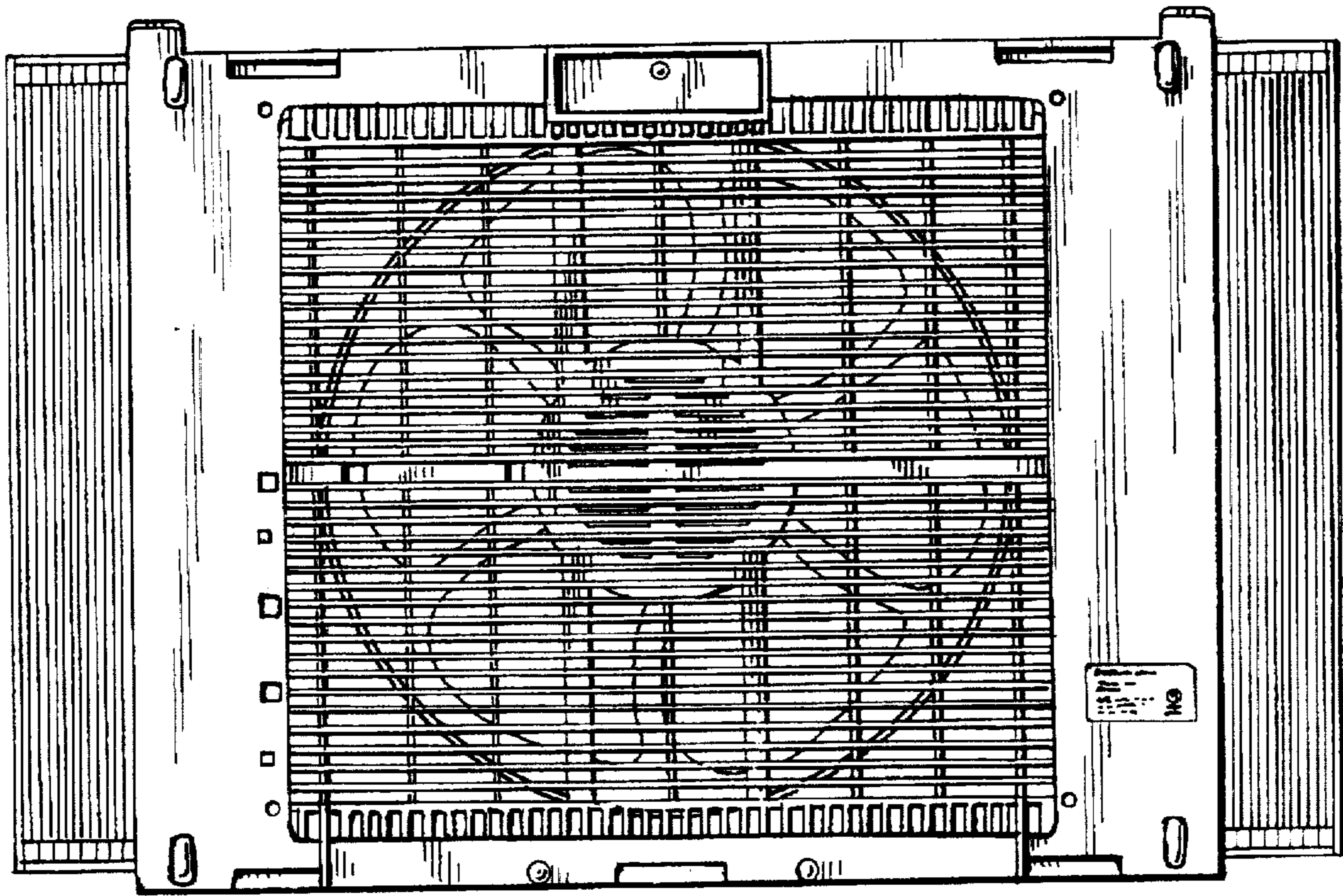

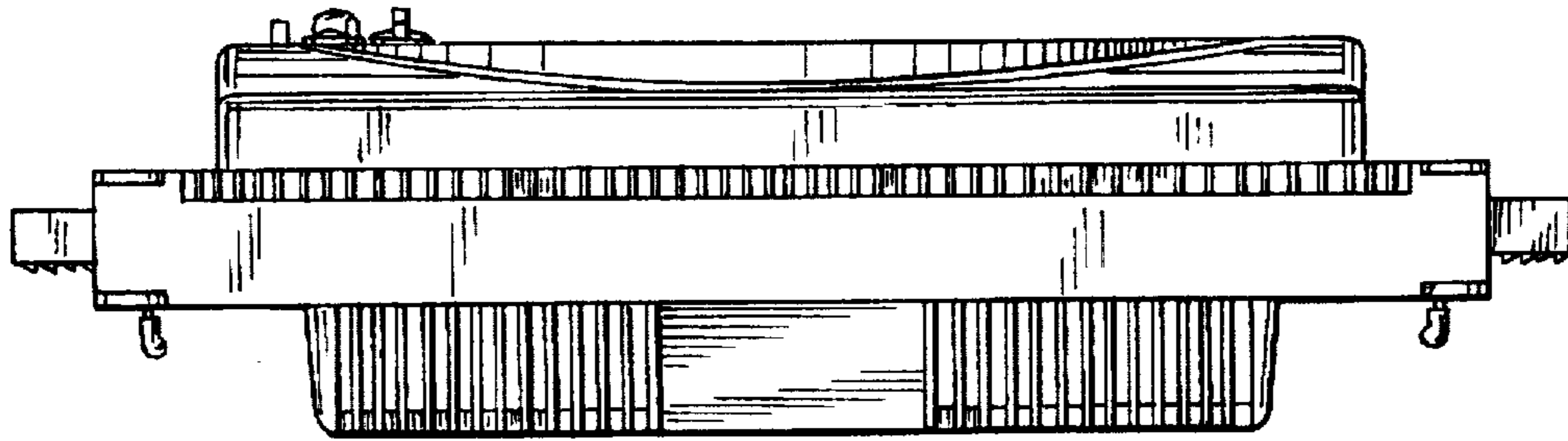

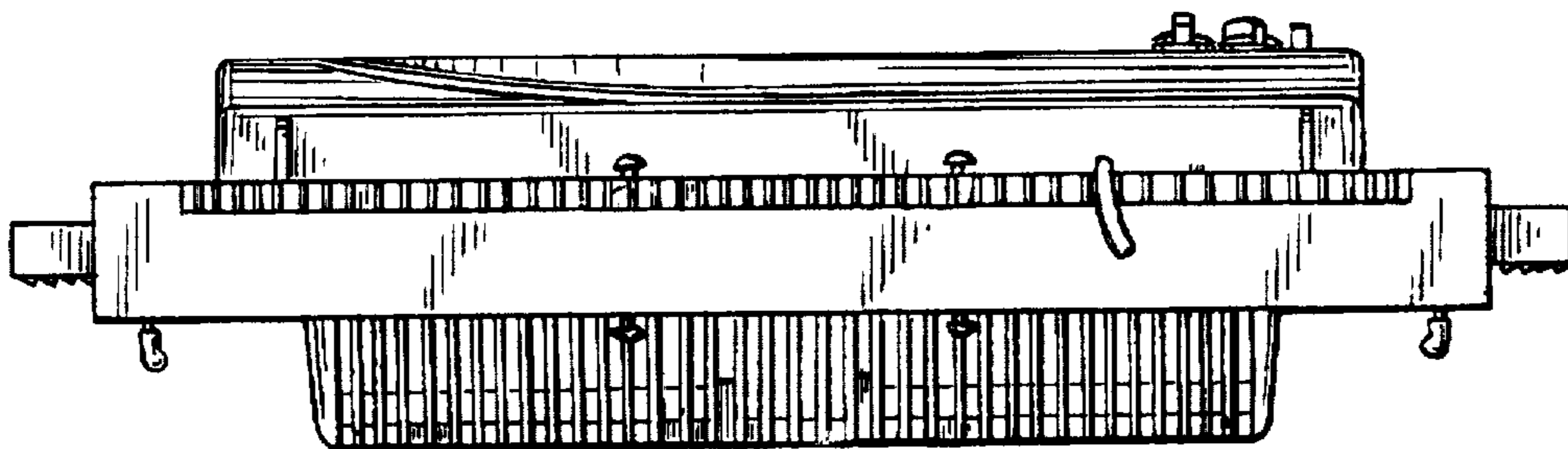
