[57] **CLAIM**

The ornamental design for a flexible multiple-compartment medical container, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a flexible multiple-compartment container, showing our new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a side elevational view of the right side thereof; FIG. 4 is a back elevational view thereof; FIG. 5 is a side elevational view of the left side thereof; FIG. 6 is a top plan view of the container oriented as in FIG. 4; and, FIG. 7 is a bottom plan view of the container oriented as in FIG. 4.

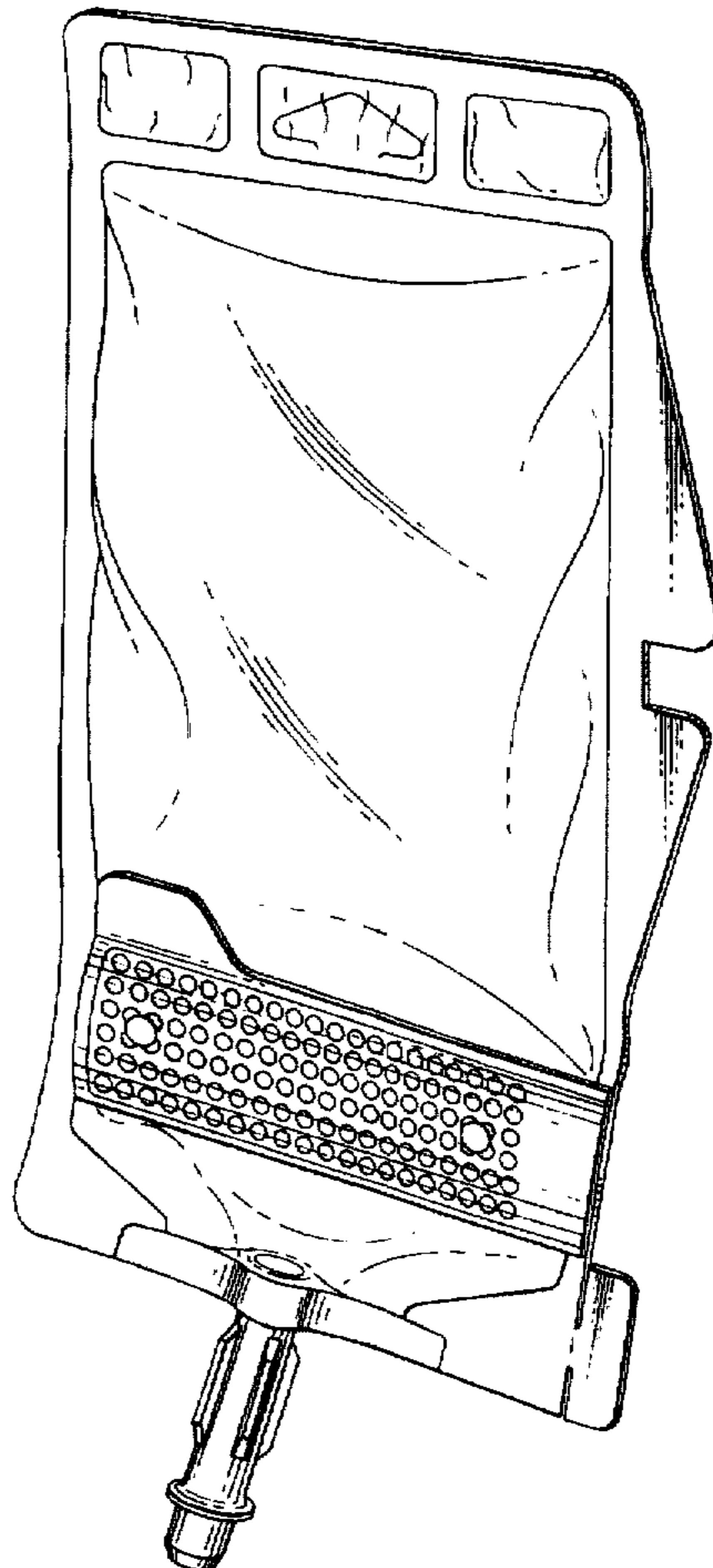

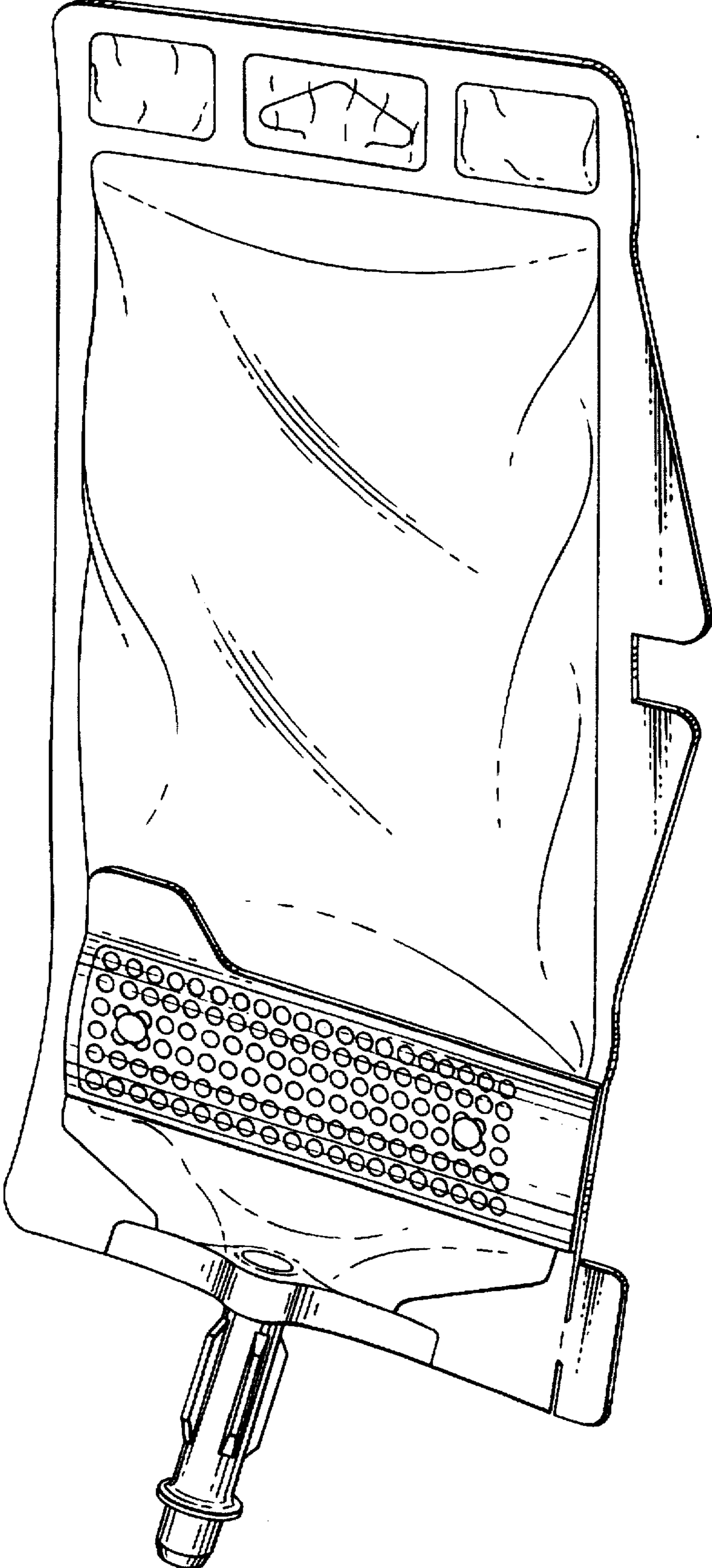

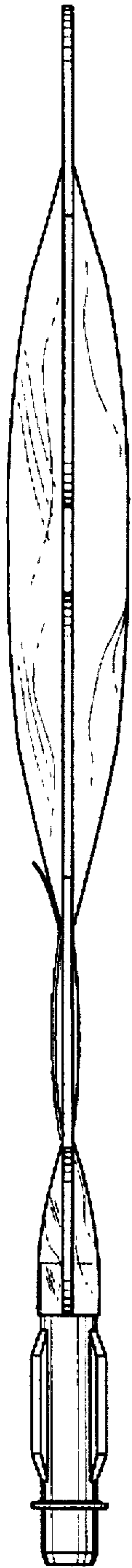

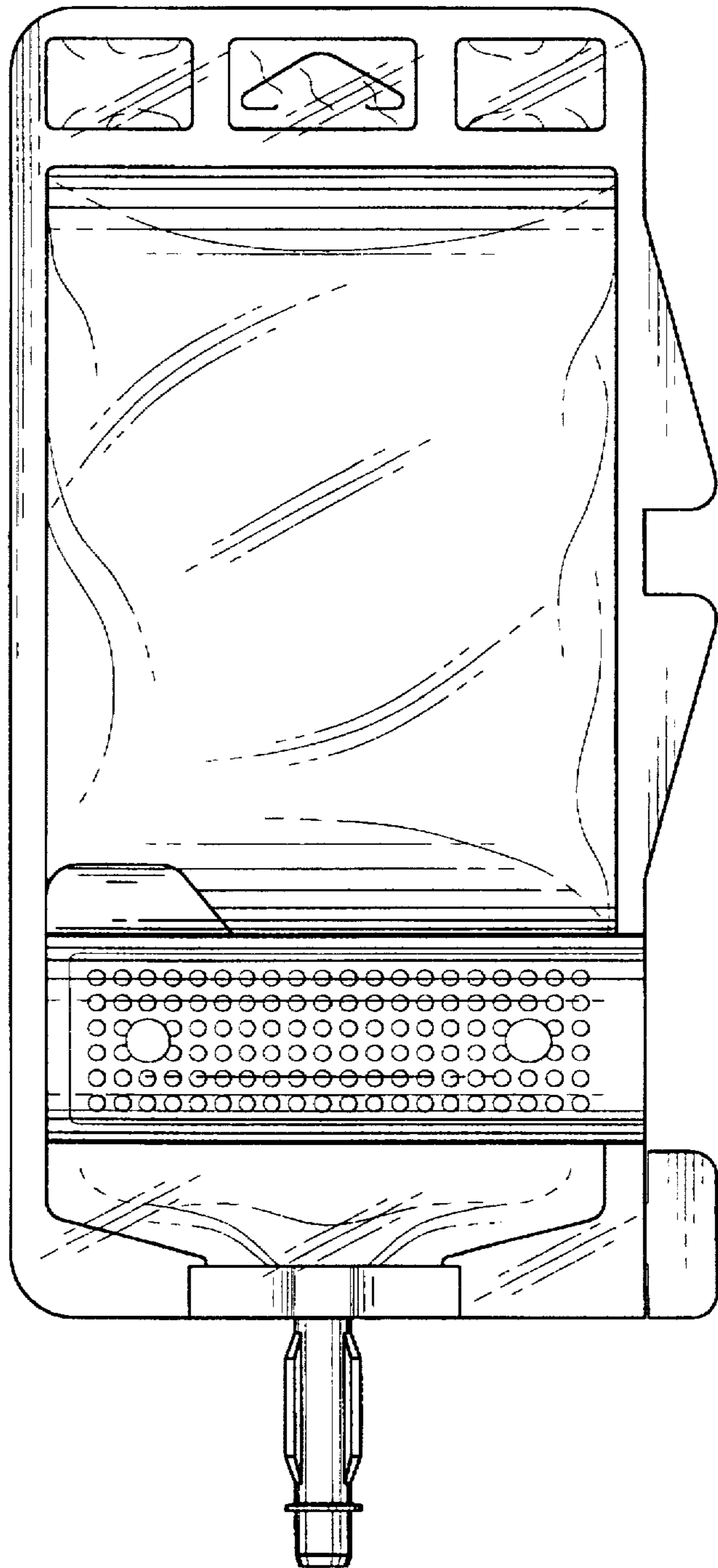

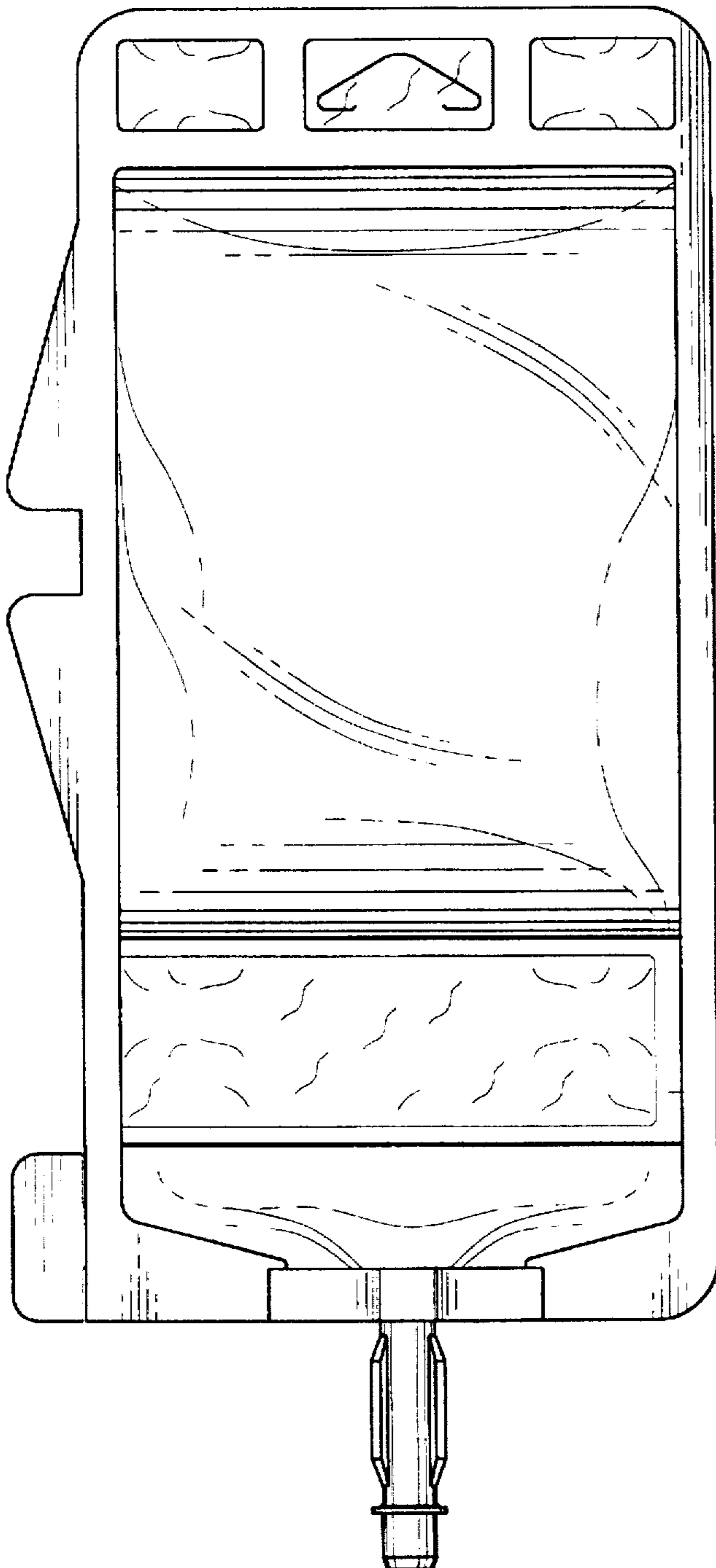

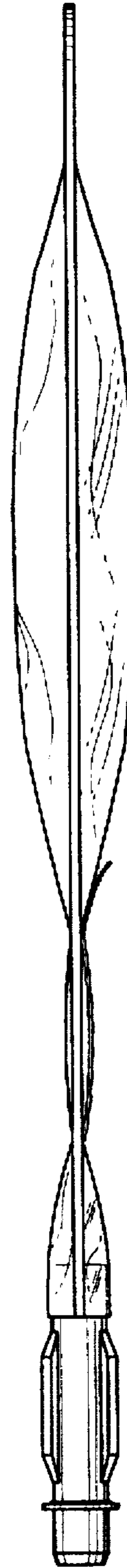

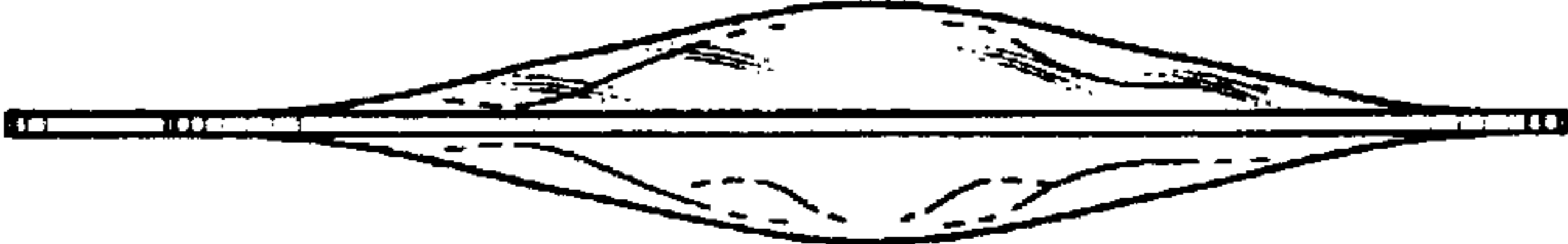
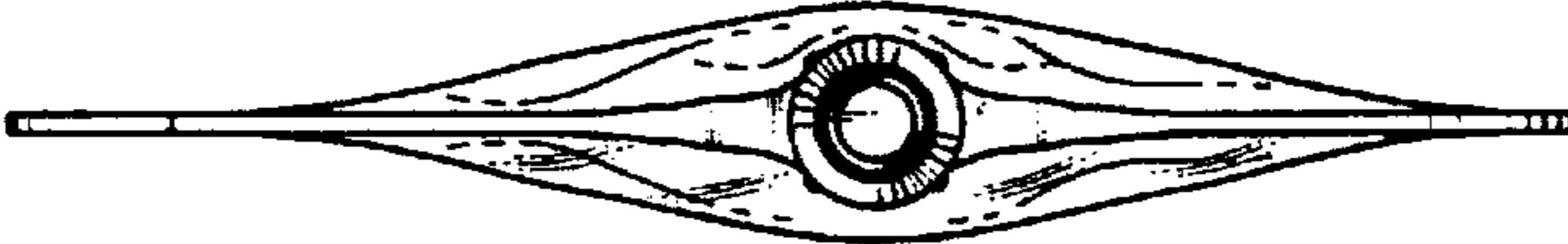
