DESCRIPTION

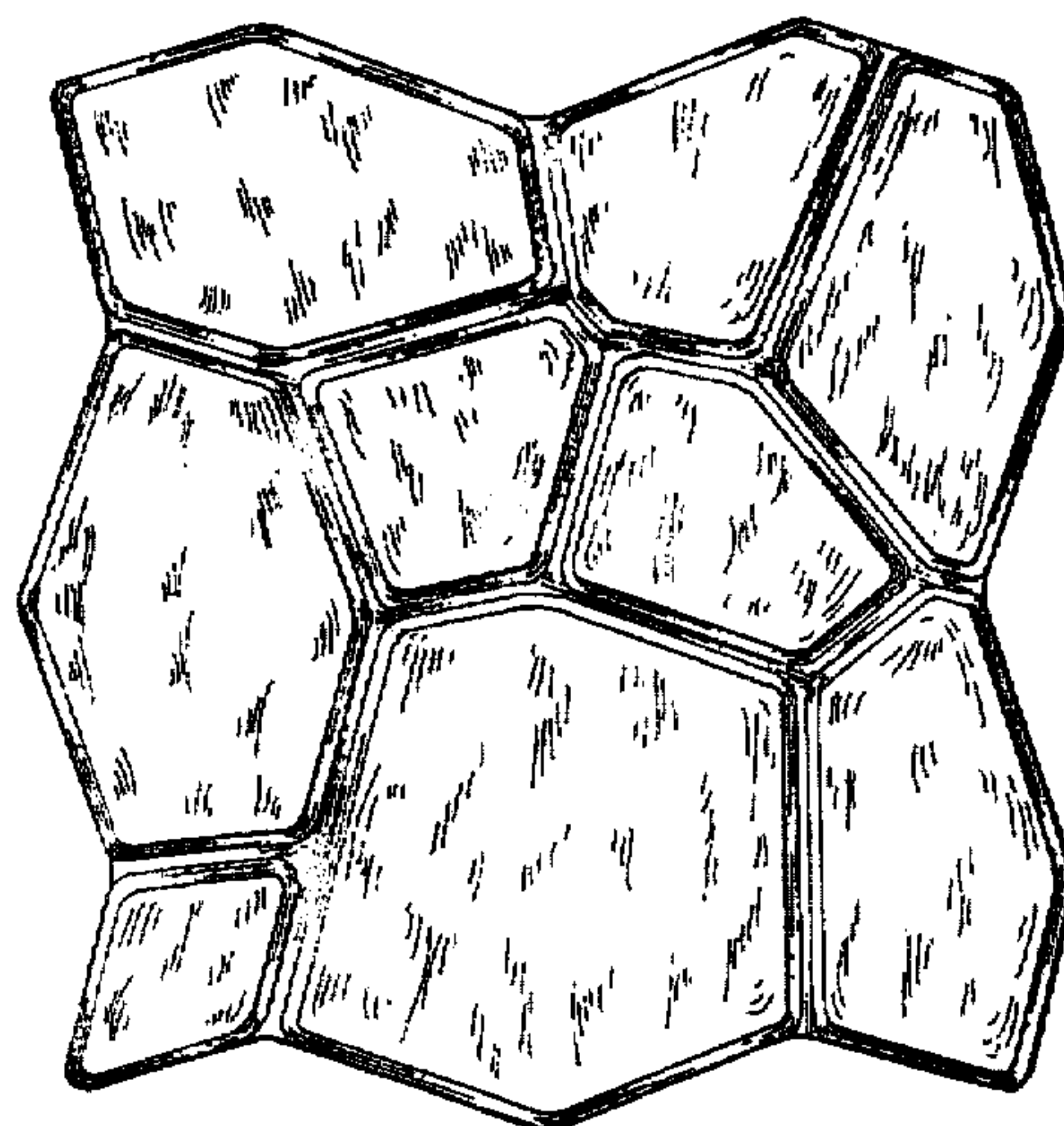
FIG. 1 is a top plan view of the paving block embodying my new design;

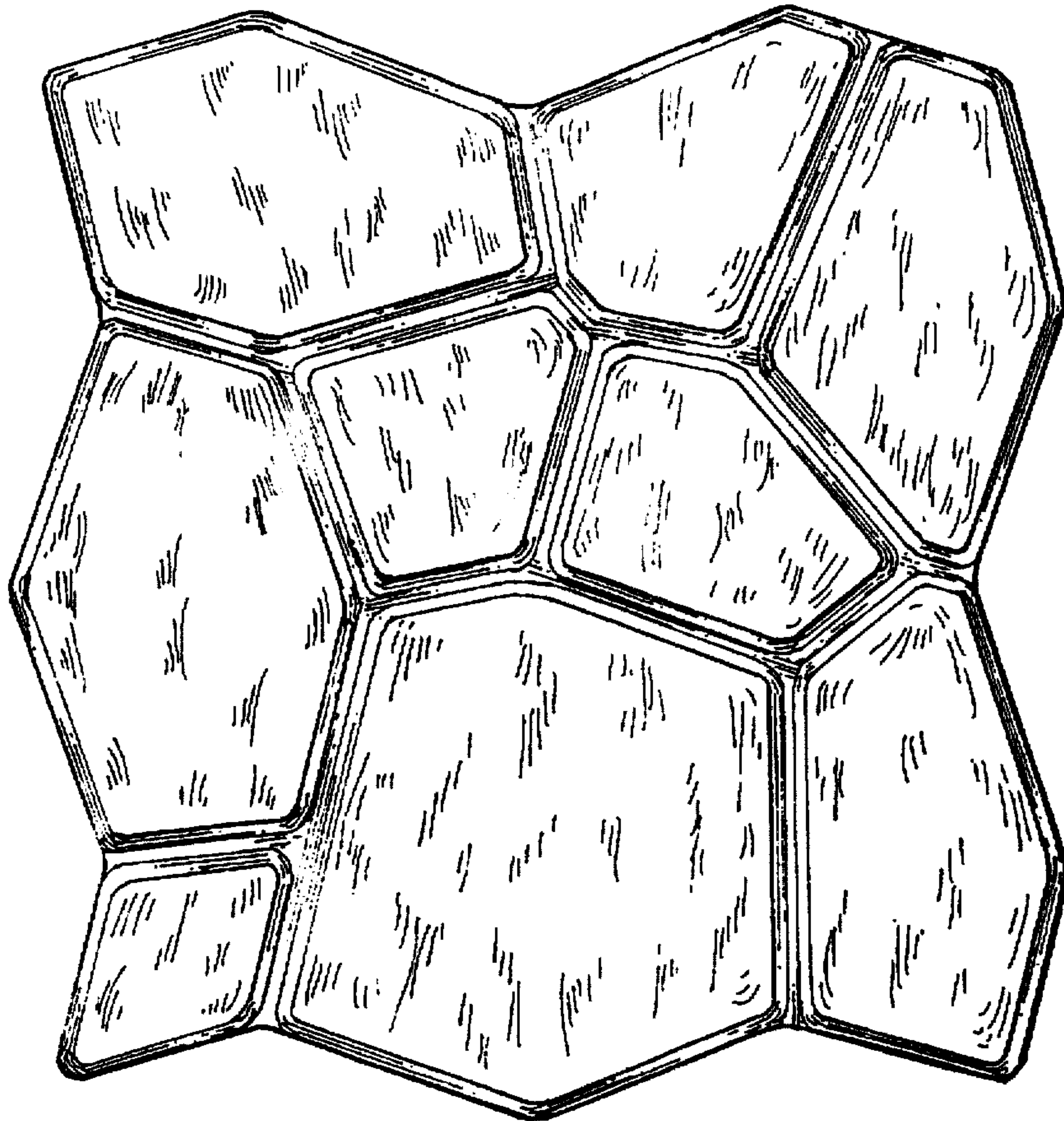

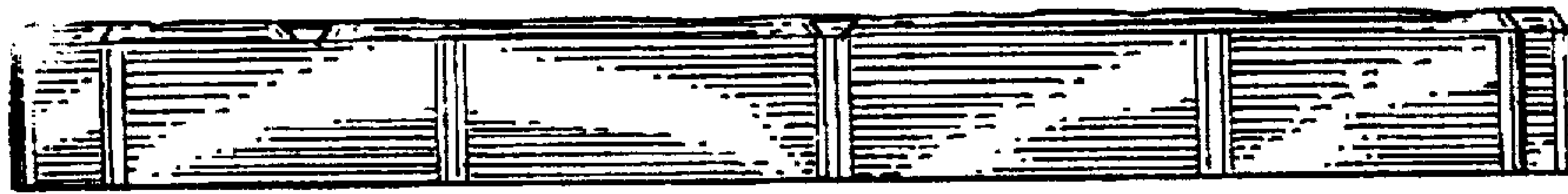

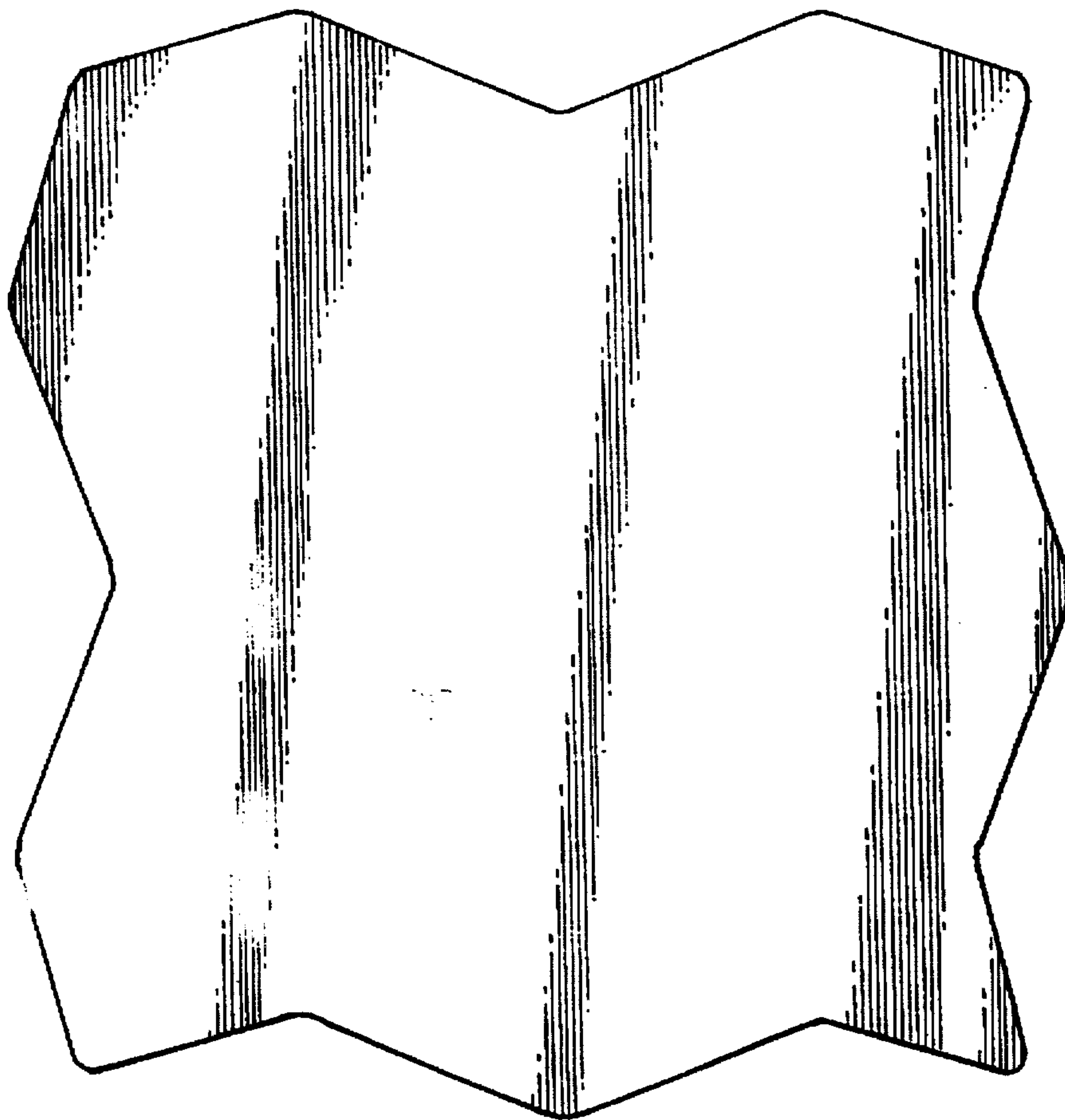

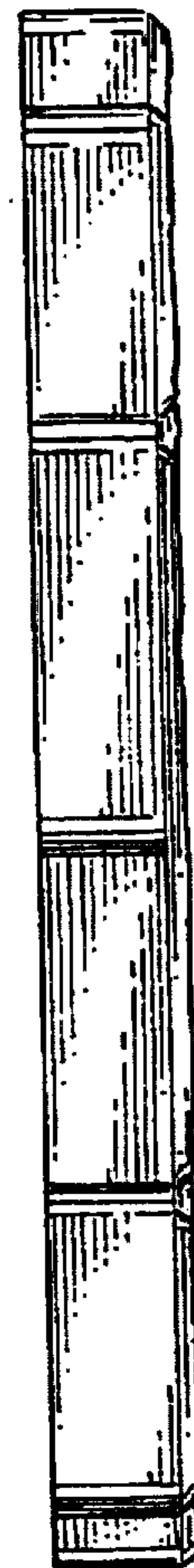
