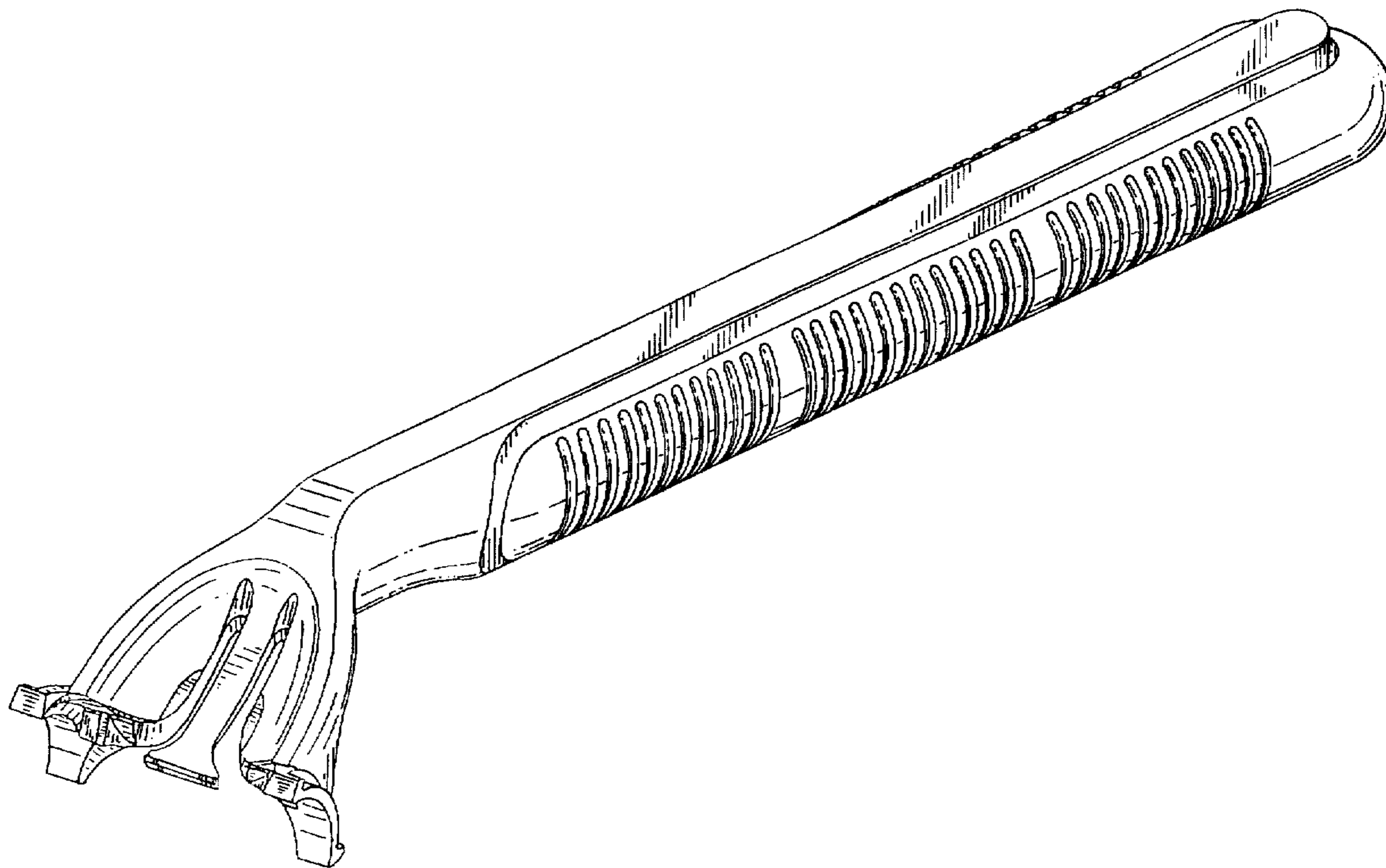
## [57] CLAIM

The ornamental design for a safety razor and handle, as shown and described.

## DESCRIPTION

FIG. 1 is a perspective view of a safety razor handle showing my new design as seen from the top, rear and right side; FIG. 2 is a rear elevational view shown on a reduced scale; FIG. 3 is a right side elevational view thereof, the opposite left side being a mirror image of the side shown; FIG. 4 is a front elevational view shown on an enlarged scale; FIG. 5 is a top plan view further enlarged with respect to FIG. 4; FIG. 6 is a bottom plan view thereof; and, FIG. 7 is a perspective view similar to FIG. 1, with a blade cartridge shown in phantom. The broken line showing of the razor cartridge in FIG. 7 is for illustrative purposes only and forms no part of the claimed design.

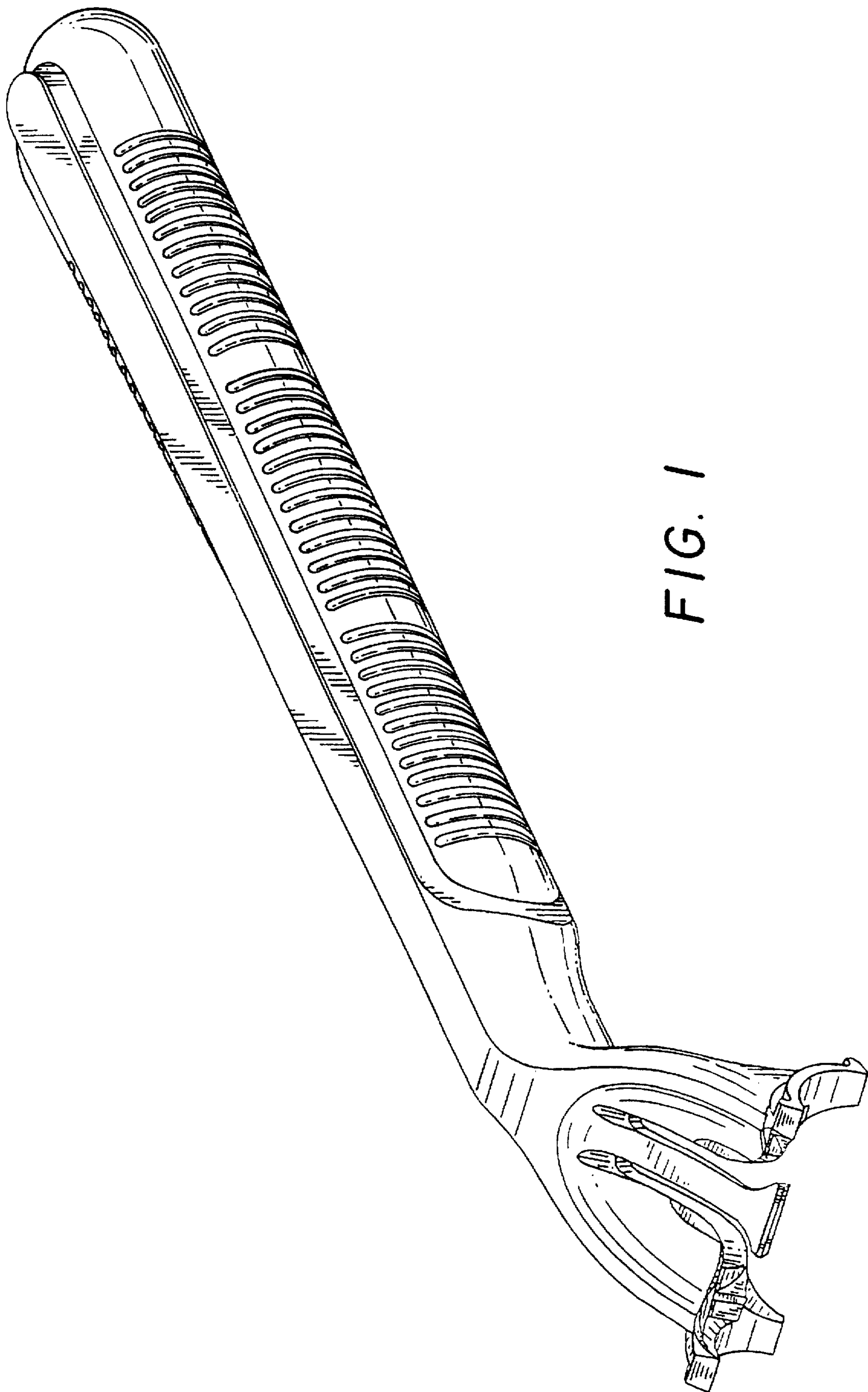

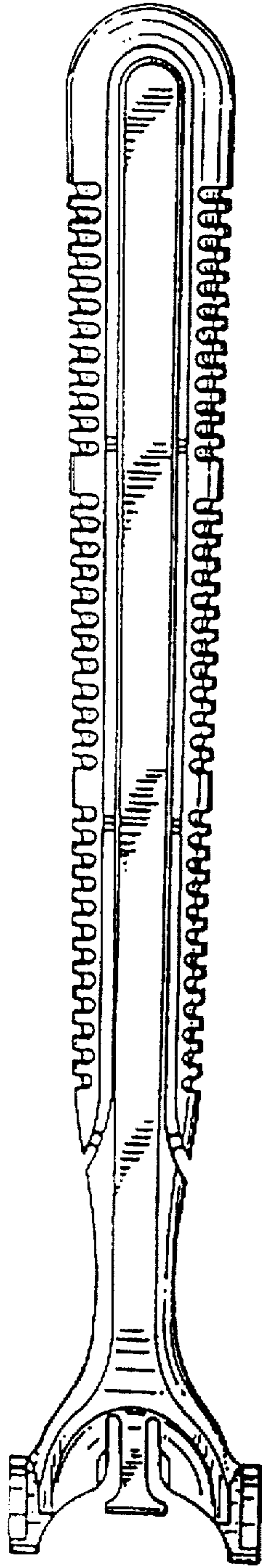

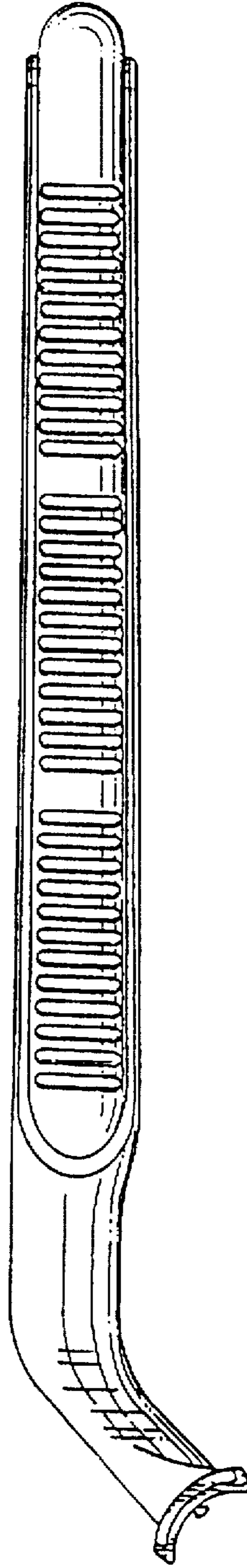

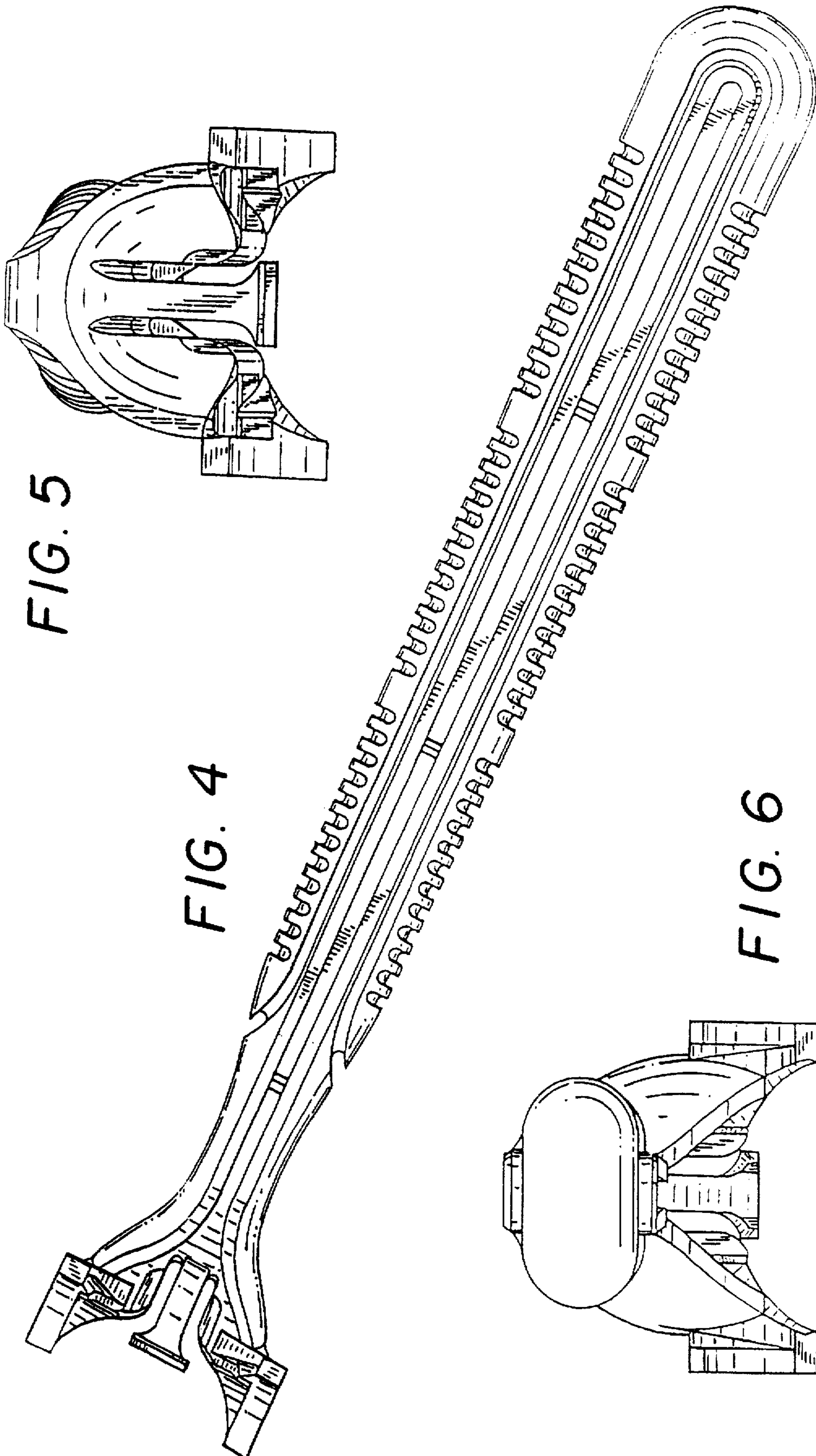

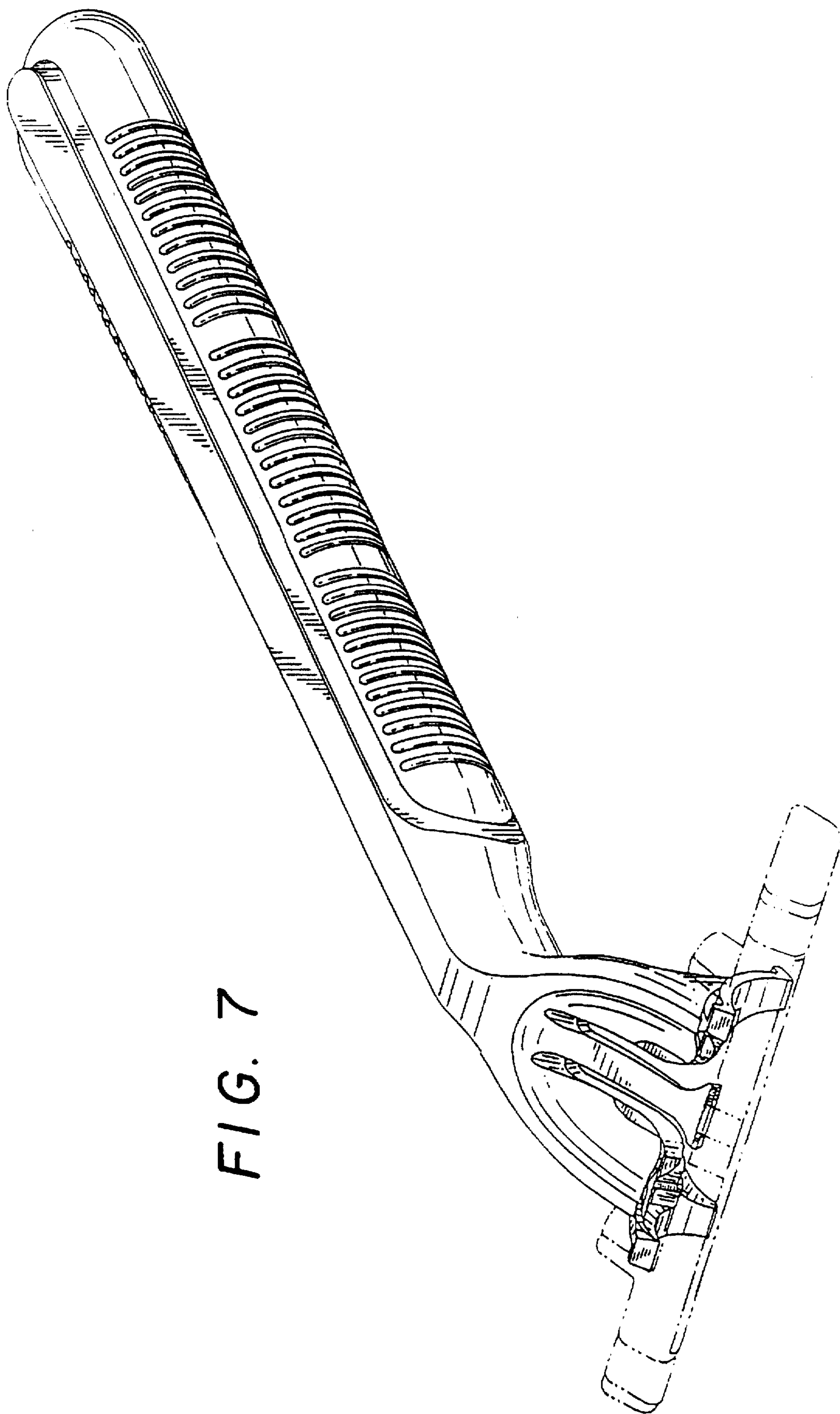
