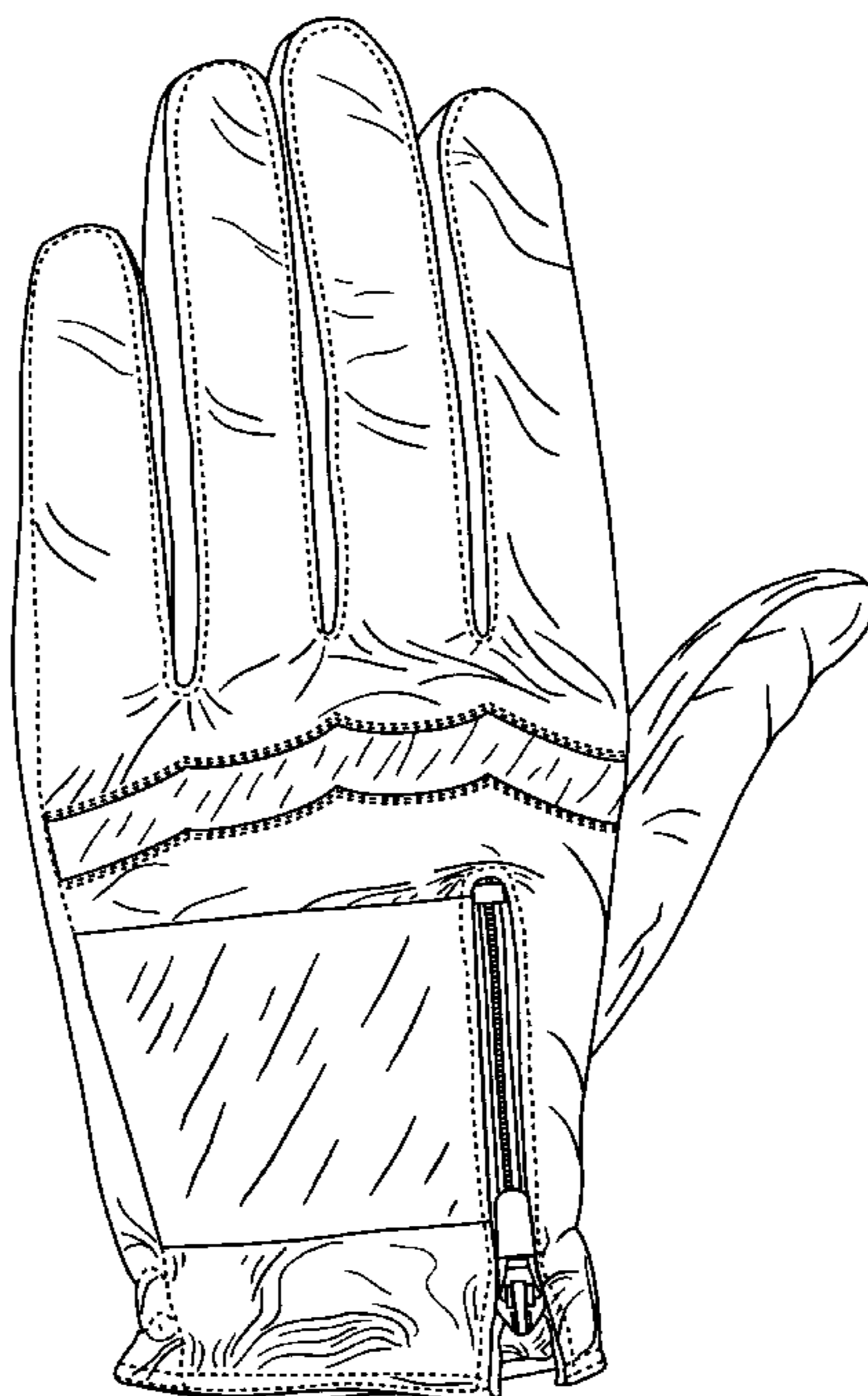
[57] **CLAIM**

The ornamental design for a zippered glove, as shown and described.

**DESCRIPTION**

FIG. 1 is a dorsal view of a first embodiment of a zippered glove showing our new design; FIG. 2 is a palmer view thereof; FIG. 3 is a left side elevational view thereof; FIG. 4 is a right side elevational view thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a bottom plan view thereof; FIG. 7 is a dorsal view of a second embodiment of a zippered glove showing our new design, the difference being the contrasting elastic back and wave pattern; FIG. 8 is a palmer view thereof; FIG. 9 is a left side elevational view thereof; FIG. 10 is a right side elevational view thereof; FIG. 11 is a top plan view thereof; and, FIG. 12 is a bottom plan view thereof.

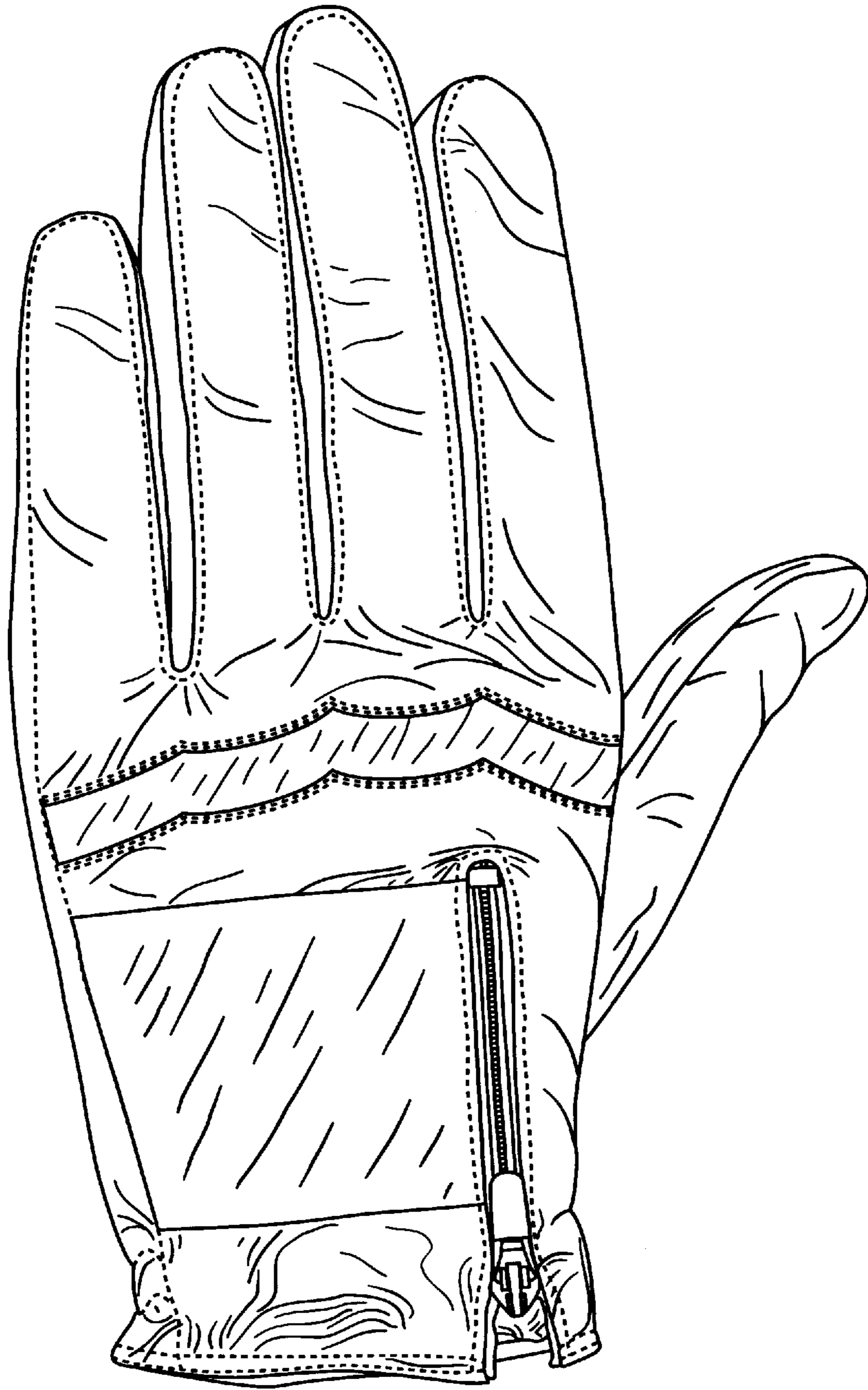

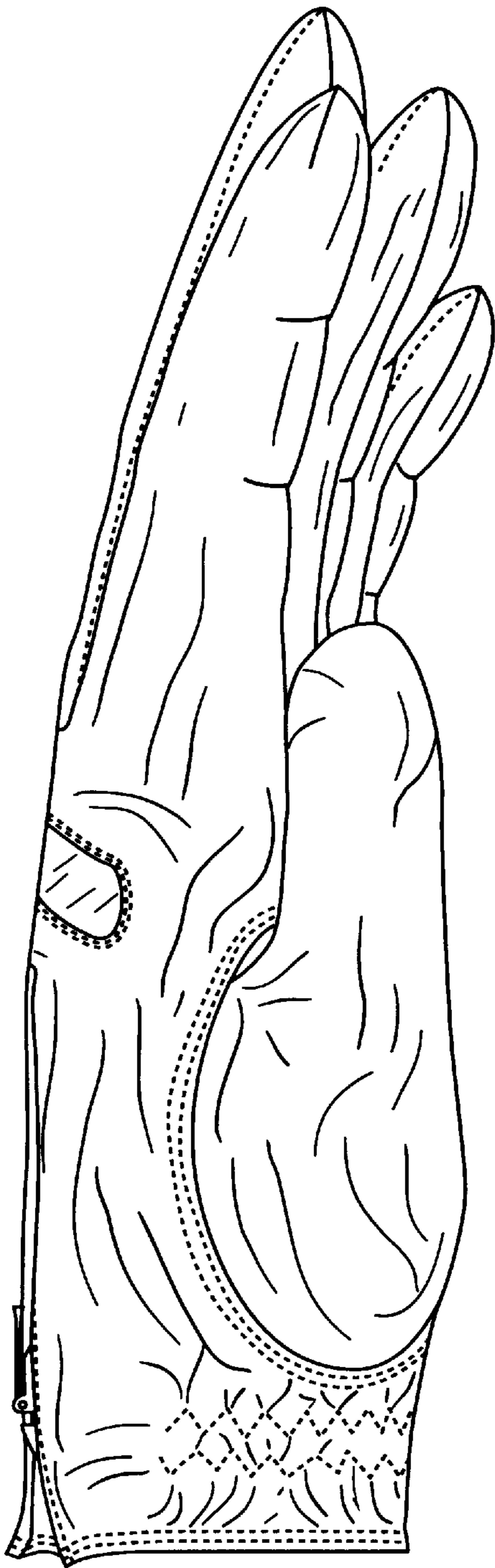

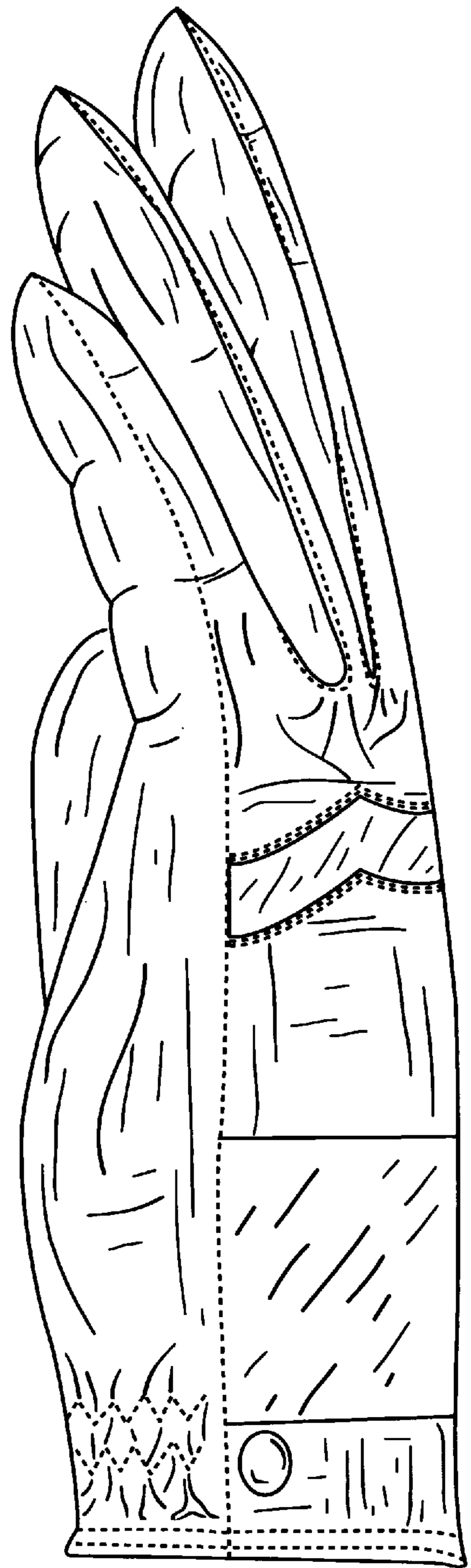

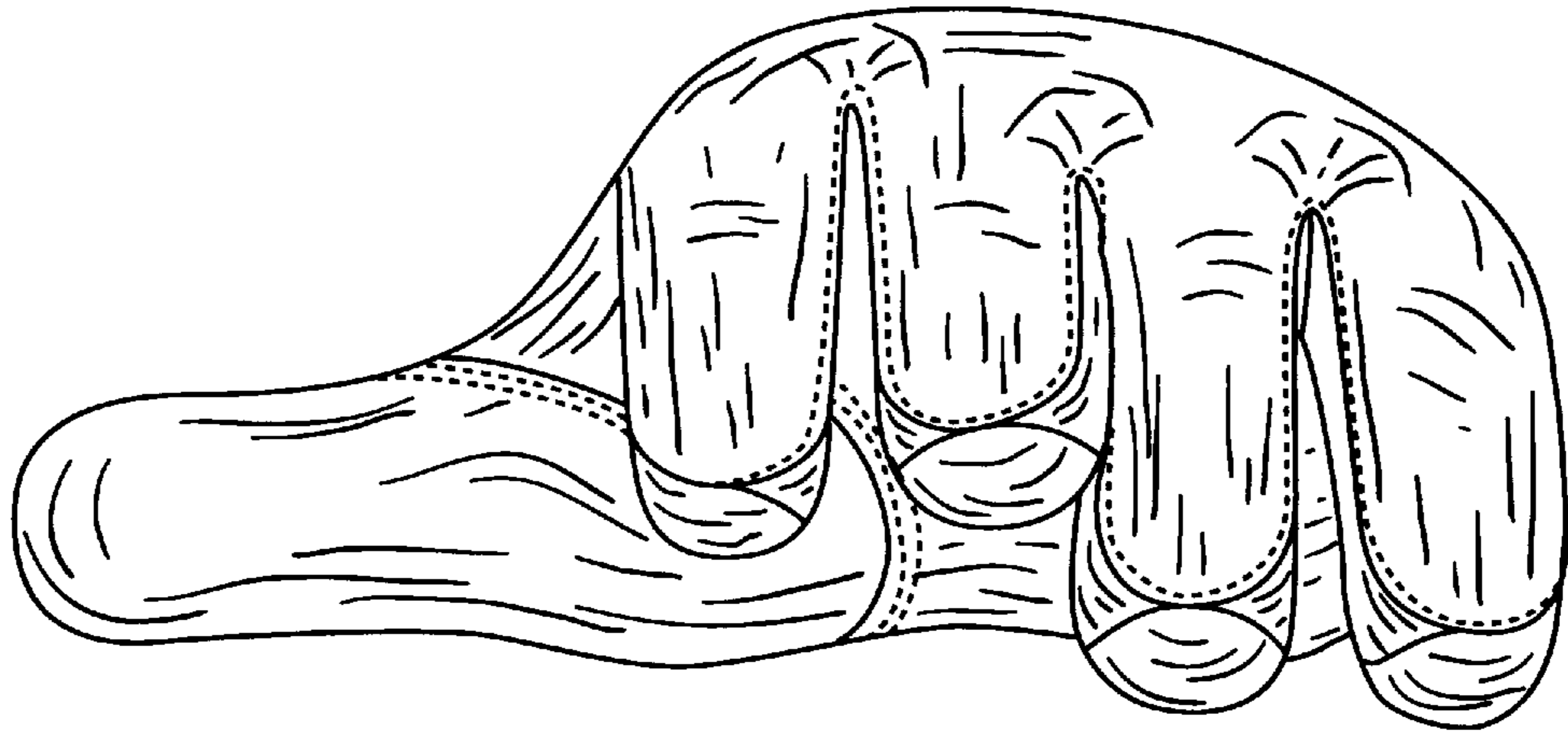

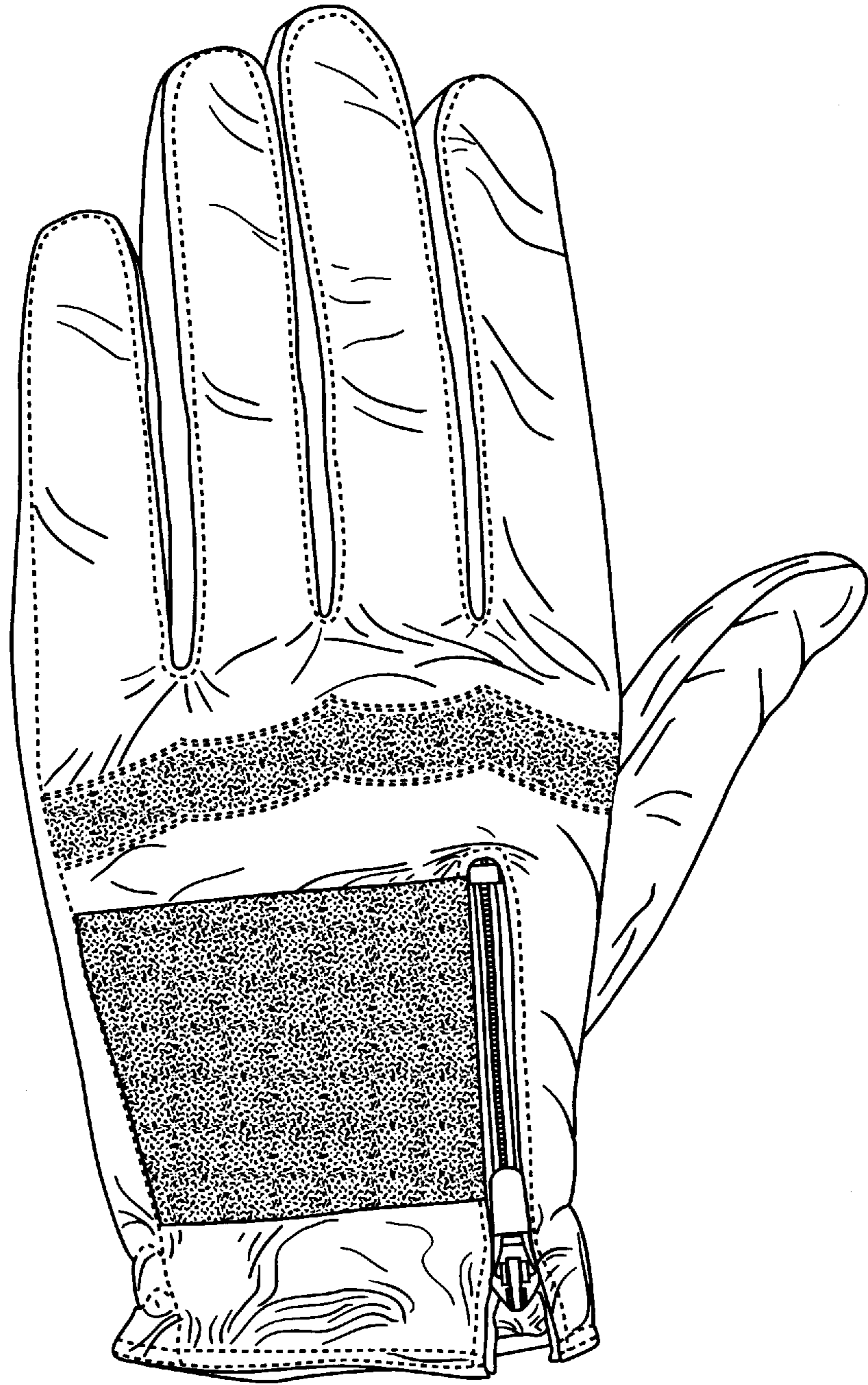

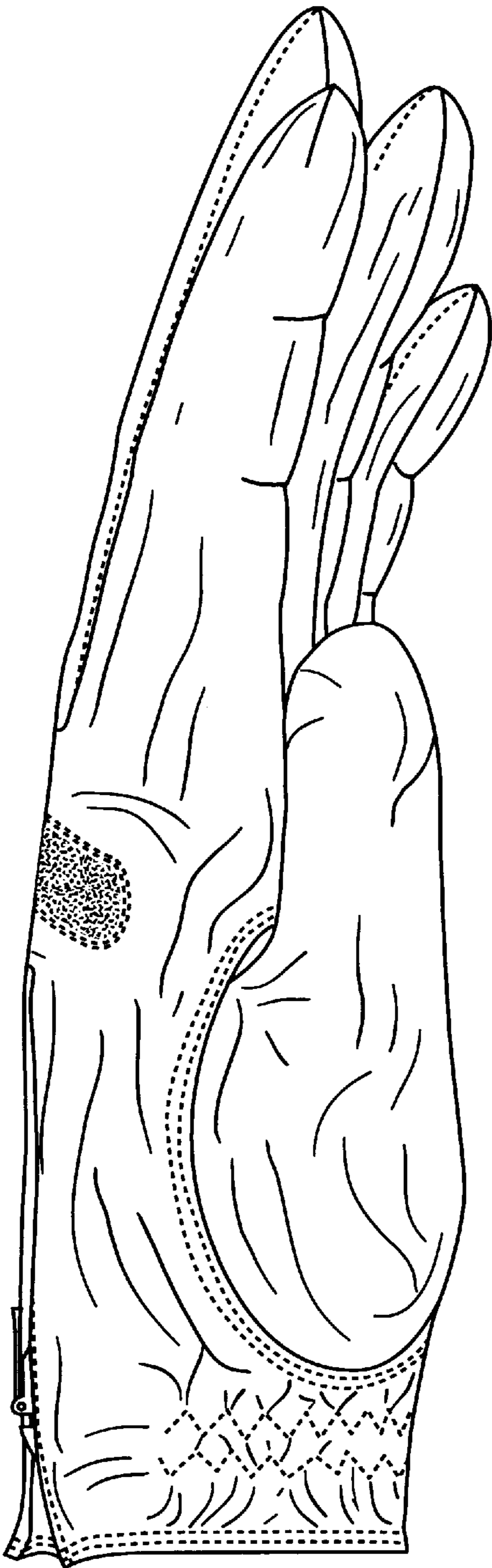

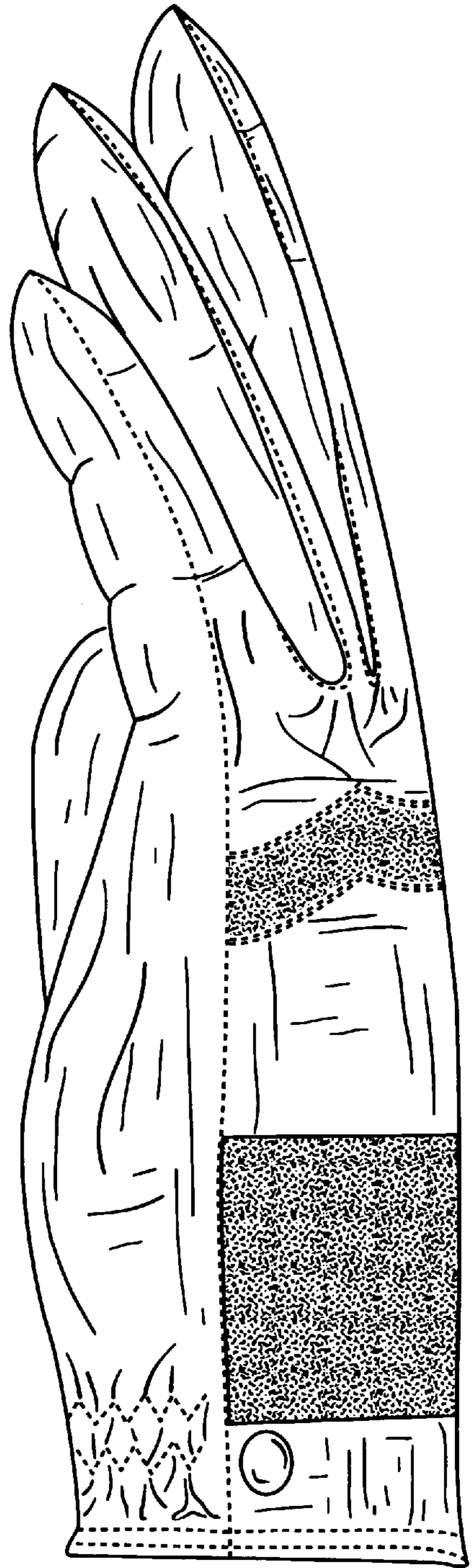

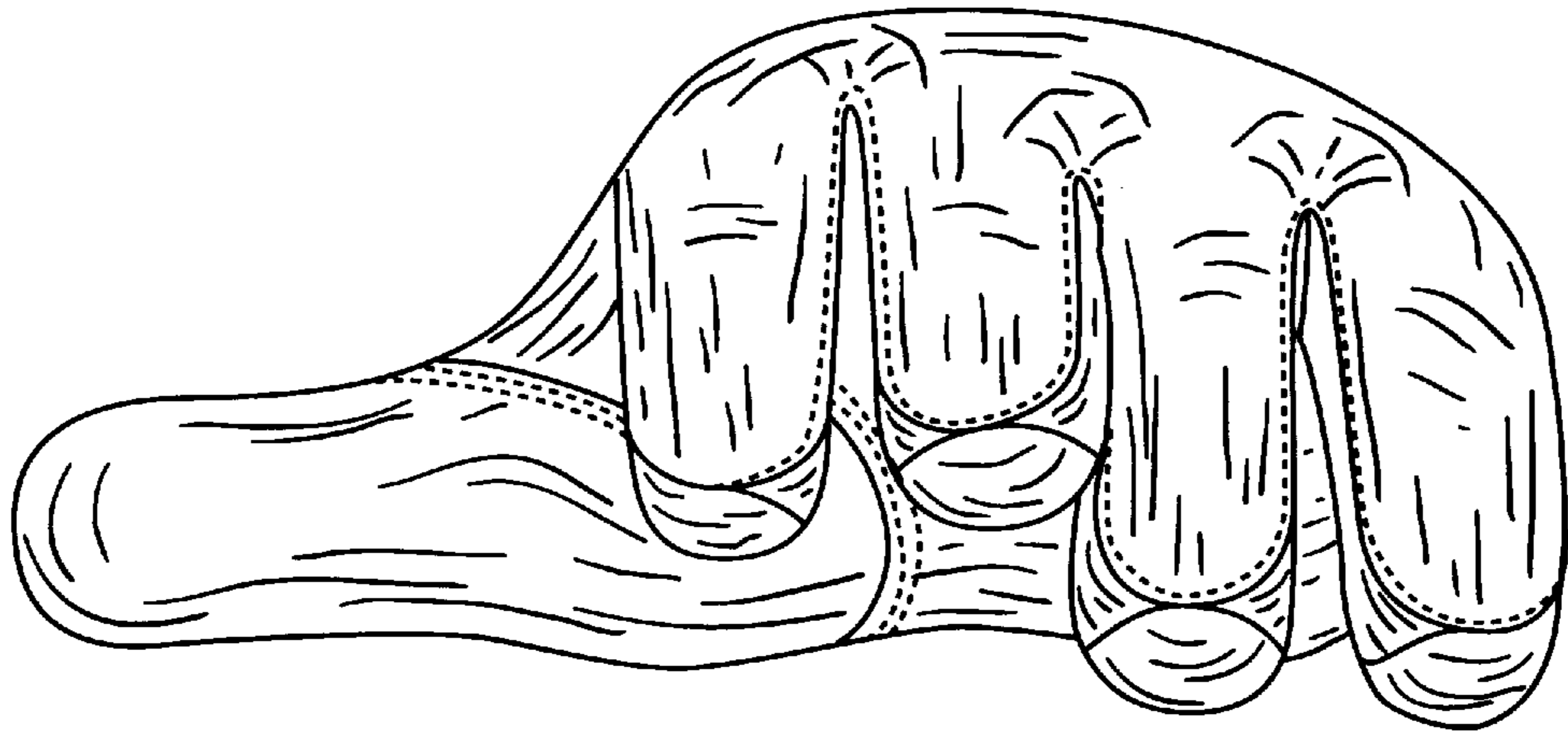

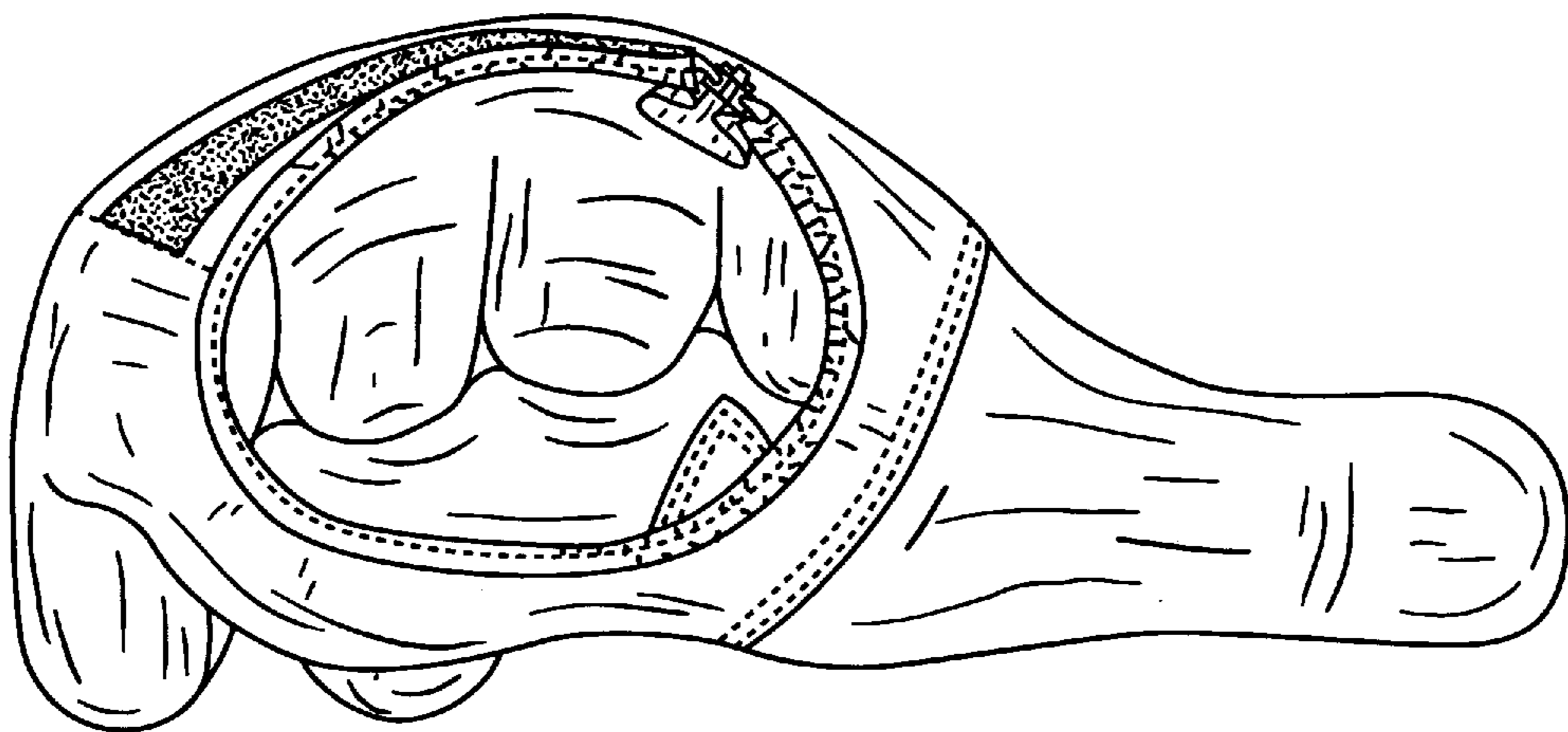
