The ornamental design for a turkey decoration, as shown and described.

DESCRIPTION

 FIG. 43 is a rear elevational view of FIG. 42;

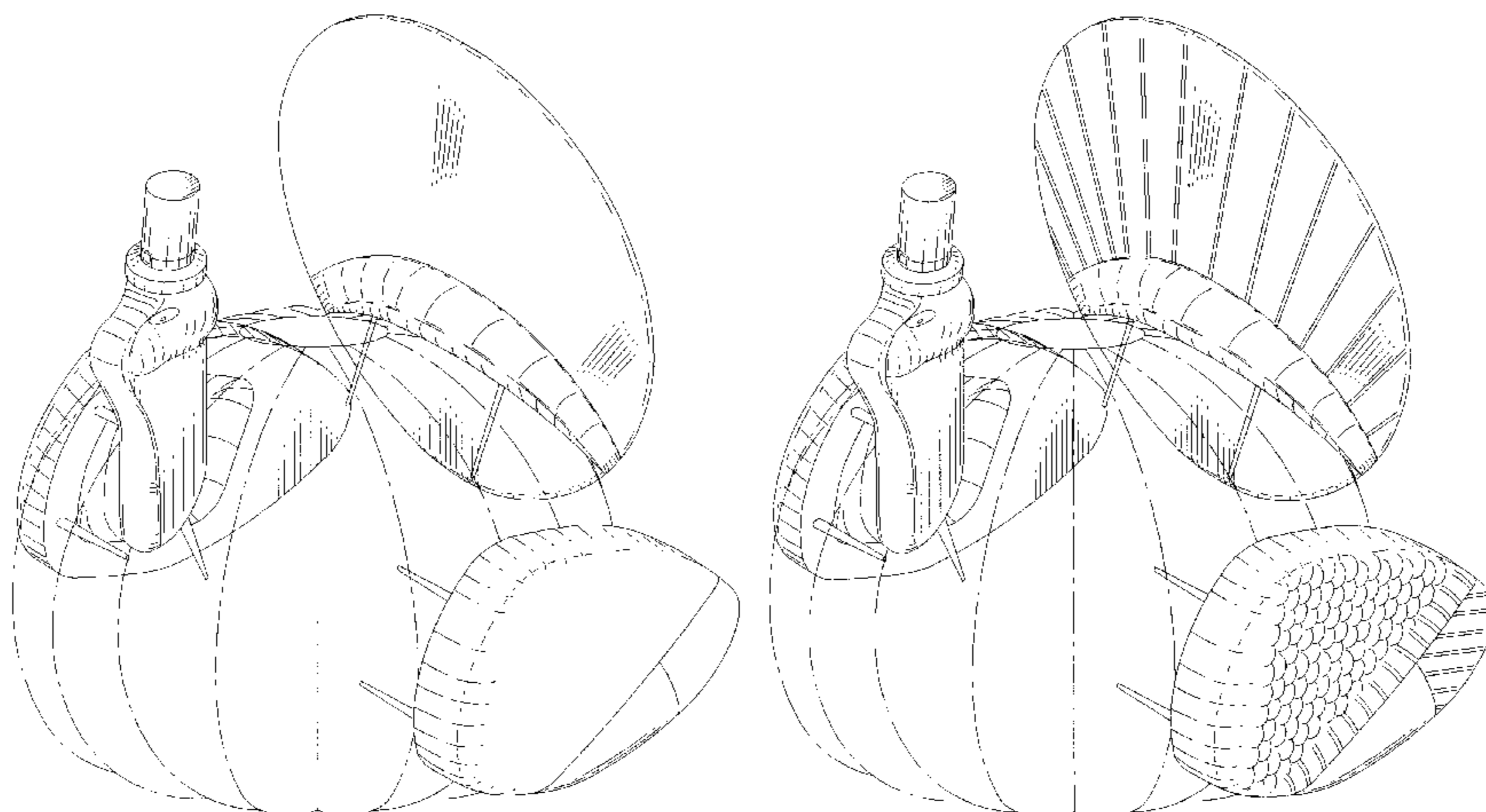


FIG. 44 is a left side elevational view of FIG. 42, the right side being a mirror image thereof;

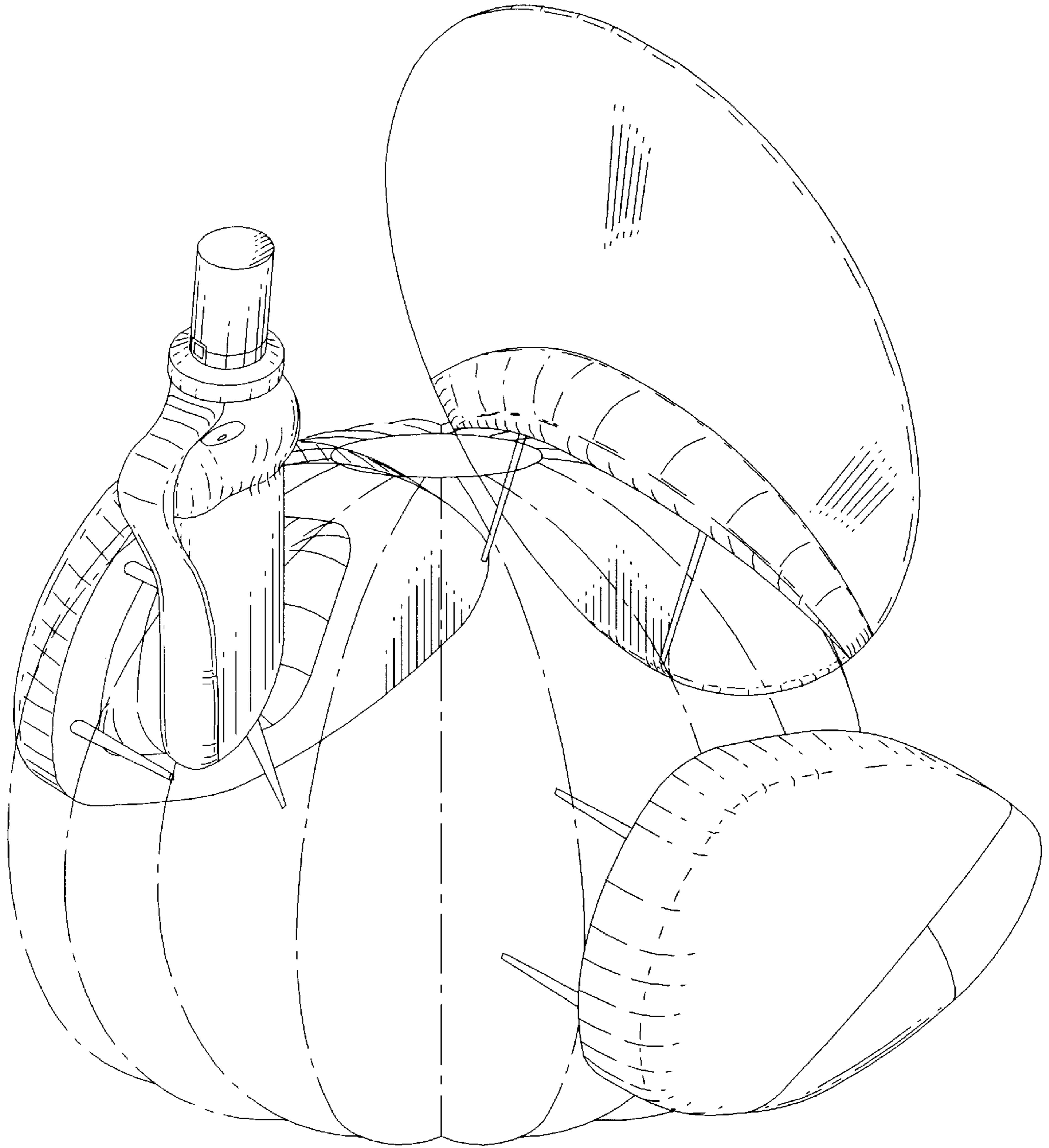

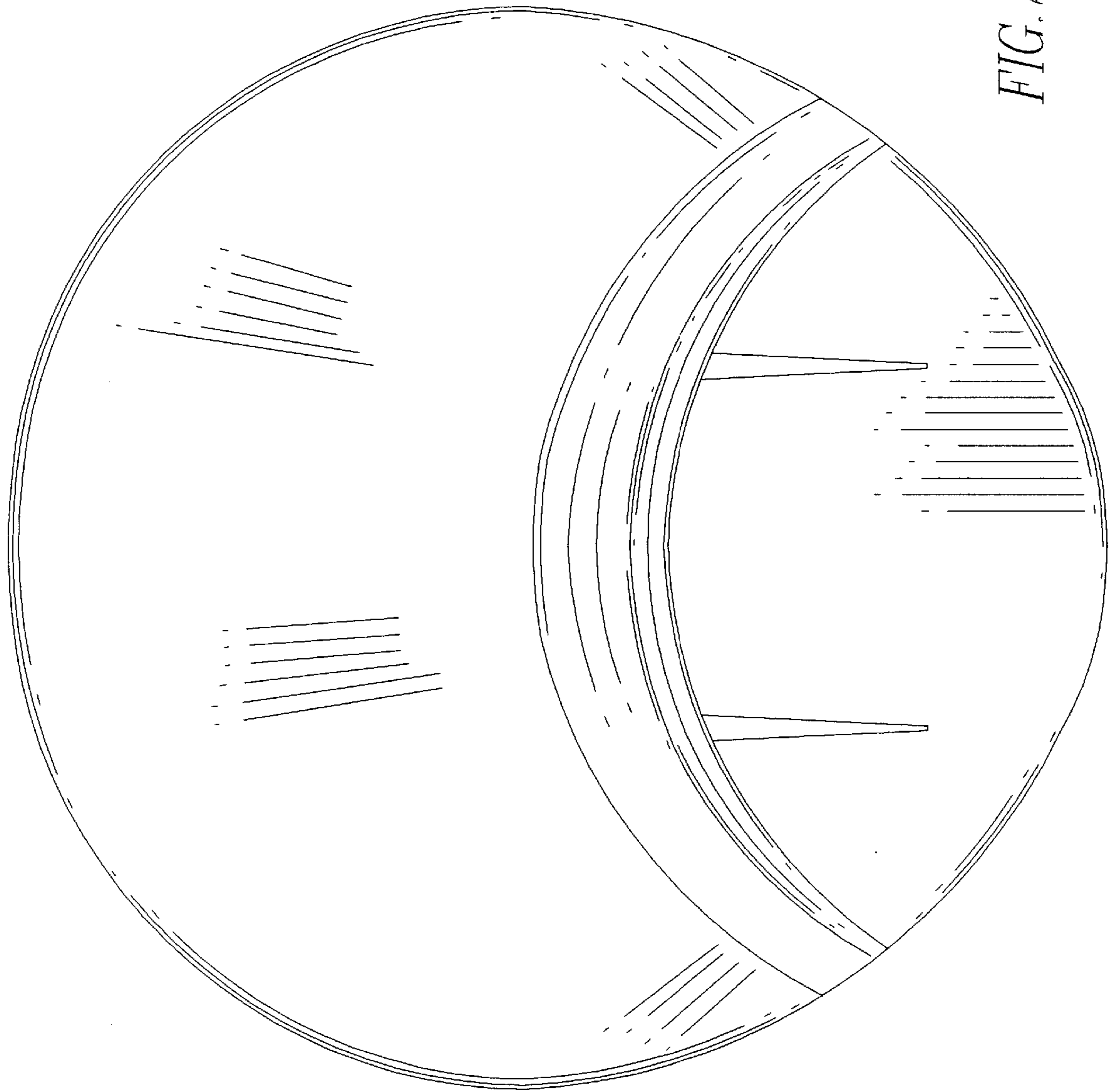

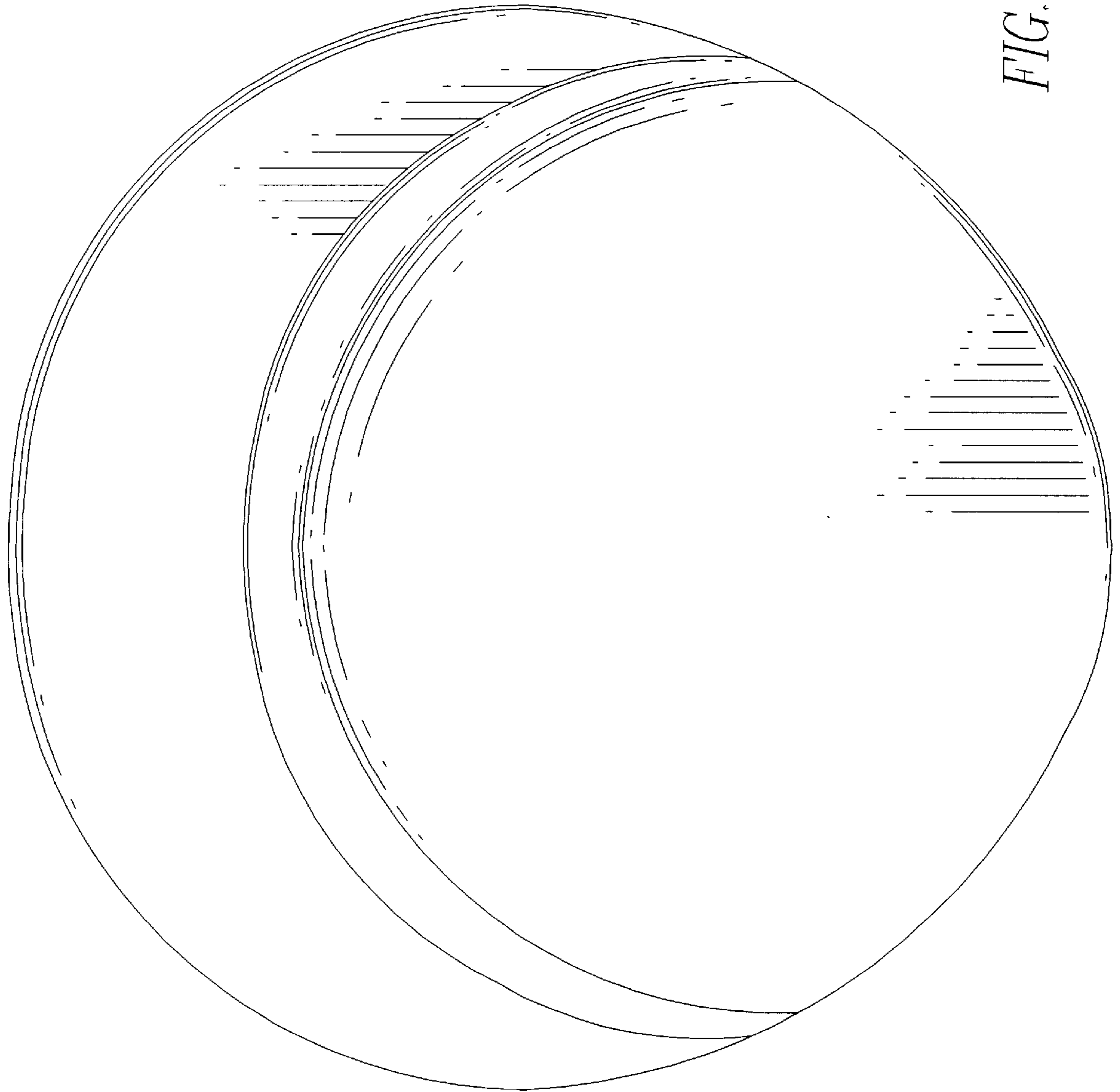

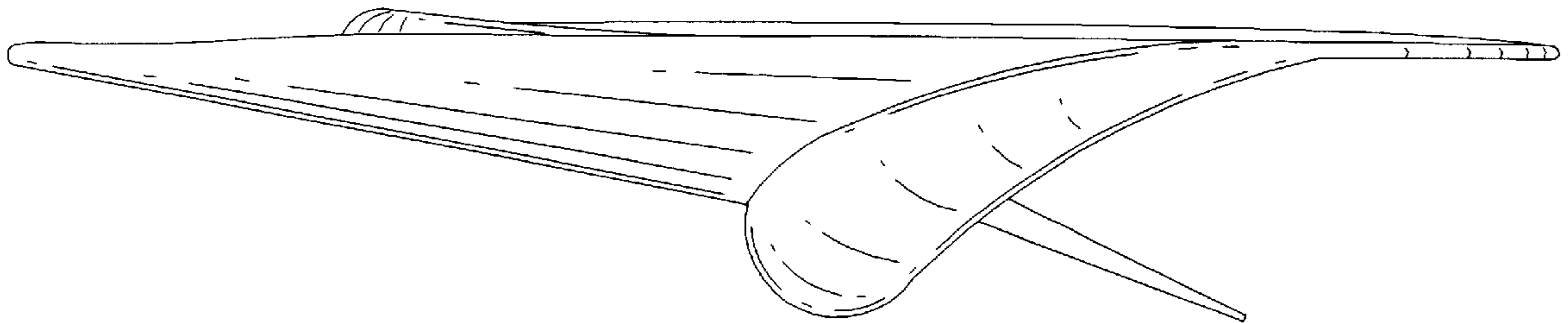

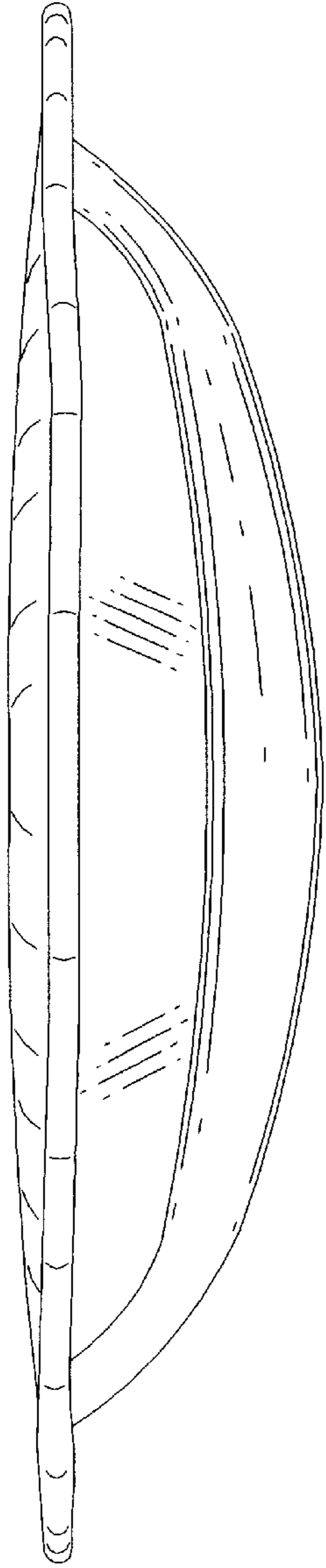

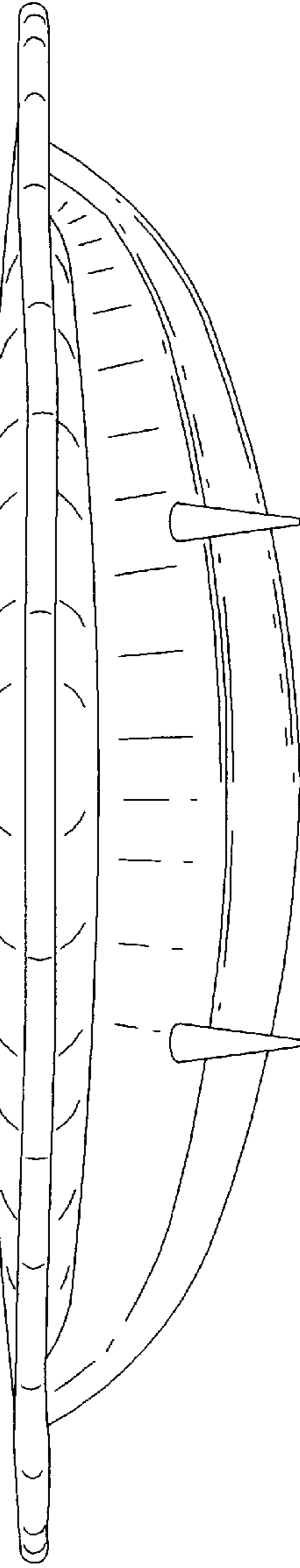

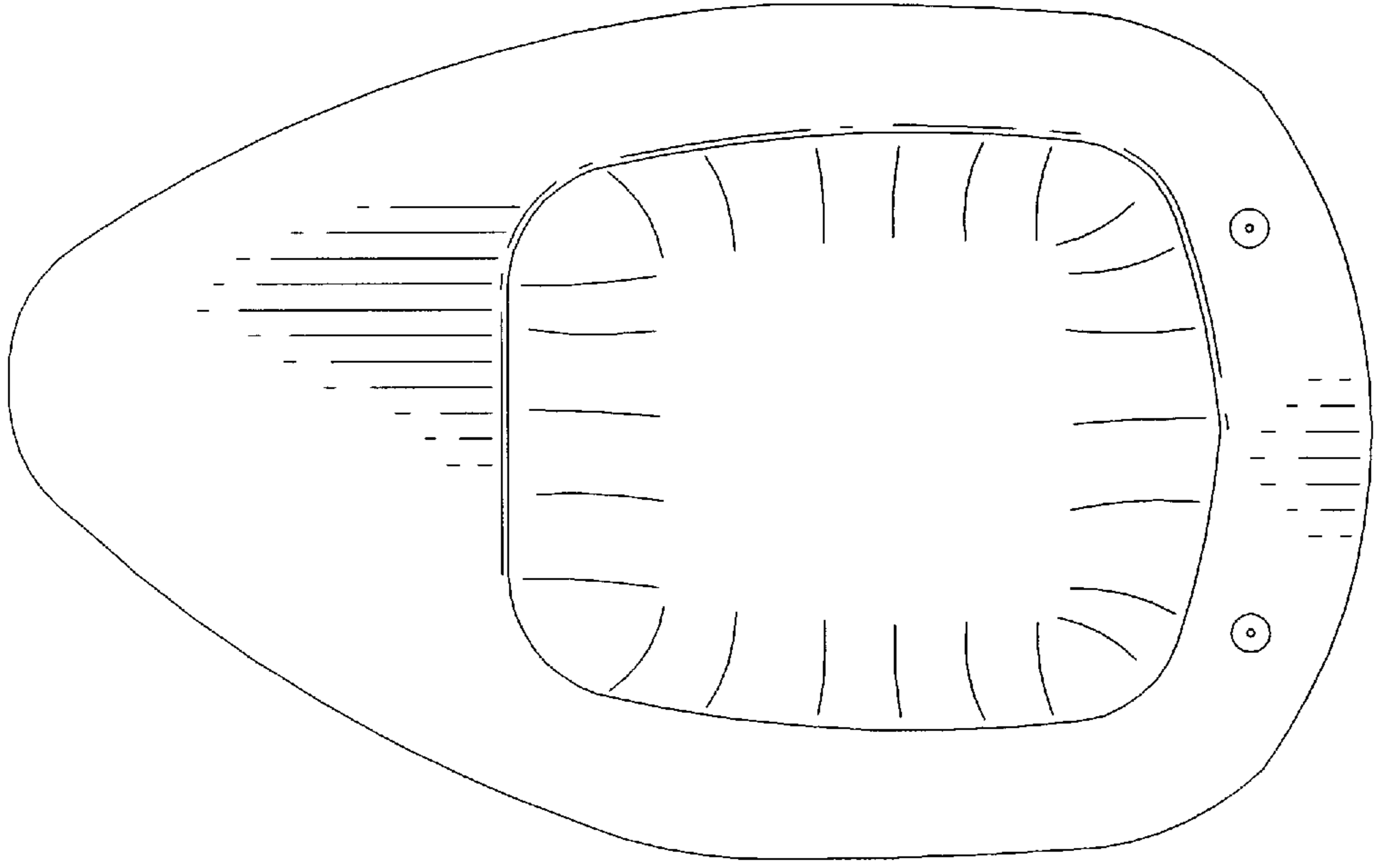

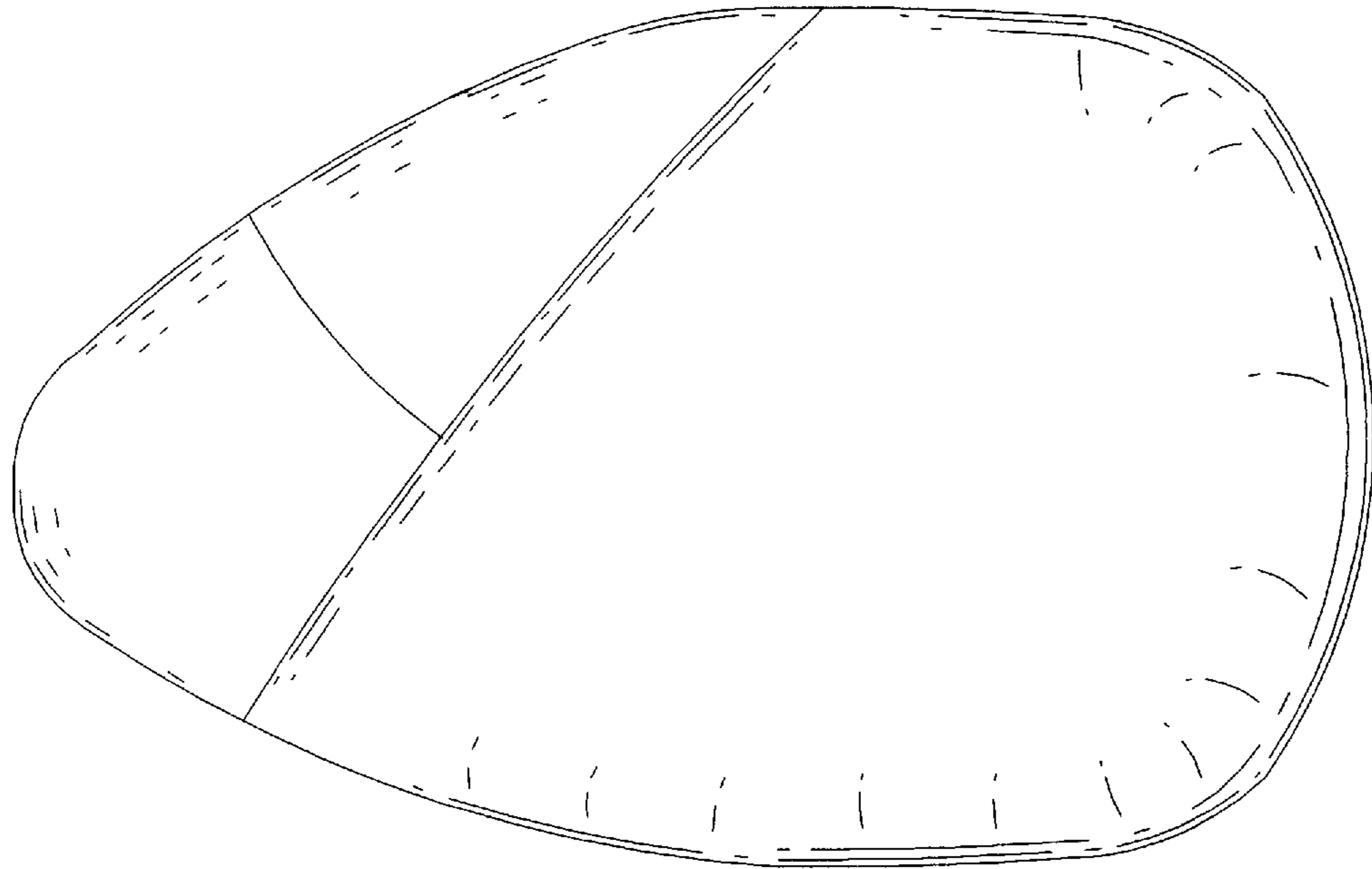

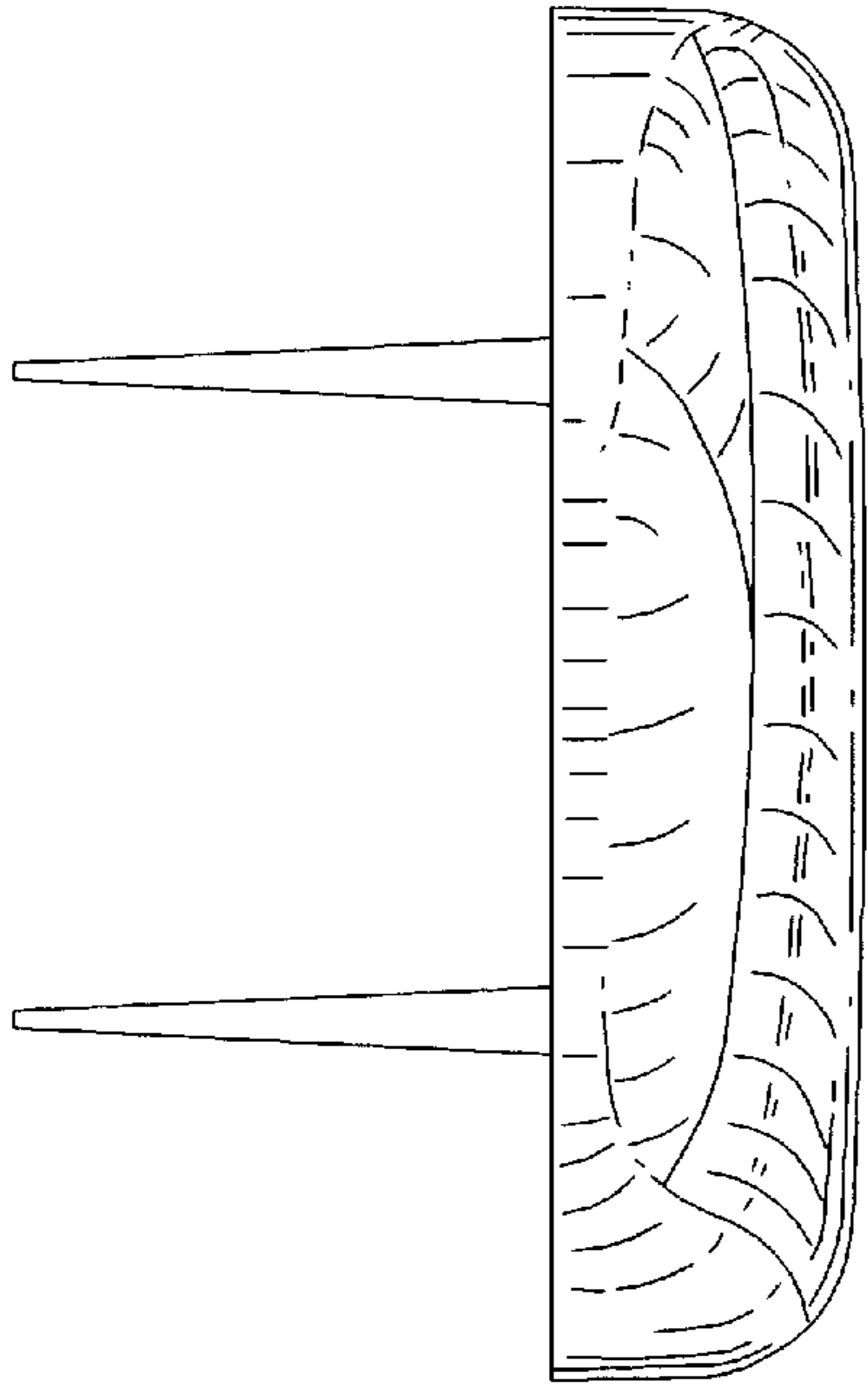

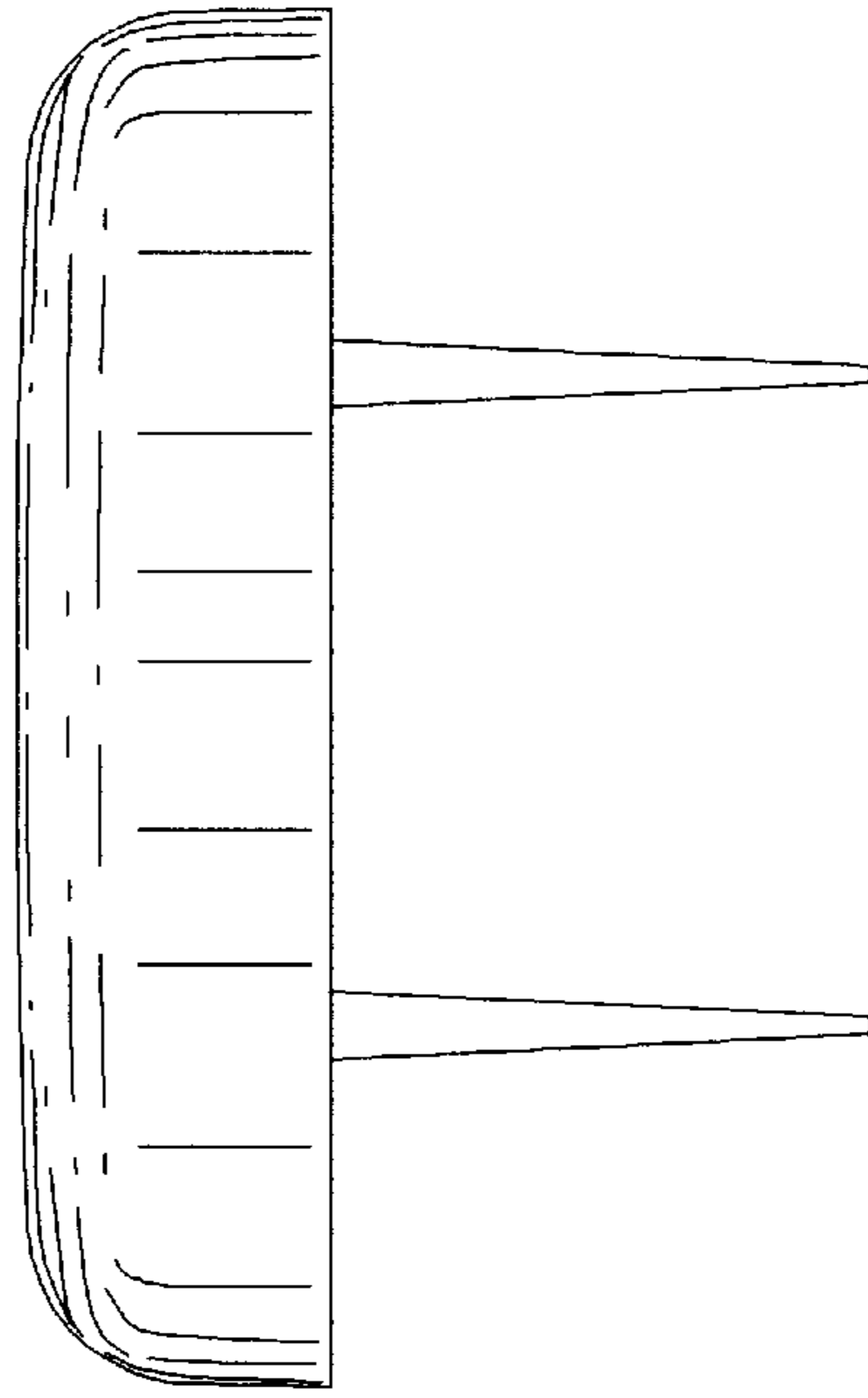

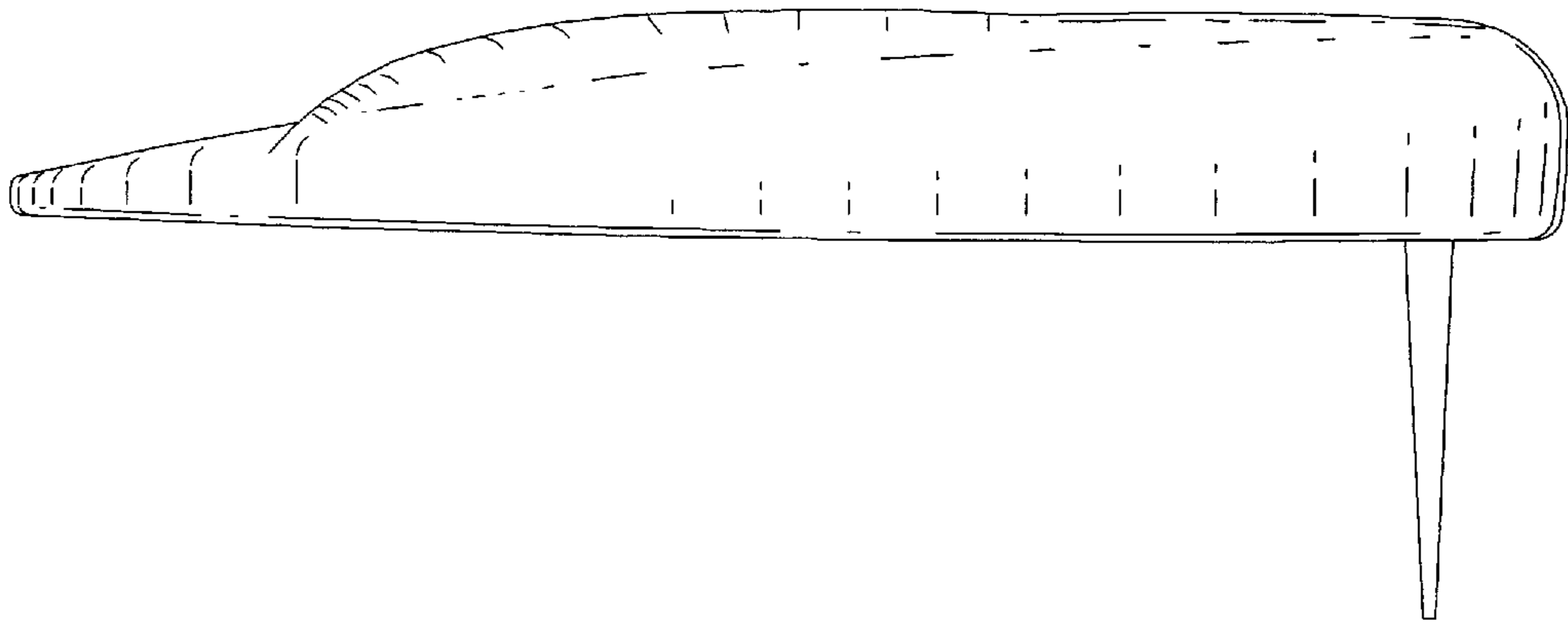

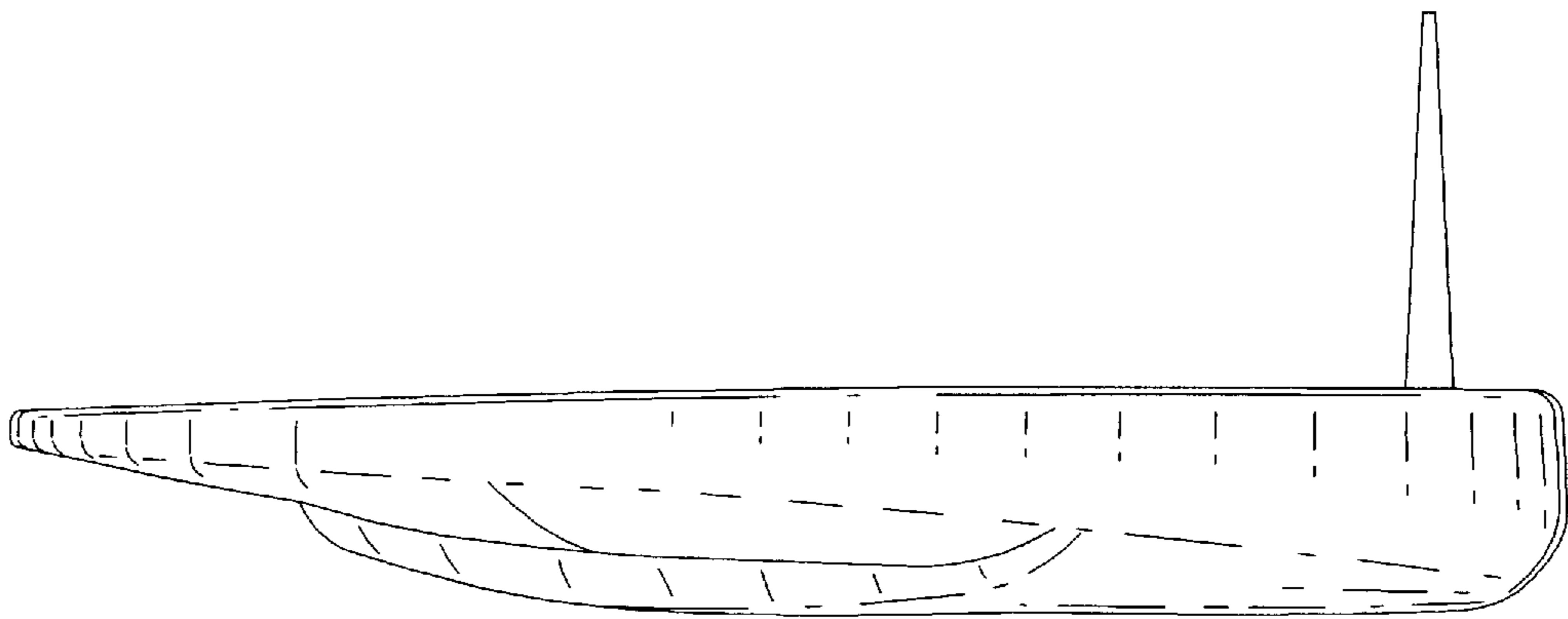

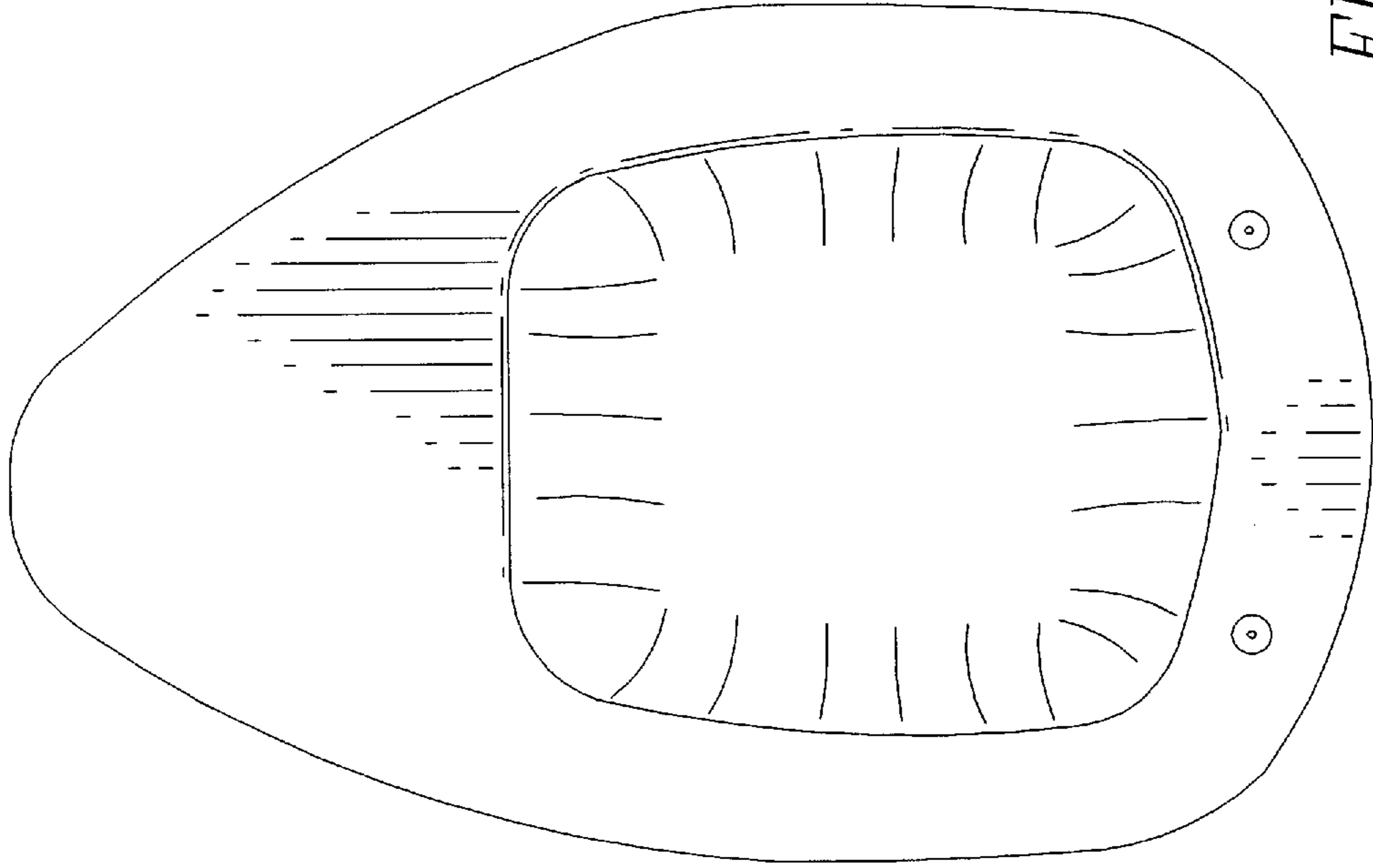

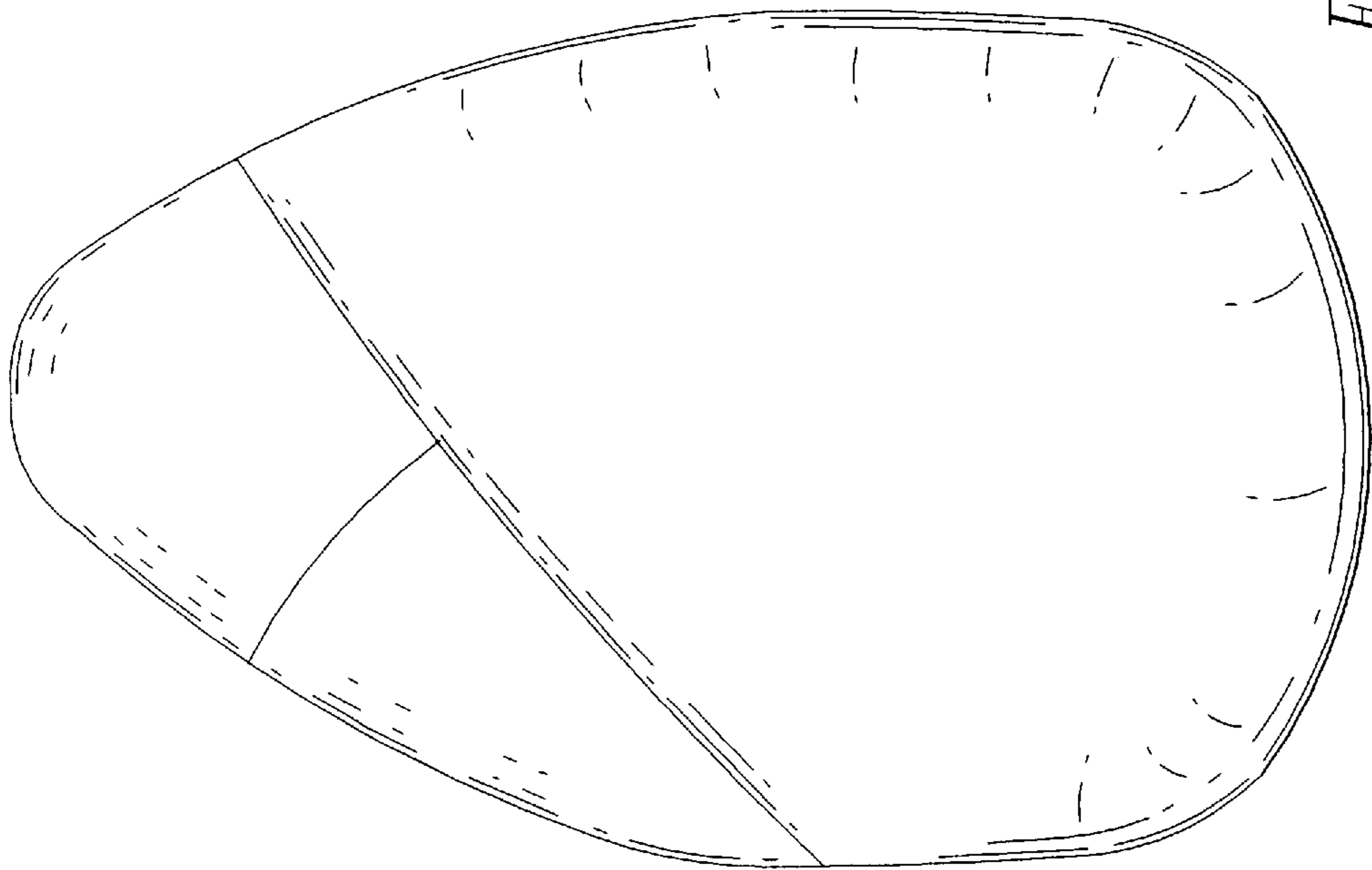

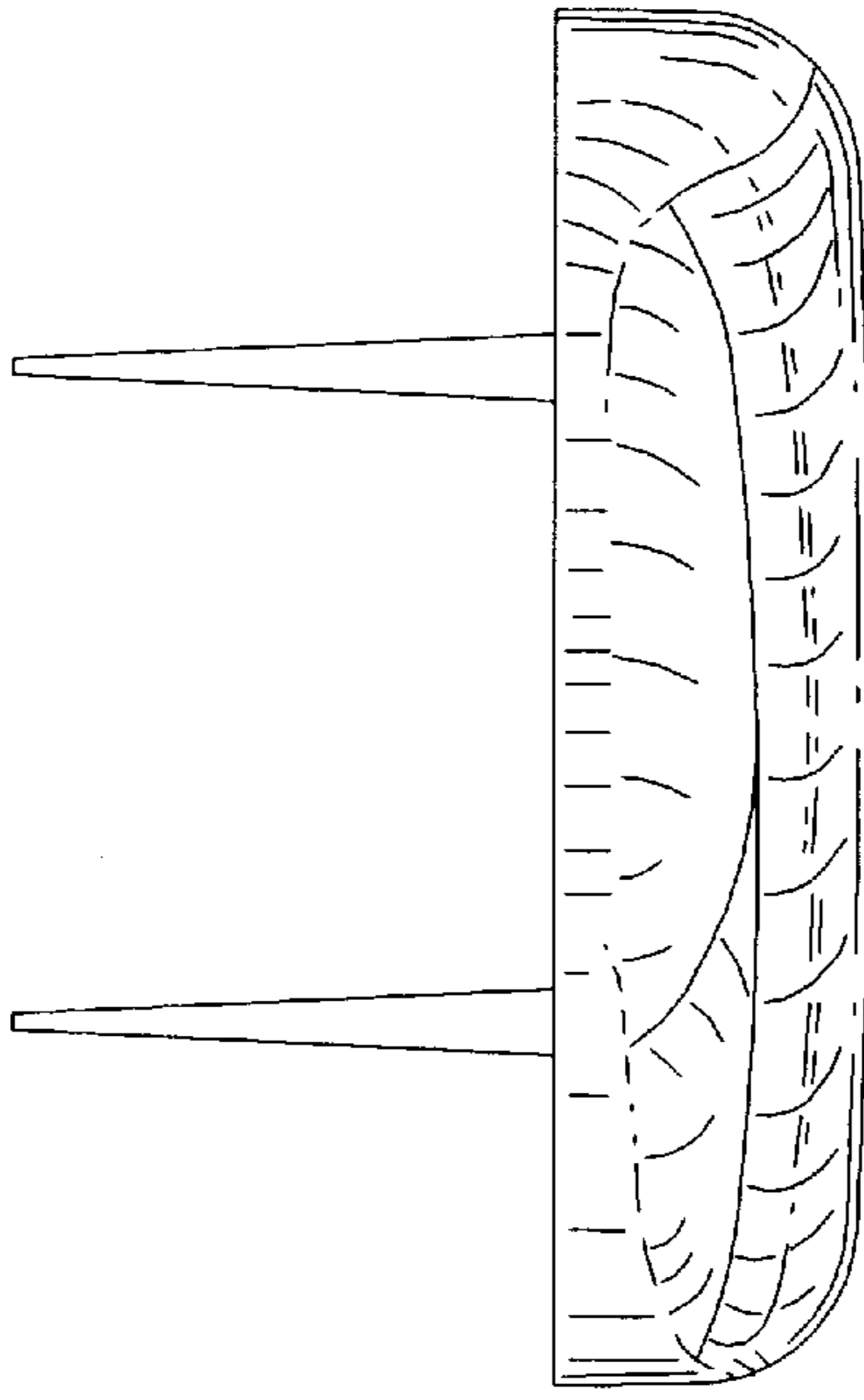

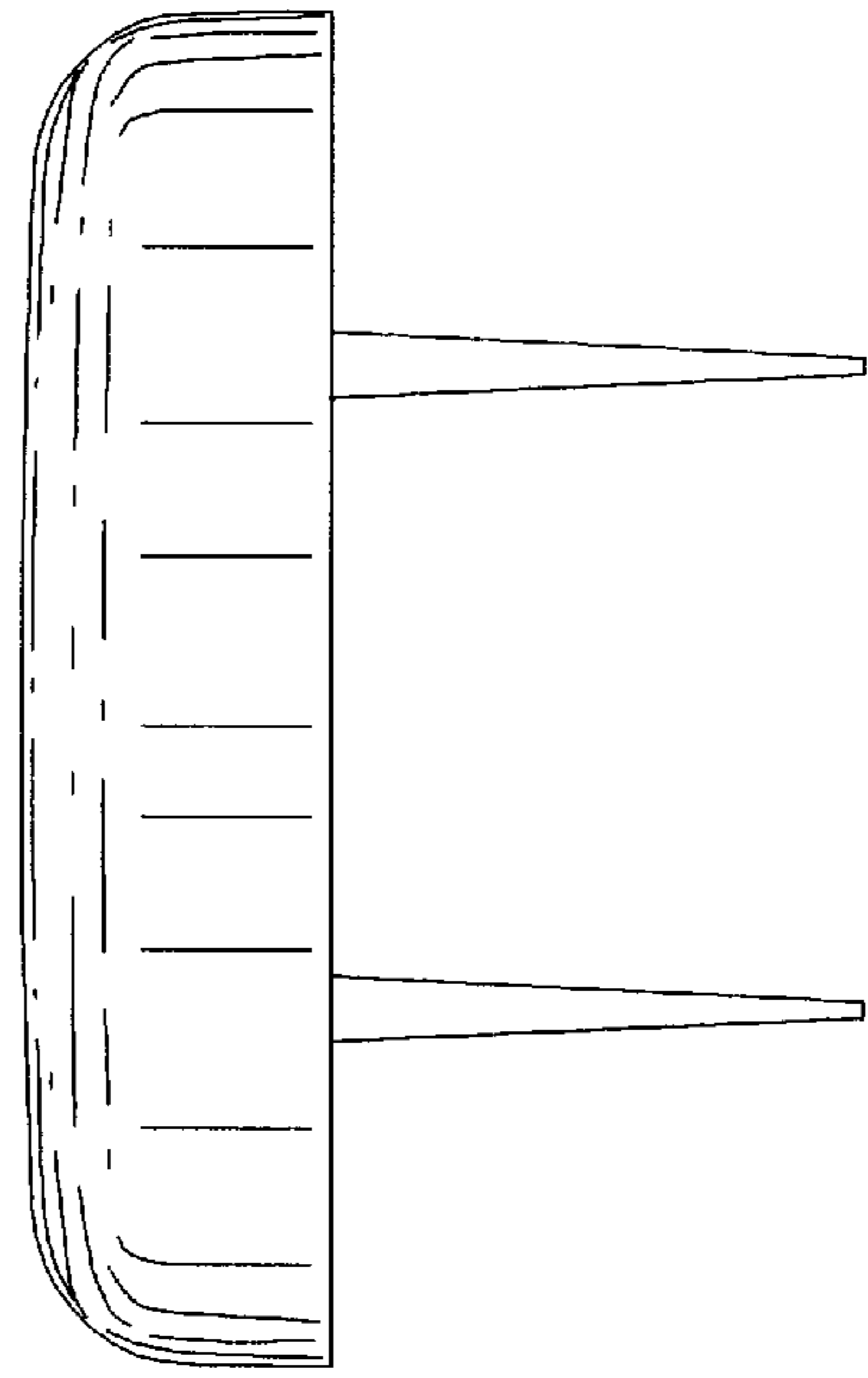

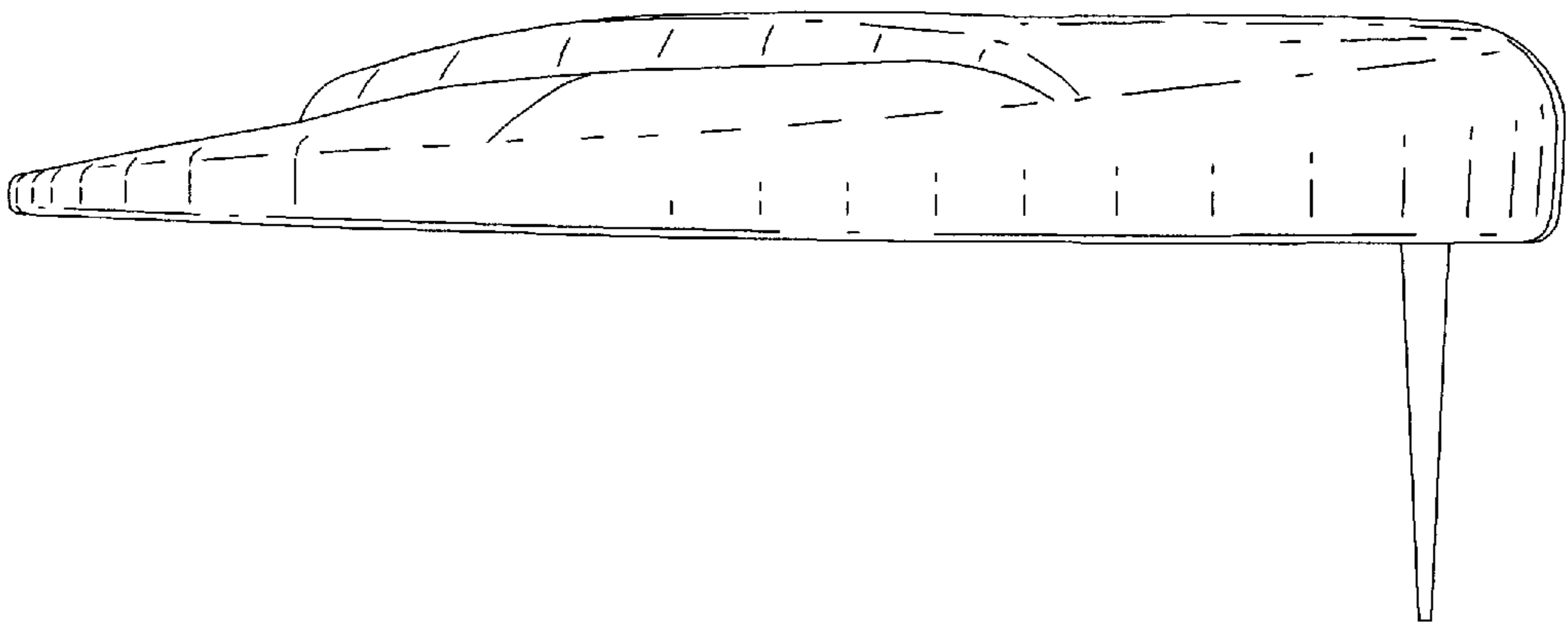

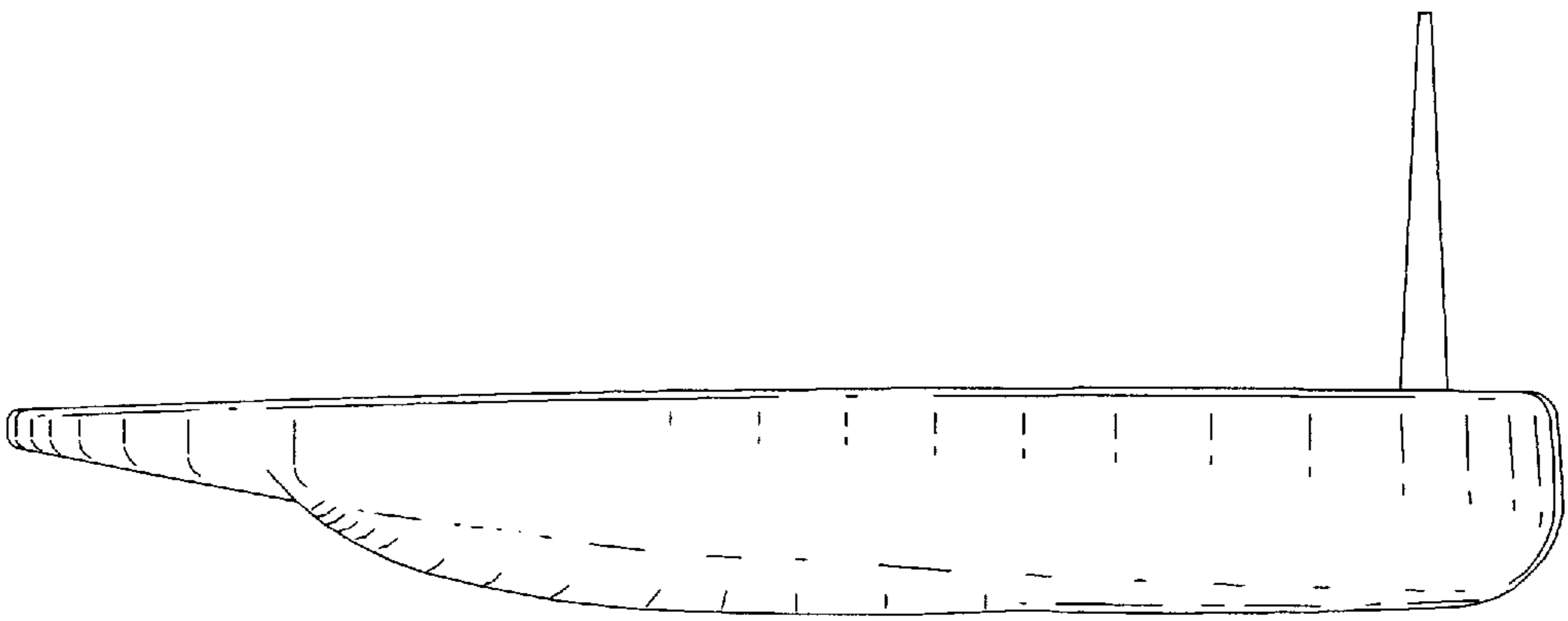

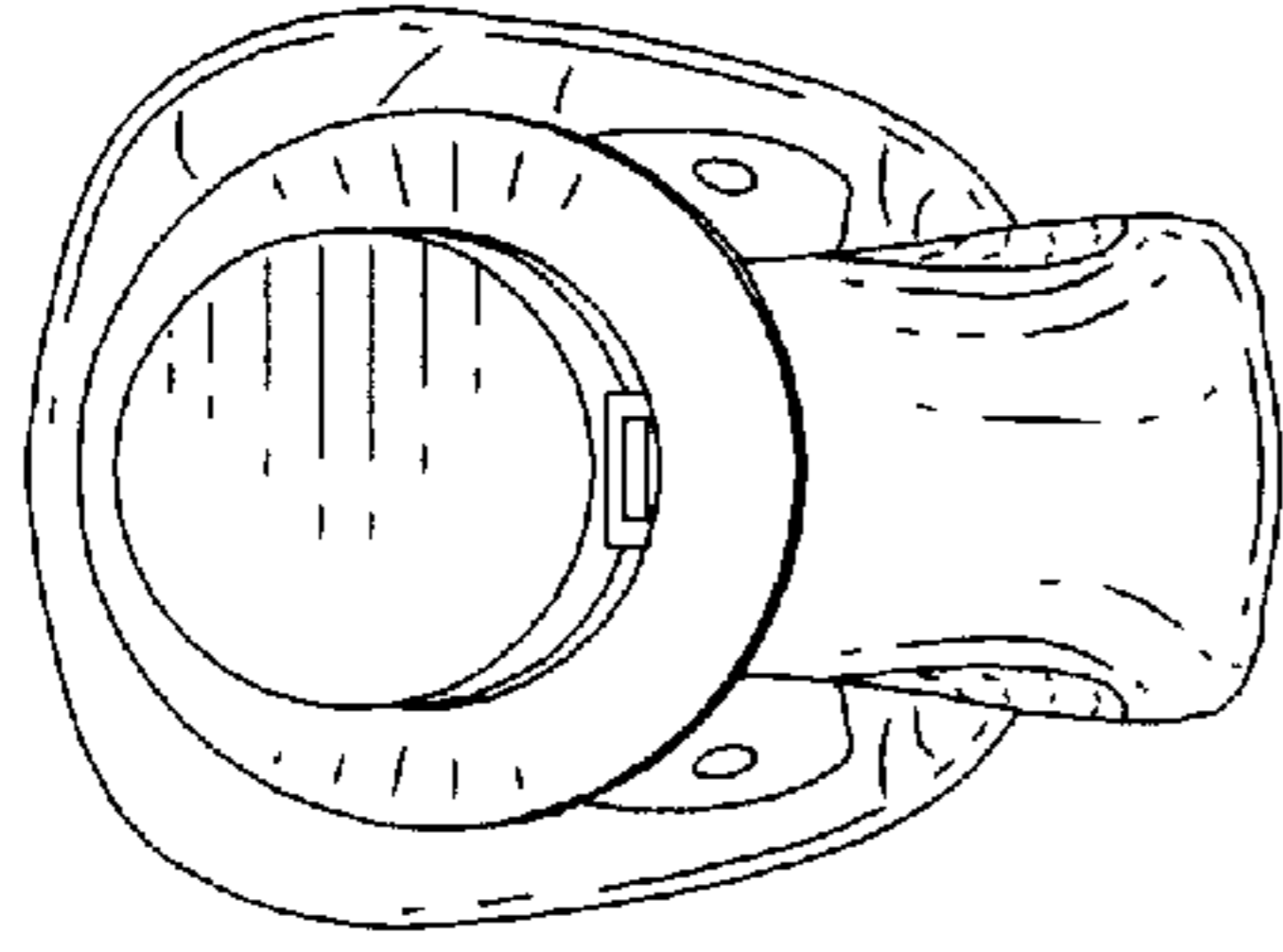

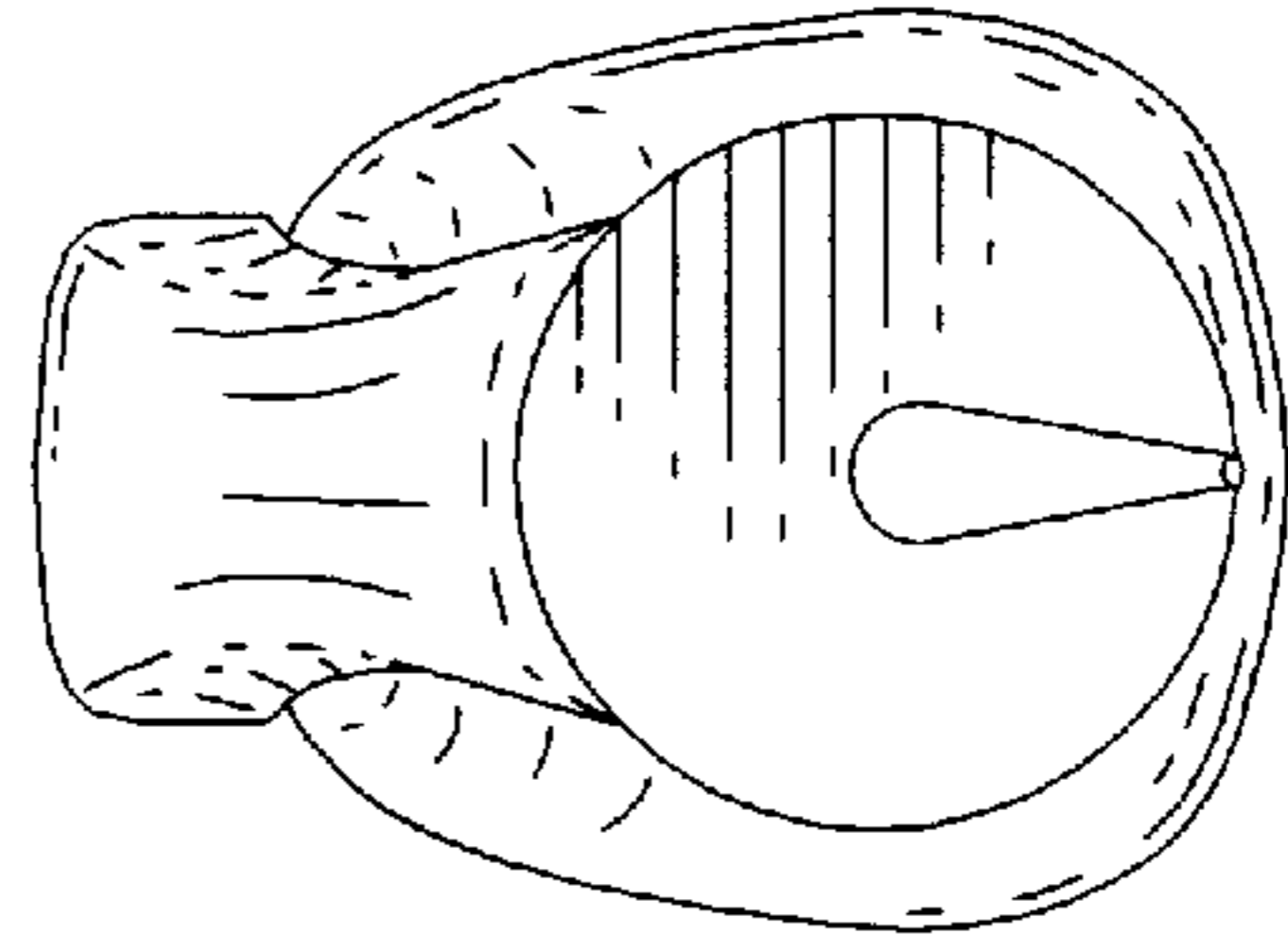

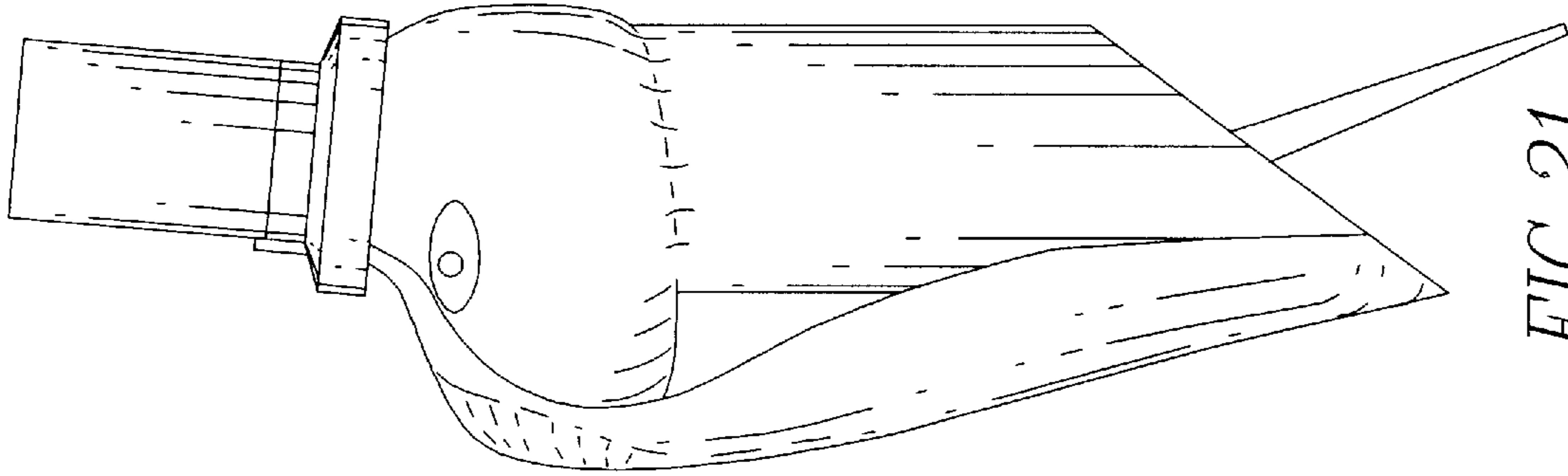

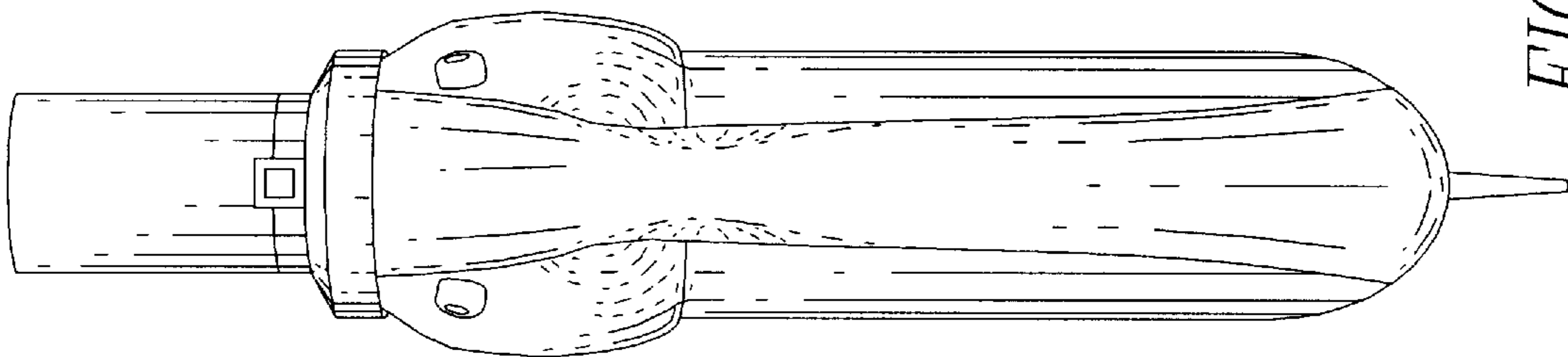

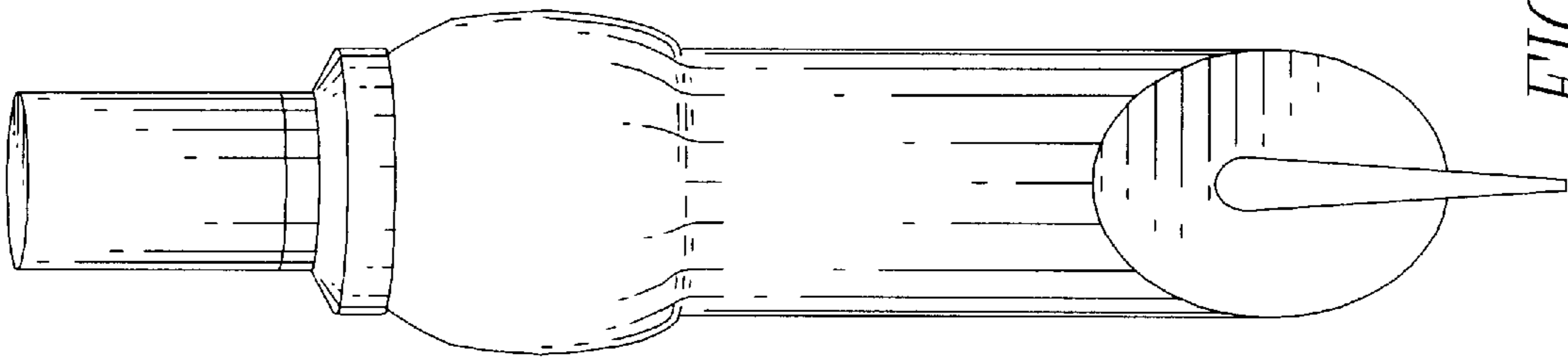

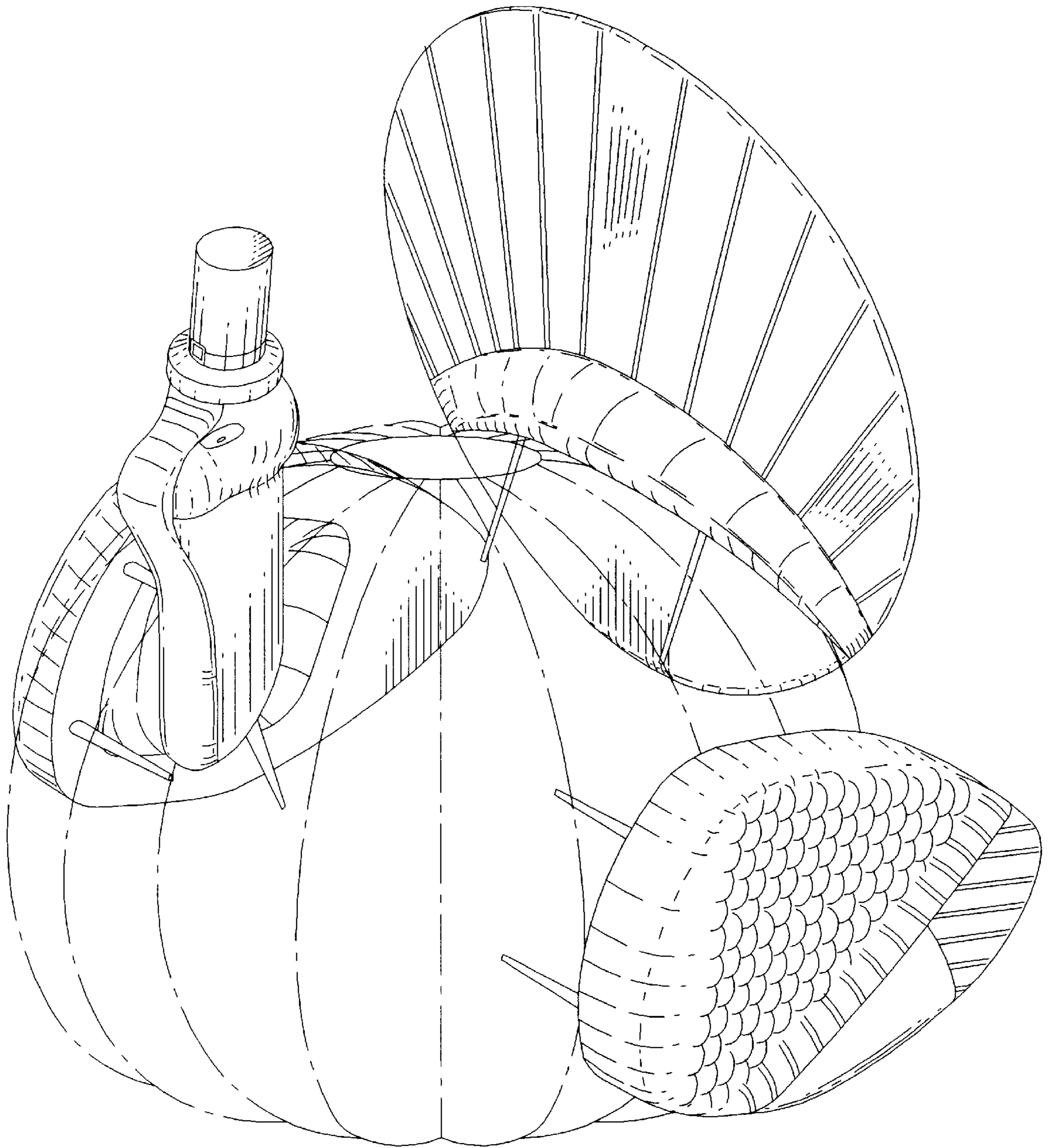

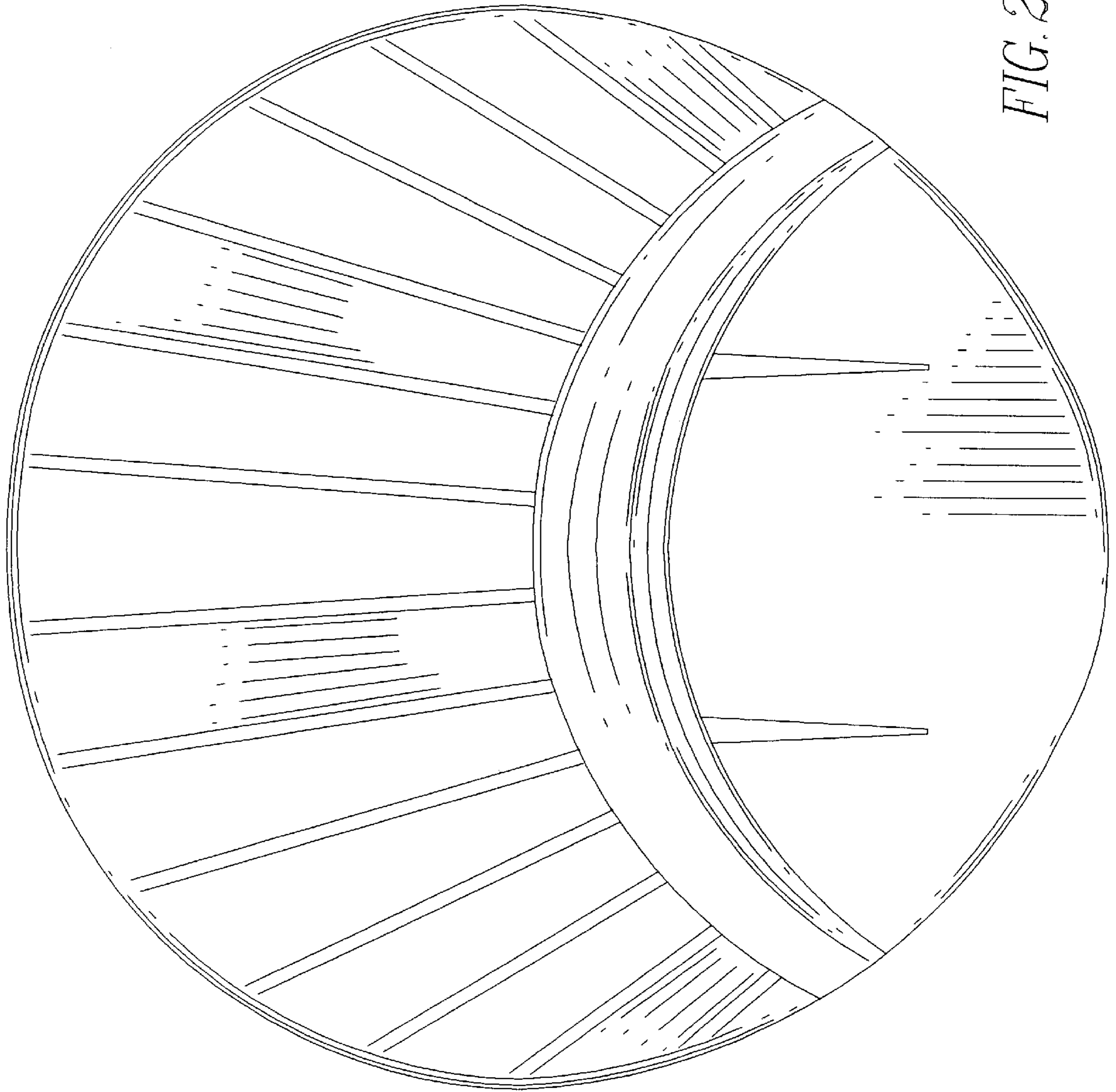

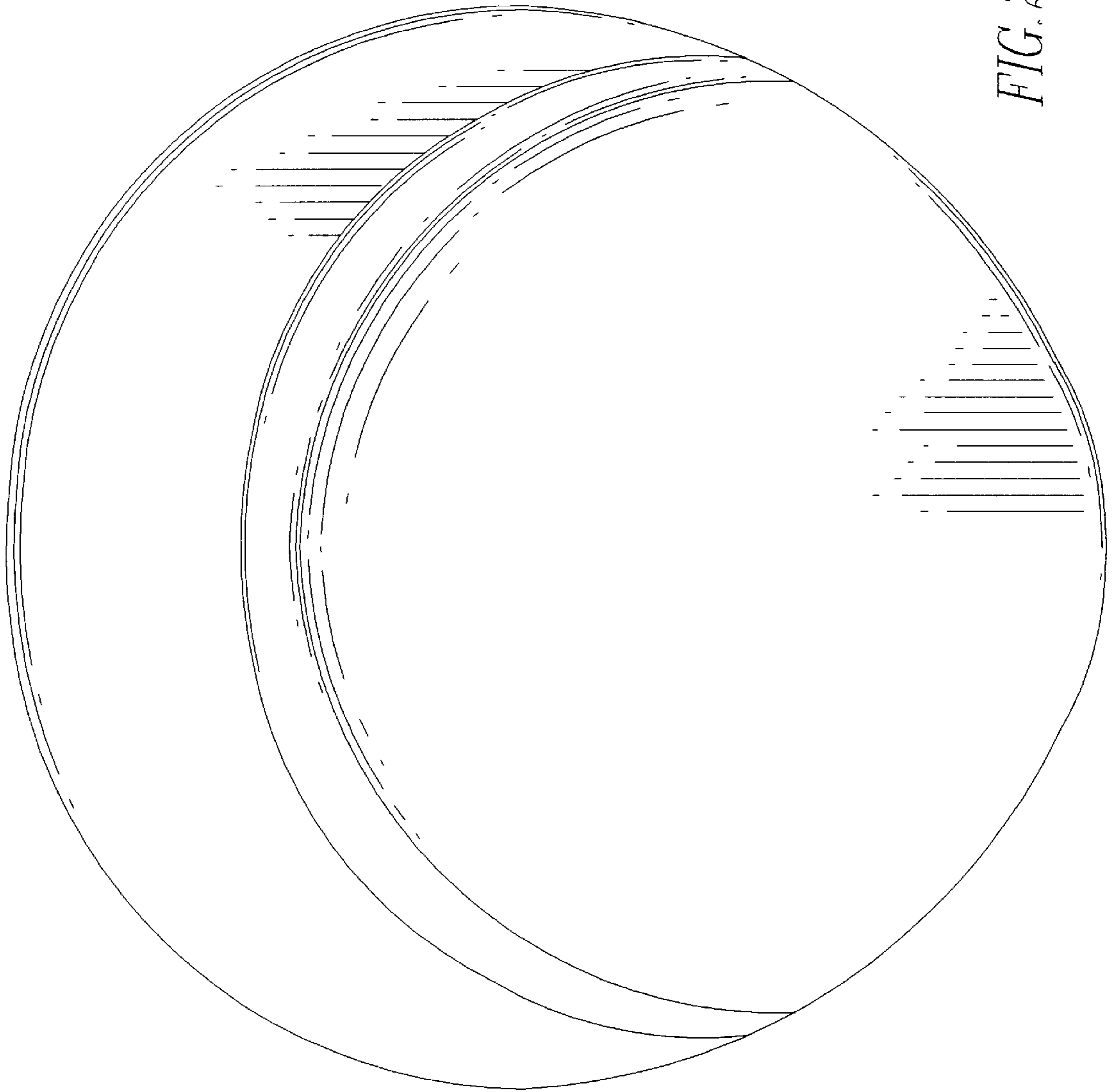

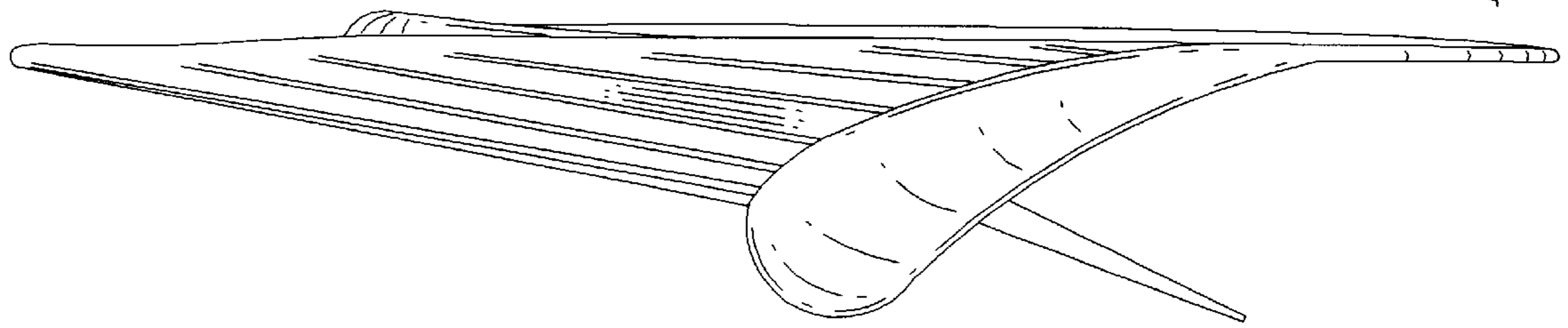

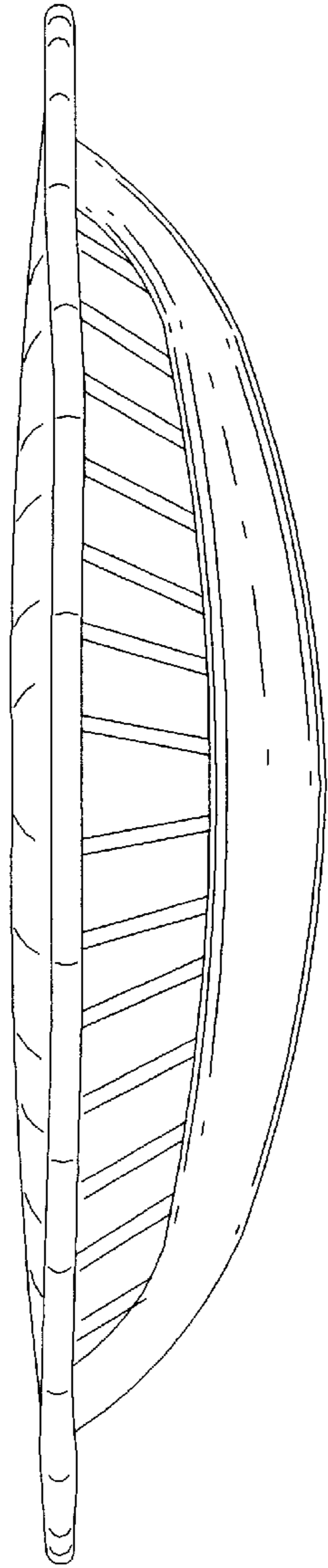

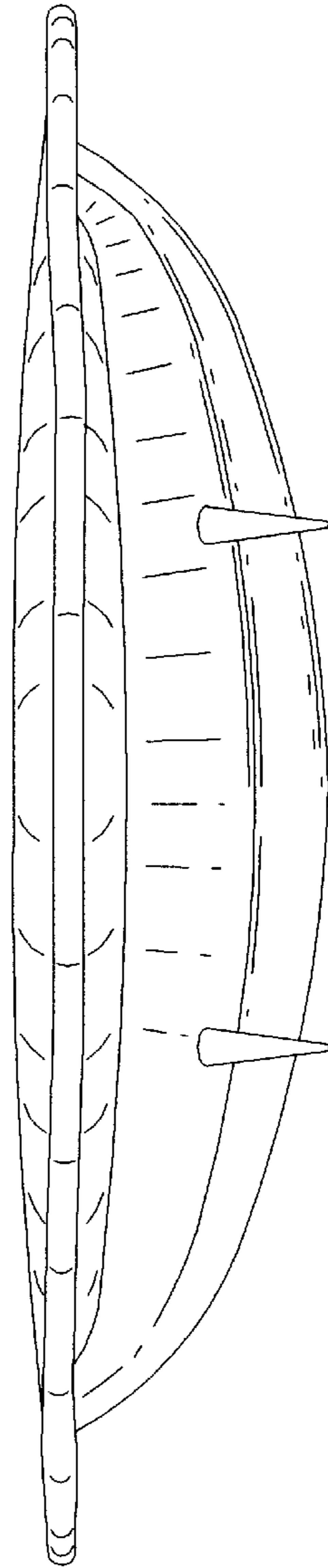

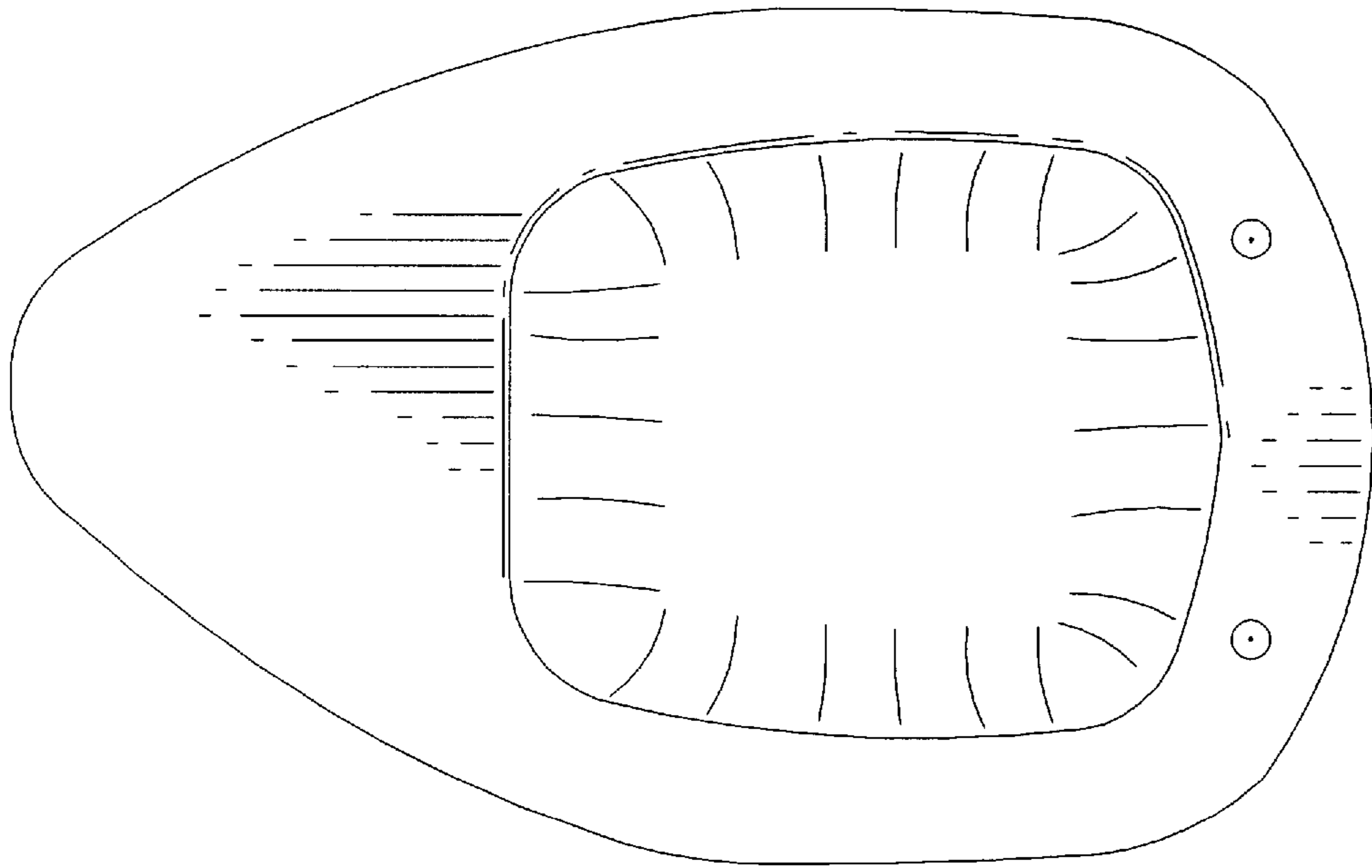

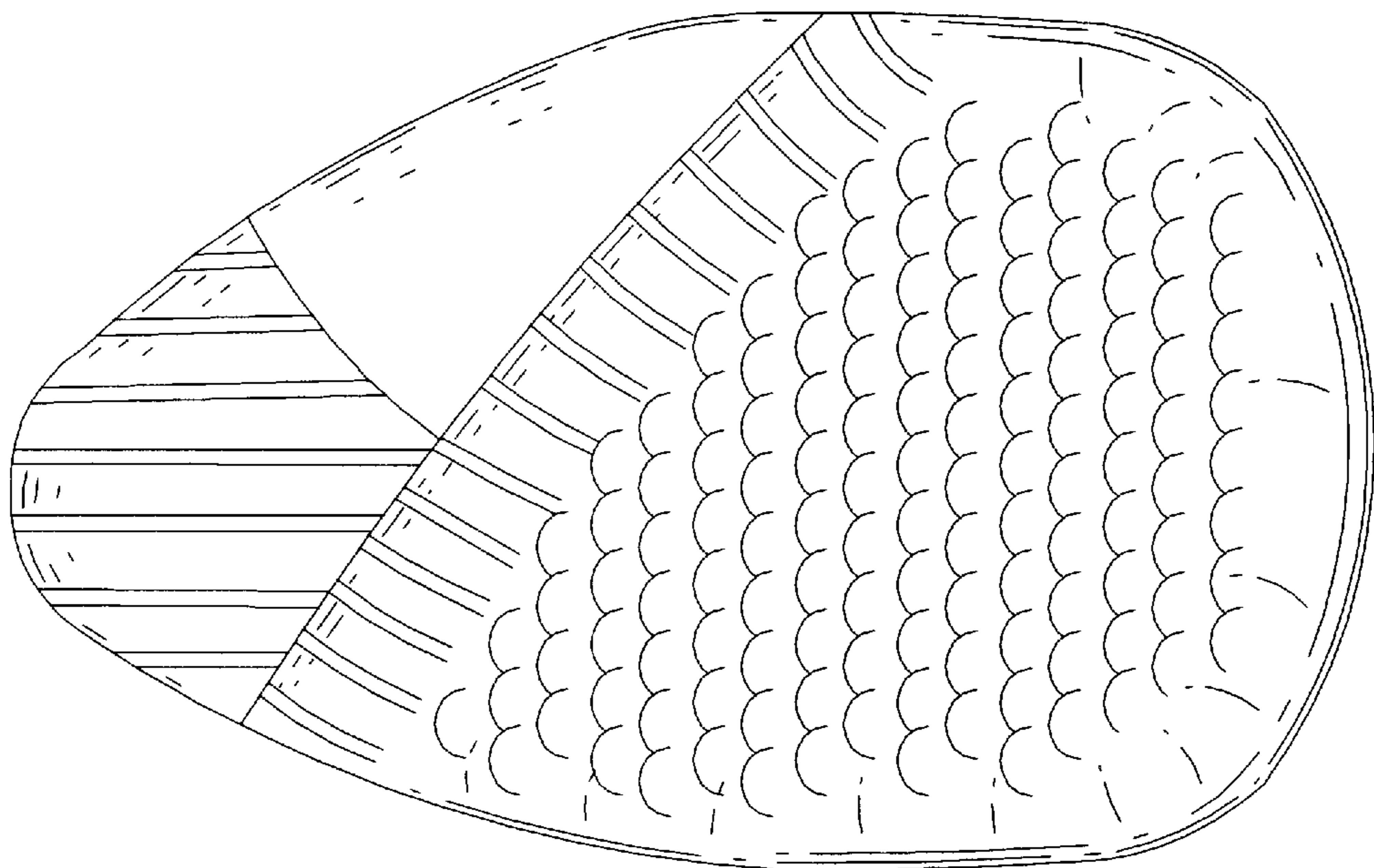

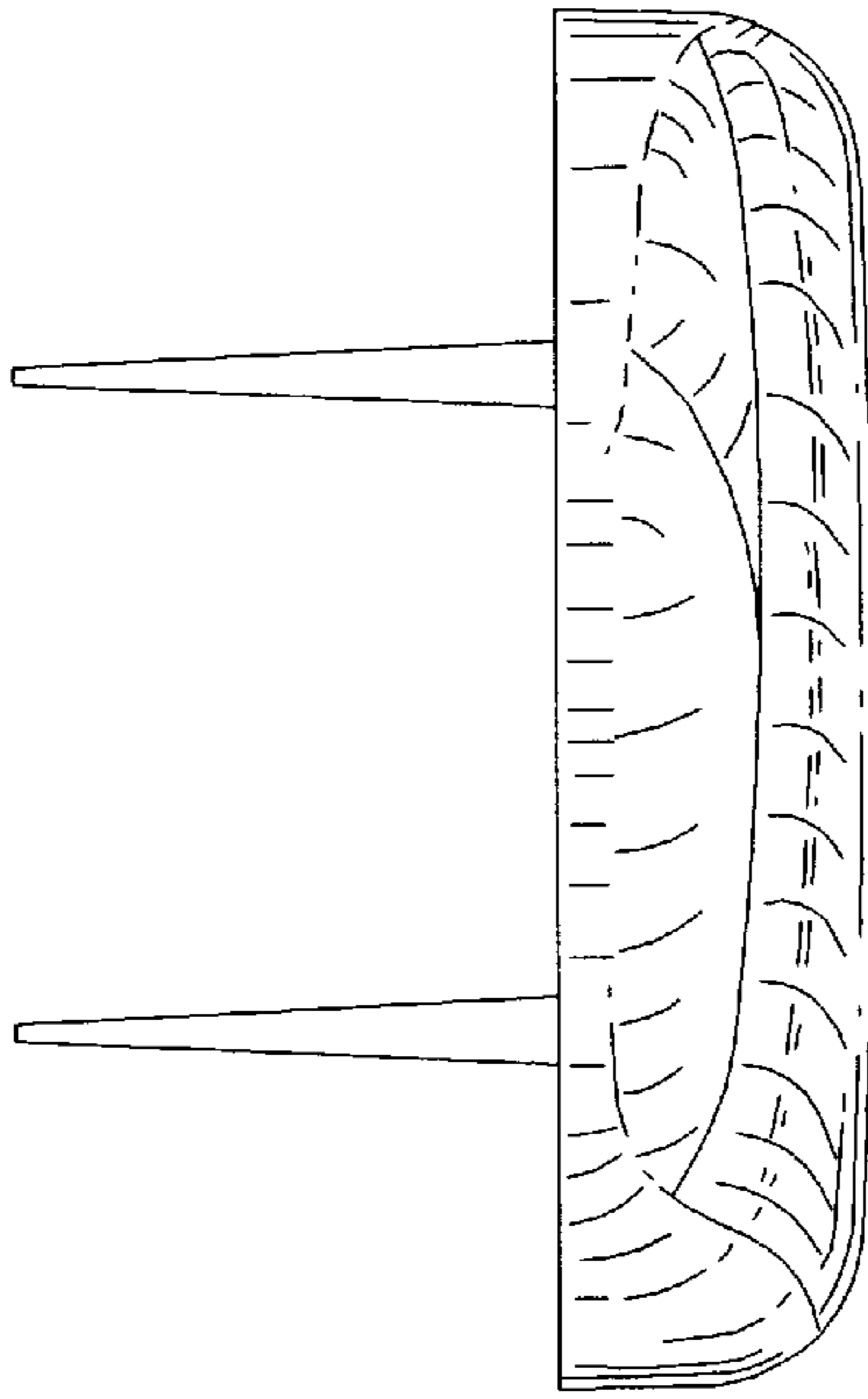

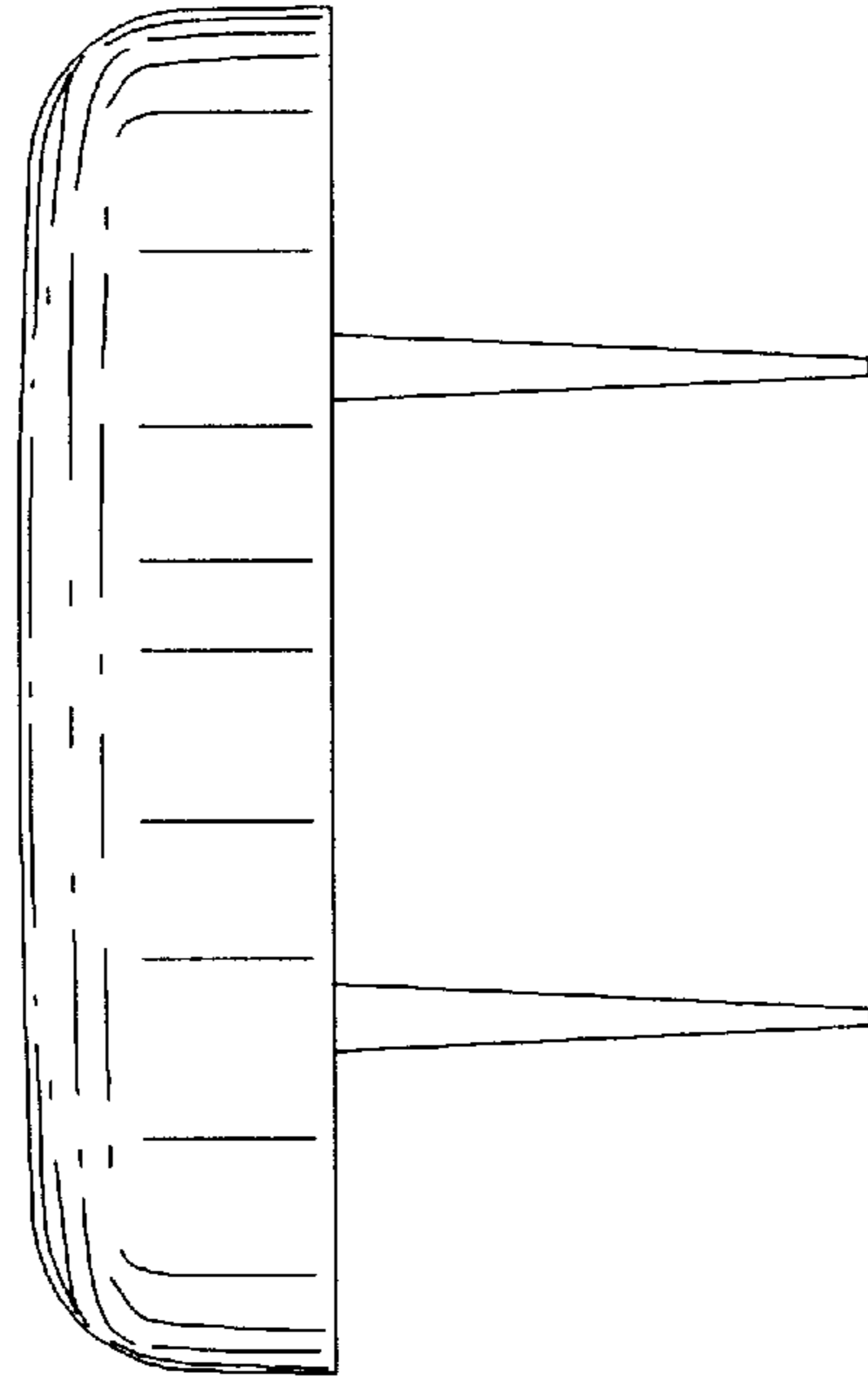

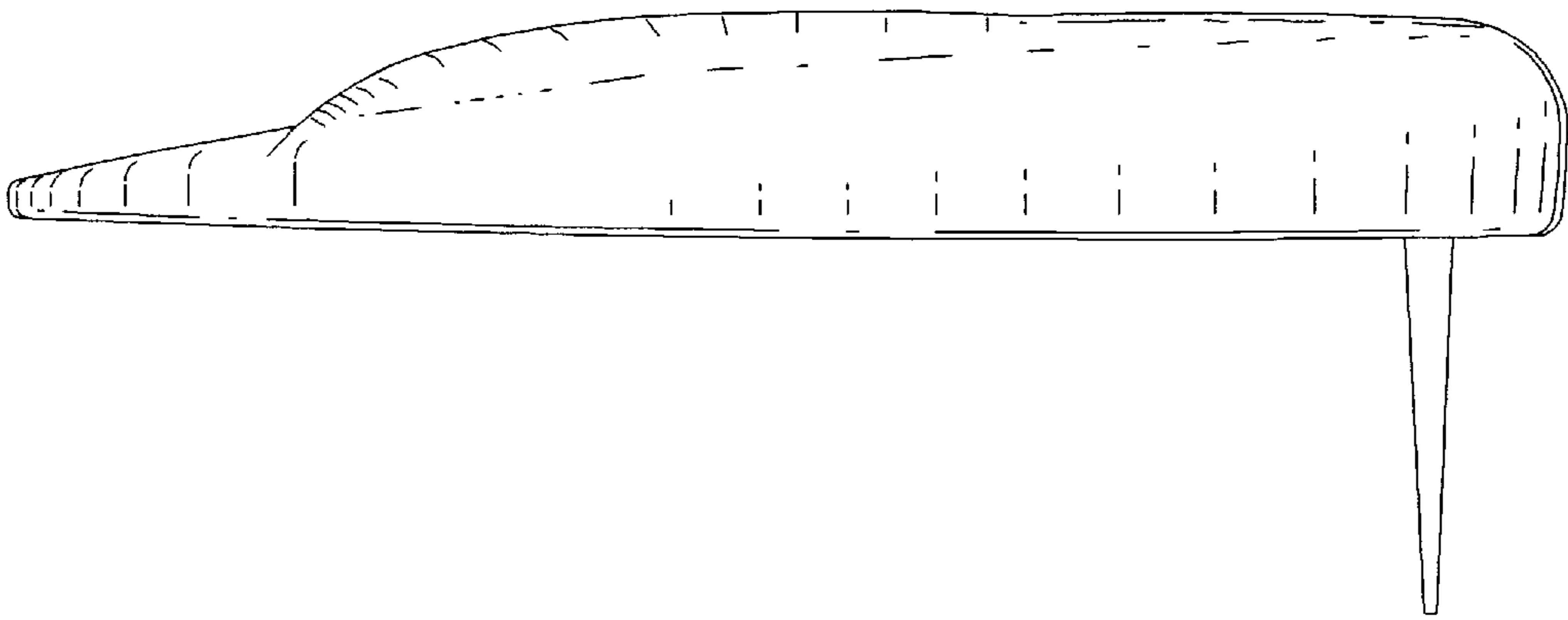

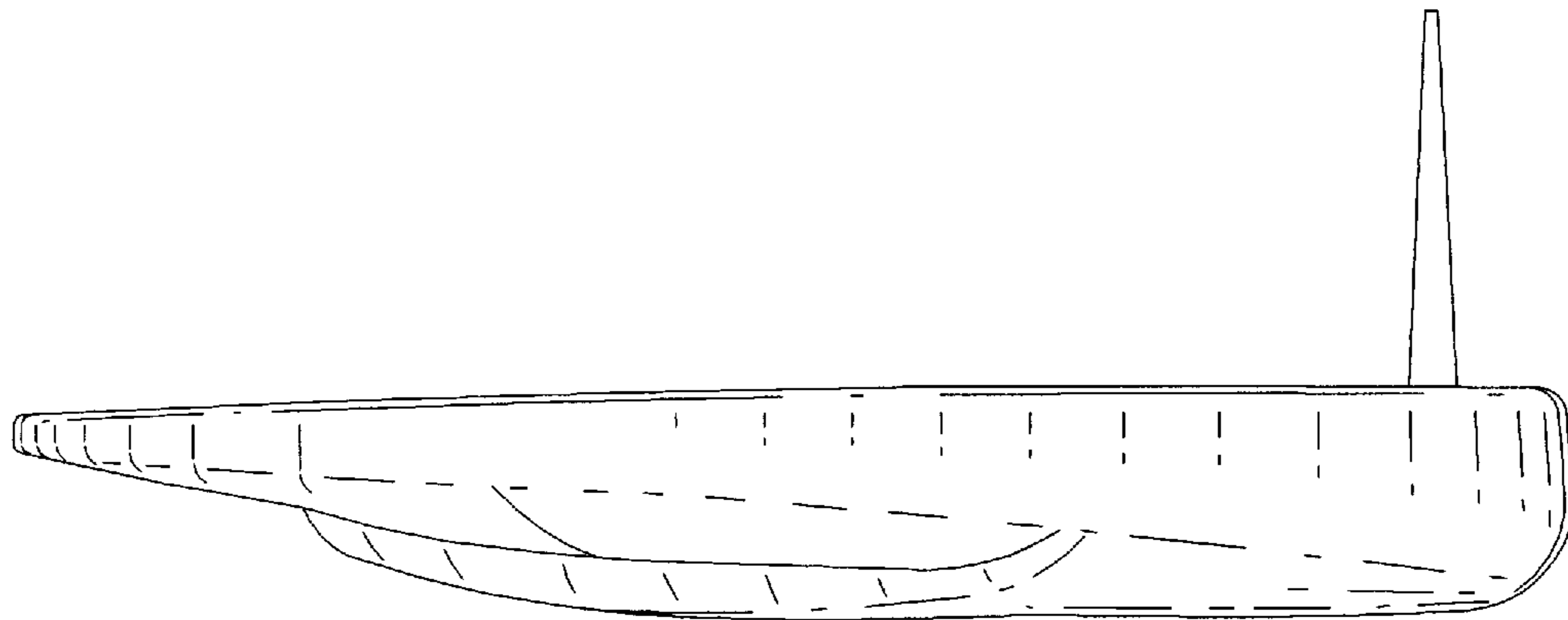

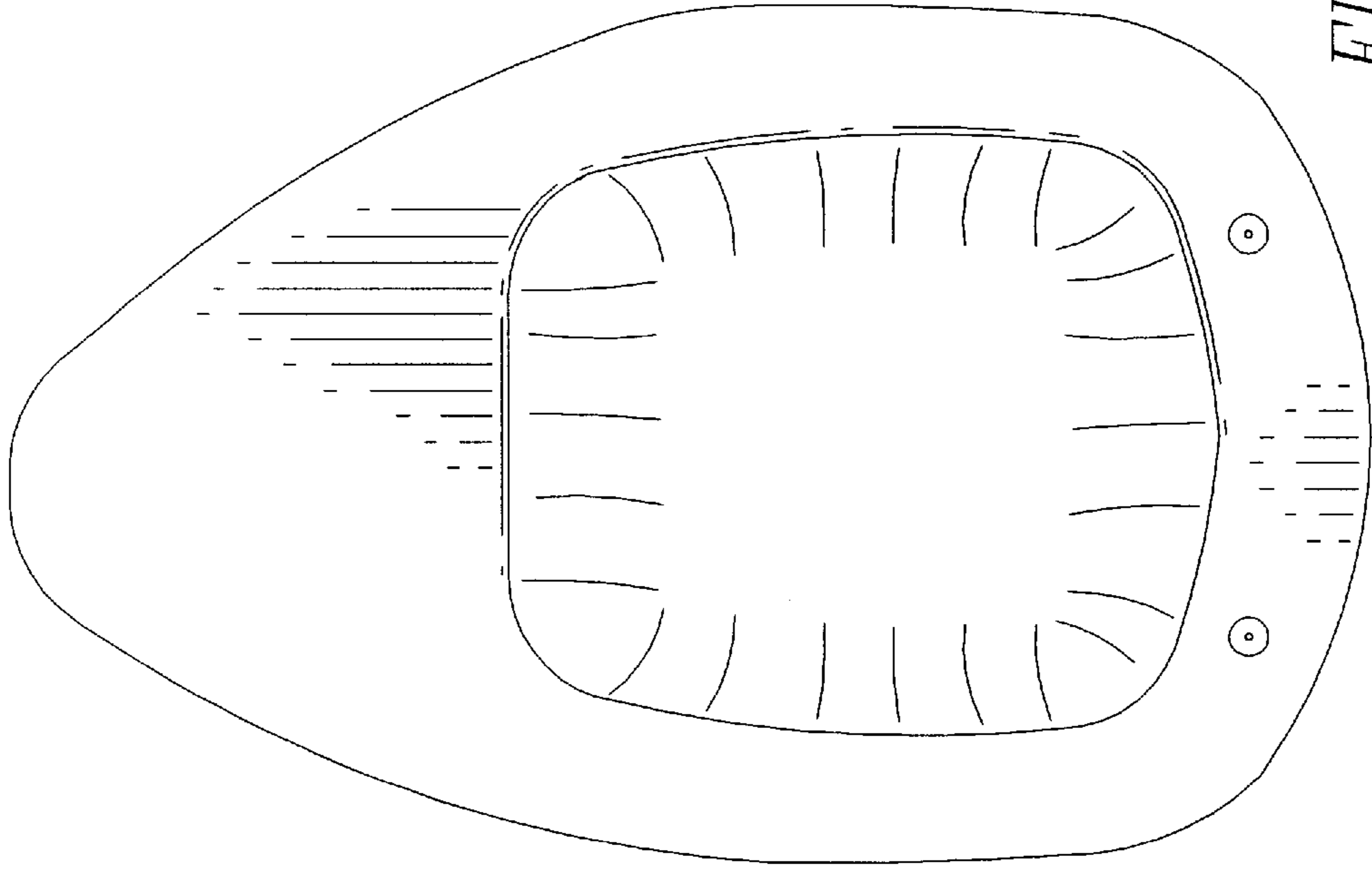

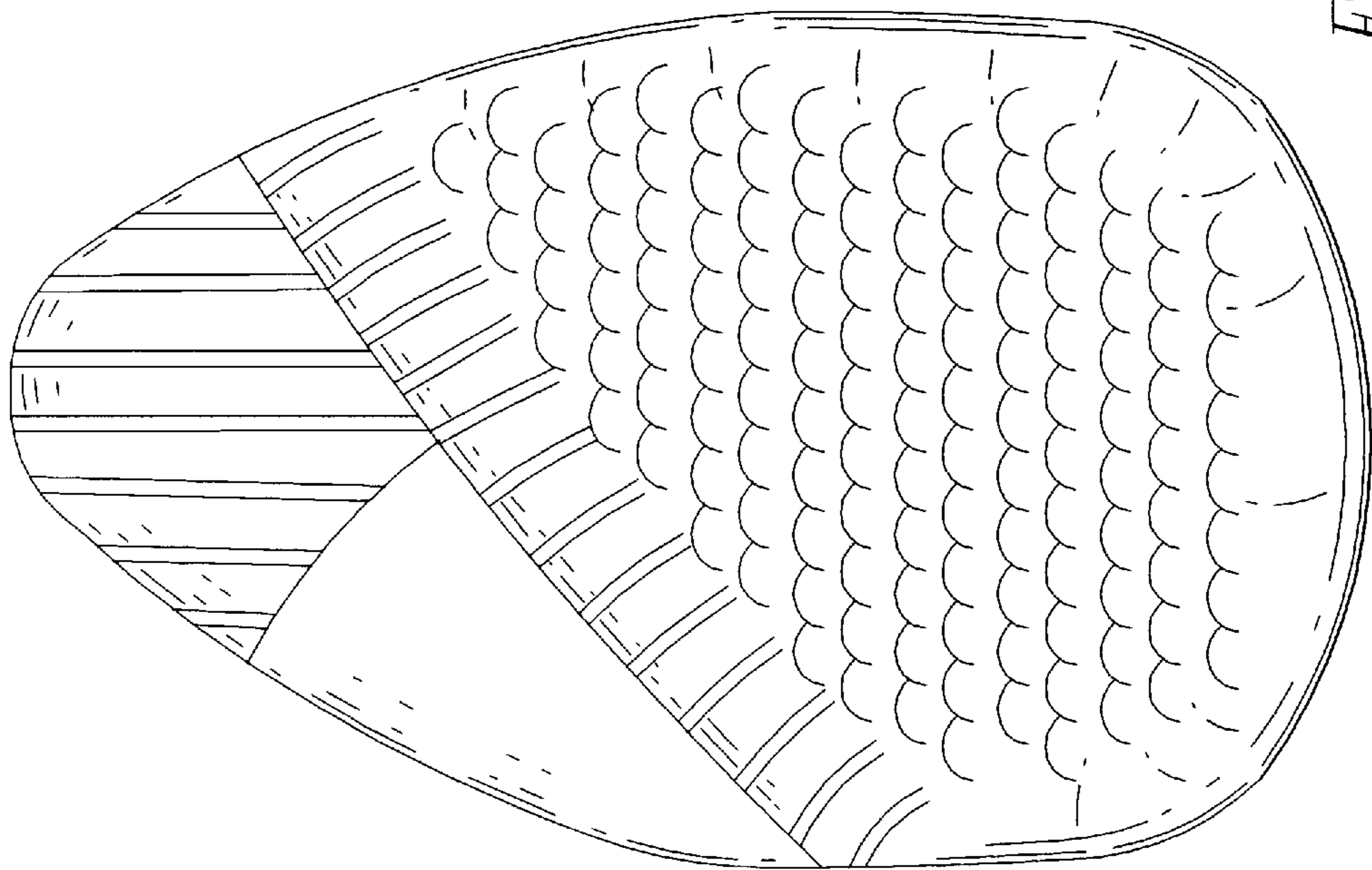

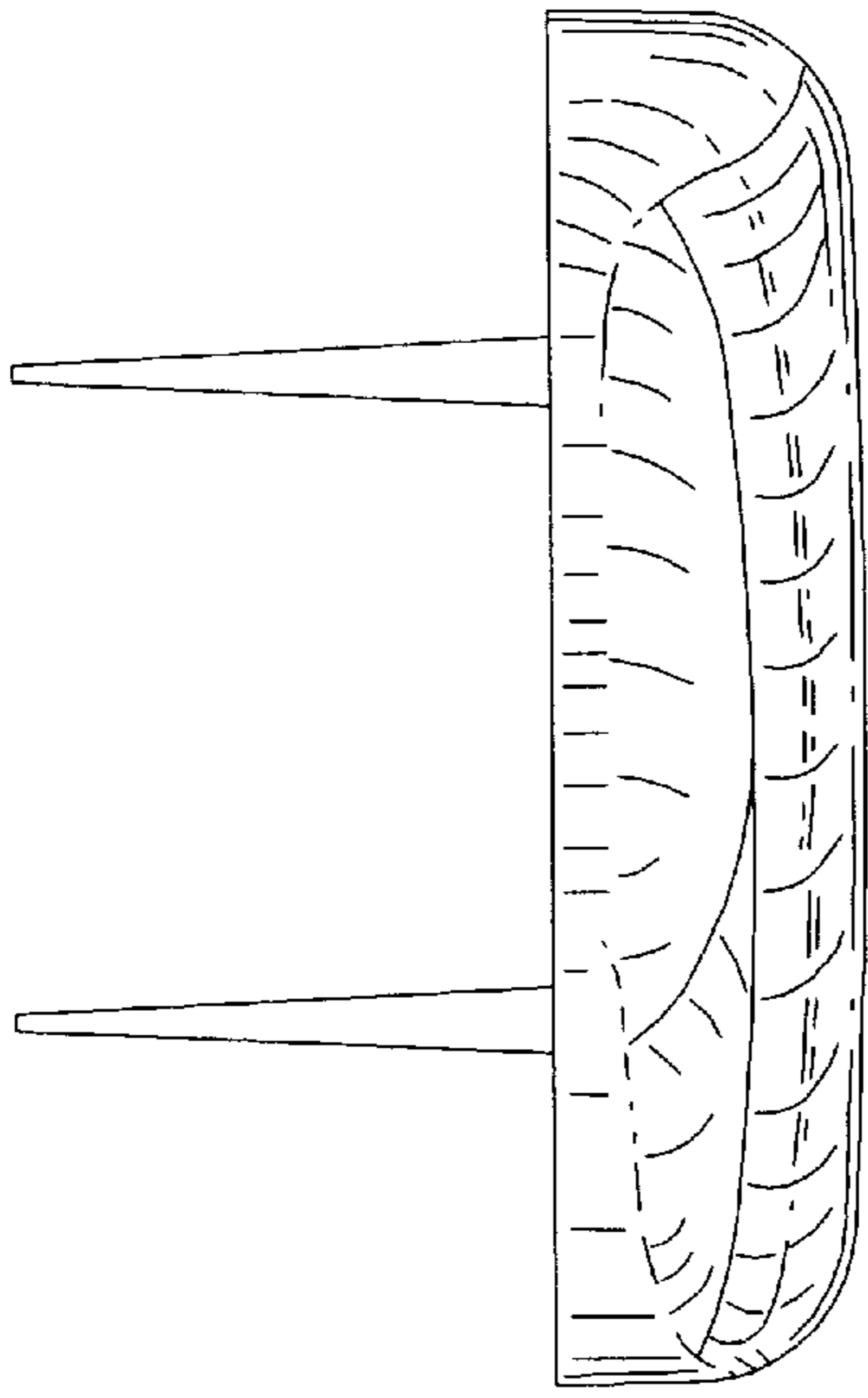

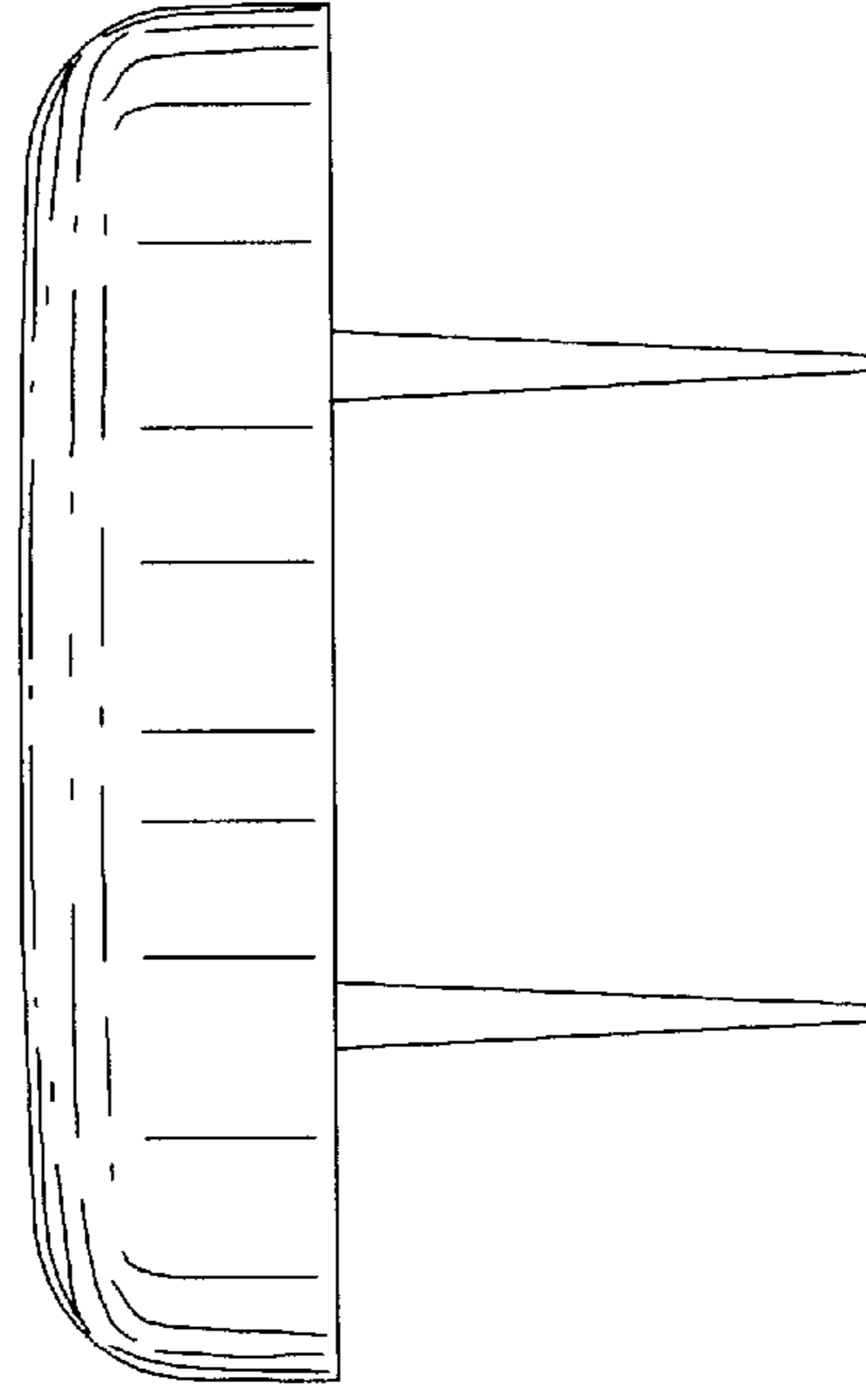

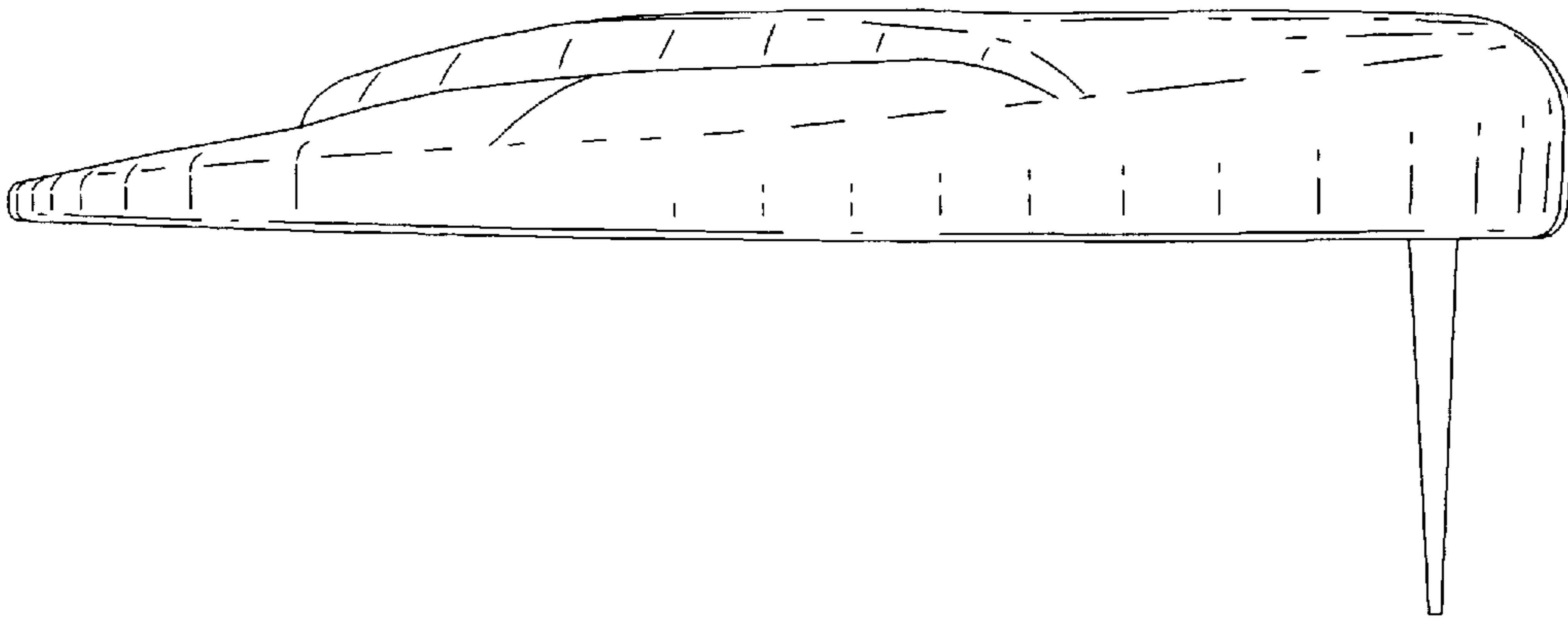

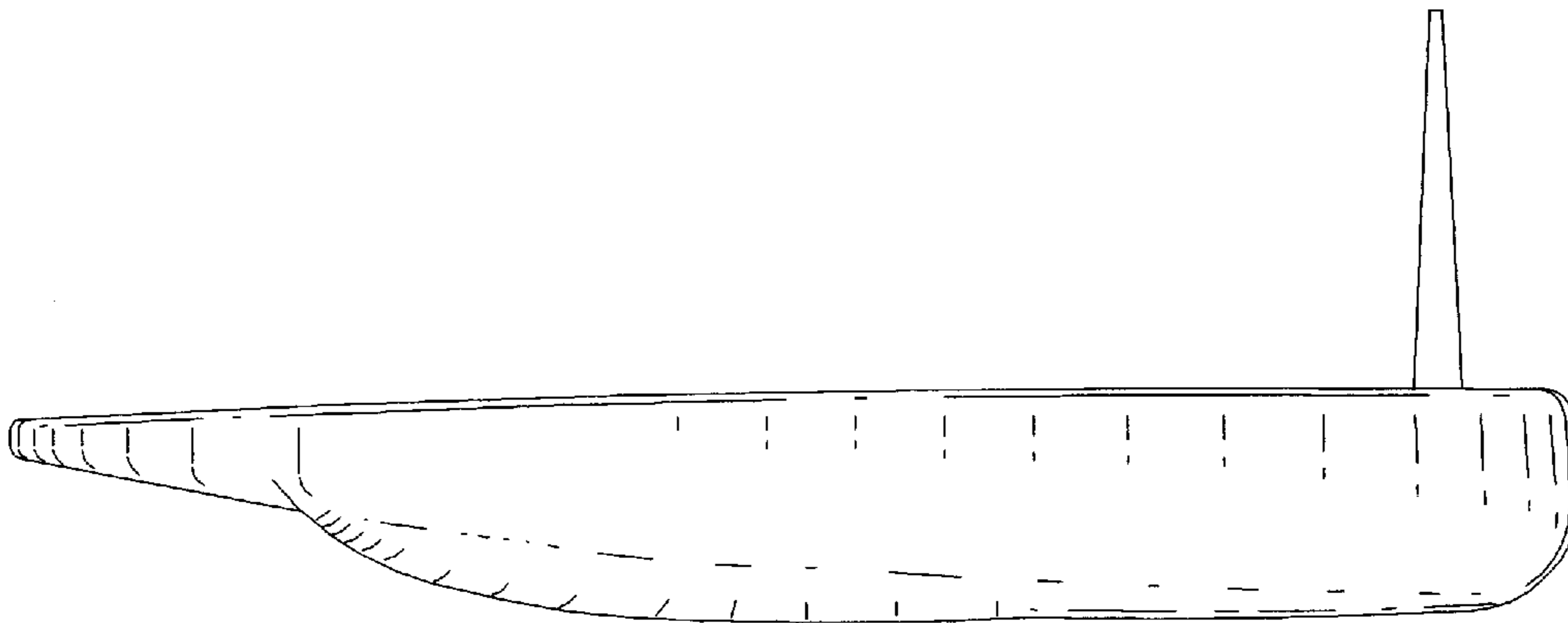

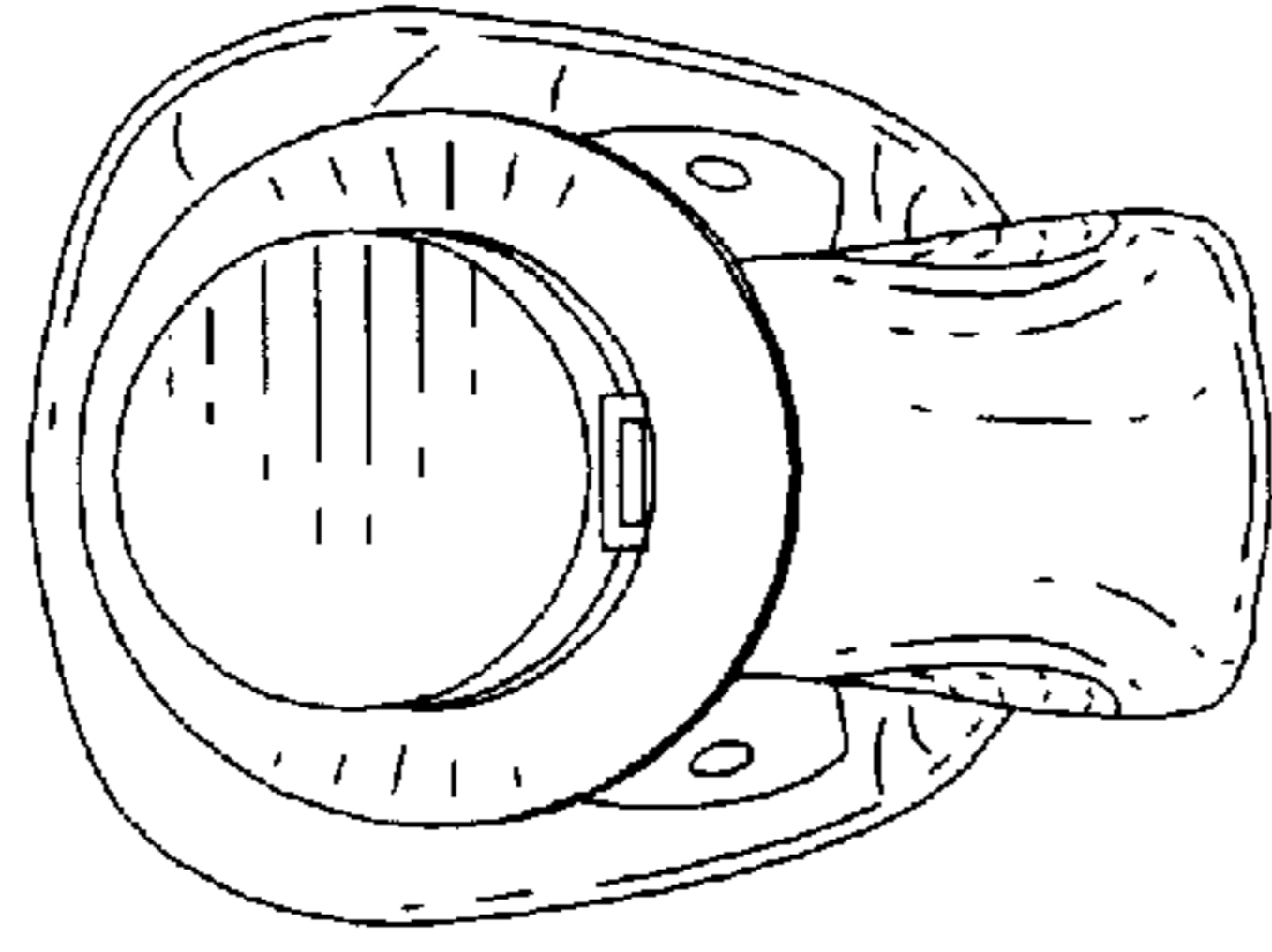

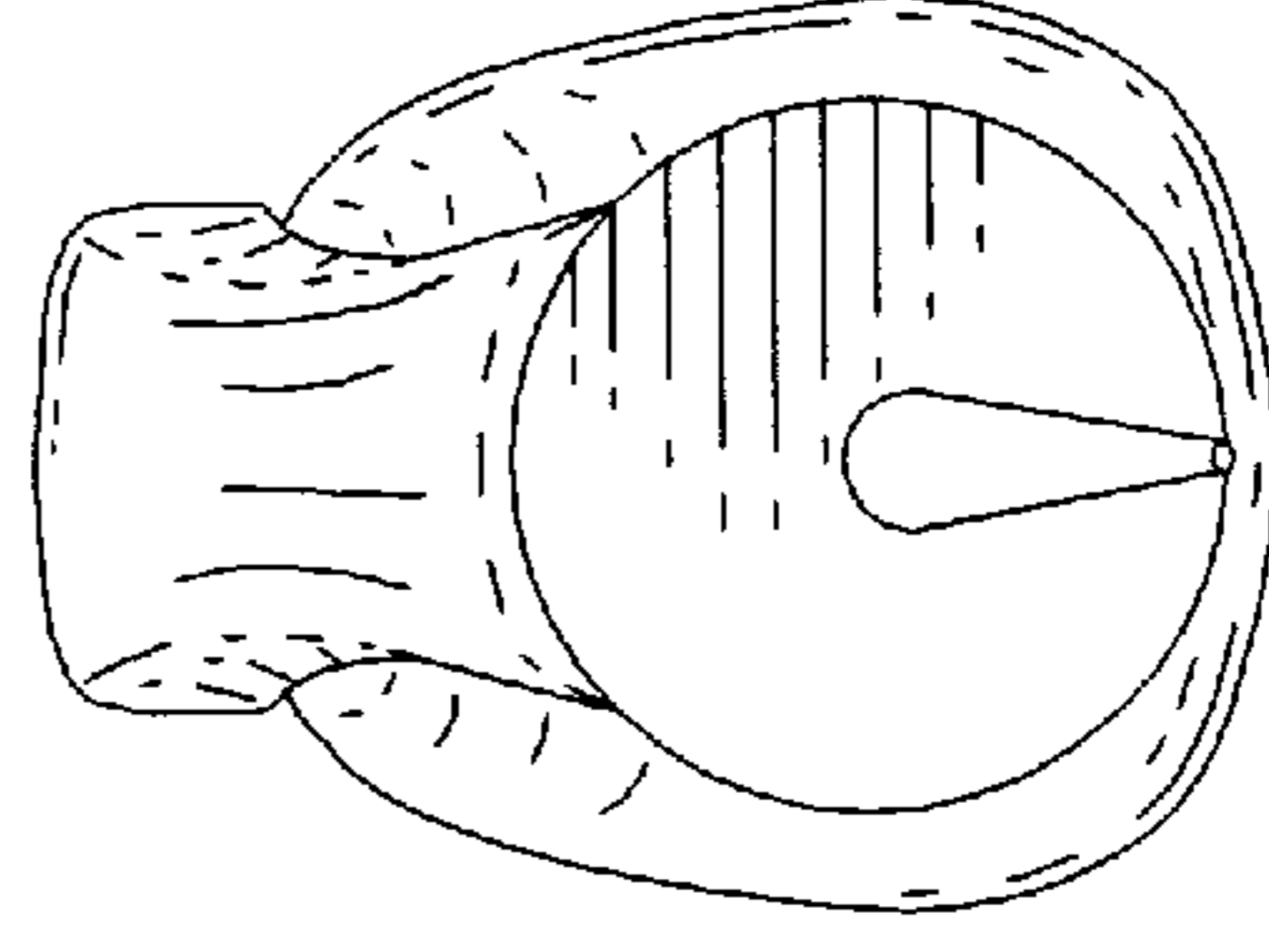

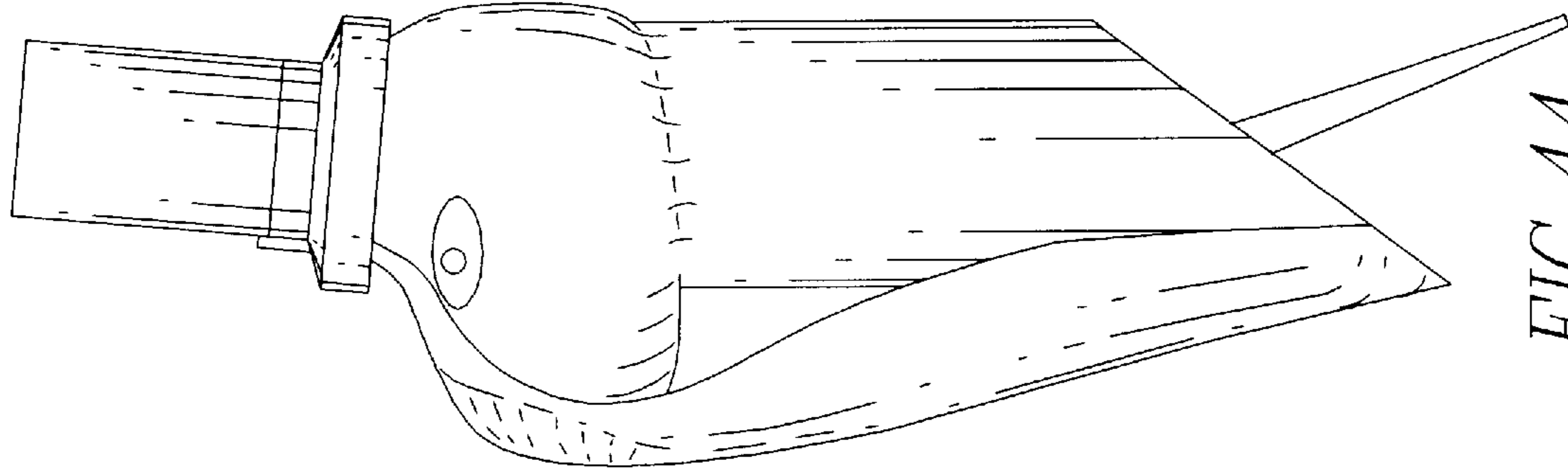

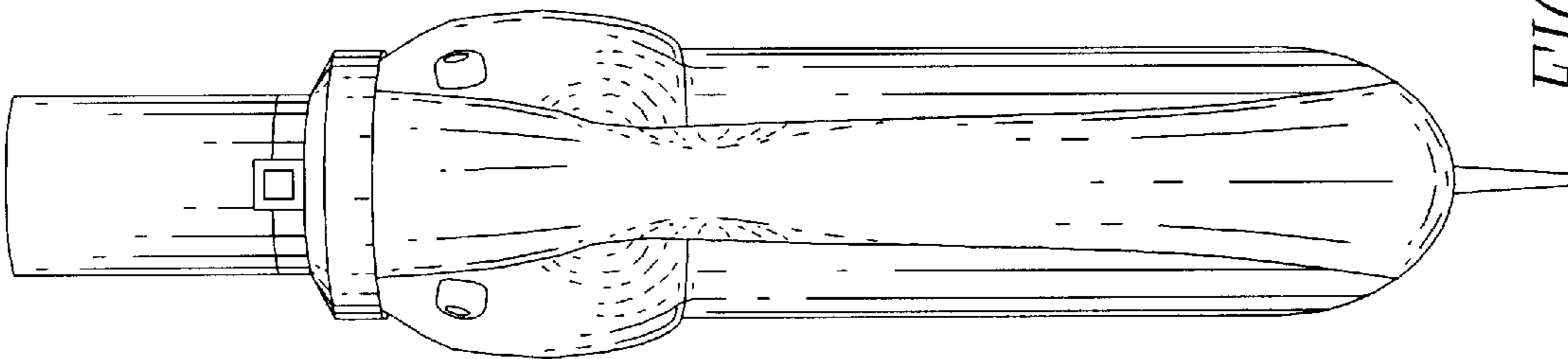

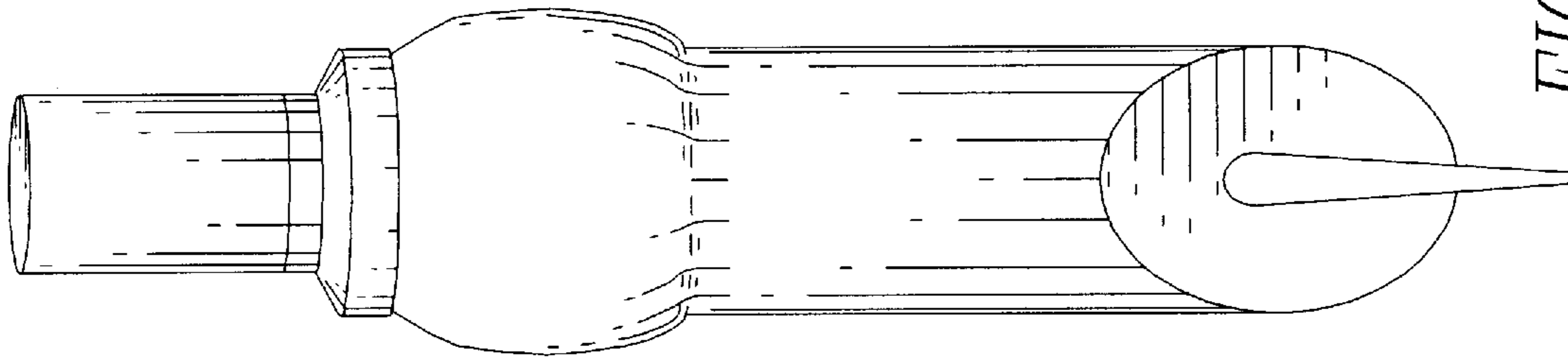
