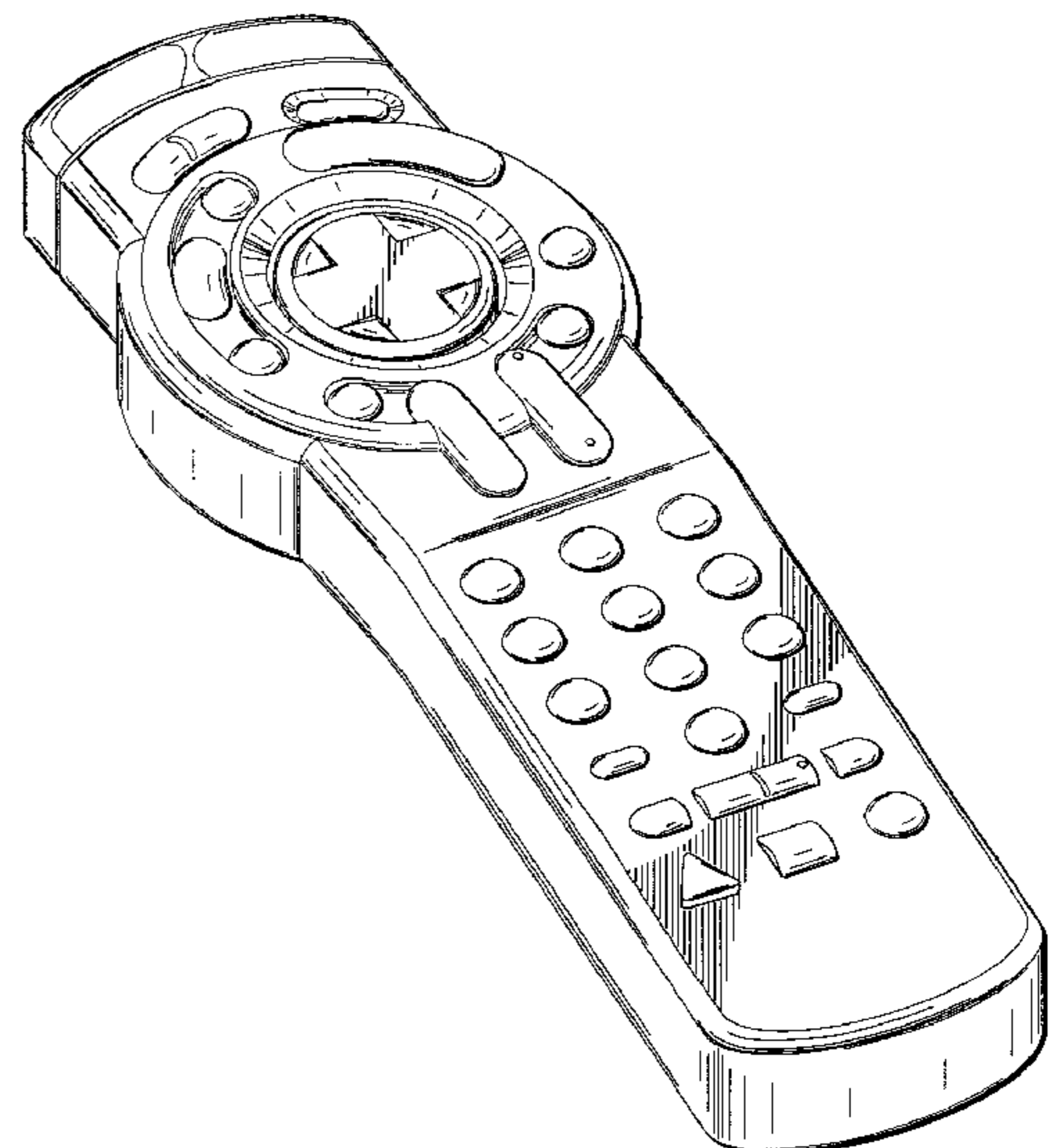
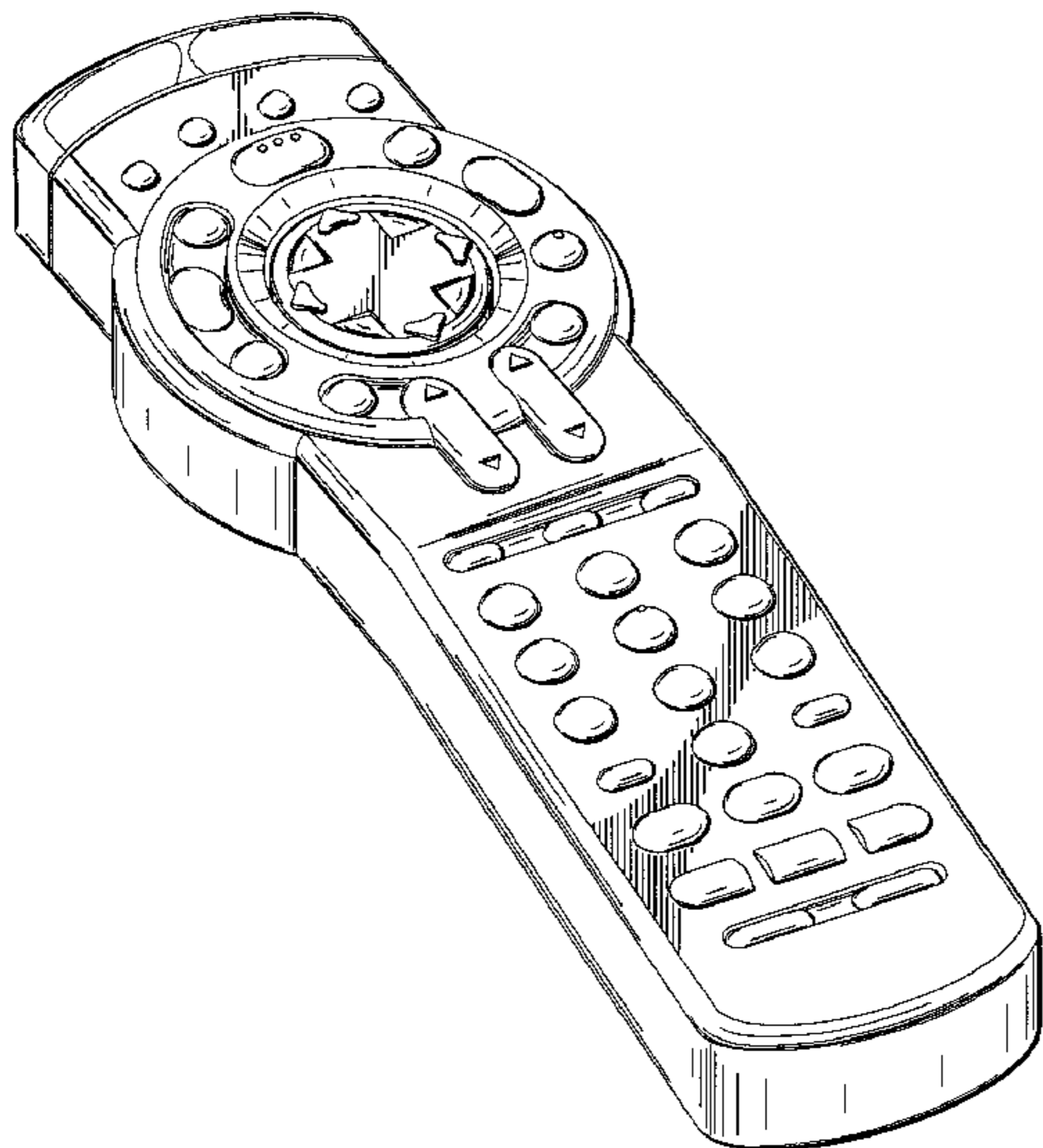
[57] **CLAIM**

The ornamental design for a pushbutton remote control, as shown.

DESCRIPTION

FIG. 1 is a top and left side perspective view of a pushbutton remote control showing our new design;
 FIG. 2 is a front perspective view thereof;
 FIG. 3 is a left side elevational view thereof;
 FIG. 4 is a right side elevational view thereof;
 FIG. 5 is a rear elevational view thereof;
 FIG. 6 is a top plan view thereof;
 FIG. 7 is a bottom plan view thereof;
 FIG. 8 is a top and left side perspective view of a second embodiment thereof;
 FIG. 9 is a front perspective view of FIG. 8;
 FIG. 10 is a left side elevational view of FIG. 8;
 FIG. 11 is a right side elevational view of FIG. 8;
 FIG. 12 is a rear elevational view of FIG. 8; and,
 FIG. 13 is a top plan view of FIG. 8.
 The bottom view of the second embodiment is shown in FIG. 7.

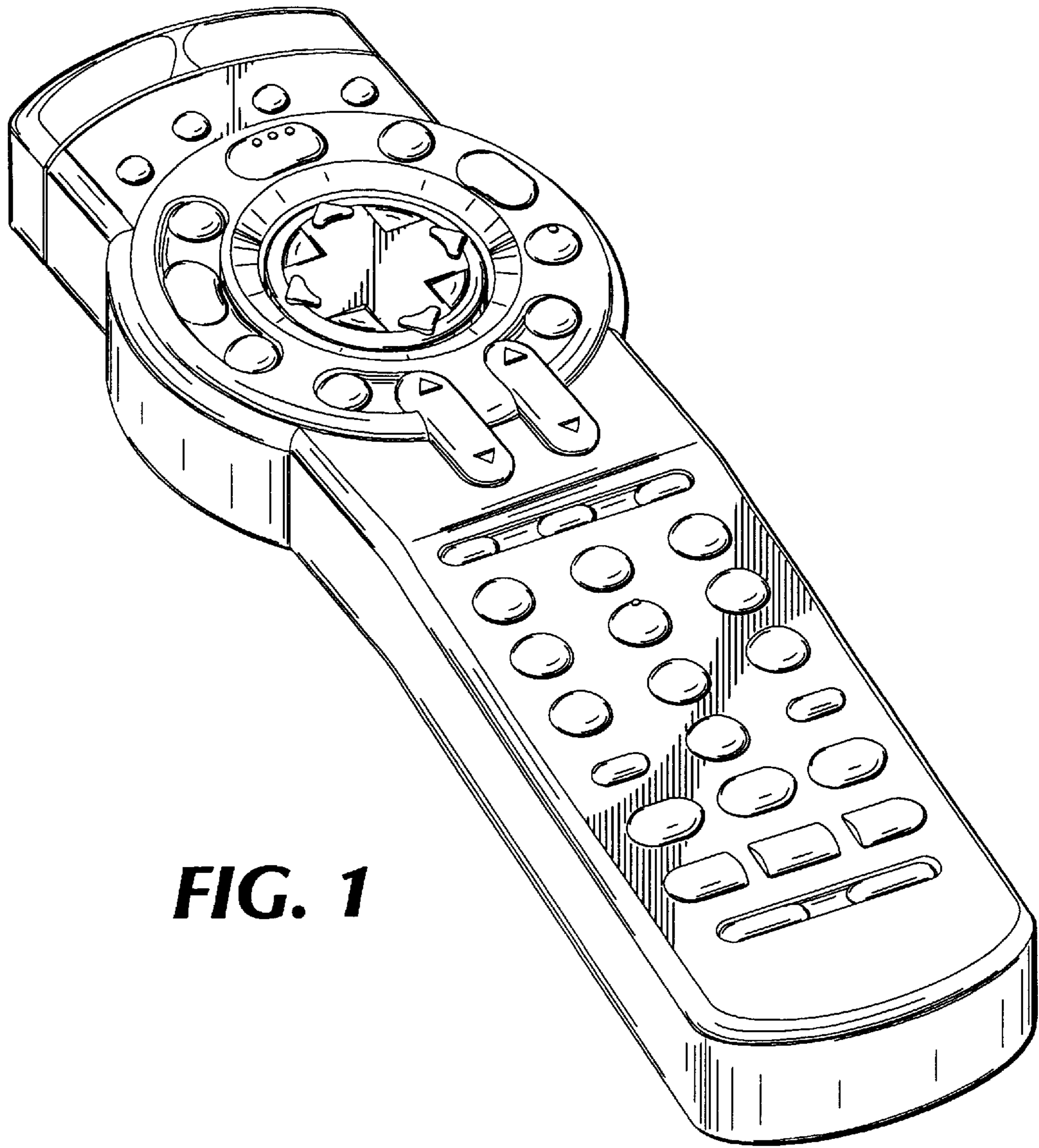

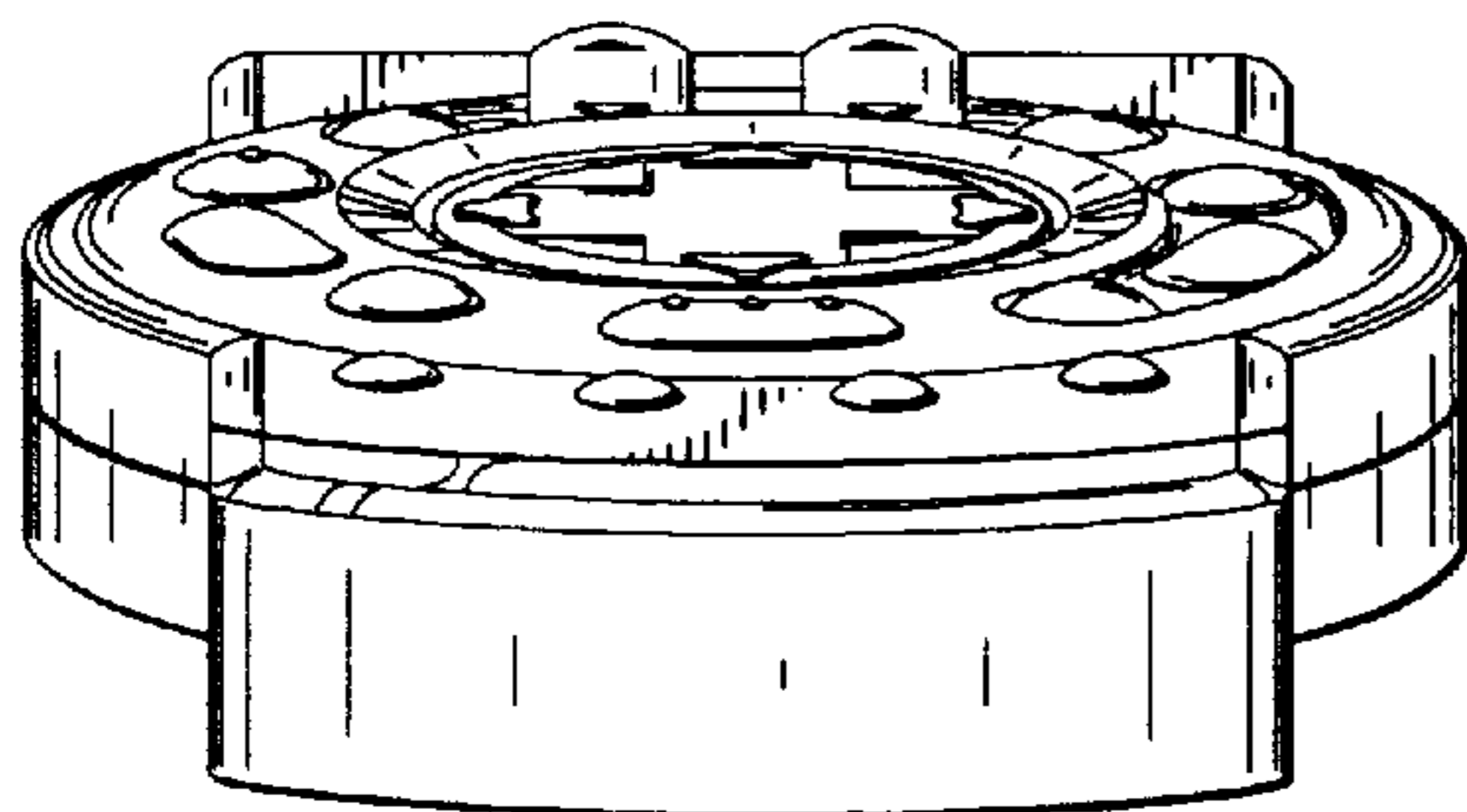

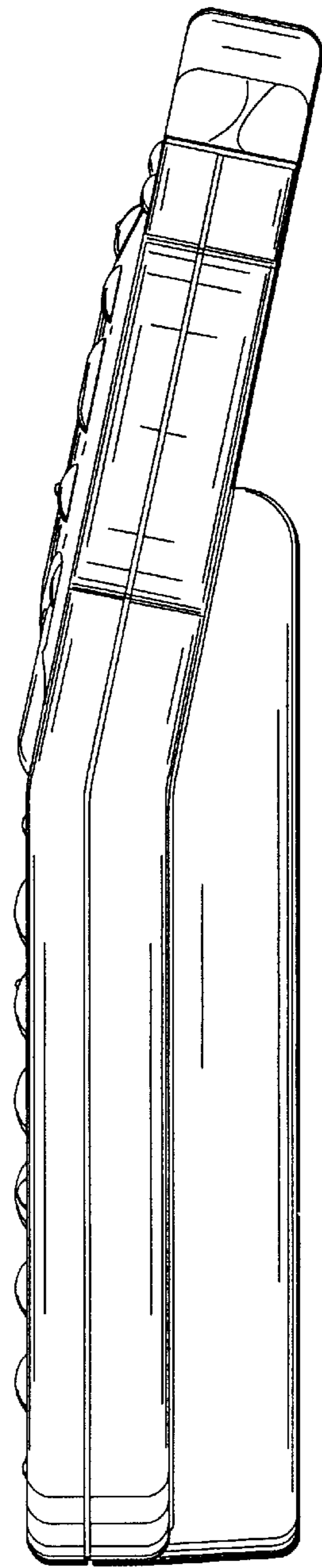

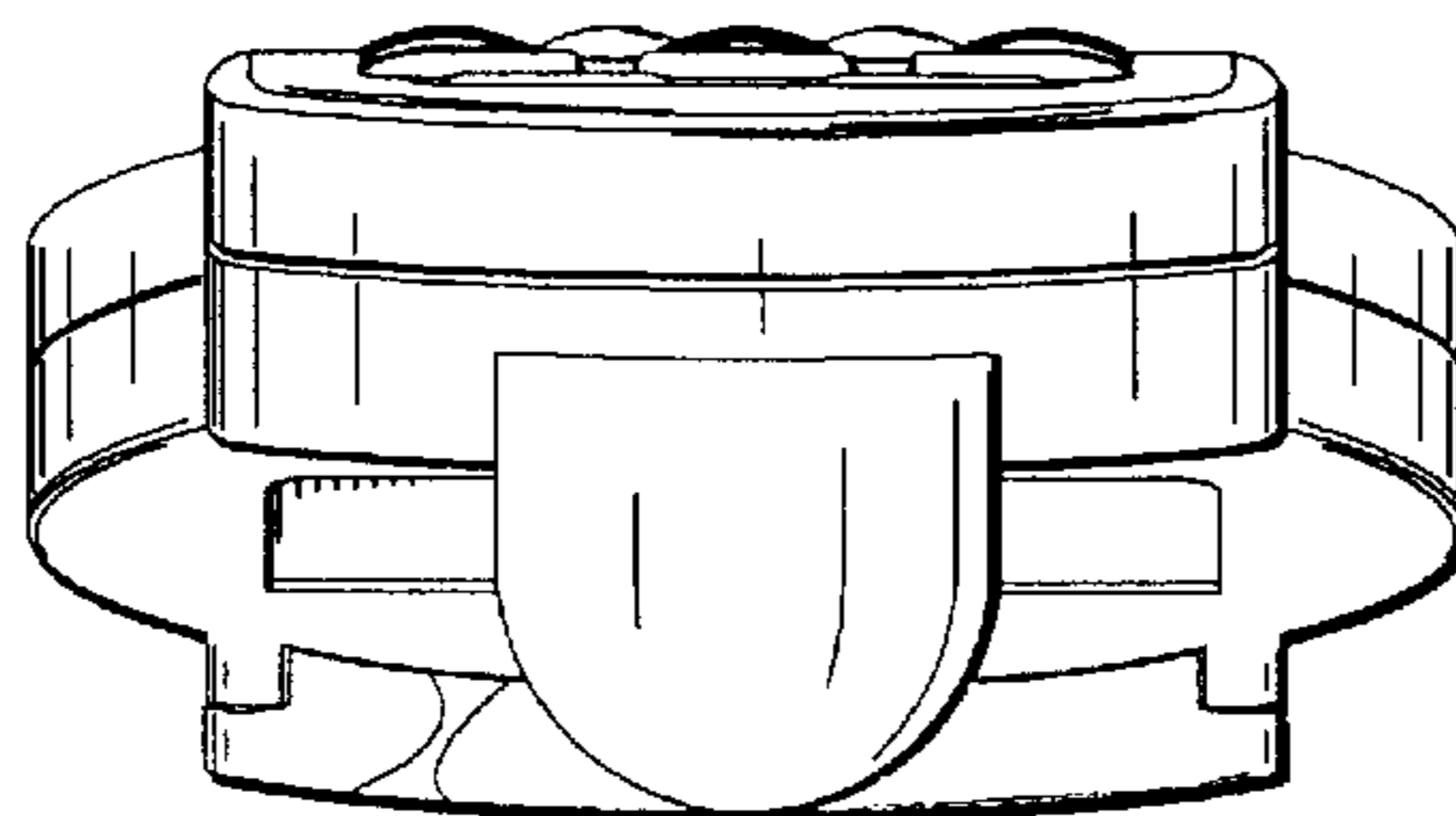

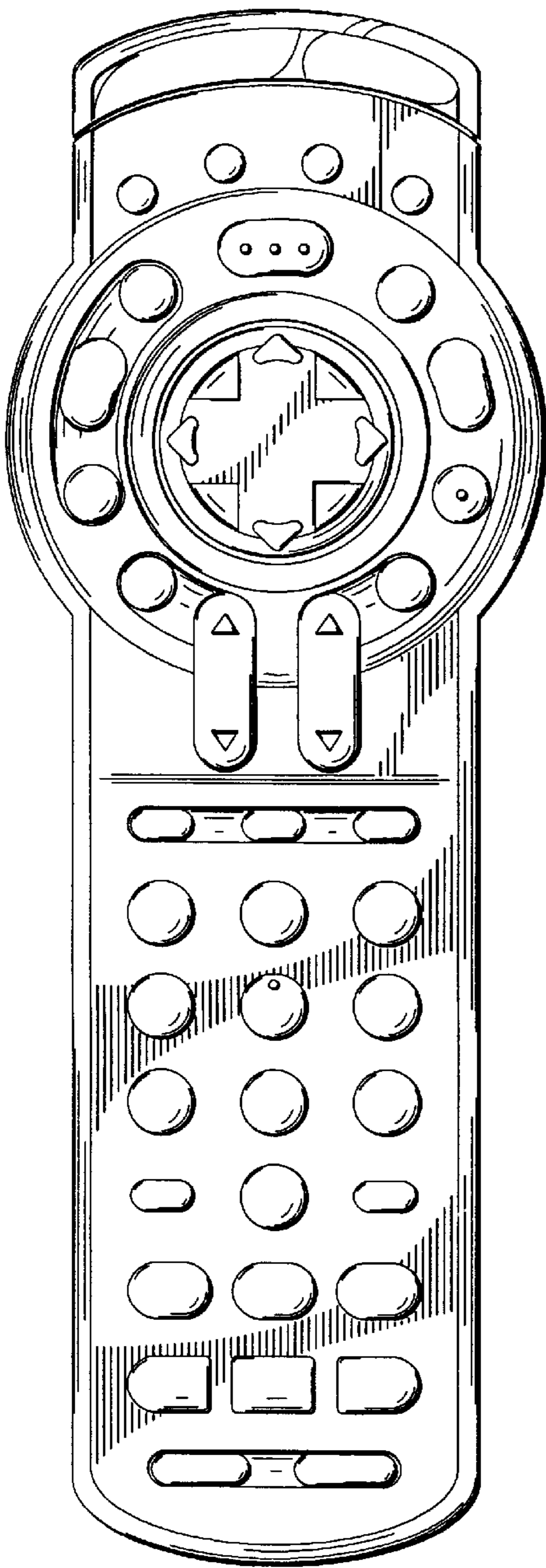

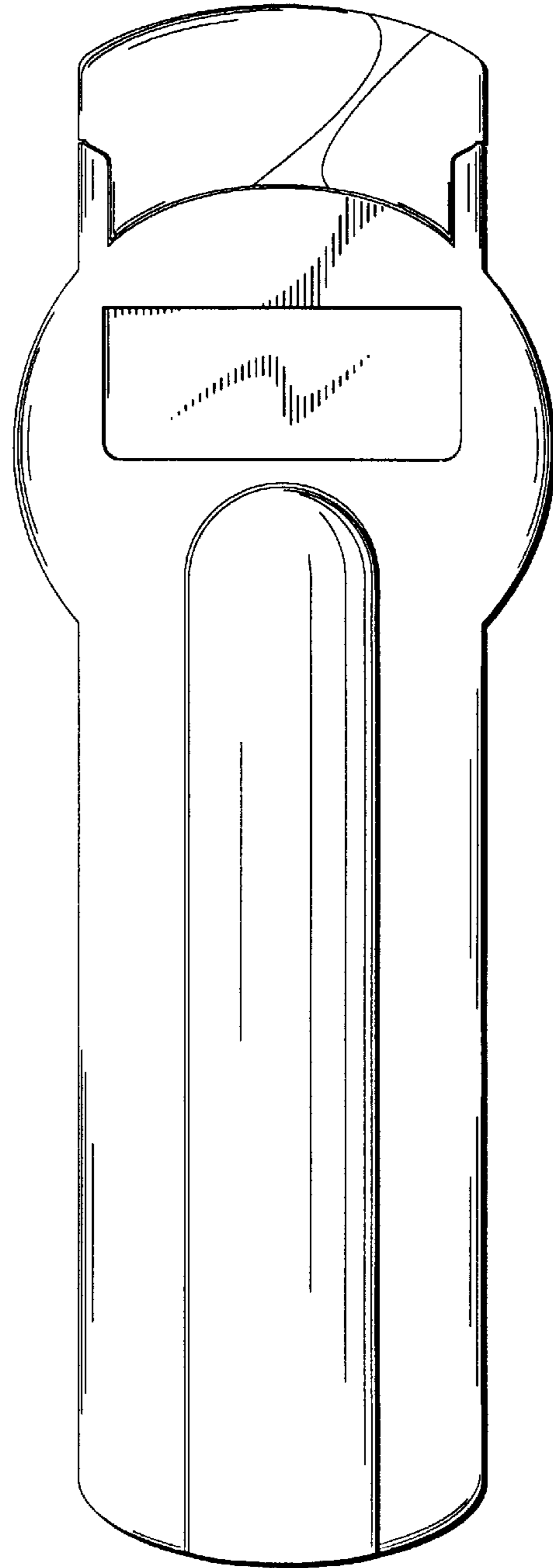

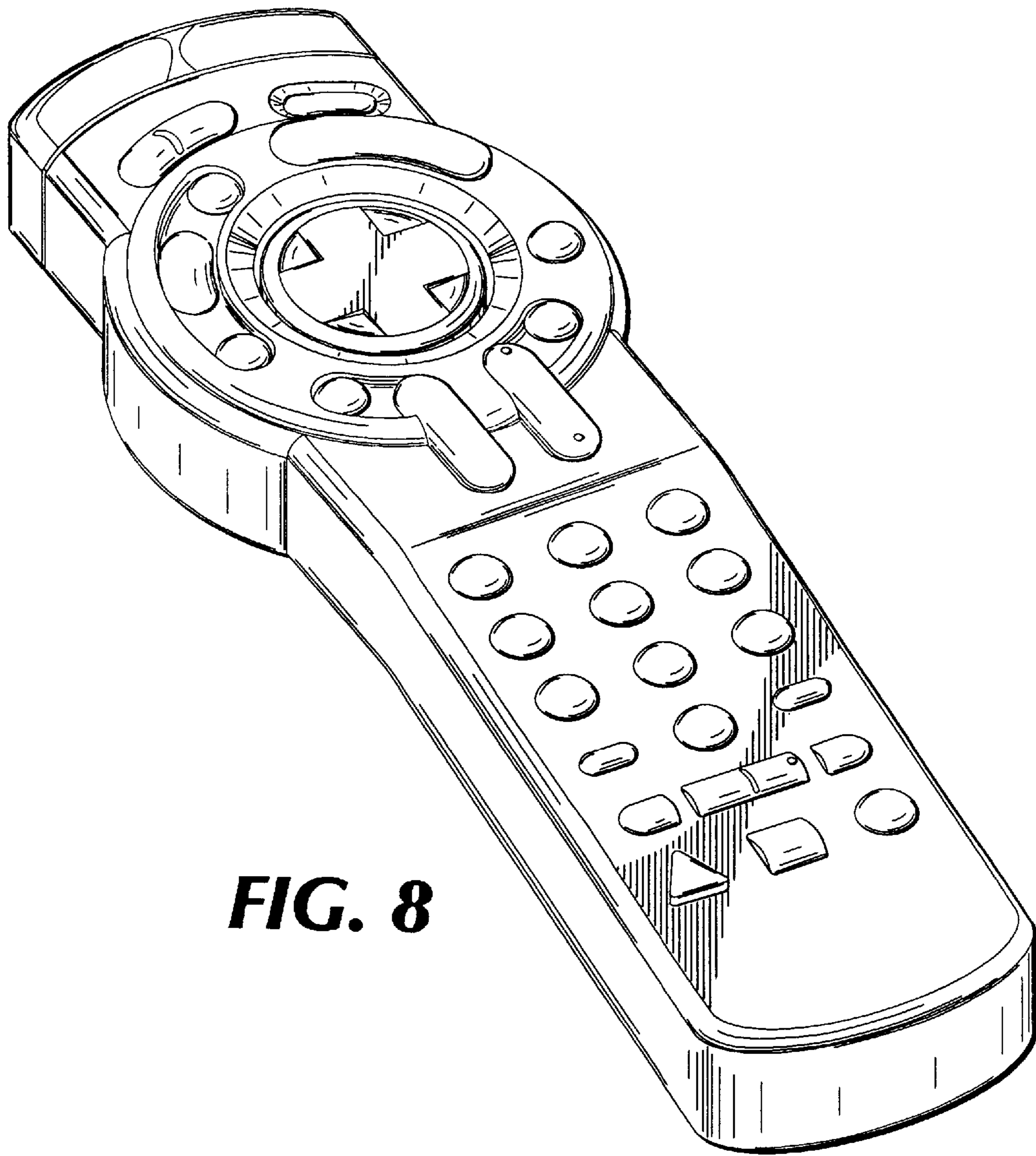

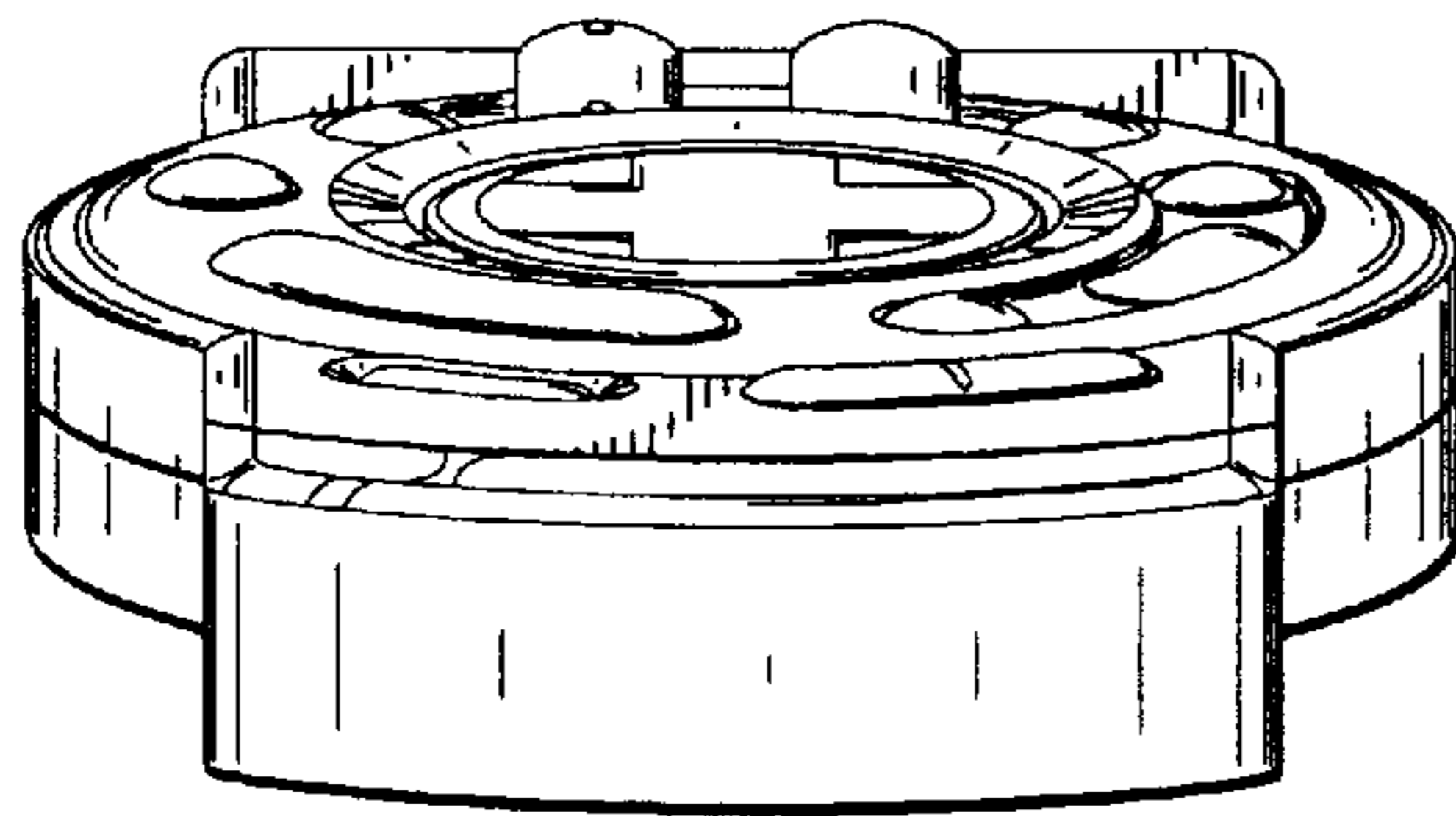

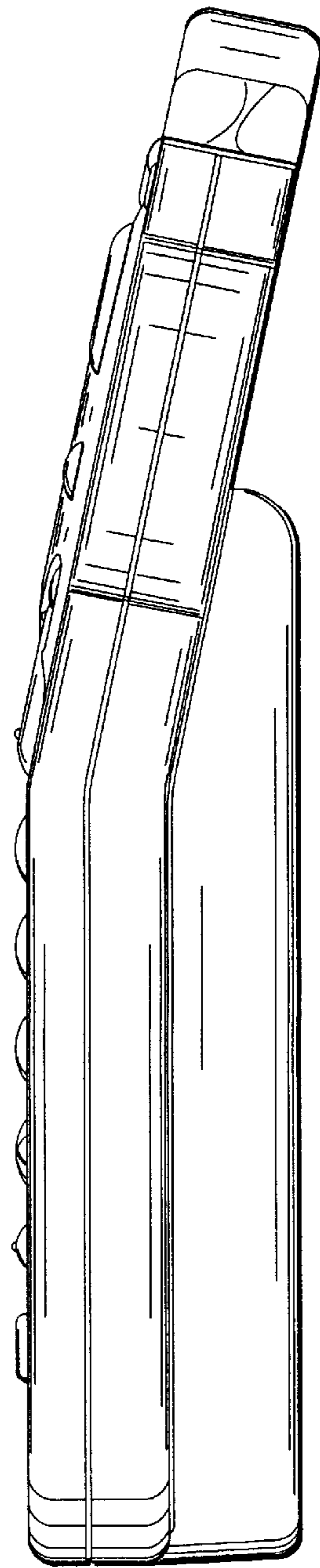

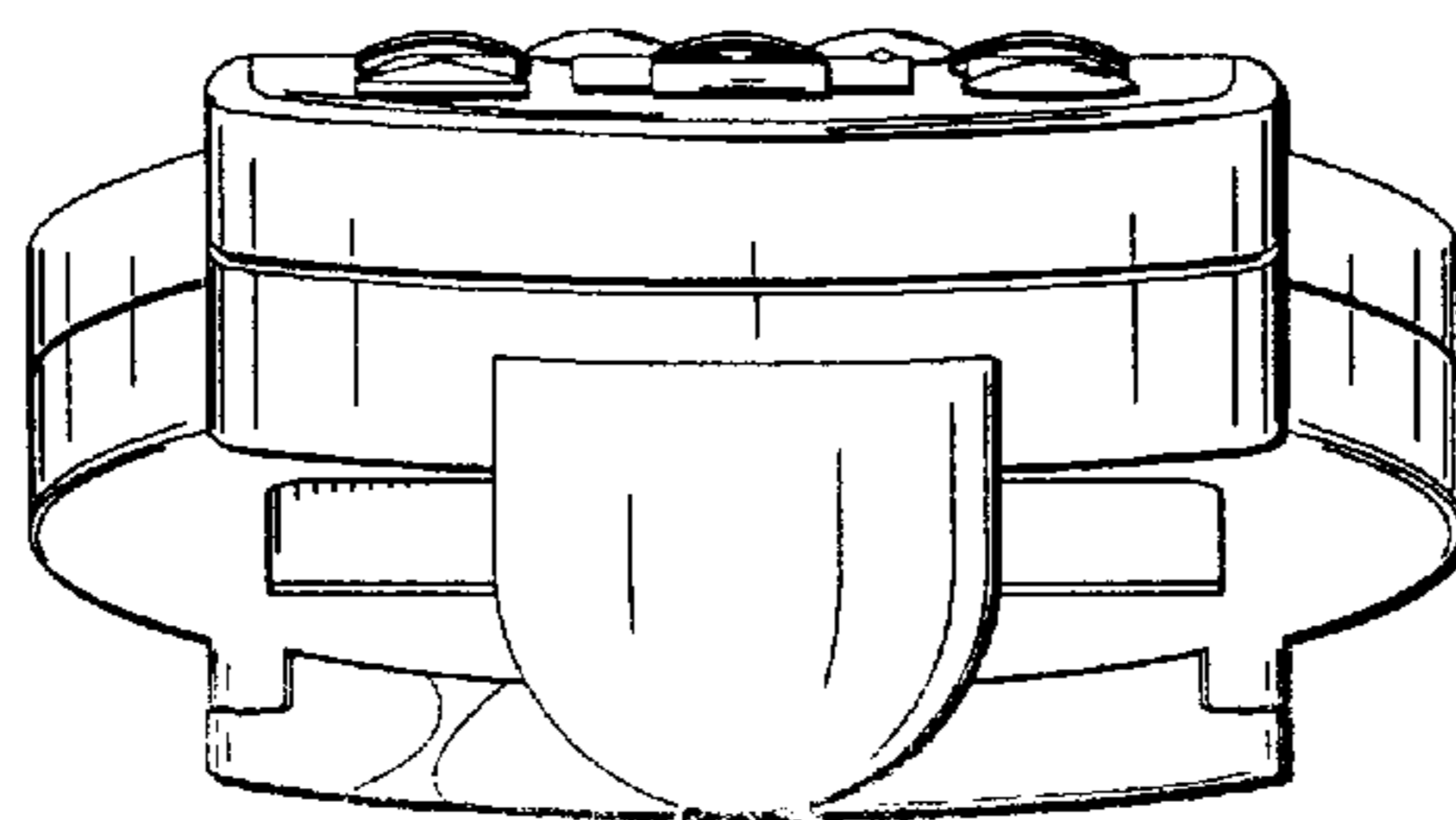

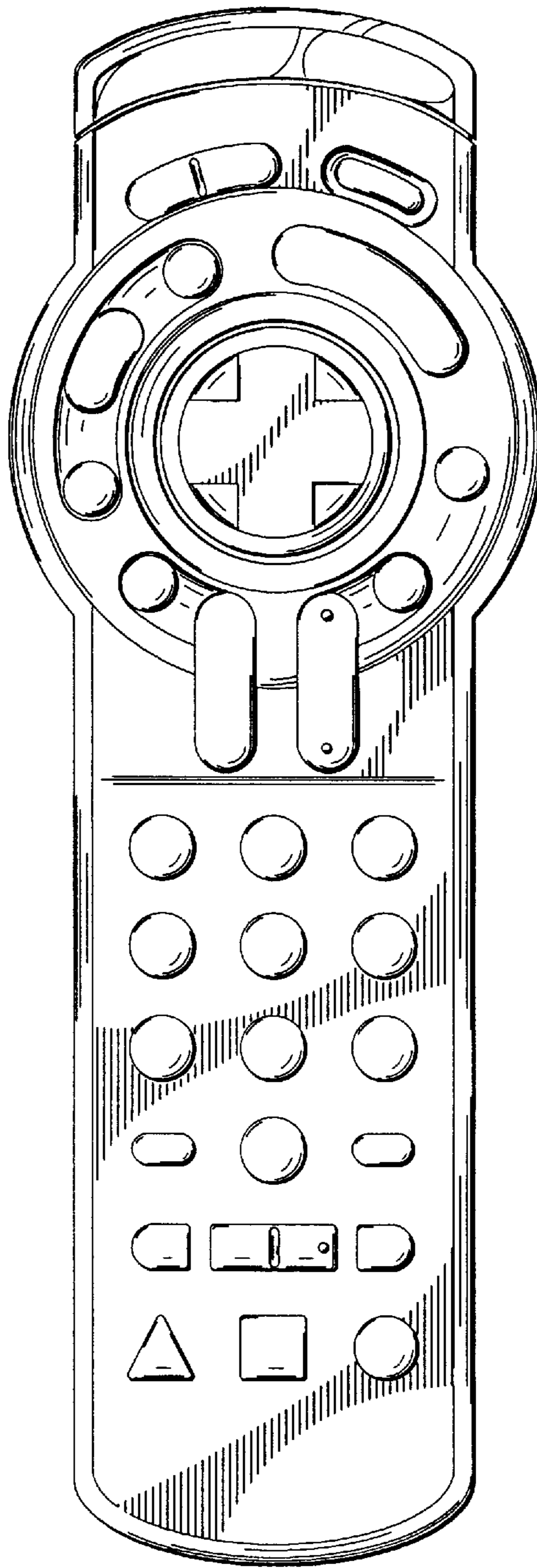
