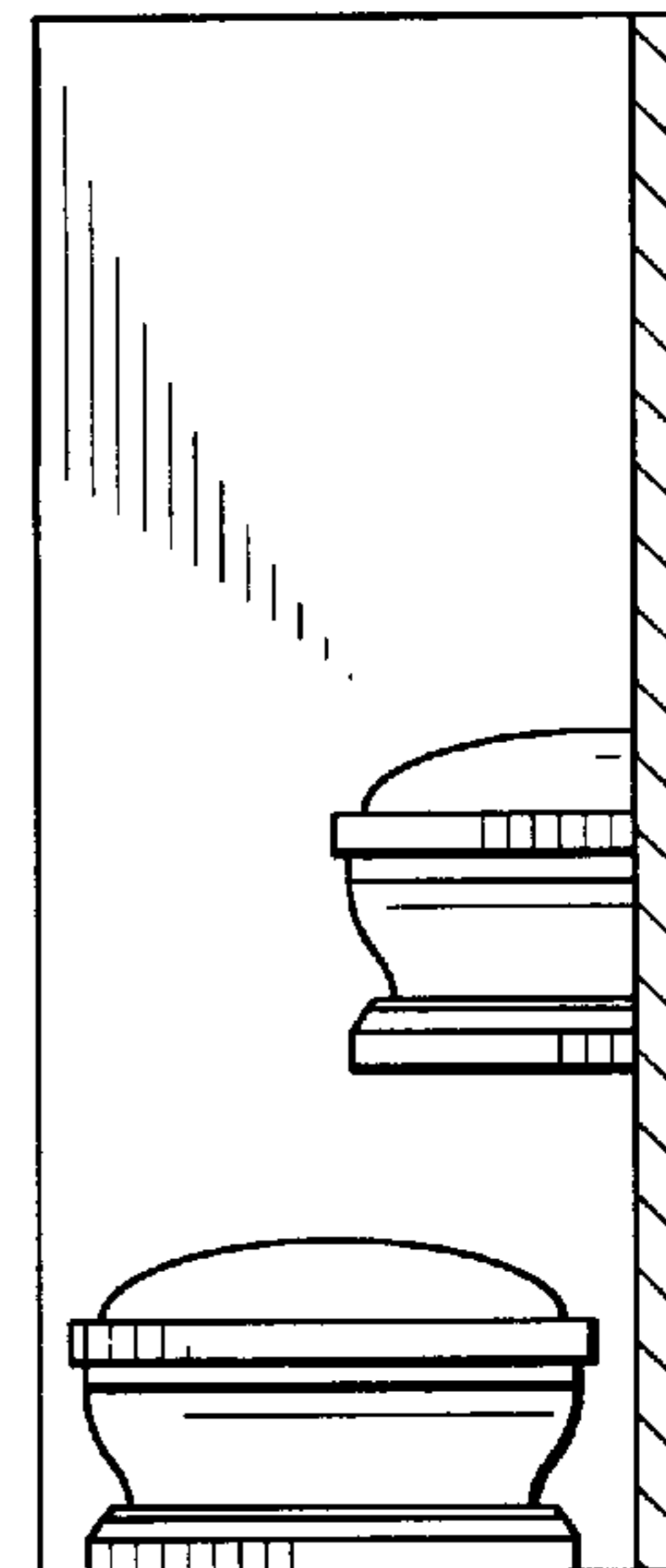
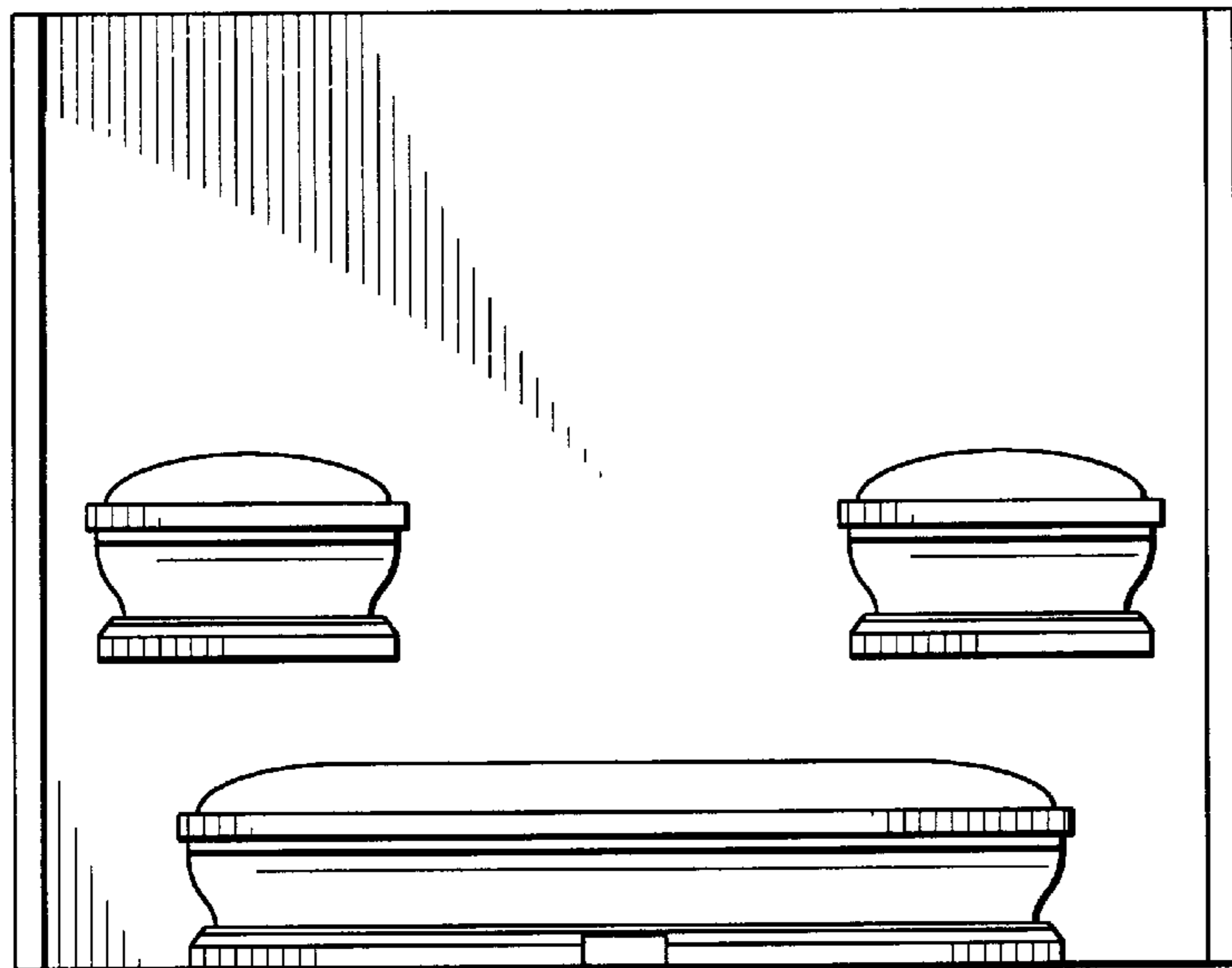
The ornamental design for a casket display, as shown and described.

**DESCRIPTION**

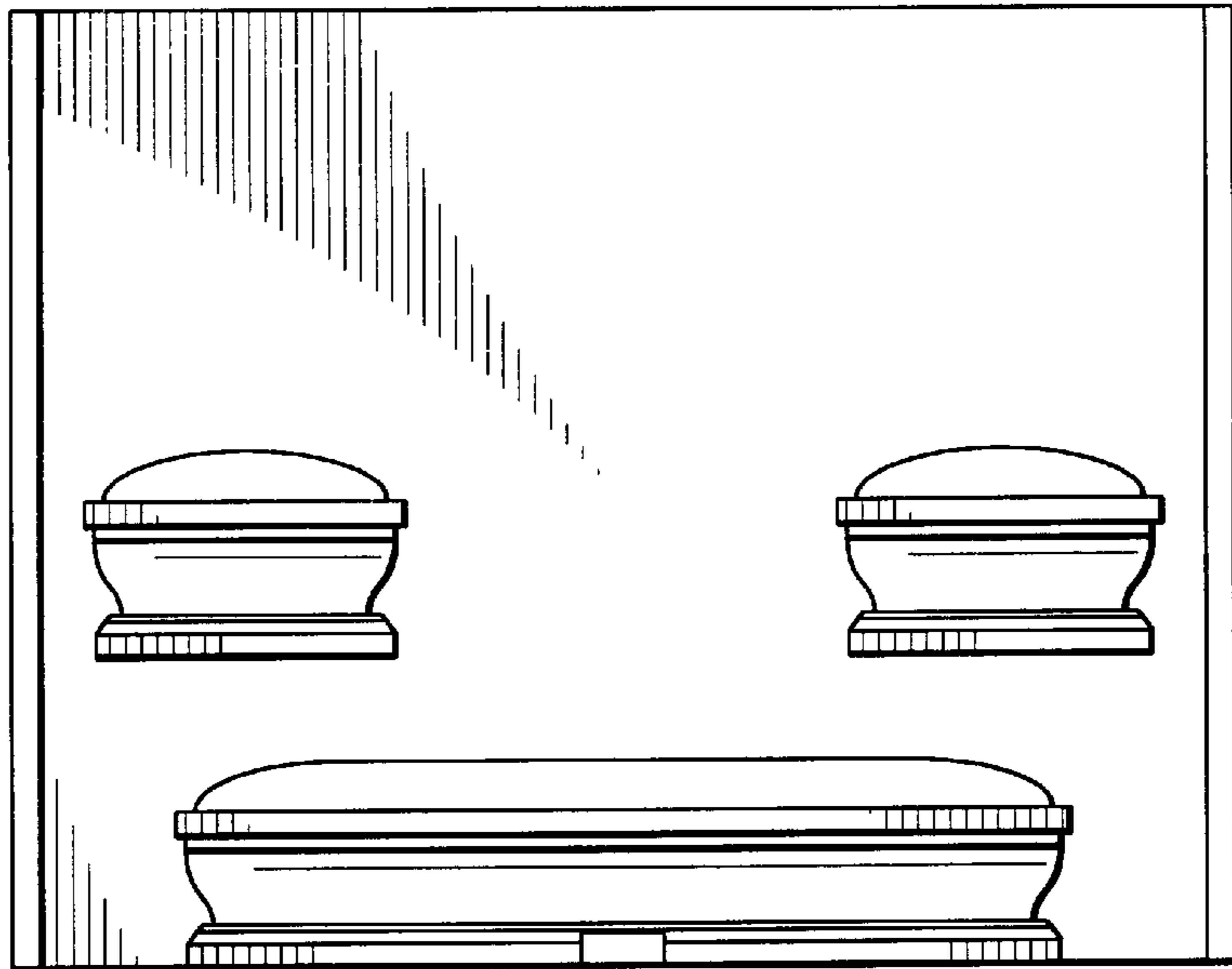
FIG. 1 is a front view of a casket display;

For convenience of illustration, the walls have been omitted in the side views of the disclosure.

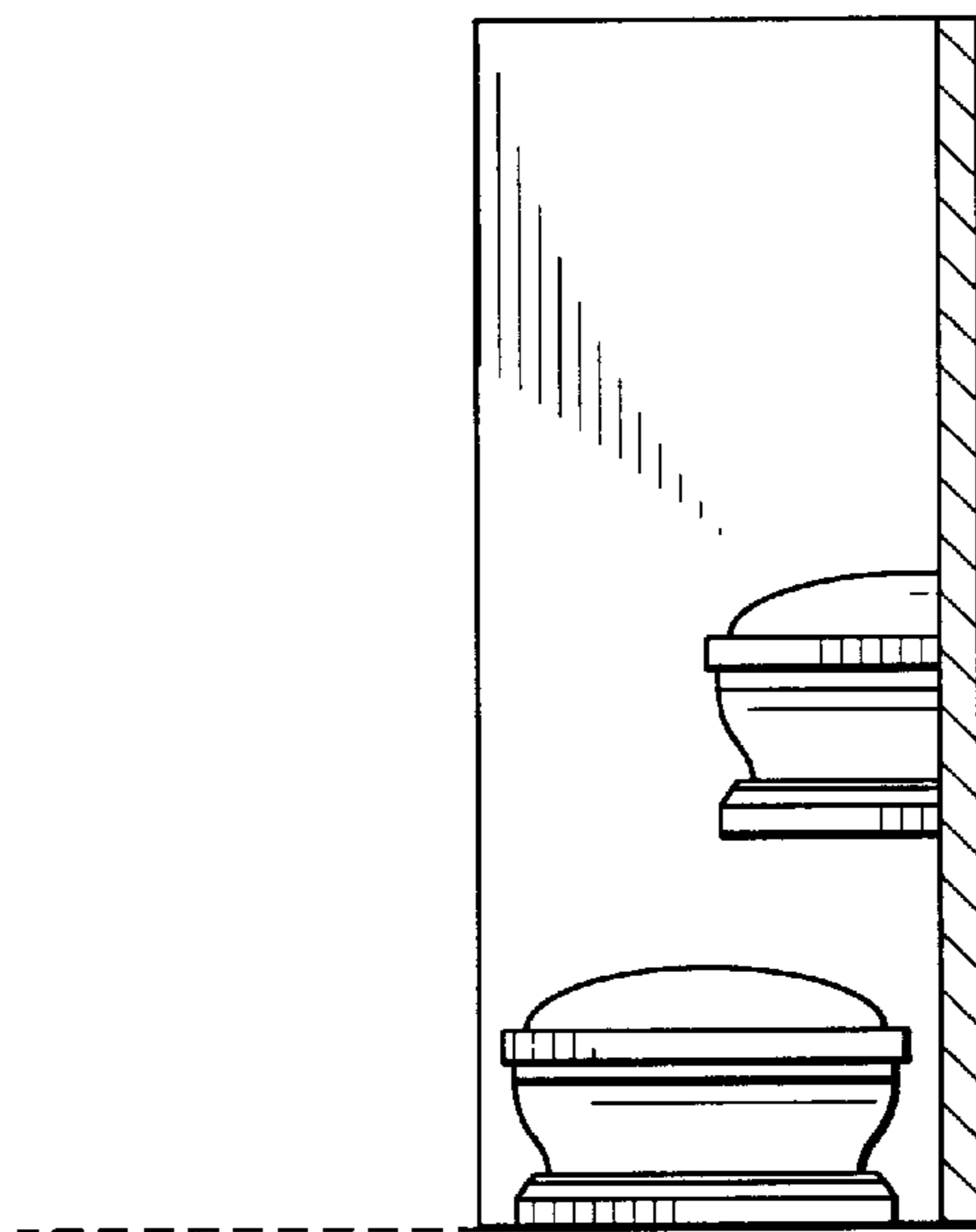

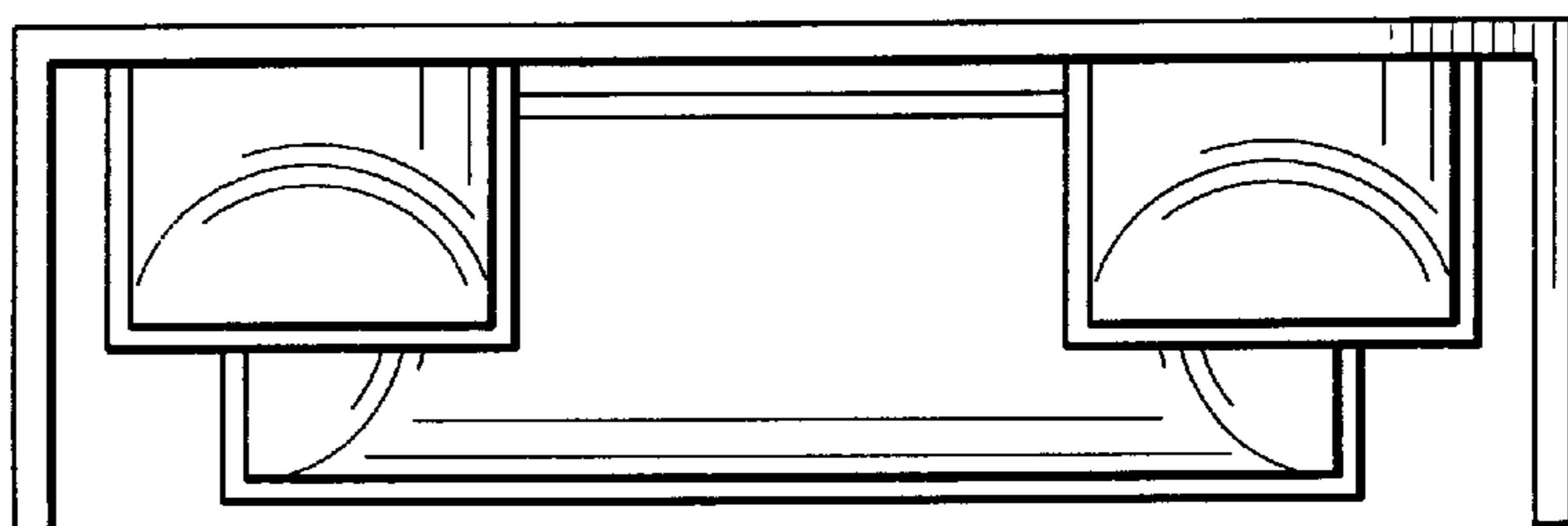

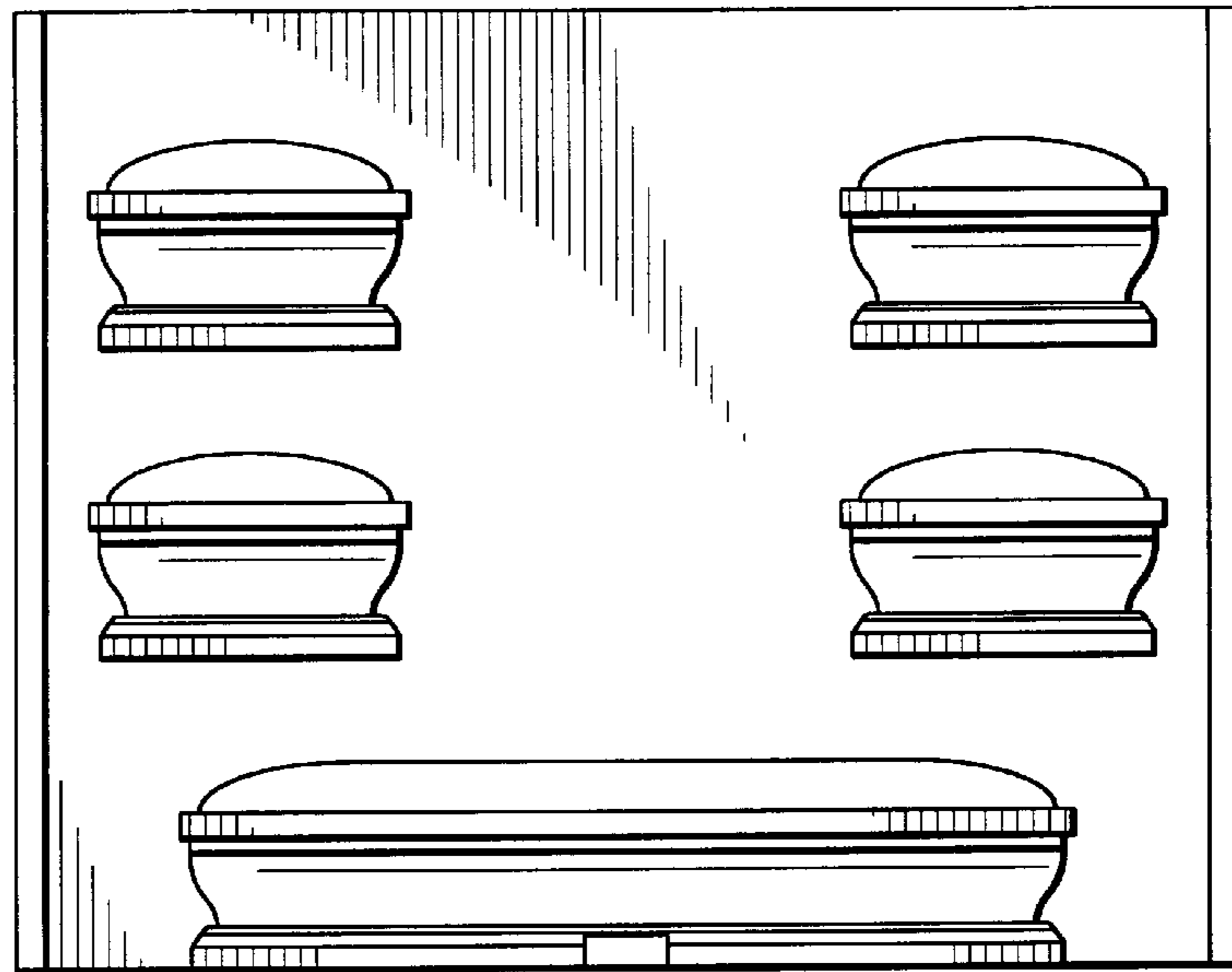

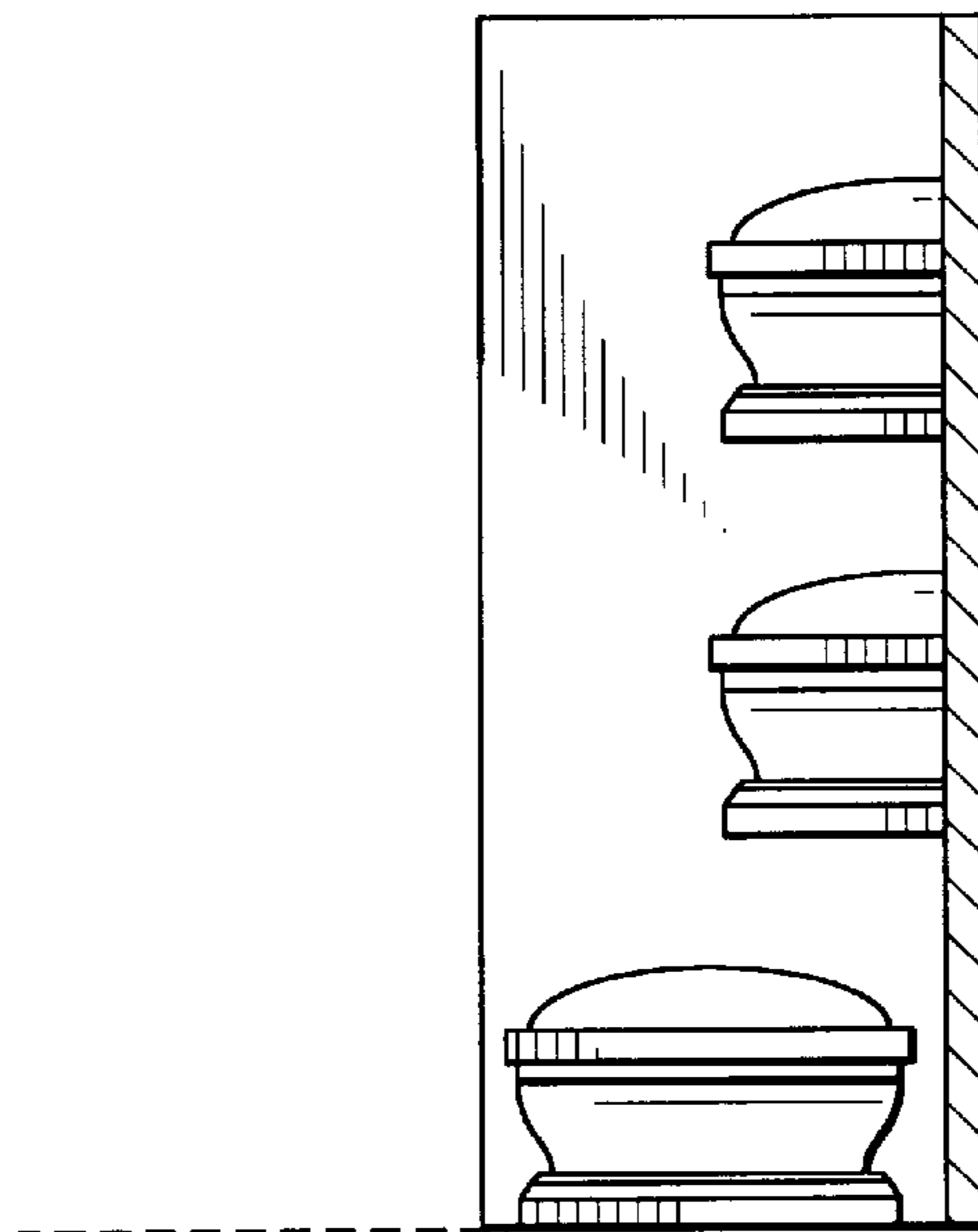

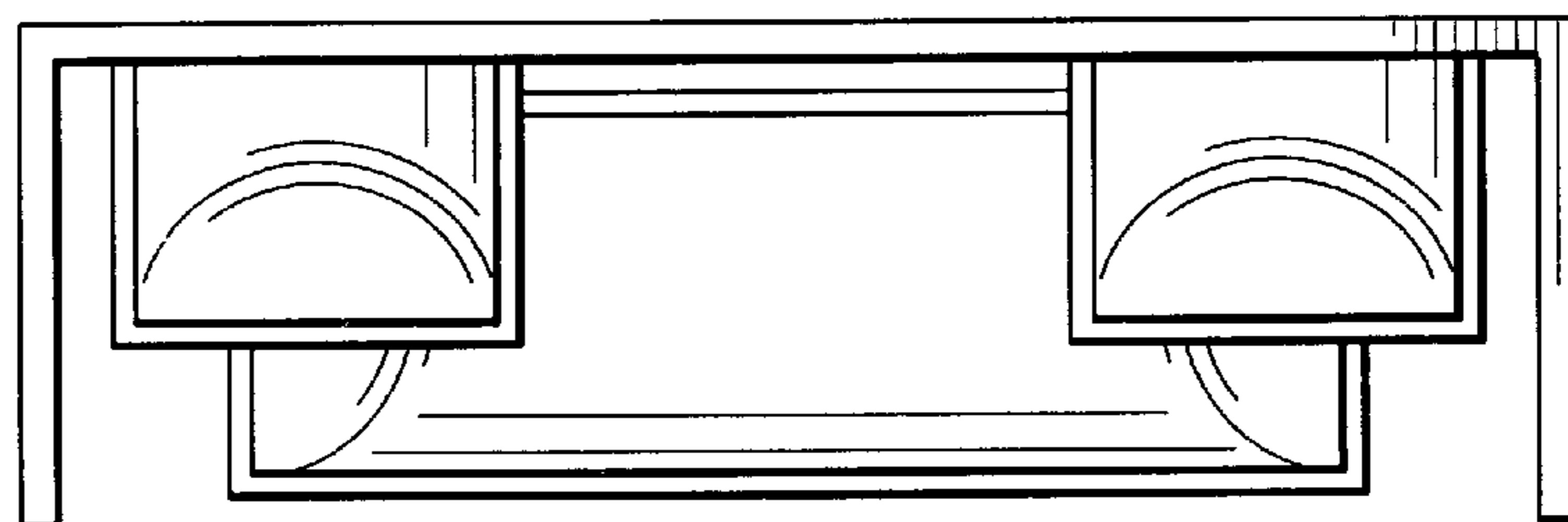

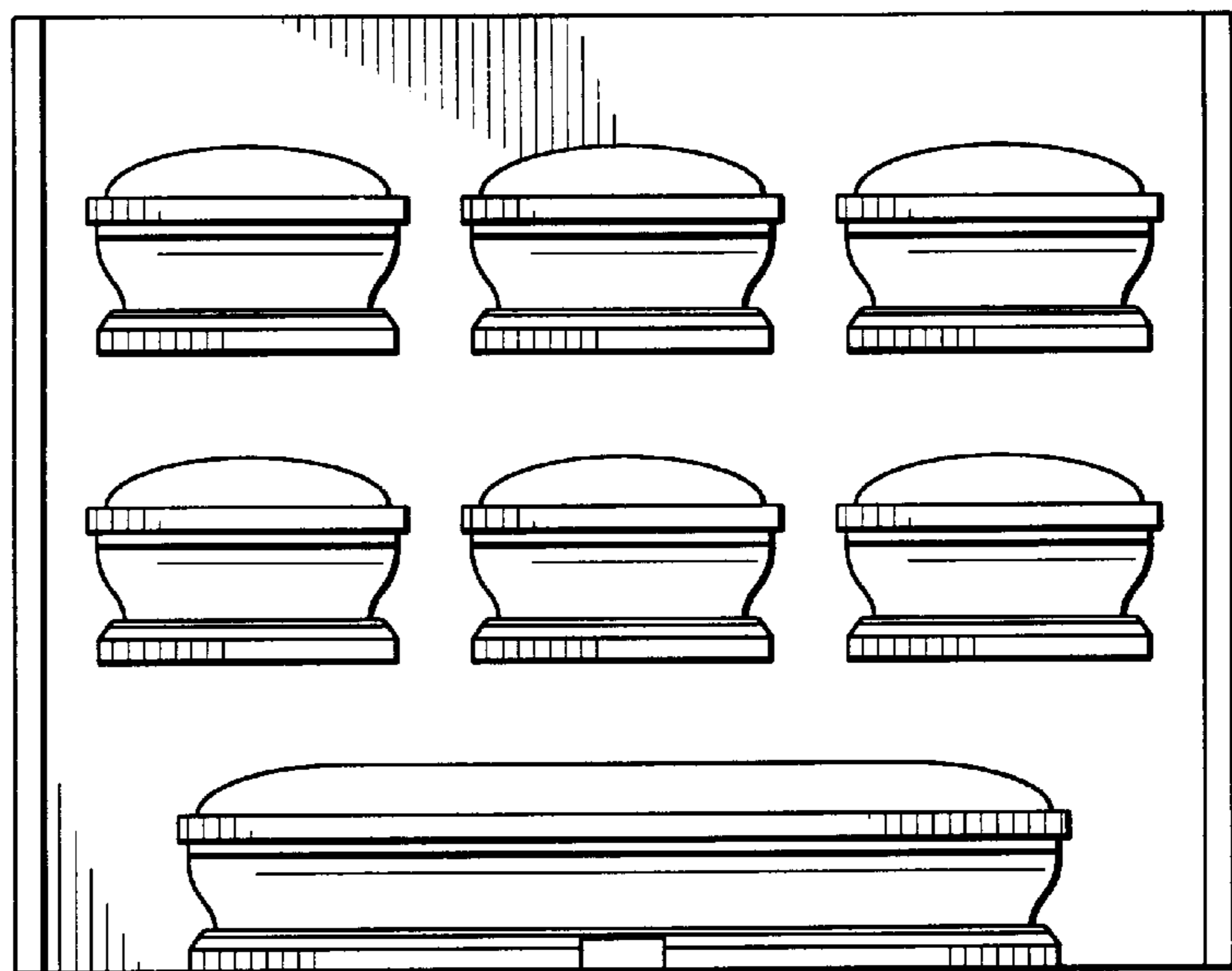

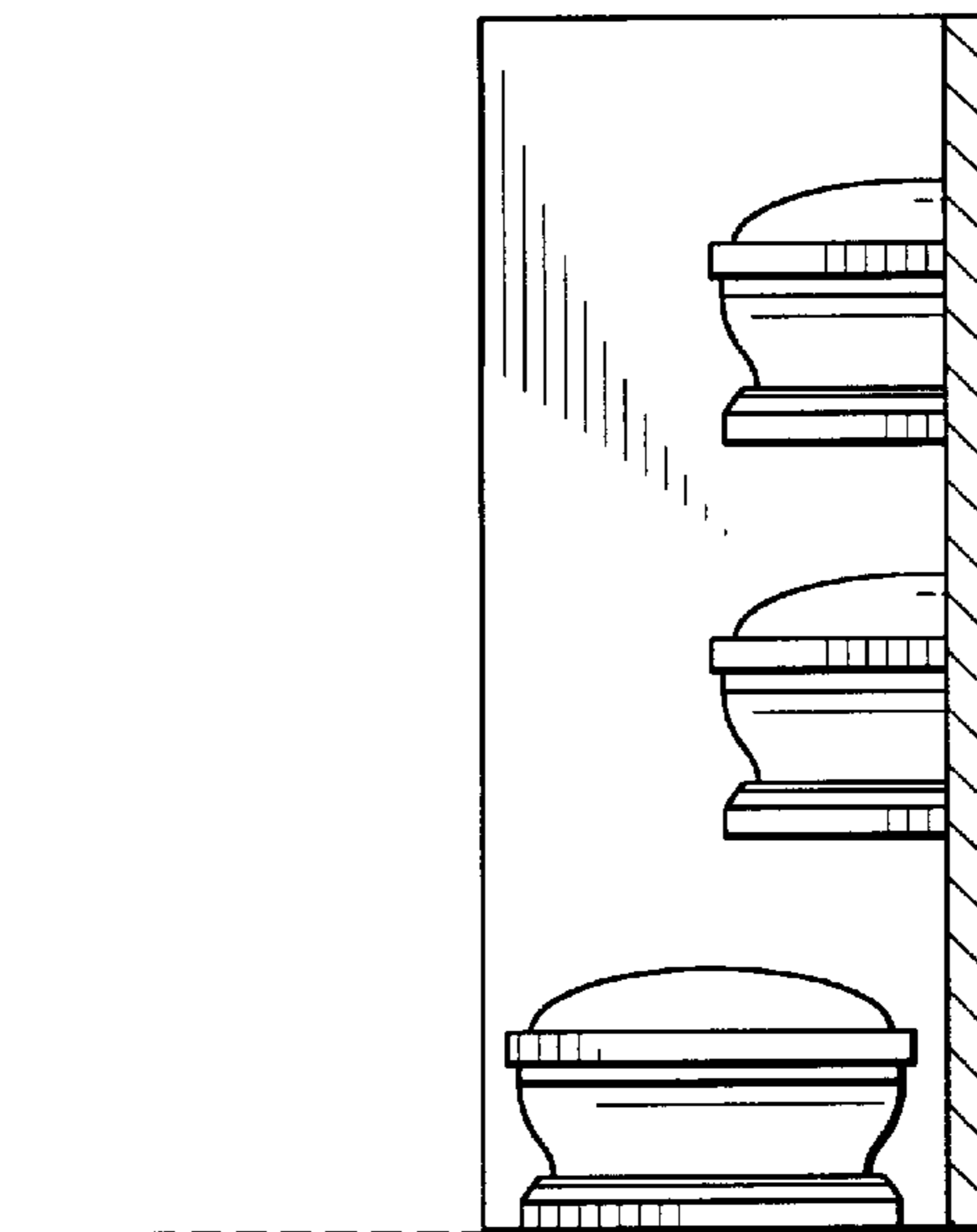

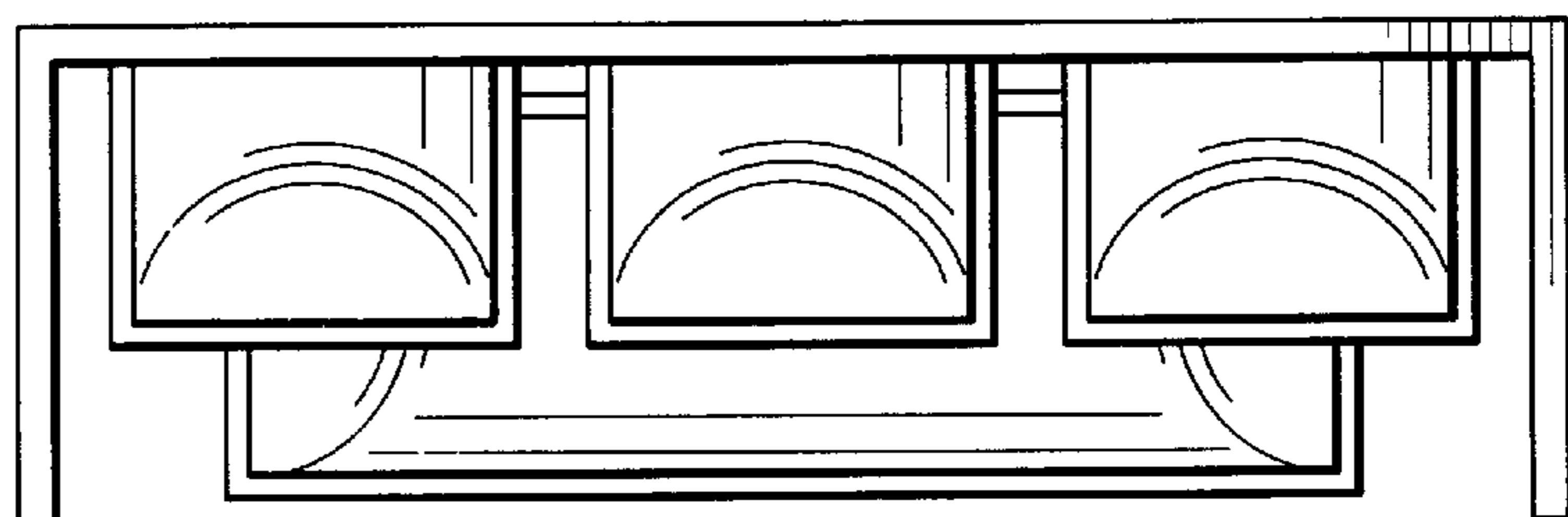

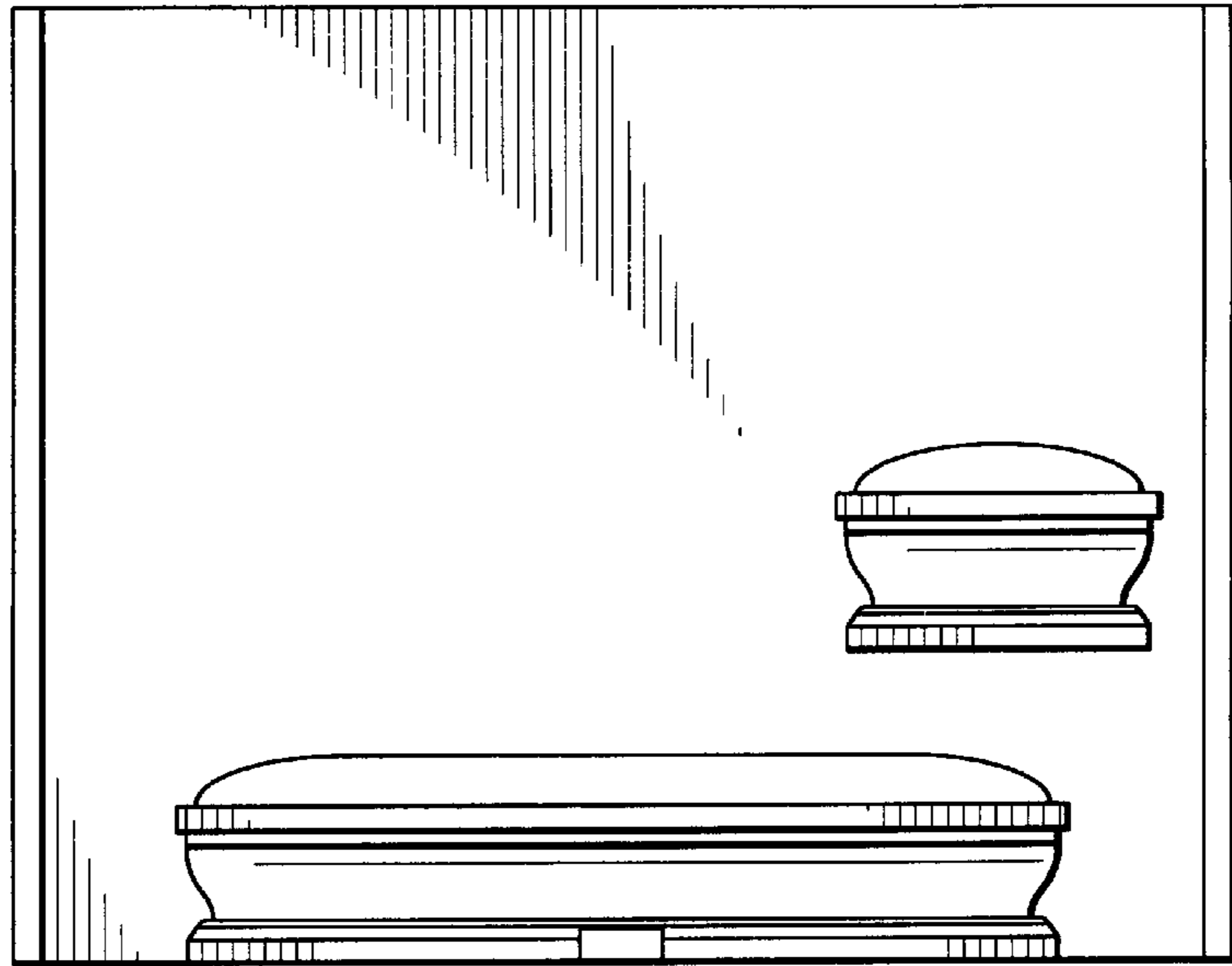

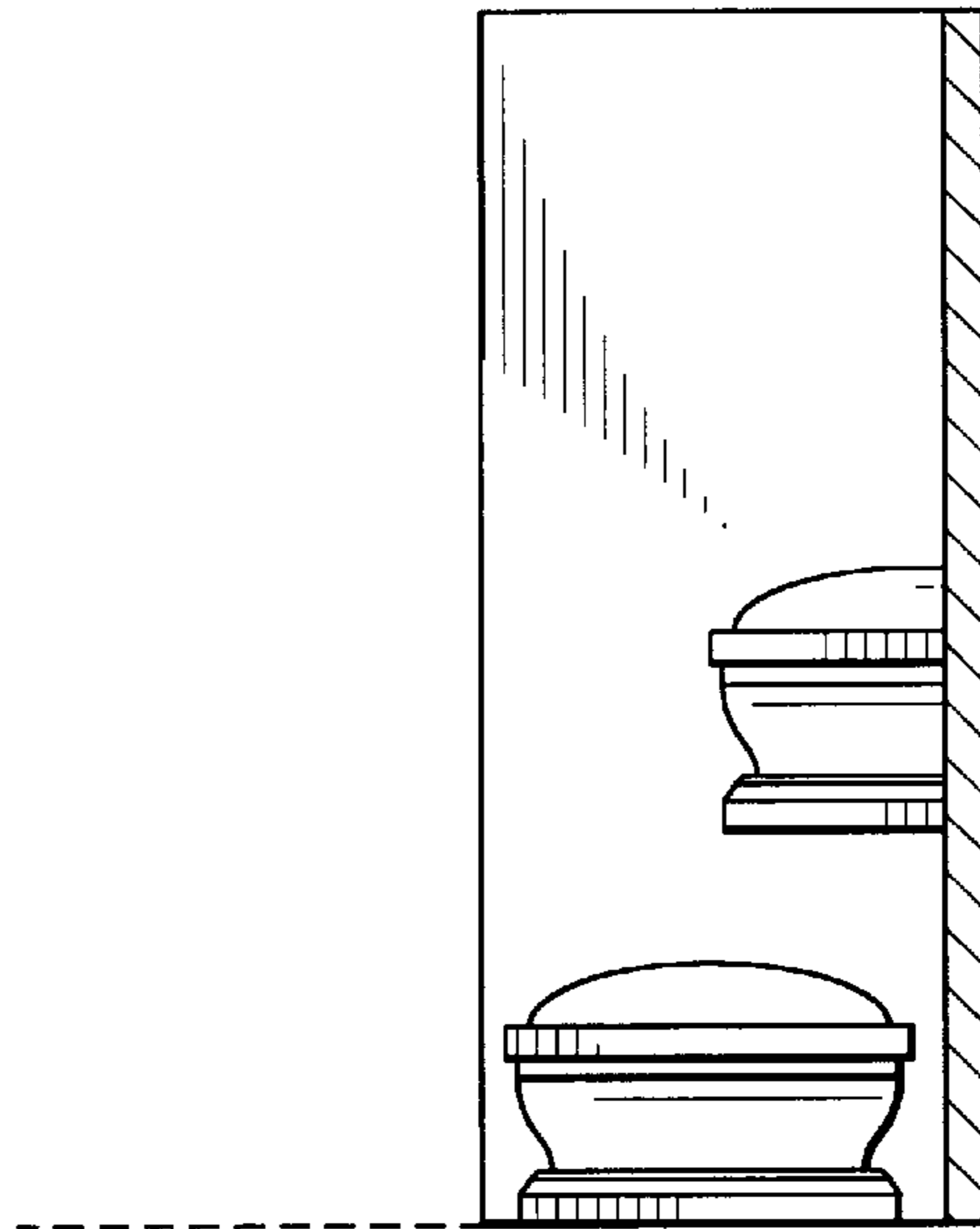

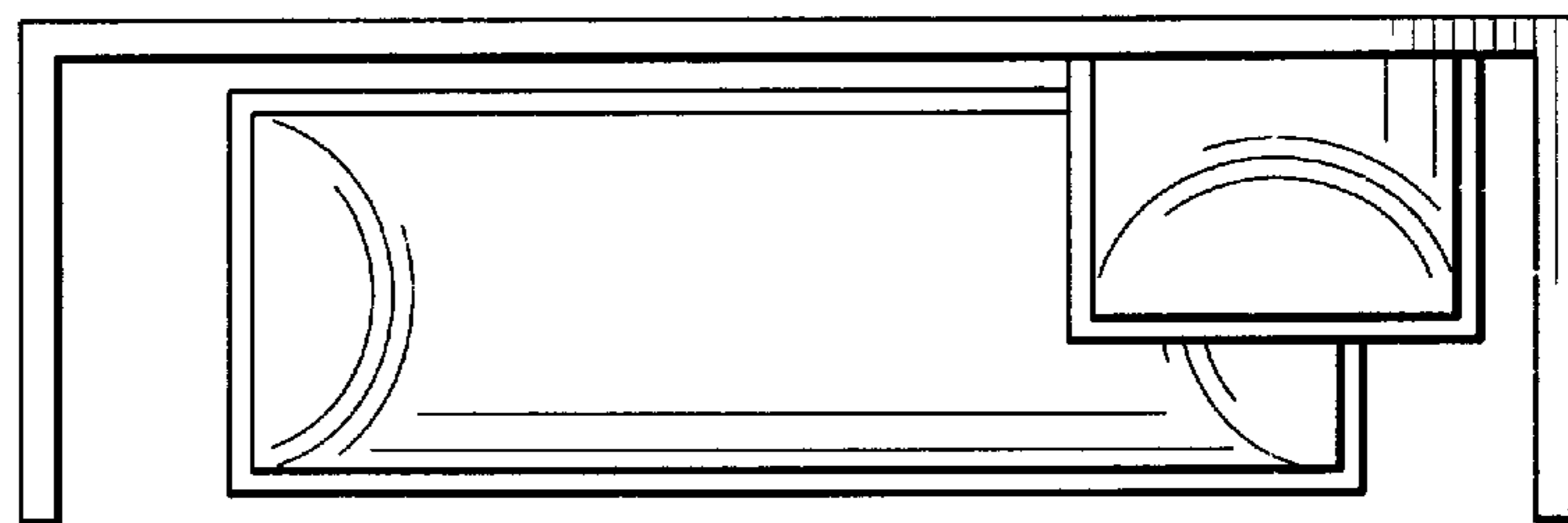

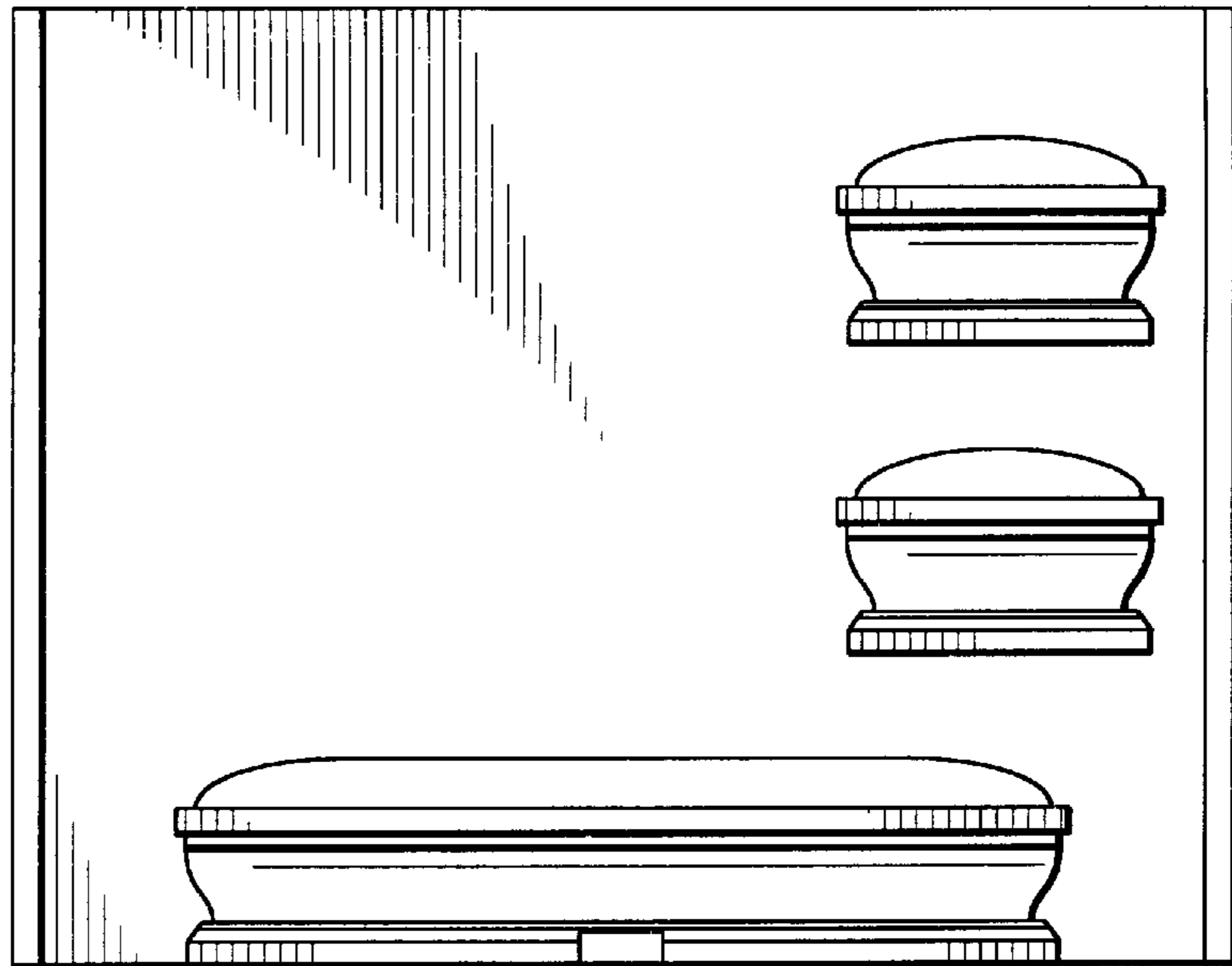

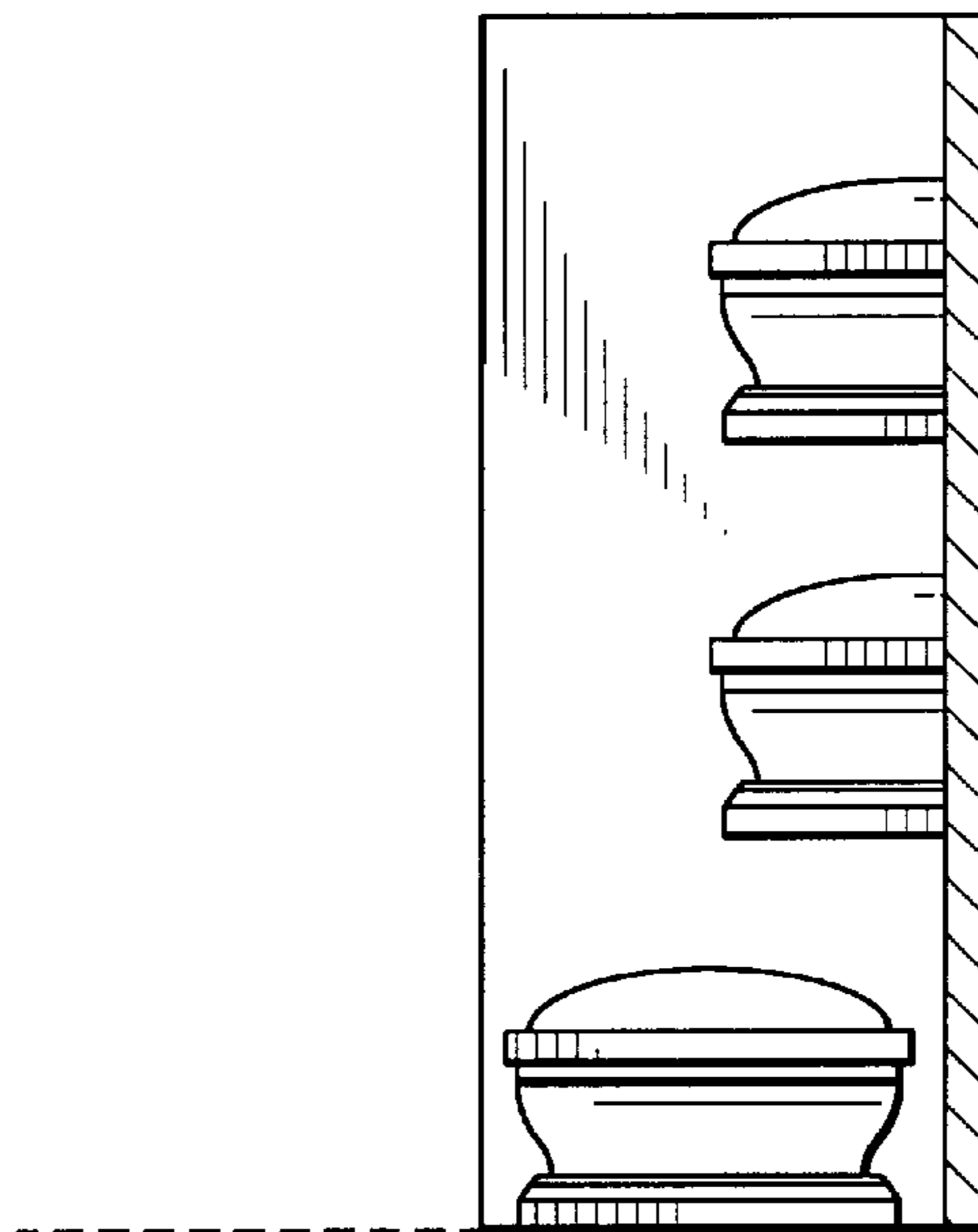
