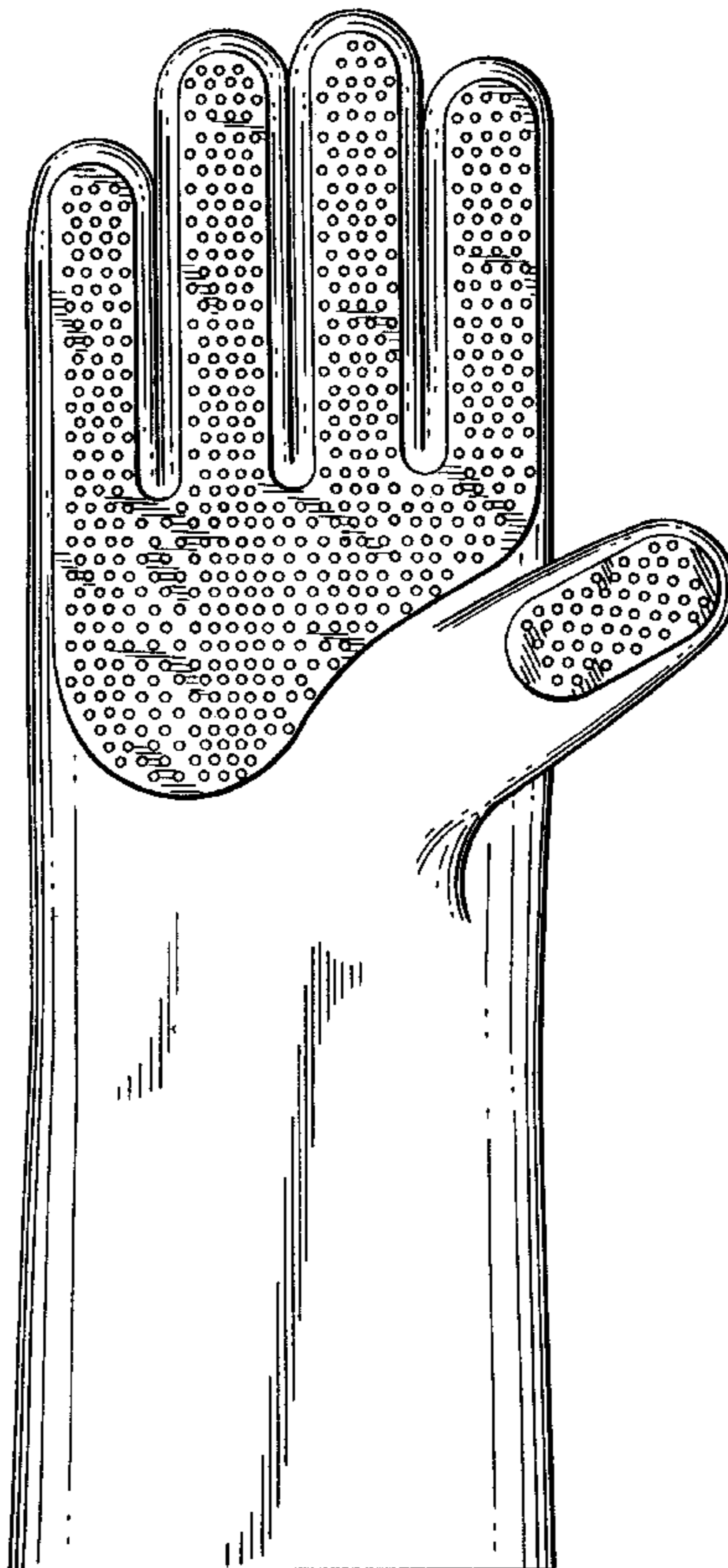

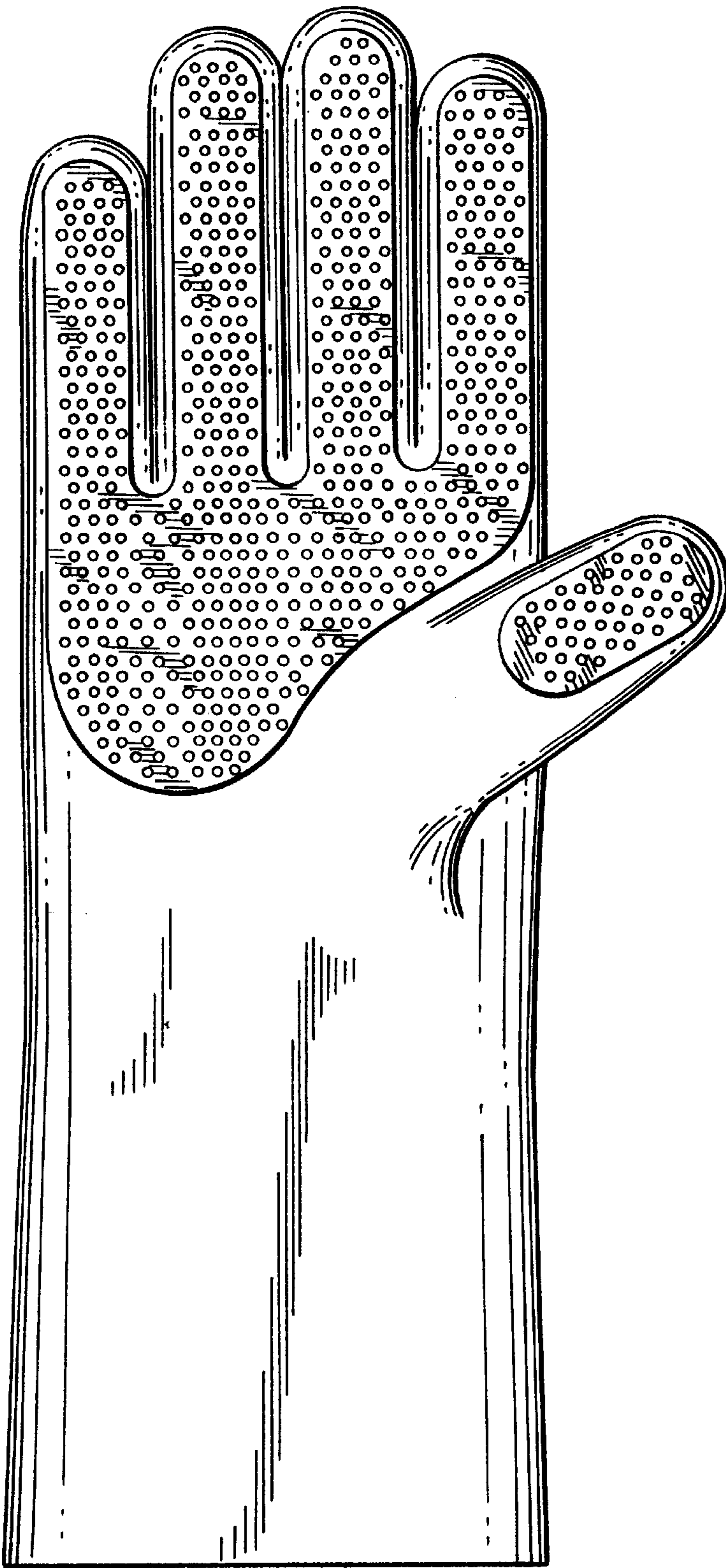
The ornamental design for a glove for grooming and shampooing pets, as shown and described.

**DESCRIPTION**

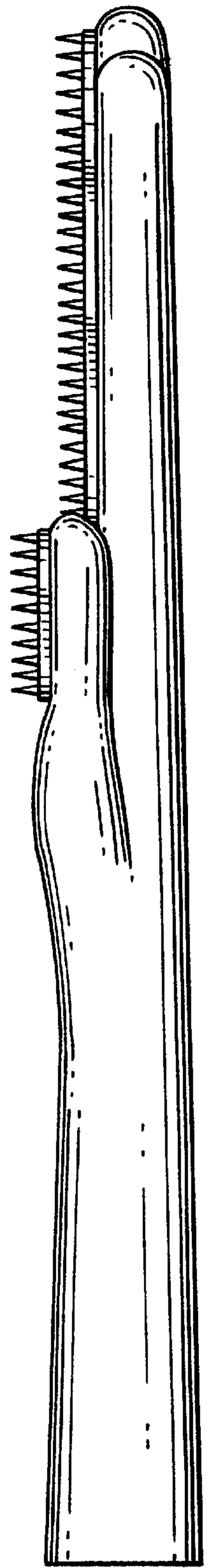
FIG. 1 is a front elevational view of a glove for grooming or shampooing pets, showing my new design therefor;

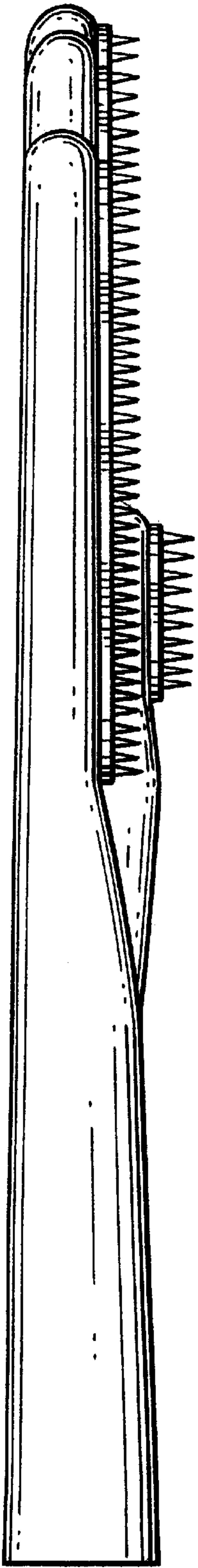




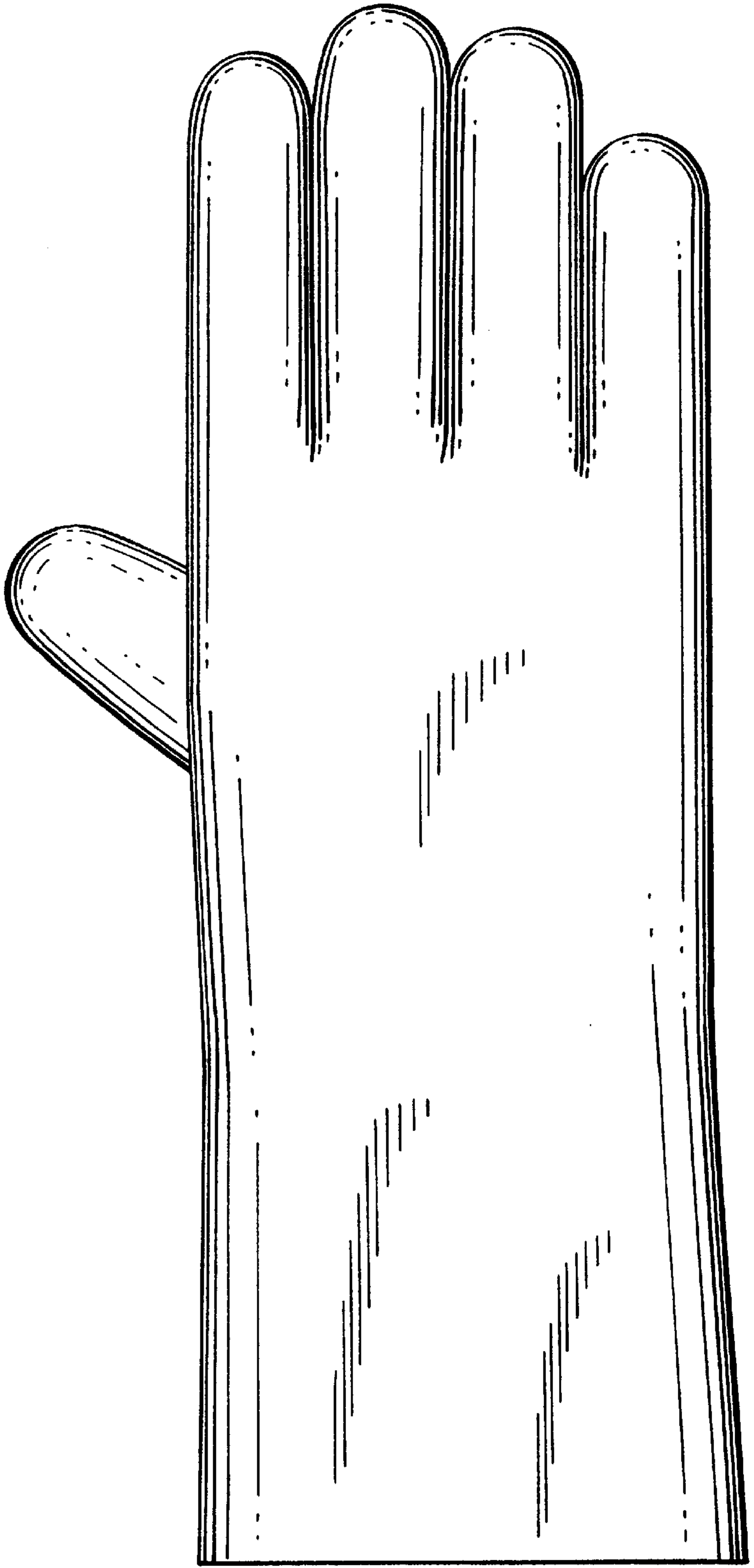

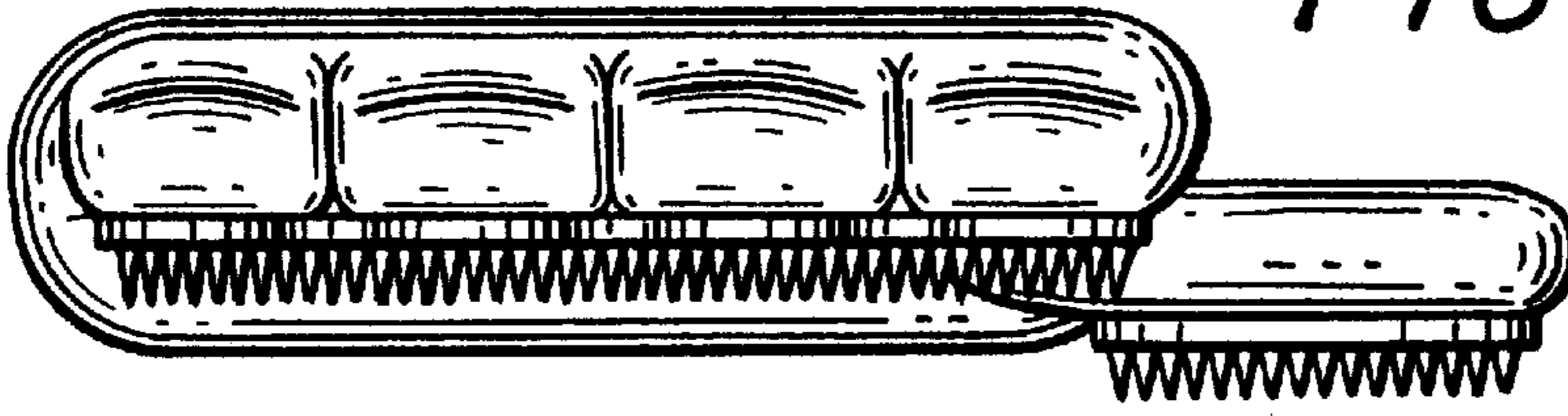
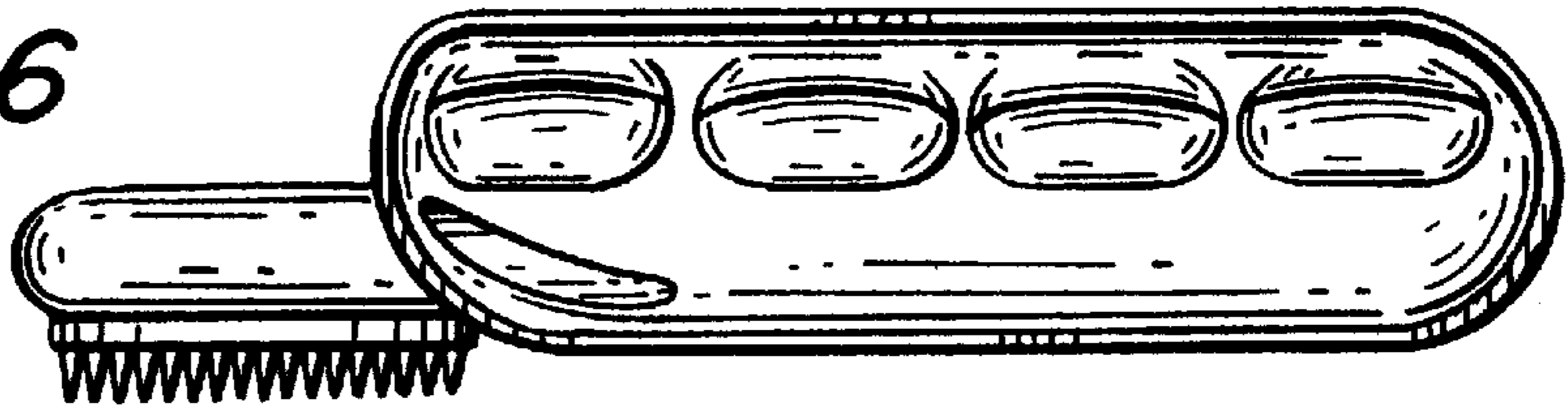
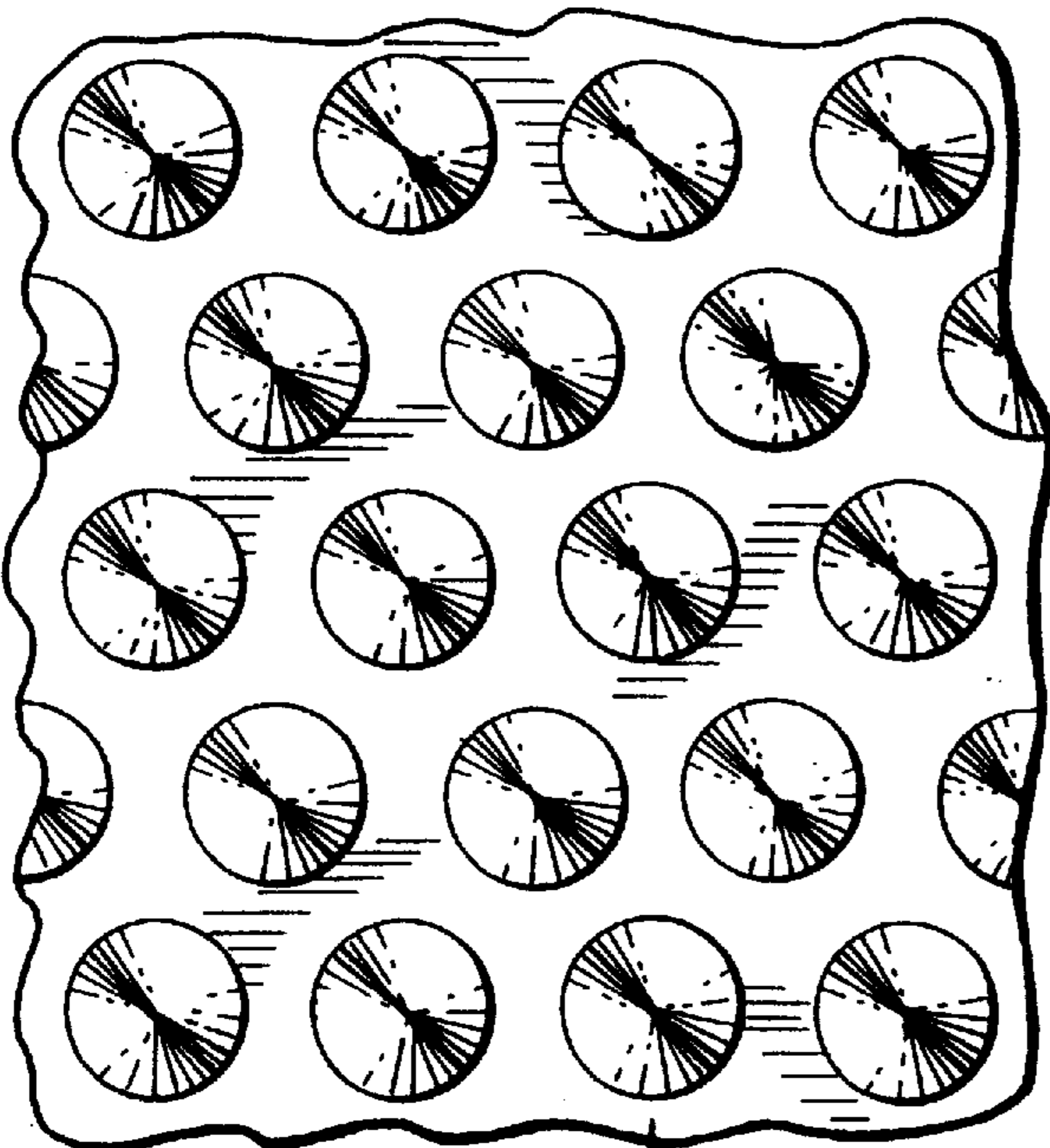

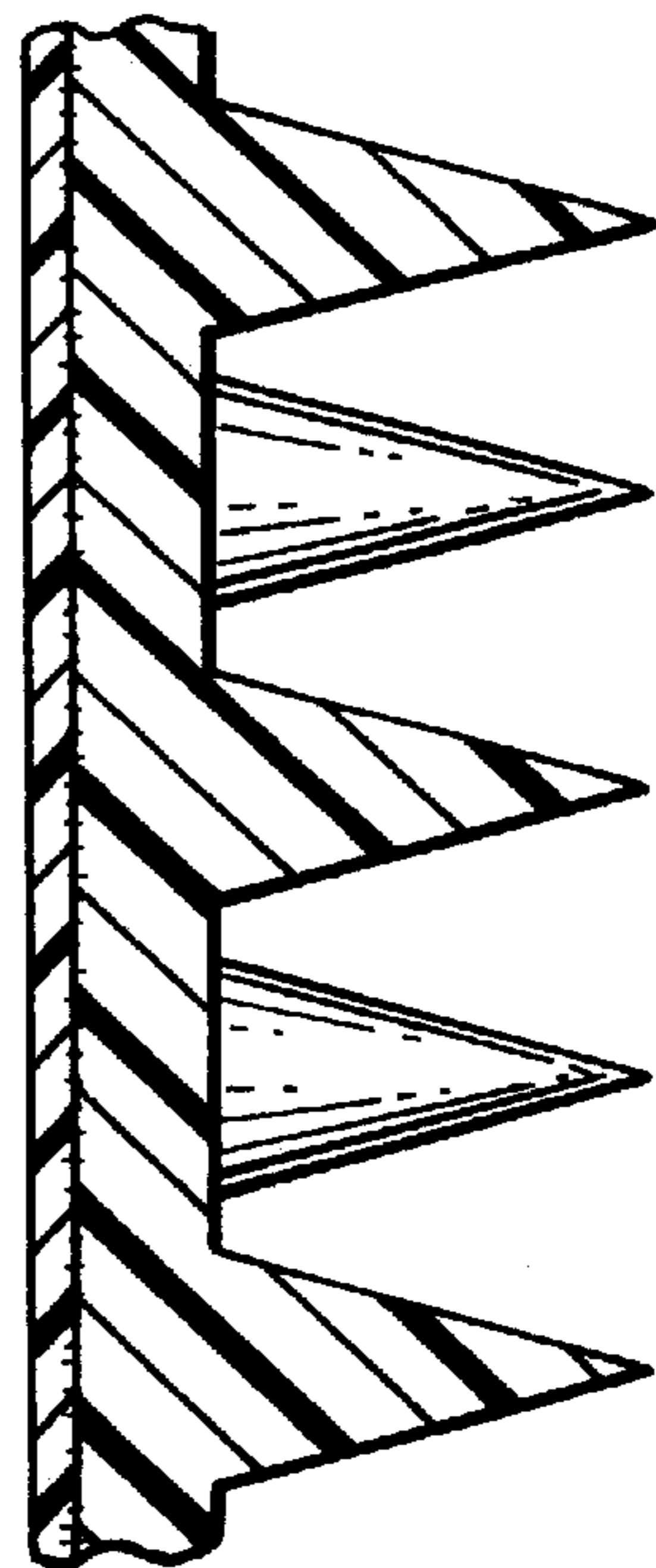

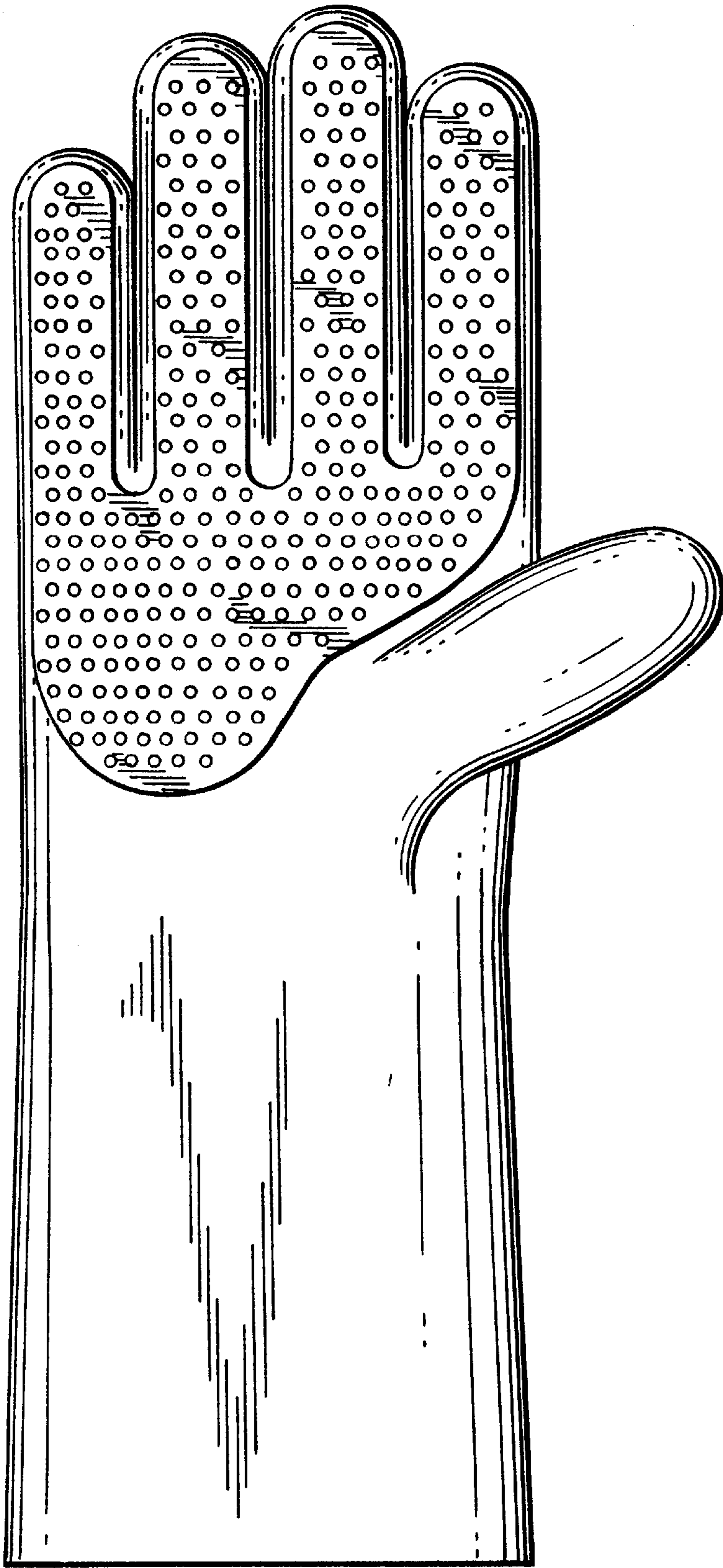

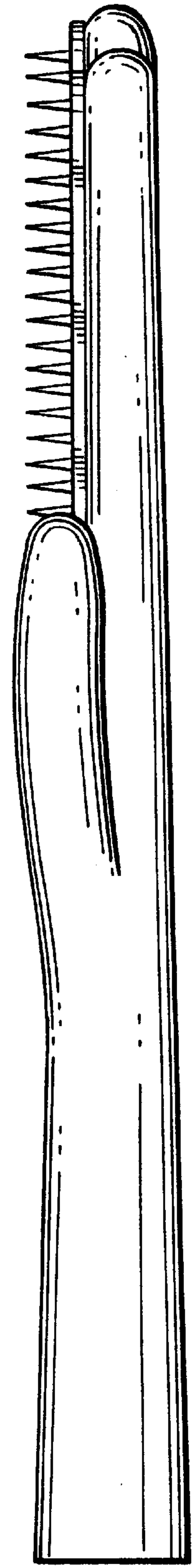
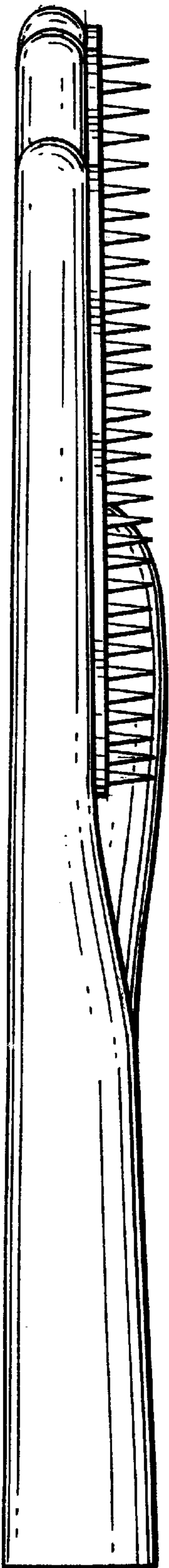
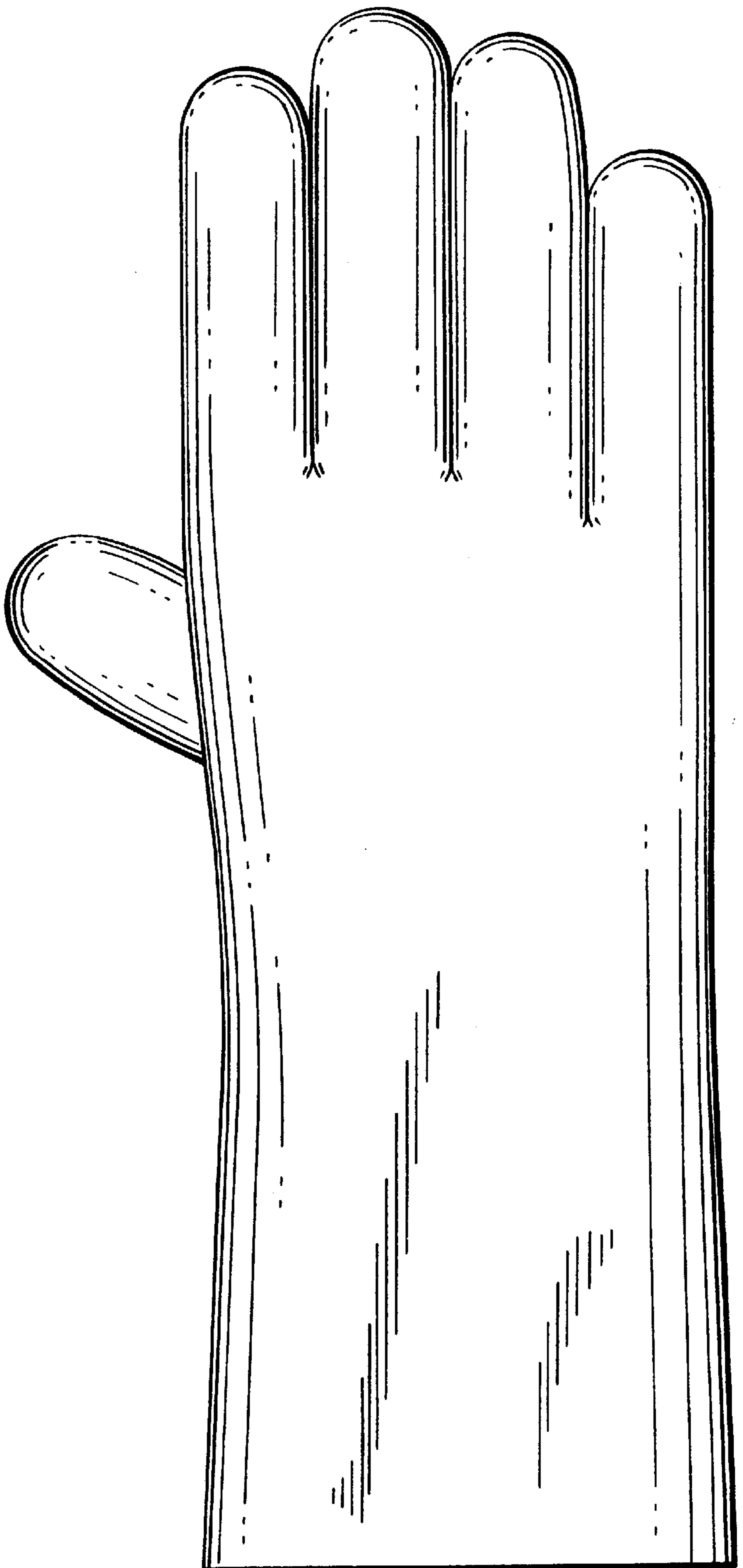

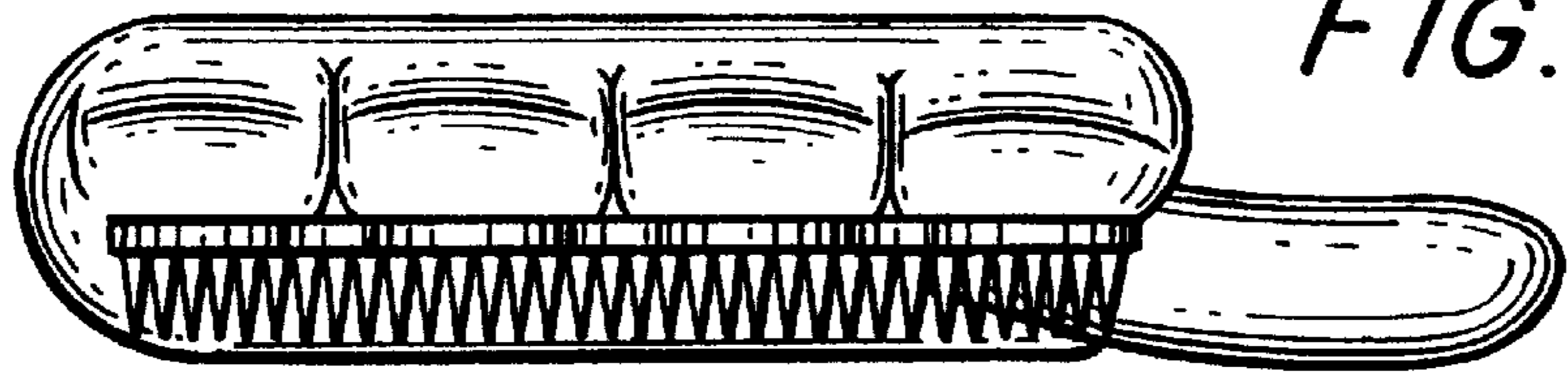

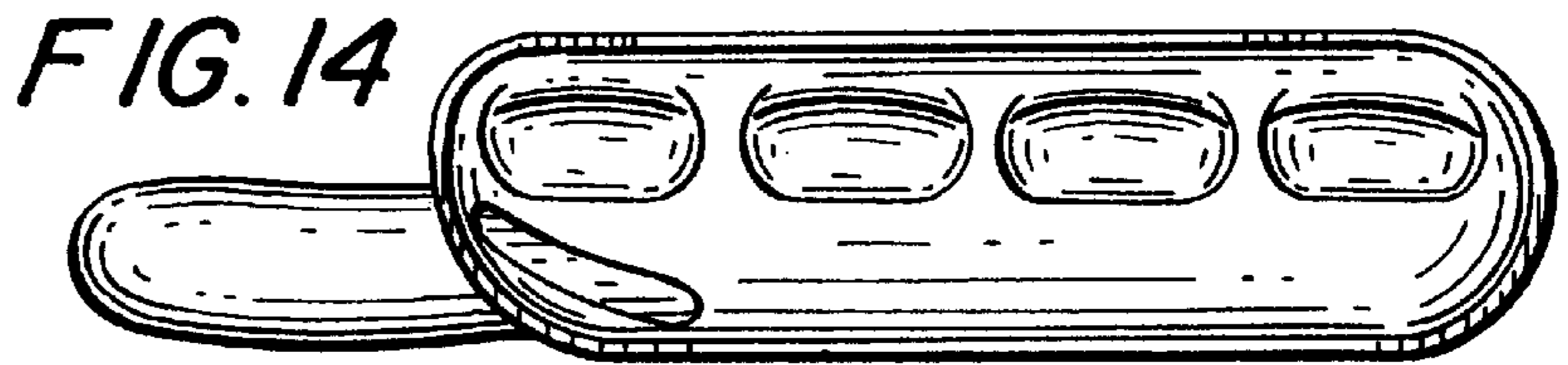

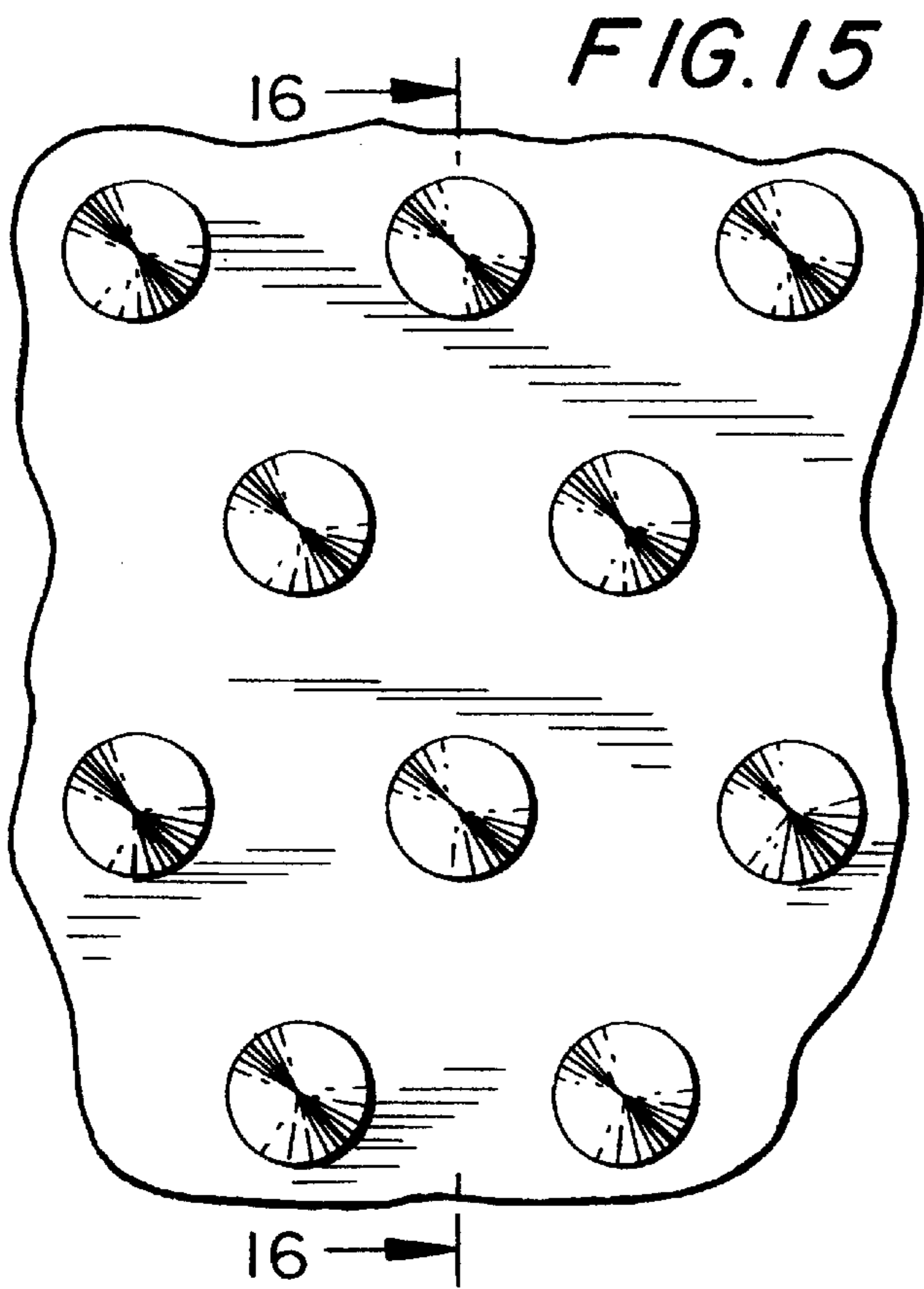

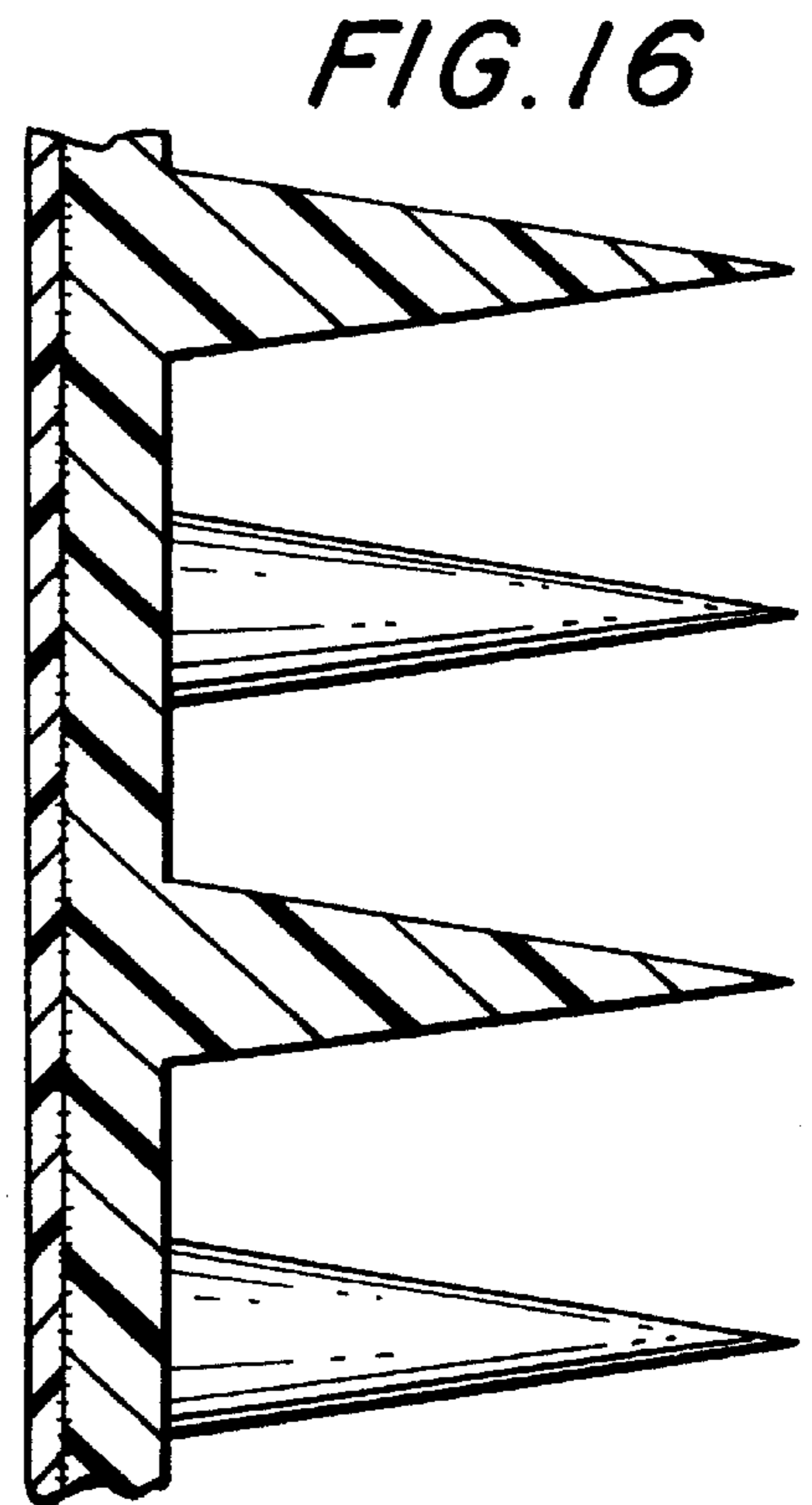
