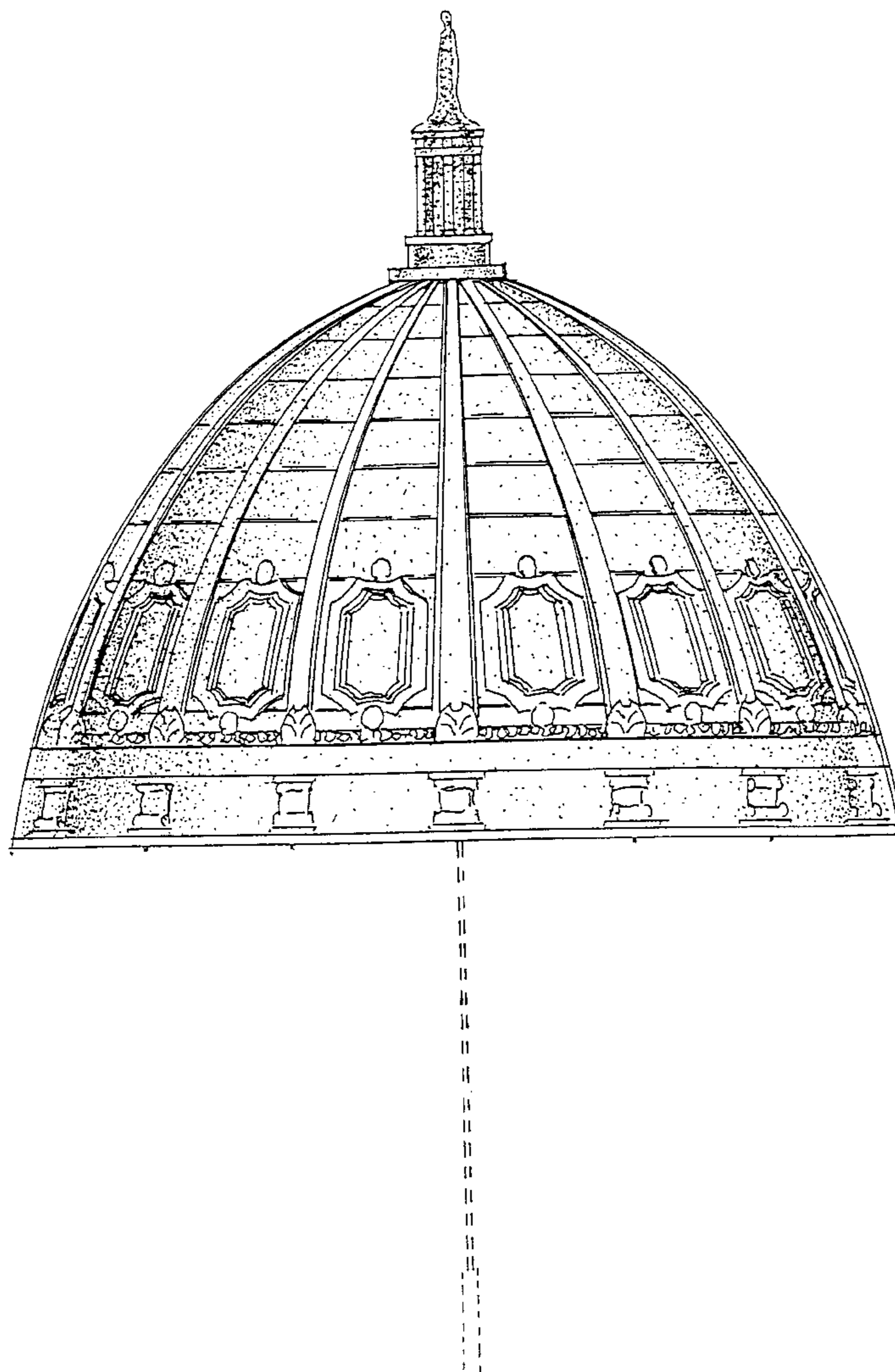

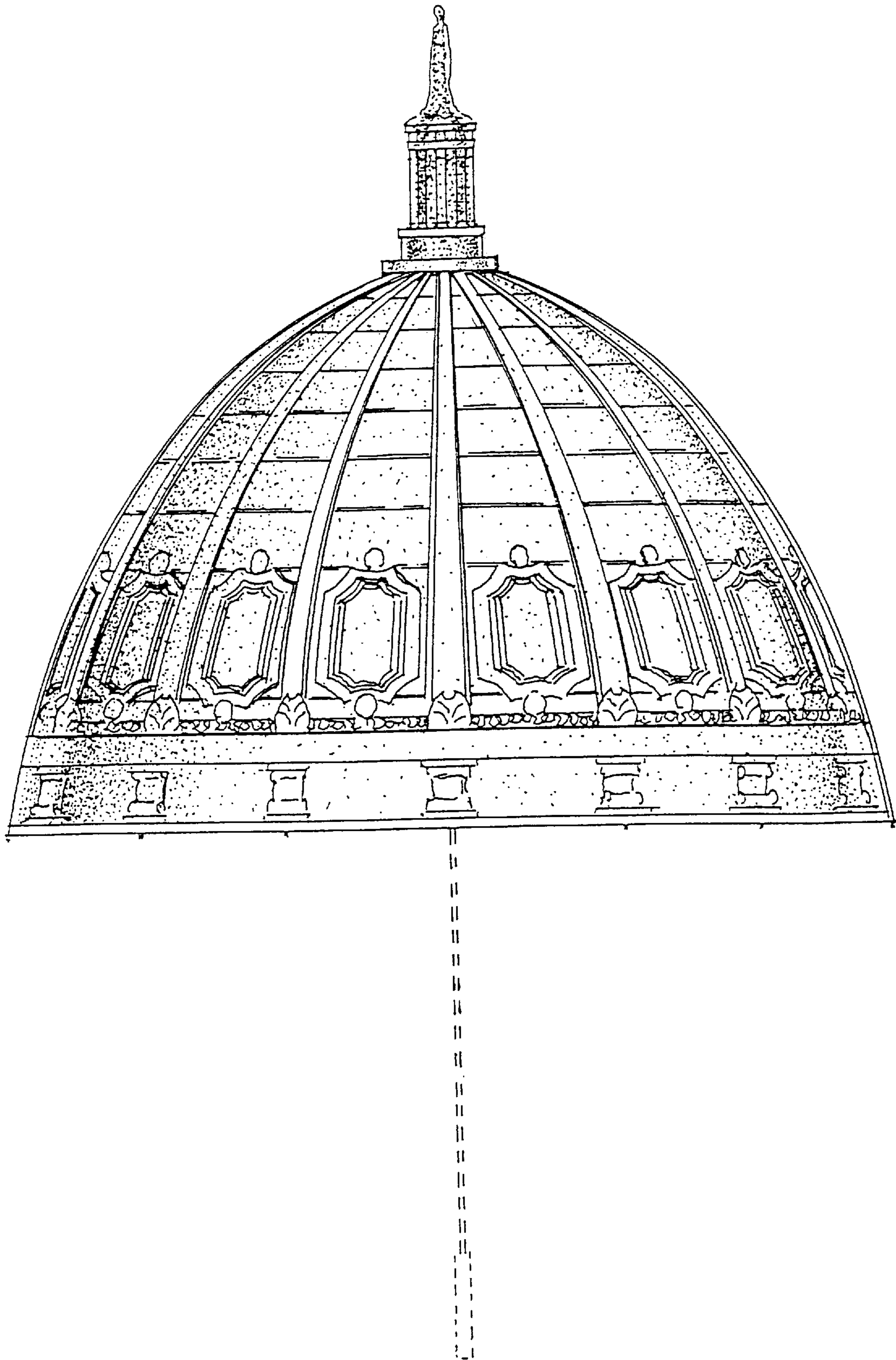

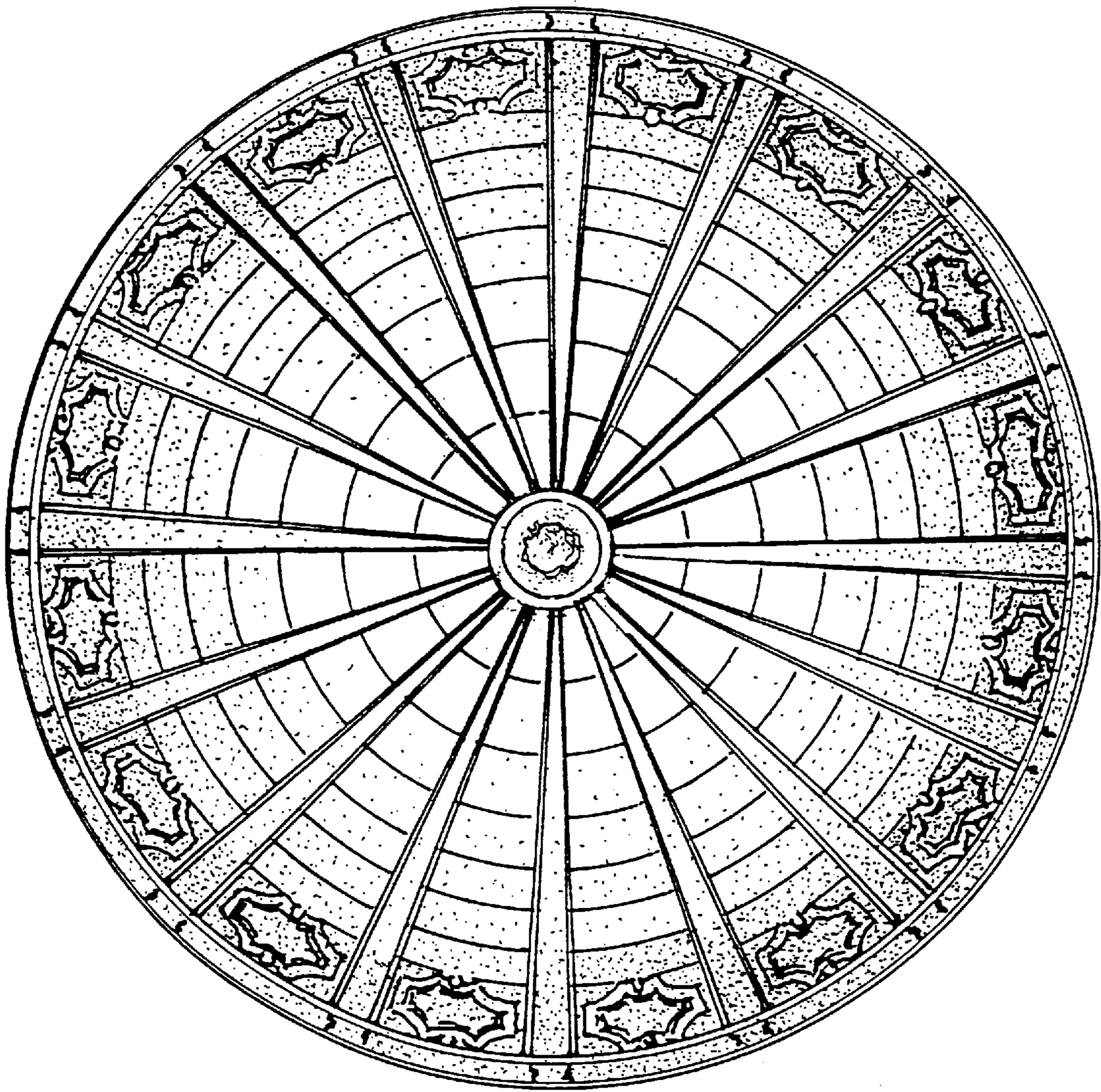

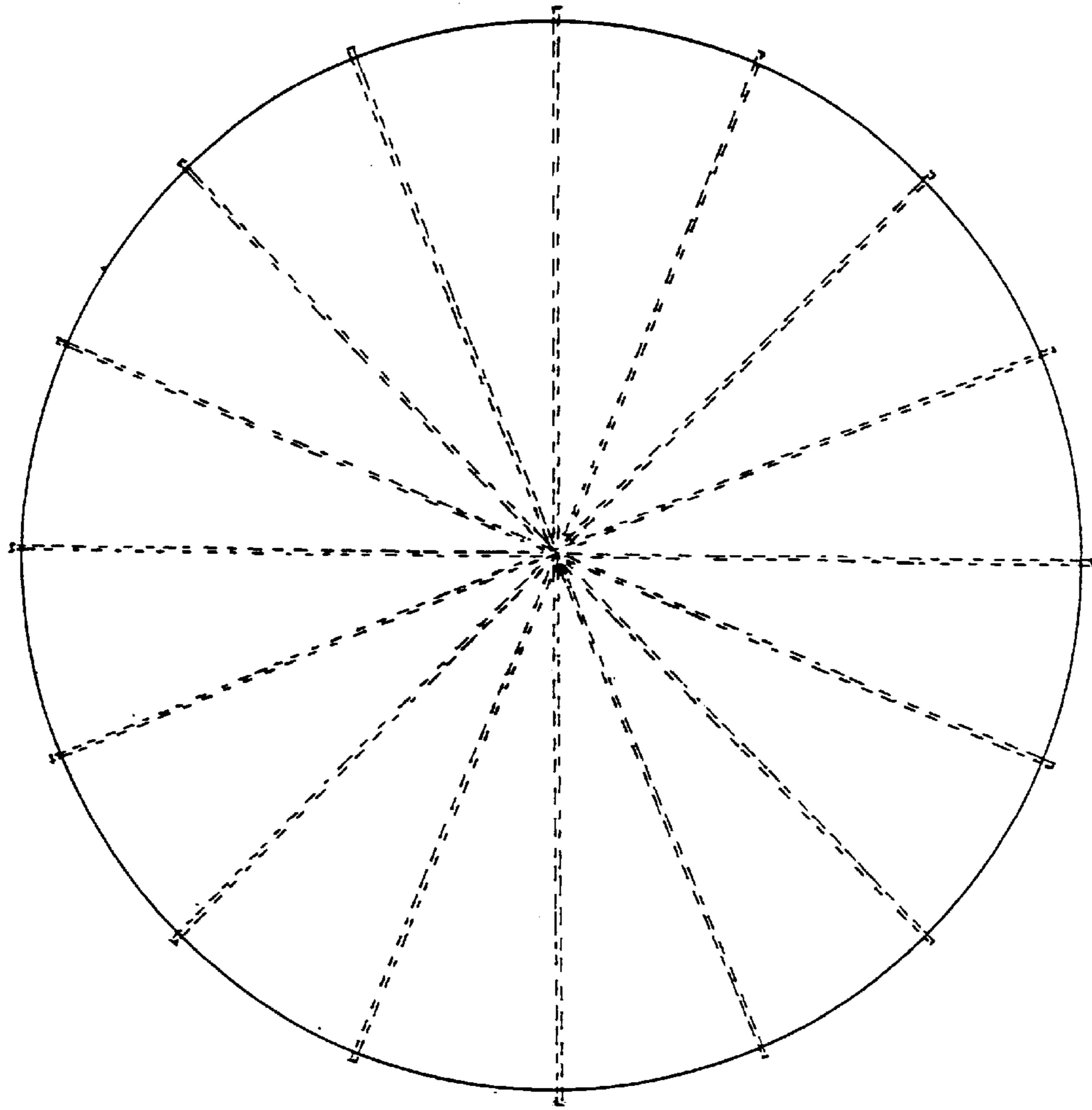

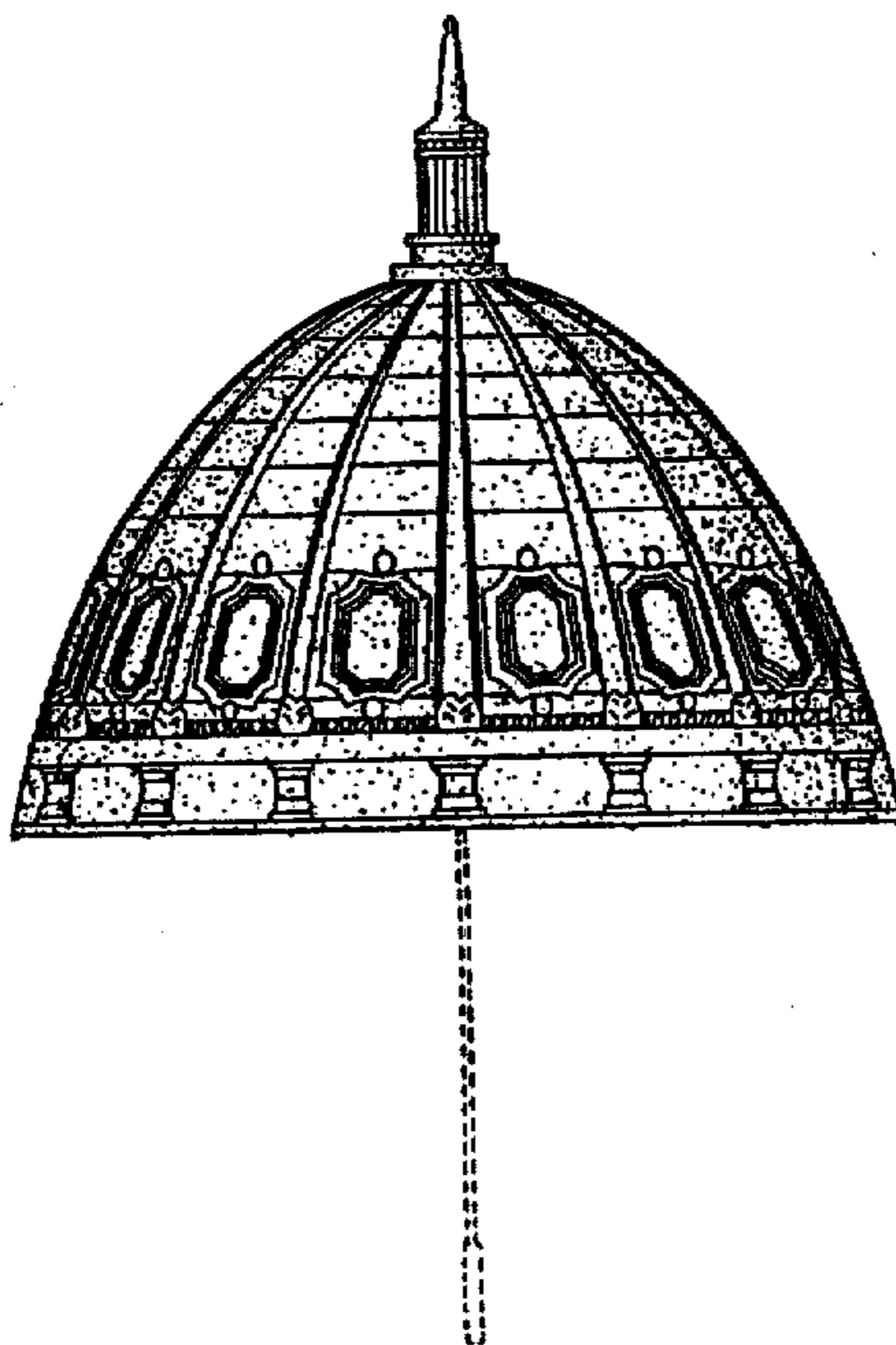
FIG. 1 is an elevation view of our new design;

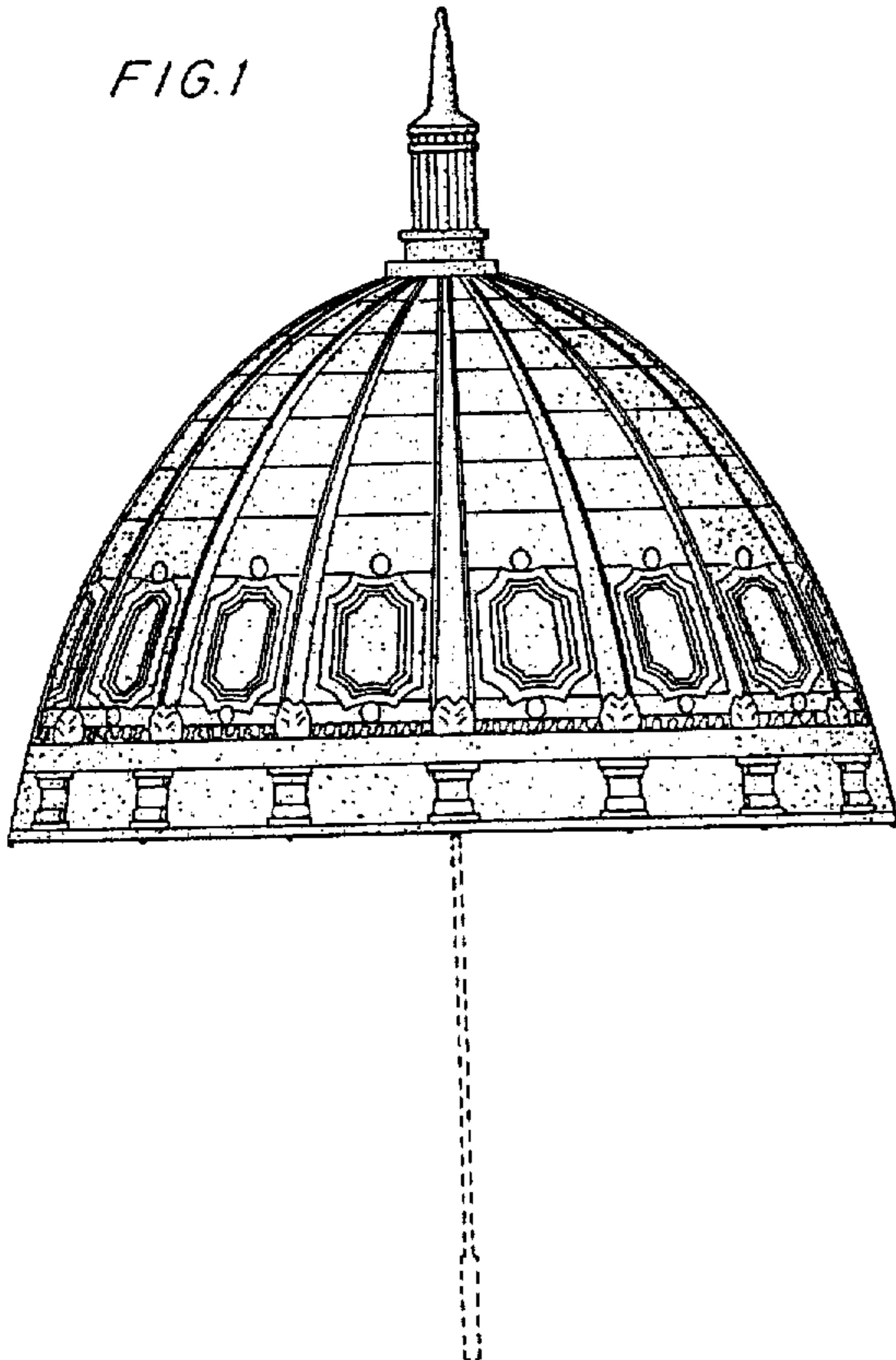

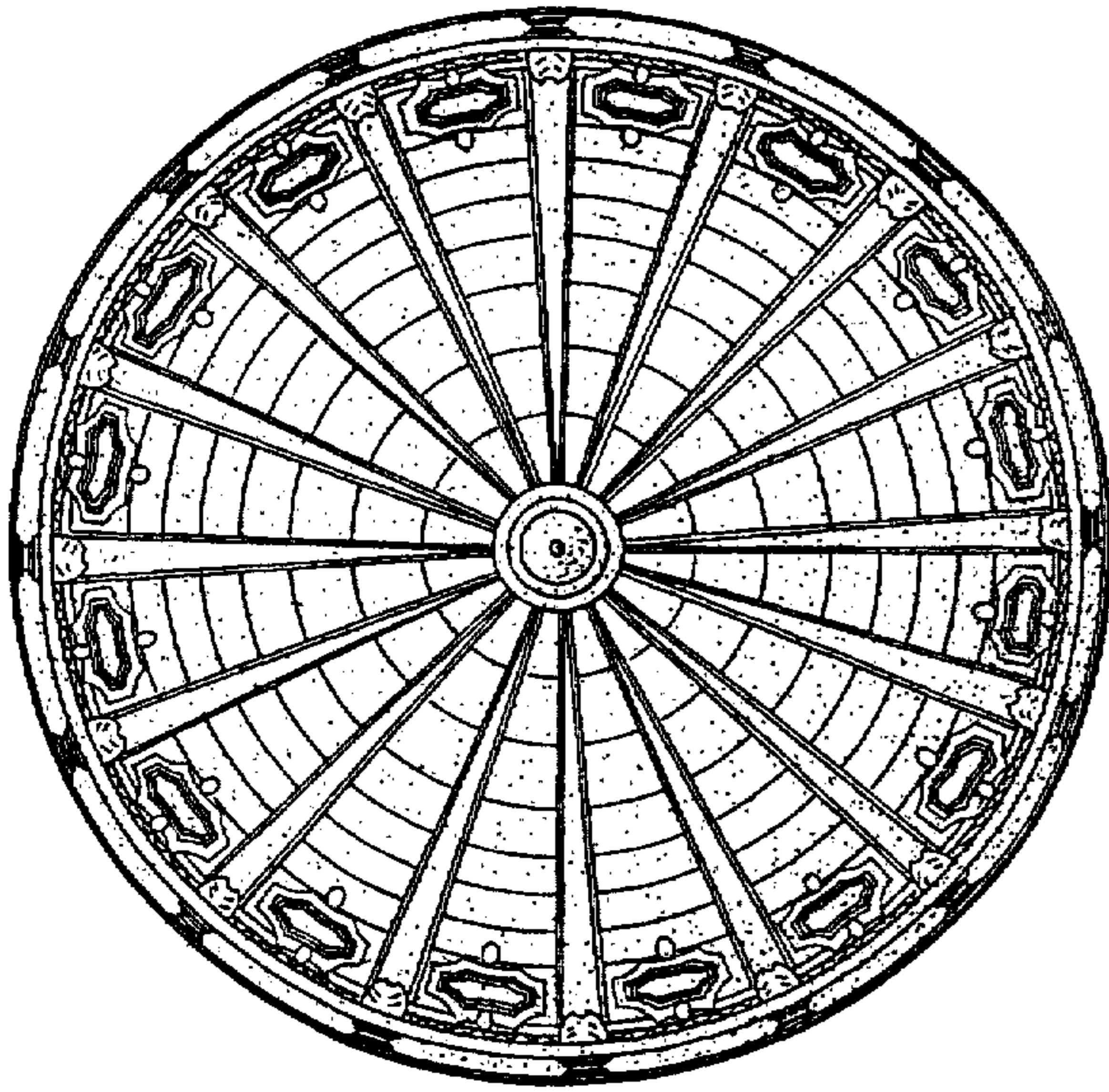

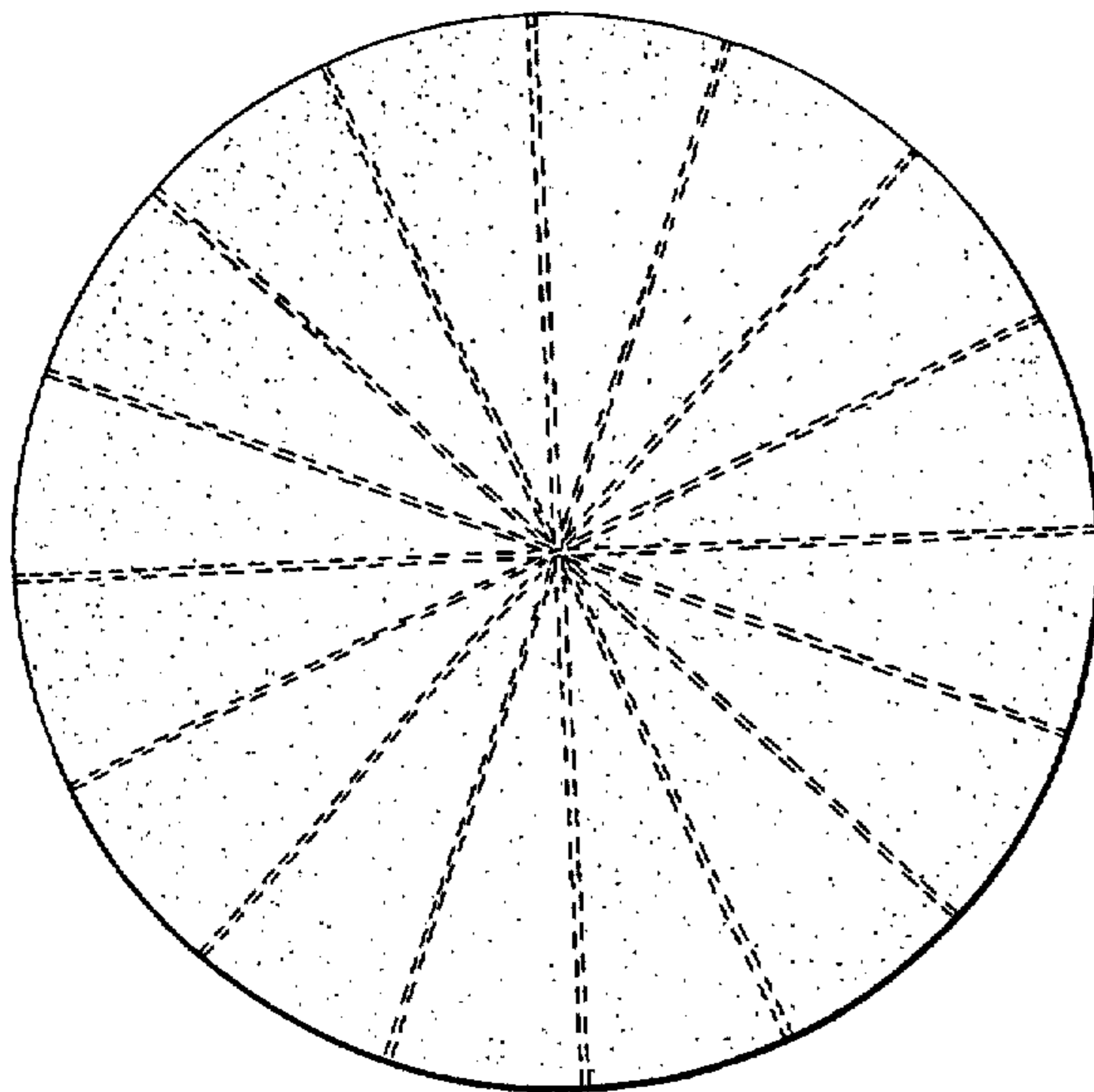
