The ornamental design for a combined bottle and pump dispenser, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a combined bottle and pump dispenser showing our new design;

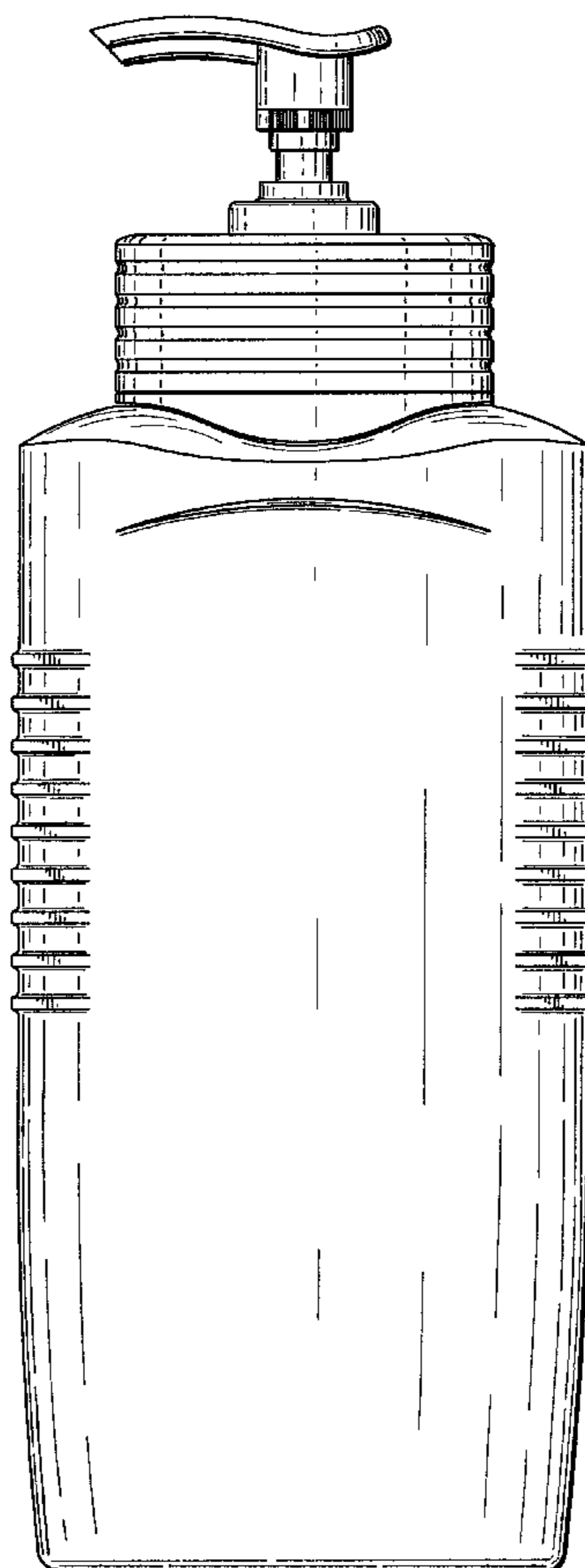

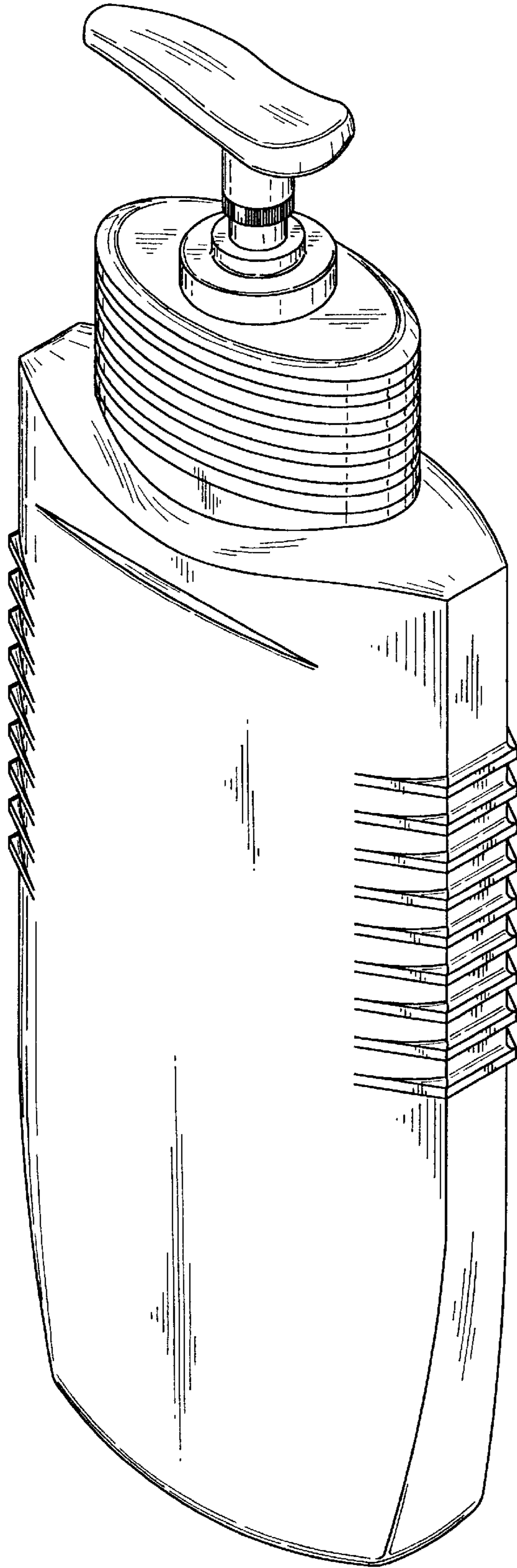

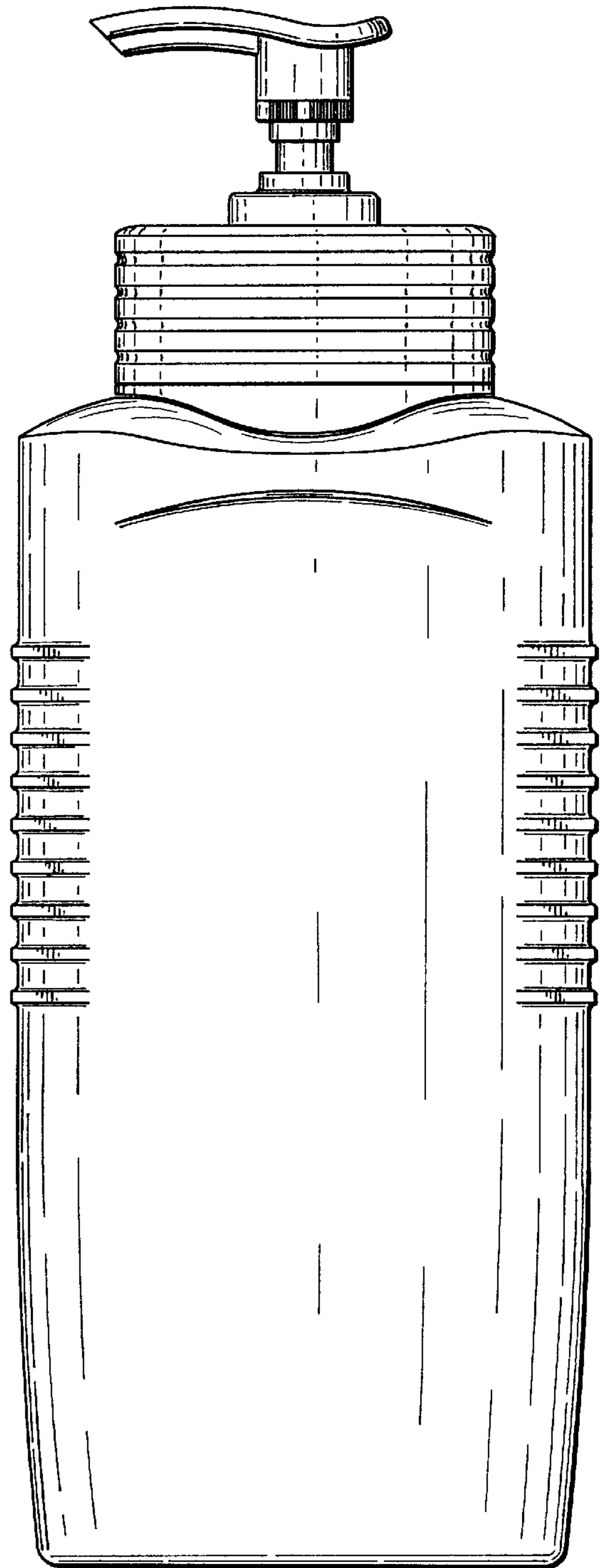

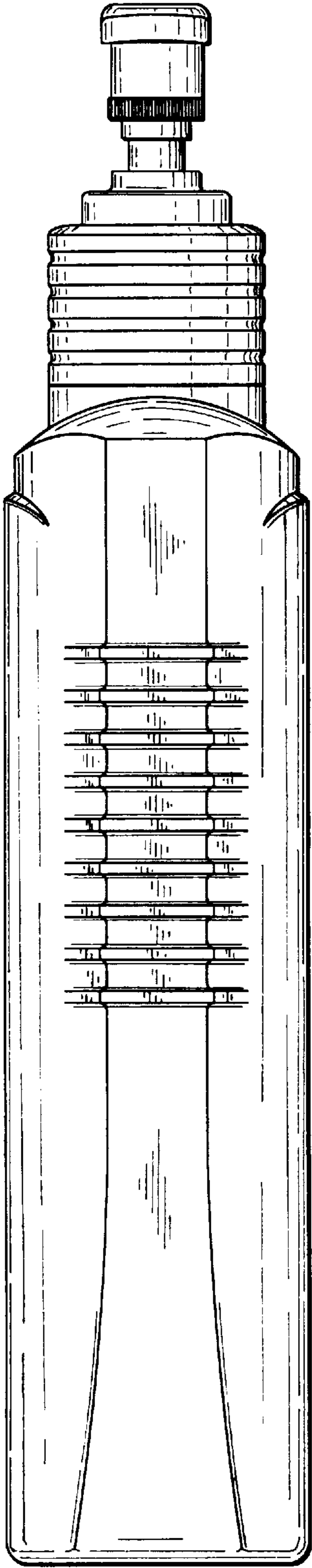

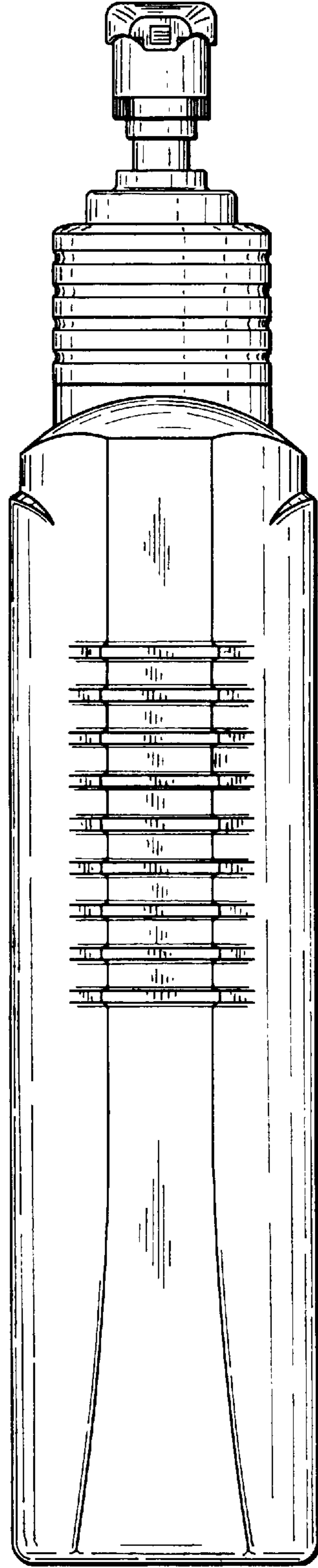

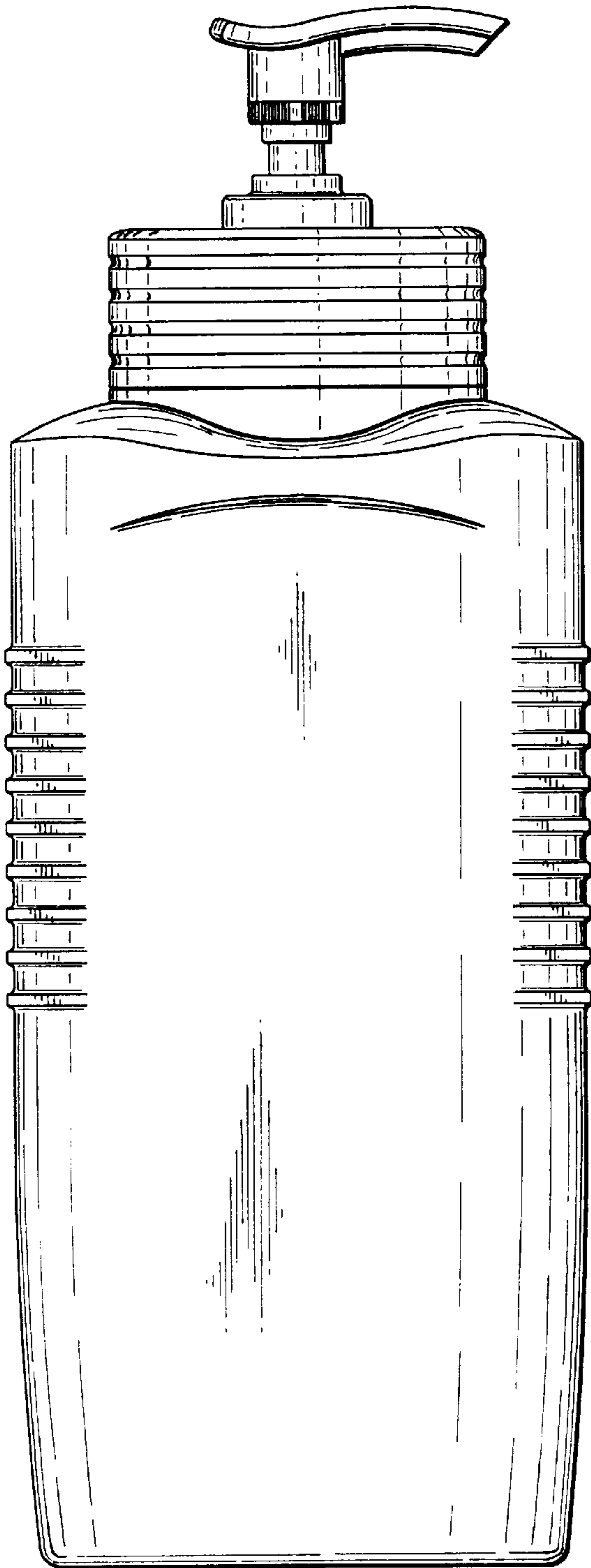

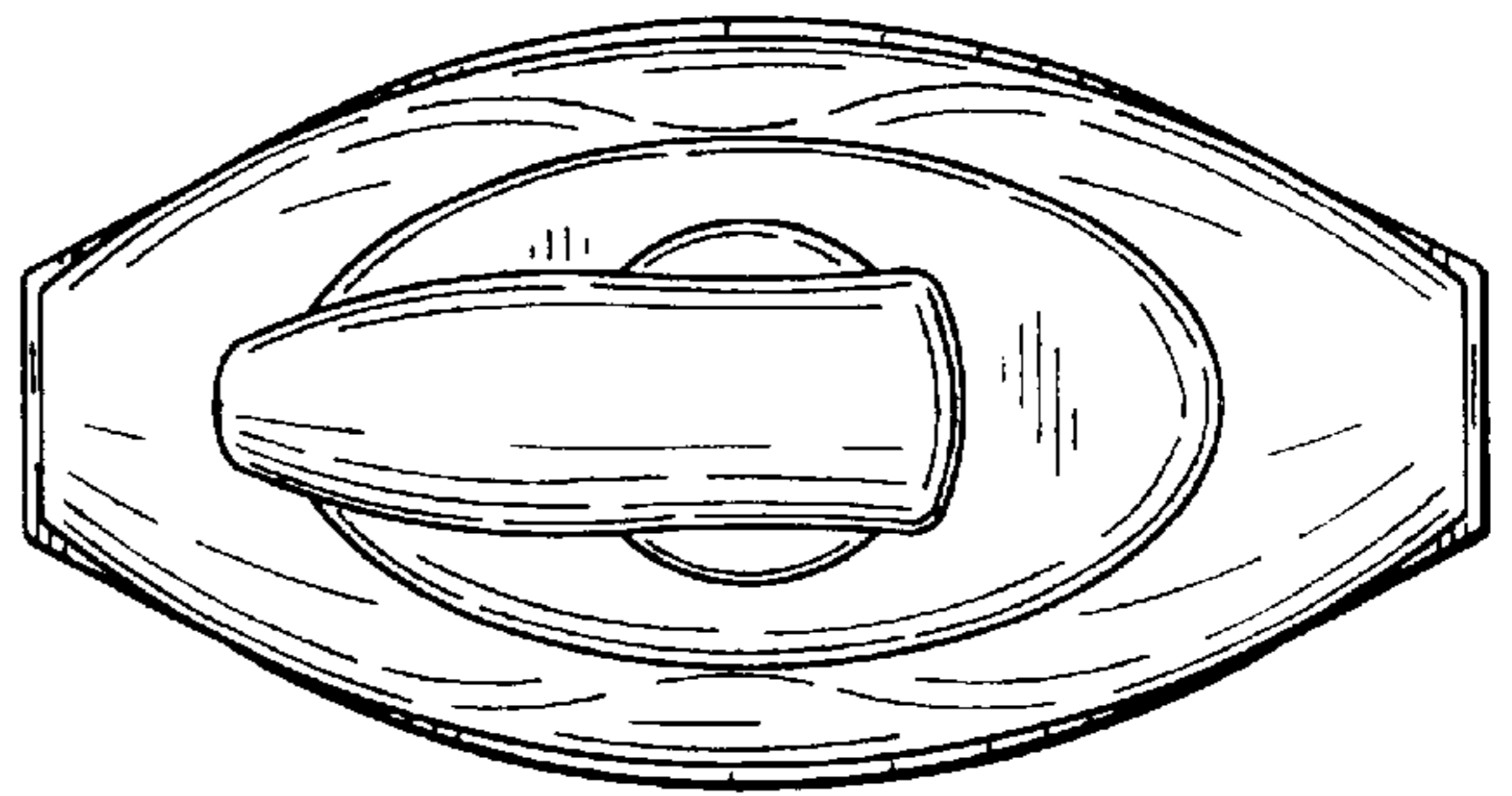
