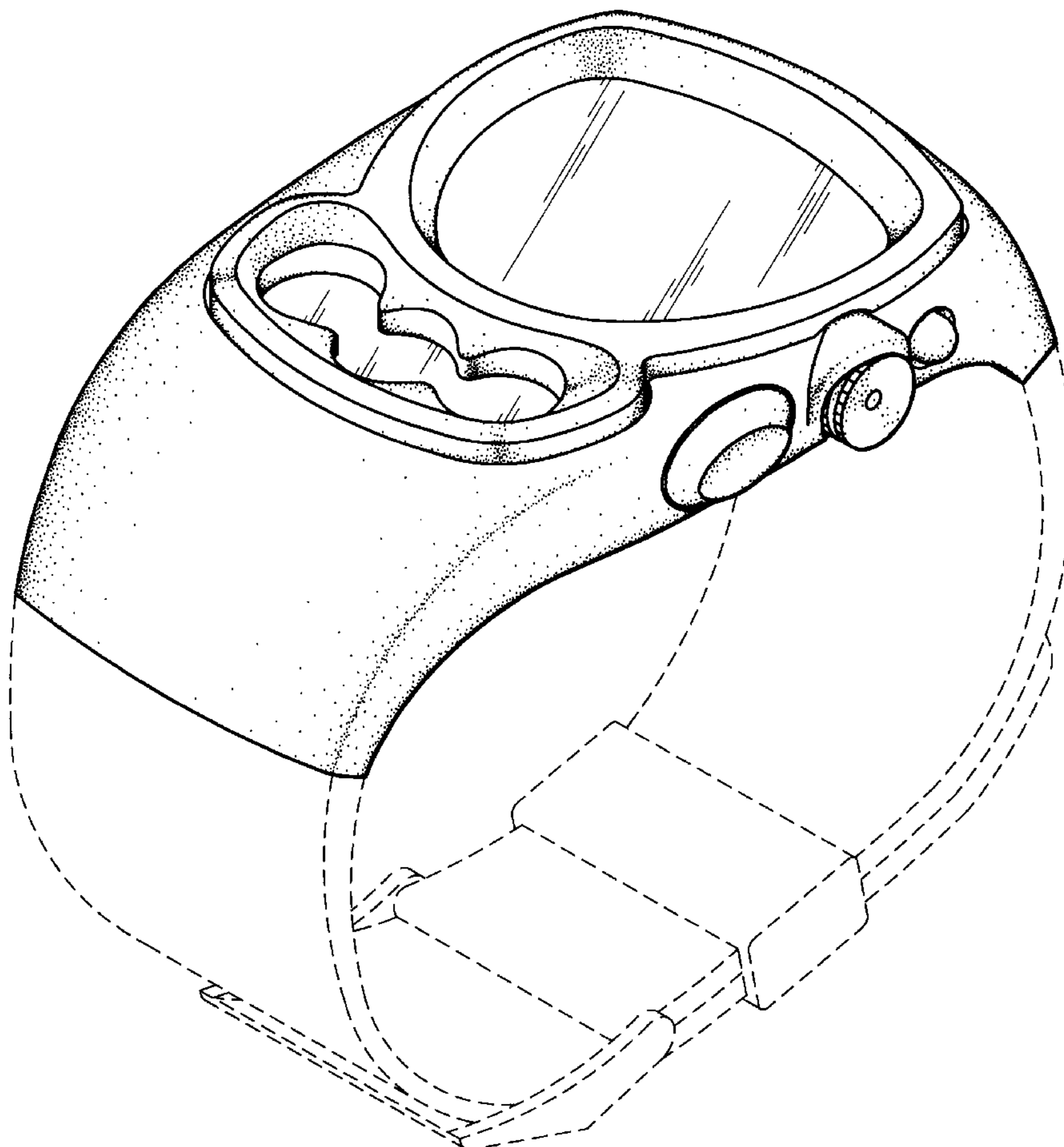
### [57] **CLAIM**

The ornamental design for a watch housing, as shown and described.

### **DESCRIPTION**

FIG. 1 is a perspective view of a watch housing in accordance with our invention;  
FIG. 2 is a front view of the watch housing of FIG. 1;  
FIG. 3 is a back view of the watch housing of FIG. 1;  
FIG. 4 is a left side view of the watch housing of FIG. 1;  
FIG. 5 is a right side view of the watch housing of FIG. 1;  
FIG. 6 is a top view of the watch housing of FIG. 1; and,  
FIG. 7 is a bottom view of the watch housing of FIG. 1.  
The broken lines show the watch band for illustrative purposes only and form no part of the claimed design.

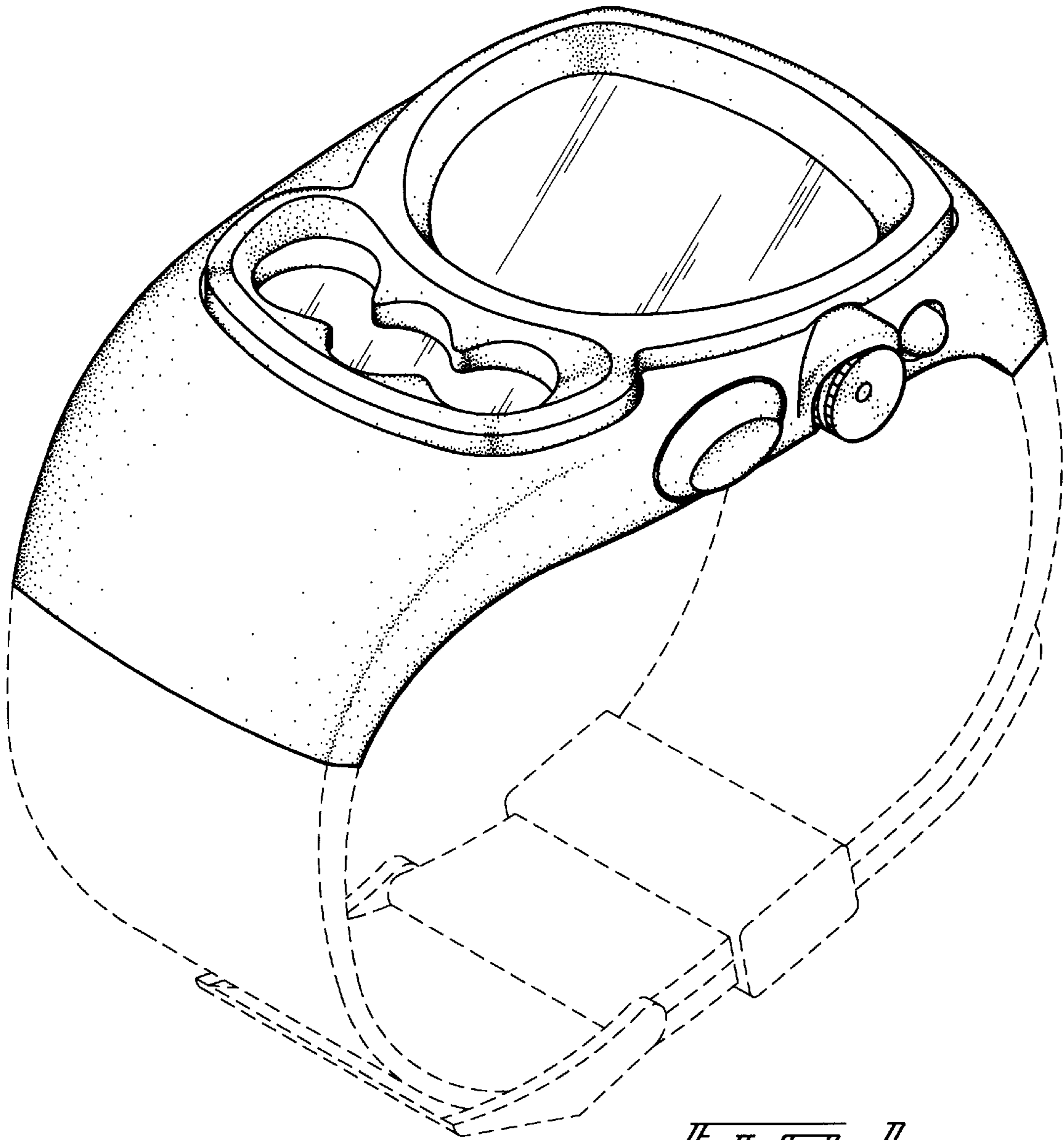

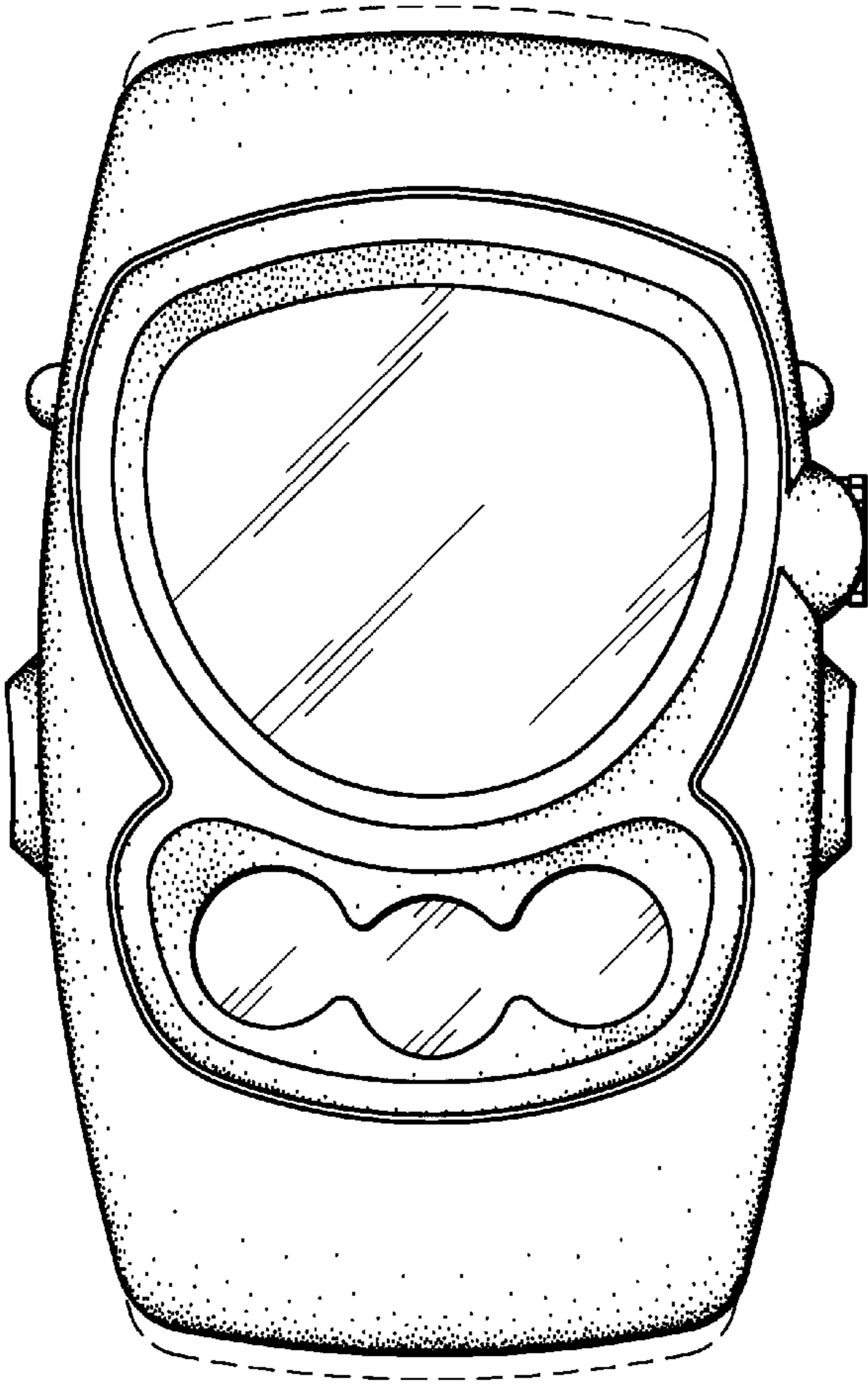

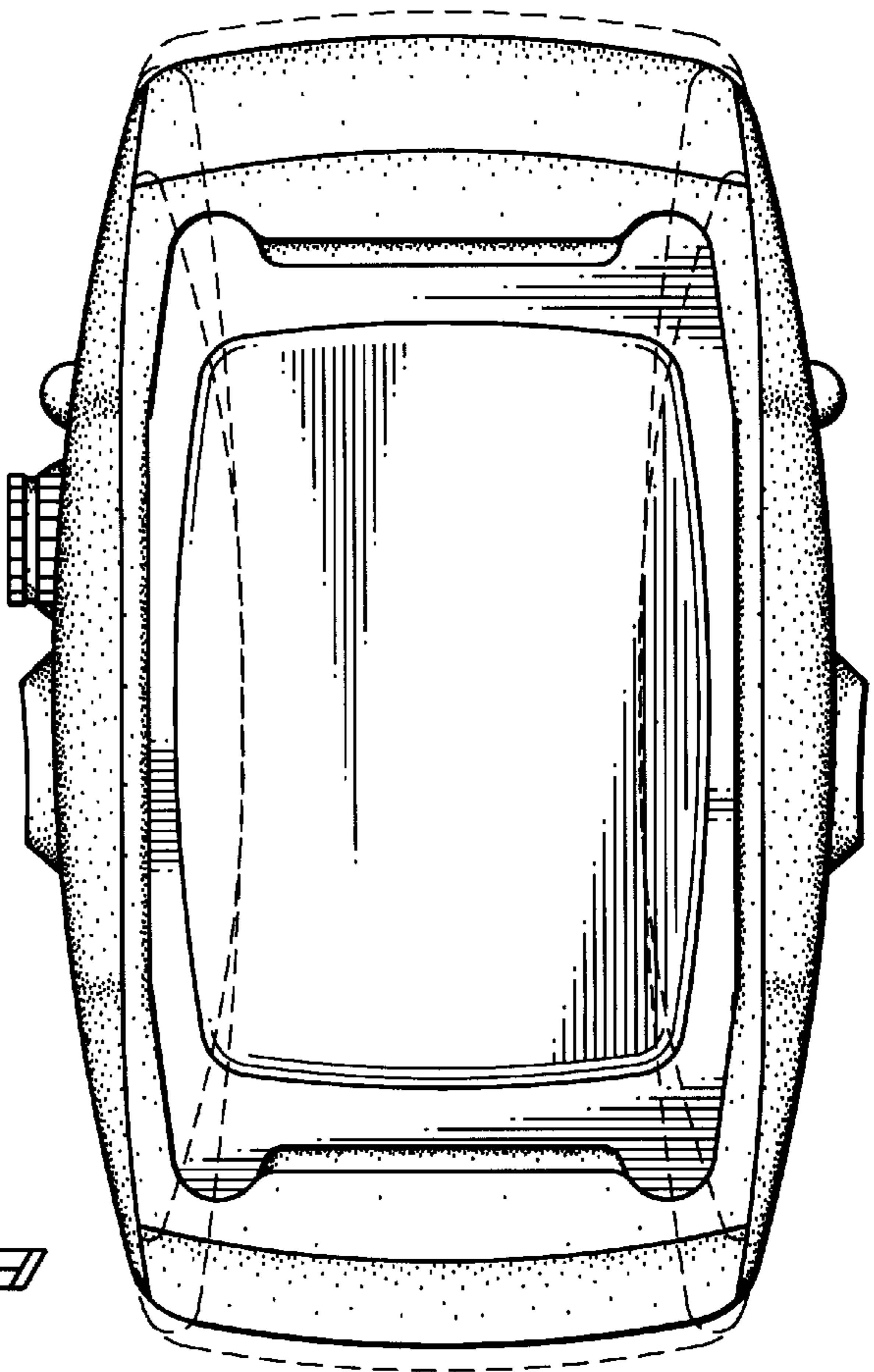

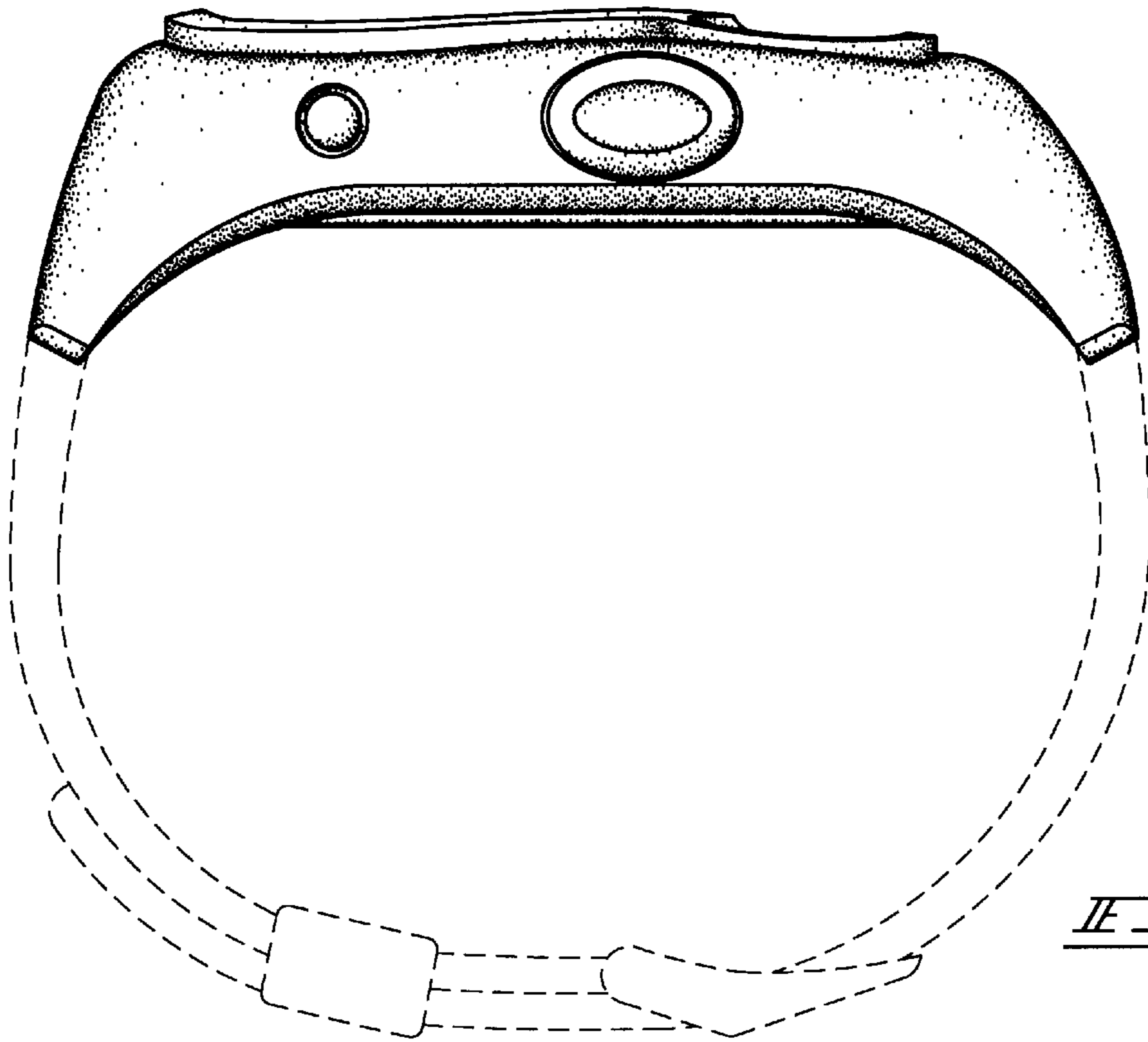

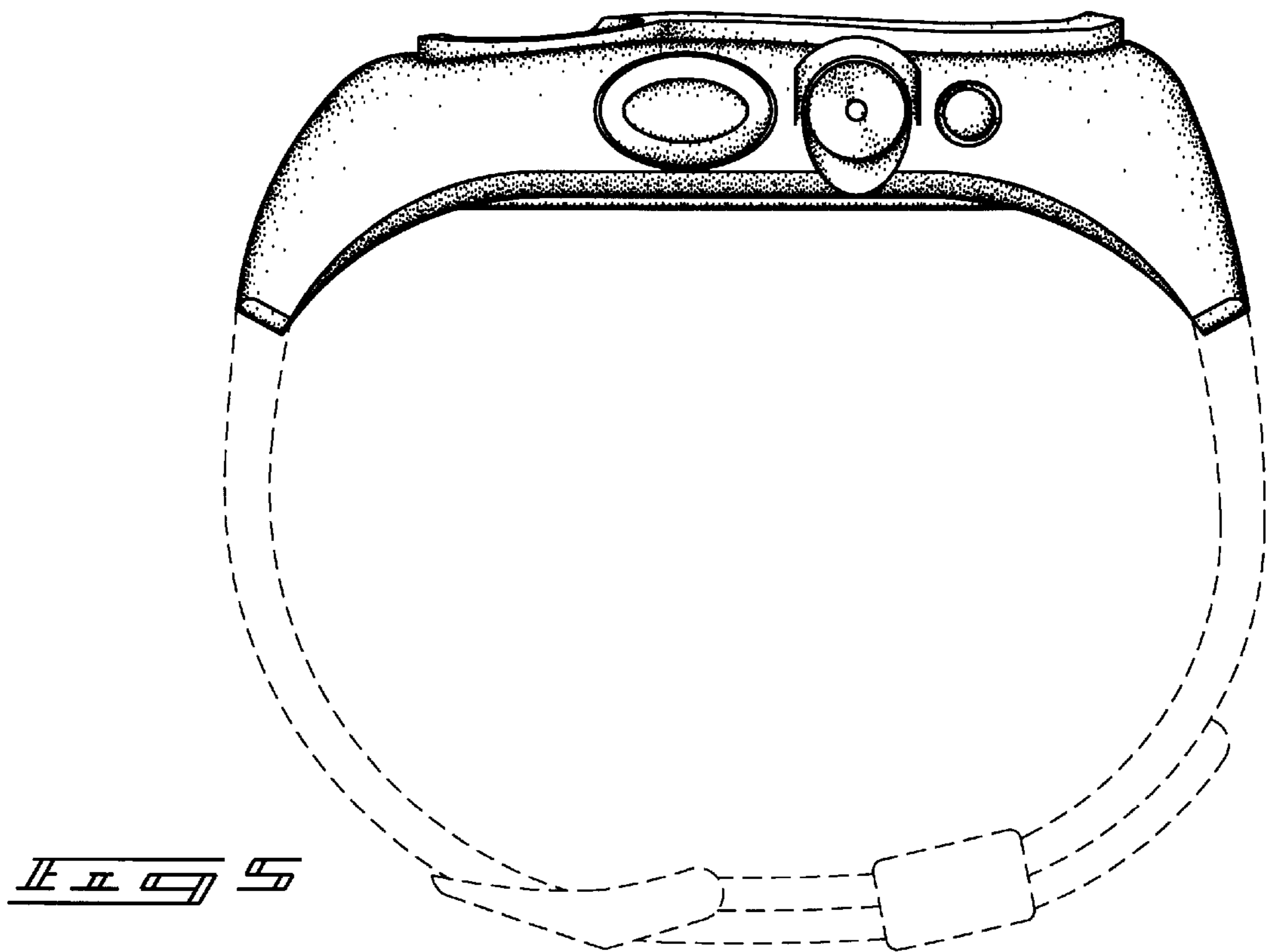

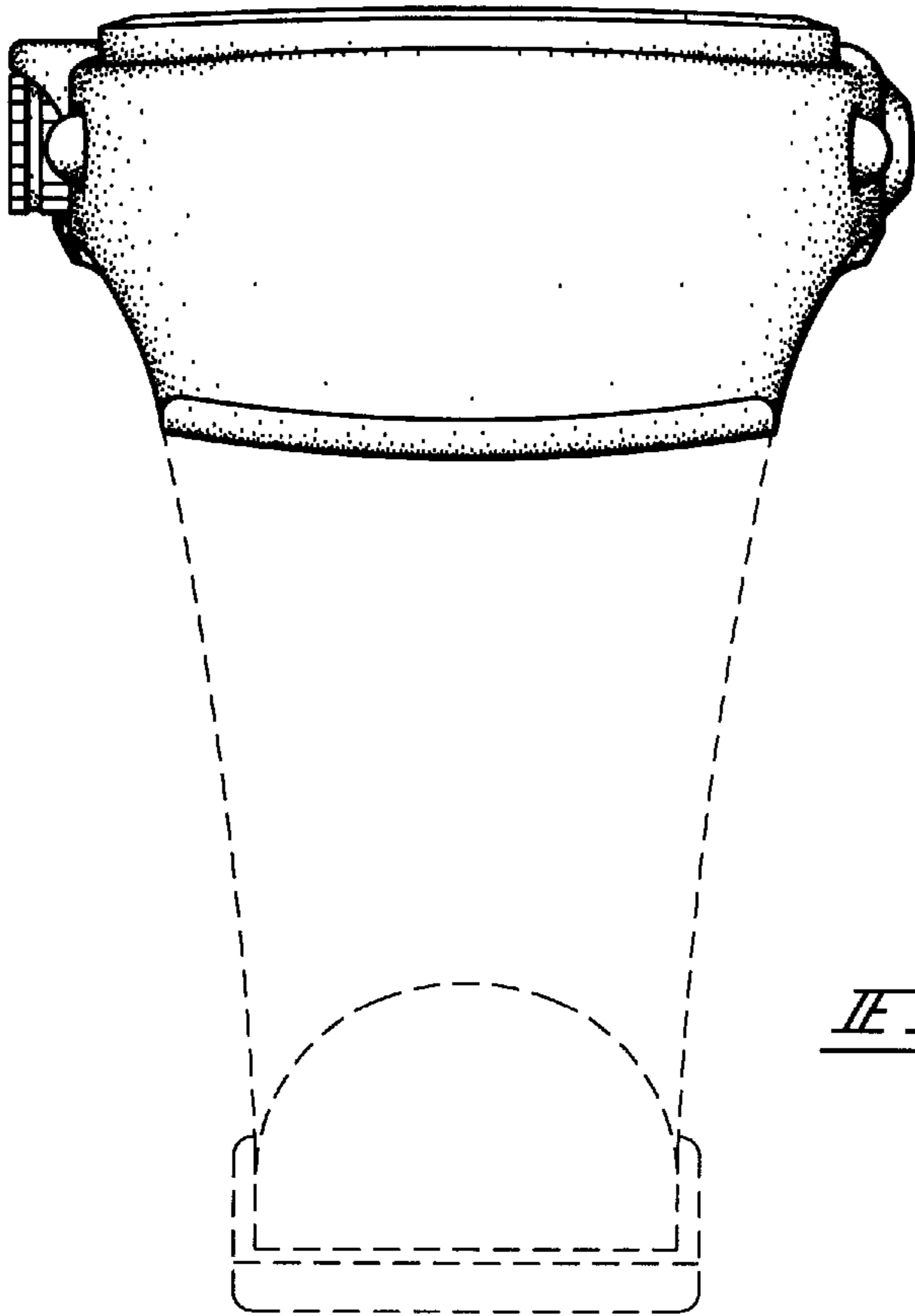

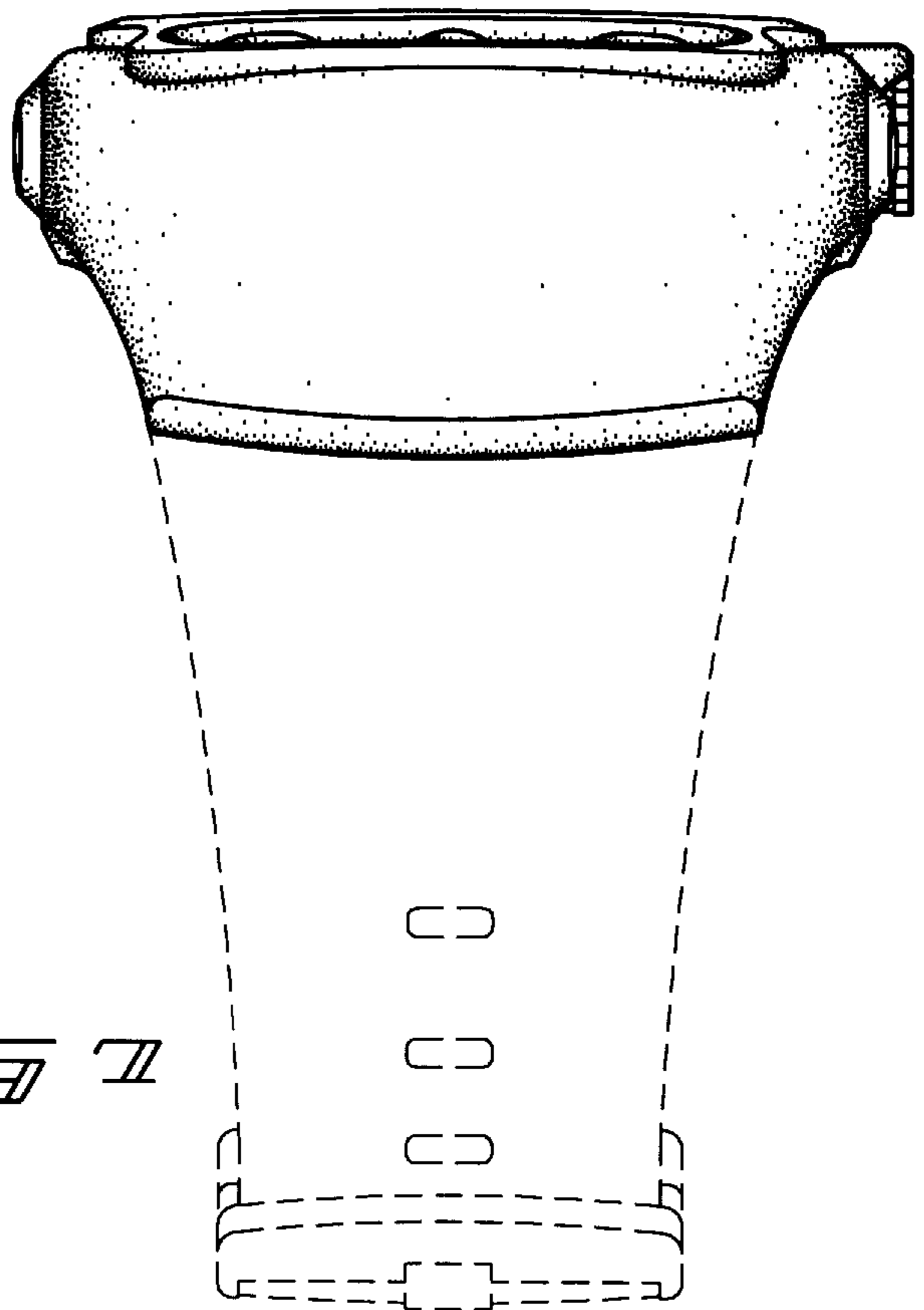
