[57] **CLAIM**

The ornamental design for a multi-triangular facet license plate frame, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevation view of a multi-triangular facet license plate frame showing my new design;  
FIG. 2 is a top plan view, the bottom plan view being the same;  
FIG. 3 is a left side elevation view, the right side elevation view being the mirror image thereof;  
FIG. 4 is a rear elevation view thereof;  
FIG. 5 is a front elevational view of a second embodiment;  
FIG. 6 is a top plan view of FIG. 5;  
FIG. 7 is a bottom plan view of FIG. 5;  
FIG. 8 is a left side elevation view of FIG. 5, the right side elevation view being the mirror image thereof;  
FIG. 9 is a rear elevation view of FIG. 5;  
FIG. 10 is a front elevation view of a third embodiment;  
FIG. 11 is a top plan view of FIG. 10;  
FIG. 12 is a bottom plan view of FIG. 10;  
FIG. 13 is a left side elevation view of FIG. 10, the right side elevation view being the mirror image thereof; and,  
FIG. 14 is a rear elevational view of FIG. 10.

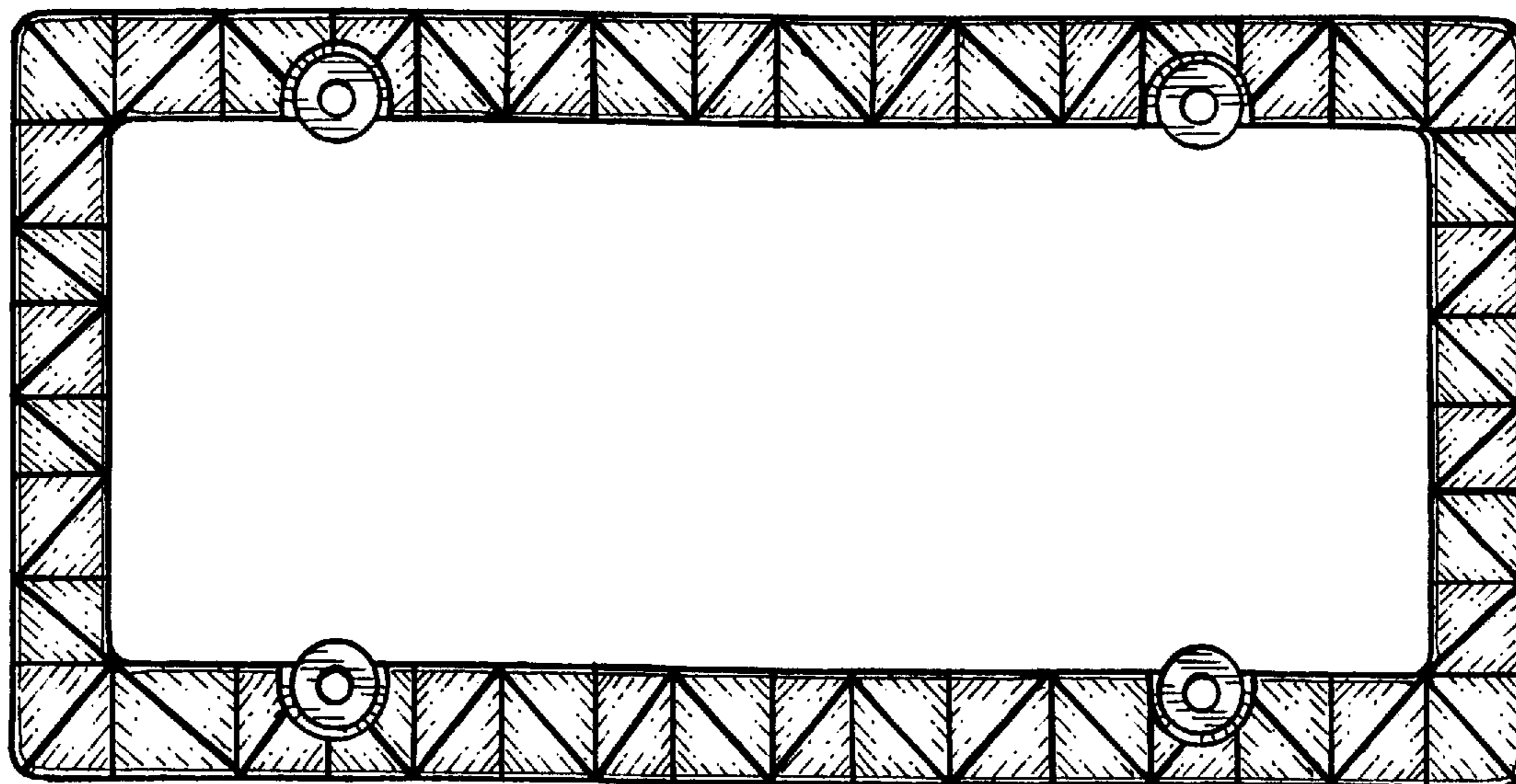

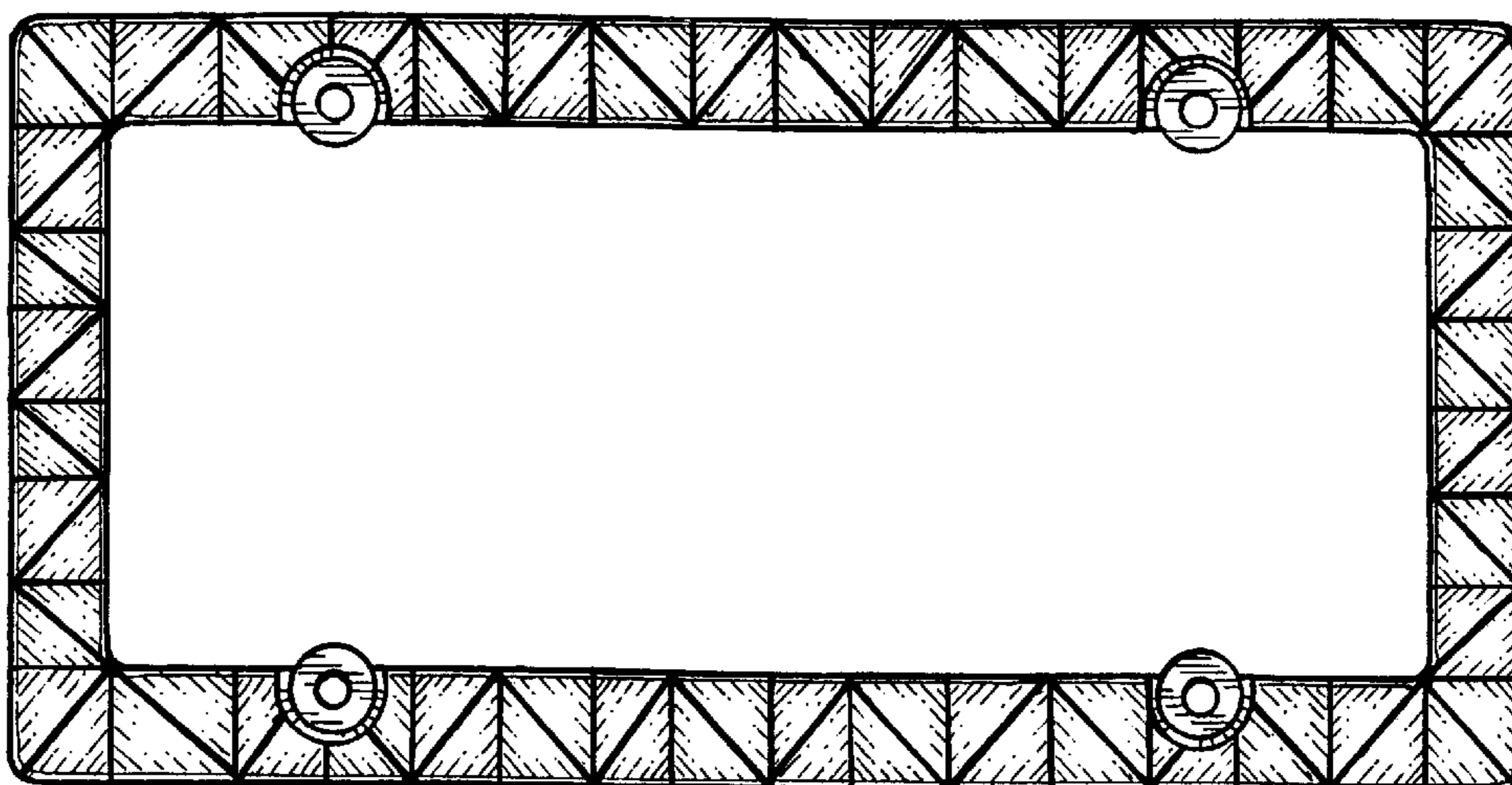

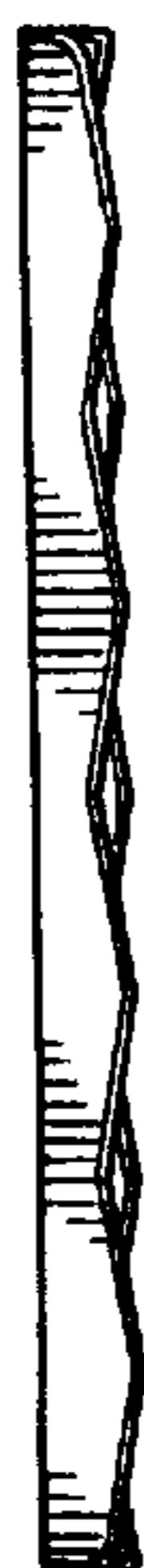

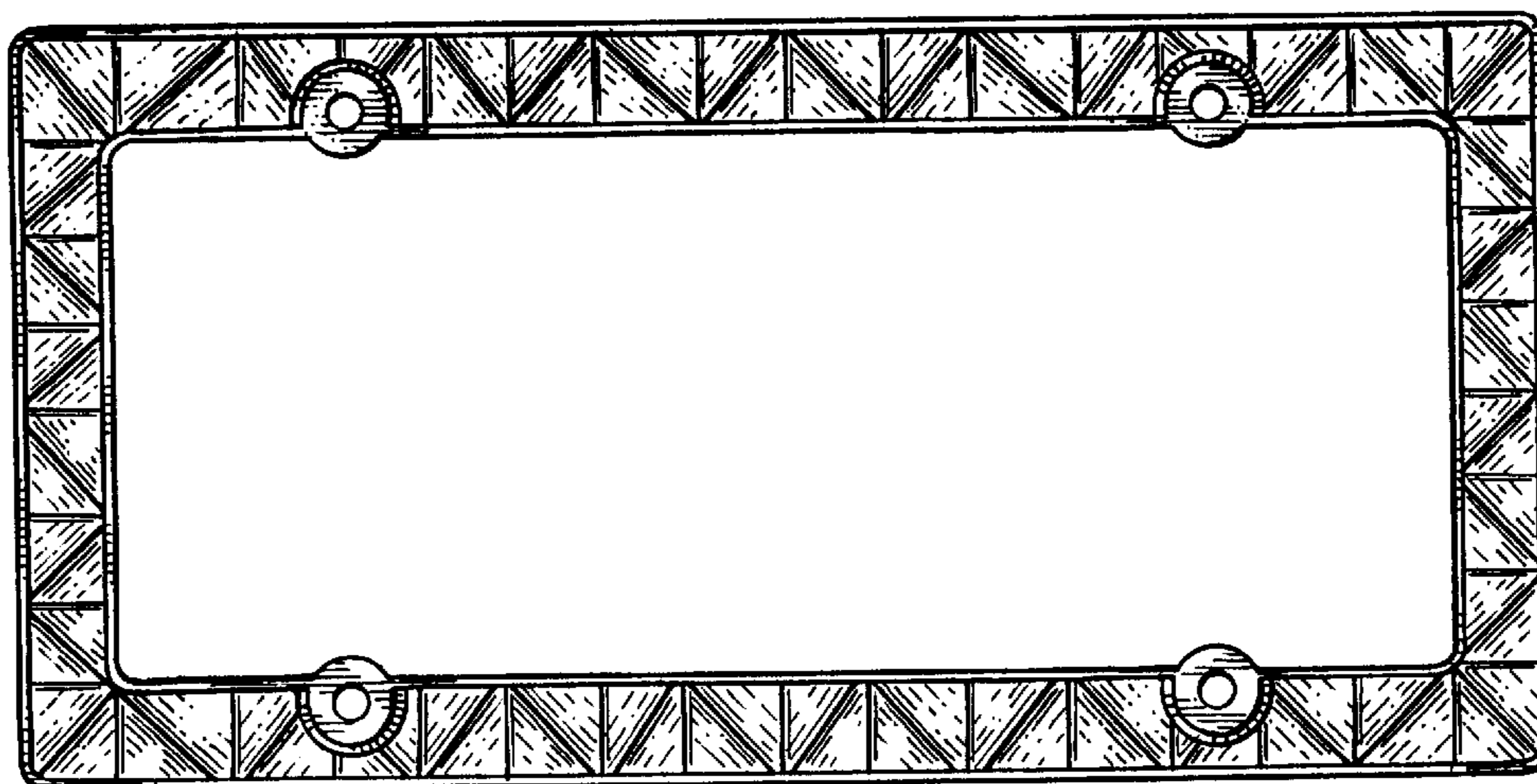

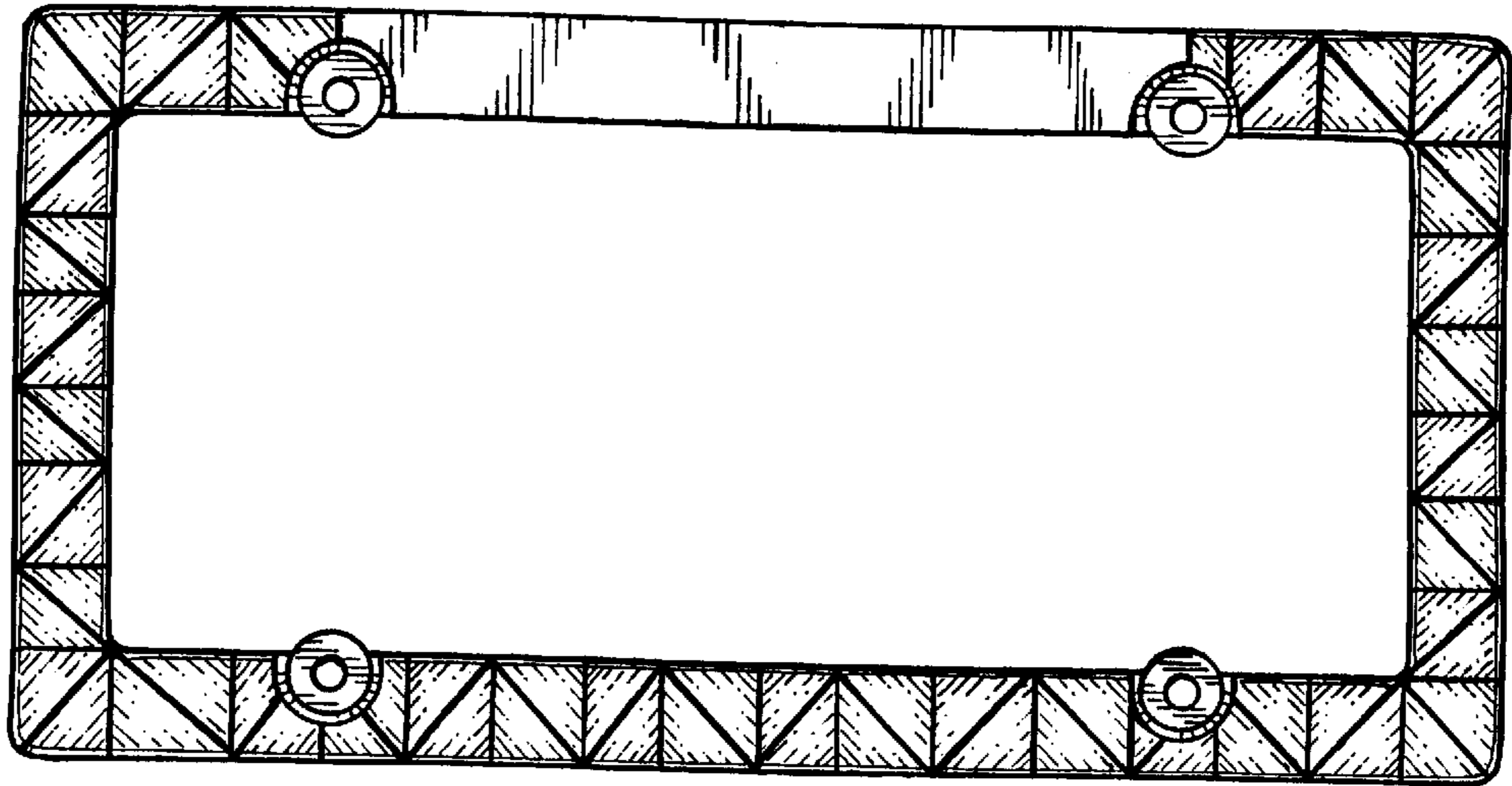

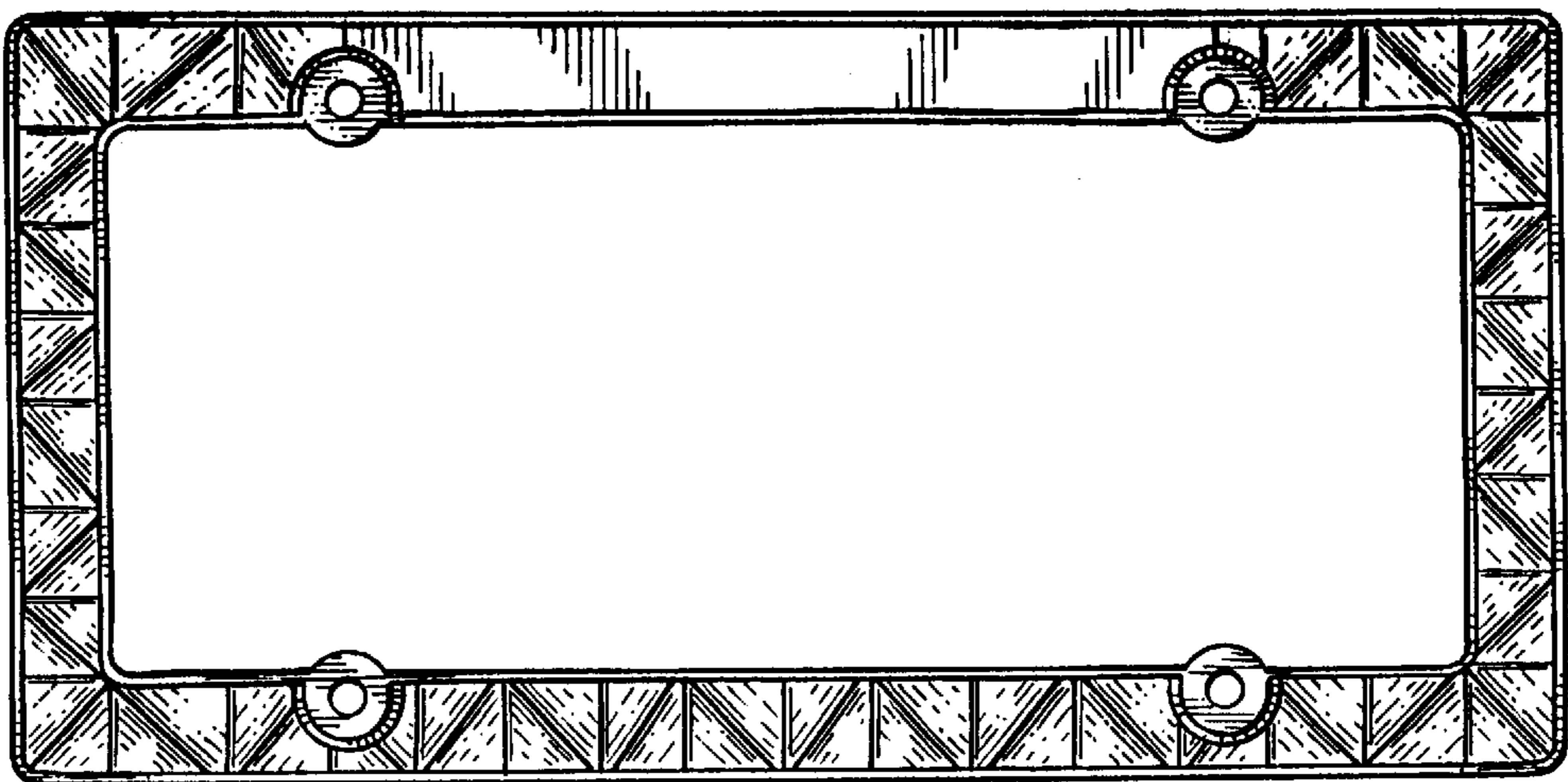

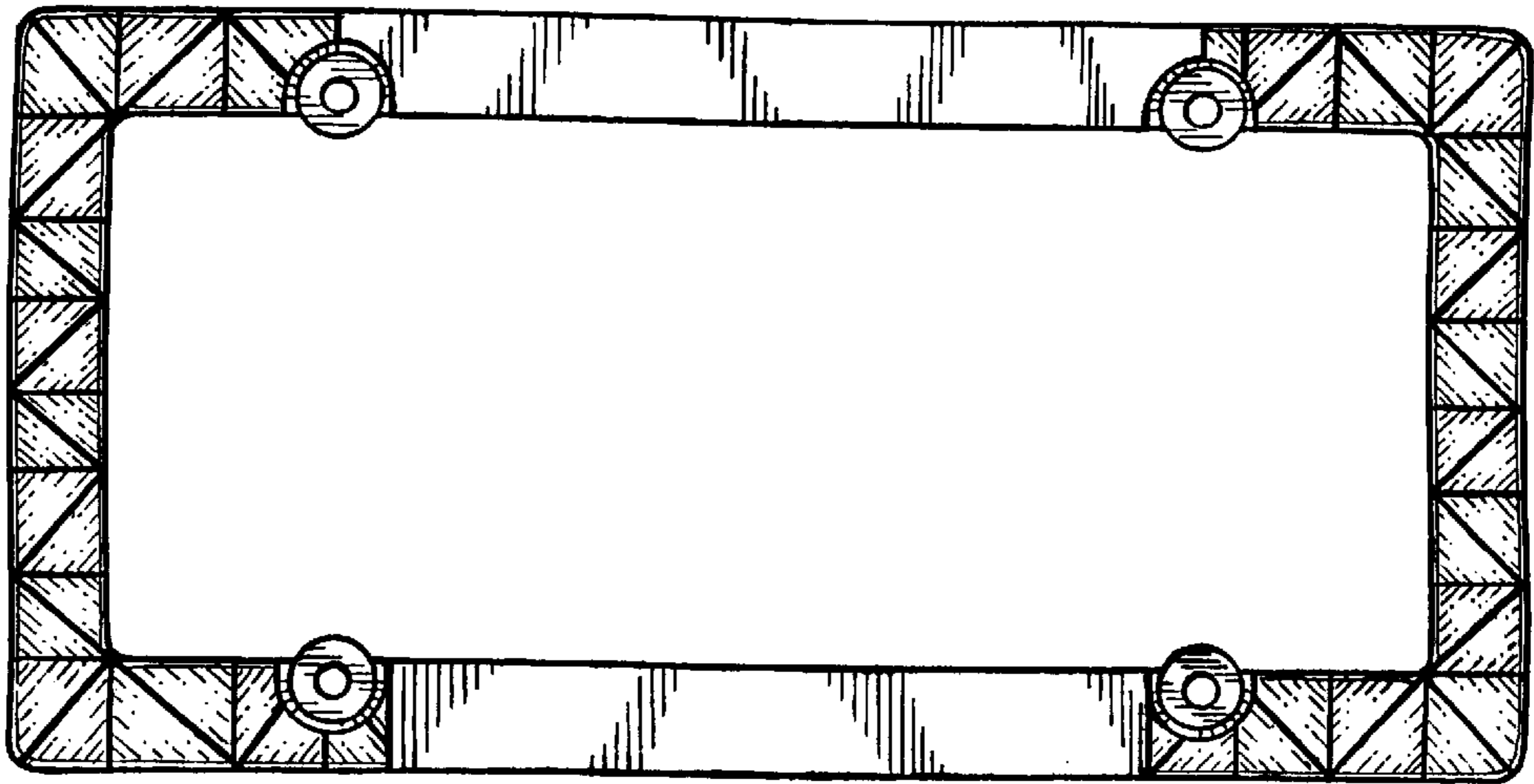

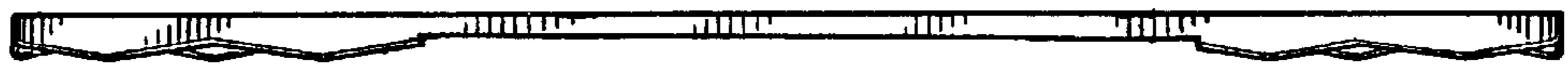
