The ornamental design for an electronic computer, as shown and described.

DESCRIPTION

FIG. 1 is a top, front and right side perspective view of an electronic computer showing my new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a top plan view thereof;
FIG. 5 is a left side elevational view thereof;
FIG. 6 is a right side elevational view thereof;
FIG. 7 is a bottom plan view thereof;
FIG. 8 is a top plan view thereof in a closed position;
FIG. 9 is a front elevational view thereof in the closed position; and,
FIG. 10 is a right side elevational view thereof in the closed position.

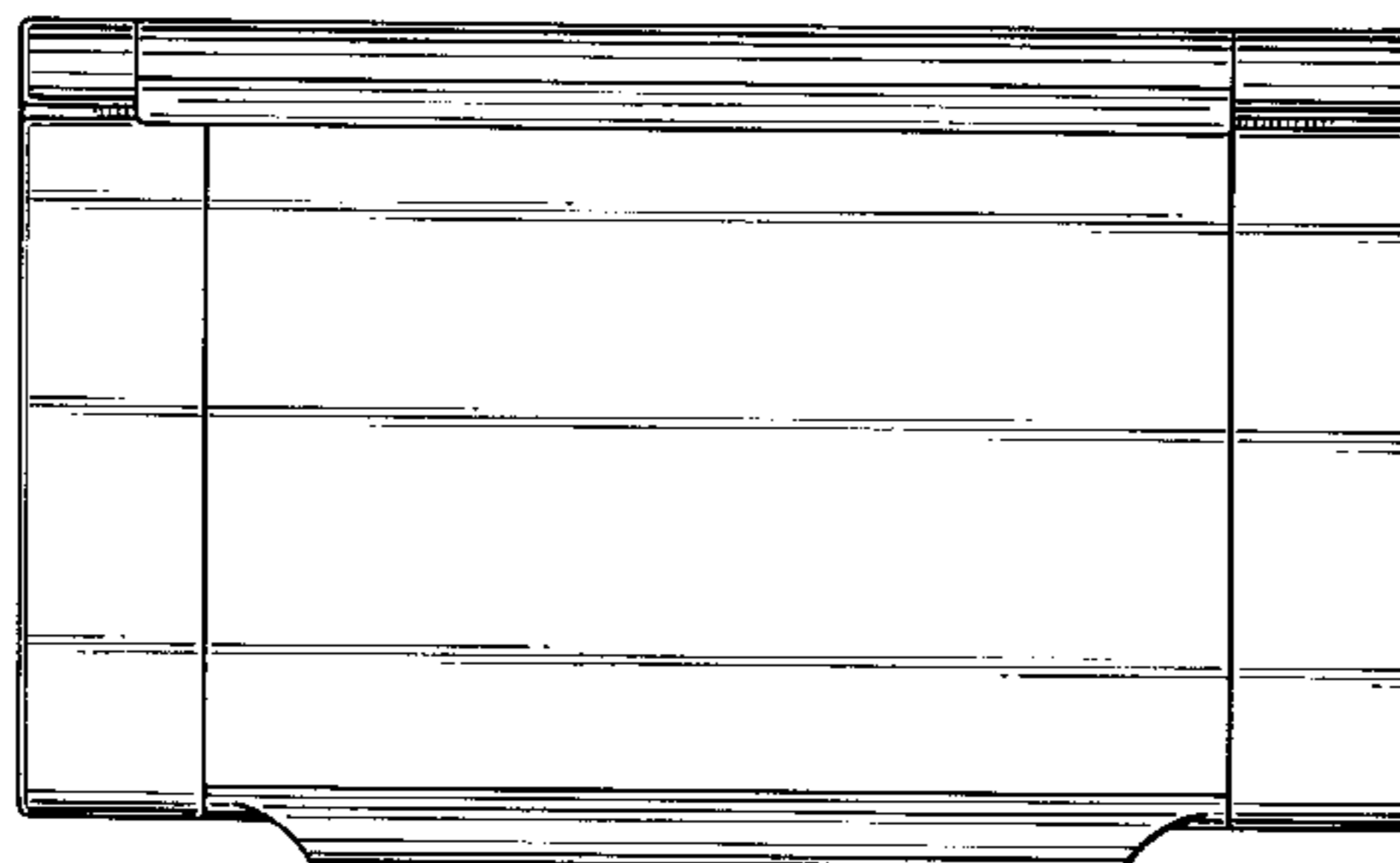
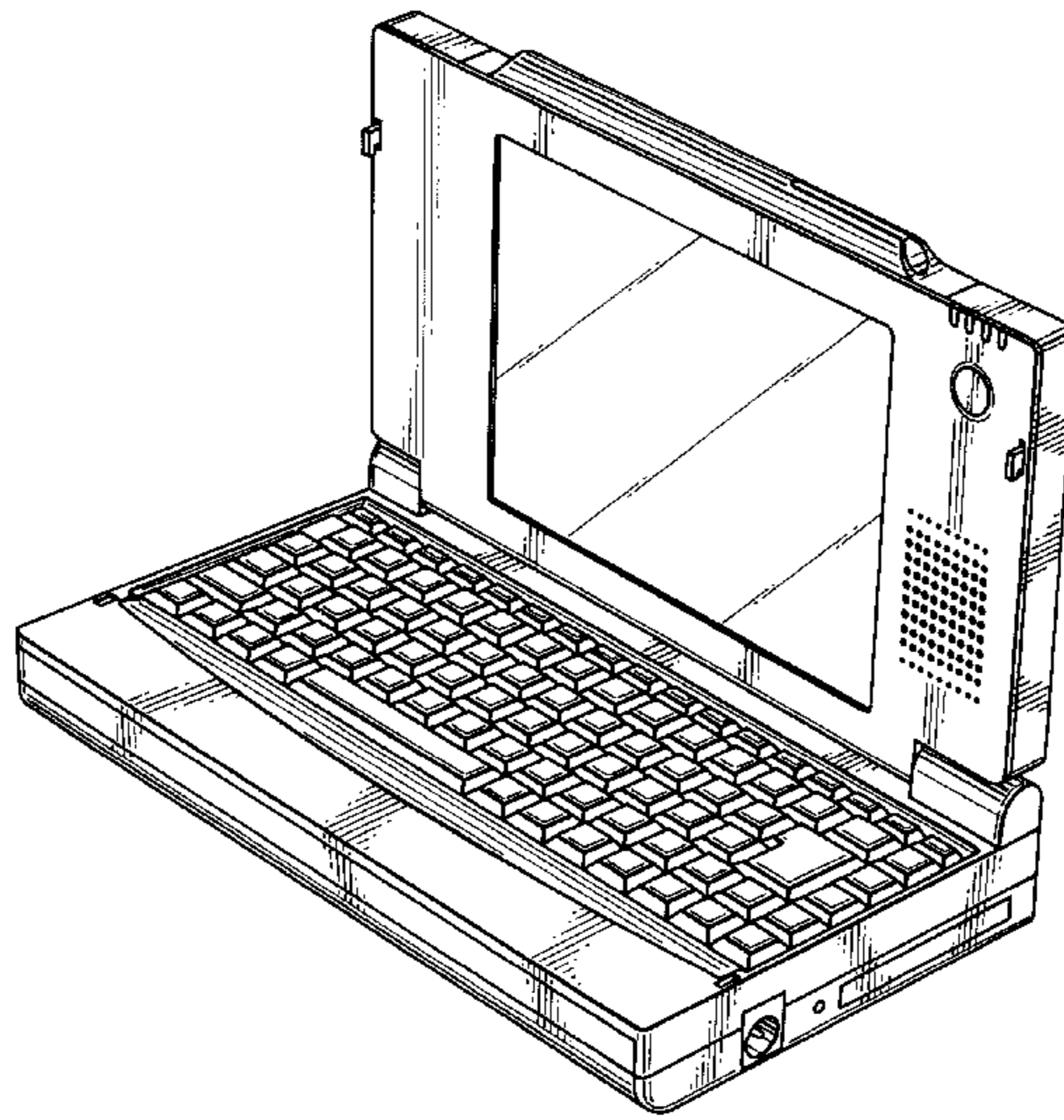

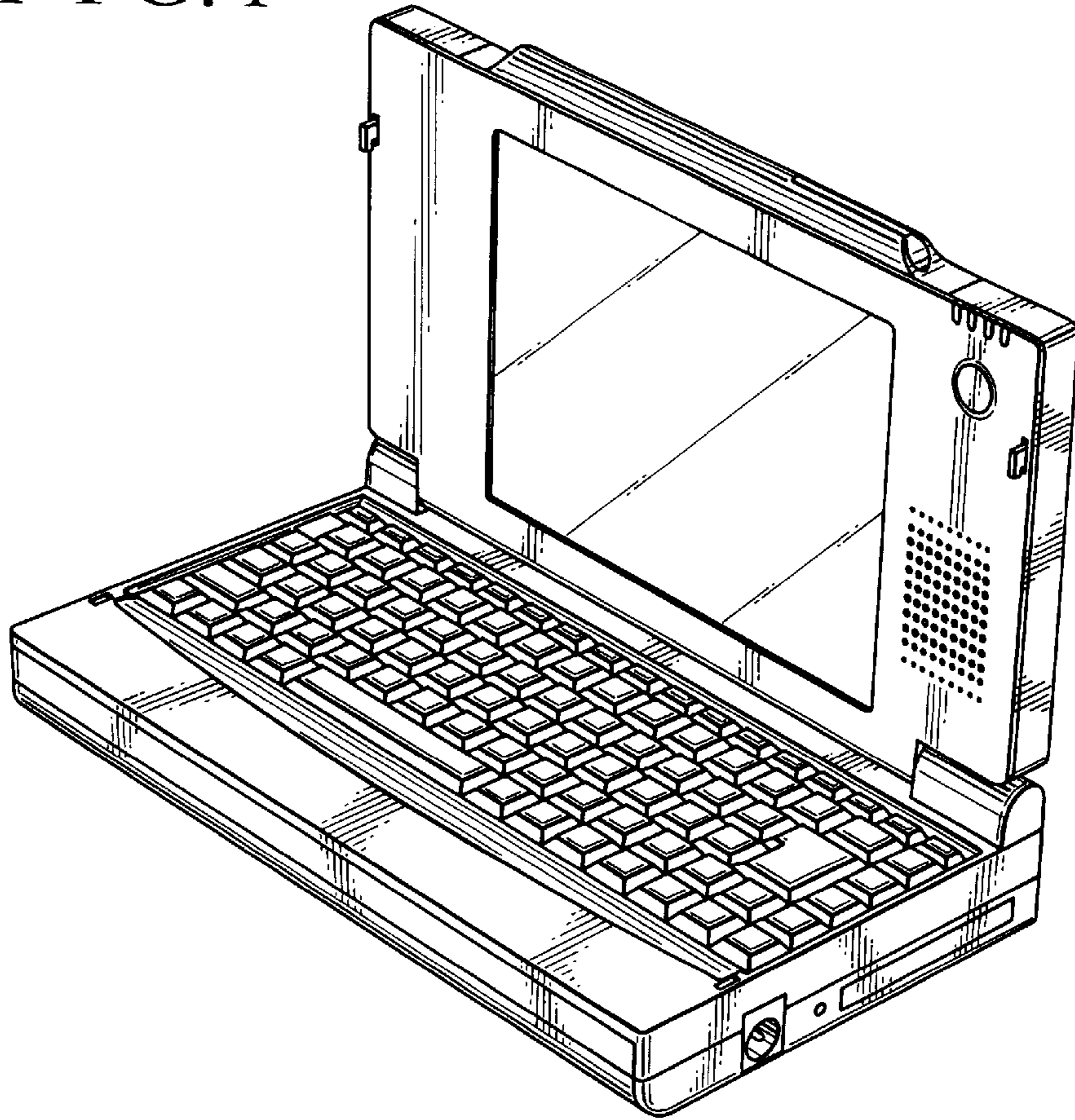

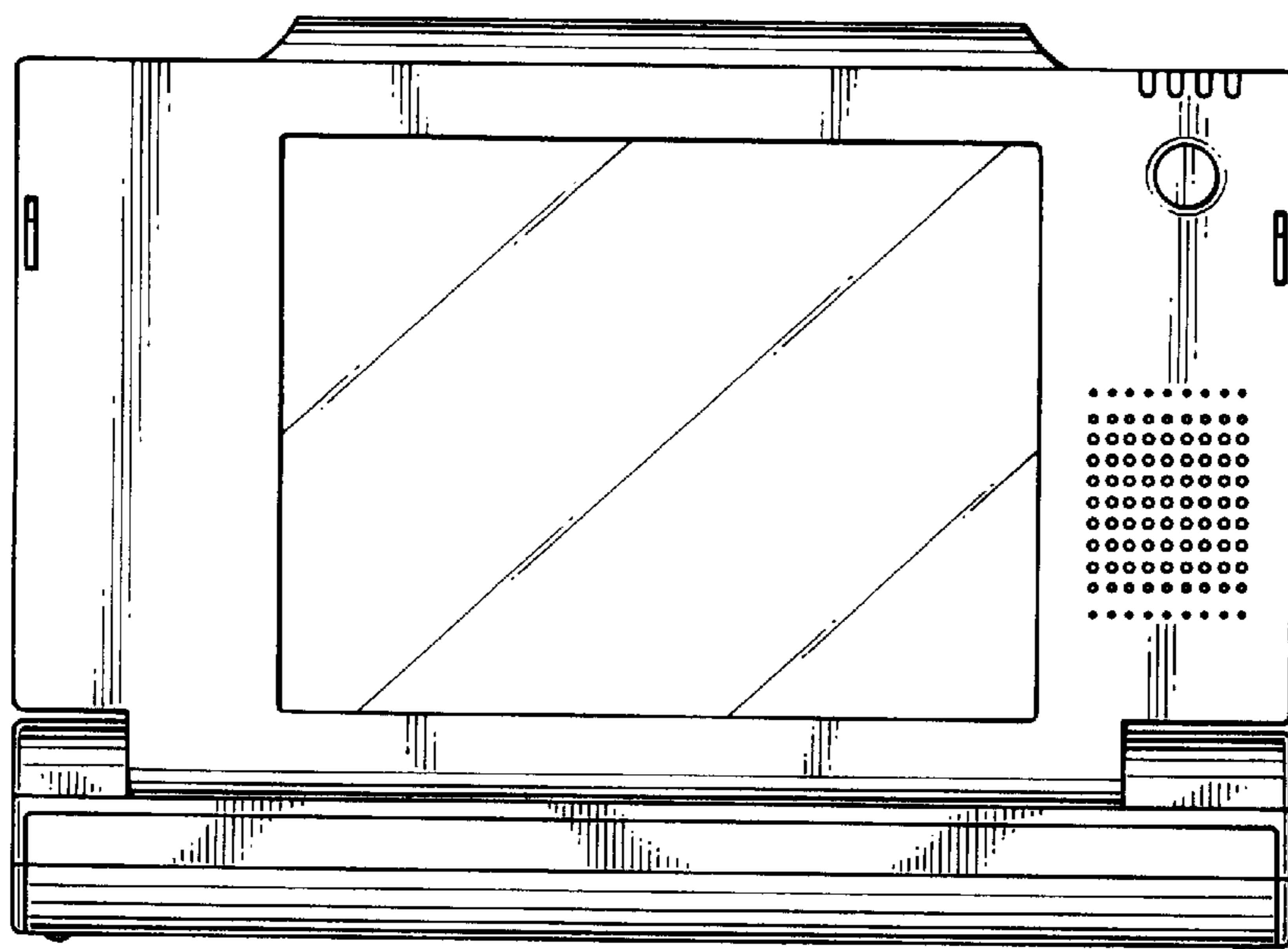

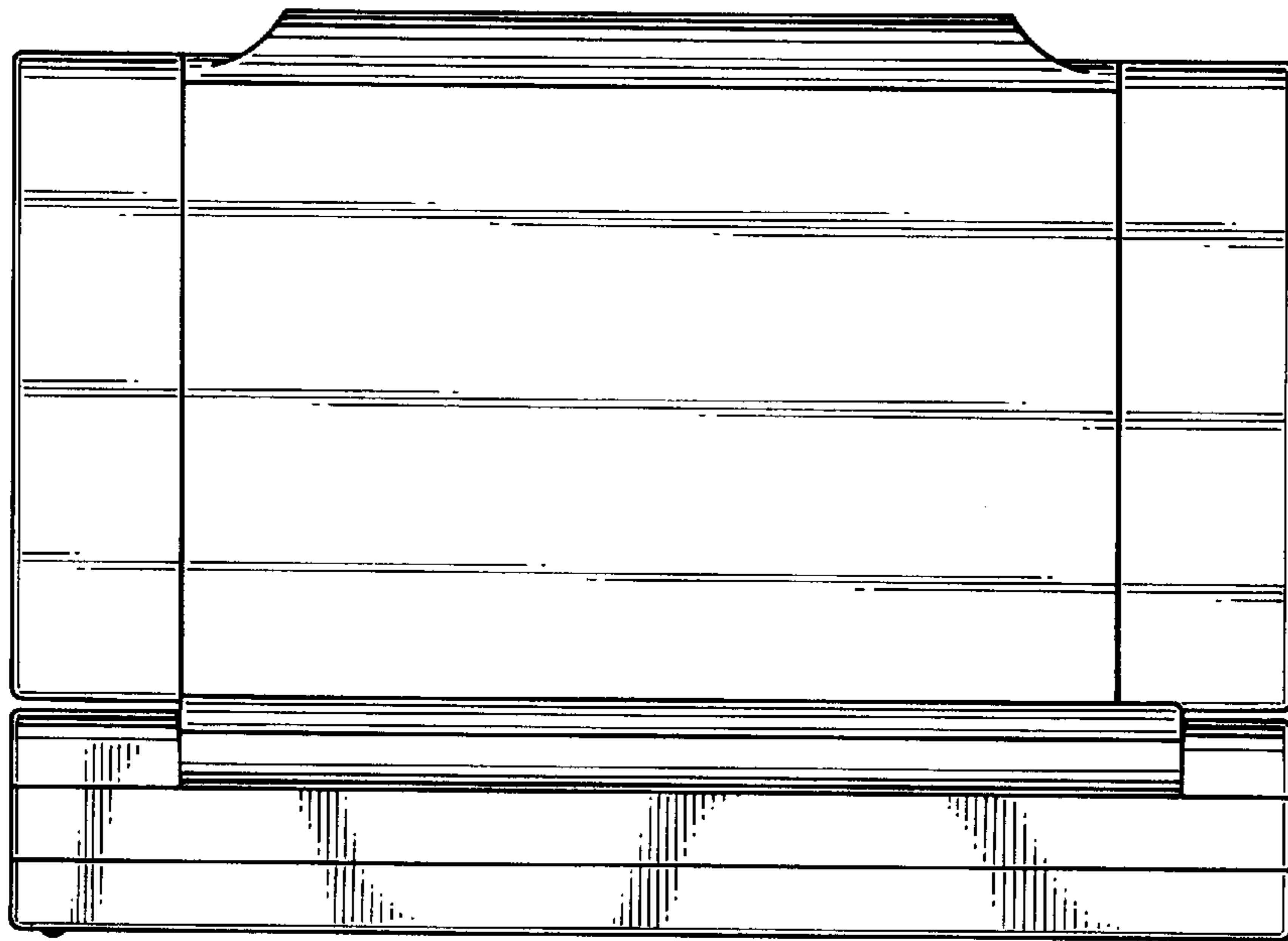

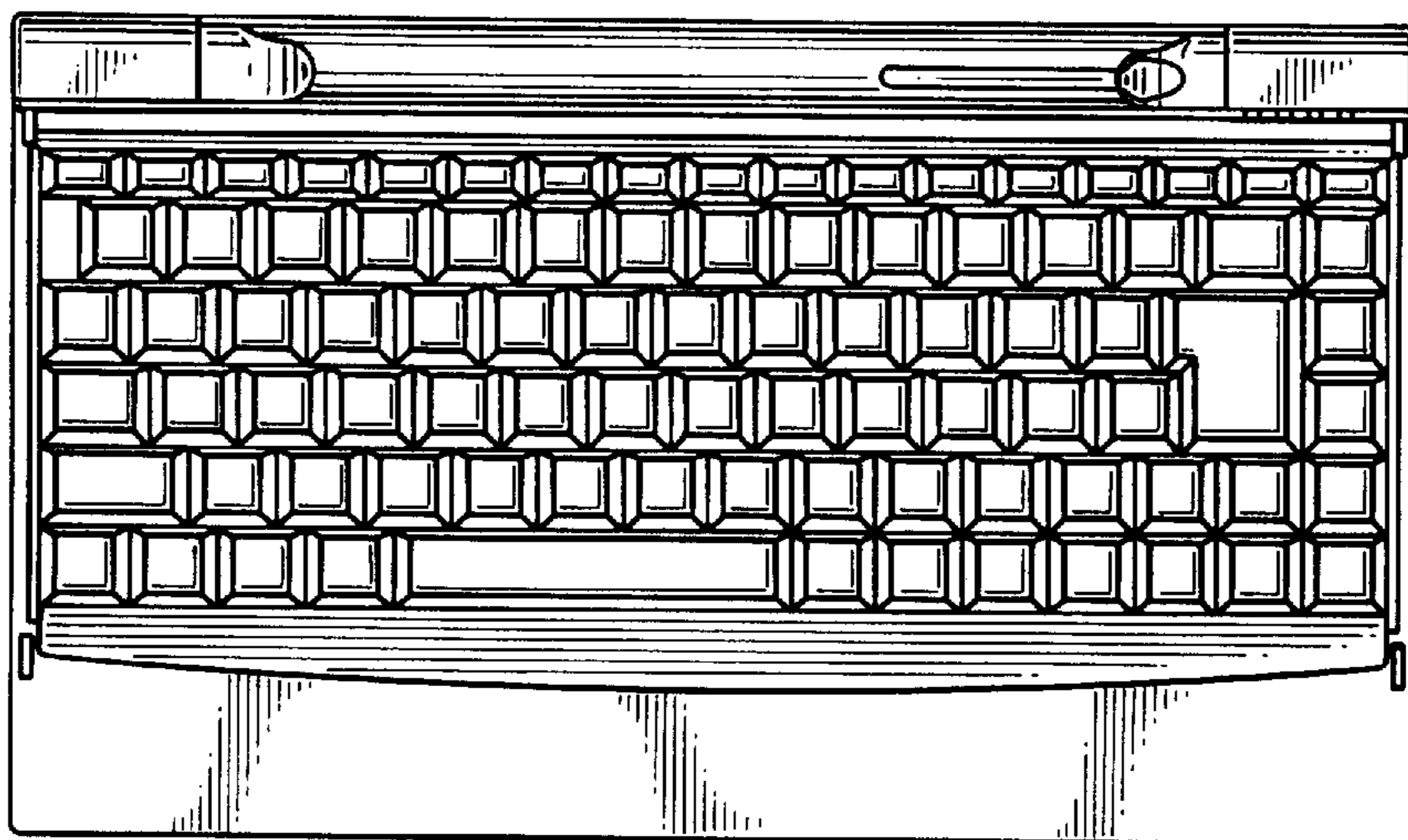

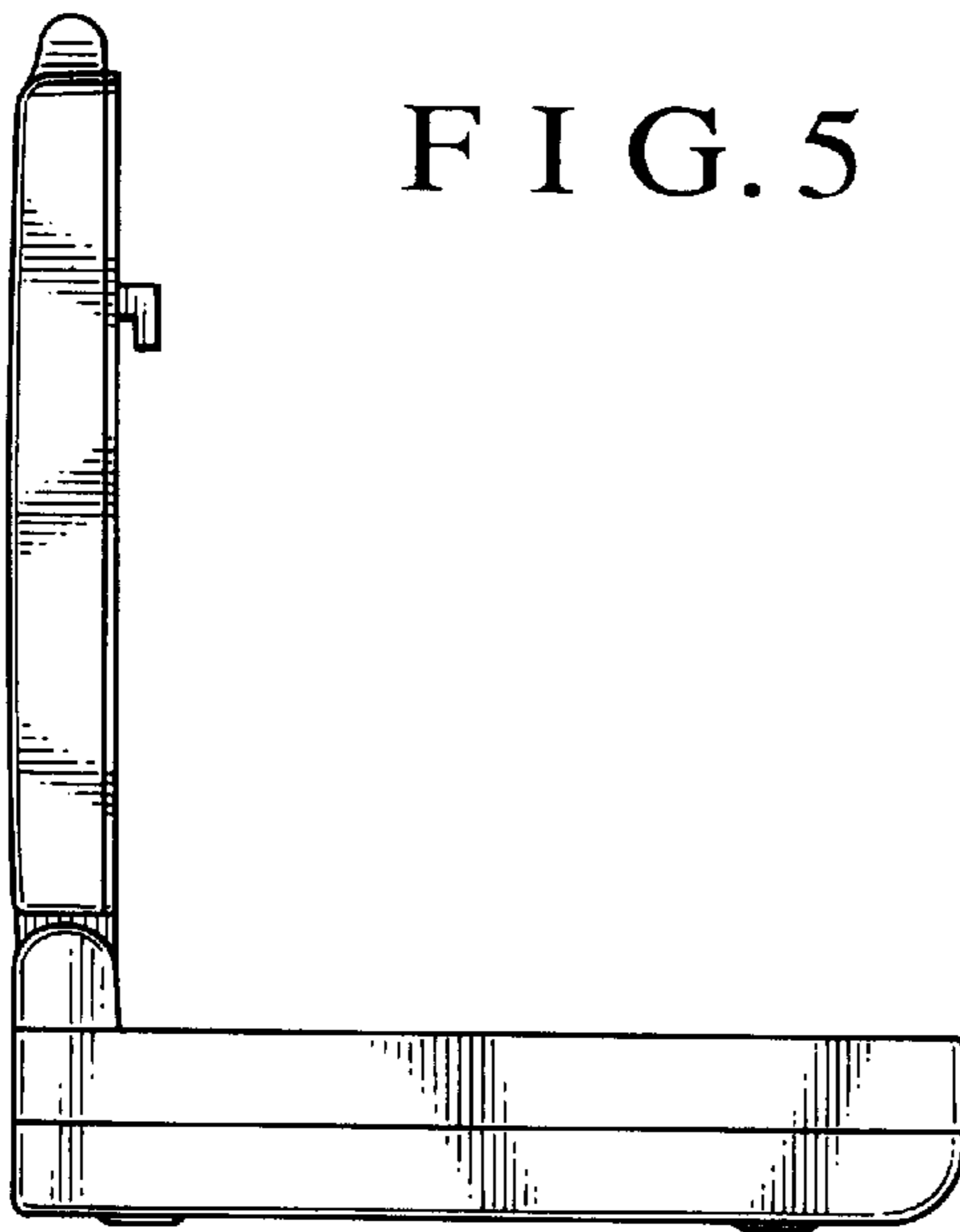

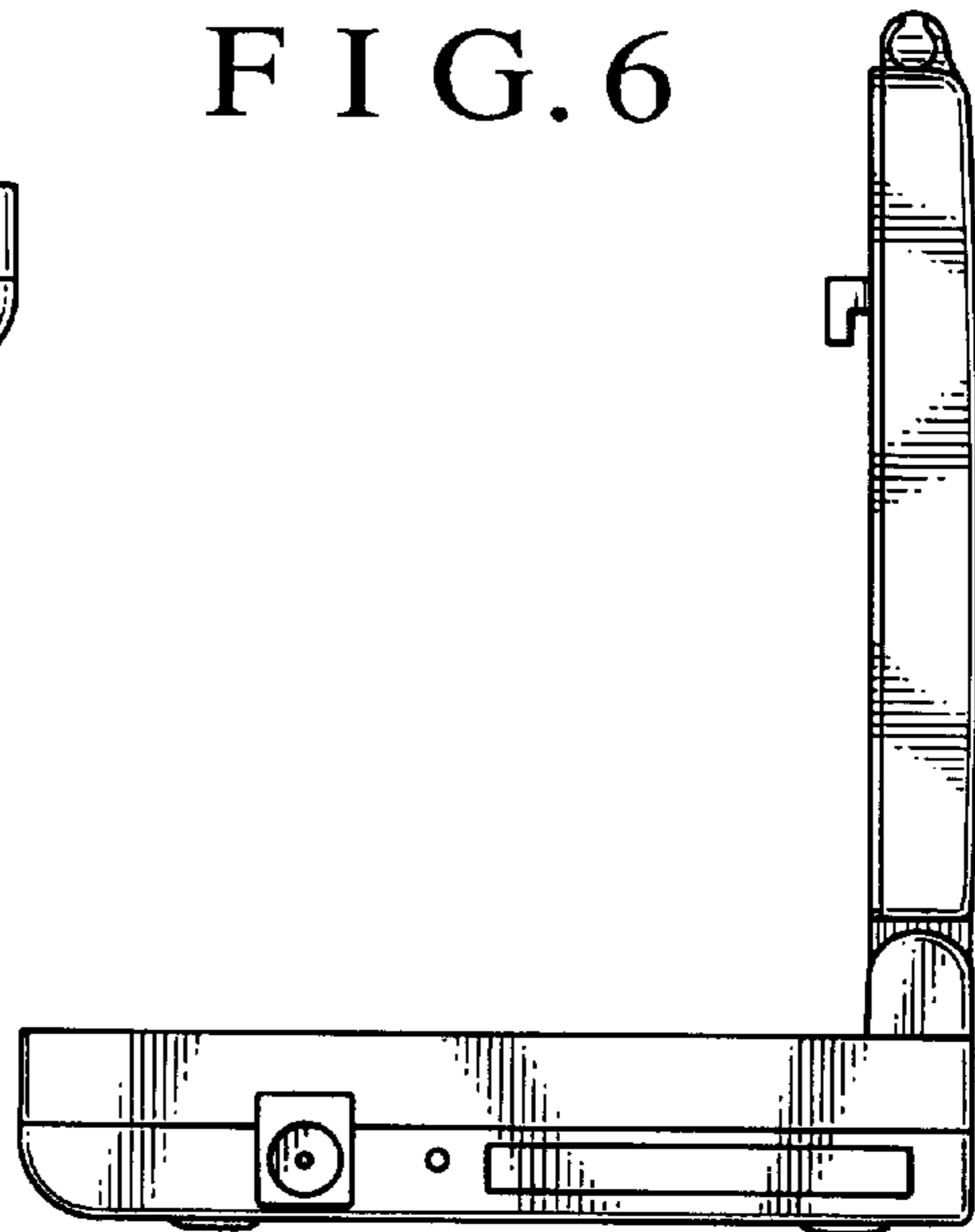

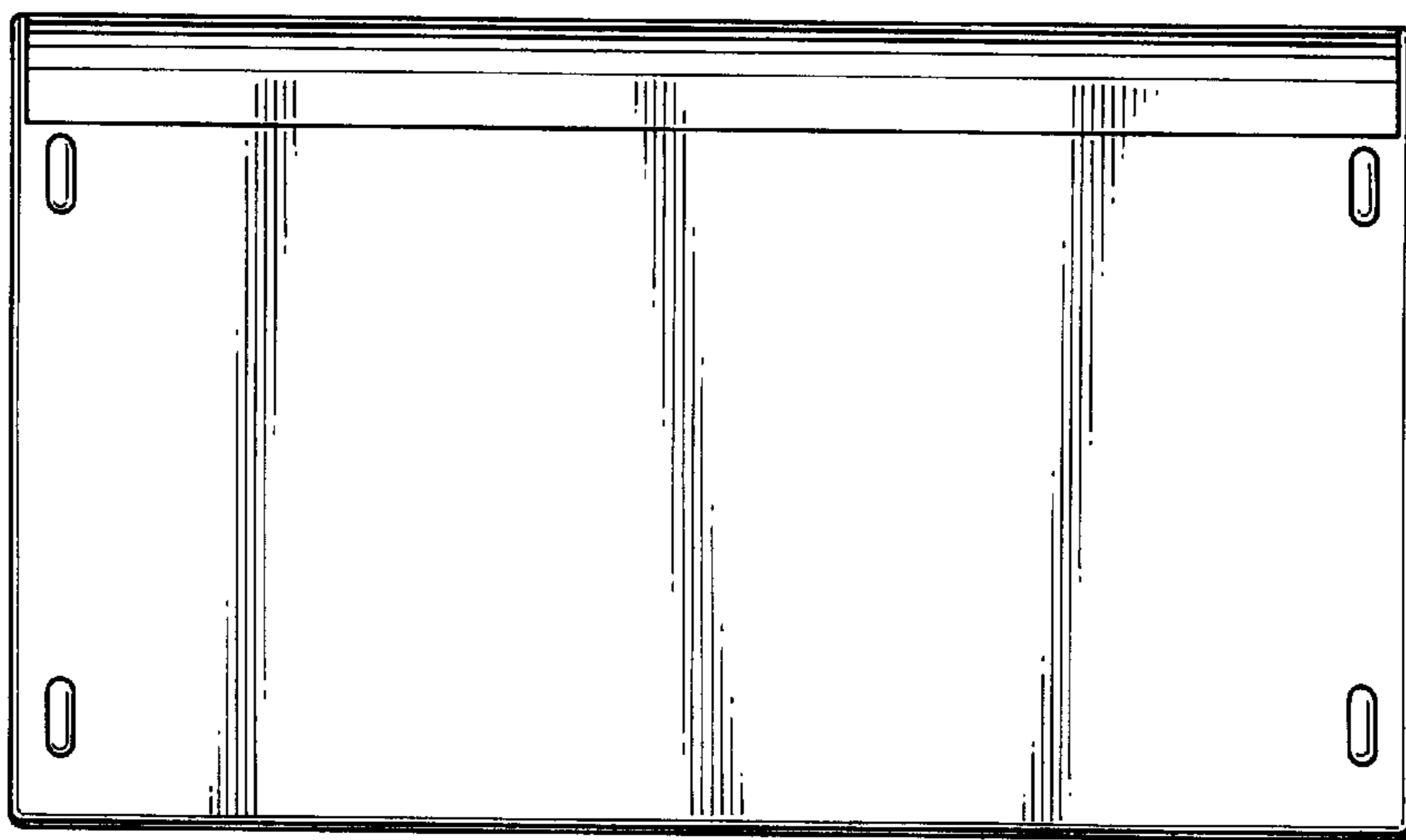

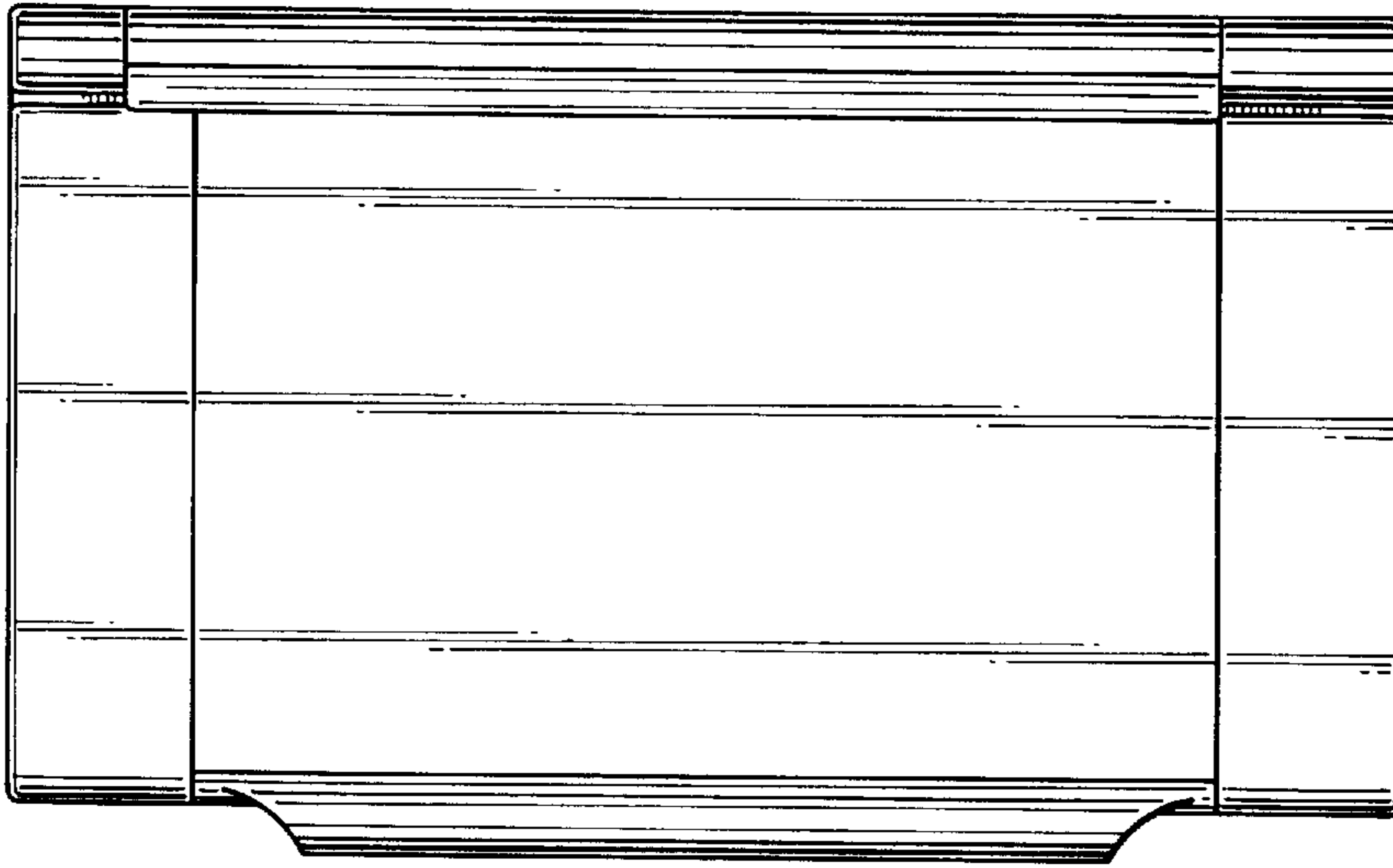

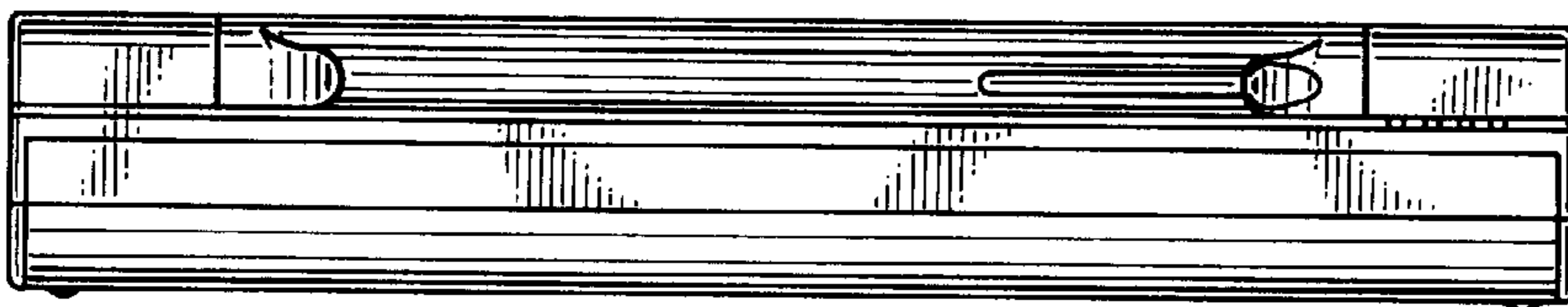
