[57] **CLAIM**

The ornamental design for a portable character/image editing unit, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a portable character/image editing unit showing my new design; FIG. 2 is a top plan view thereof; FIG. 3 is a top end elevational view thereof; FIG. 4 is a bottom end elevational view thereof; FIG. 5 is a left side elevational view thereof; FIG. 6 is a right side elevational view thereof; FIG. 7 is a bottom plan view thereof; FIG. 8 is a top plan view thereof shown in the folded state; FIG. 9 is a right side elevational view thereof; FIG. 10 is a top end elevational view thereof; FIG. 11 is a bottom end elevational view thereof; and, FIG. 12 is a top bottom end and left side perspective view thereof showing a pen storage section in a withdrawn state.

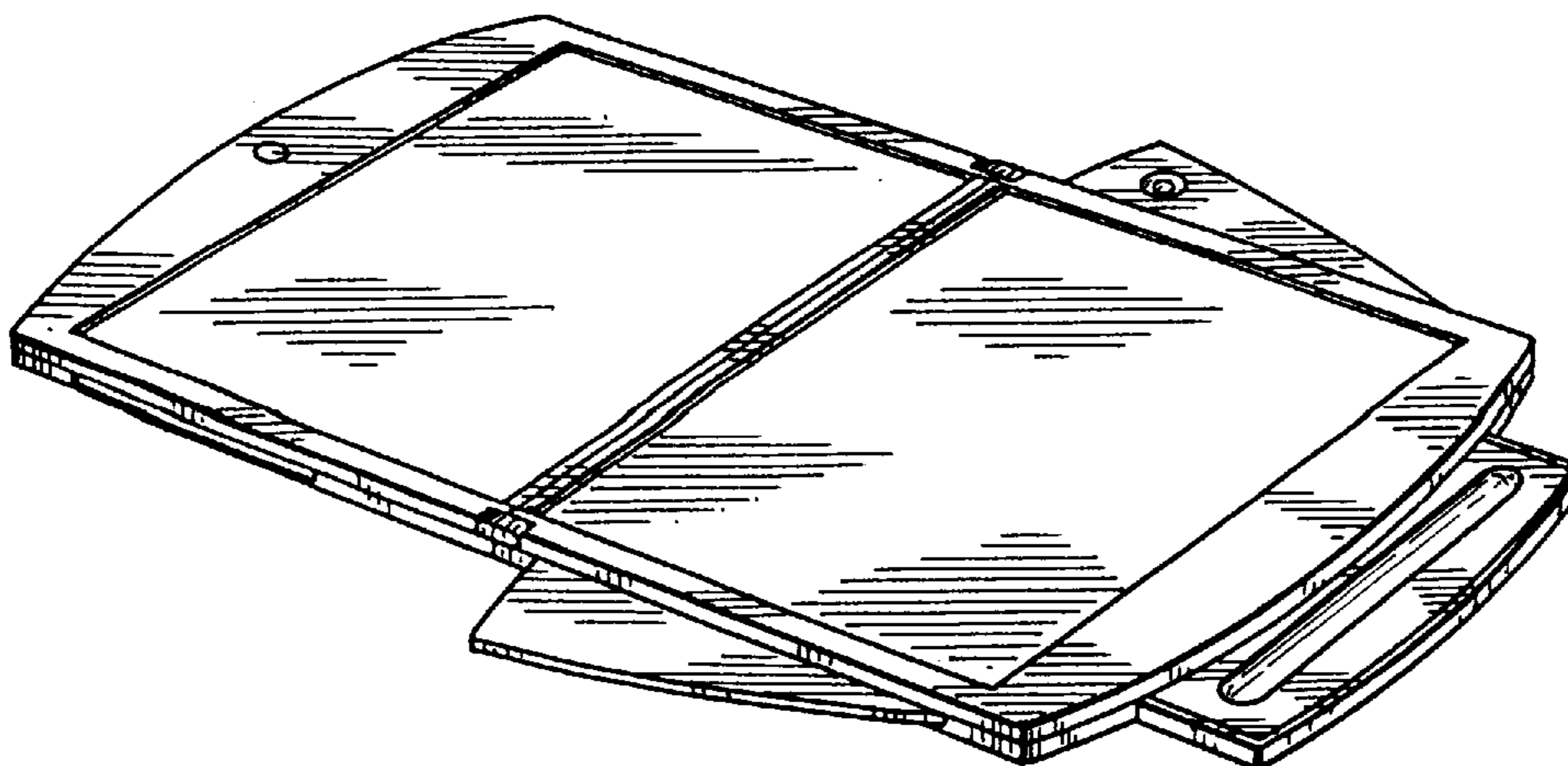

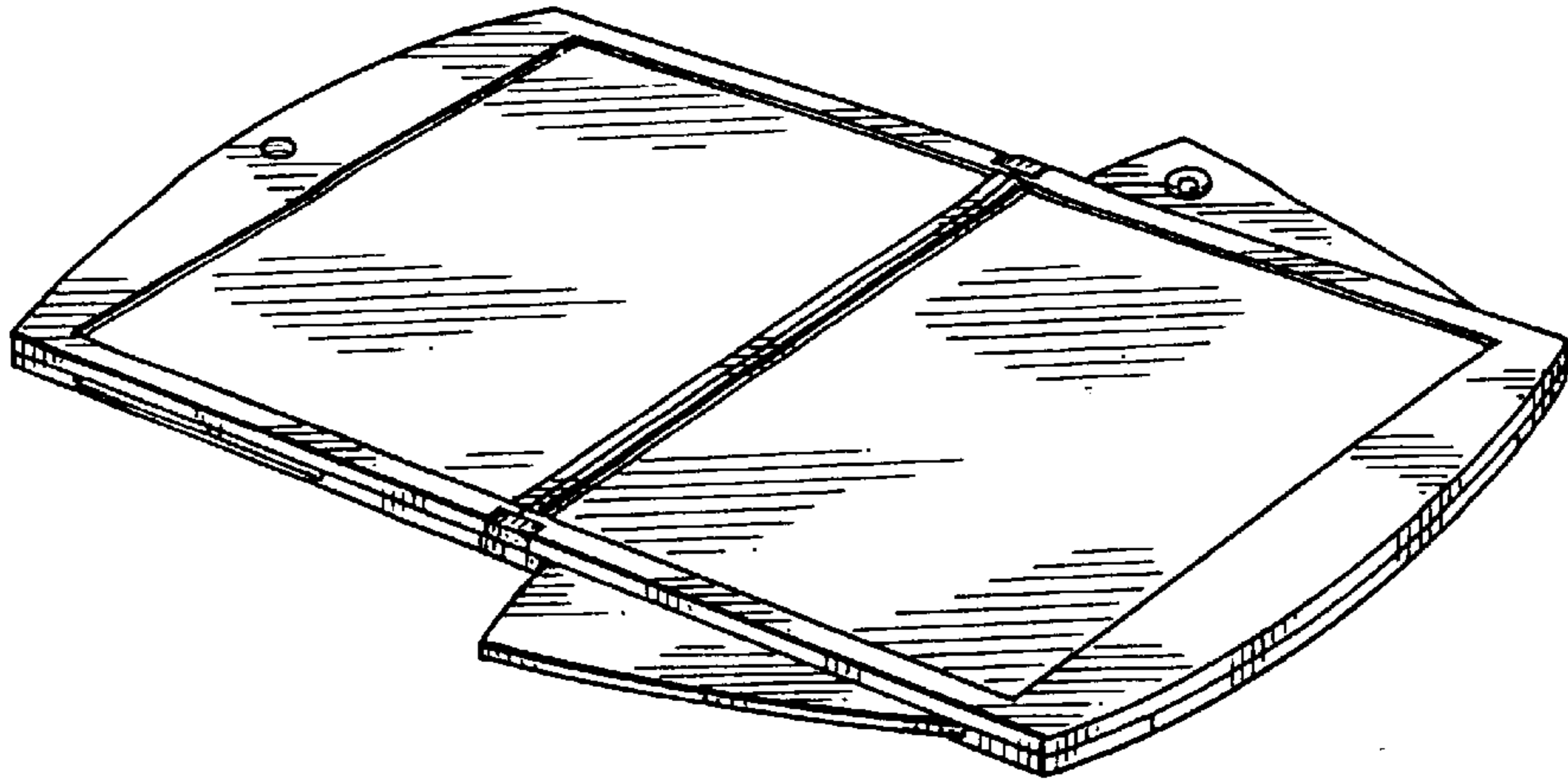

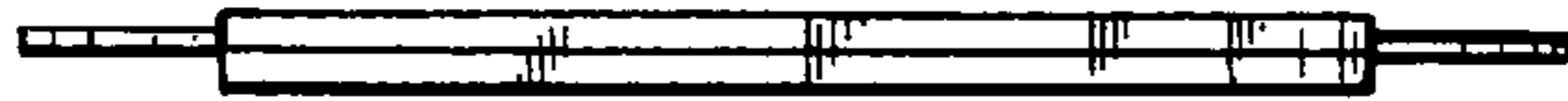

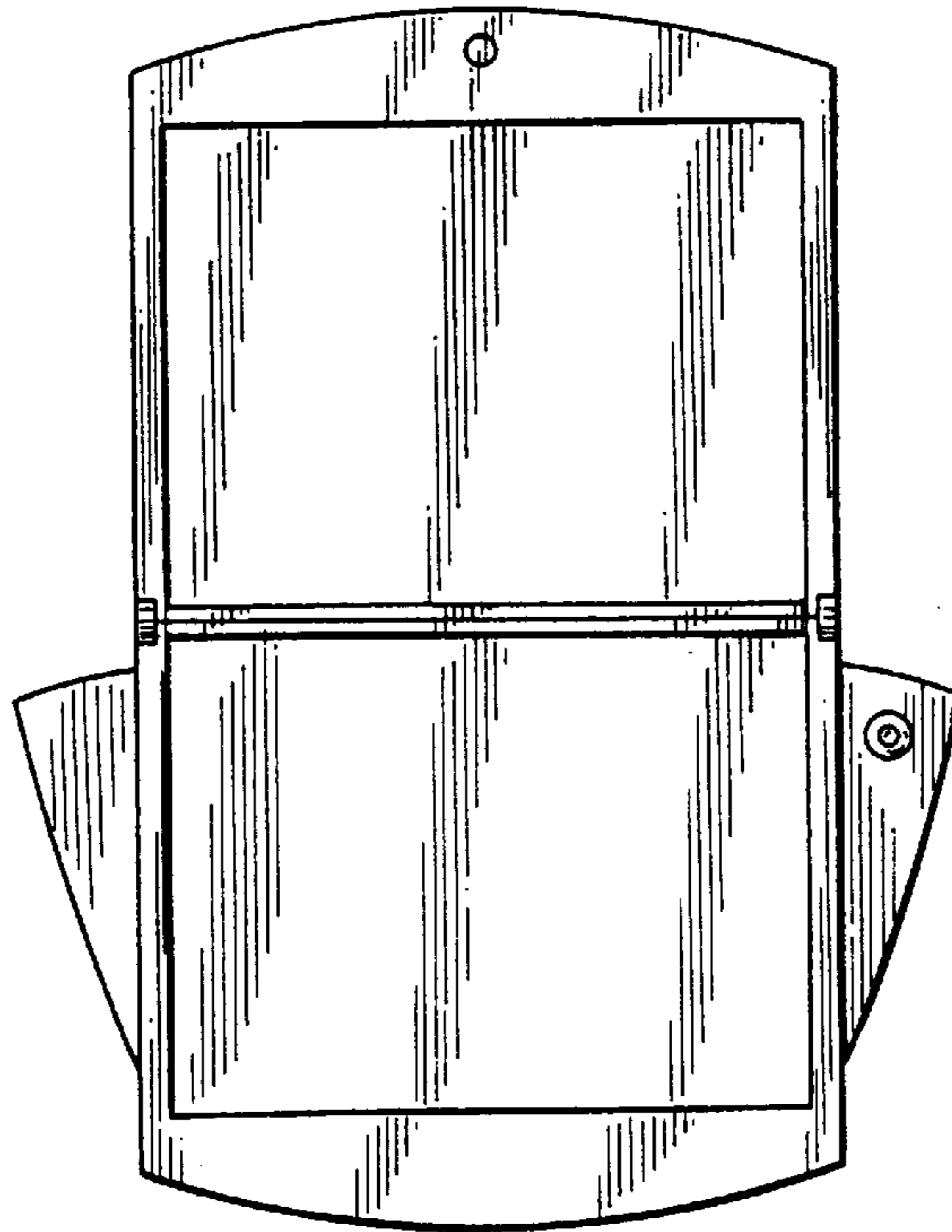

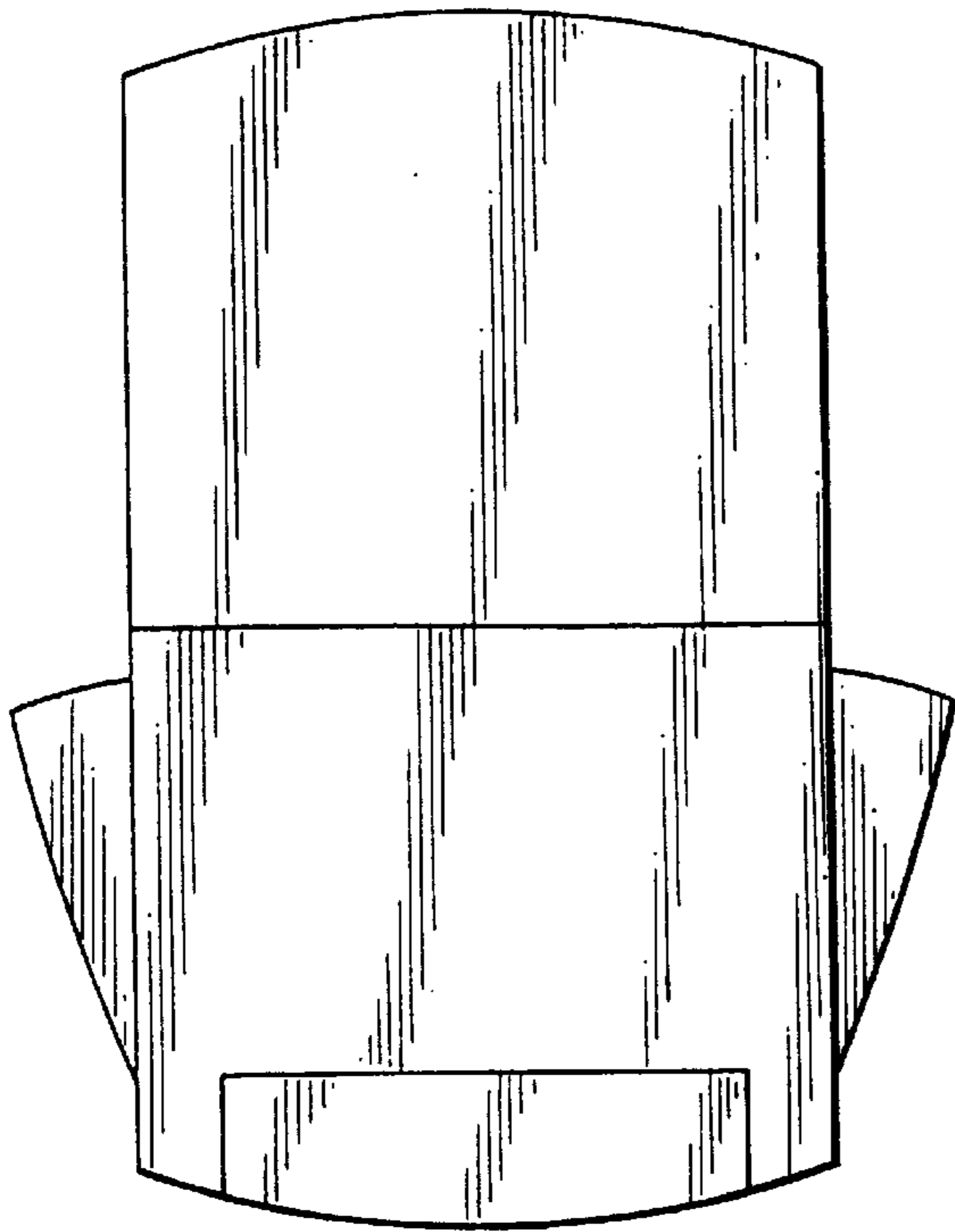

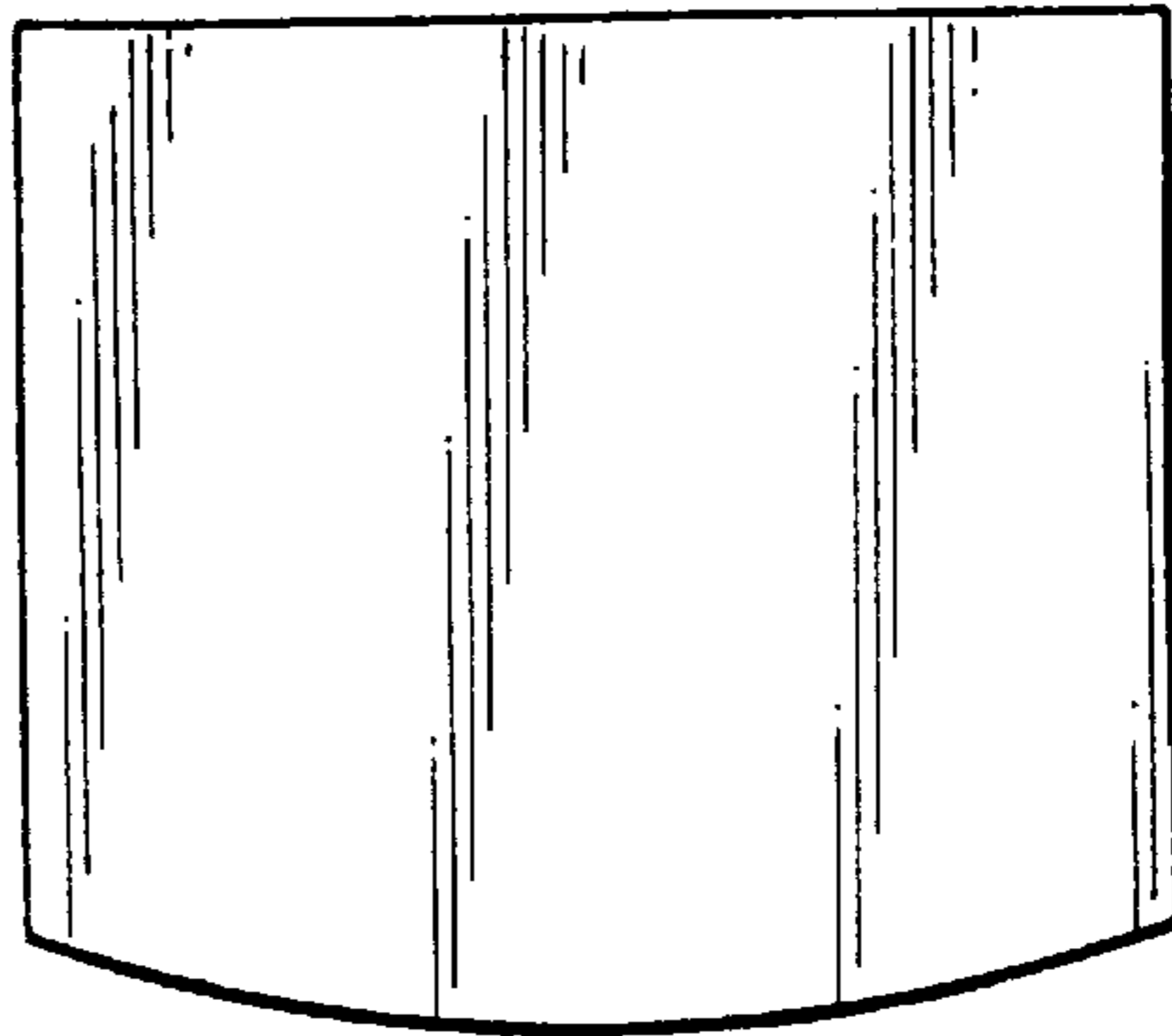

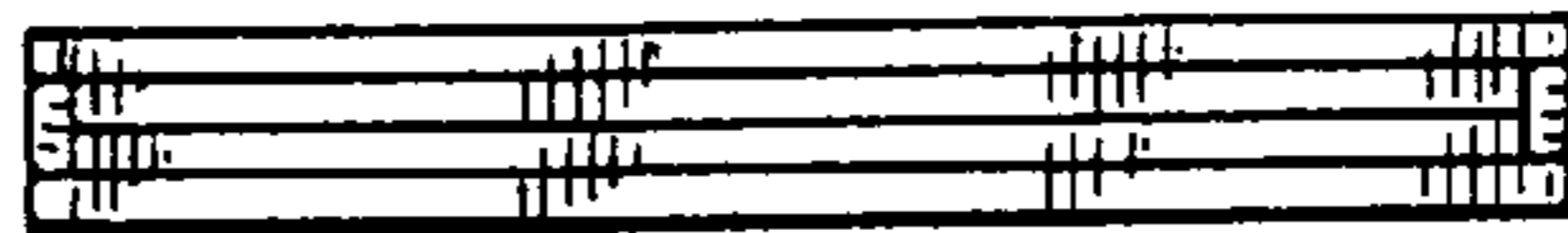

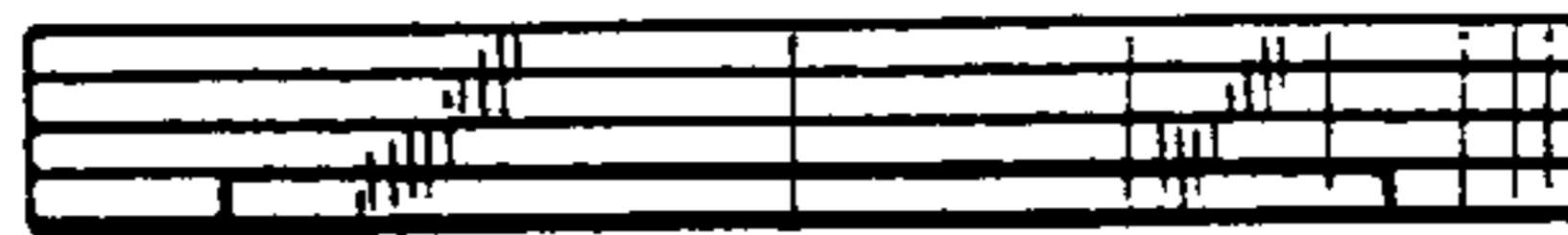
