The ornamental design for mobile telephone and organizer, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the mobile telephone and organizer showing my new design with the rear cover closed; FIG. 2 is a left side view thereof; FIG. 3 is a top view thereof; FIG. 4 is a rear view thereof; FIG. 5 is a right side view thereof; FIG. 6 is a bottom view thereof; and, FIG. 7 is a rear view thereof with the rear cover open to show the organizer keypad and display.

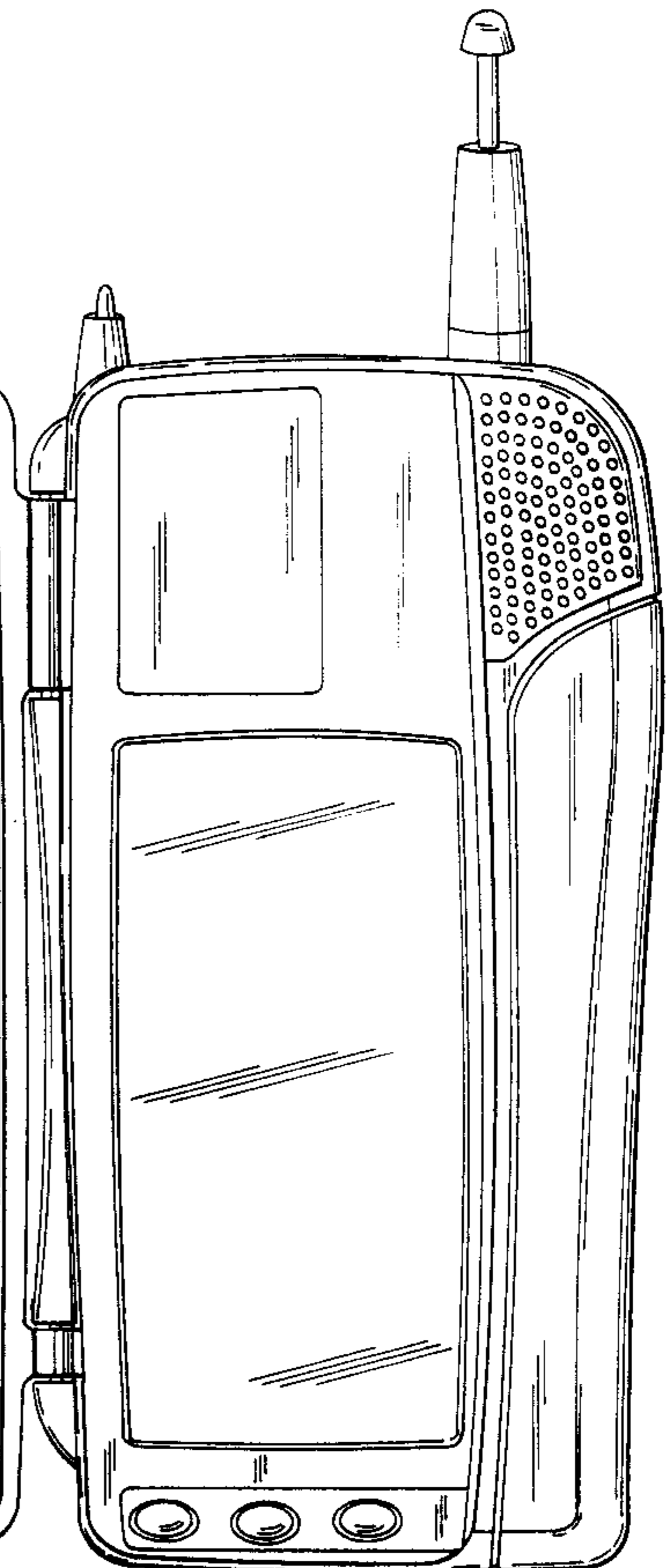
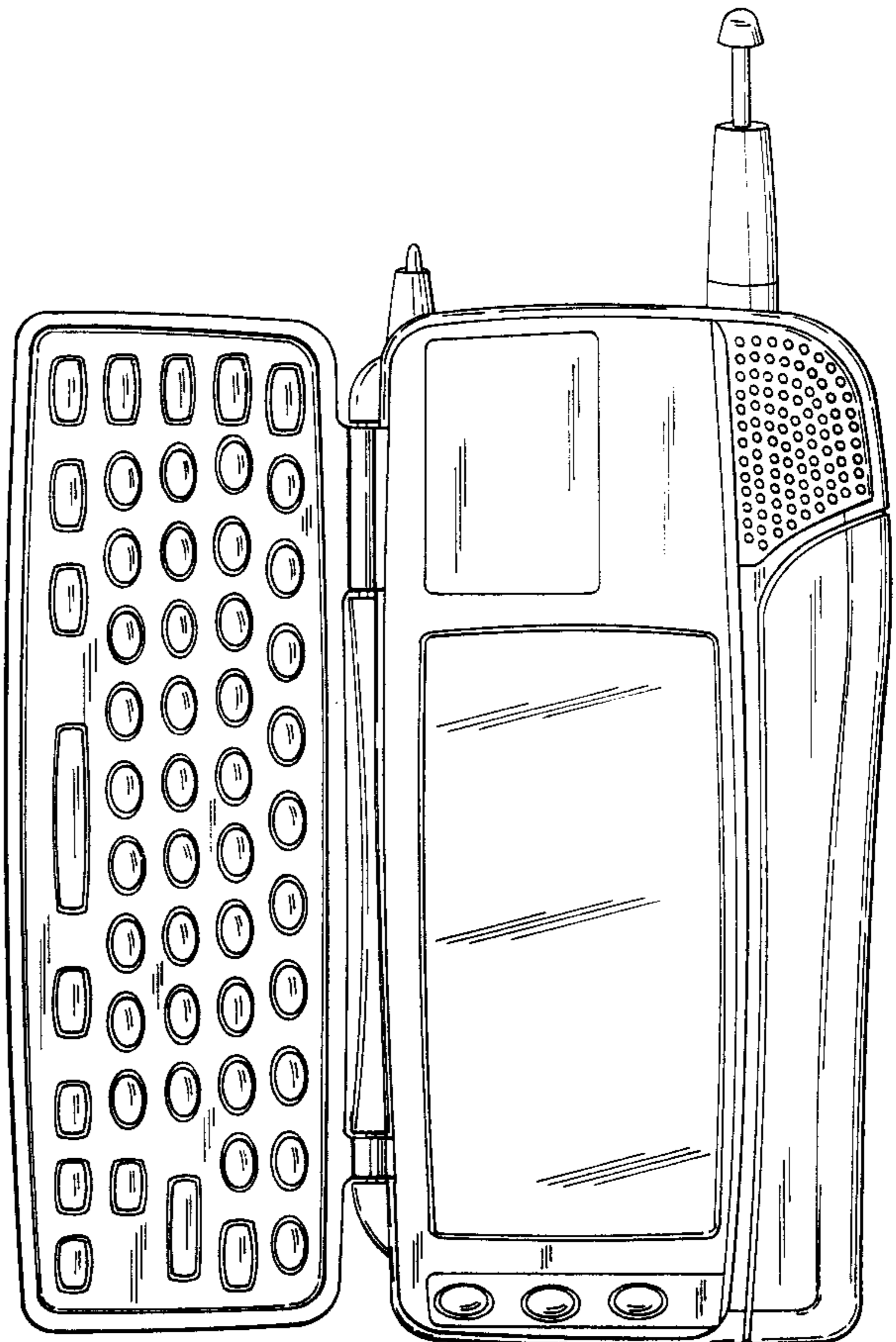
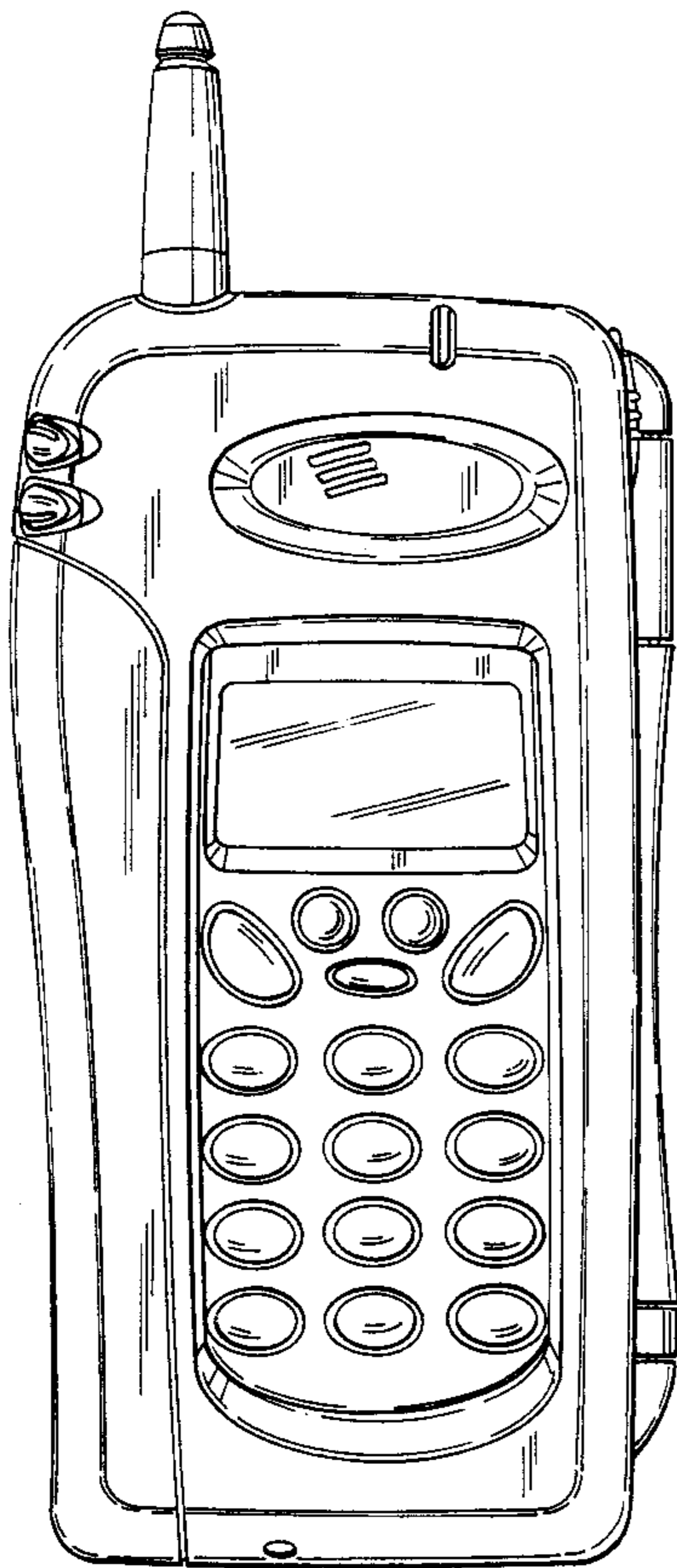

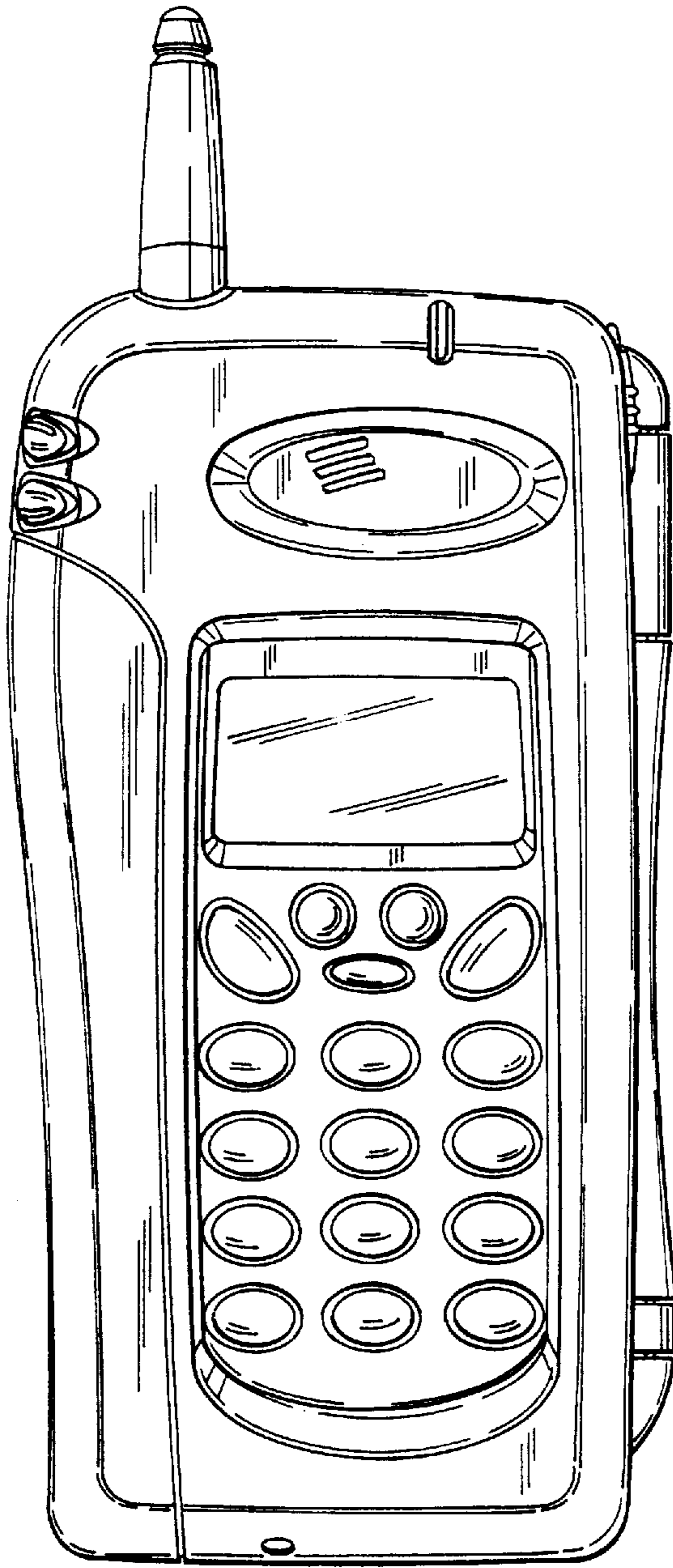

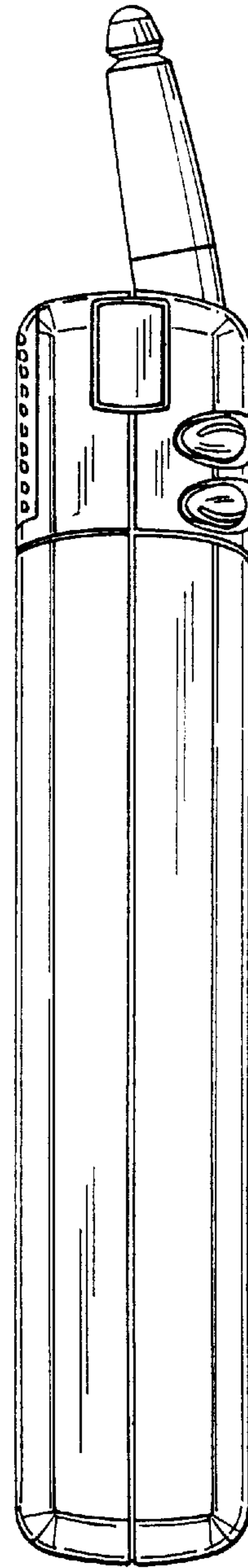

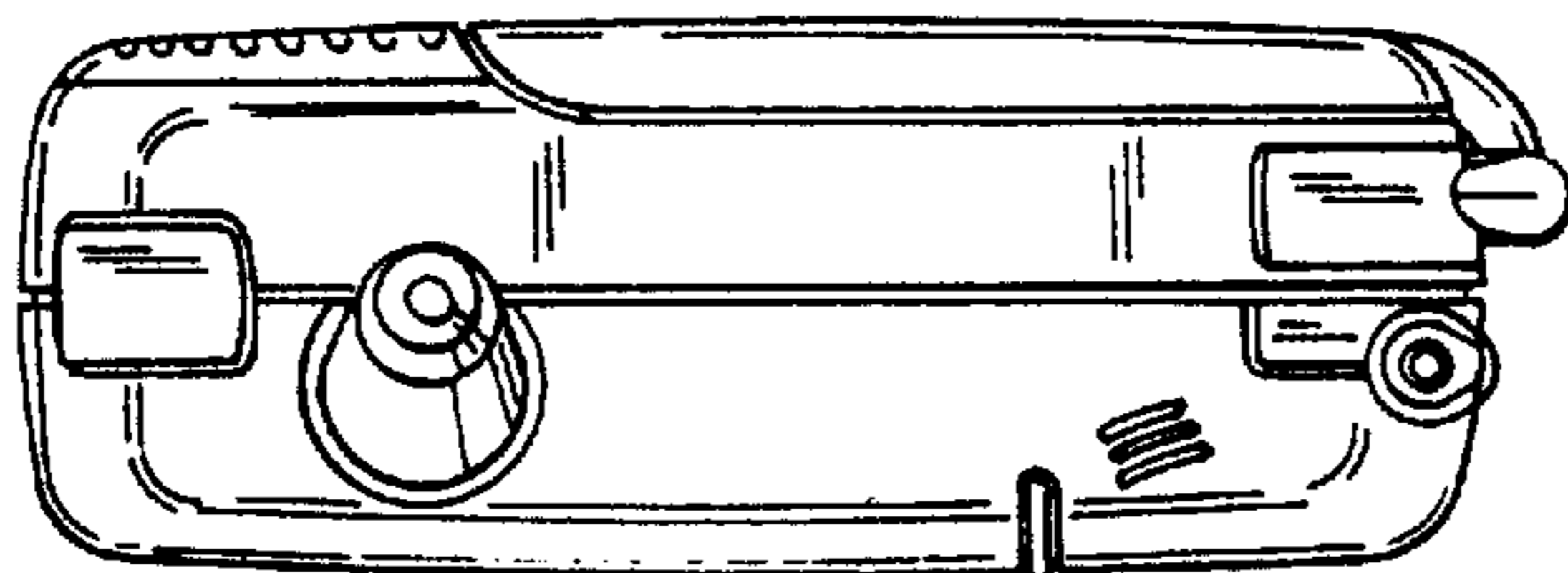

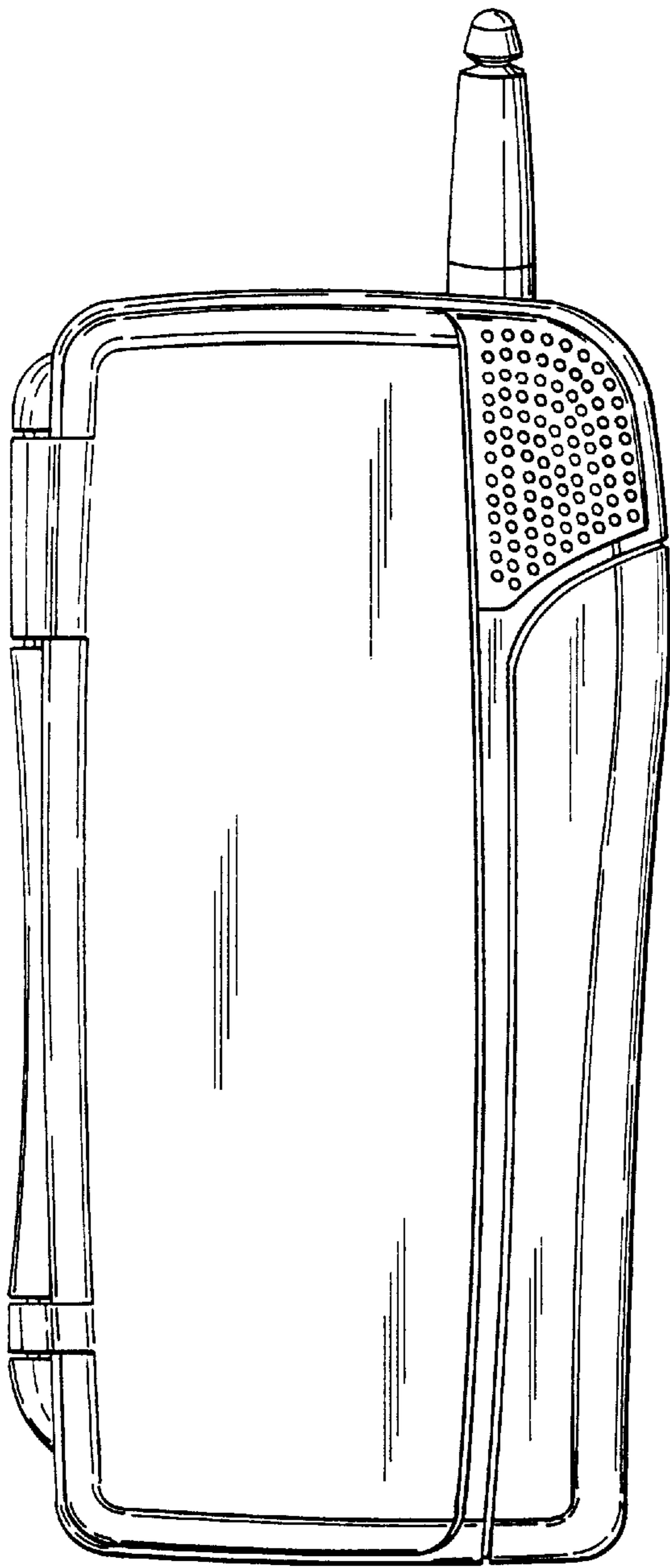

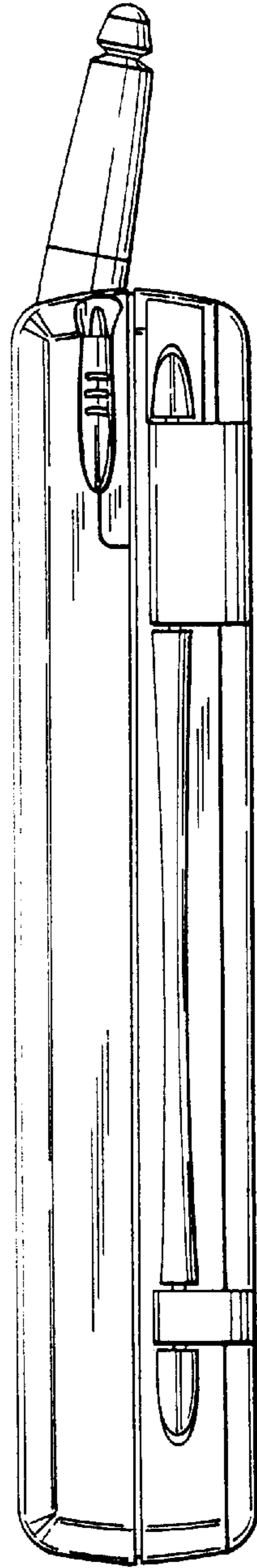

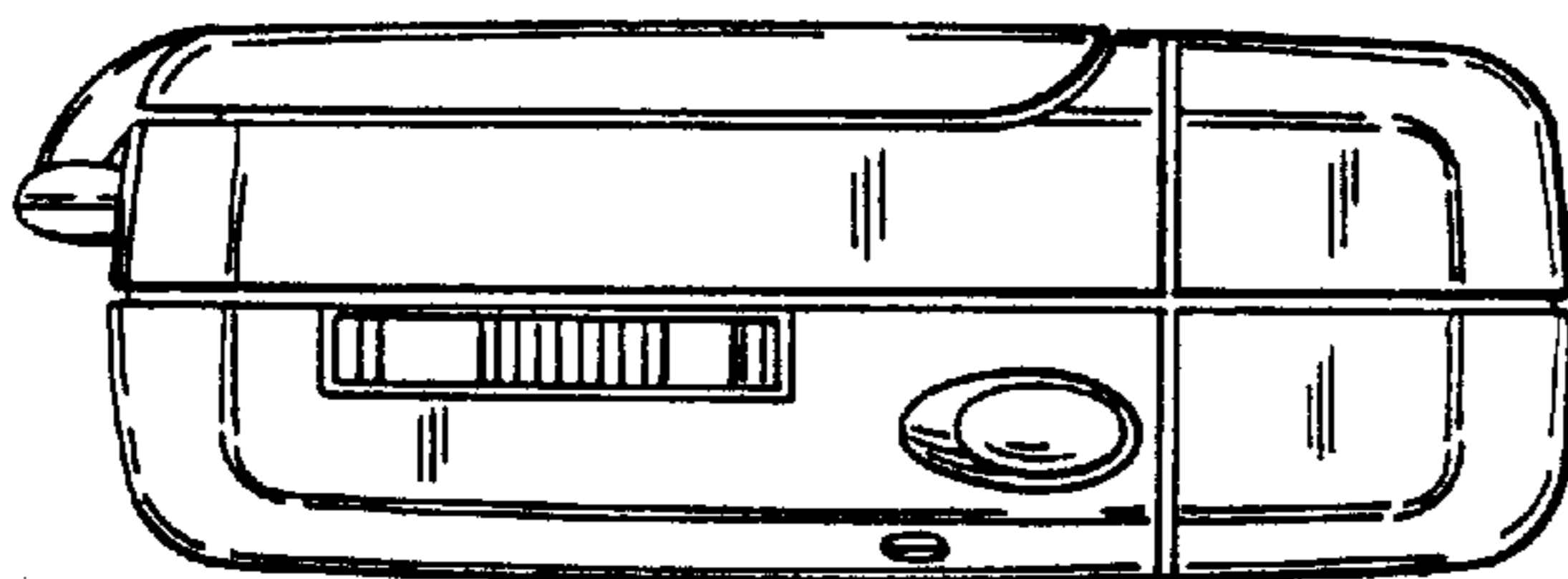
