The ornamental design for a golf club head, as shown and described.

### DESCRIPTION

FIG. 1 is a front elevational view of a golf club head showing my new design;  
 FIG. 2 is a bottom plan view thereof;  
 FIG. 3 is a left side elevational view thereof;  
 FIG. 4 is a right side elevational view thereof;  
 FIG. 5 is a rear elevational view thereof;  
 FIG. 6 is a top plan view thereof;  
 FIG. 7 is a front elevational view of a second embodiment of the club head as disclosed in FIG. 1;  
 FIG. 8 is a bottom plan view of FIG. 7;  
 FIG. 9 is a rear elevational view of FIG. 7;  
 FIG. 10 is a top plan view of FIG. 7;  
 FIG. 11 is a left side elevational view of FIG. 7;  
 FIG. 12 is a right side elevational view of FIG. 7;

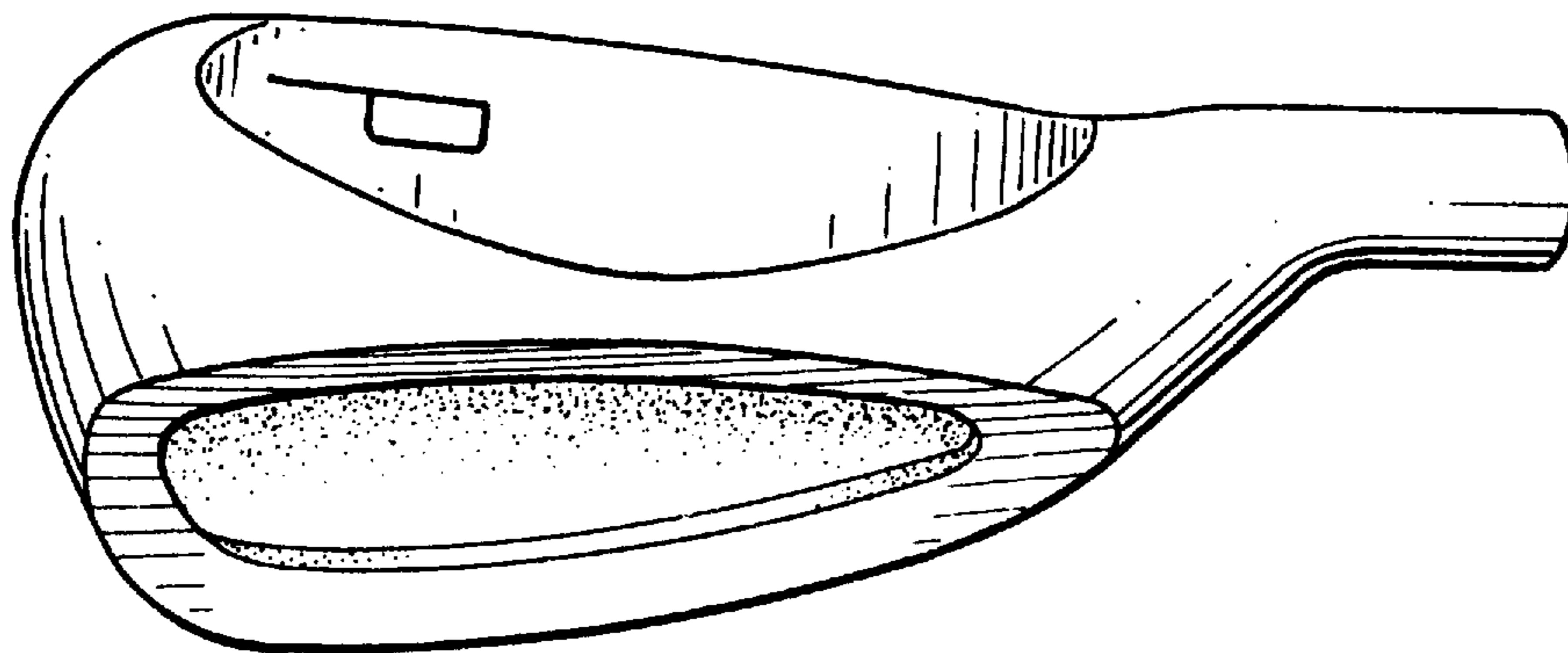


FIG. 13 is a front elevational view of a third embodiment of the club head as disclosed in FIG. 1;

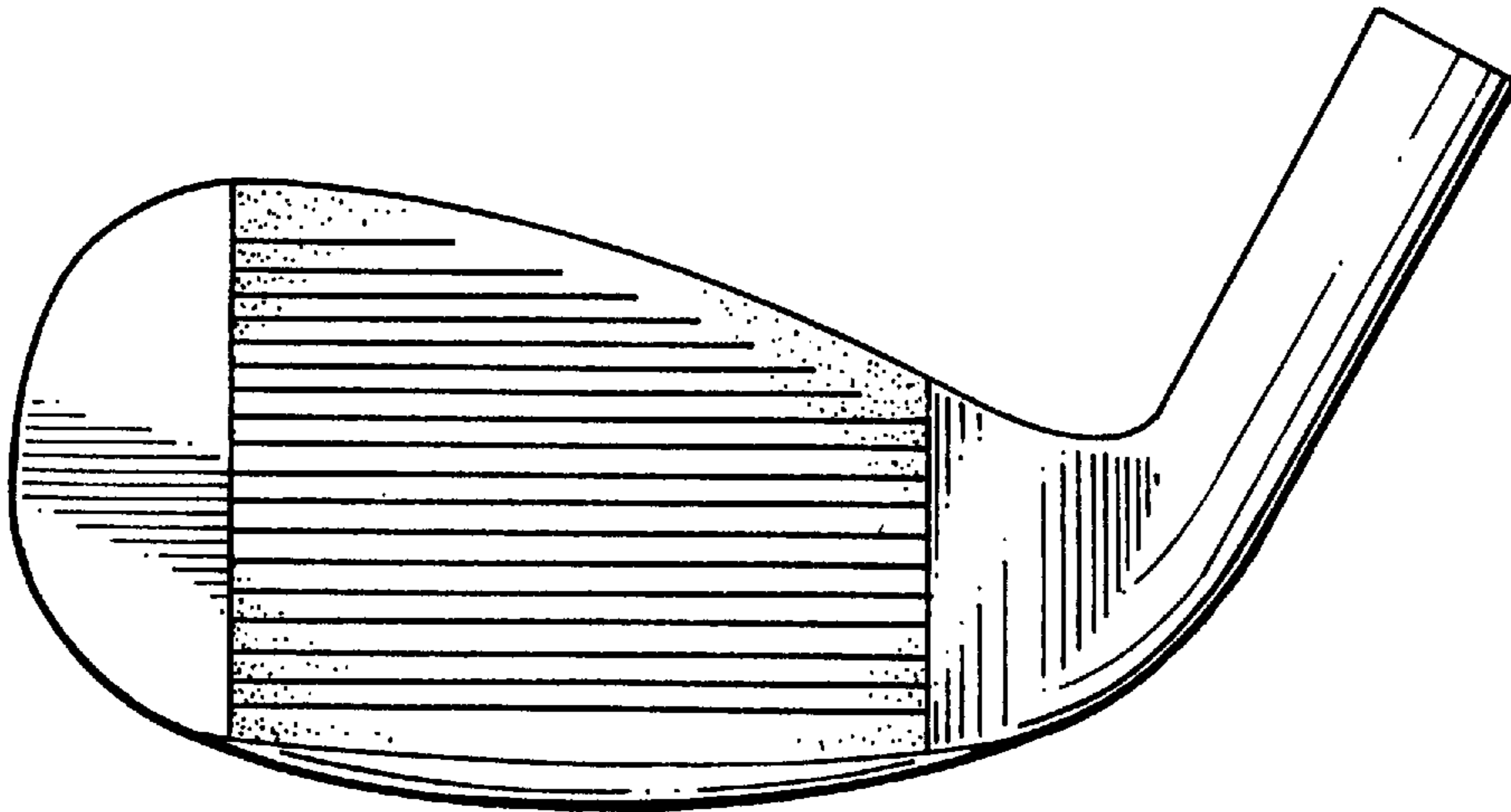

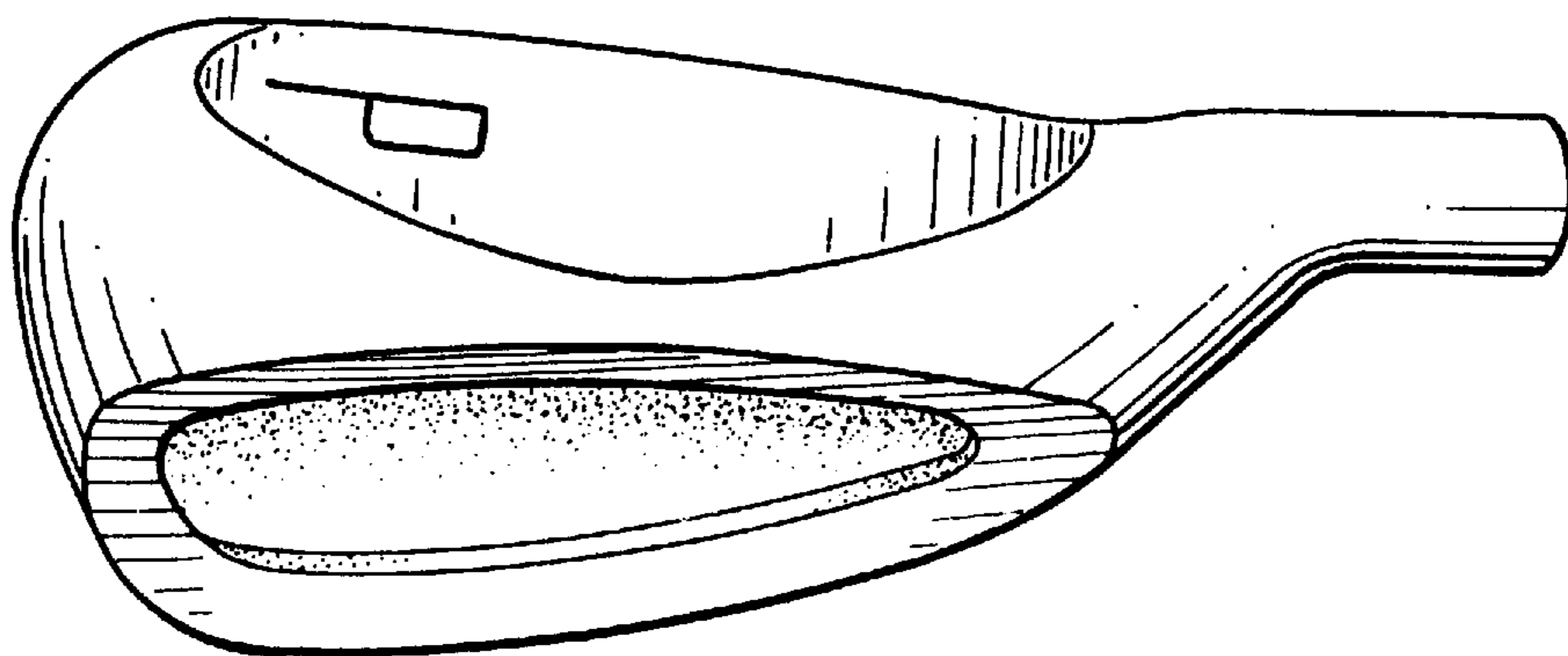

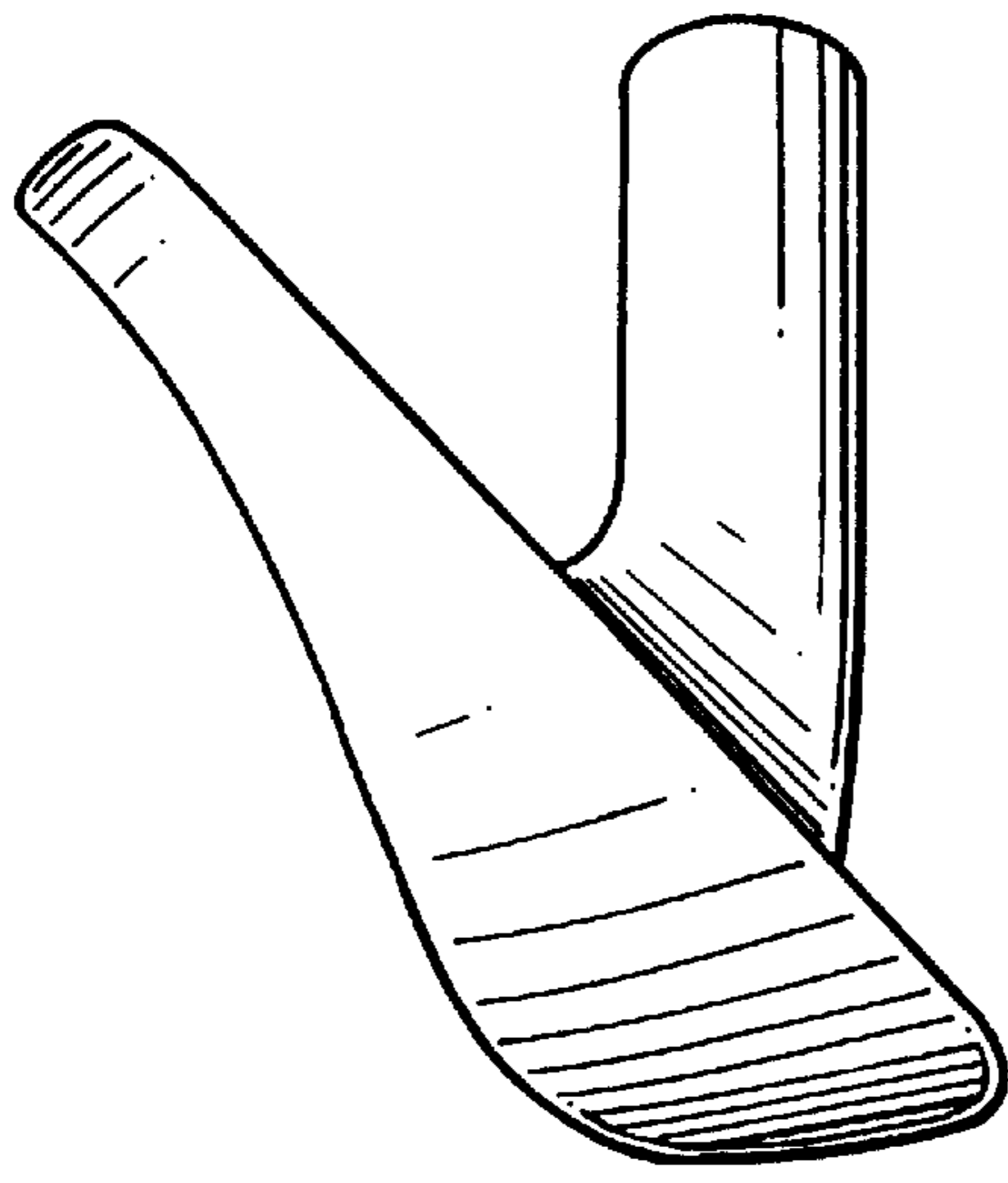

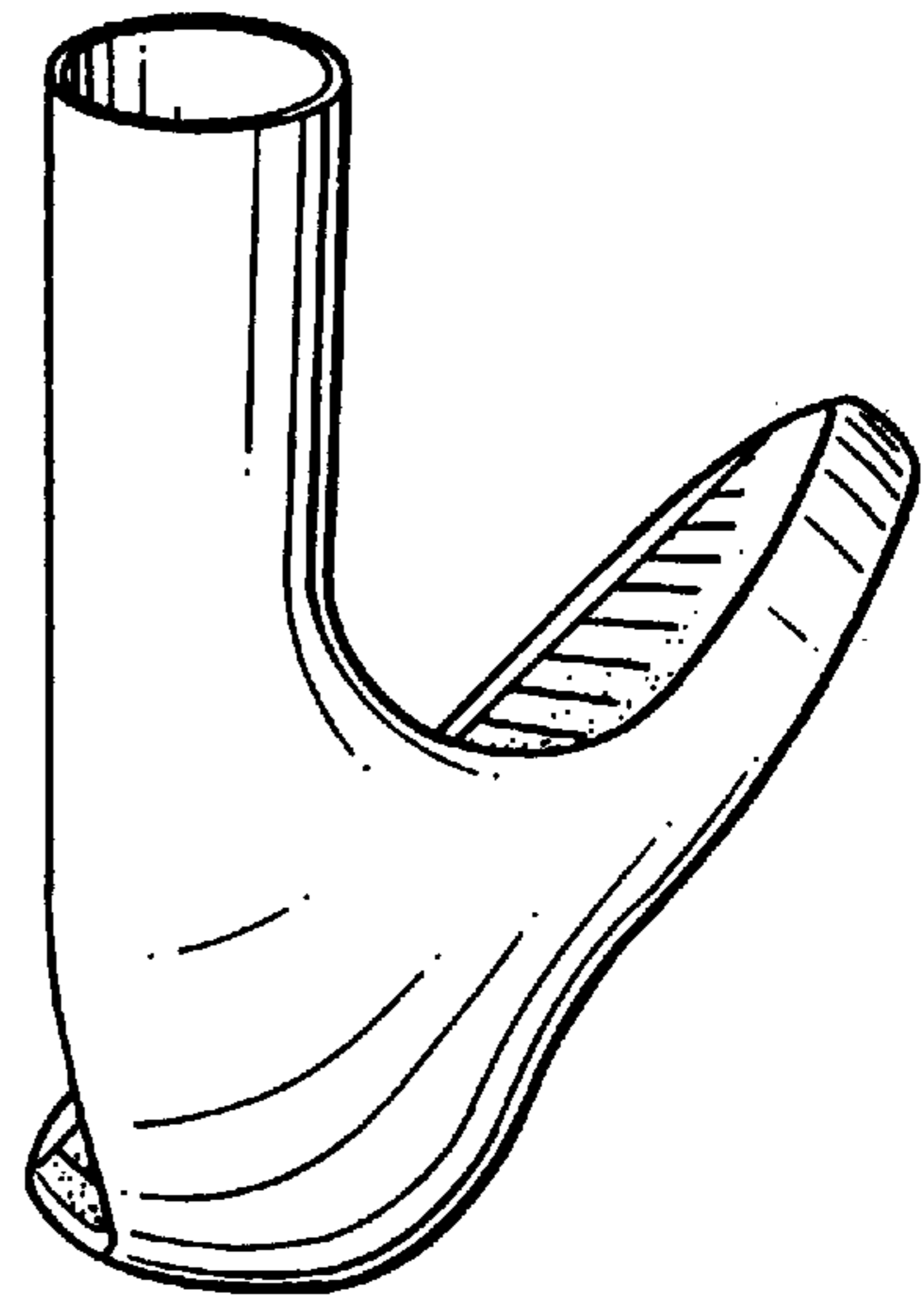

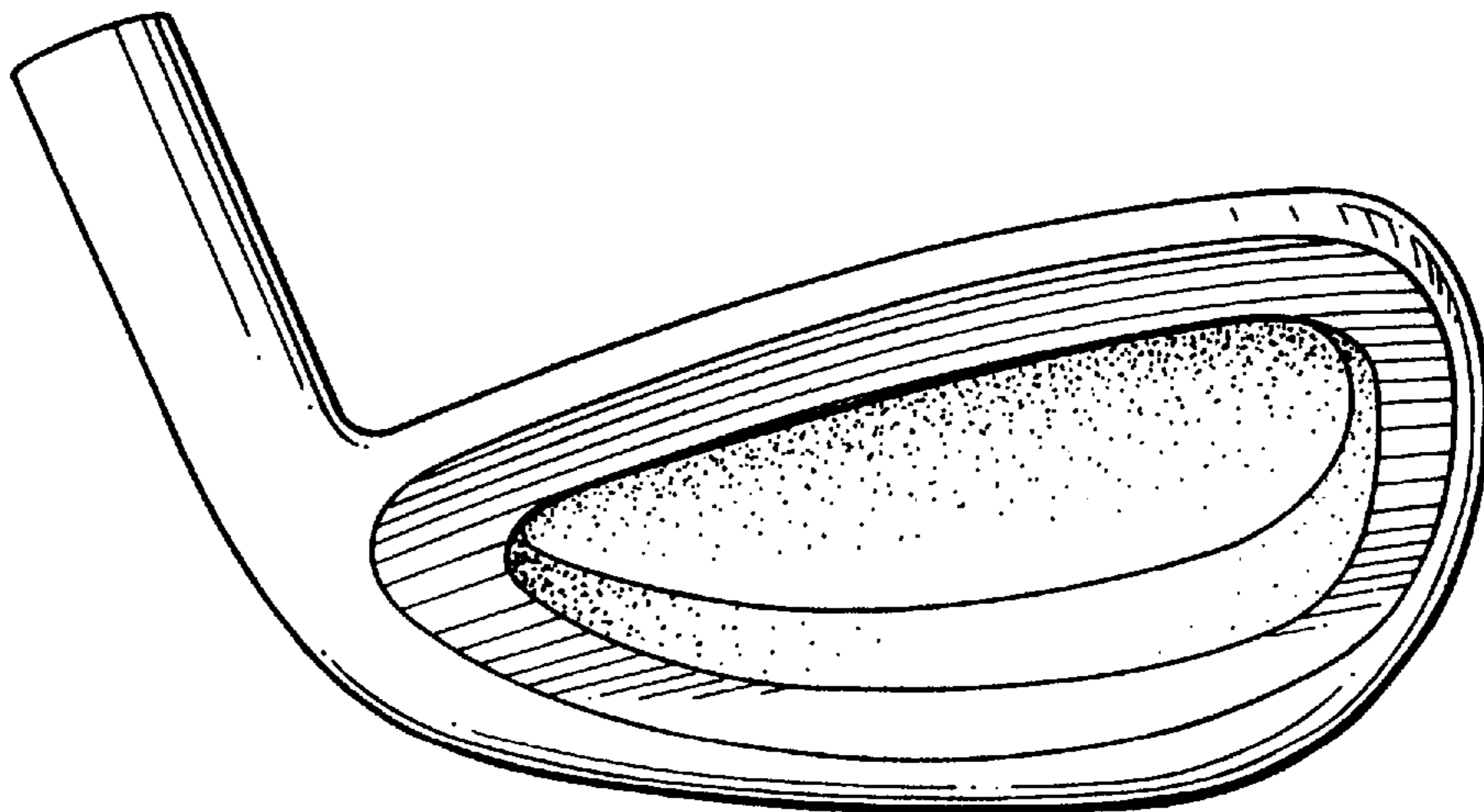

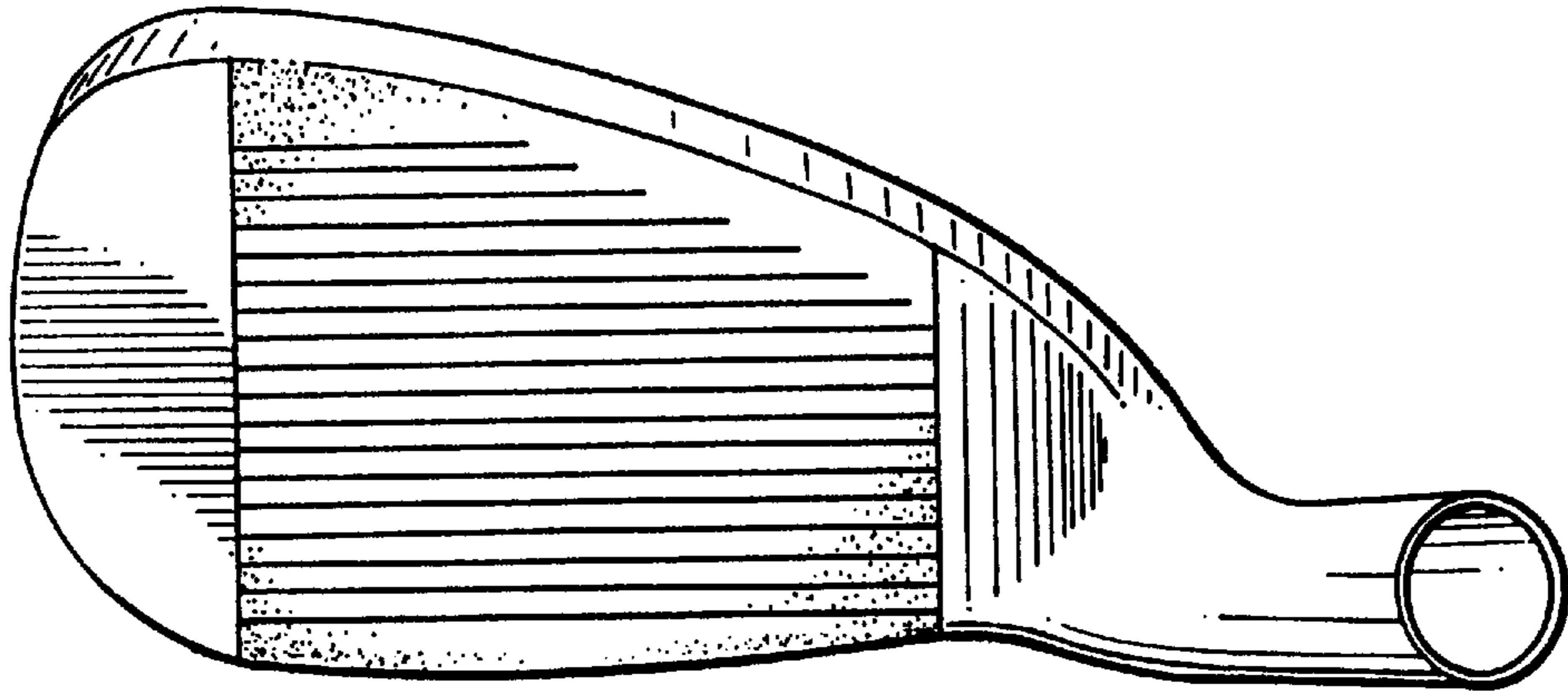

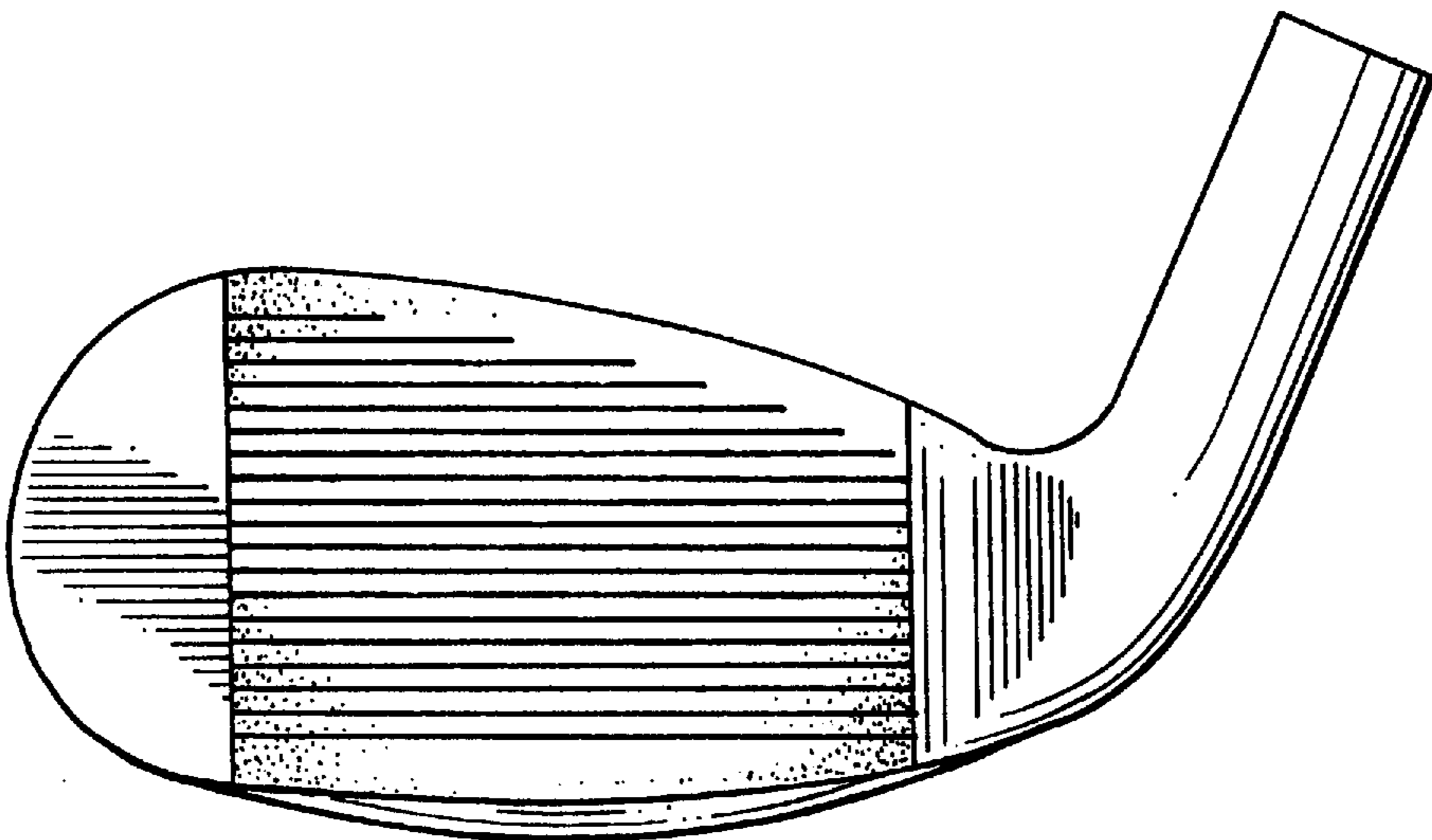

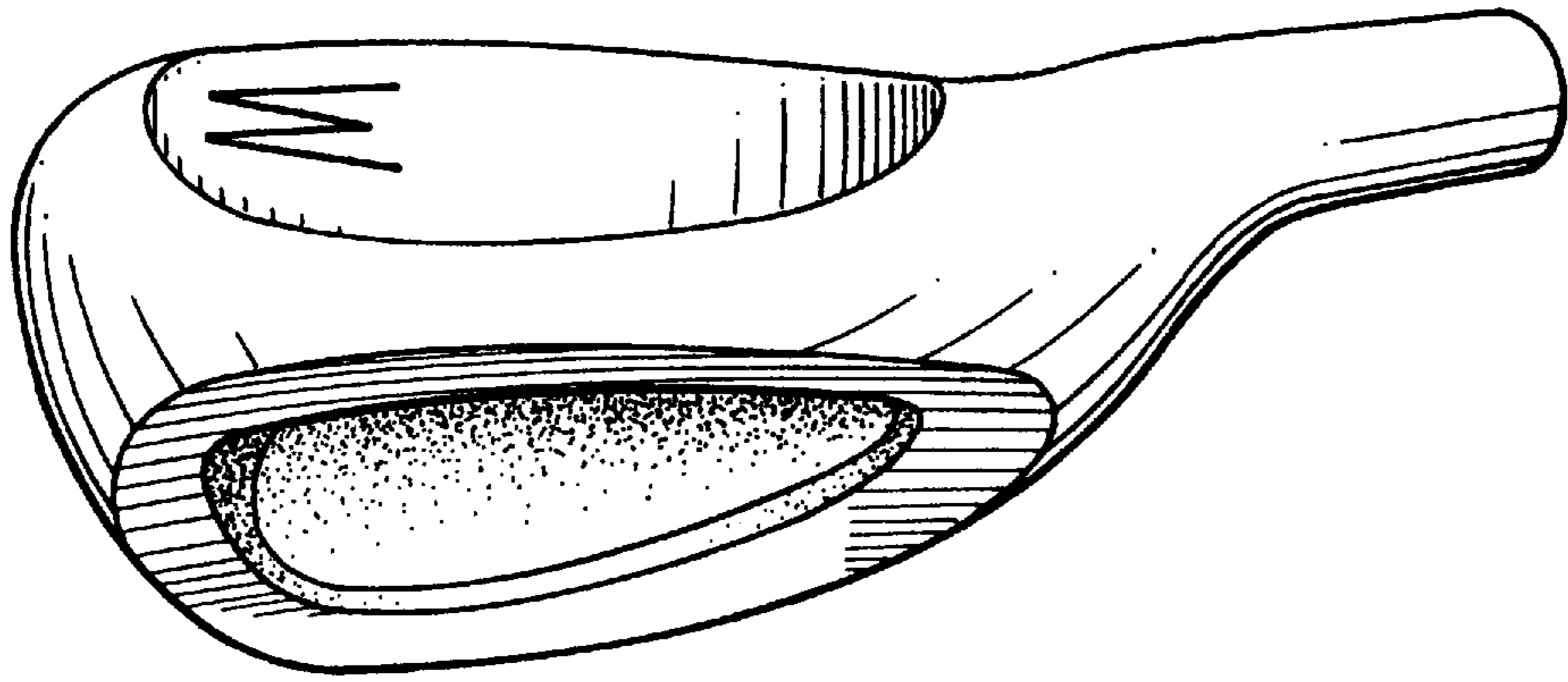

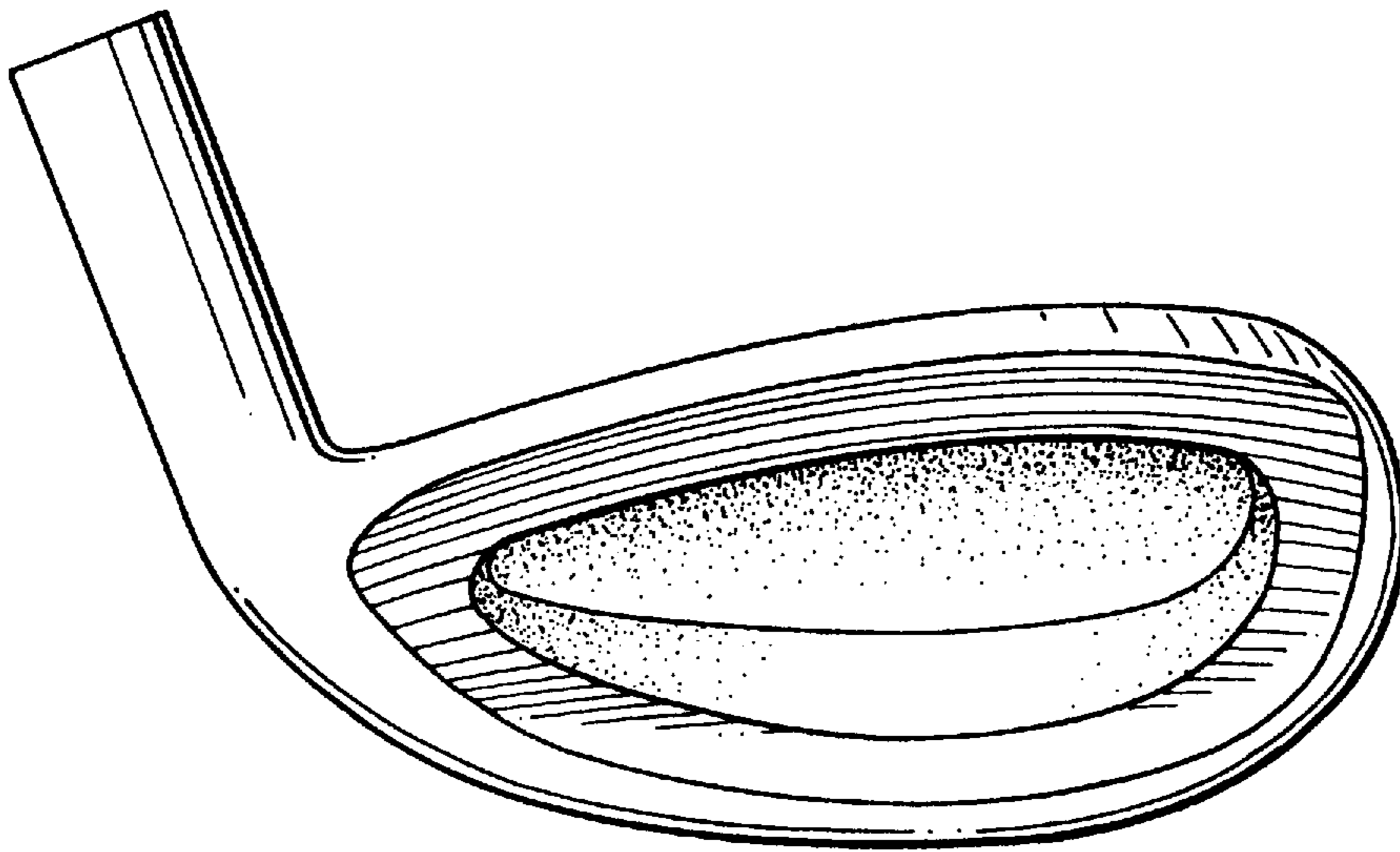

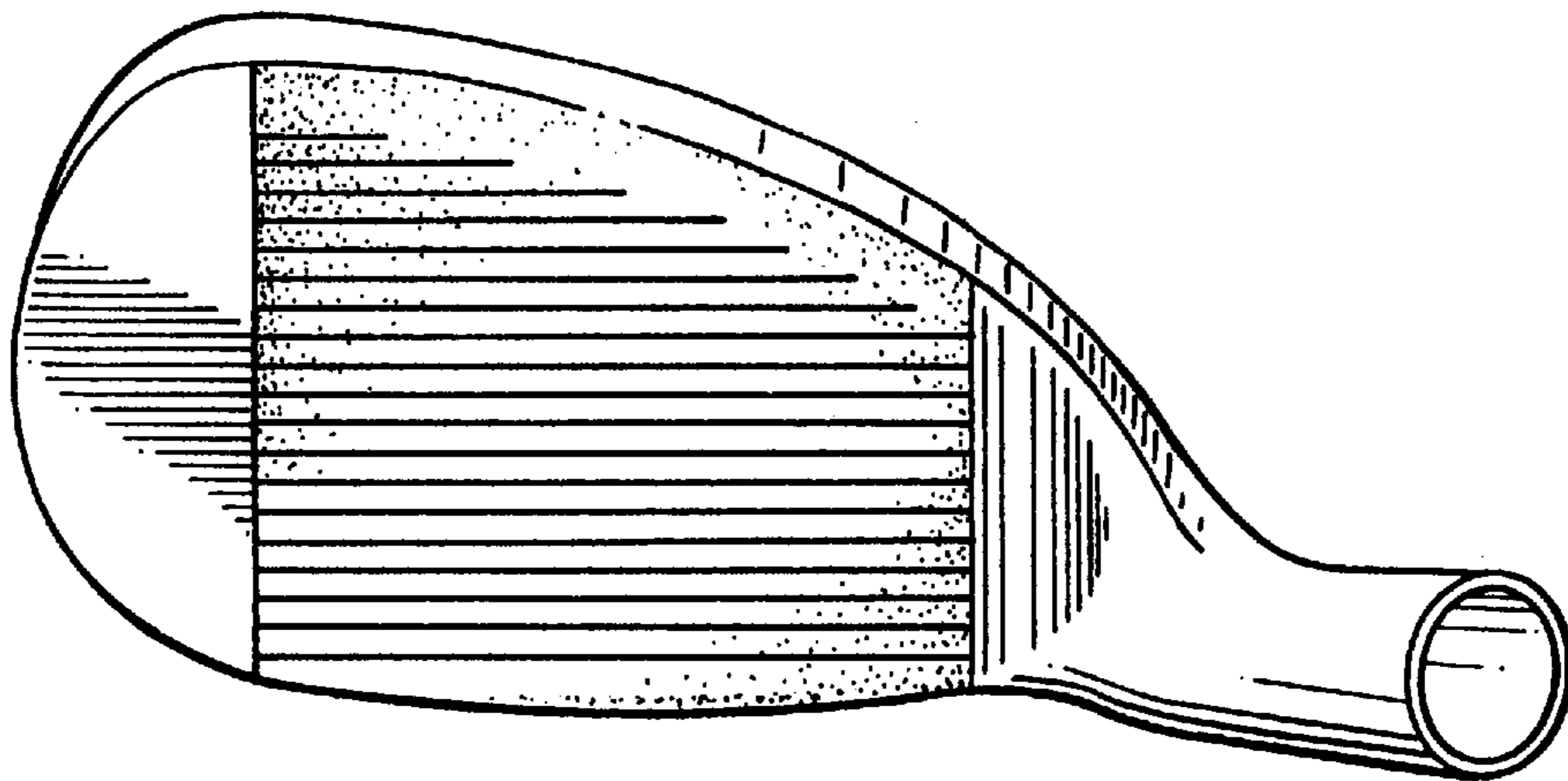

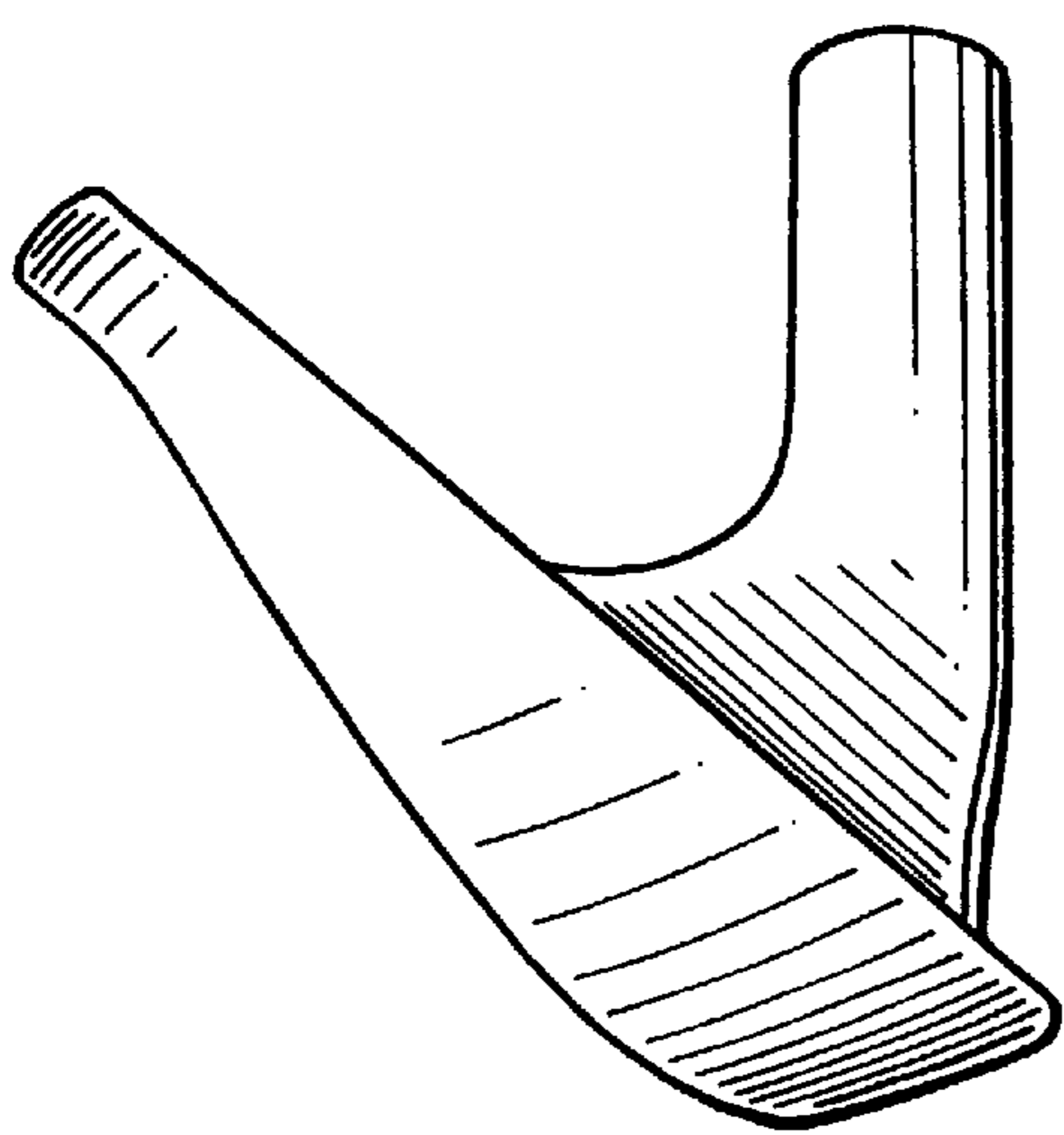

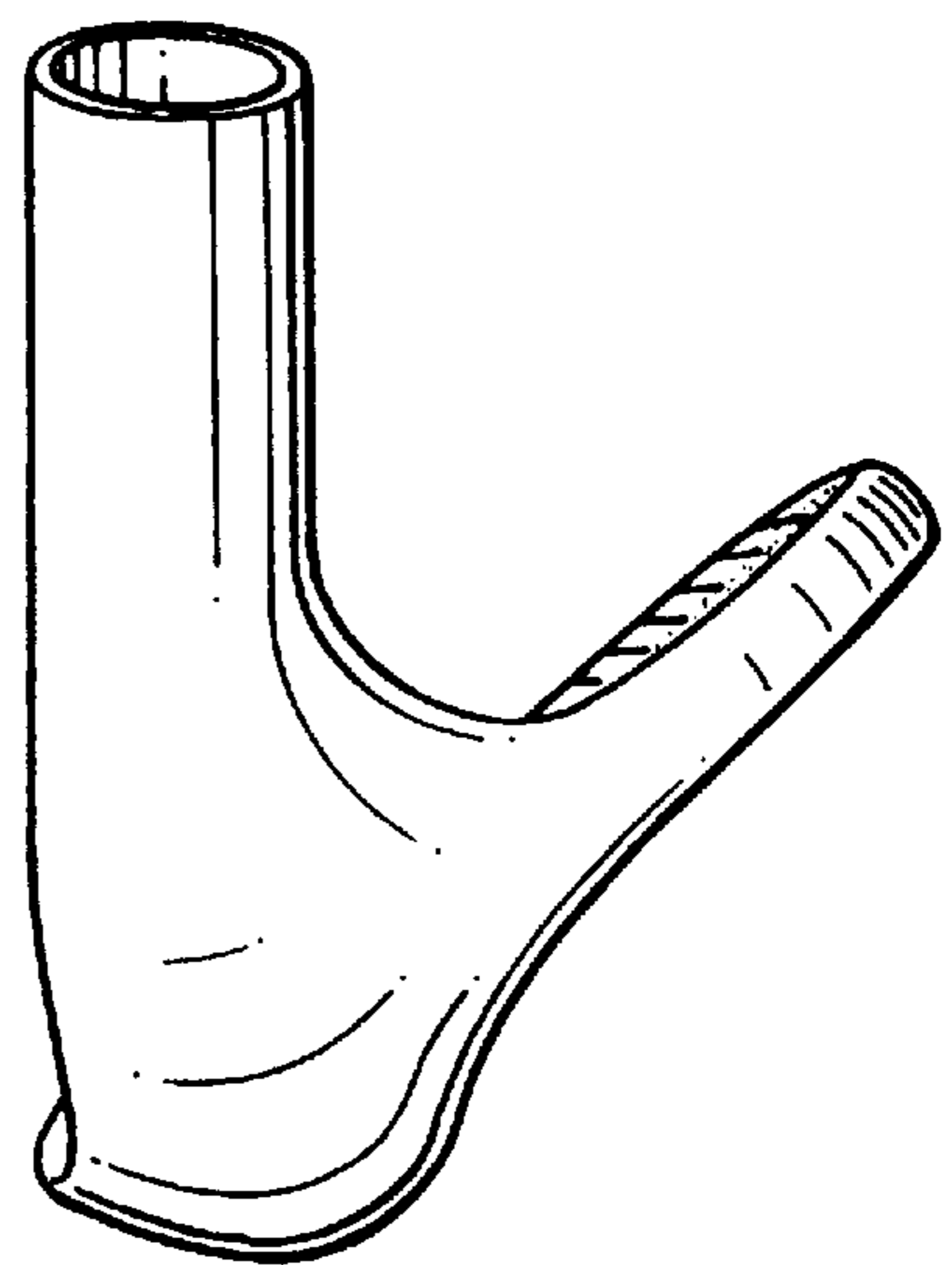

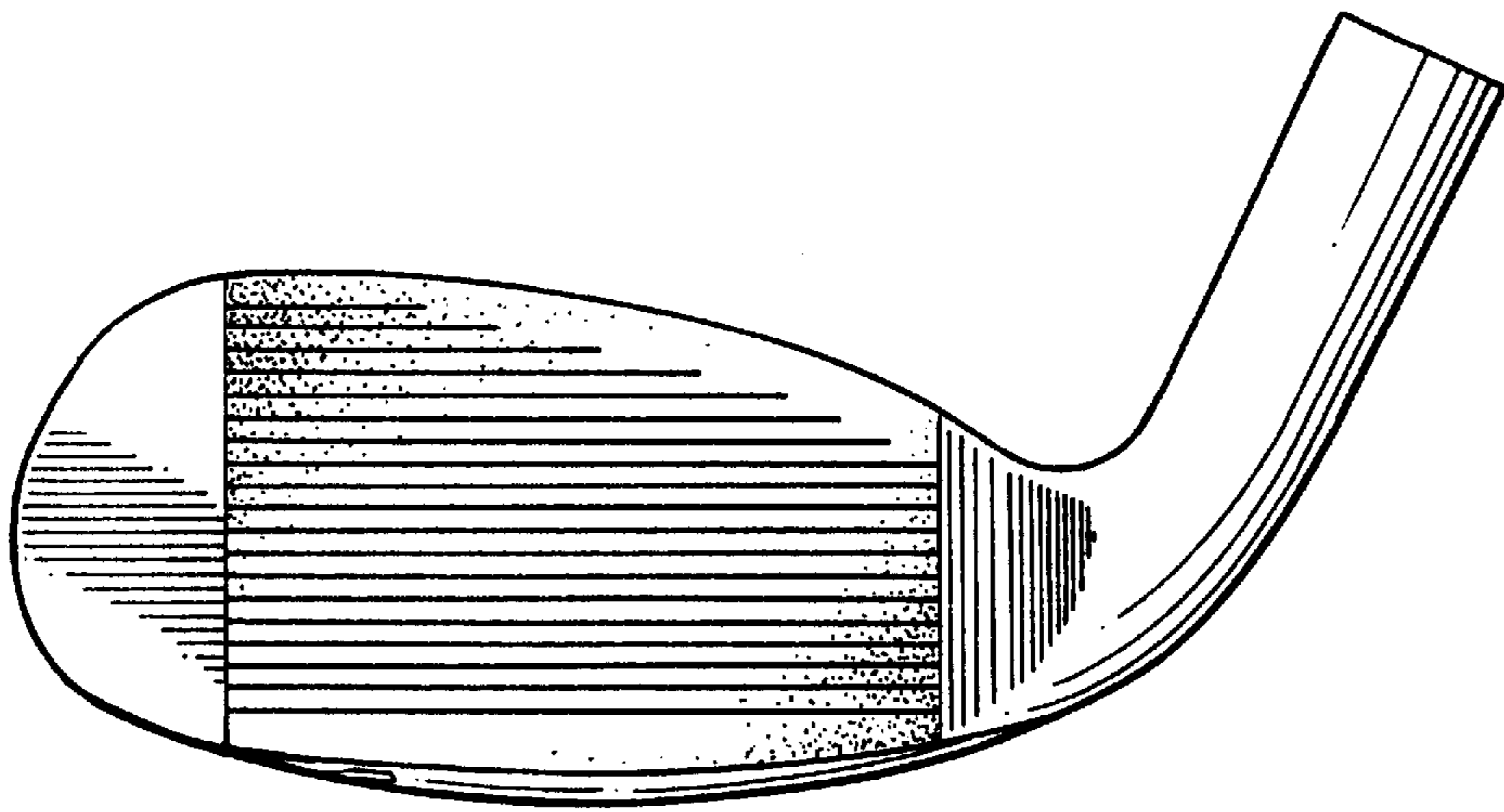

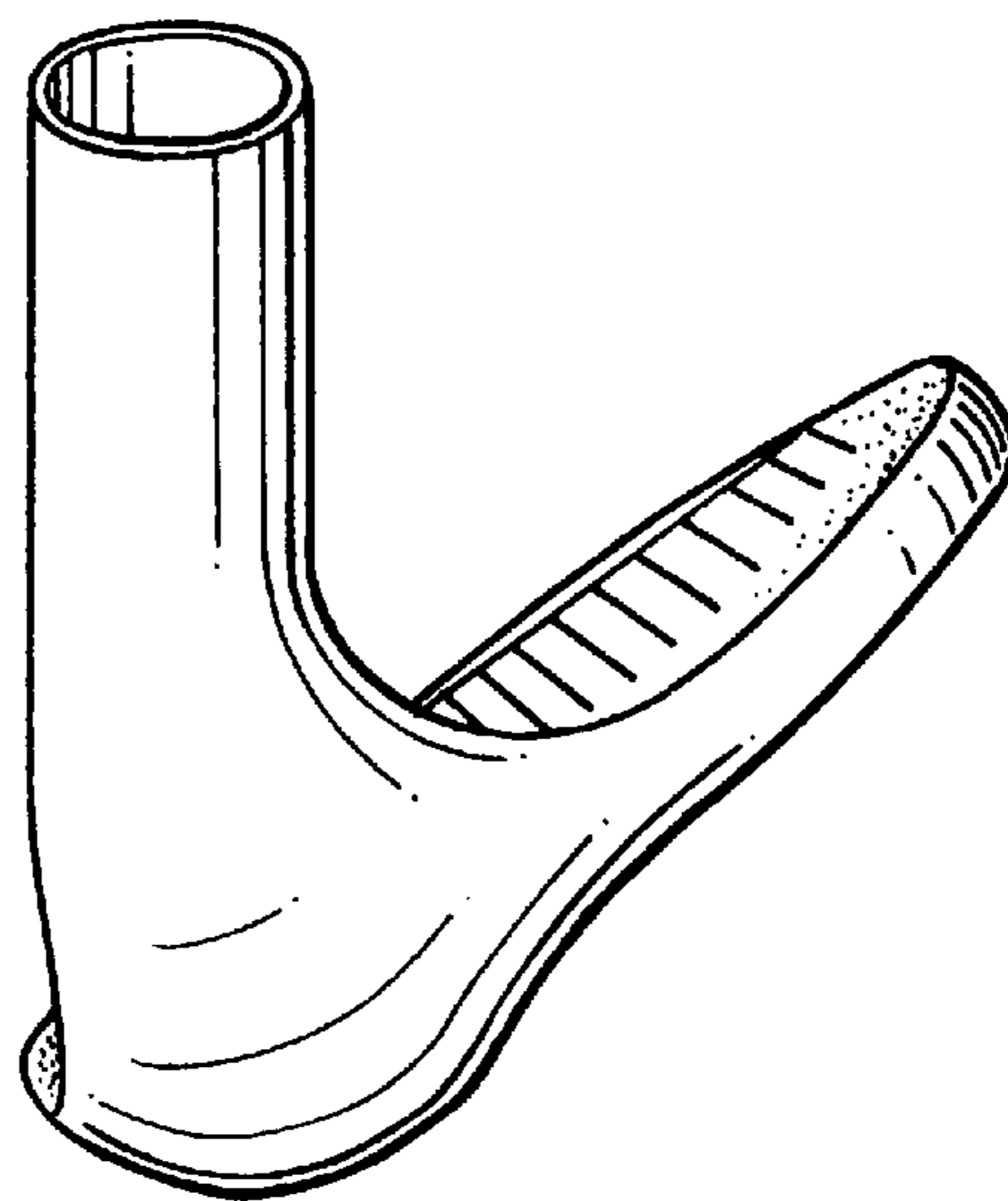

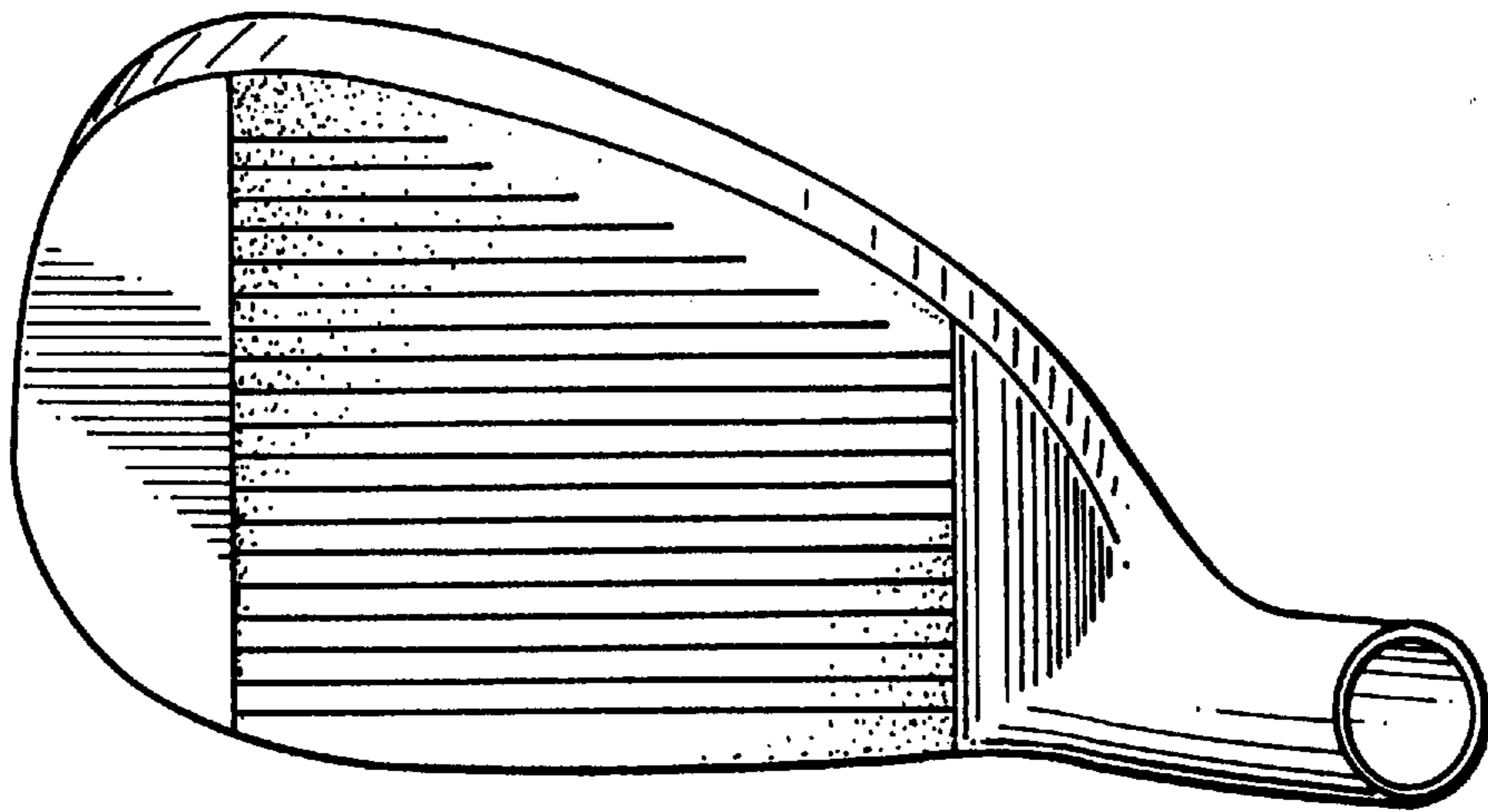

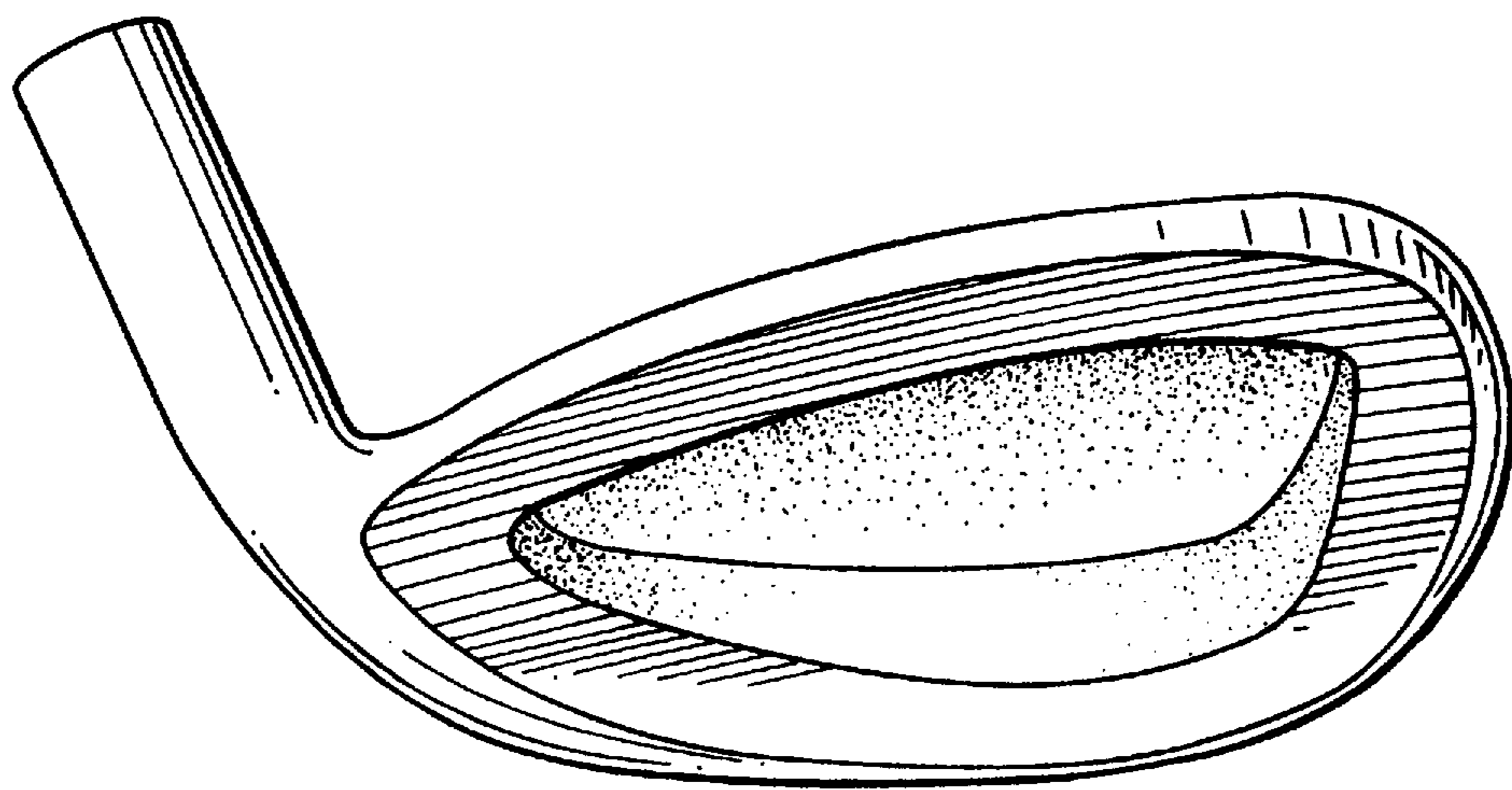

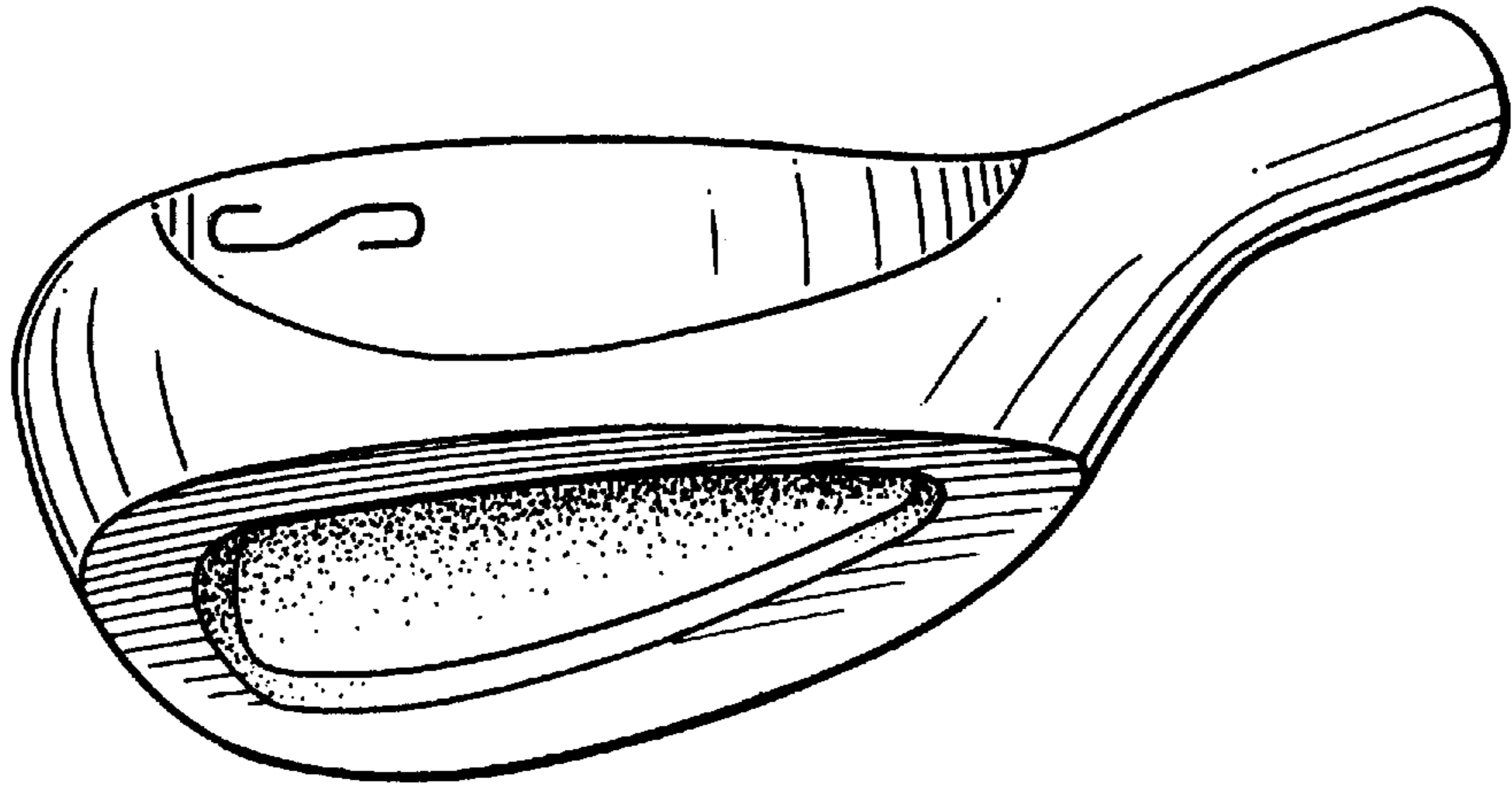

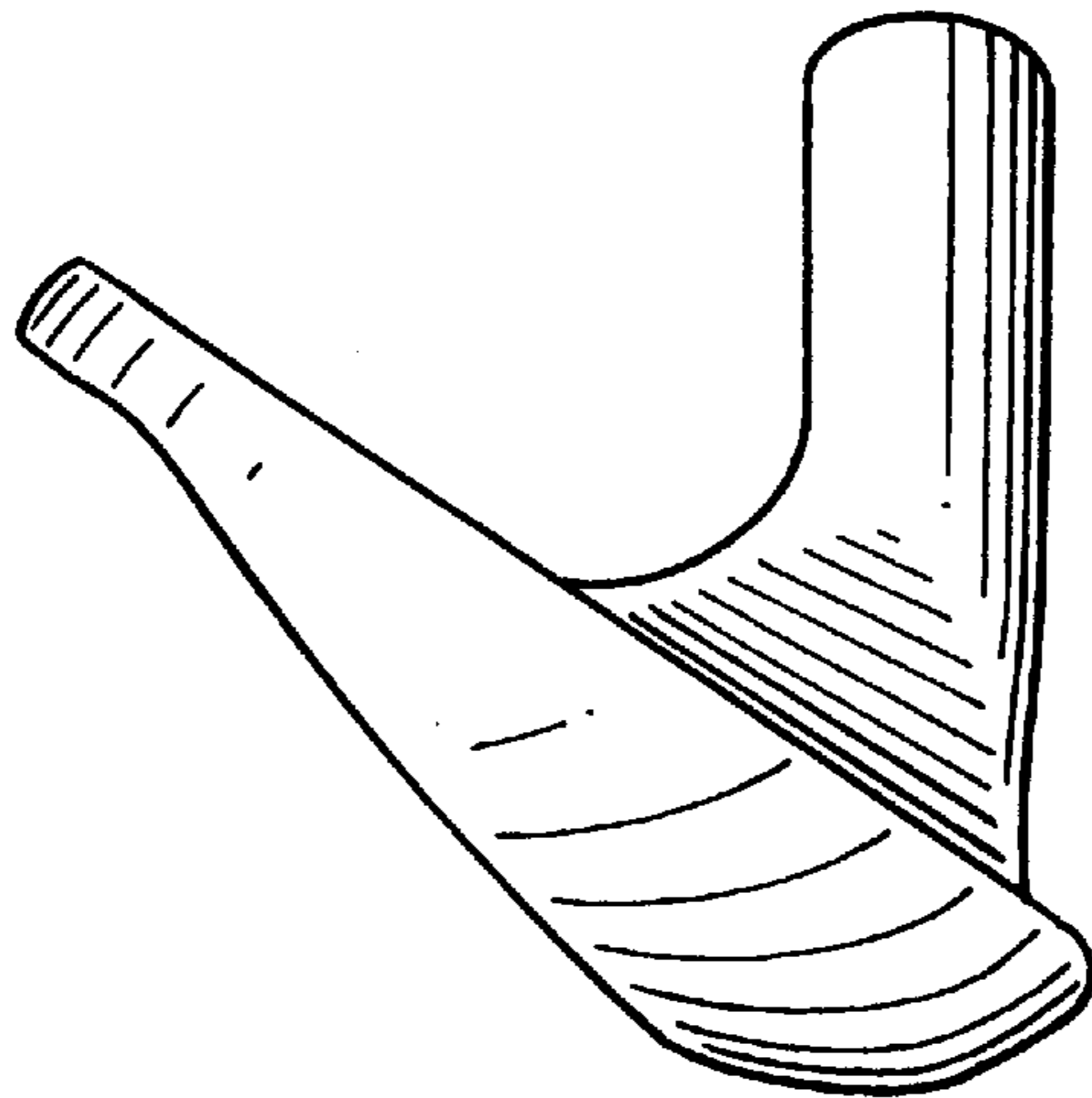

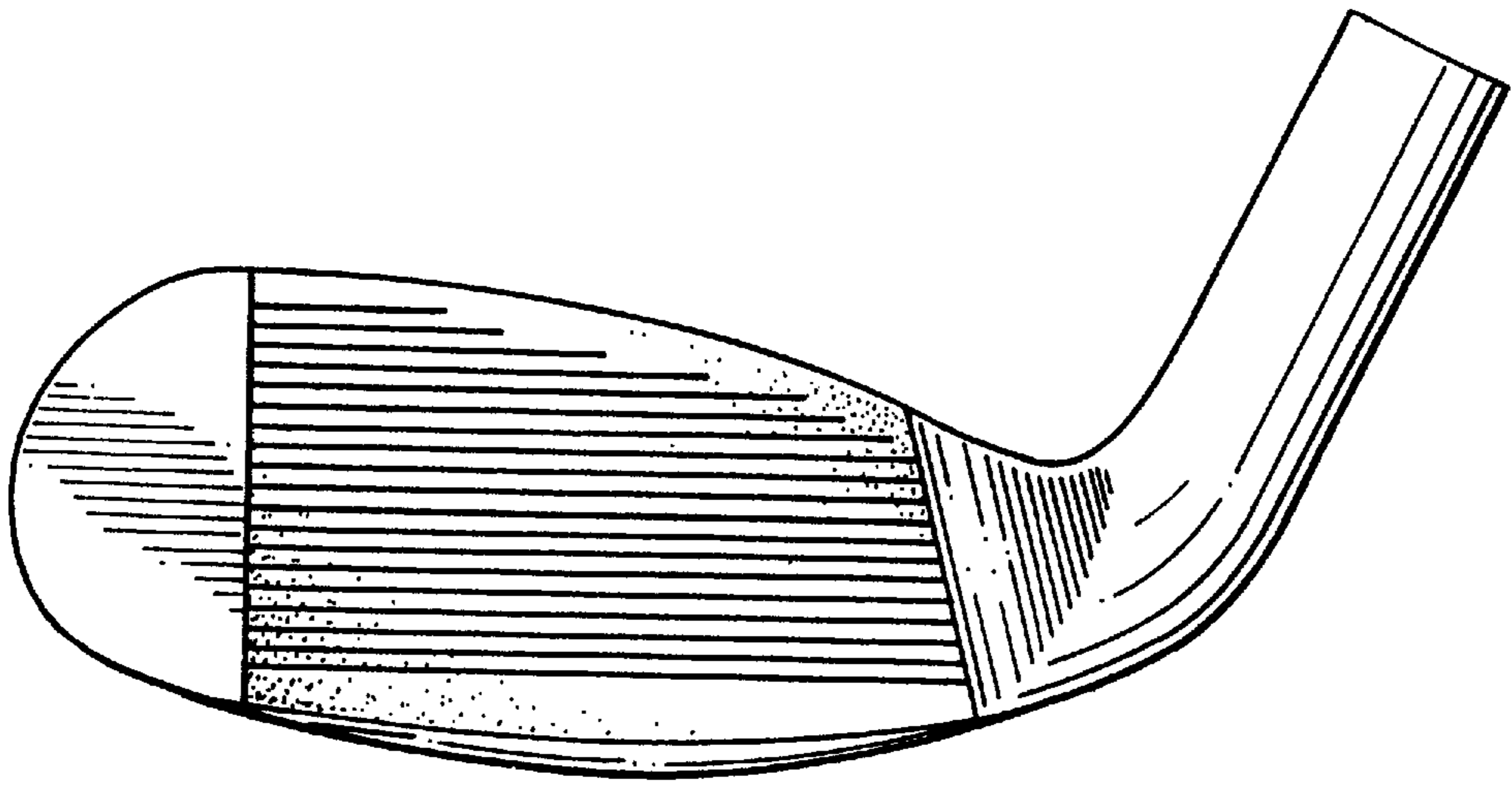

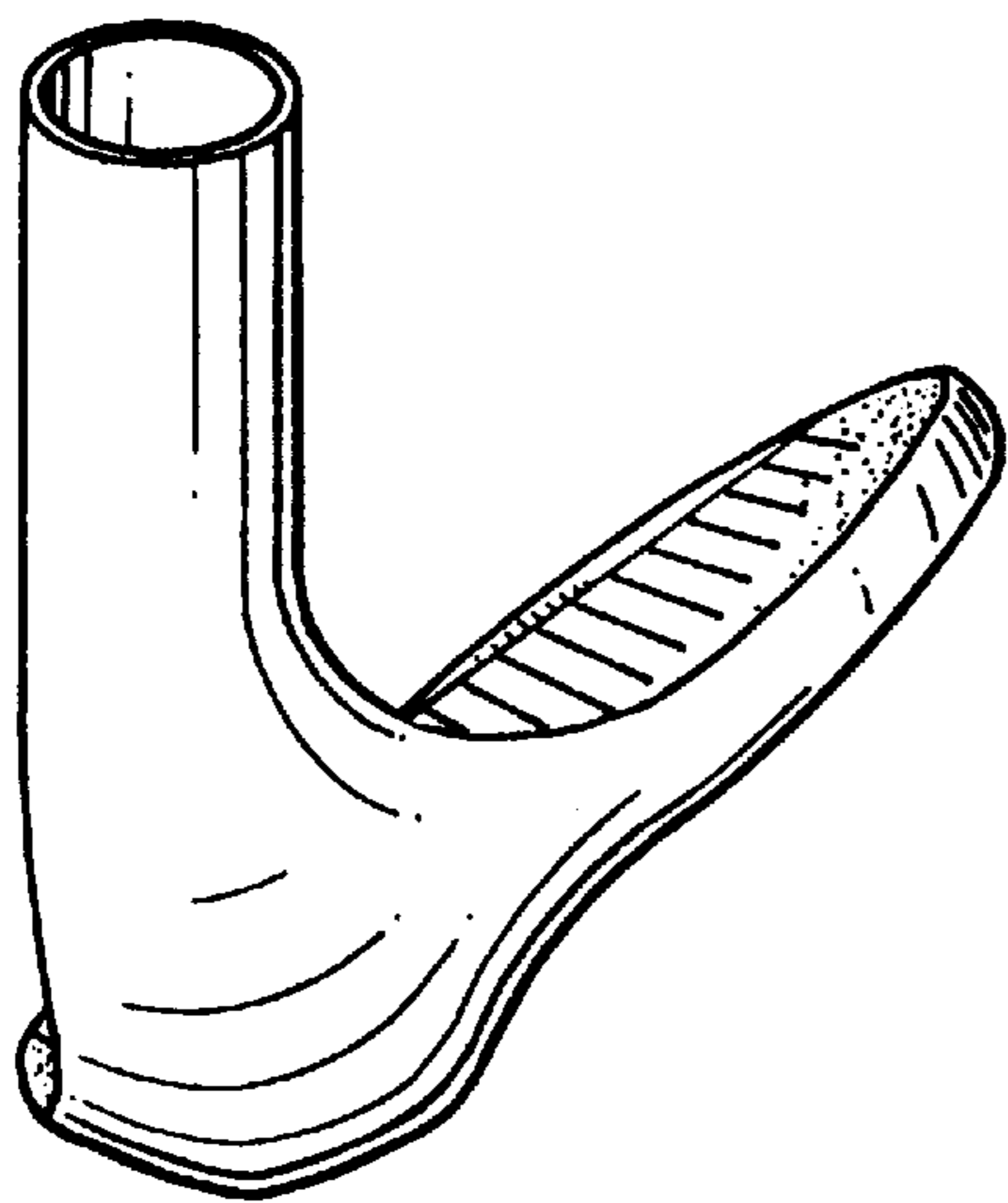

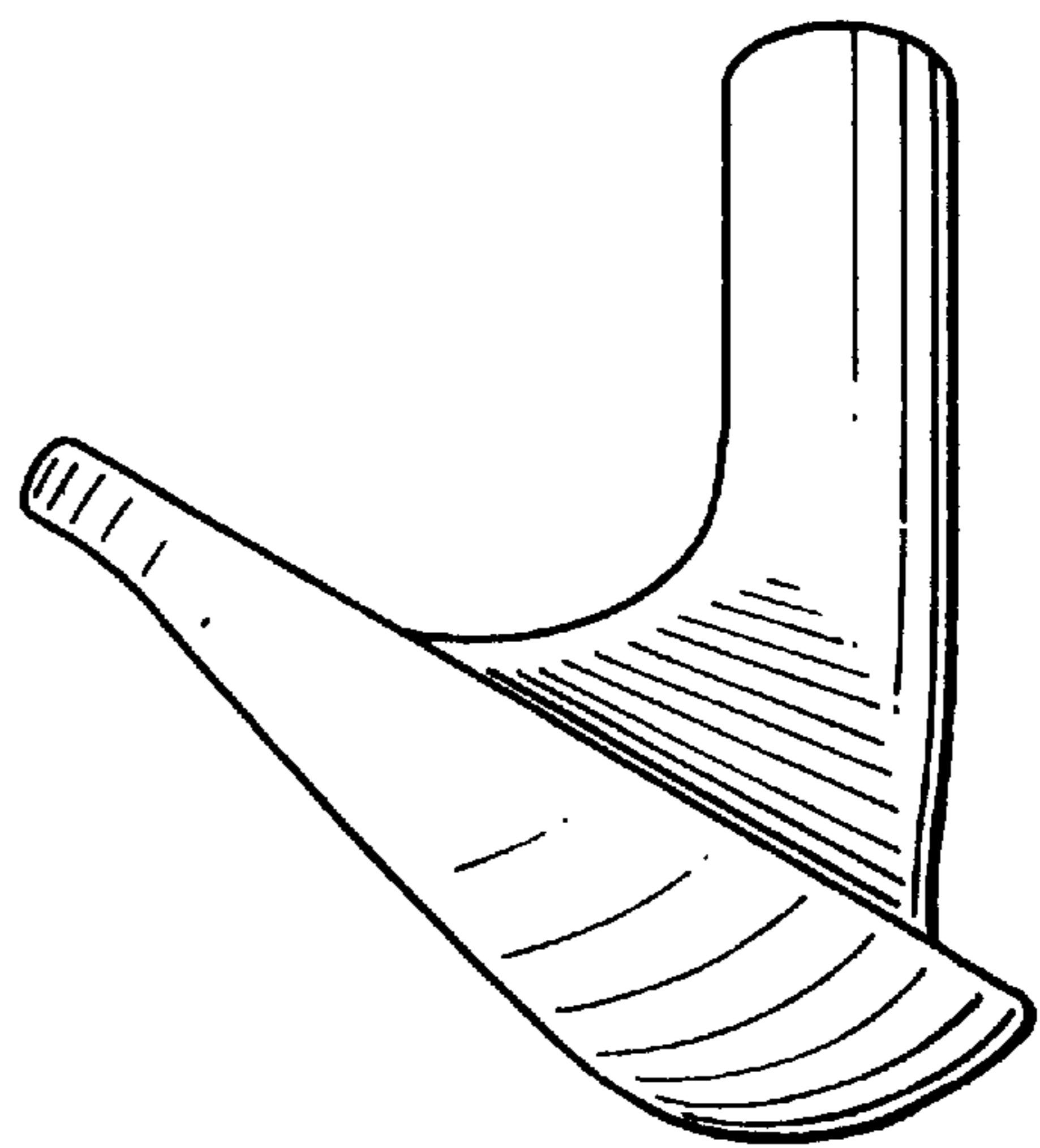

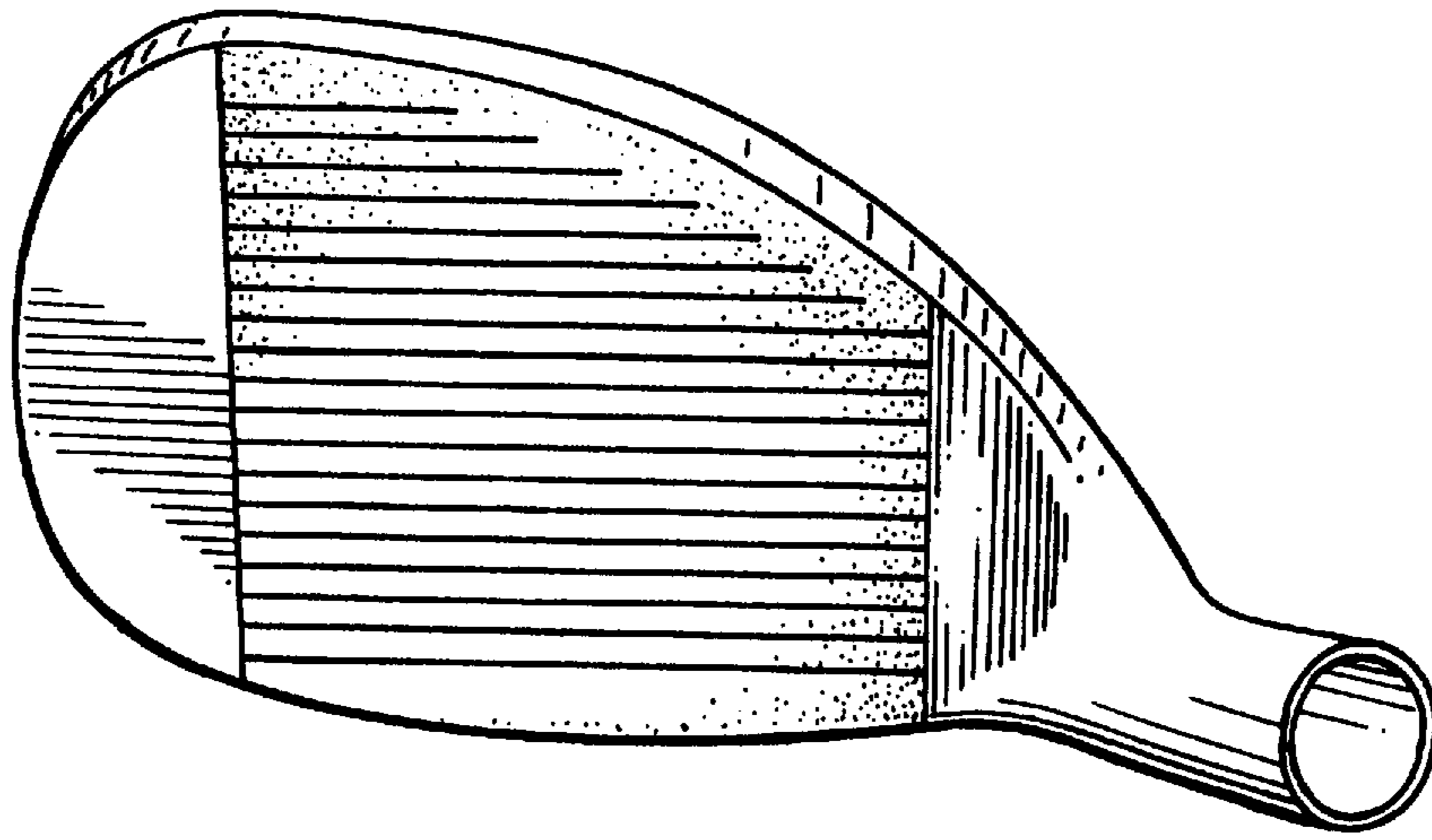

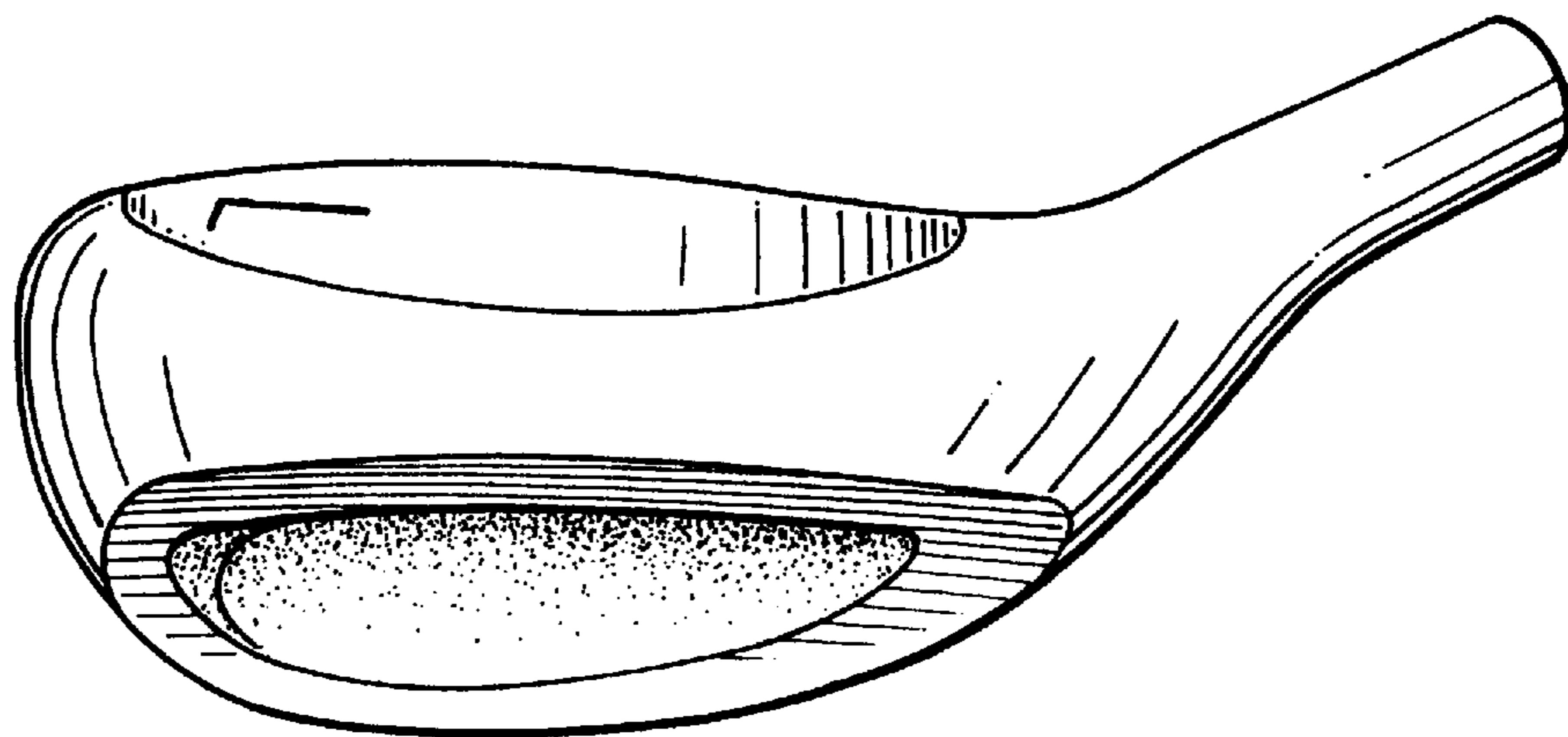

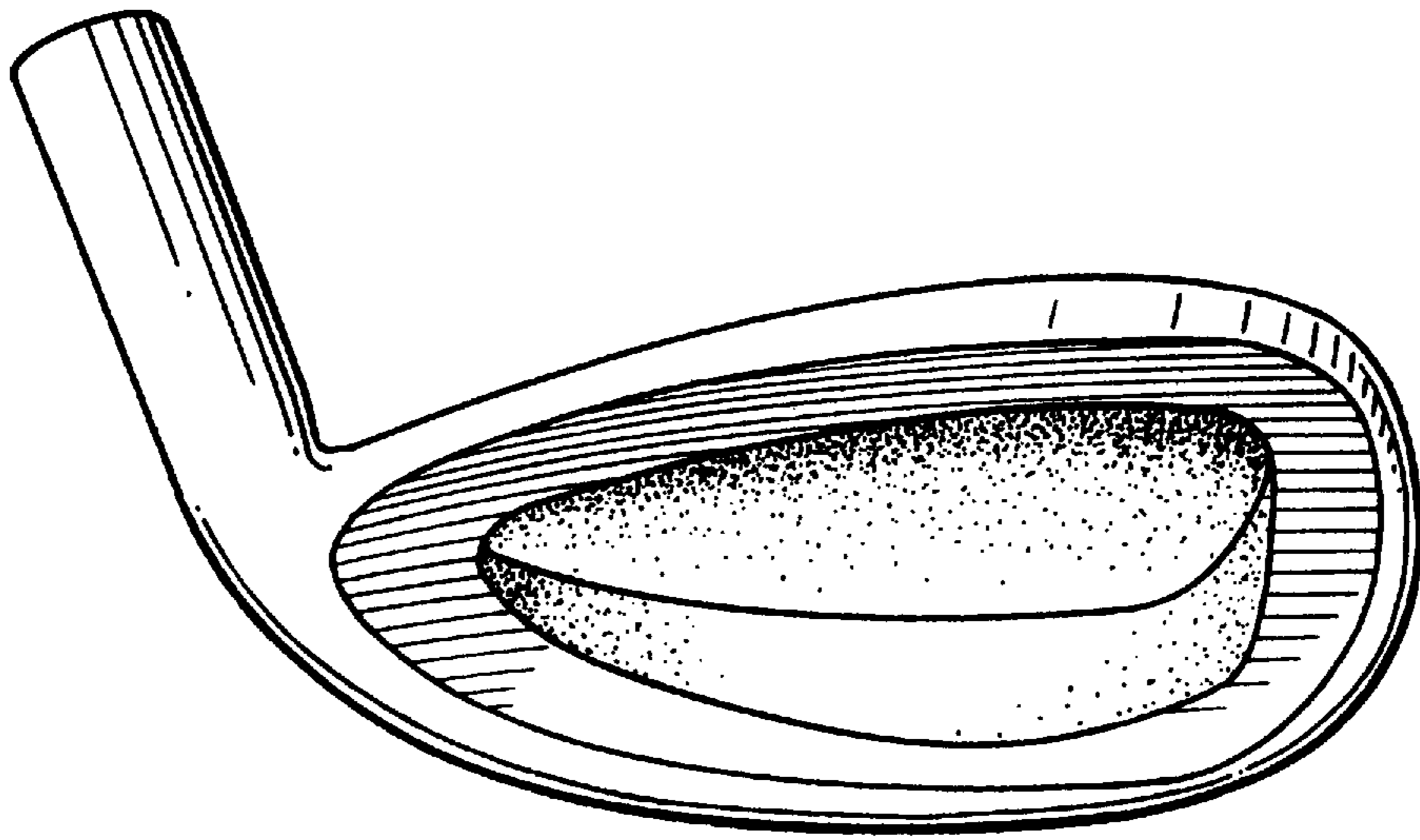
