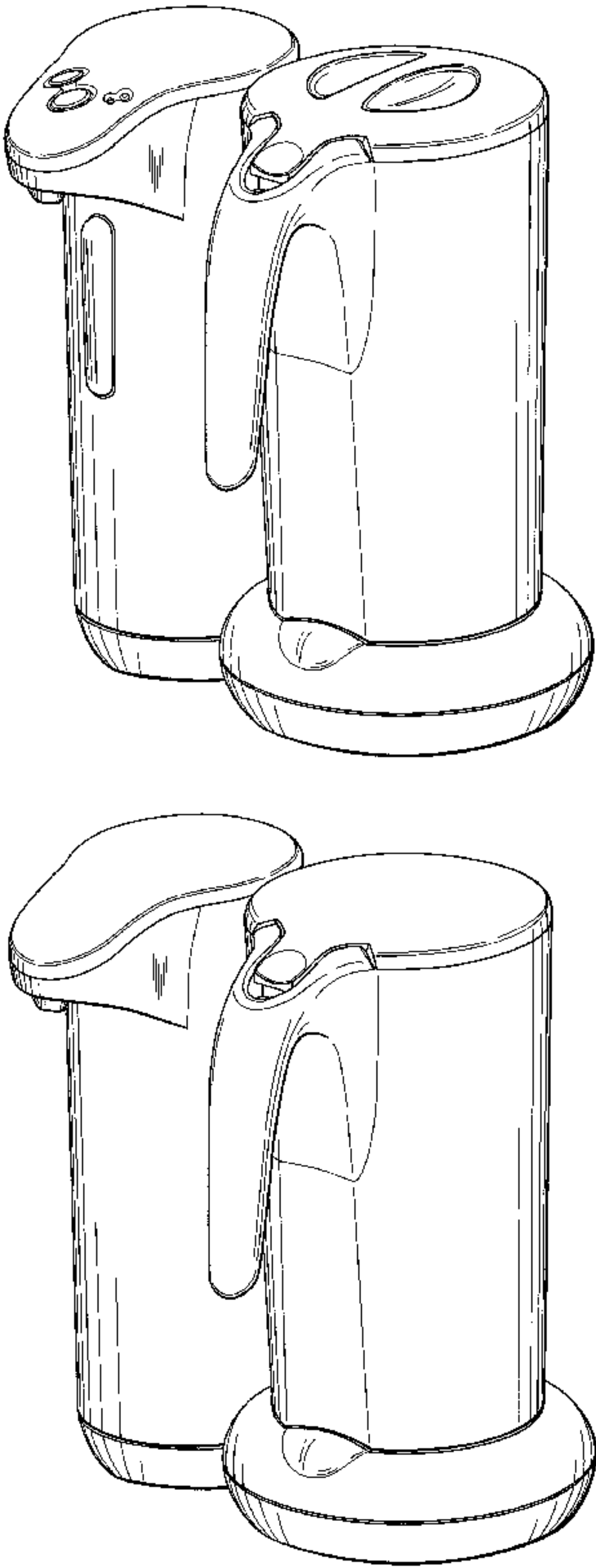
[57] CLAIM

DESCRIPTION

FIG. 1 is perspective view of water filter of the present invention;
FIG. 2 is a front elevational view of the water filter of FIG. 1;
FIG. 3 is a rear elevational view of the water filter of FIG. 1;
FIG. 4 is a left side elevational view of the water filter of FIG. 1;
FIG. 5 is a right side elevational view of the water filter of FIG. 1;
FIG. 6 is a bottom plan view of the water filter of FIG. 1;
FIG. 7 is a top plan view of the water filter of FIG. 1;
FIG. 8 is perspective view of another water filter of the present invention;
FIG. 9 is a front elevational view of the water filter of FIG. 8;

FIG. 12 is a right side elevational view of the water filter of FIG. 8;

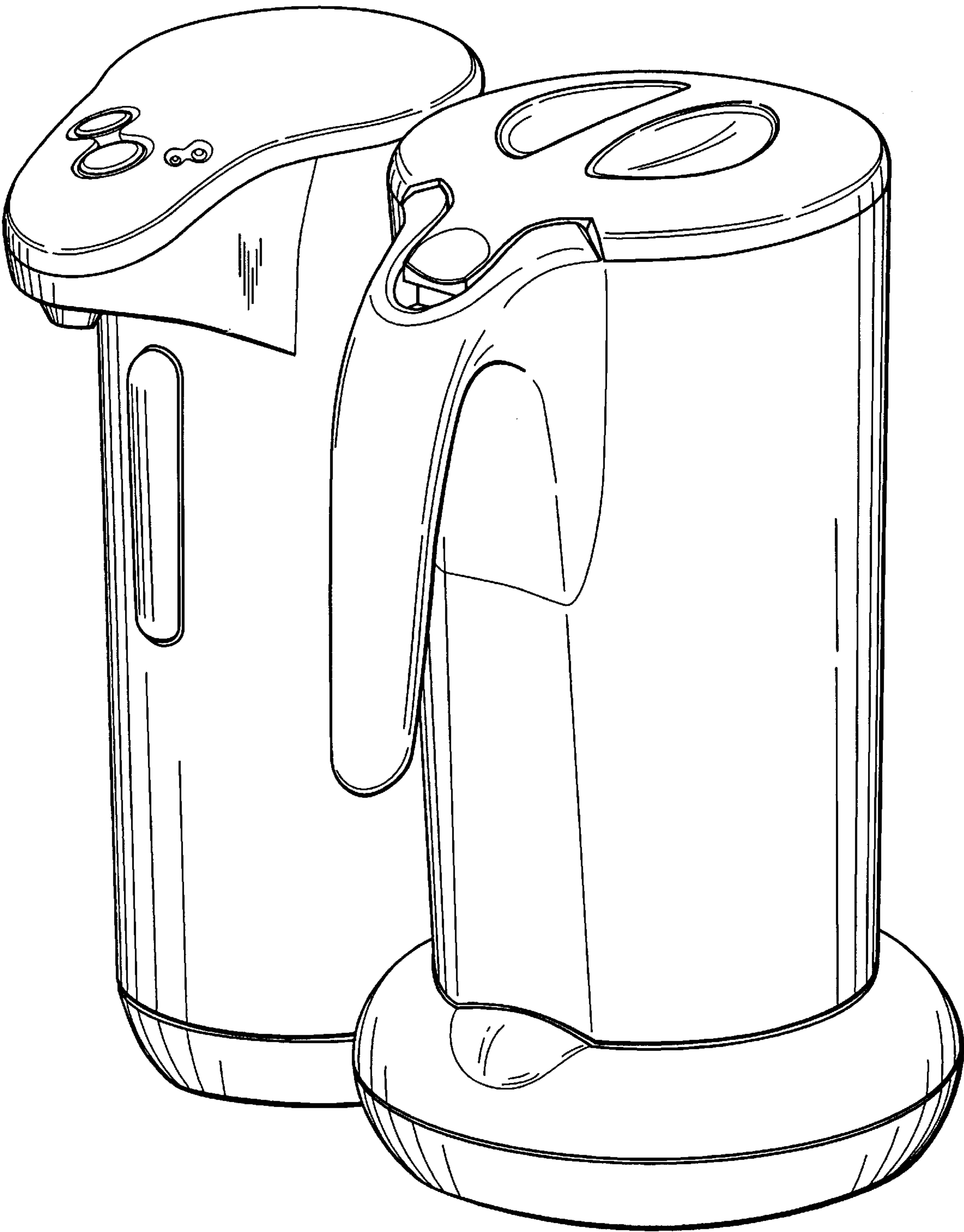

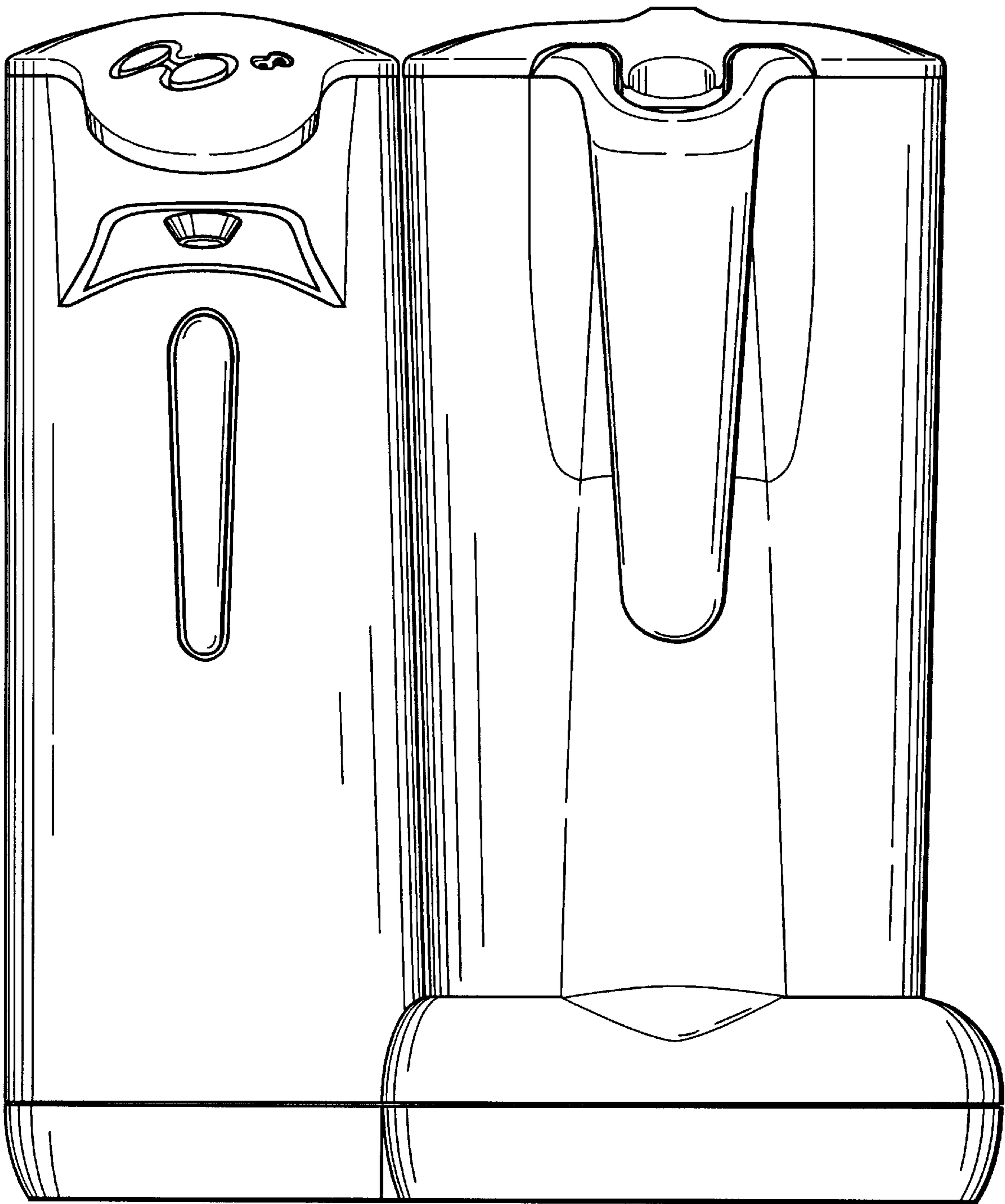

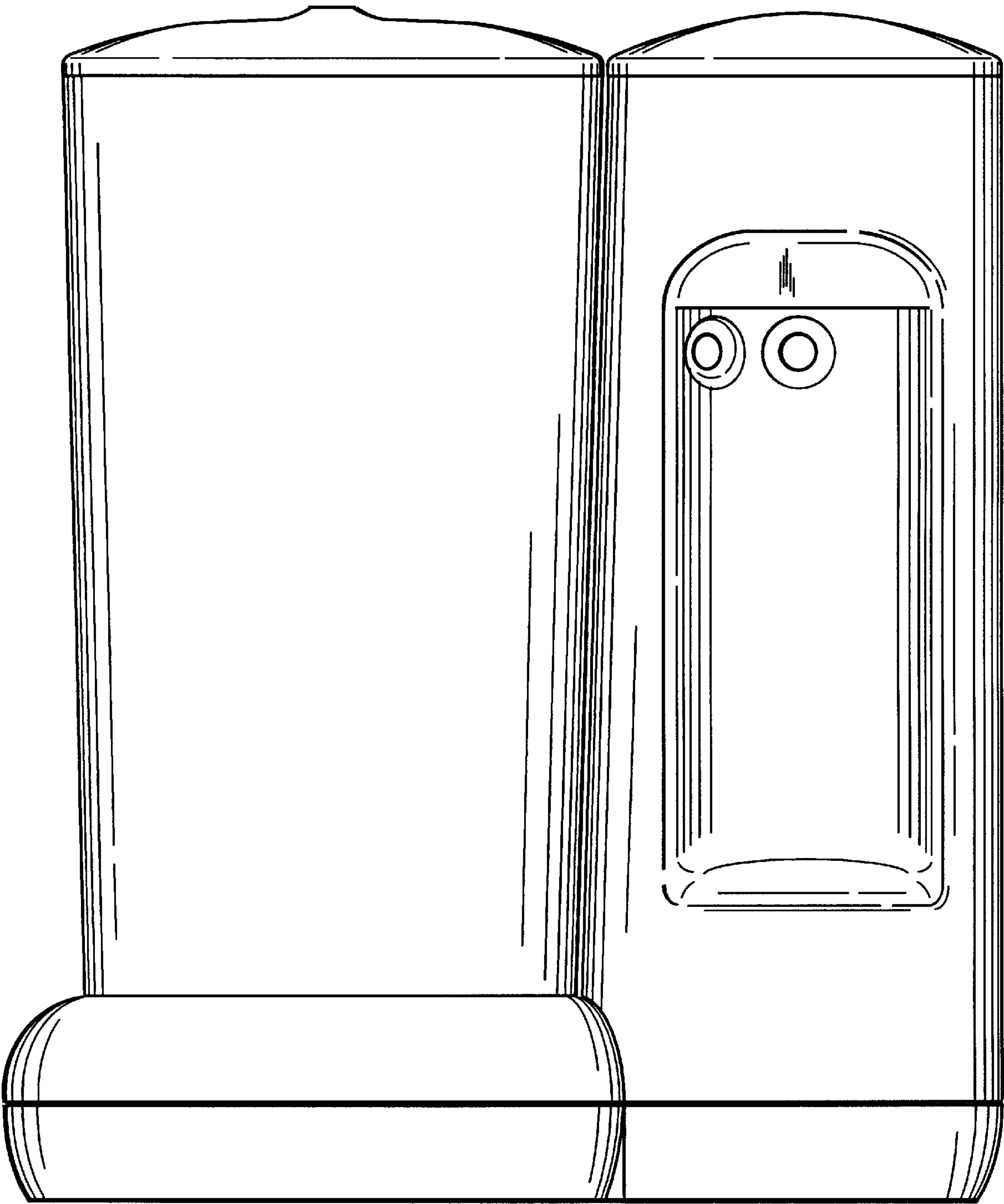

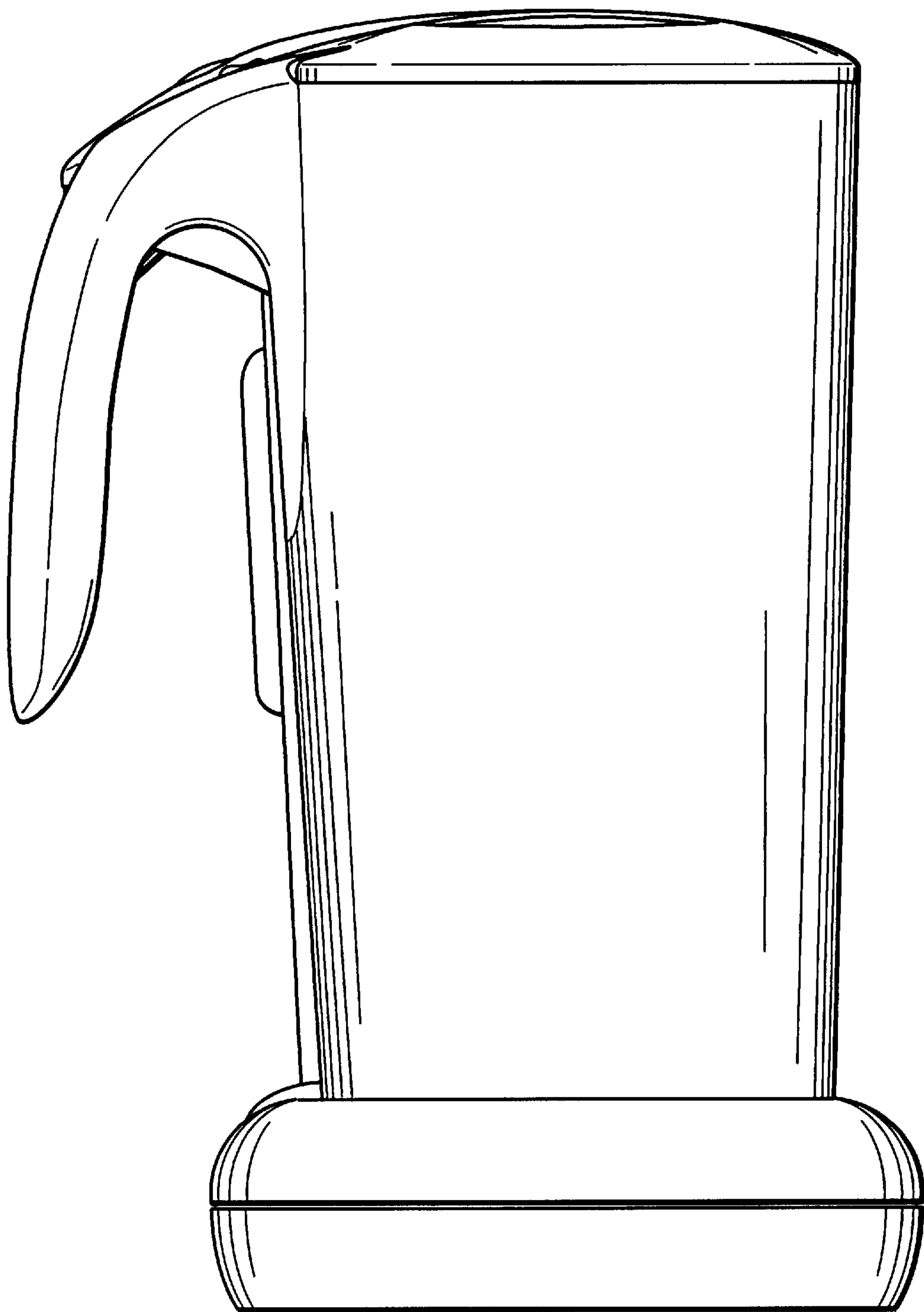

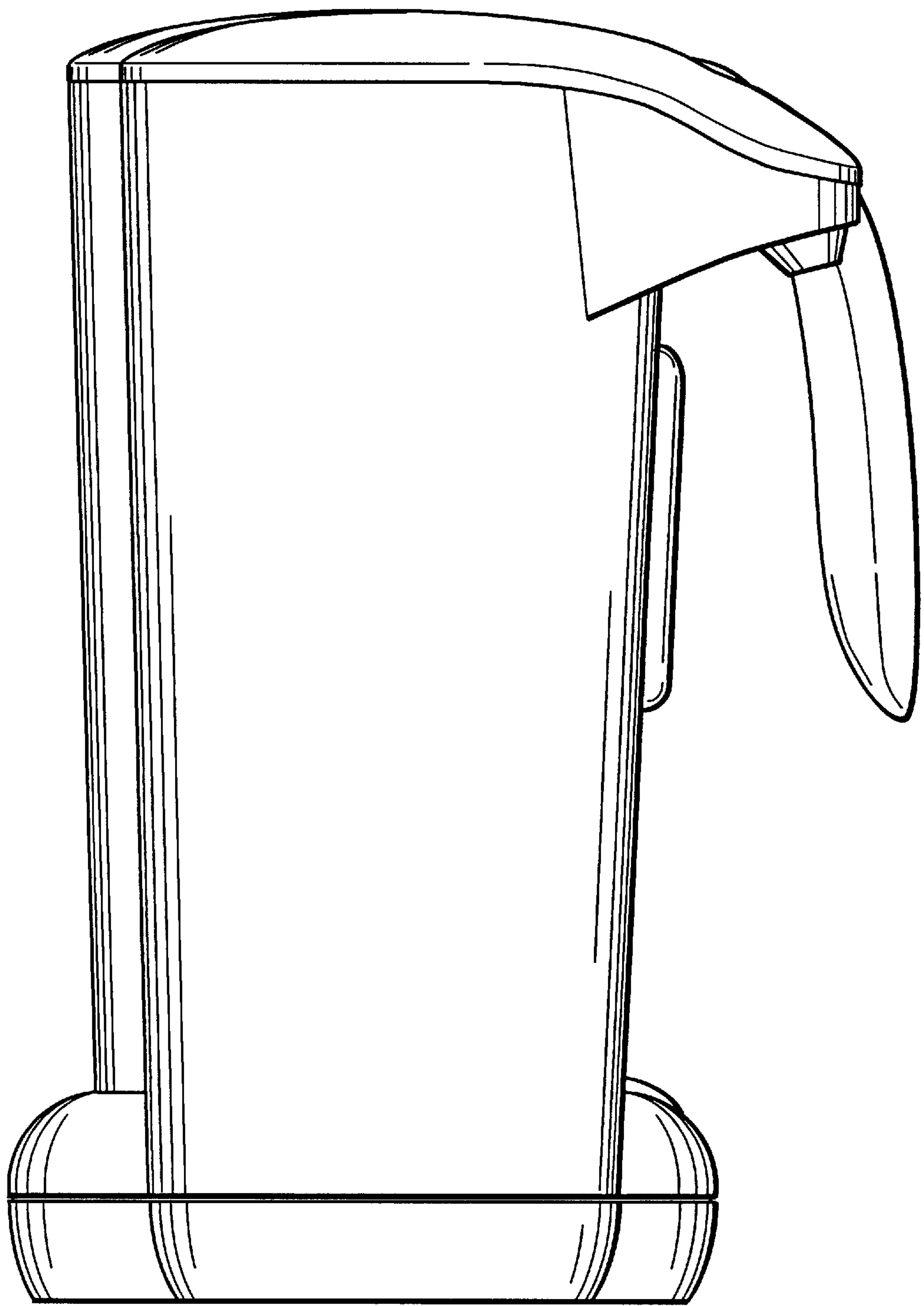
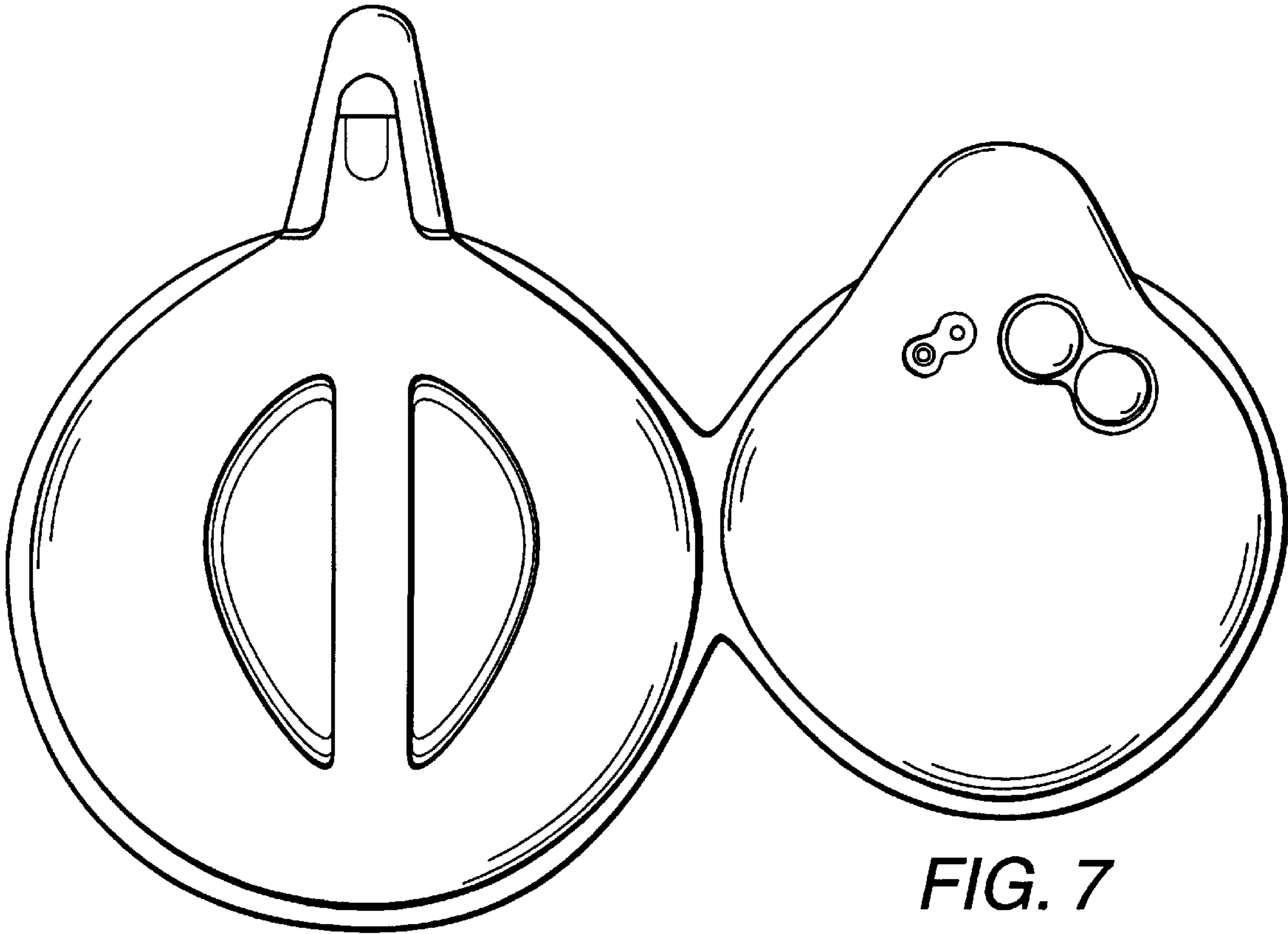
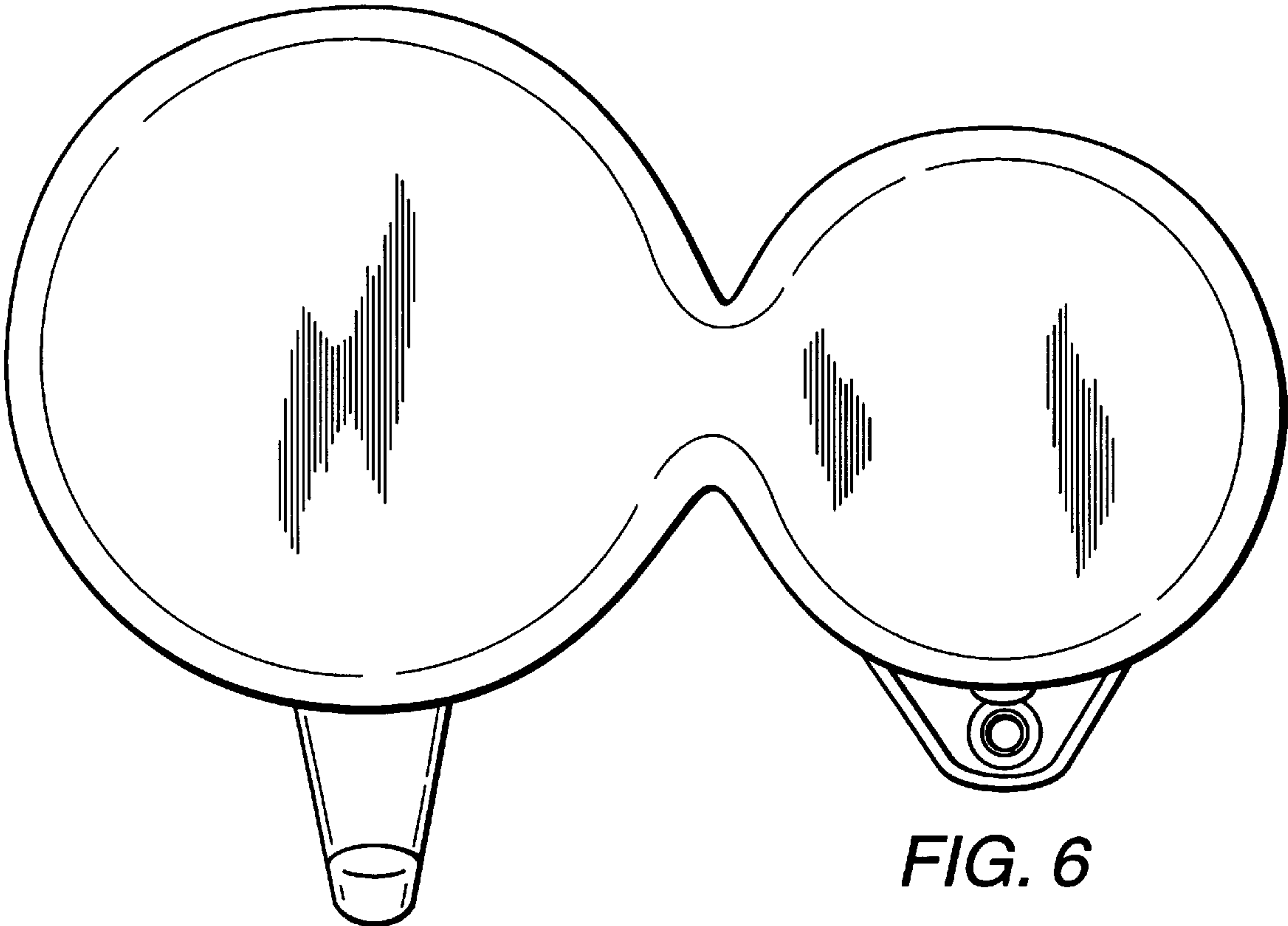

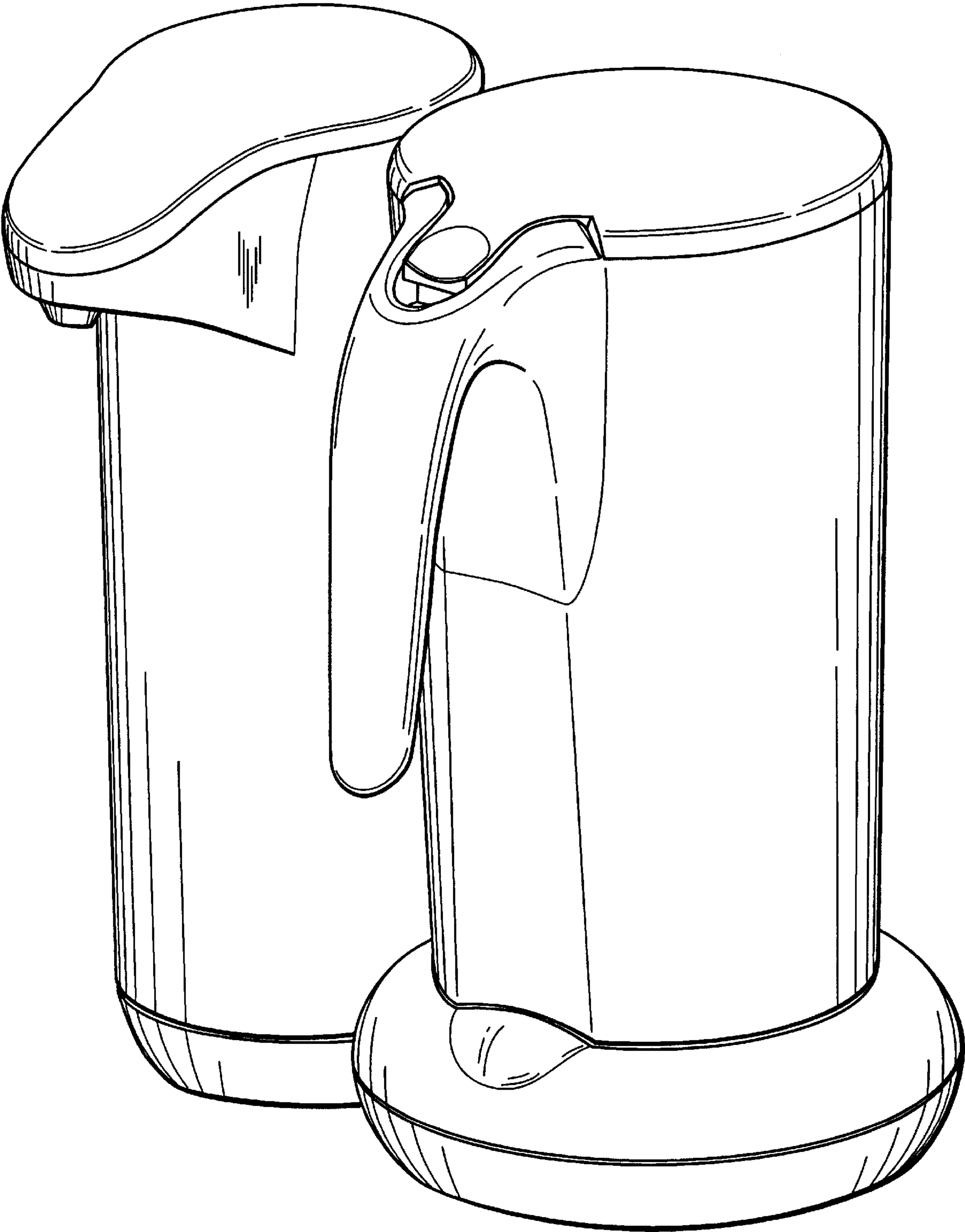

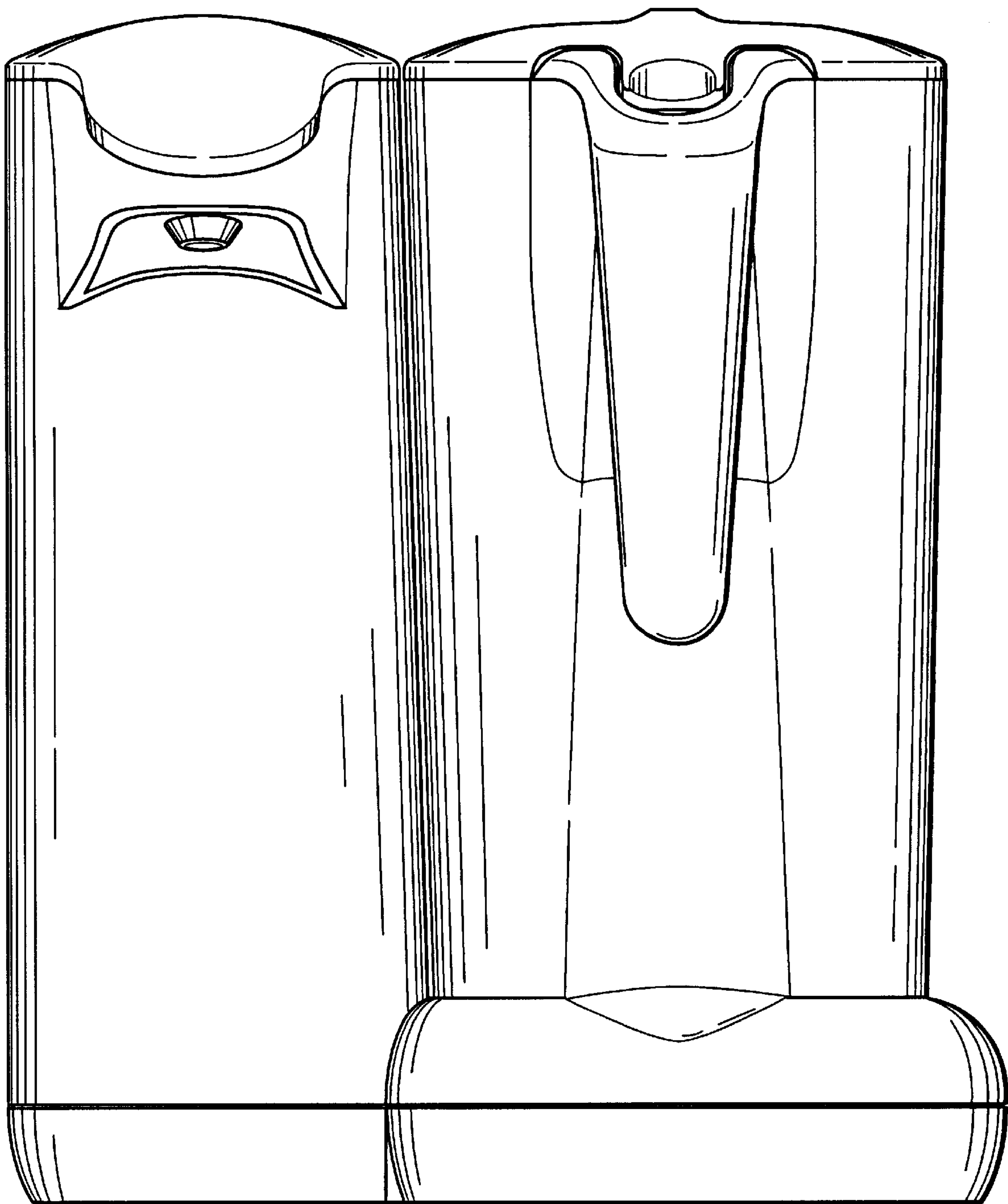

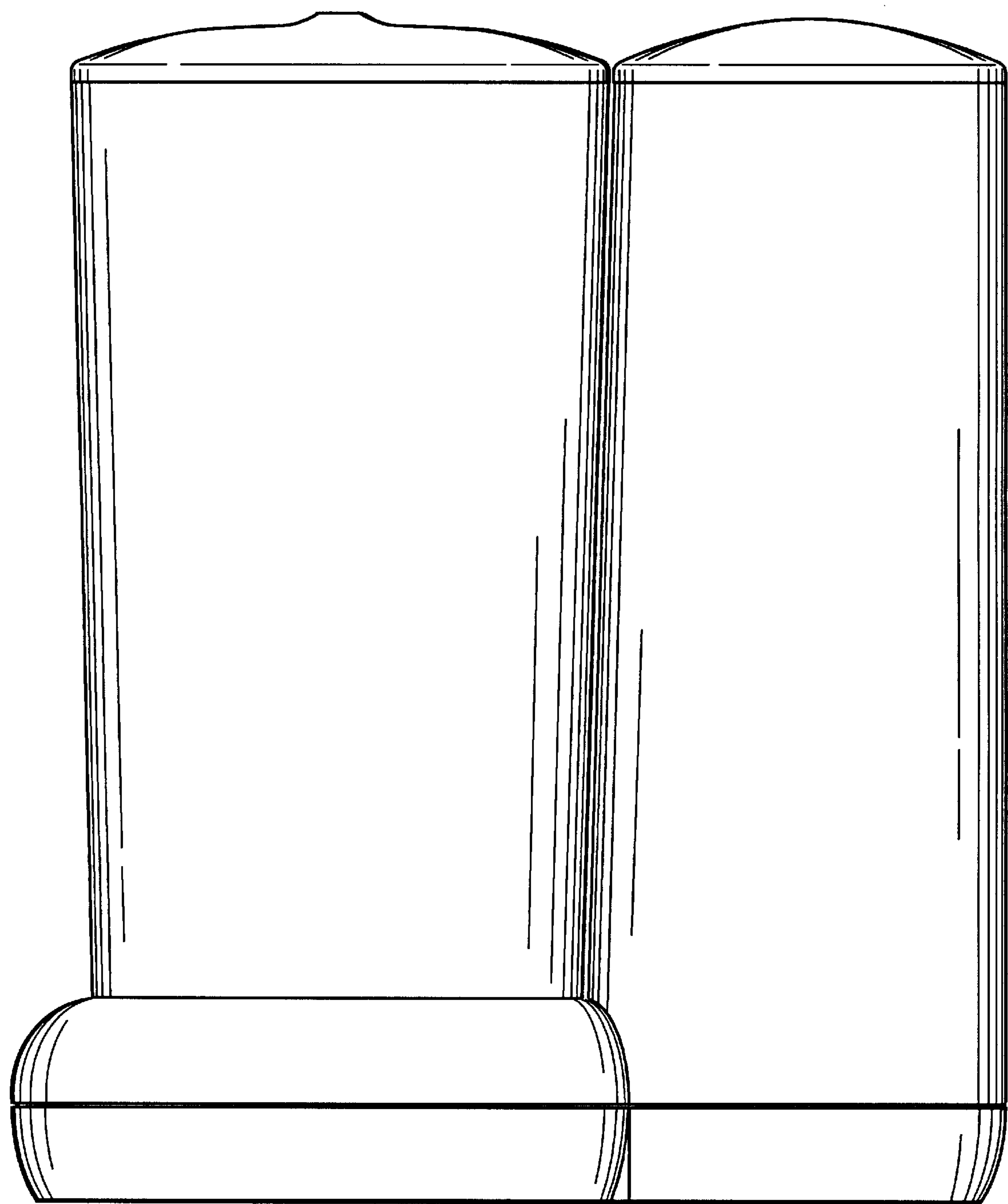

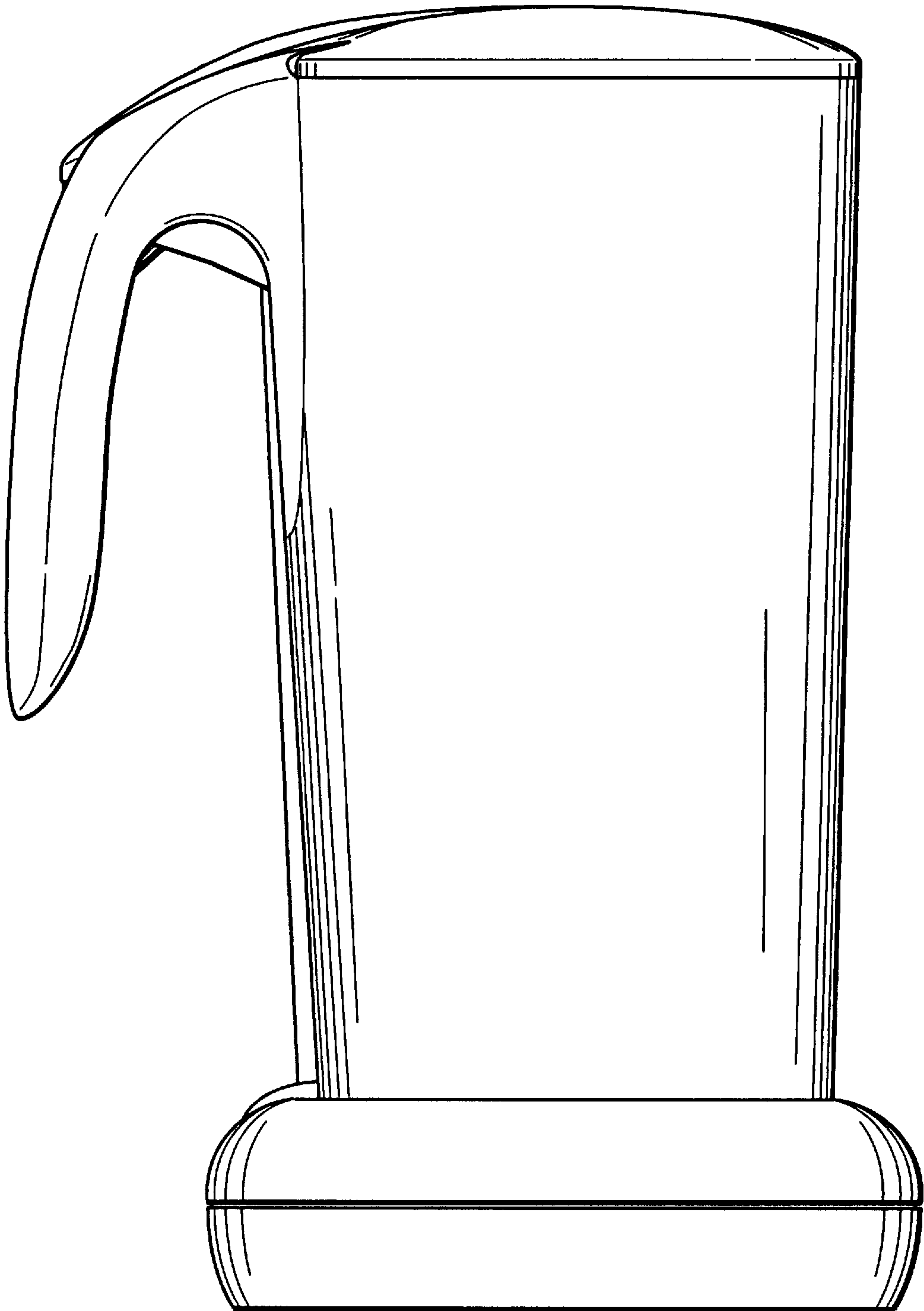

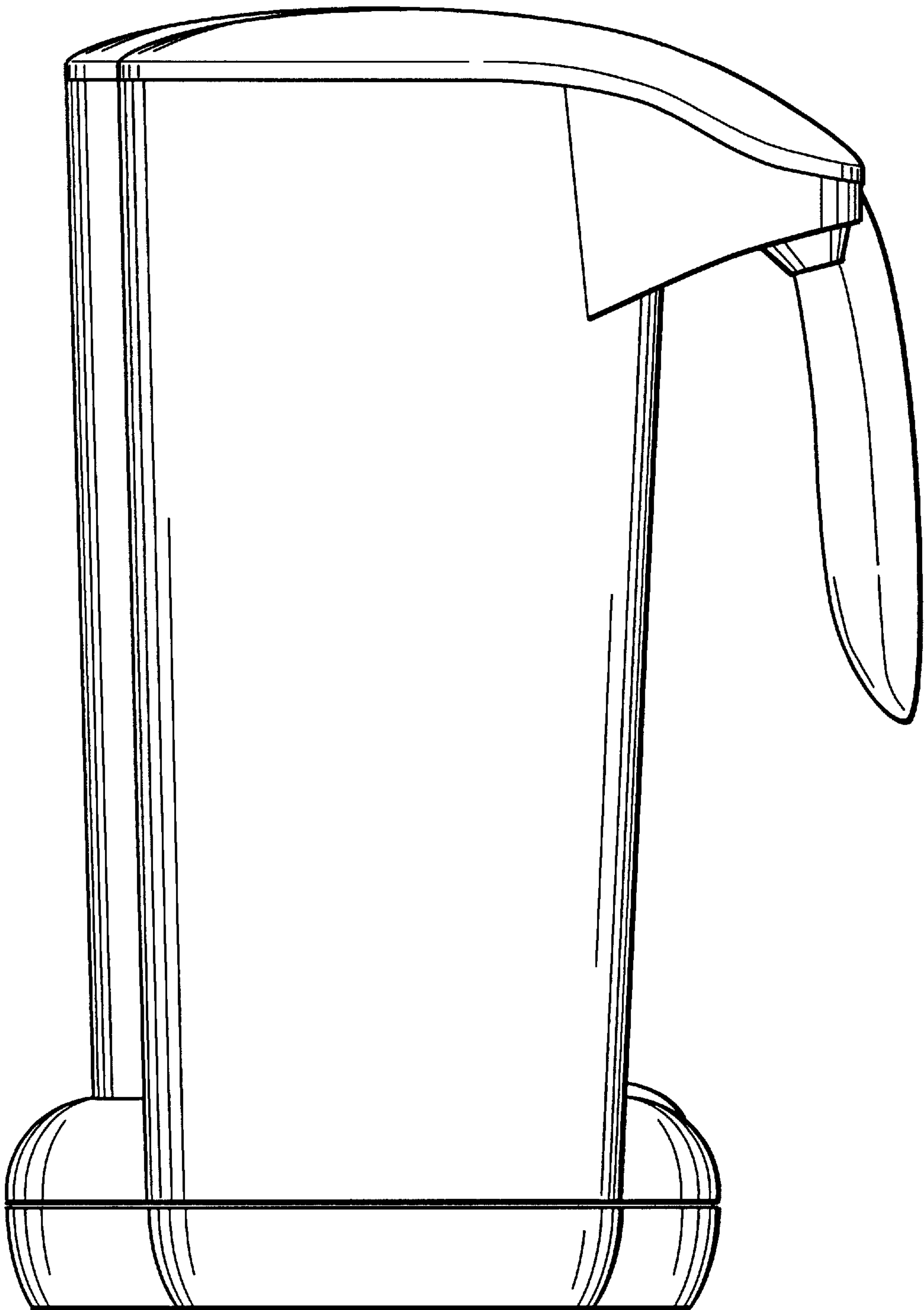

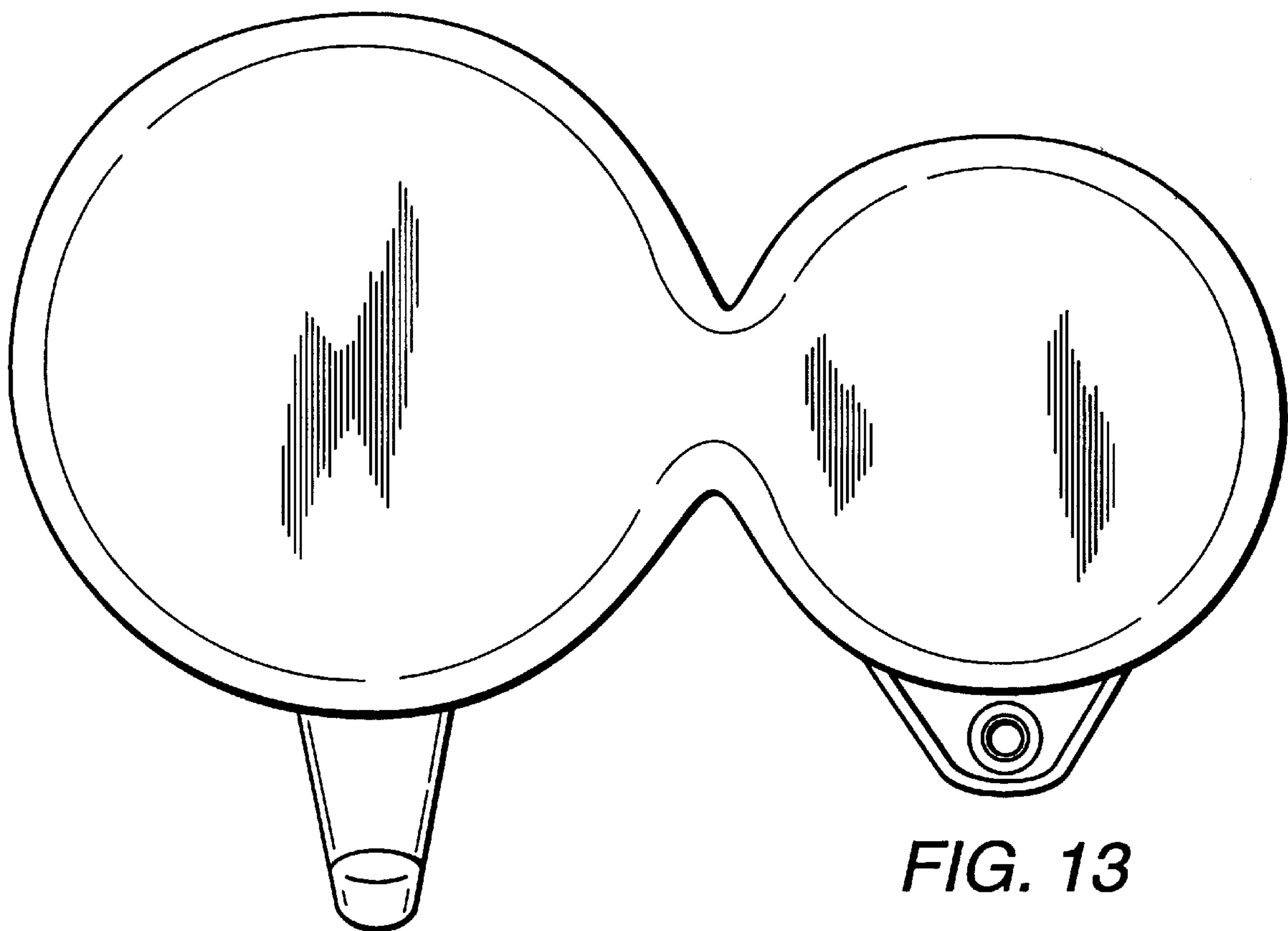

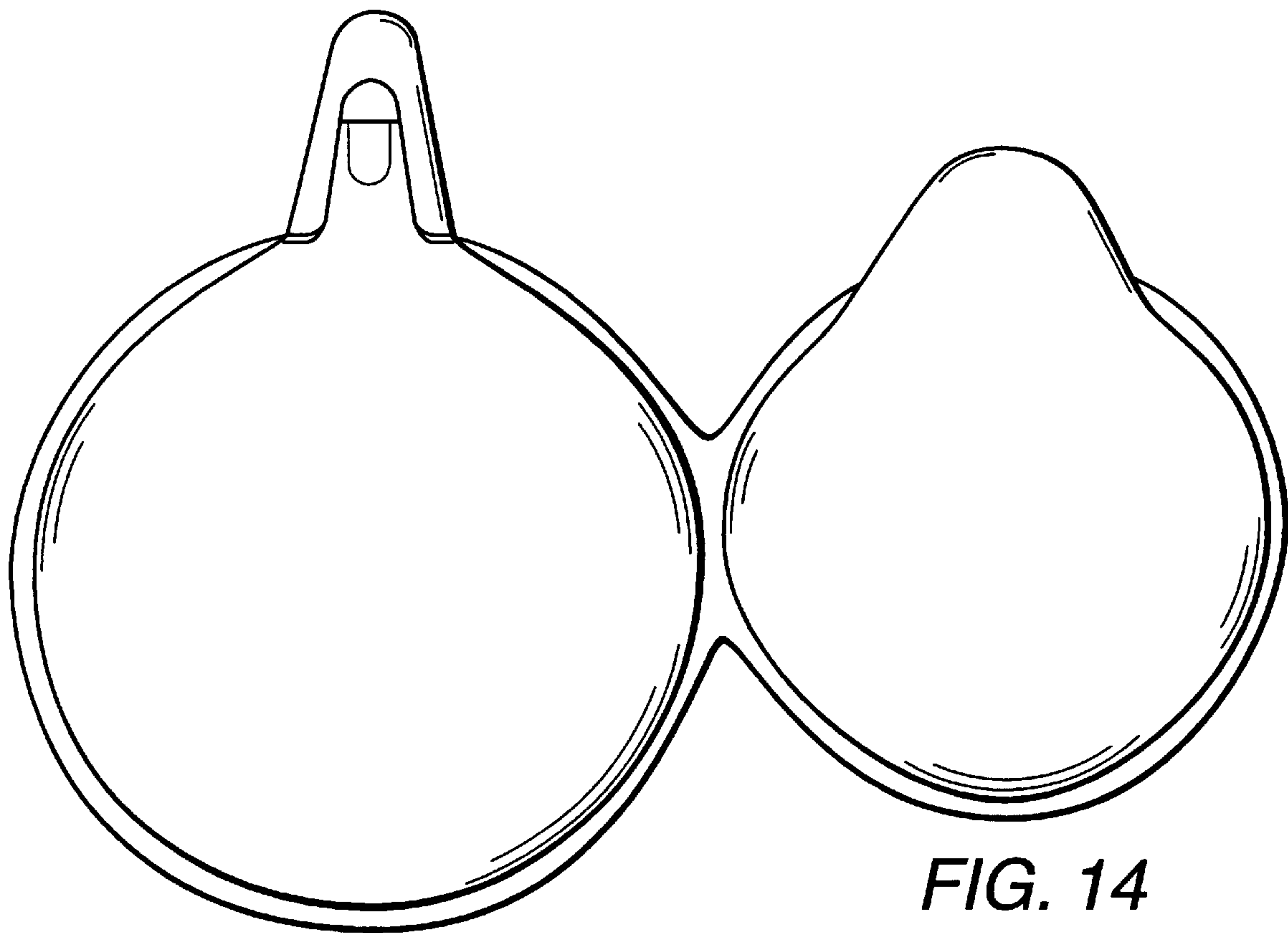
