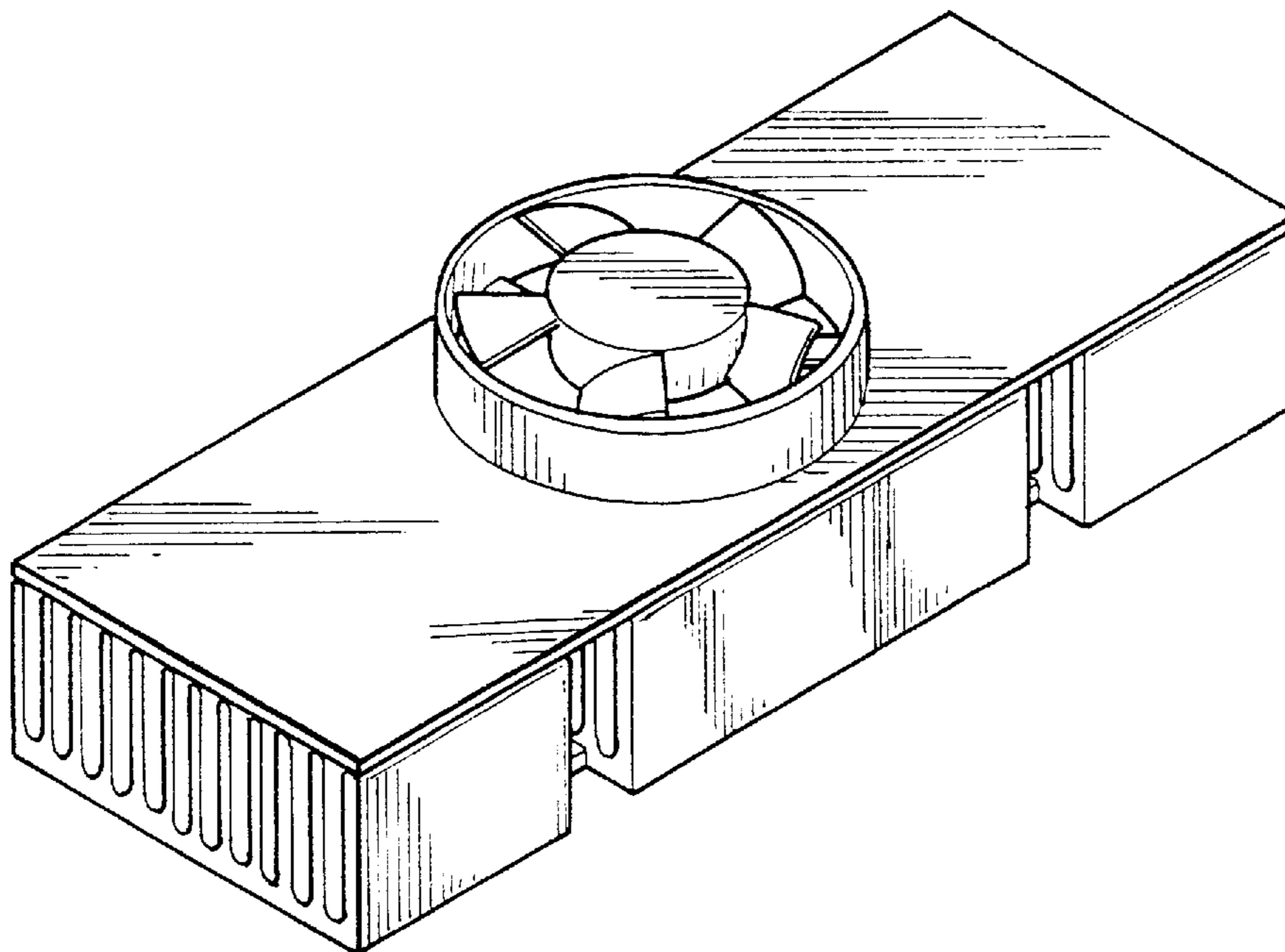
[57] **CLAIM**

The ornamental design for a heat dissipation fan, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the heat dissipation fan in accordance with the first embodiment of the claimed design; FIG. 2 is a top plan view thereof; FIG. 3 is a right side elevational view thereof; FIG. 4 is a front elevational view thereof; FIG. 5 is a rear elevational view thereof; FIG. 6 is a left side elevational view thereof; FIG. 7 is a bottom plan view thereof; FIG. 8 is a perspective view of the heat dissipation fan in accordance with the second embodiment of the claimed design; FIG. 9 is a top plan view of FIG. 8; FIG. 10 is a right side elevational view of FIG. 8; FIG. 11 is a front elevational view of FIG. 8; FIG. 12 is a rear elevational view of FIG. 8; FIG. 13 is a left side elevational view of FIG. 8; and, FIG. 14 is a bottom plan view of FIG. 8.

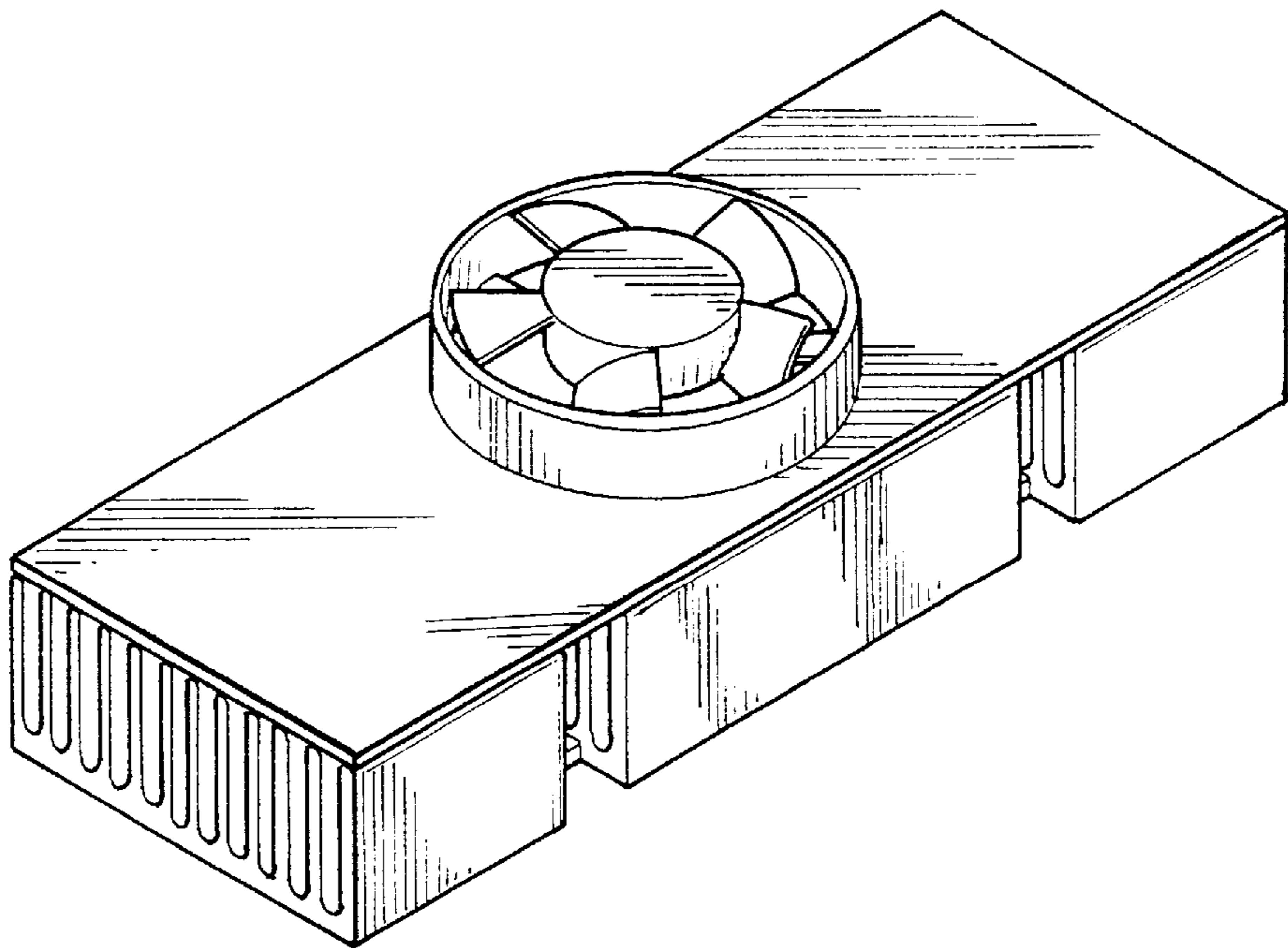

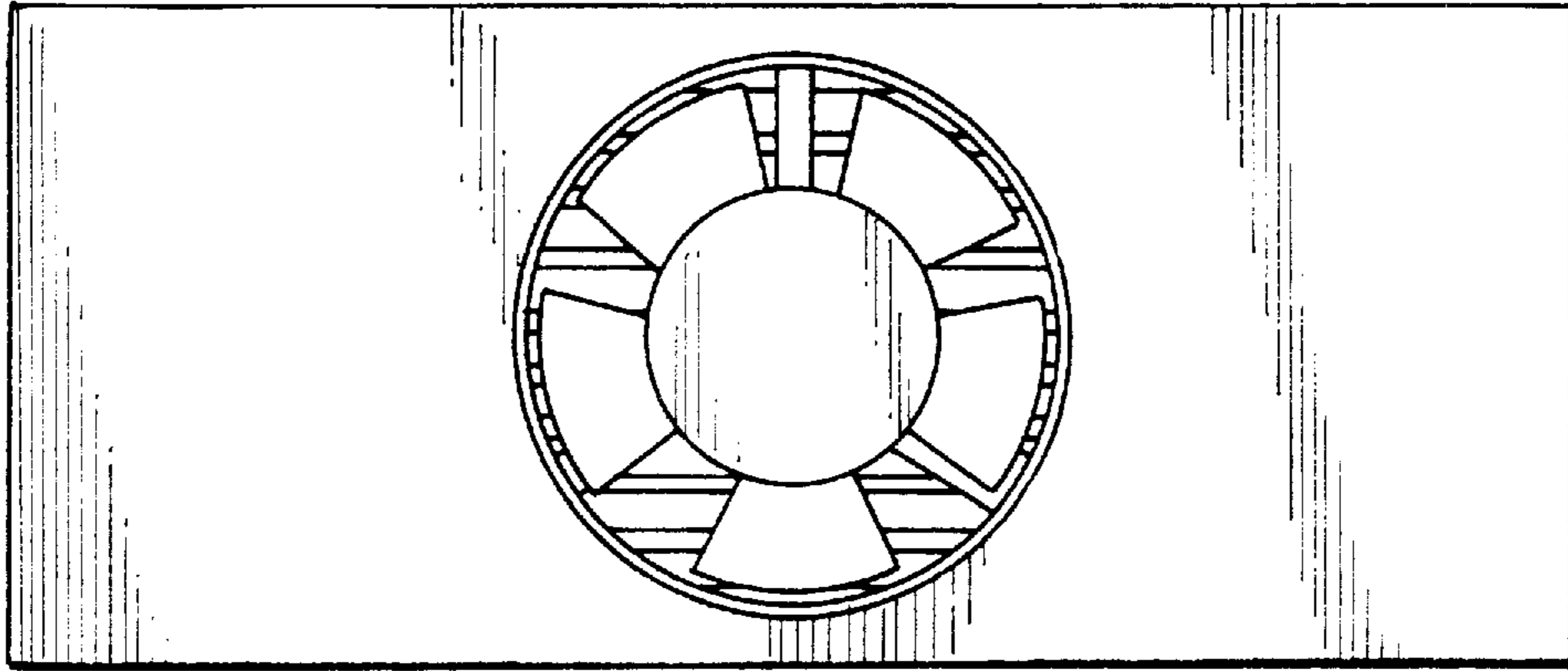

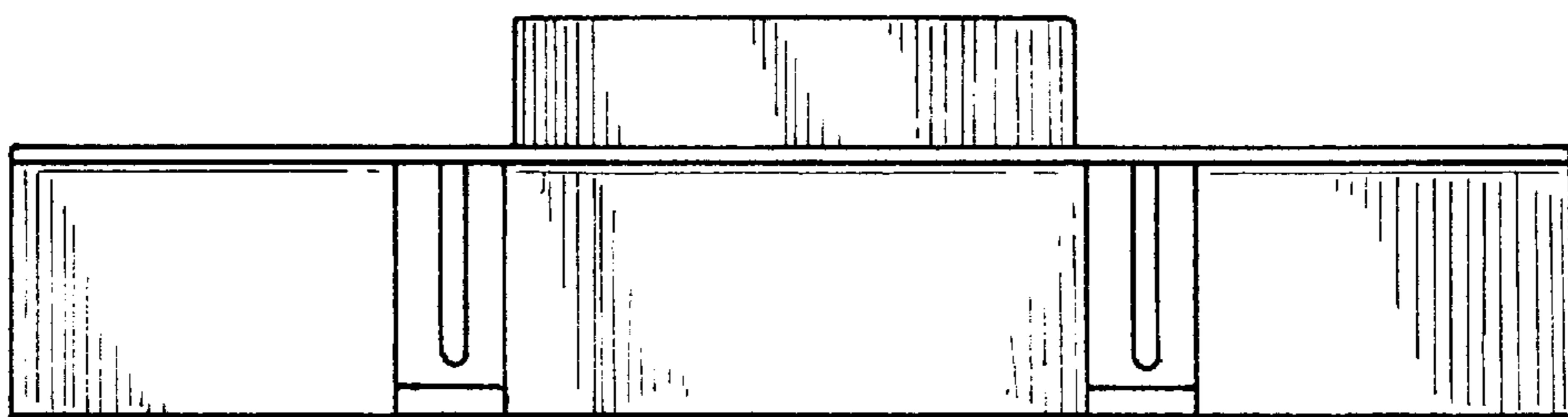

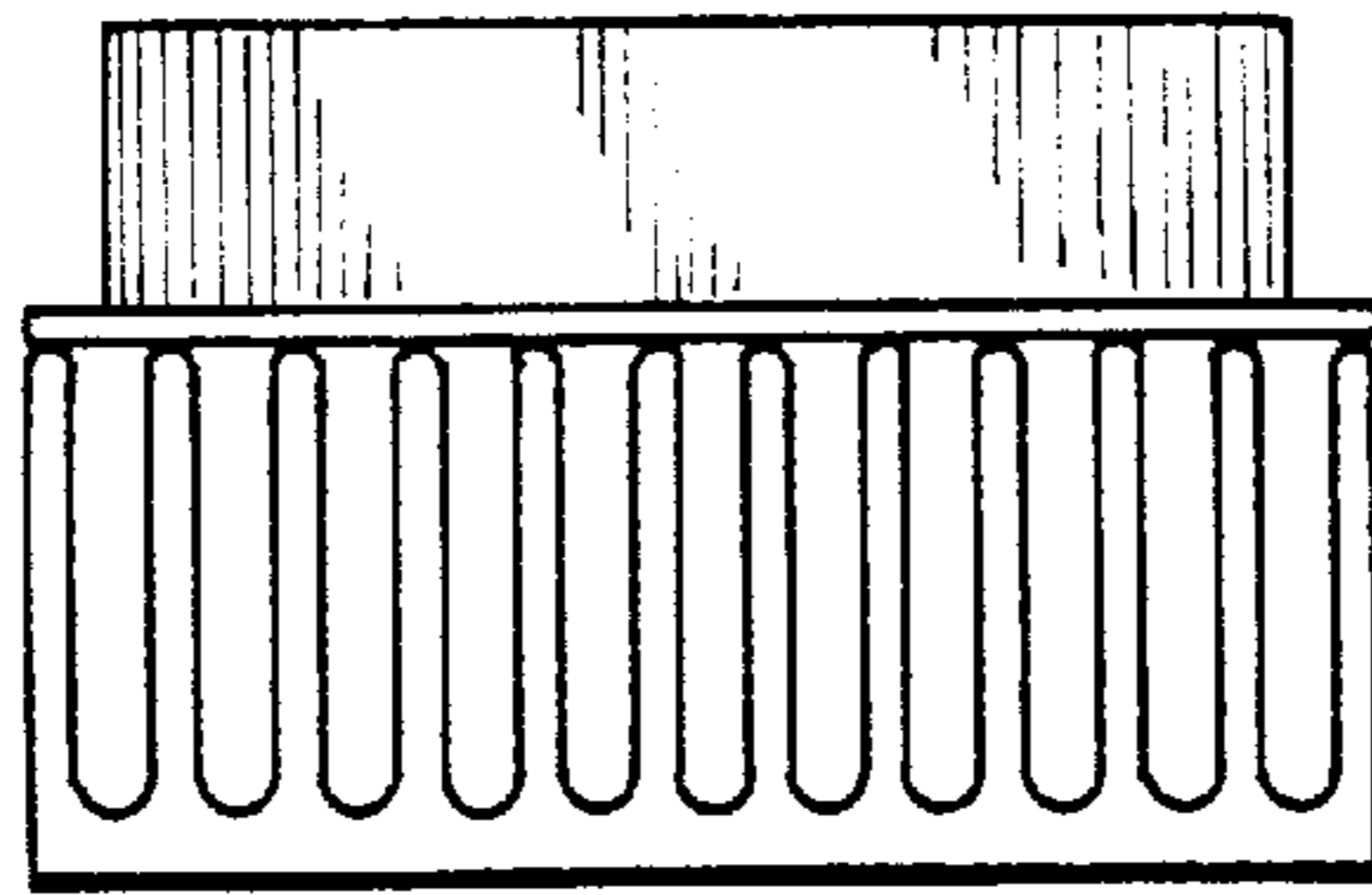

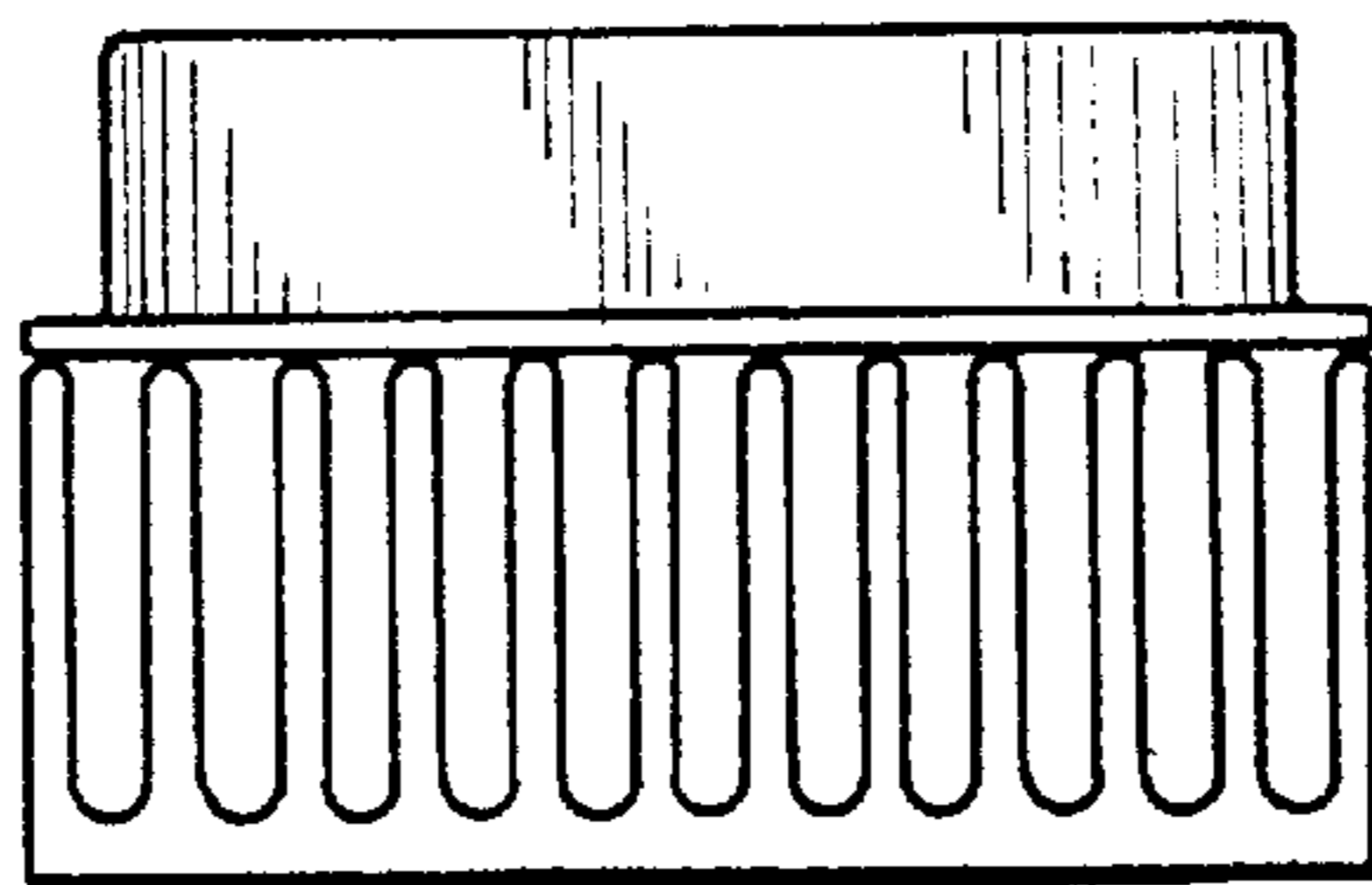

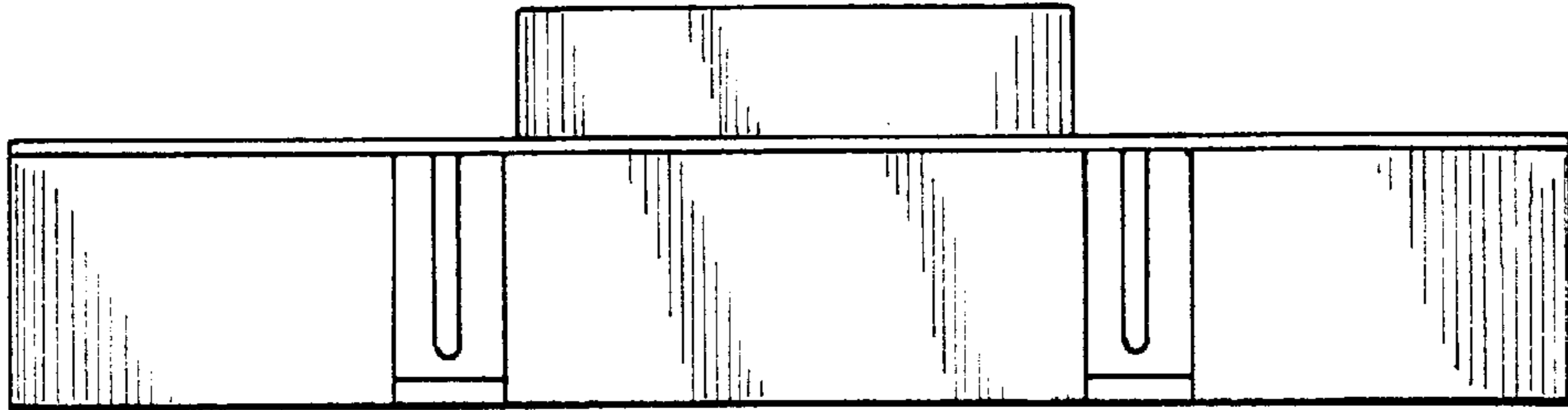

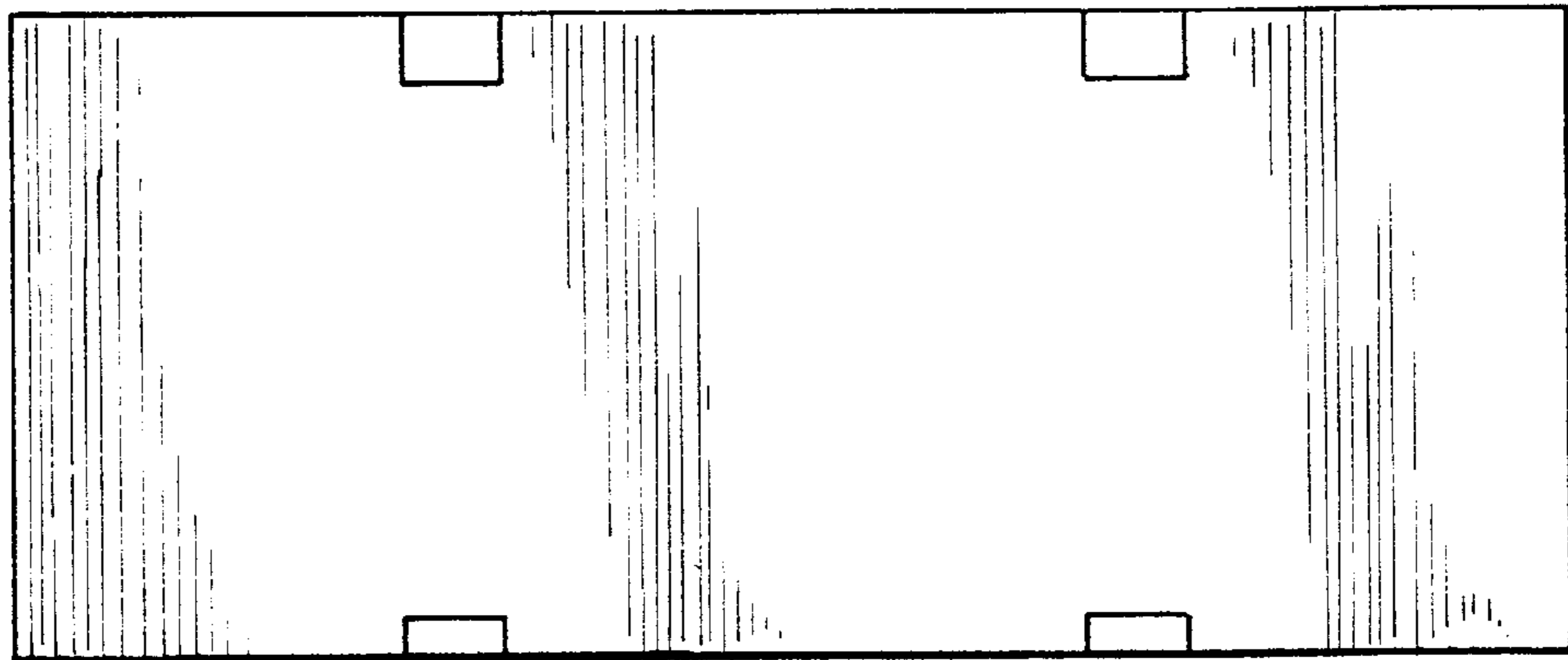

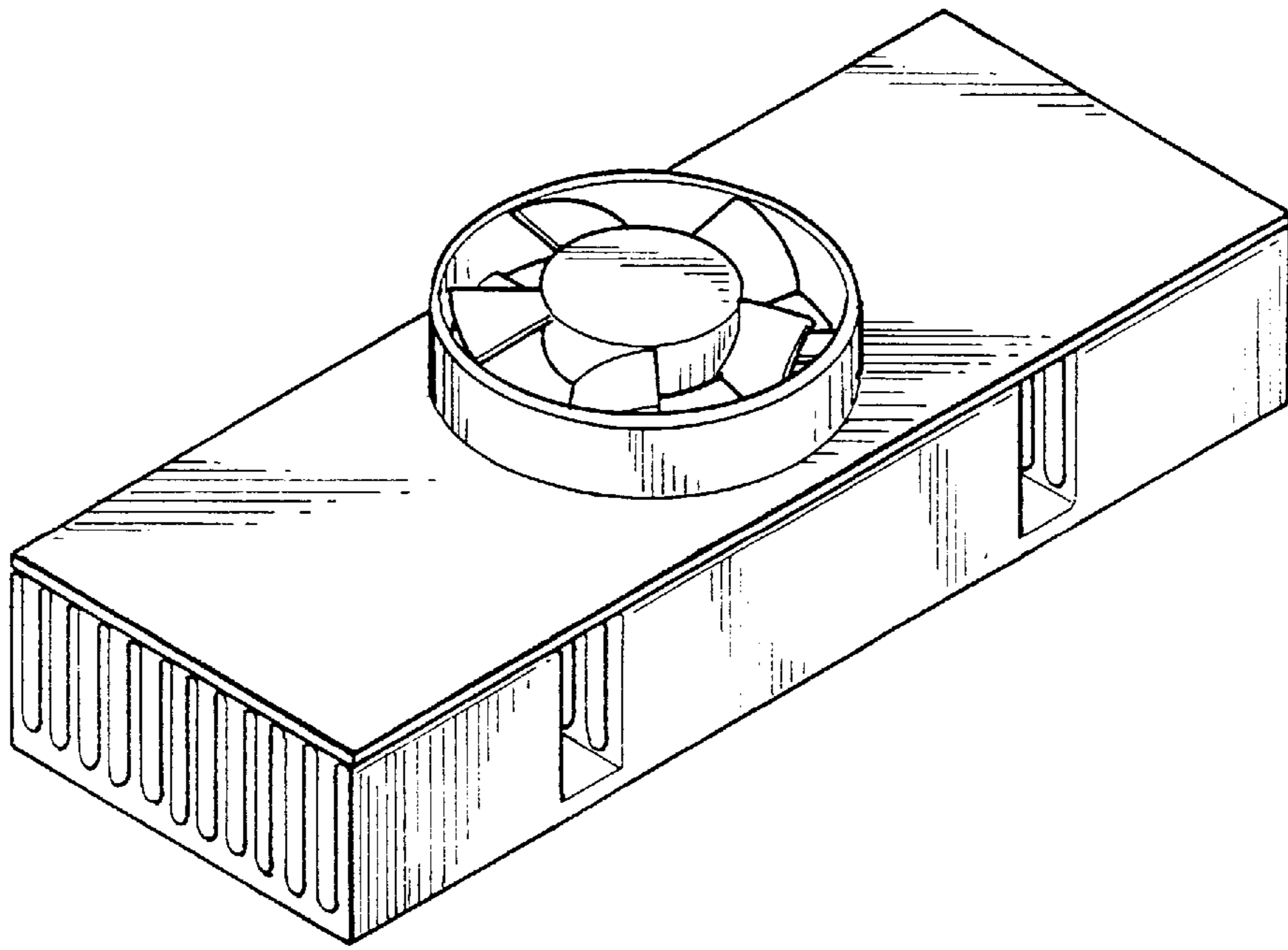

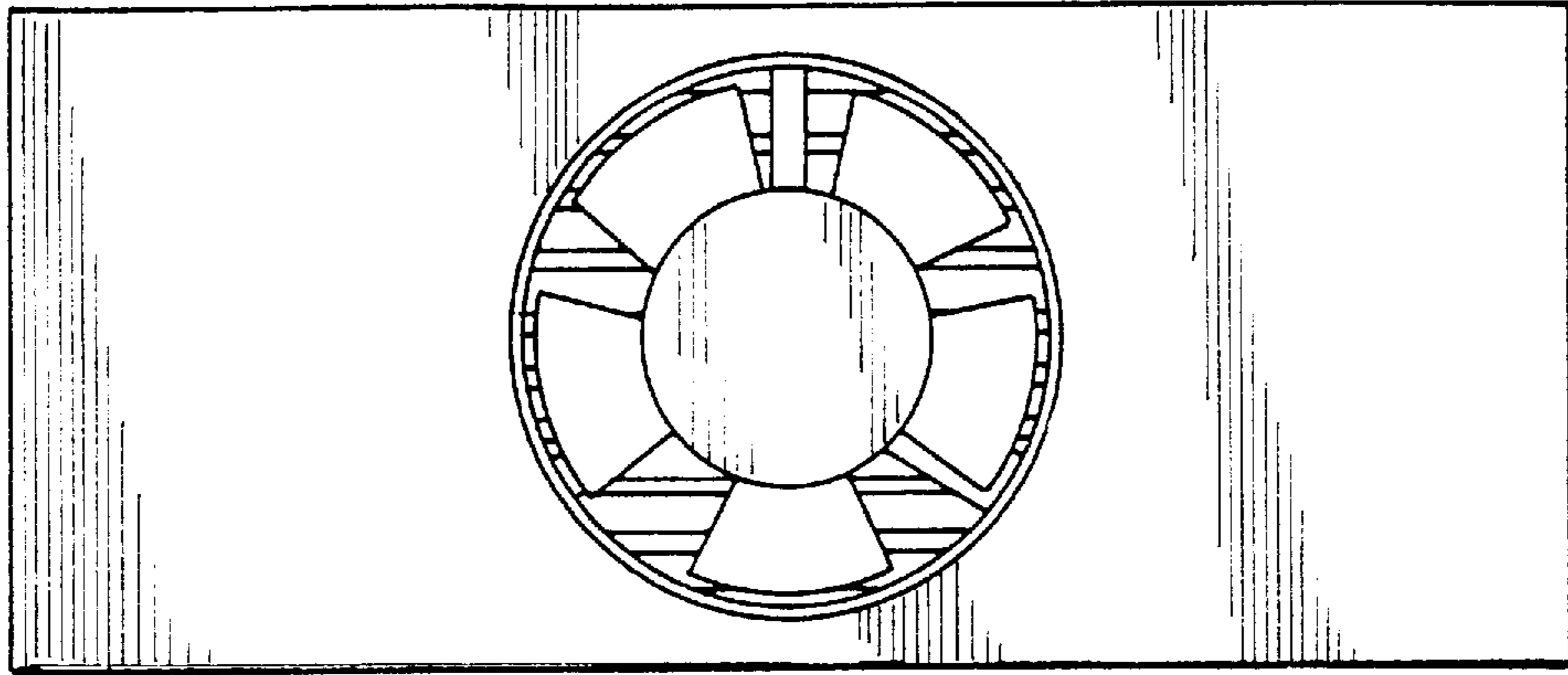

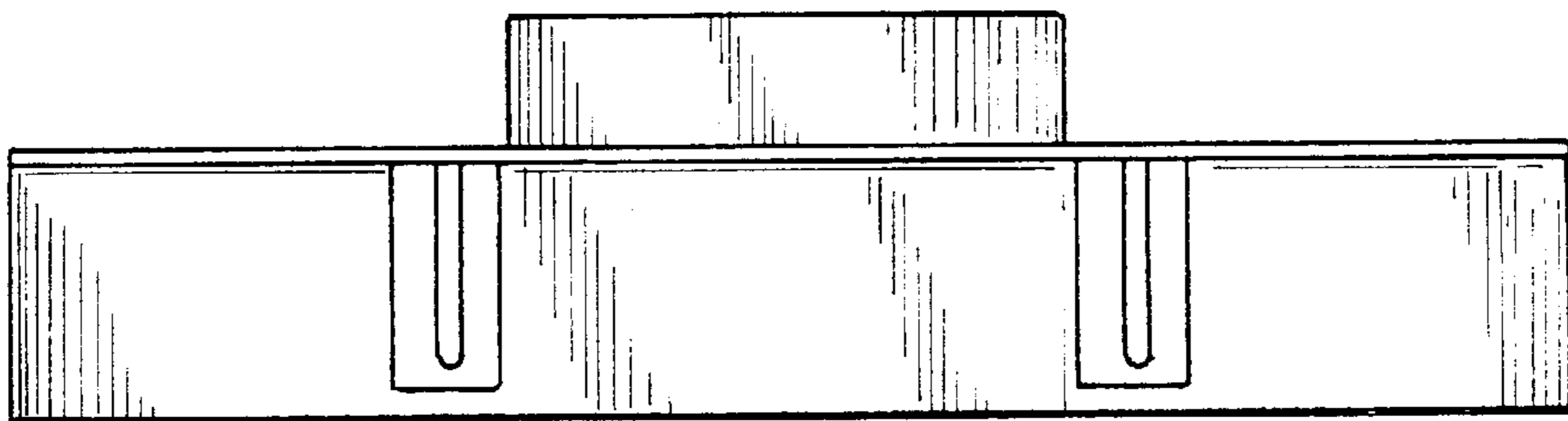

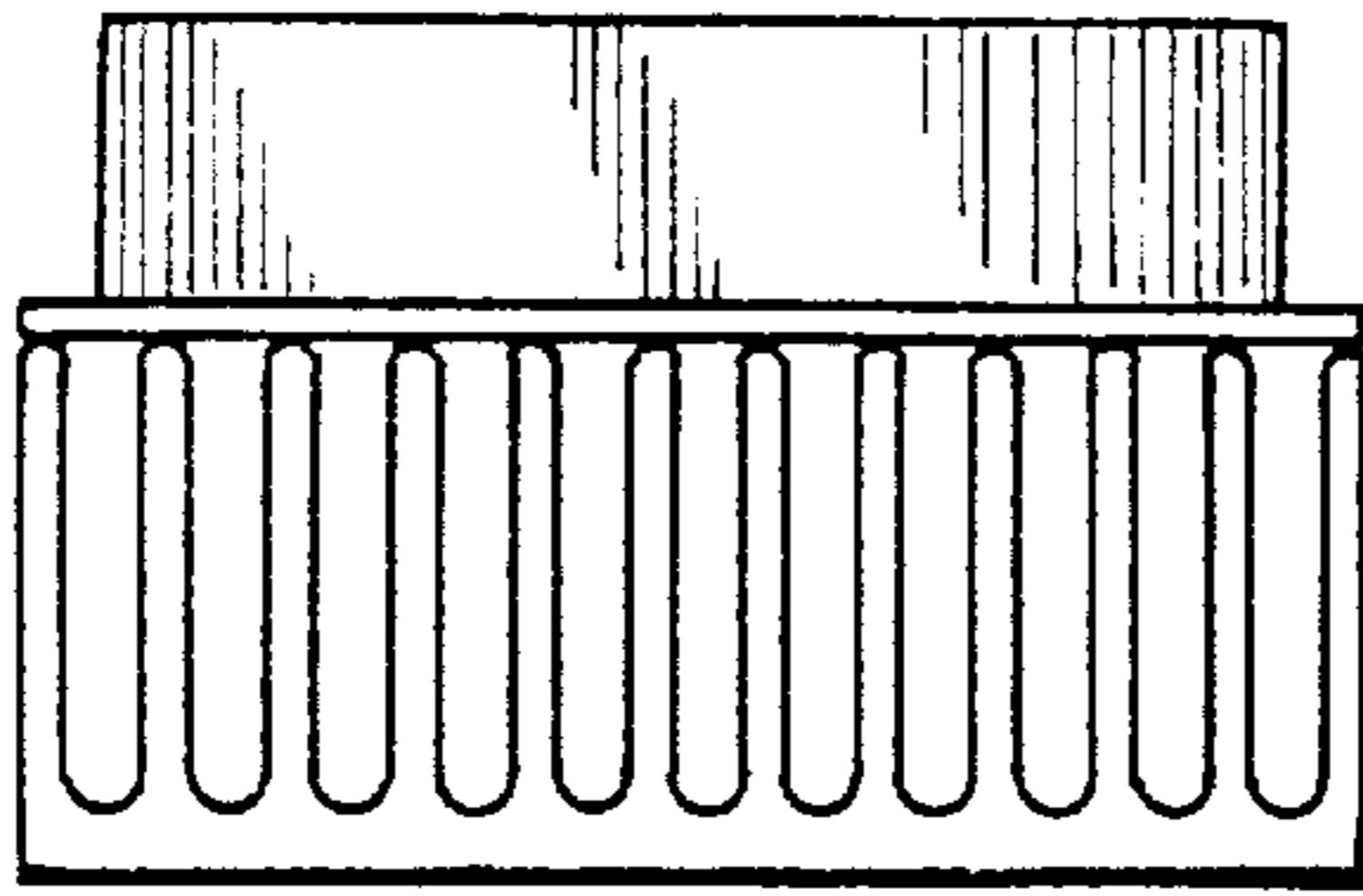

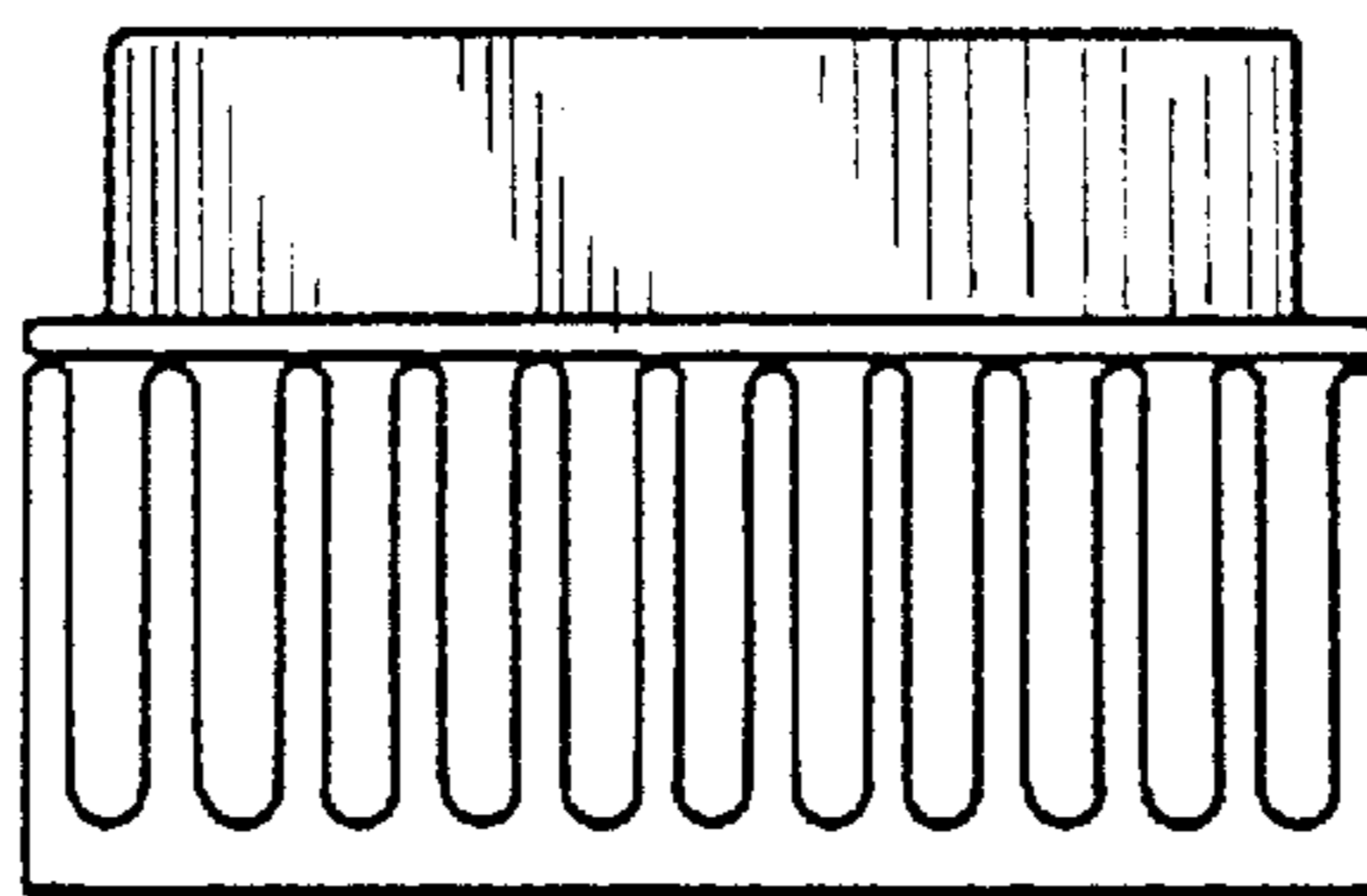

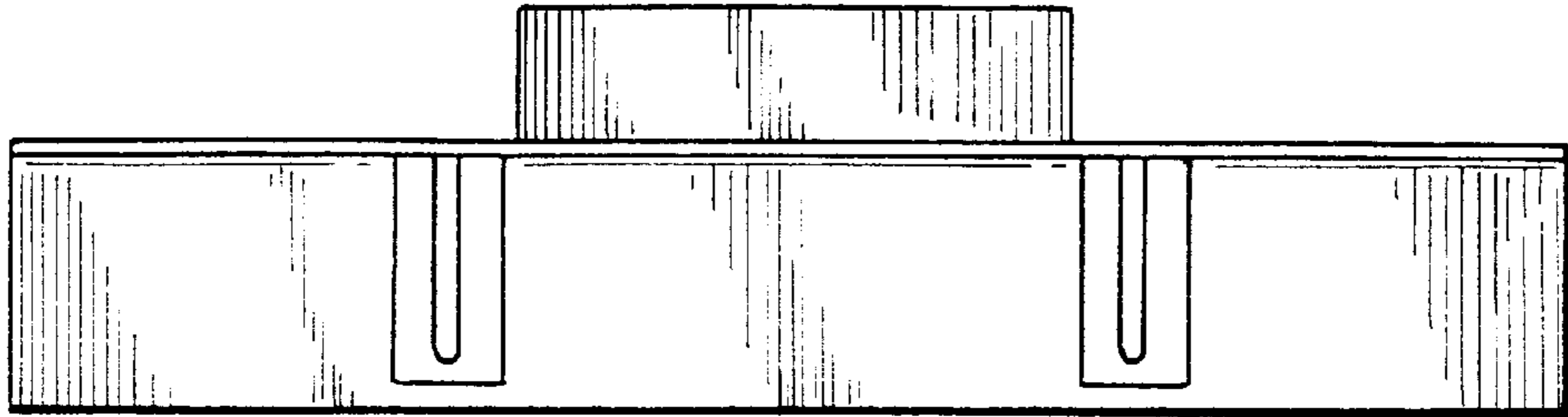

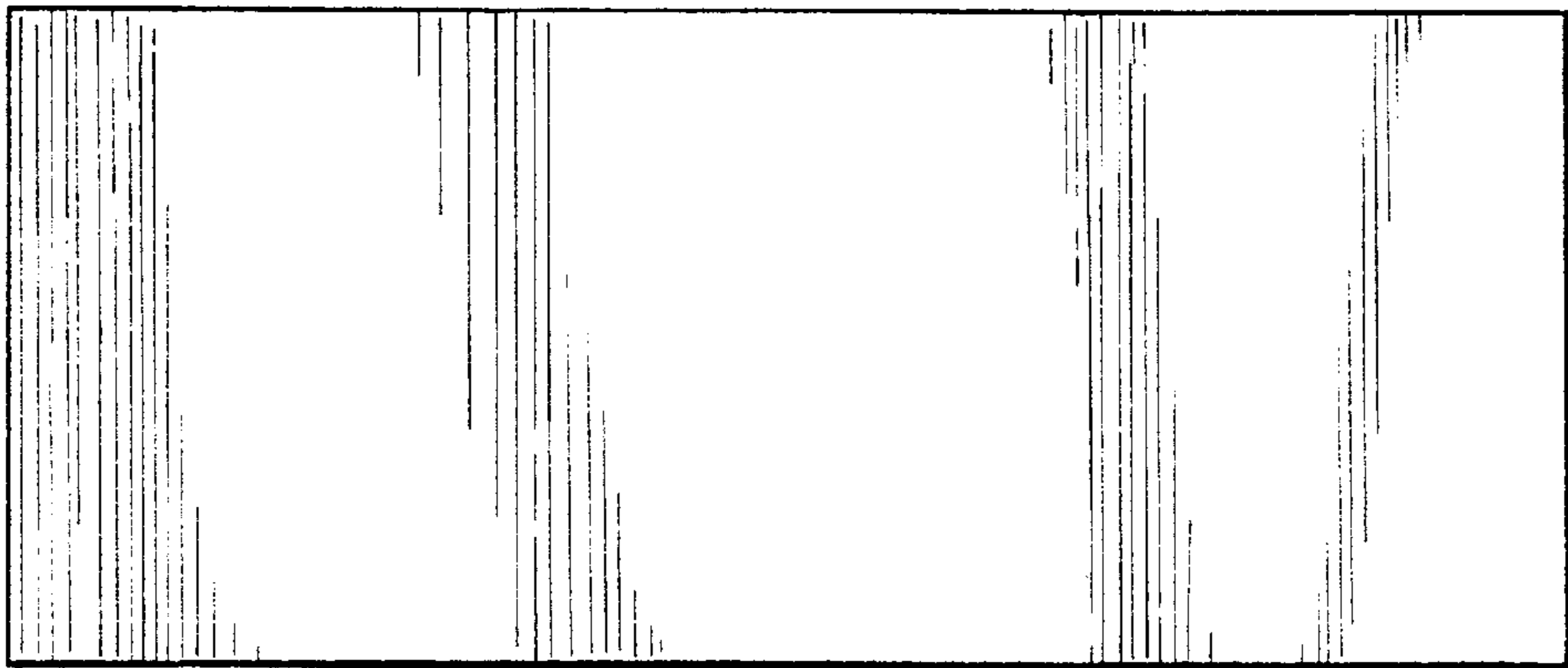
