FIG. 5 is a perspective view of the back side of the combined face, ears and neck protector from hot electric curling irons of this invention;

FIG. 6 is a top view looking down on the combined face, ears and neck protector from hot electric curling irons of this invention; and,

FIG. 7 is a bottom view looking up on the combined face, ears and neck protector from hot electric curling irons of this invention.
