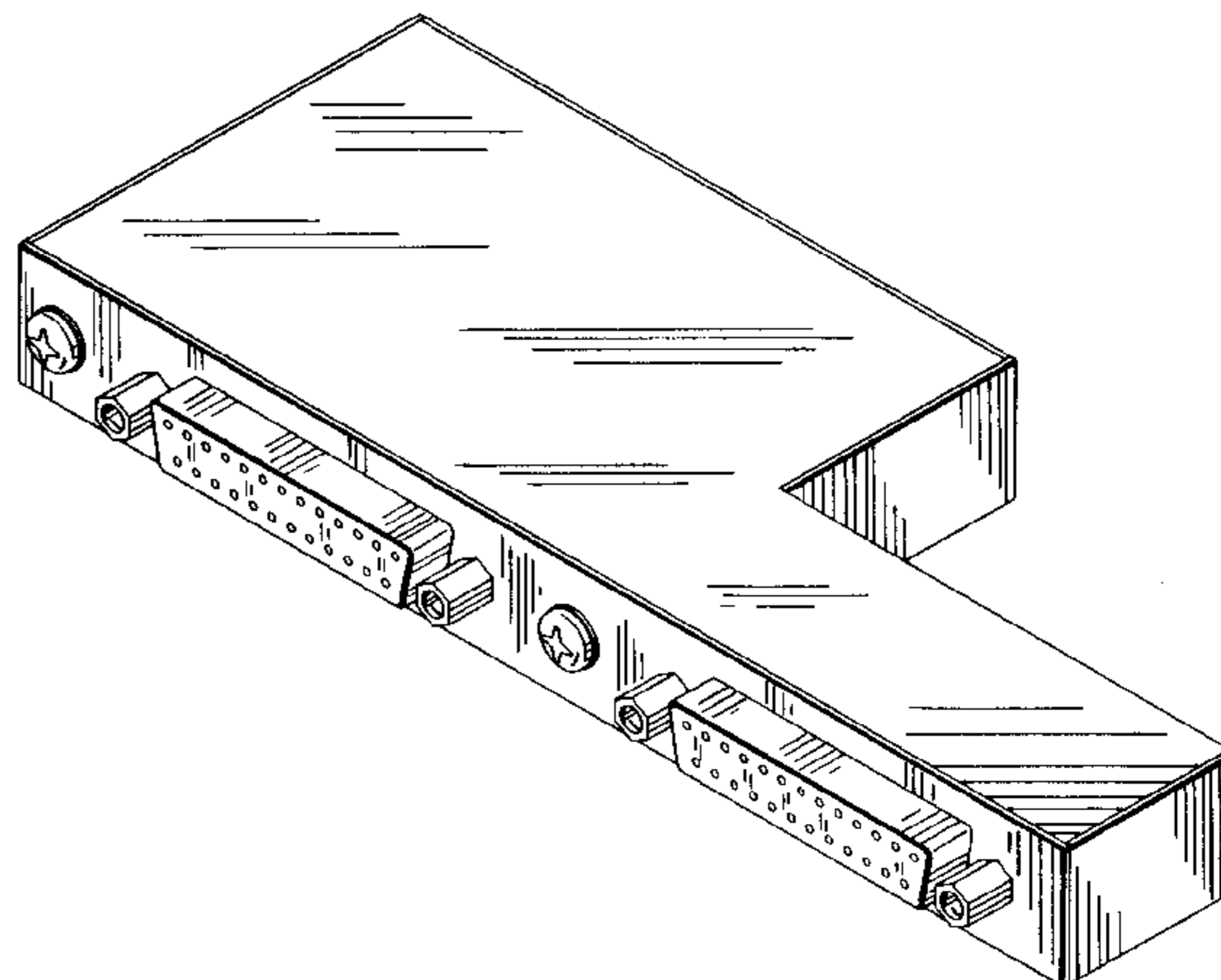
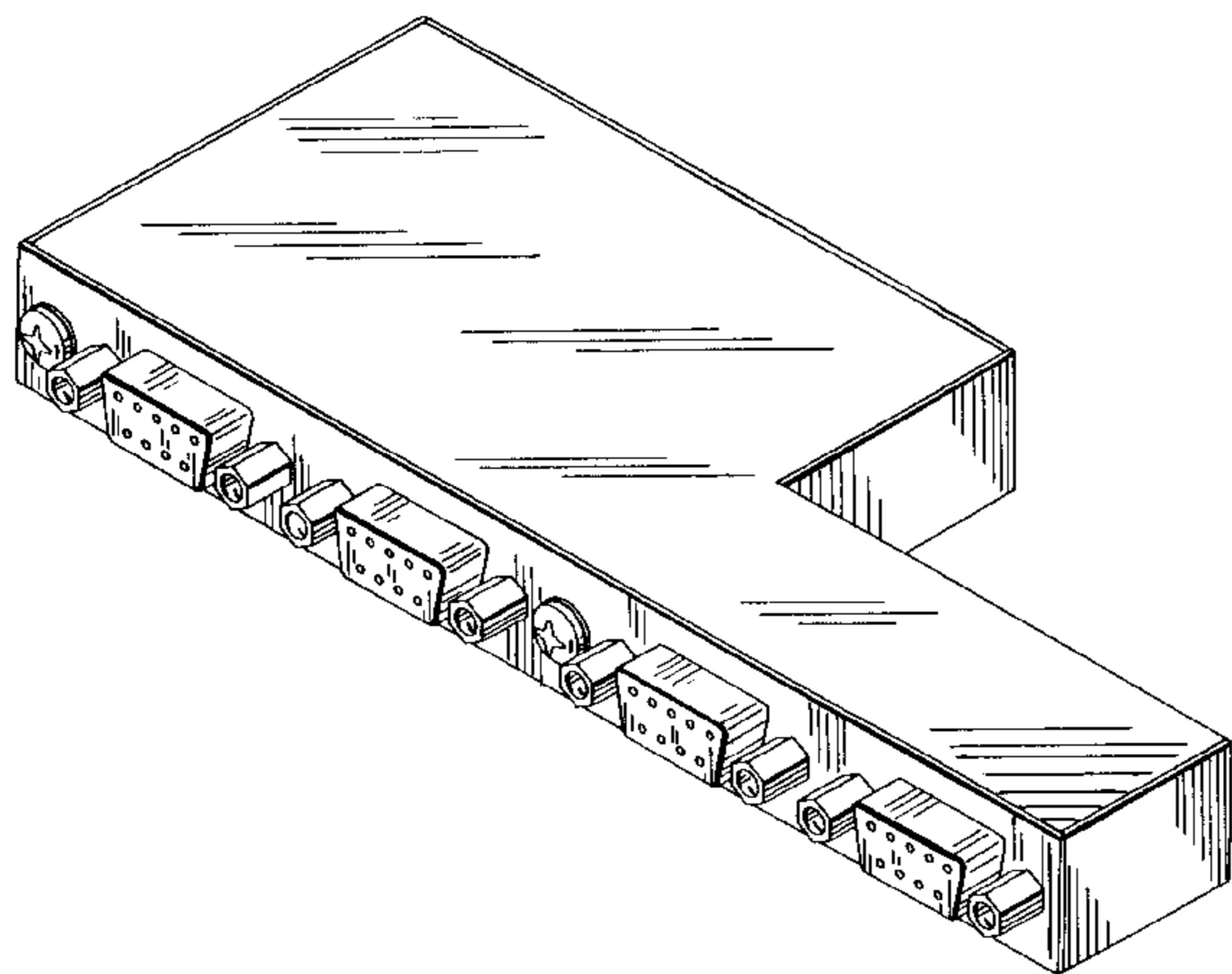
[57] **CLAIM**

The ornamental design for a multi-connector expansion interface device, as shown and described.

DESCRIPTION

FIG. 1 is a top, front and right side perspective view of a multi-connector expansion interface device which incorporates the new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a front view thereof;
FIG. 4 is a right side view thereof;
FIG. 5 is a left side view thereof; and
FIG. 6 is a rear view thereof;
FIG. 7 is a top, front and right side perspective view of an alternative embodiment of a multi-connector expansion interface device which incorporates the new design;

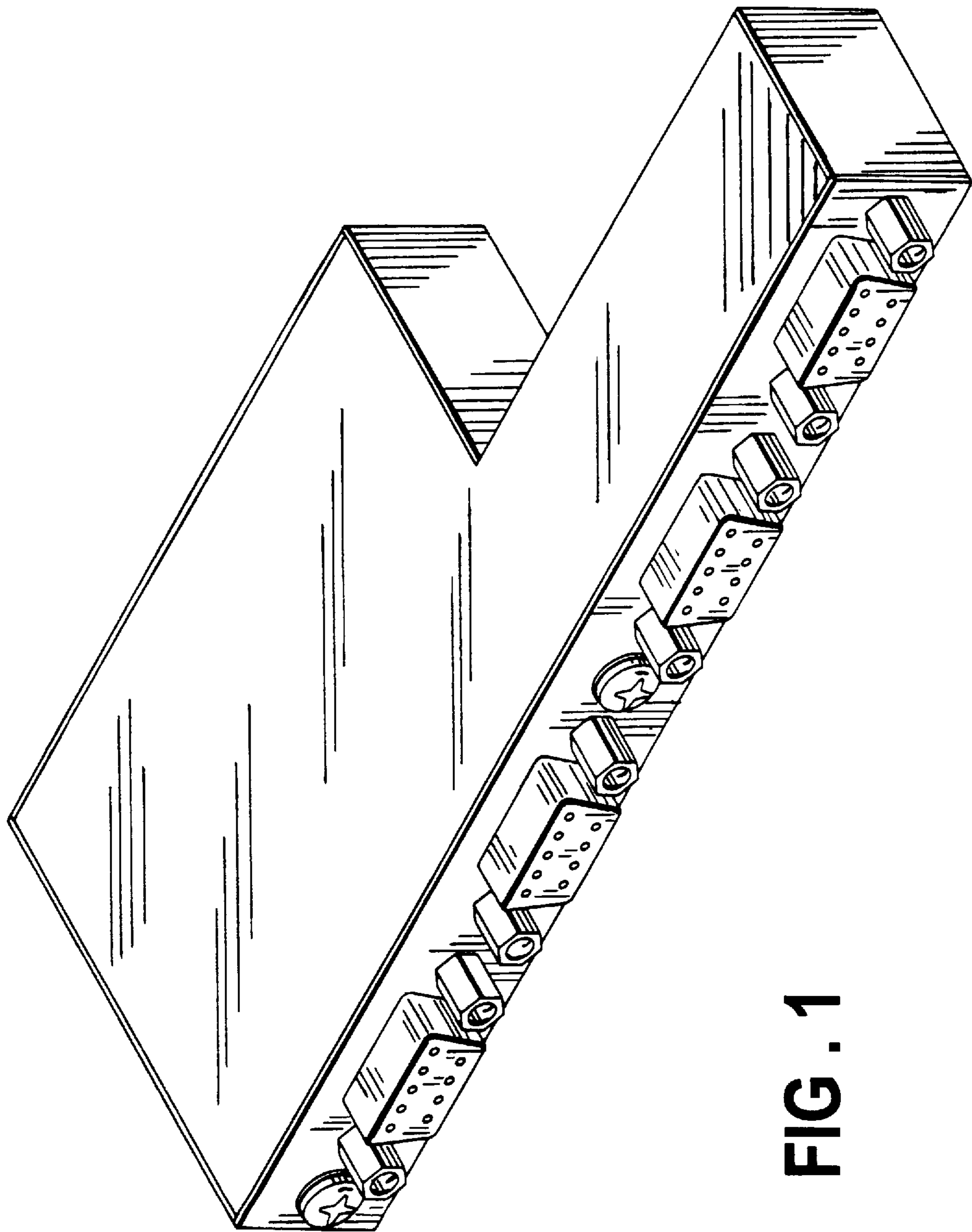

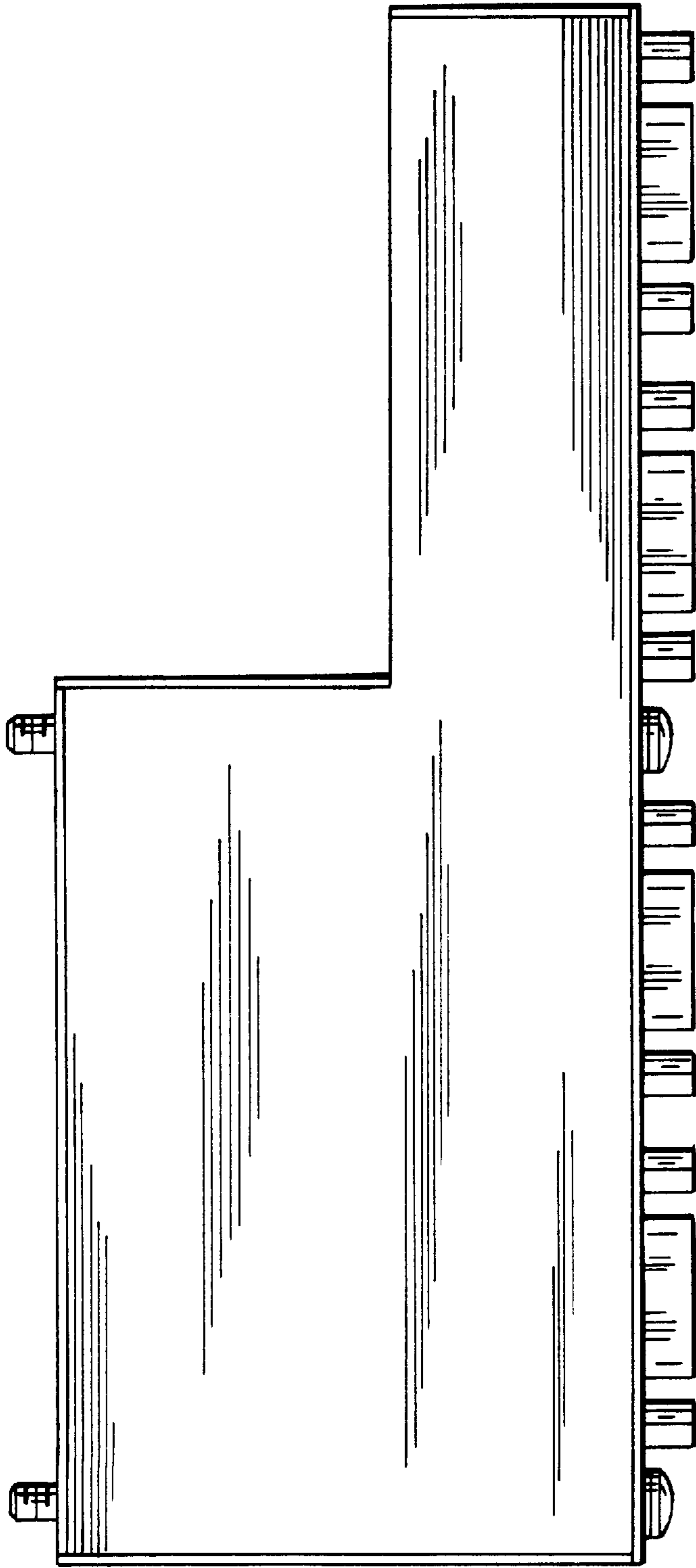

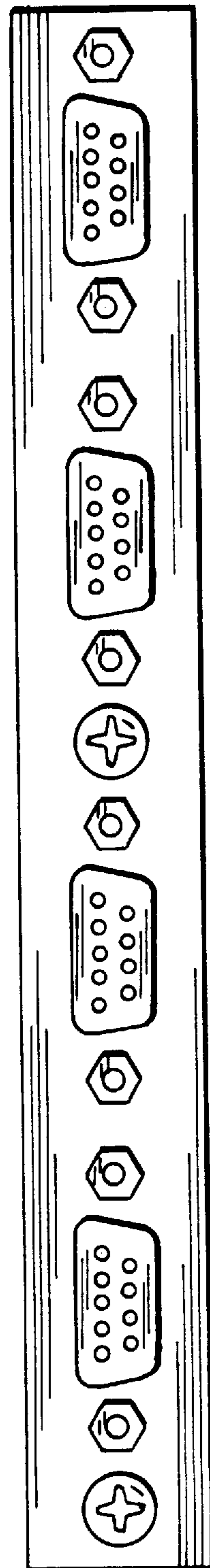

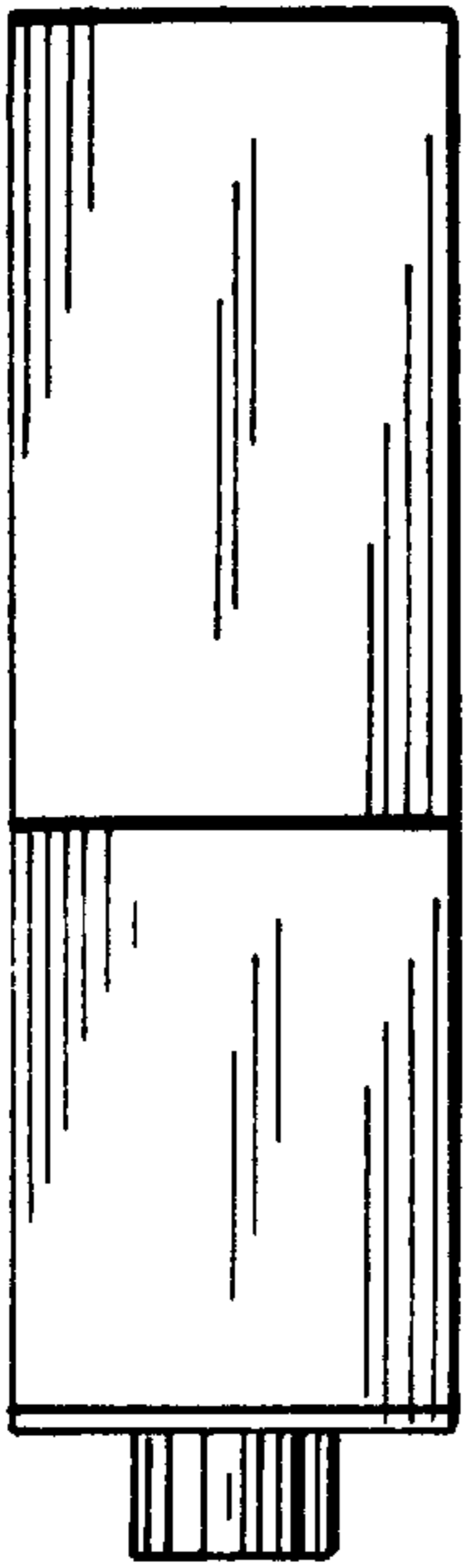

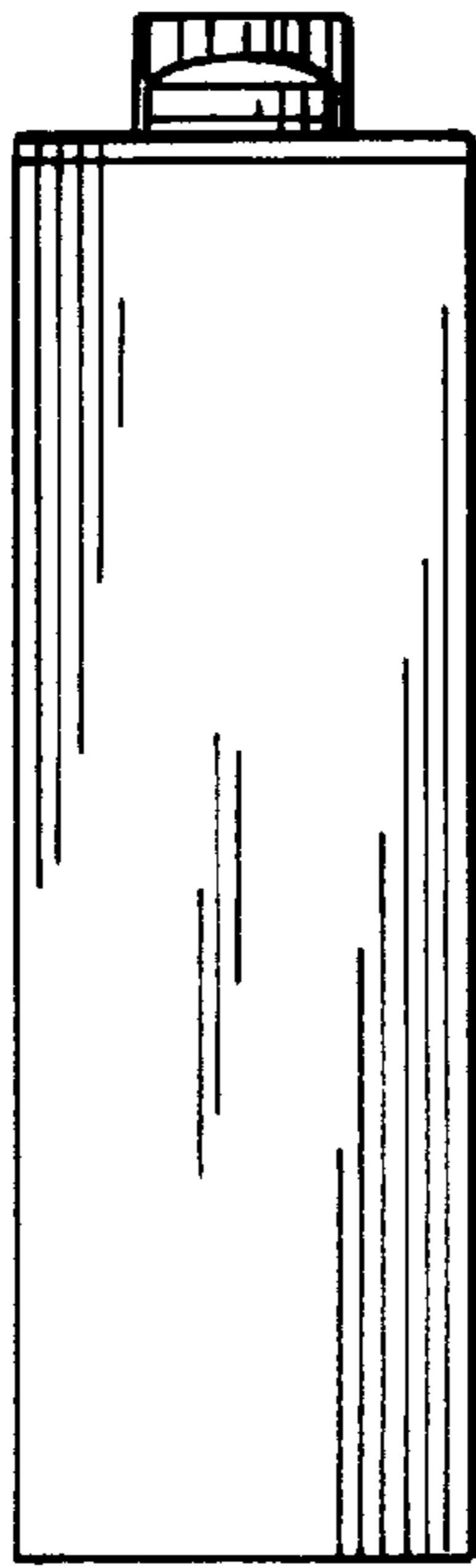

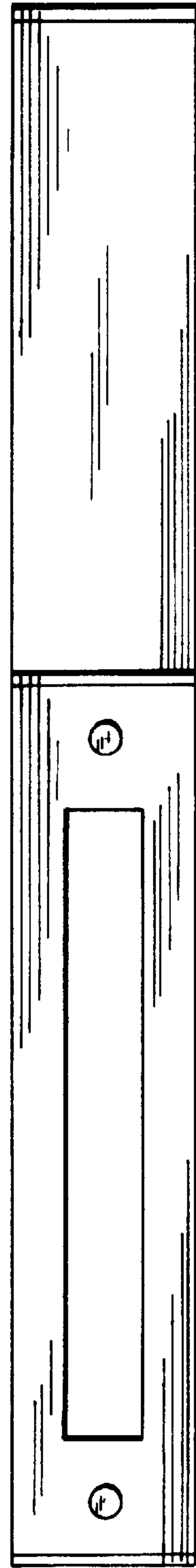

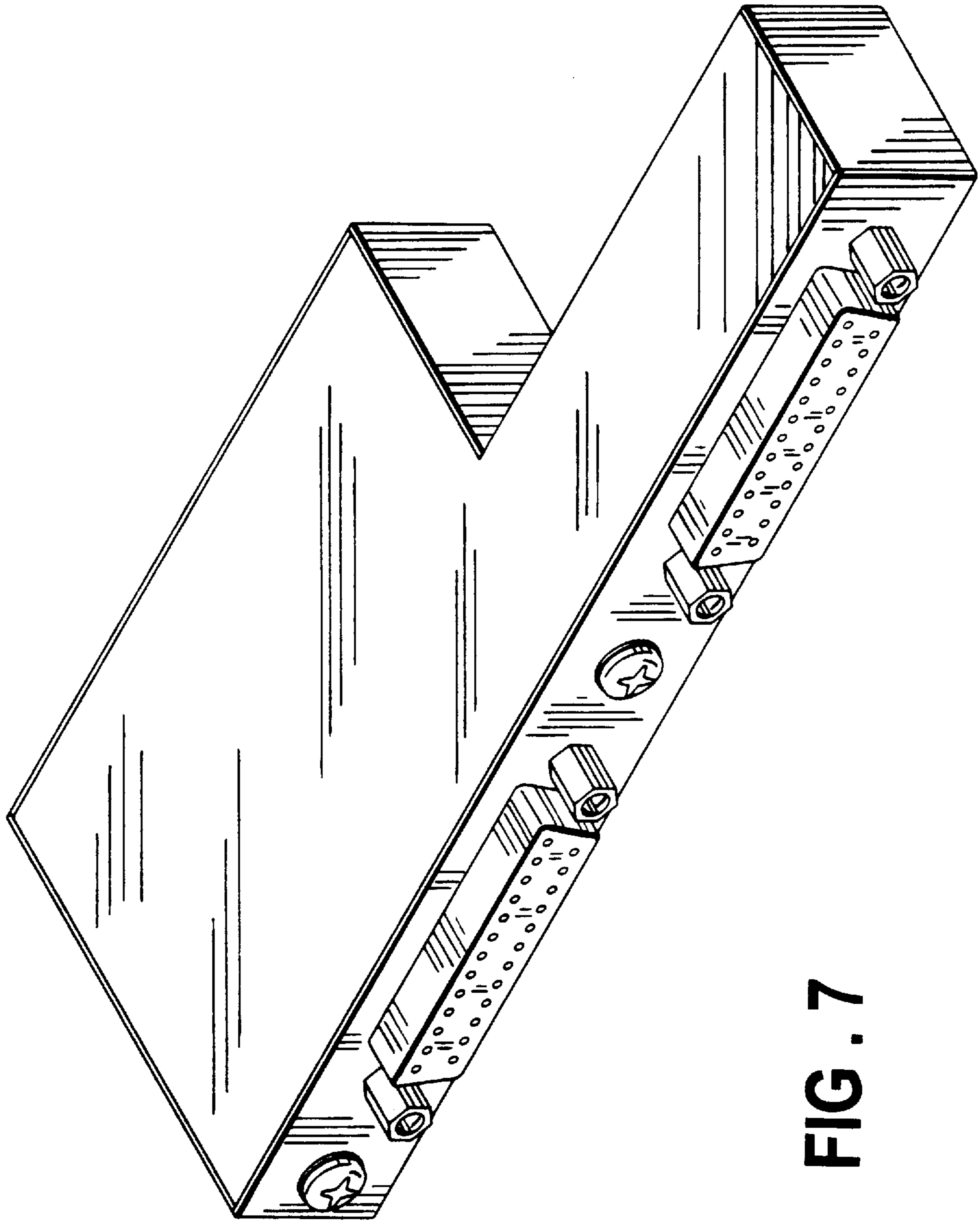

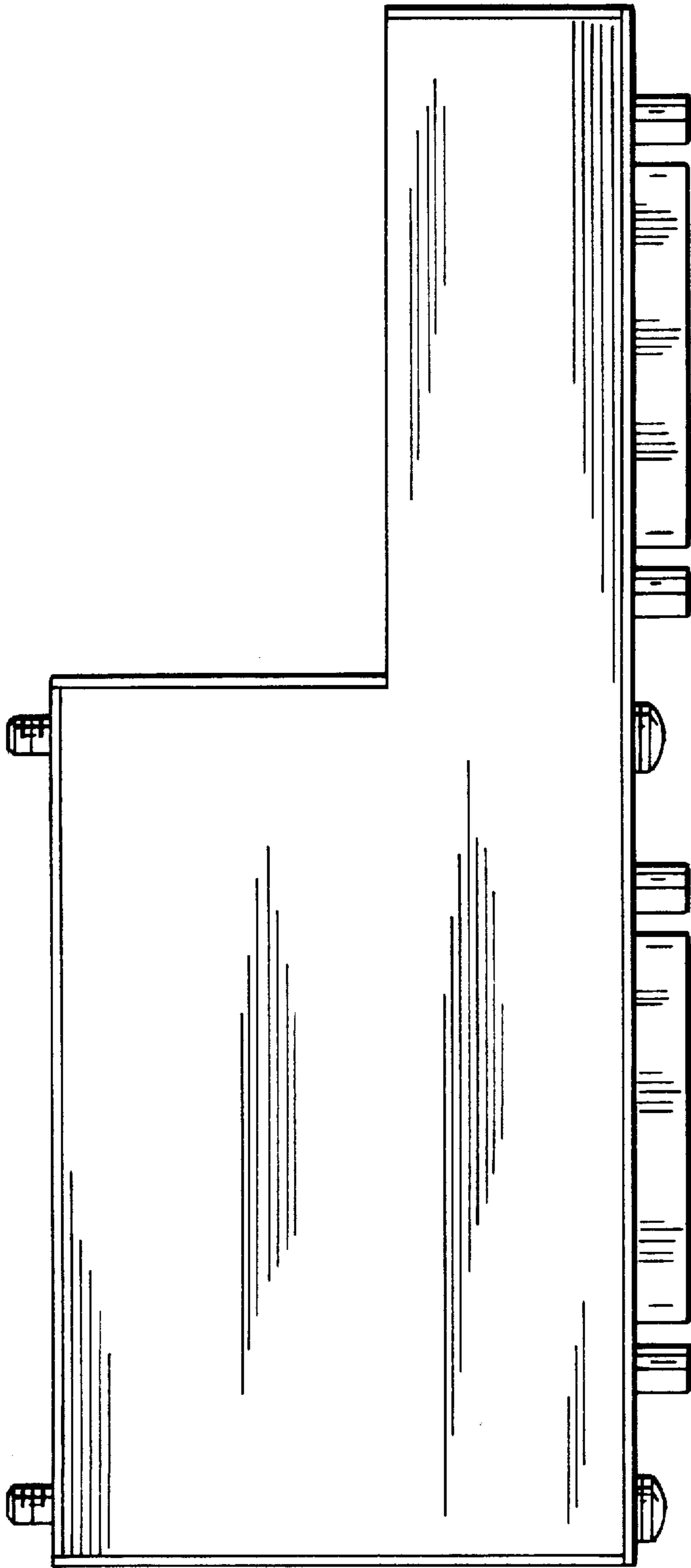

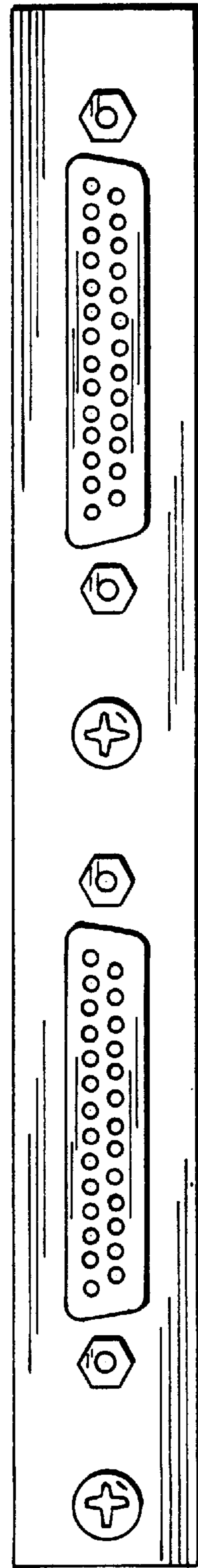

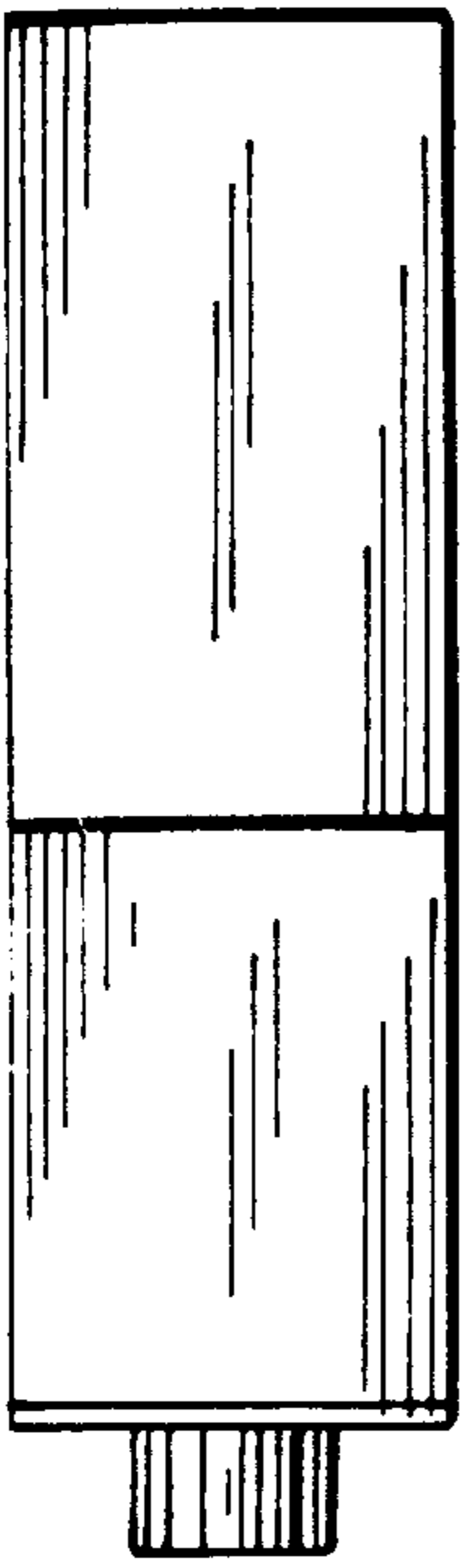

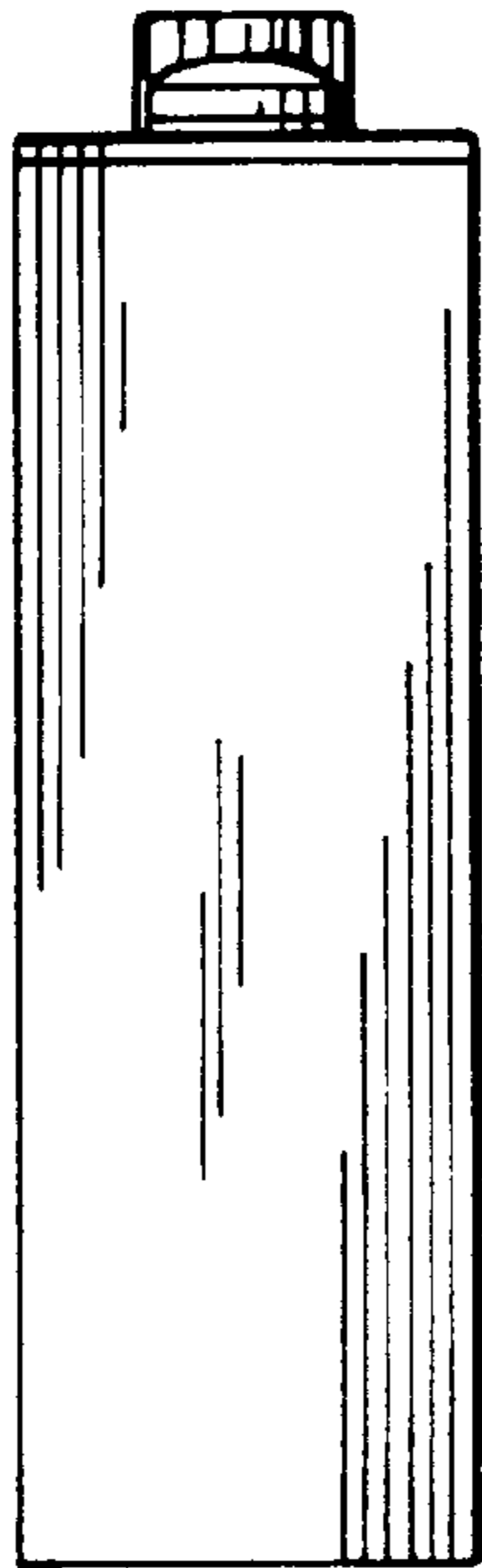

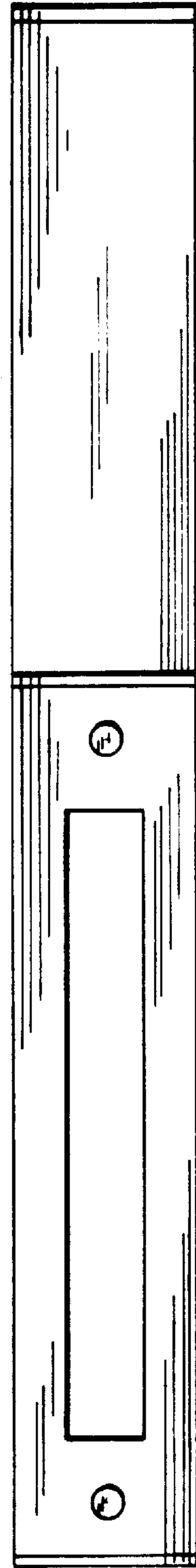
