The ornamental design for a computer monitor screen with a graphical window, as shown and described.

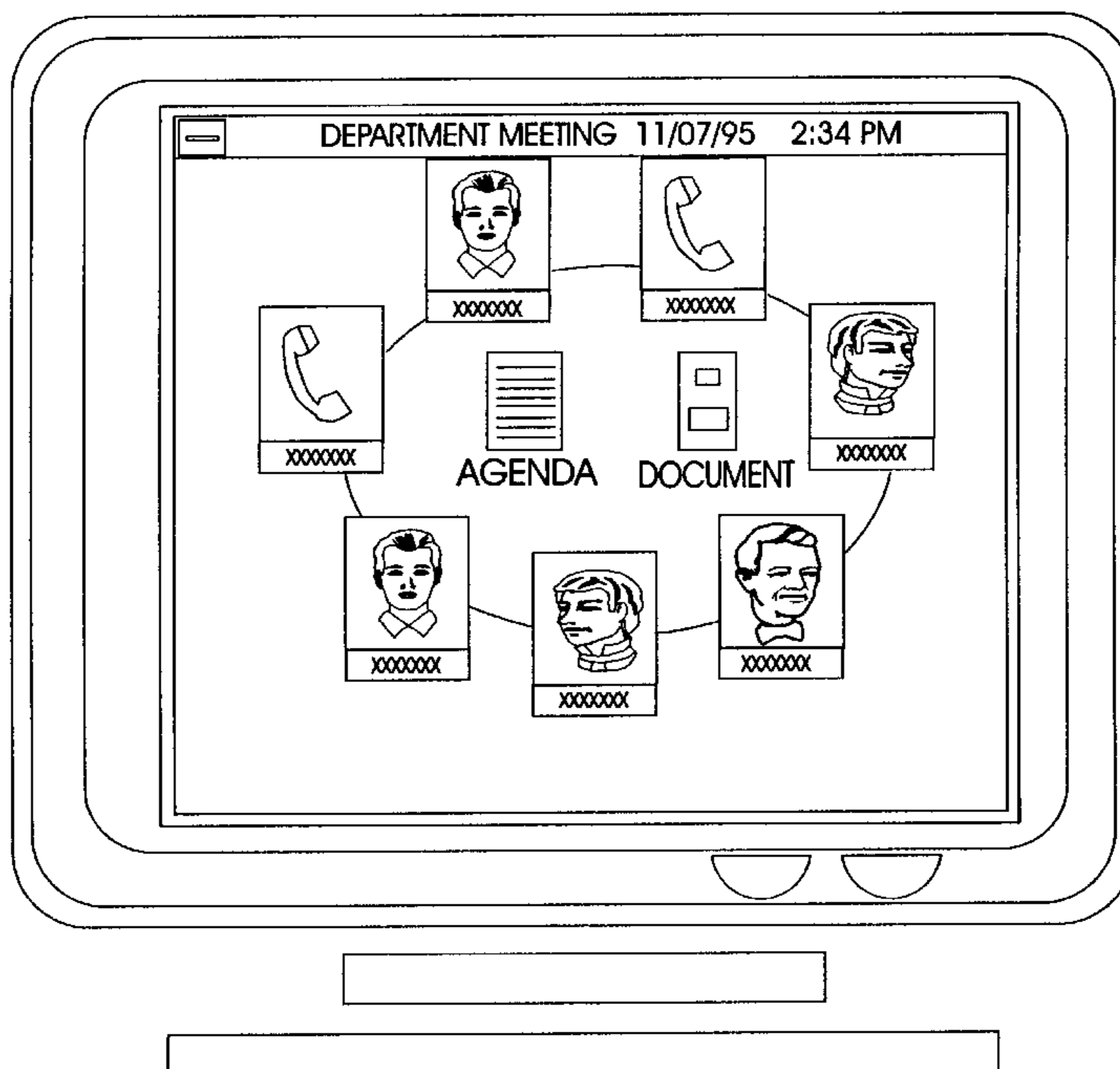

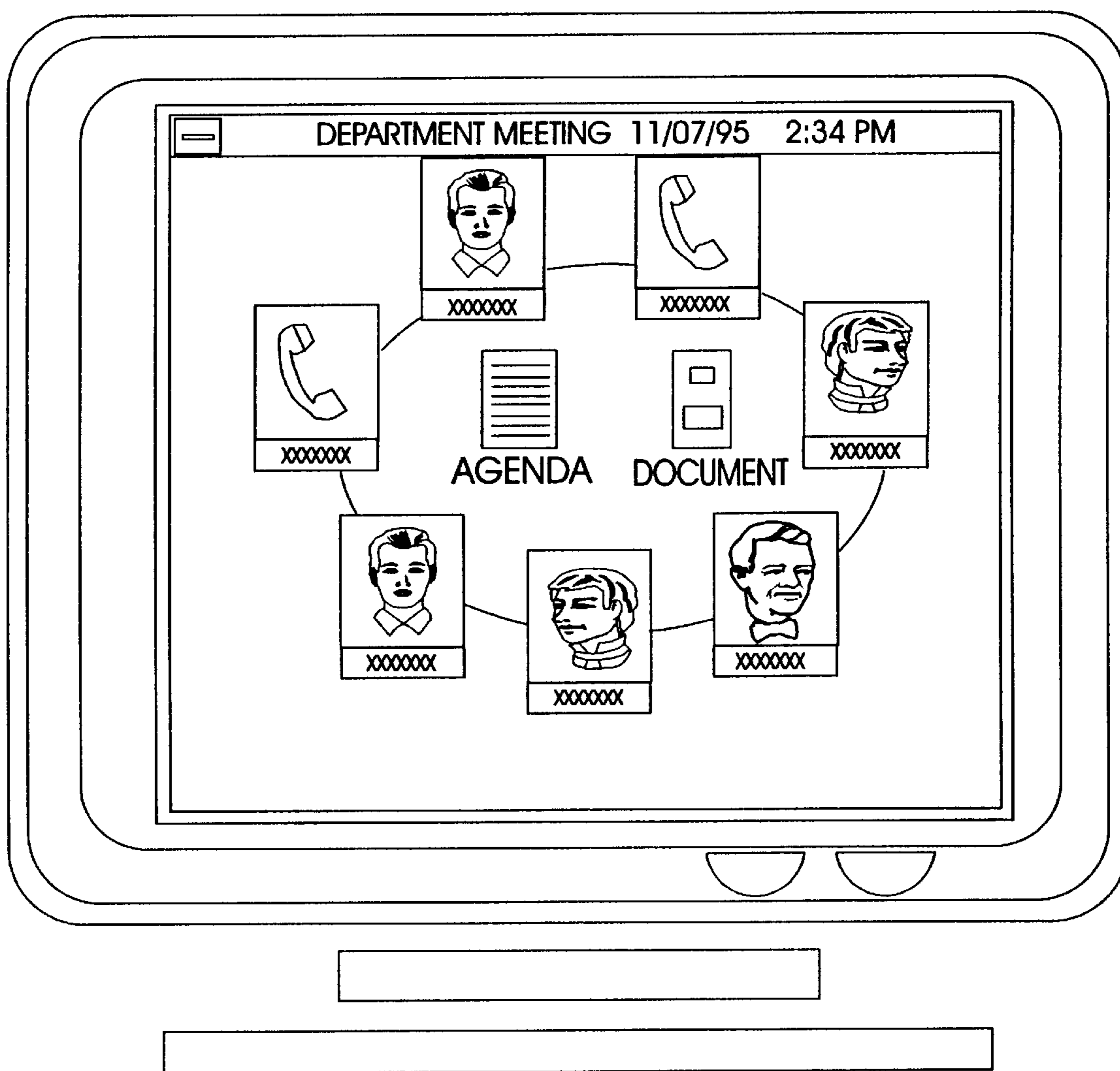

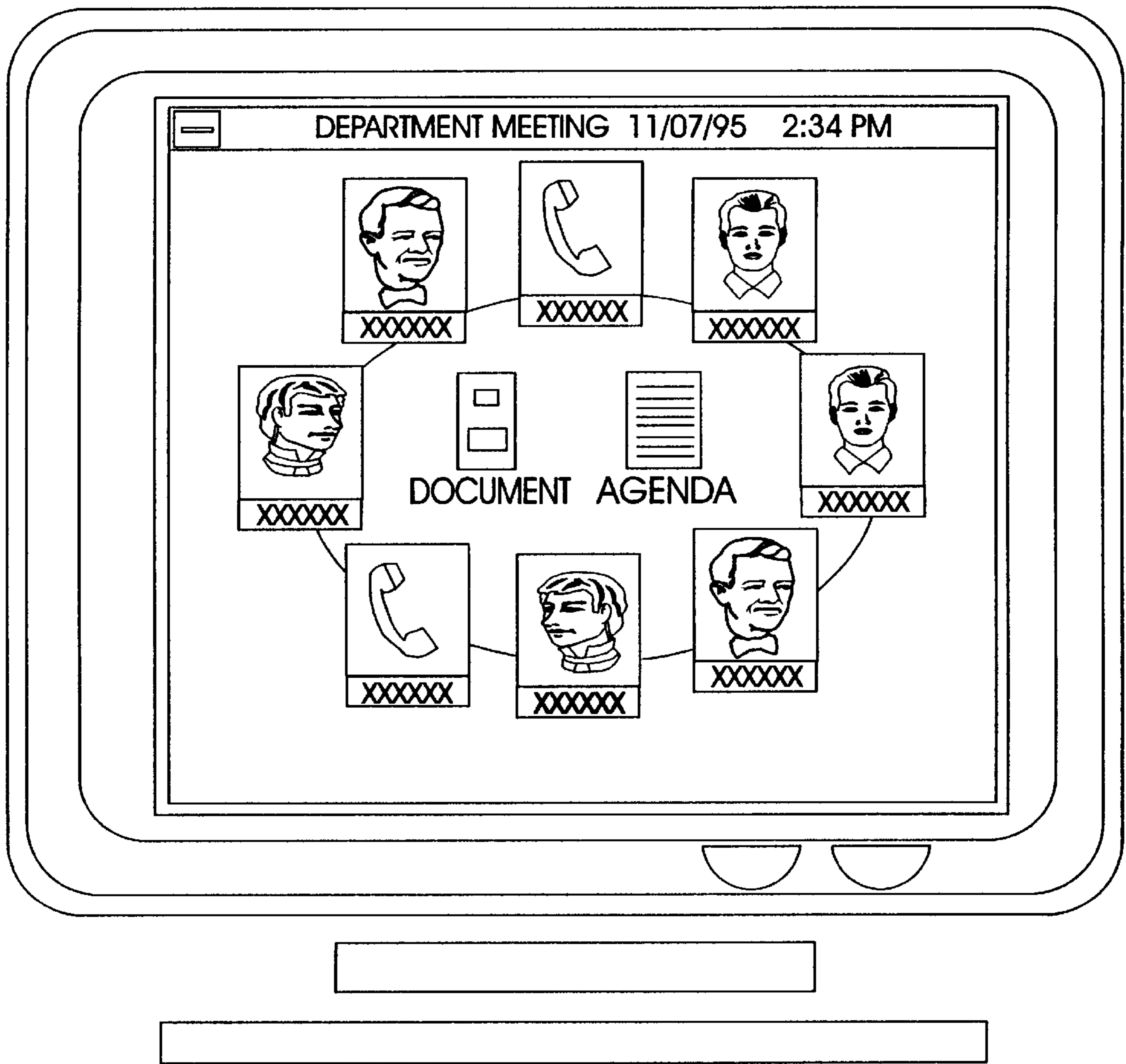

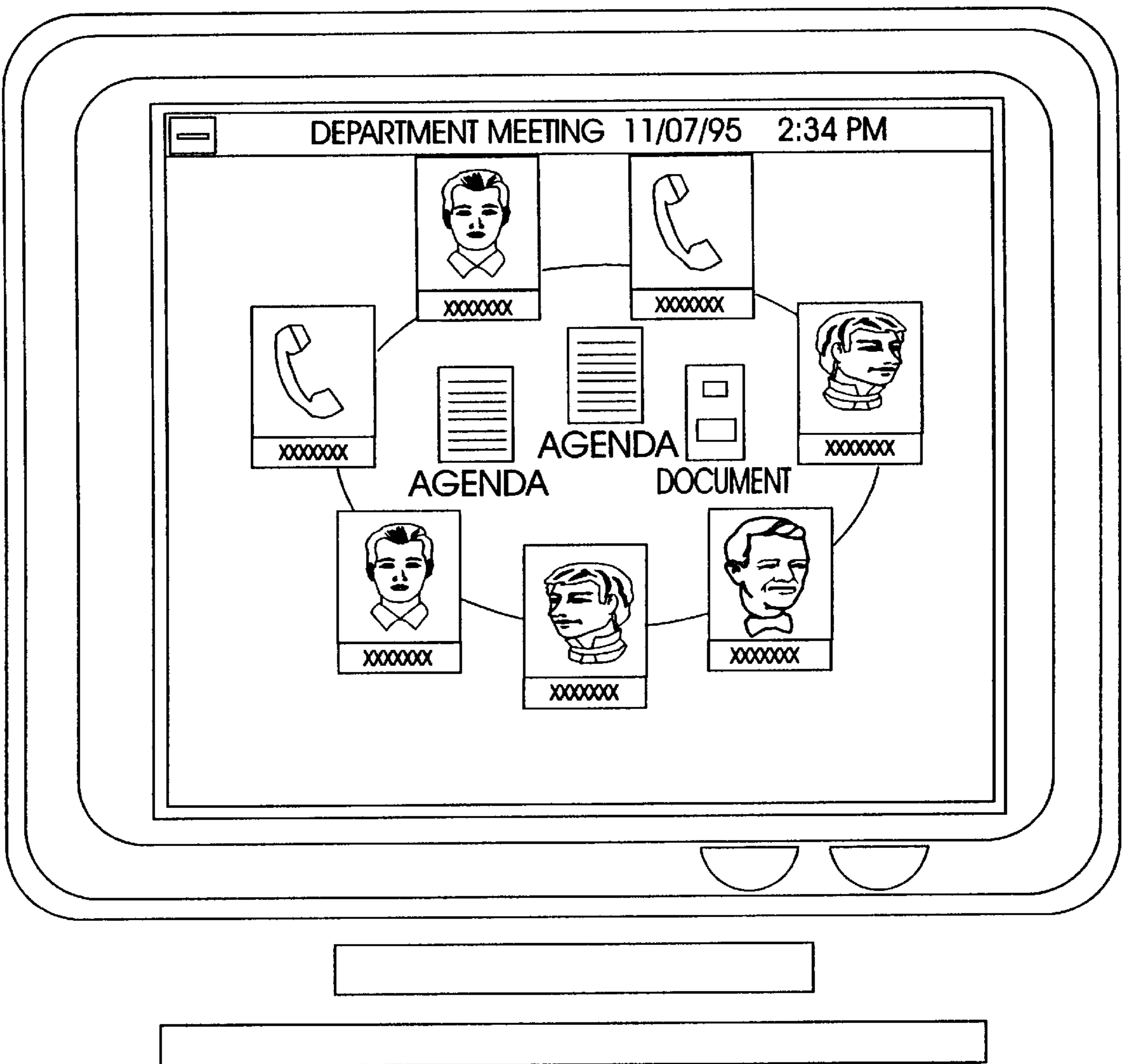

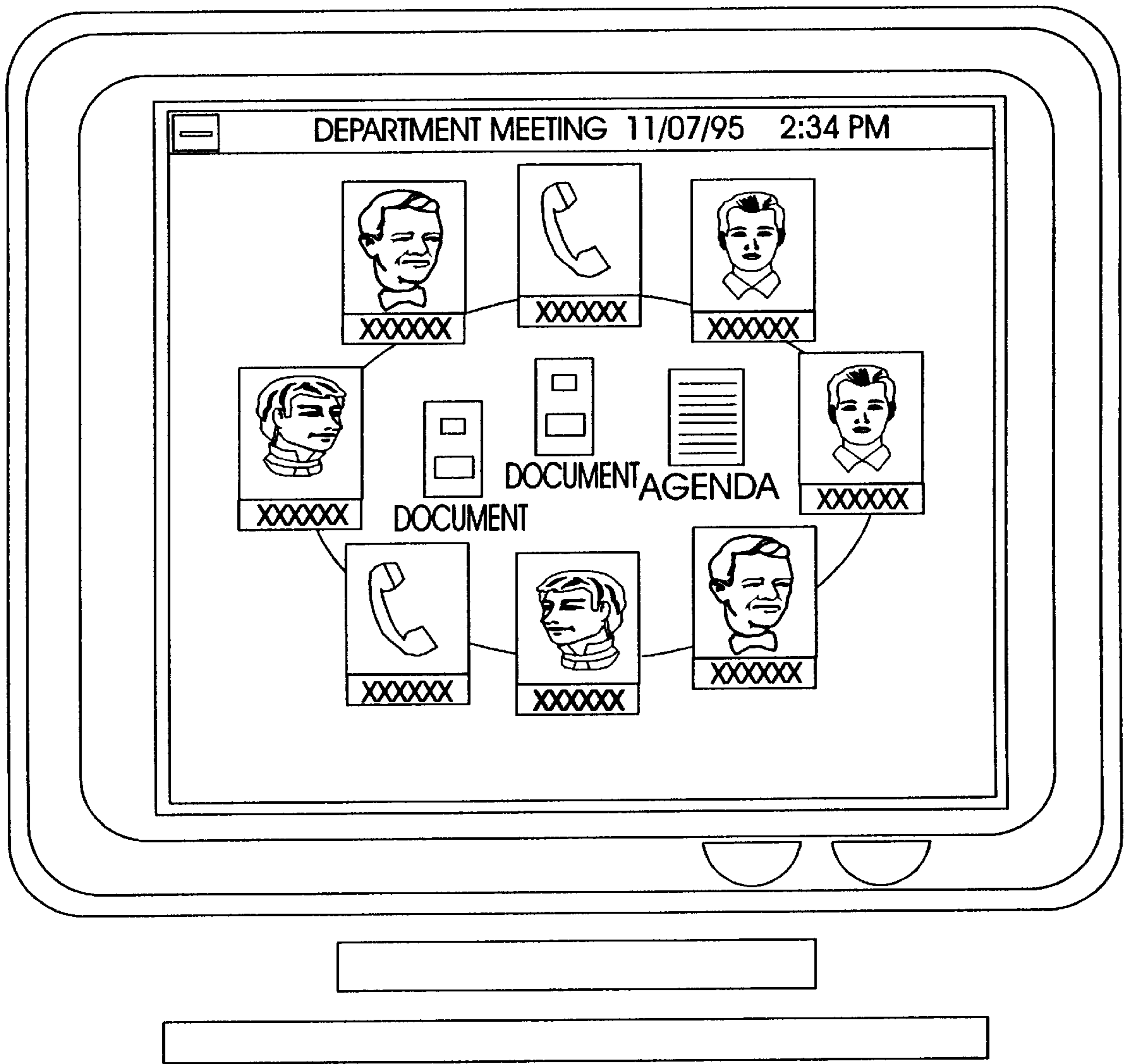

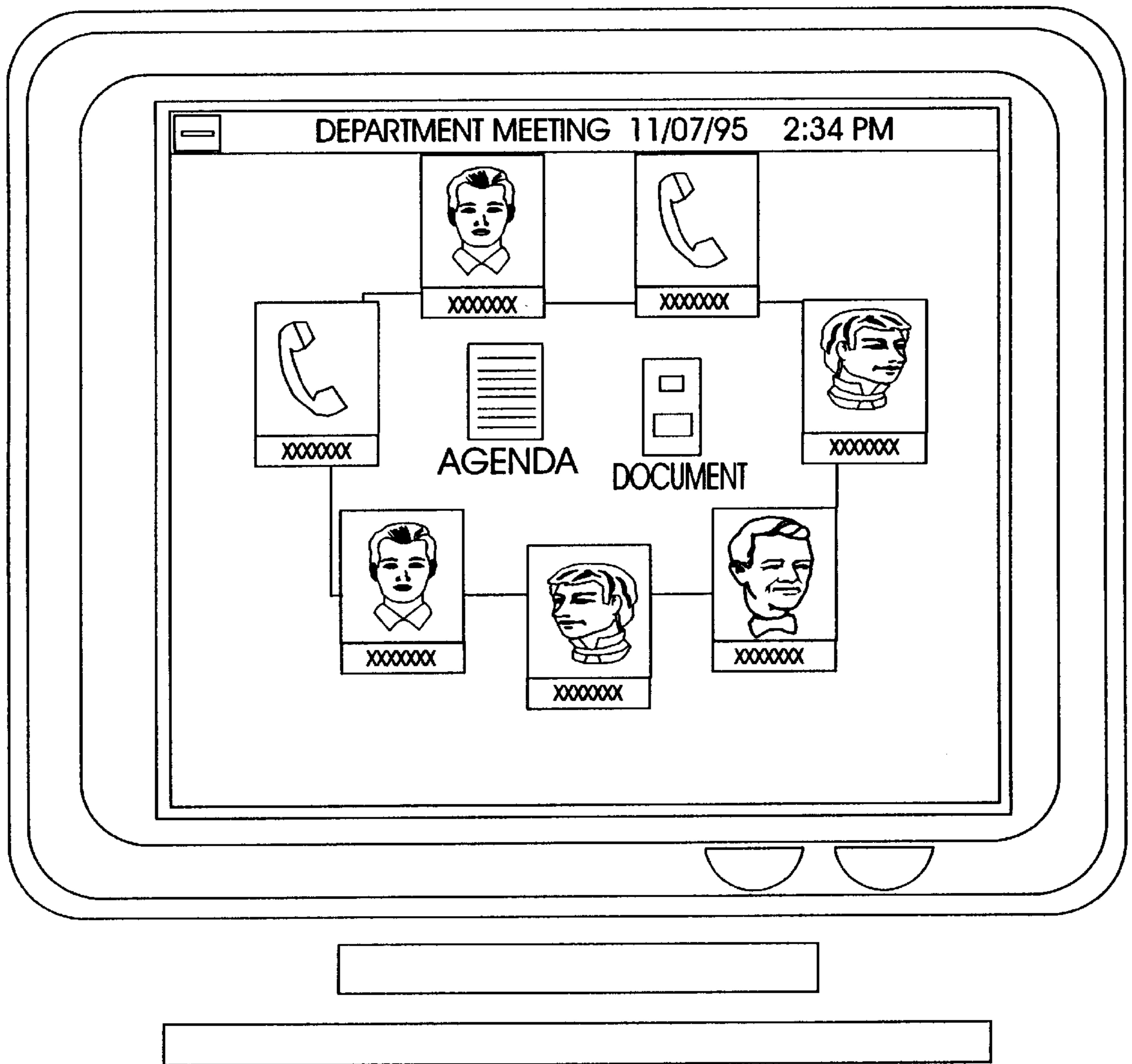

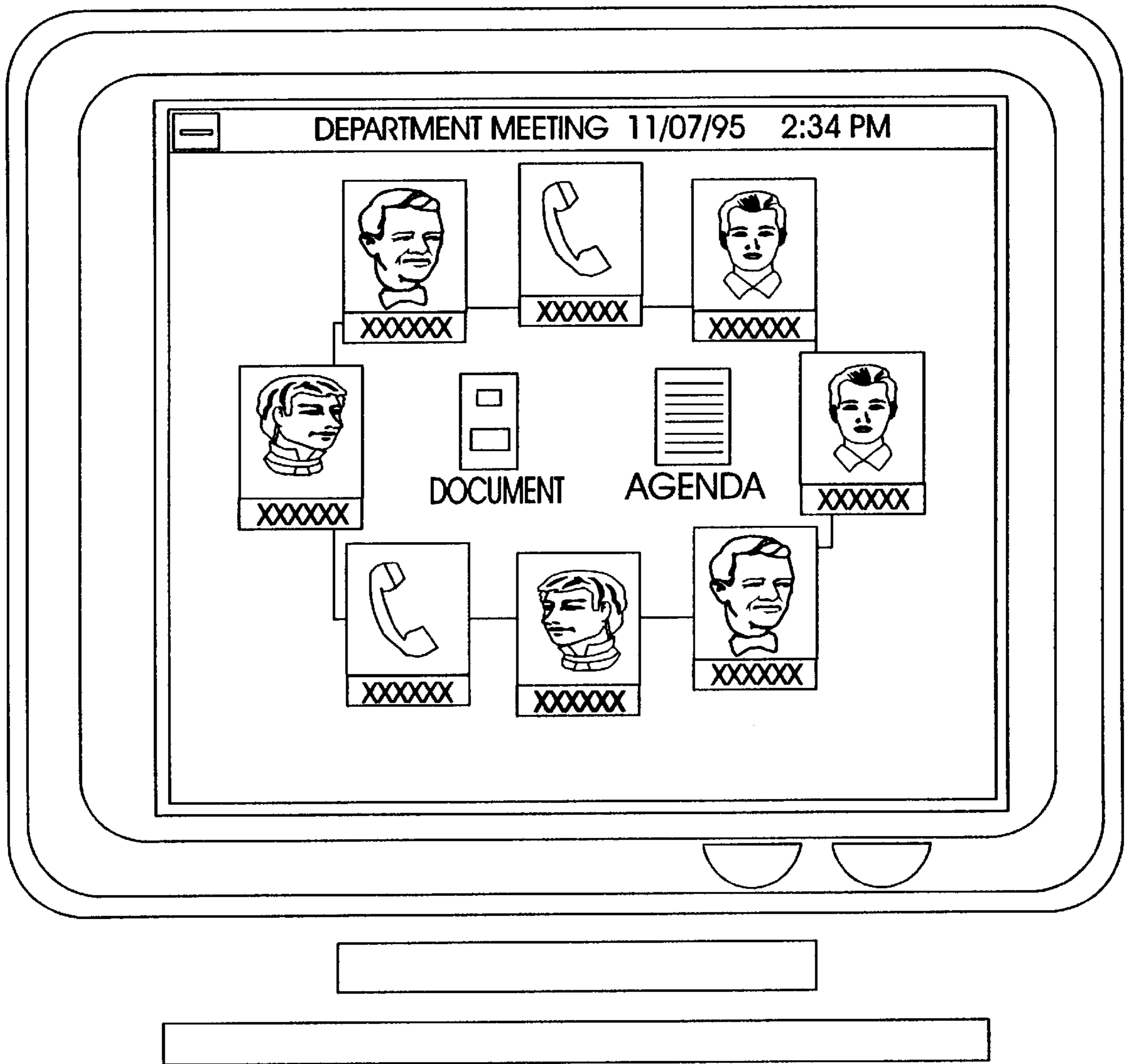

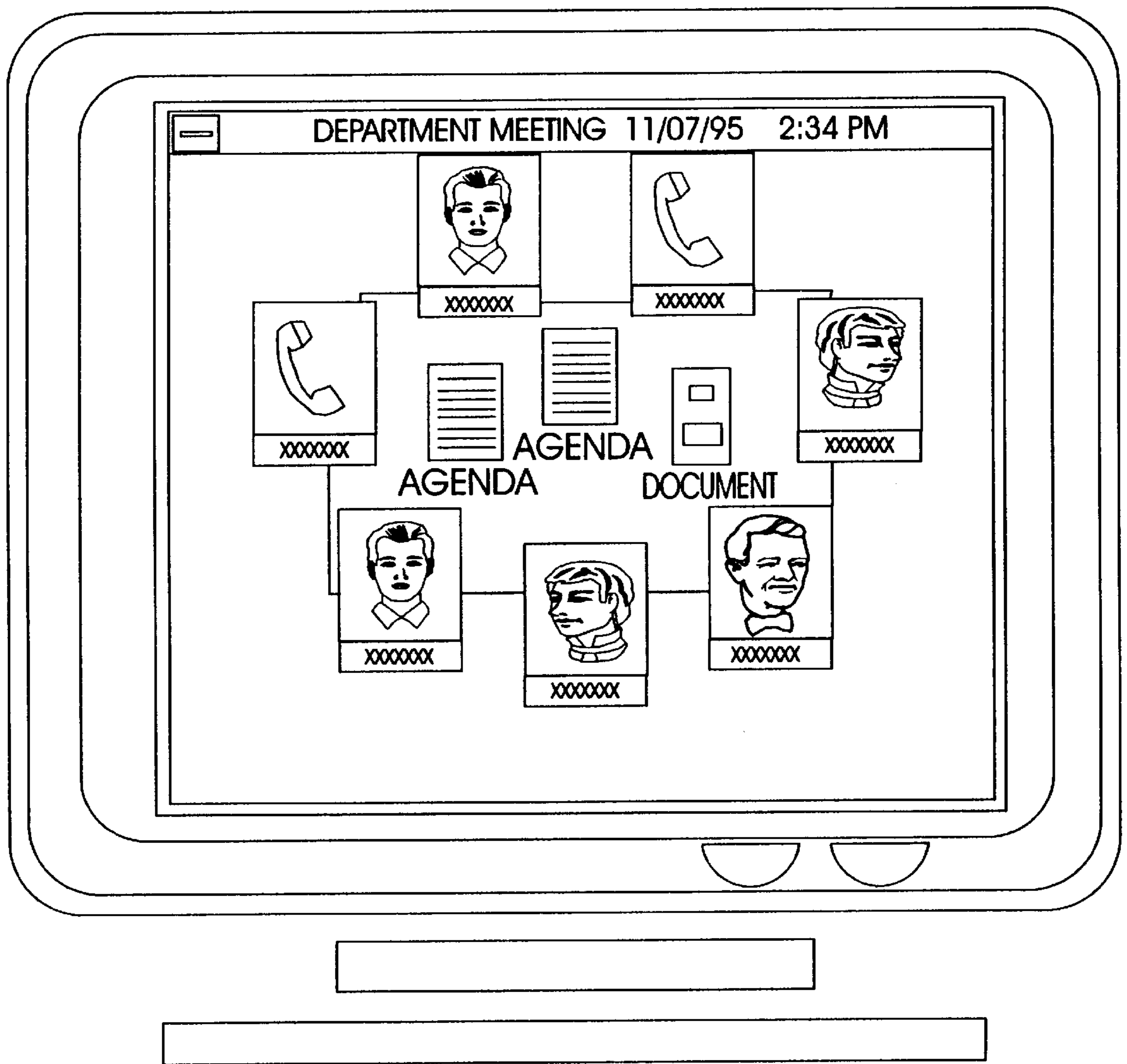

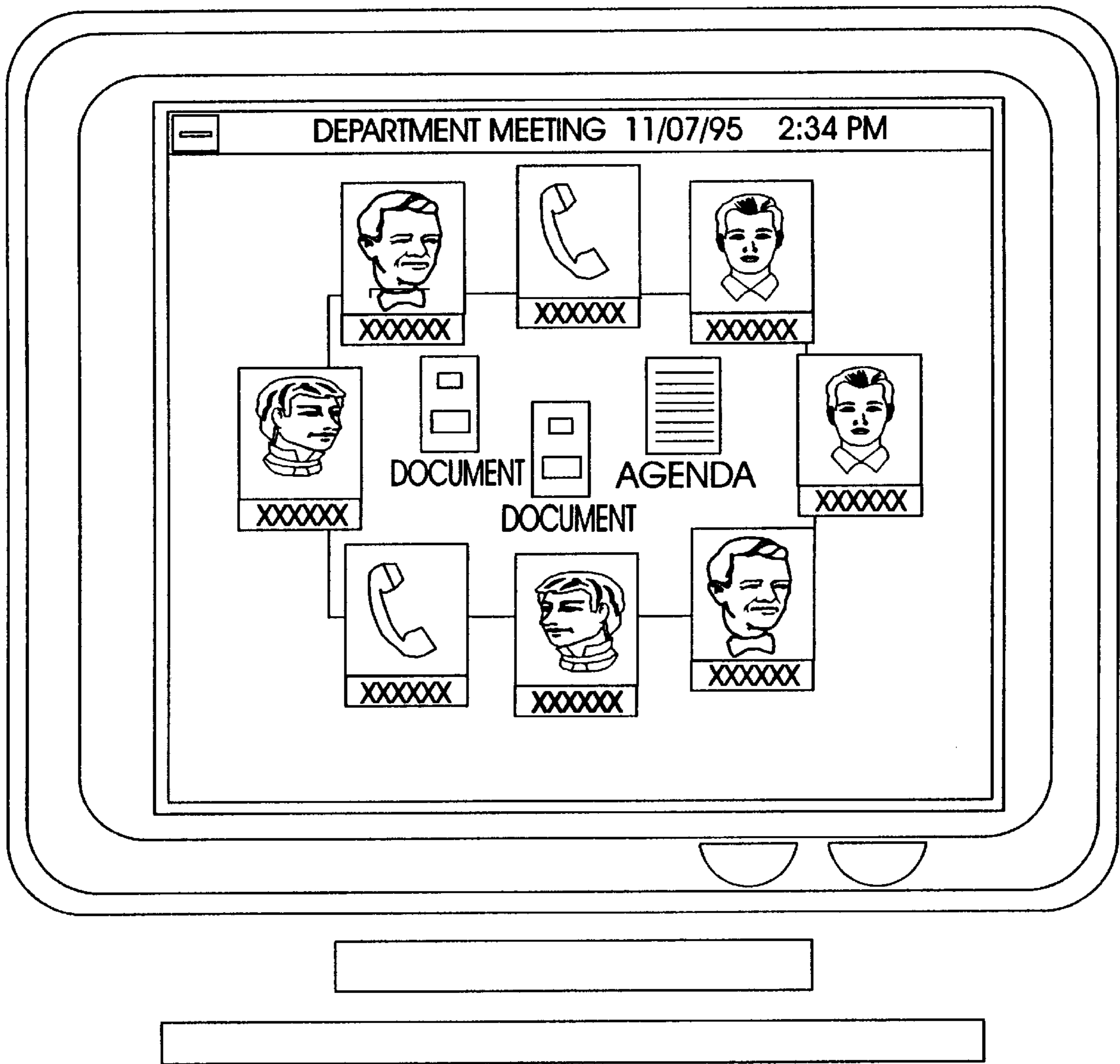

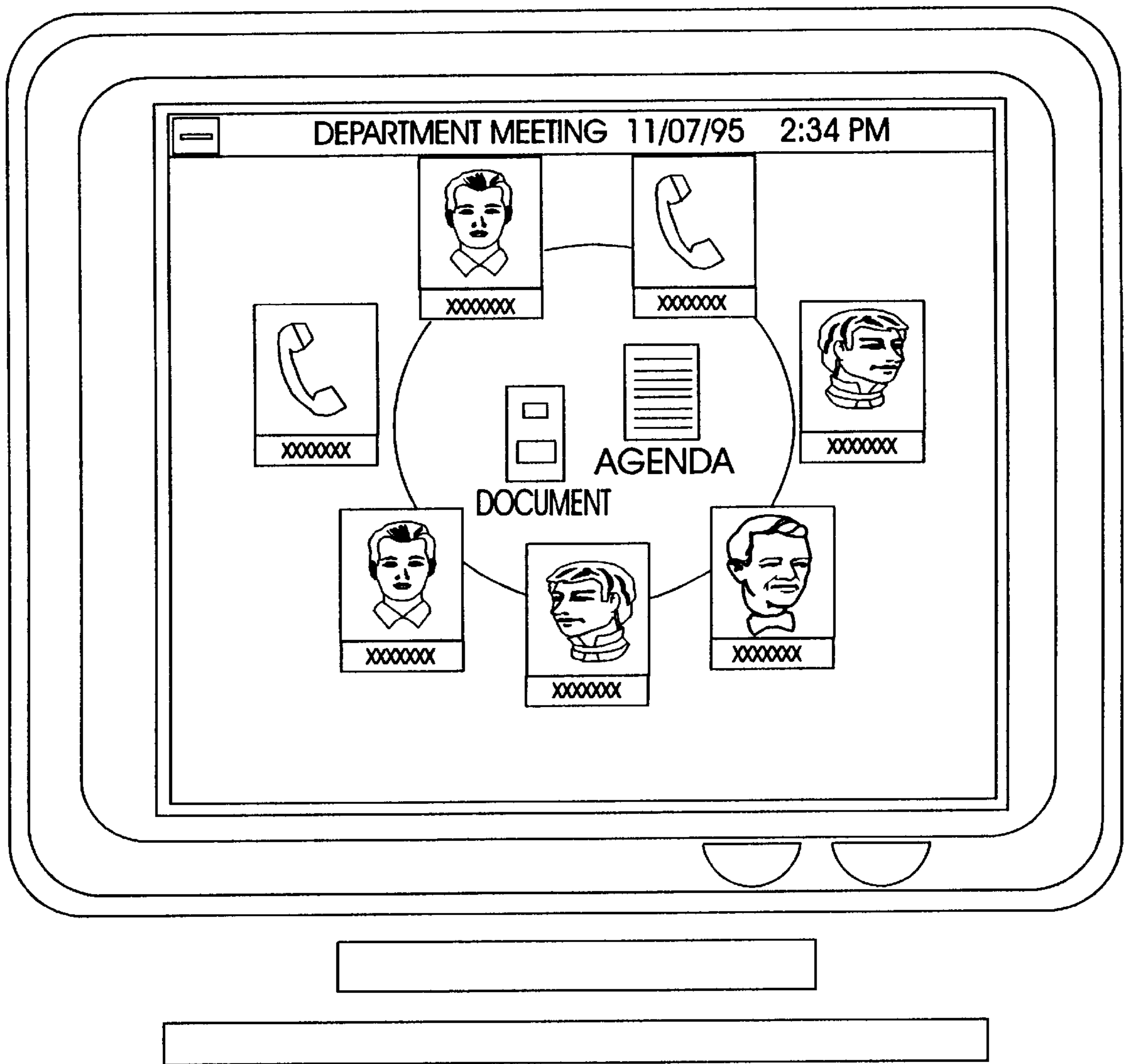

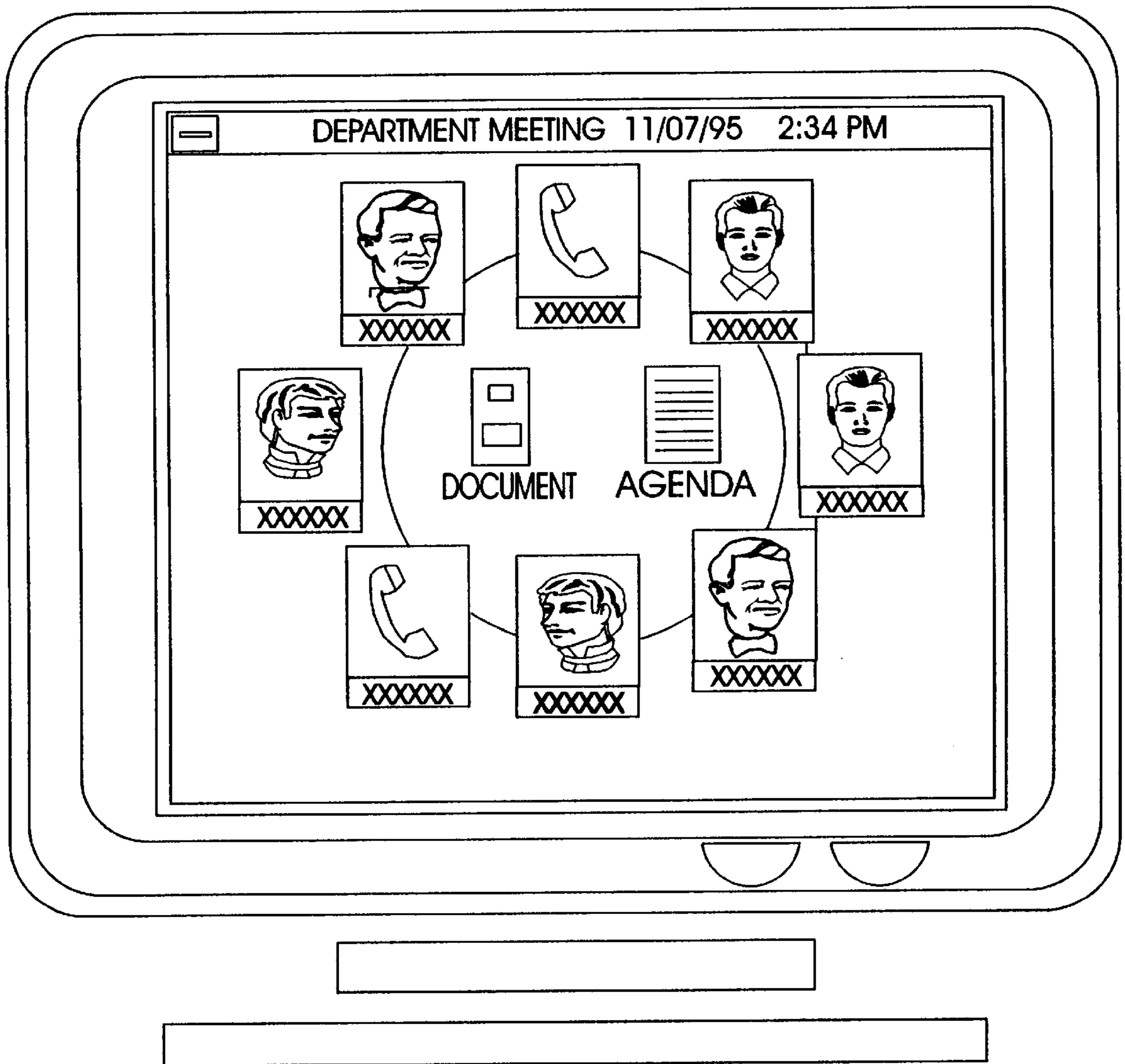

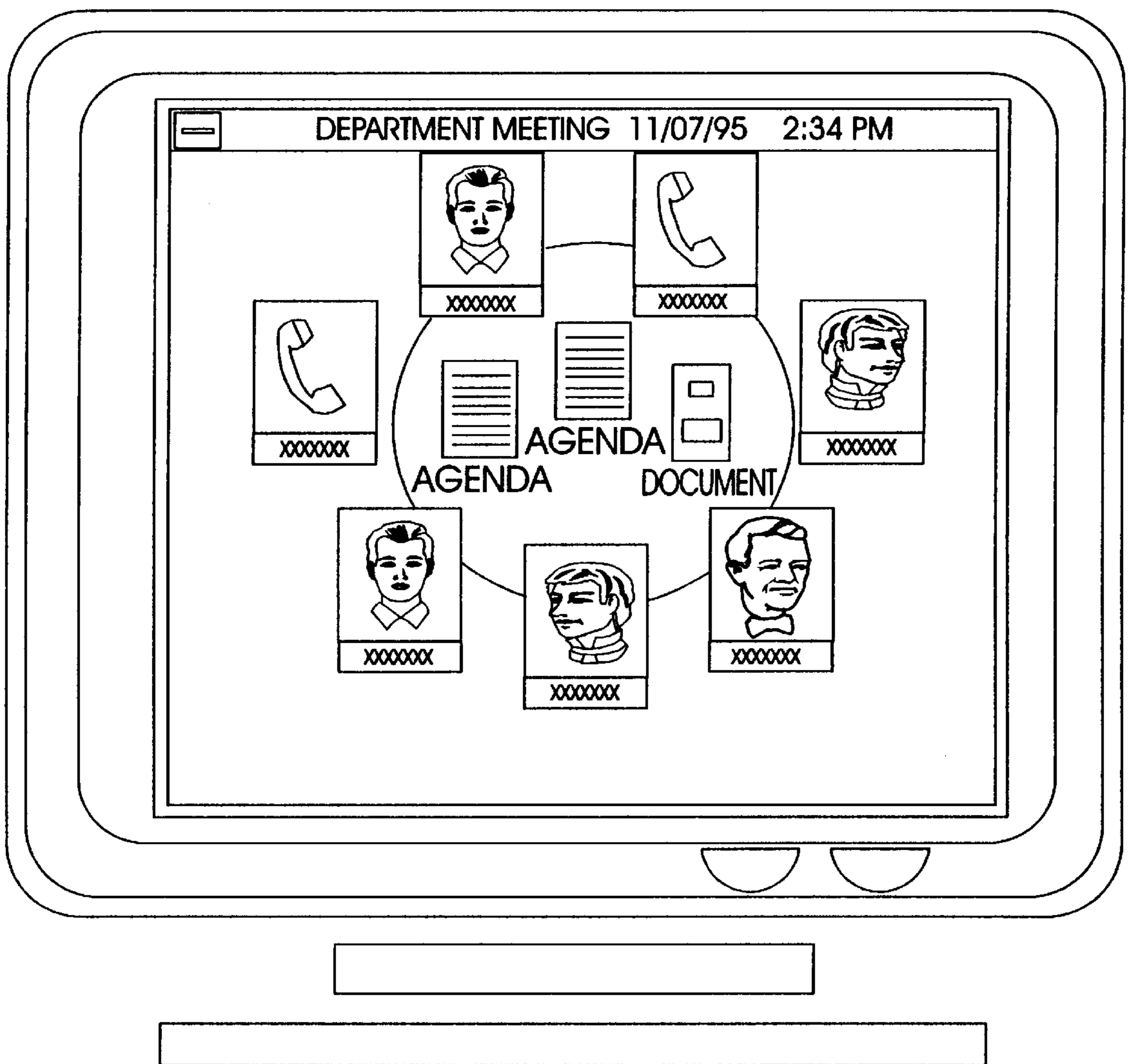
