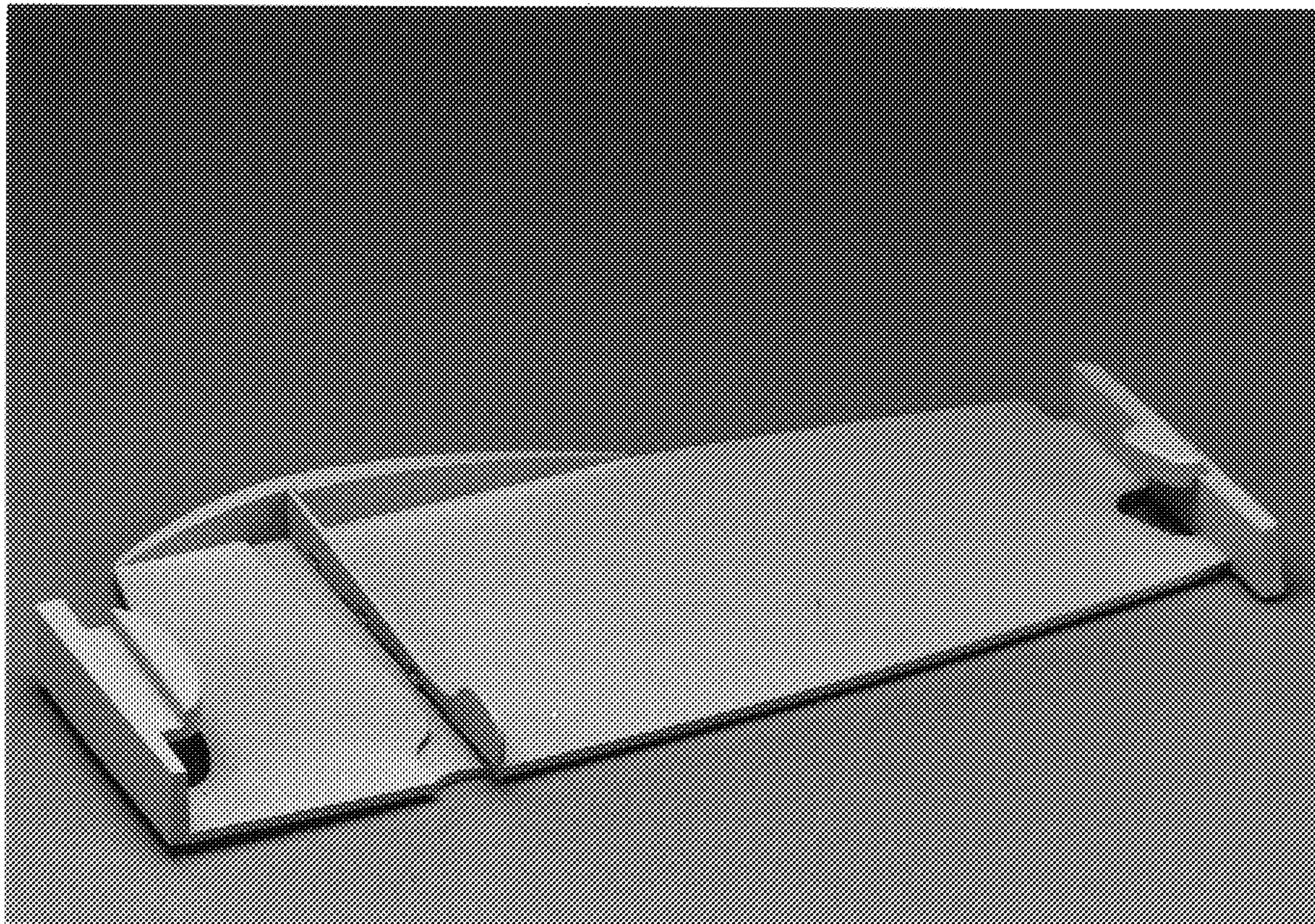
[57] **CLAIM**

The ornamental design for a printer stand with media organizer, as shown and described.

**DESCRIPTION**

FIG. 1 is a top view of a first embodiment of a printer stand with media organizer showing our new design; FIG. 2 is a front view thereof, showing a tray of size for envelopes on the left and a tray of size for correspondence paper on the right; FIG. 3 is a right side view thereof; FIG. 4 is a left side view thereof; FIG. 5 is a rear view thereof; FIG. 6 is a bottom view thereof; FIG. 7 is a top, front left side perspective view thereof; FIG. 8 is a top, front left side perspective view of a second embodiment of a printer stand with media organizer showing our new design; FIG. 9 is a front view thereof, showing two trays of size for envelopes on the left and two trays of size for correspondence paper on the right; FIG. 10 is a right side view thereof; FIG. 11 is a left side view thereof; and, FIG. 12 is a rear view thereof.

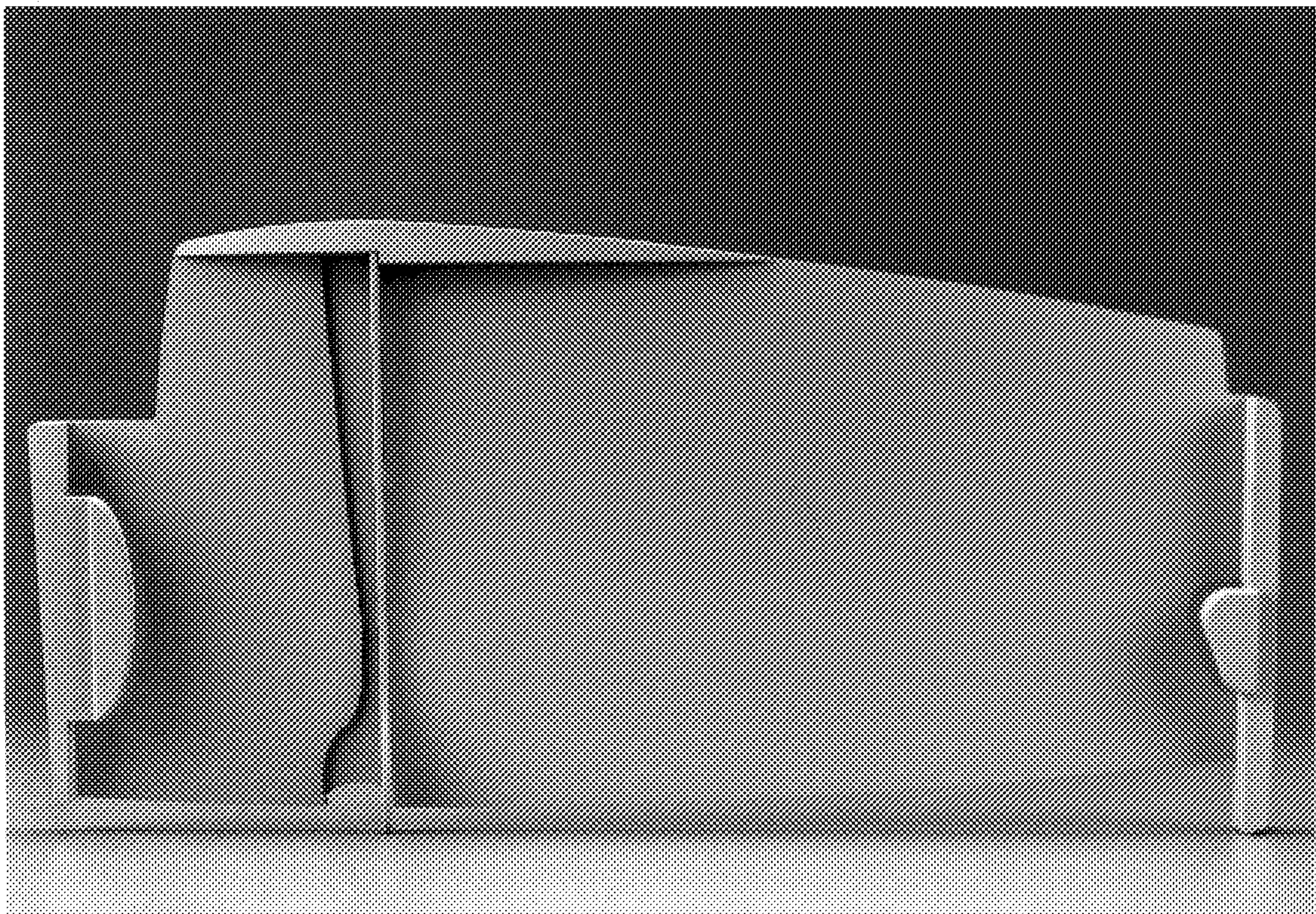

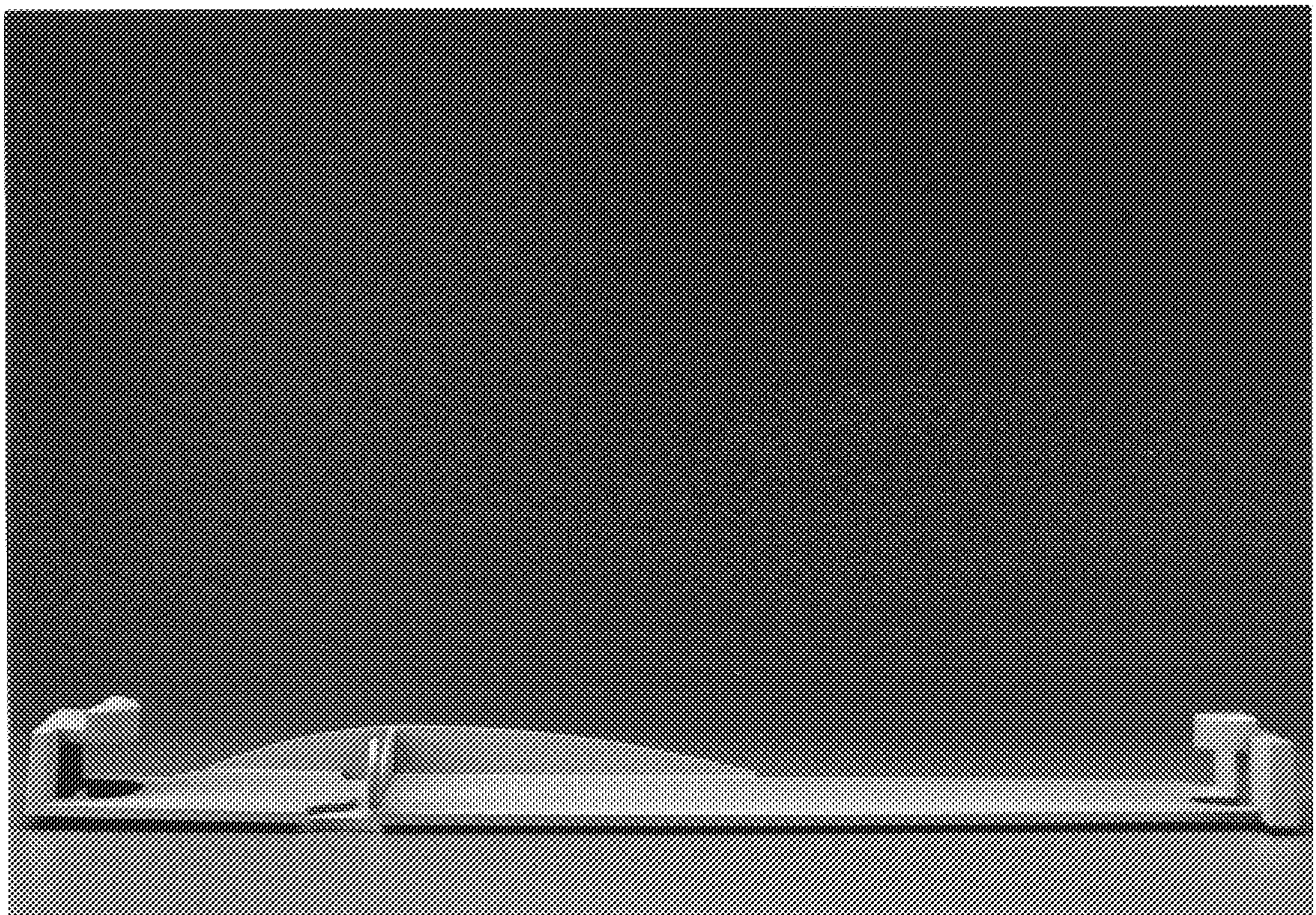

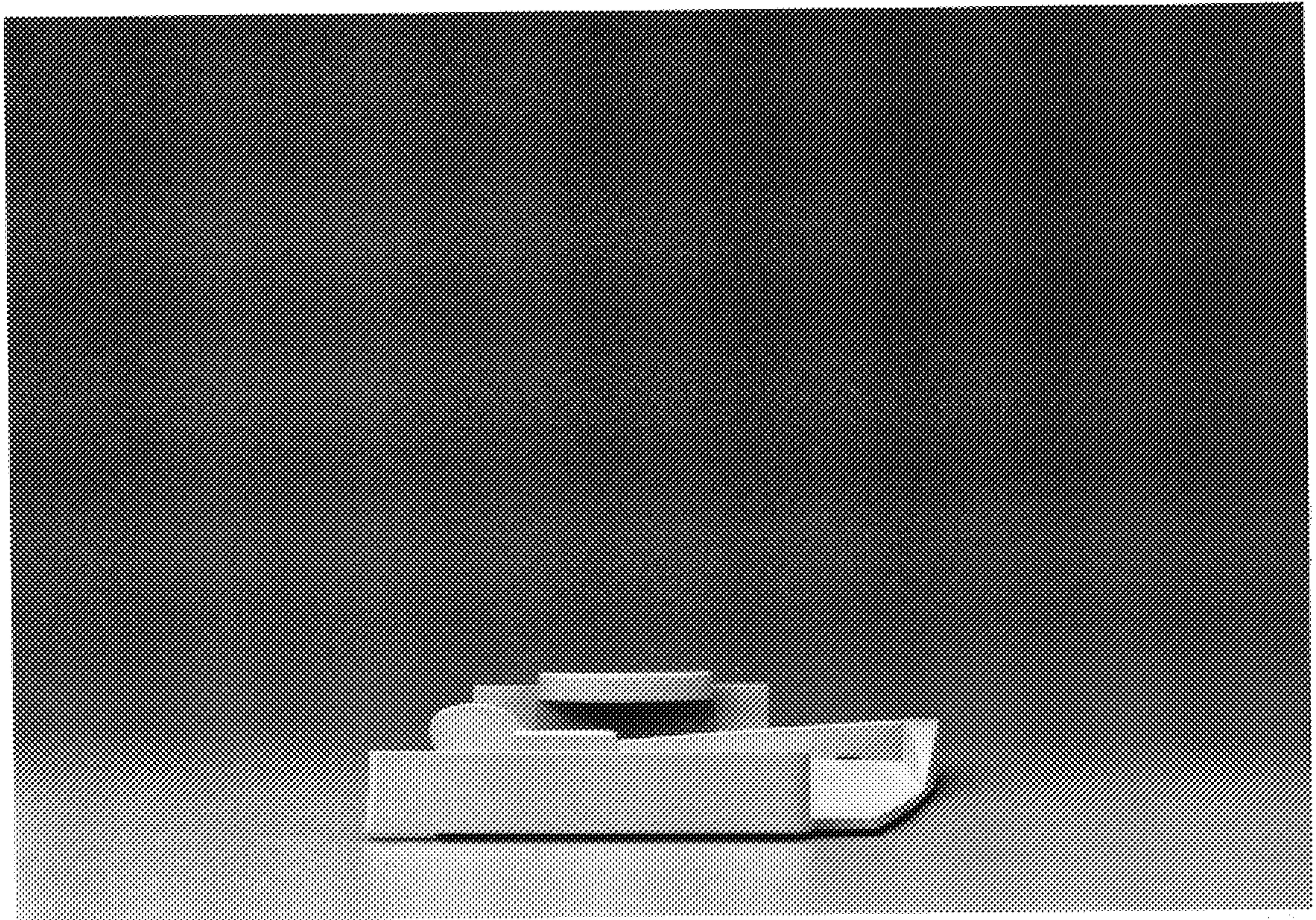

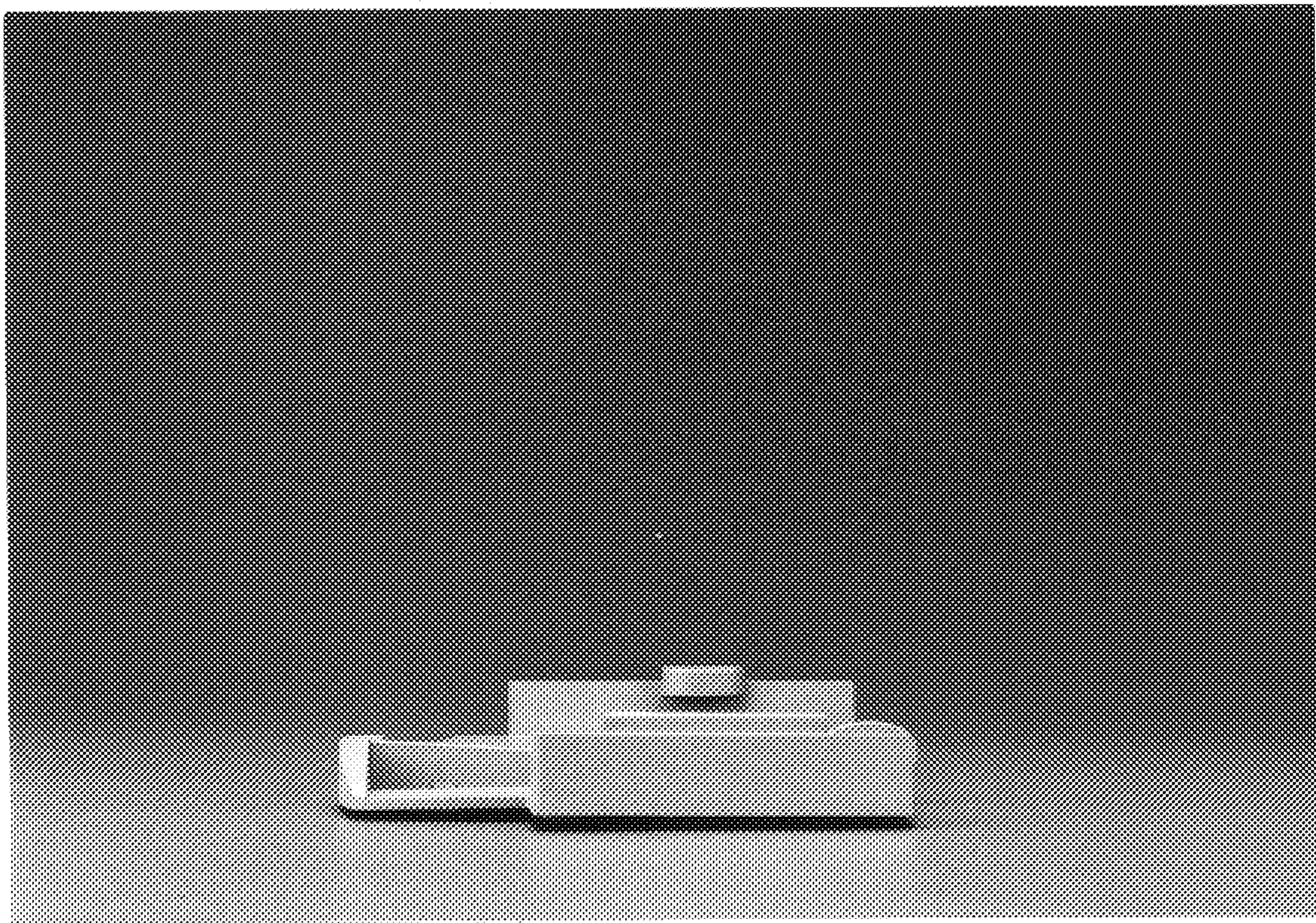

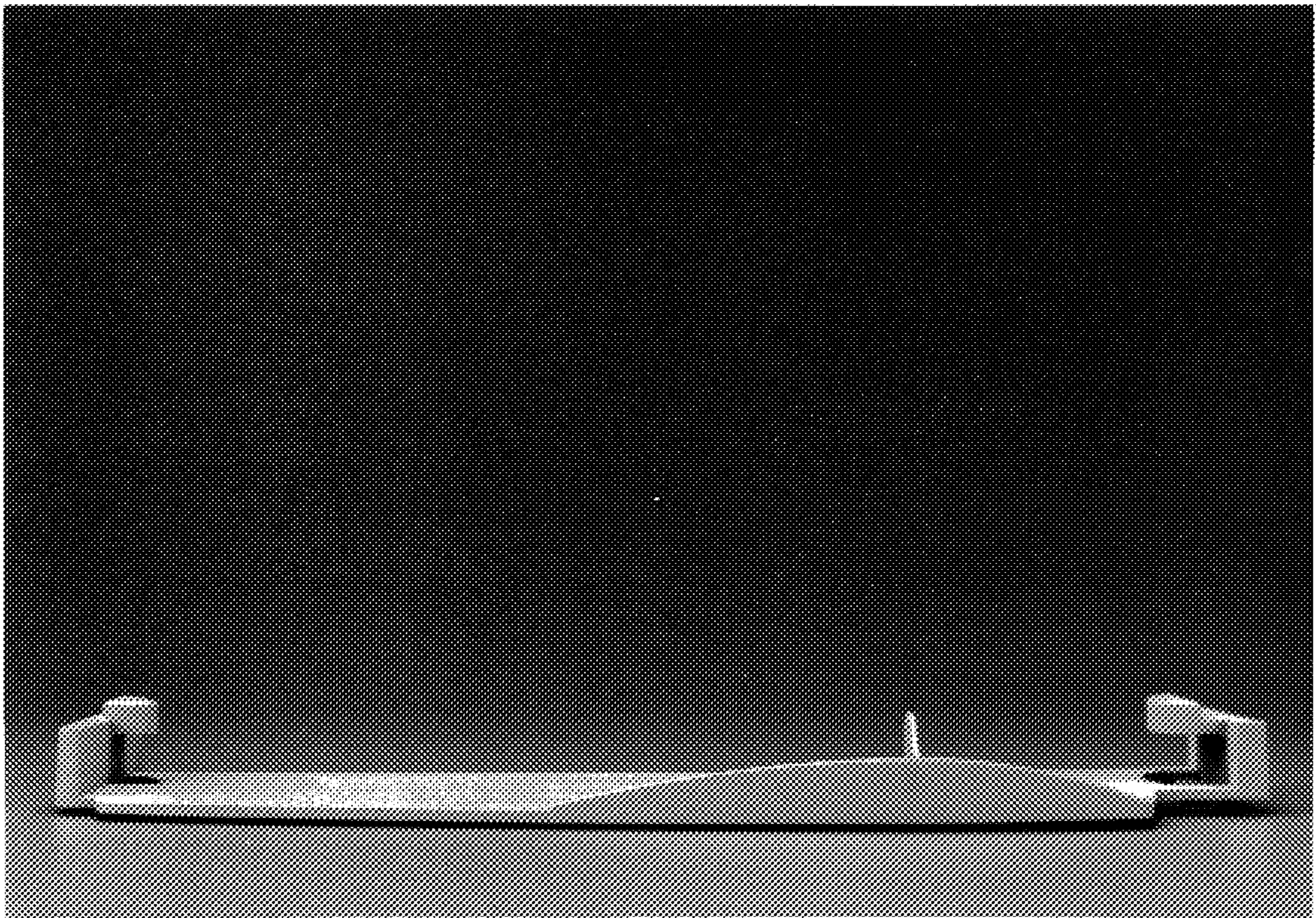

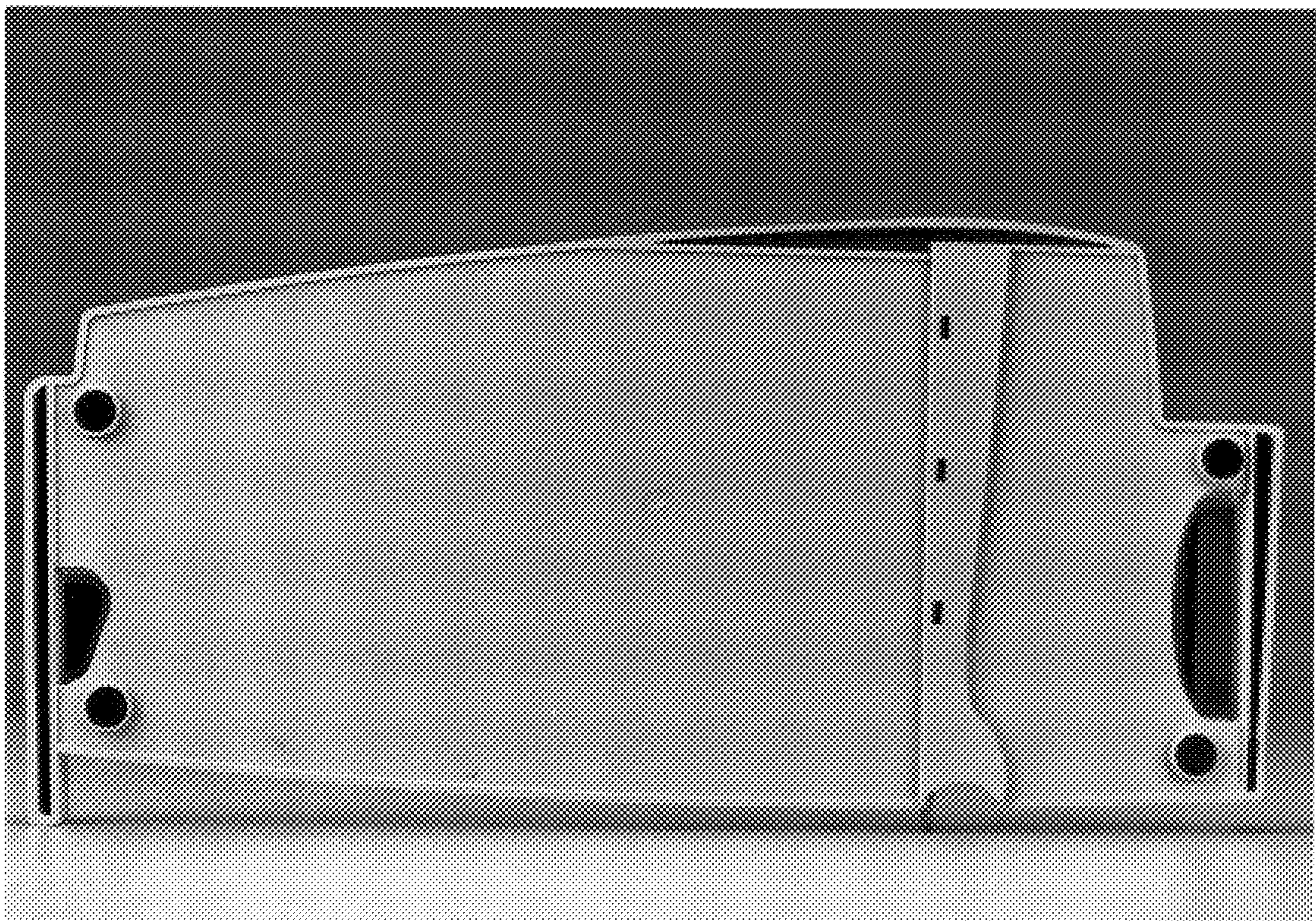

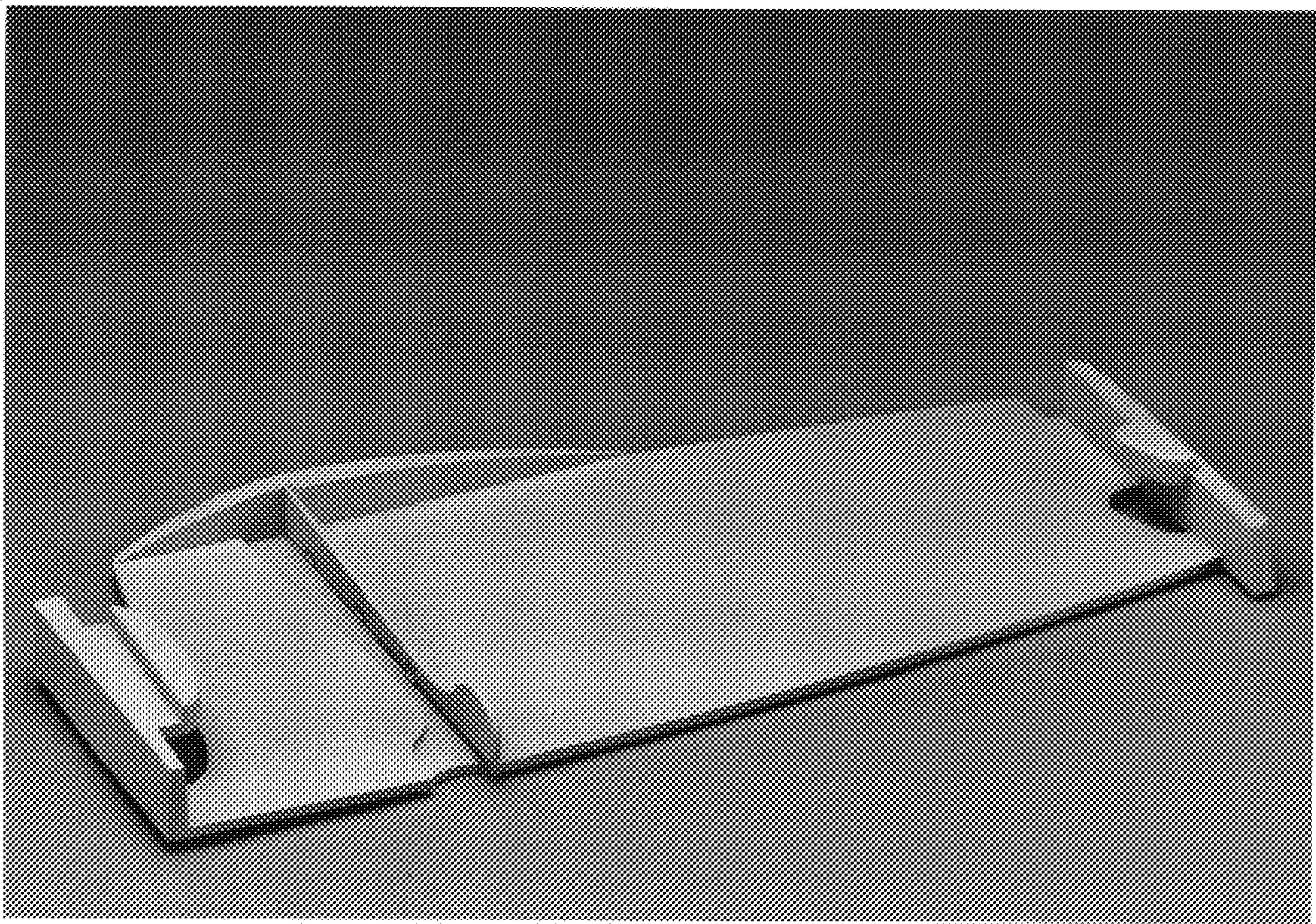

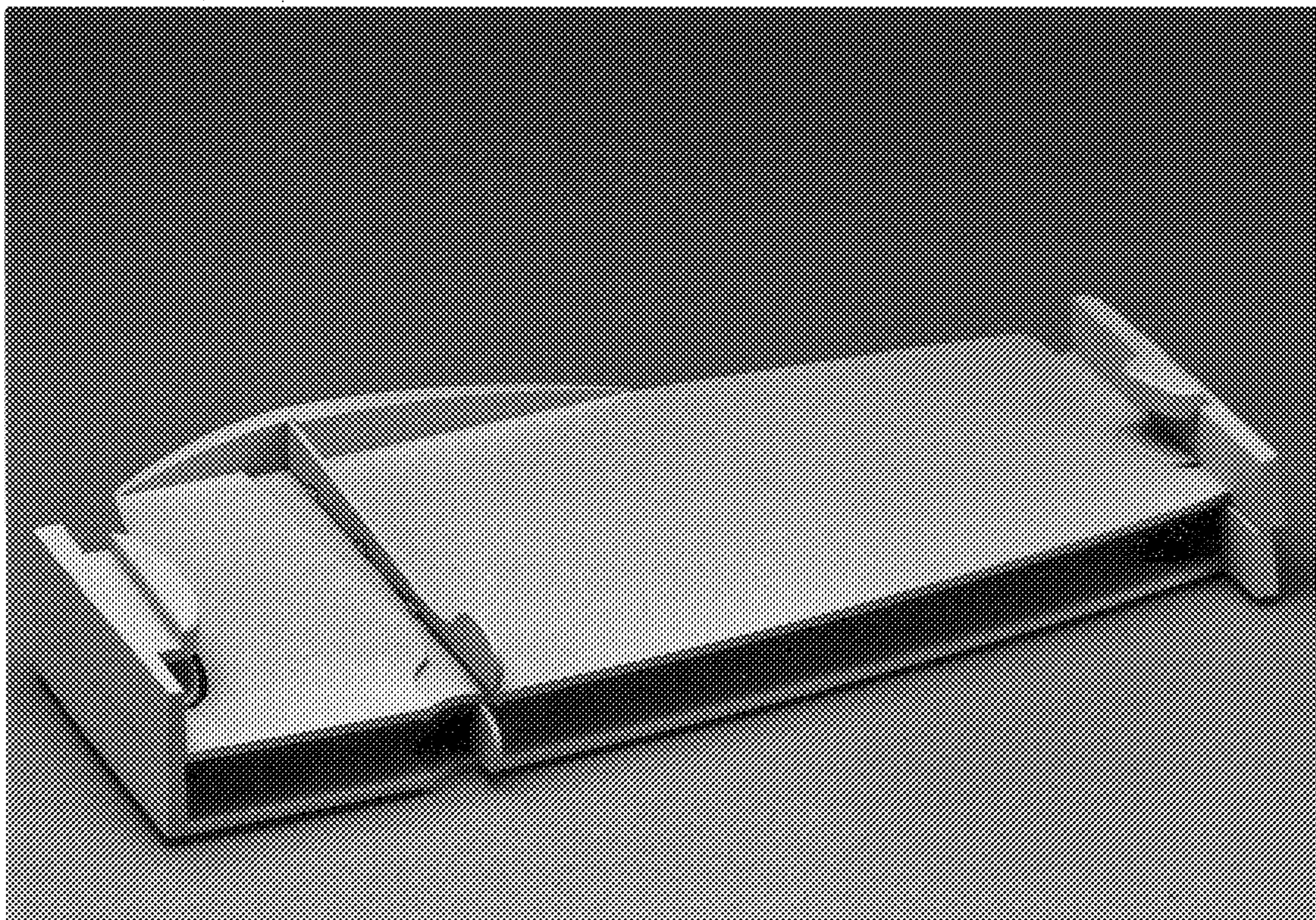

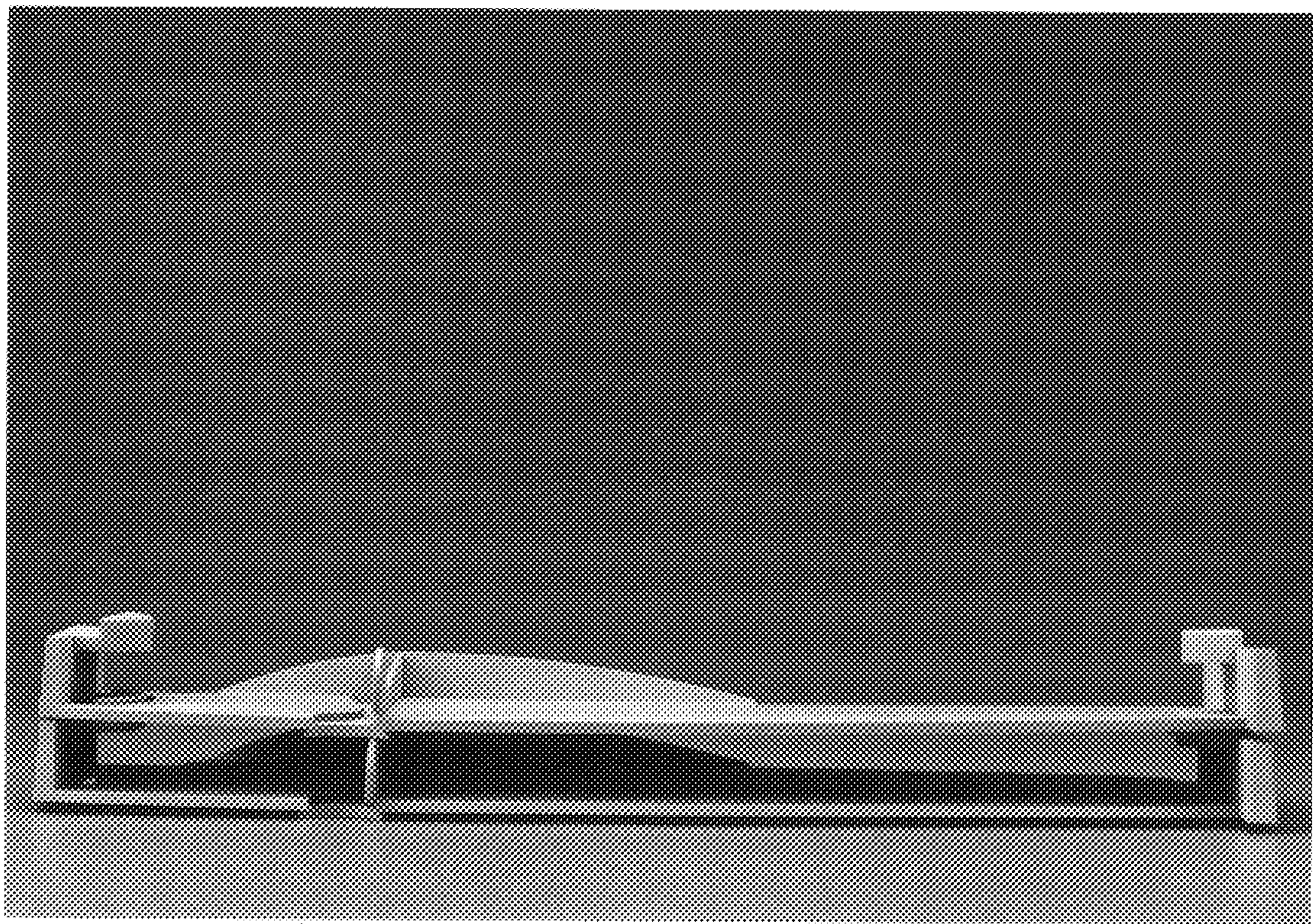

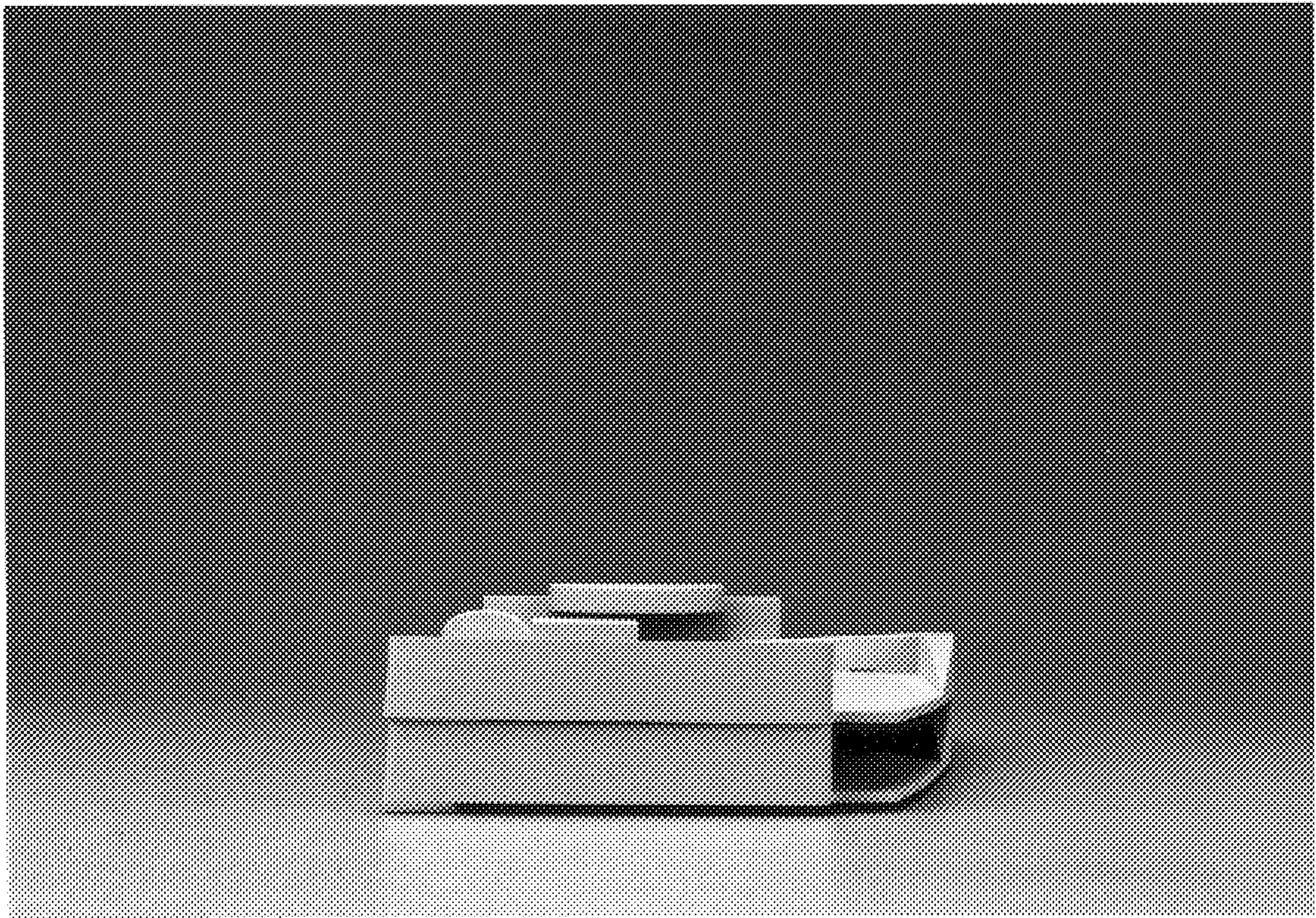

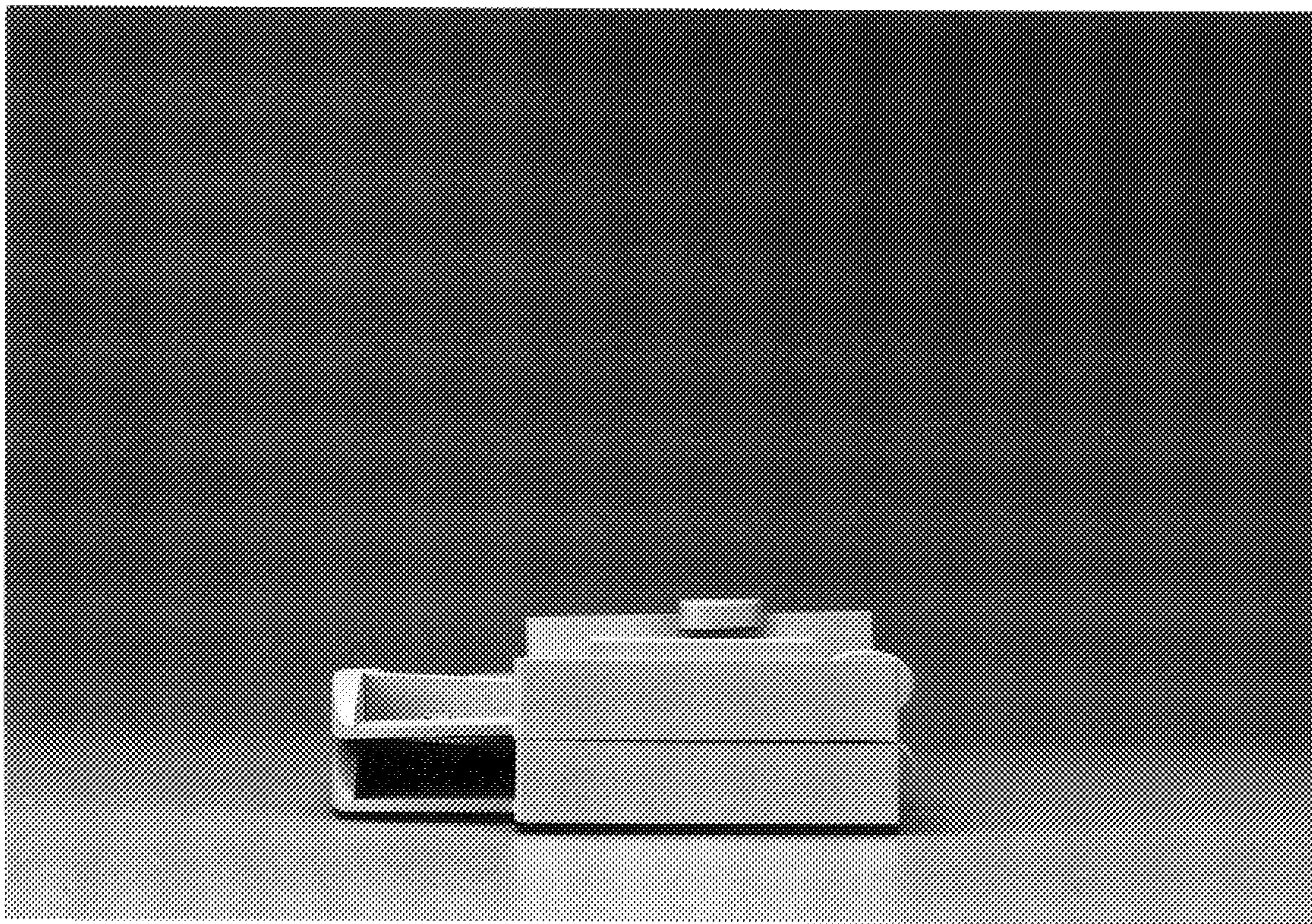

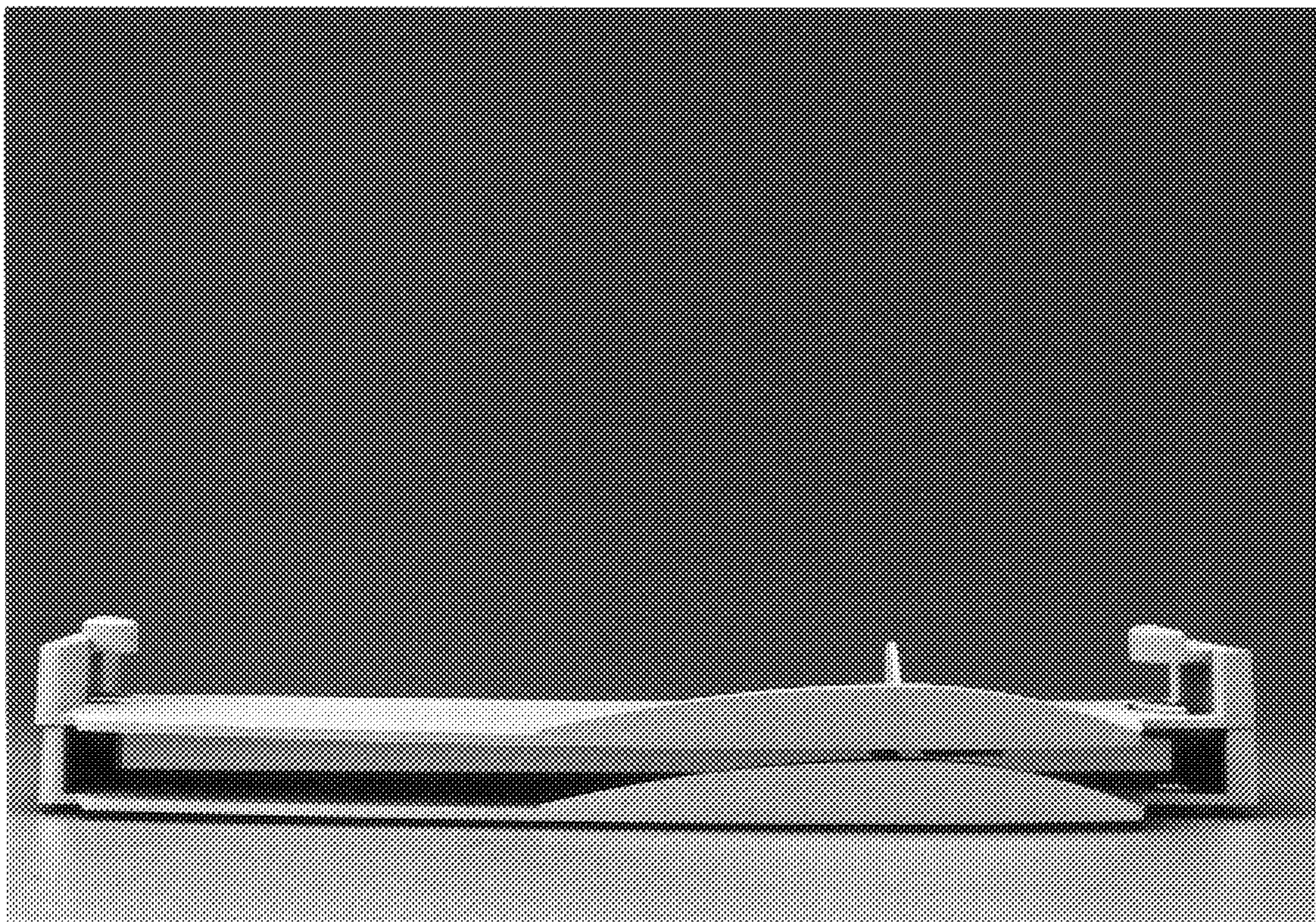
