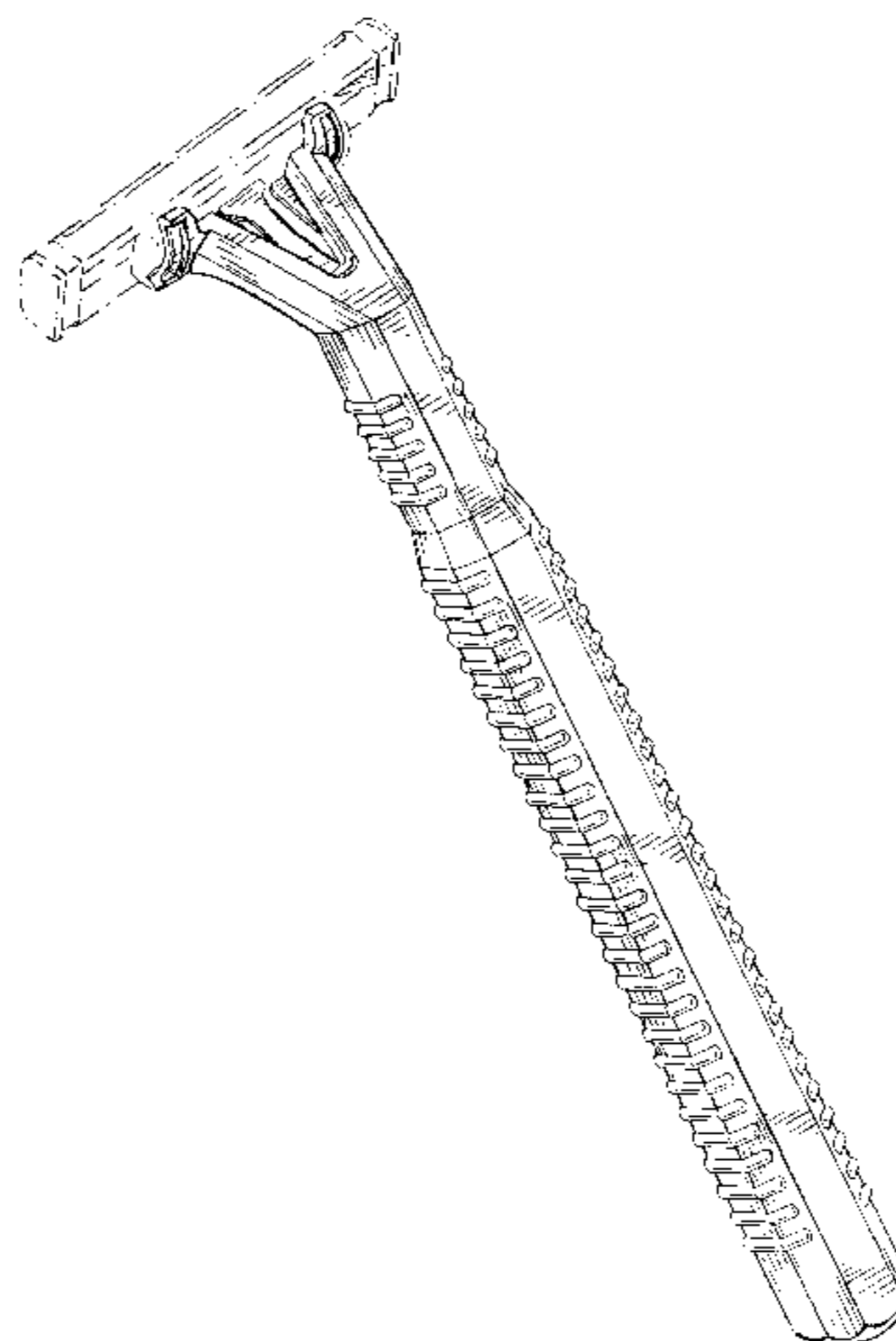
[57] CLAIM

The ornamental design for a razor handle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a razor handle, with a blade cartridge shown in phantom, the phantom line showing of the razor cartridge being for illustrative purposes only and forming no part of the claimed design;
FIG. 2 is a top view of the razor handle;
FIGS. 3, 4 and 5 are front, side and back views of the razor handle, respectively; the undisclosed opposite side of FIG. 4 being a mirror image of the side shown; and,
FIG. 6 is a bottom view of the razor handle.

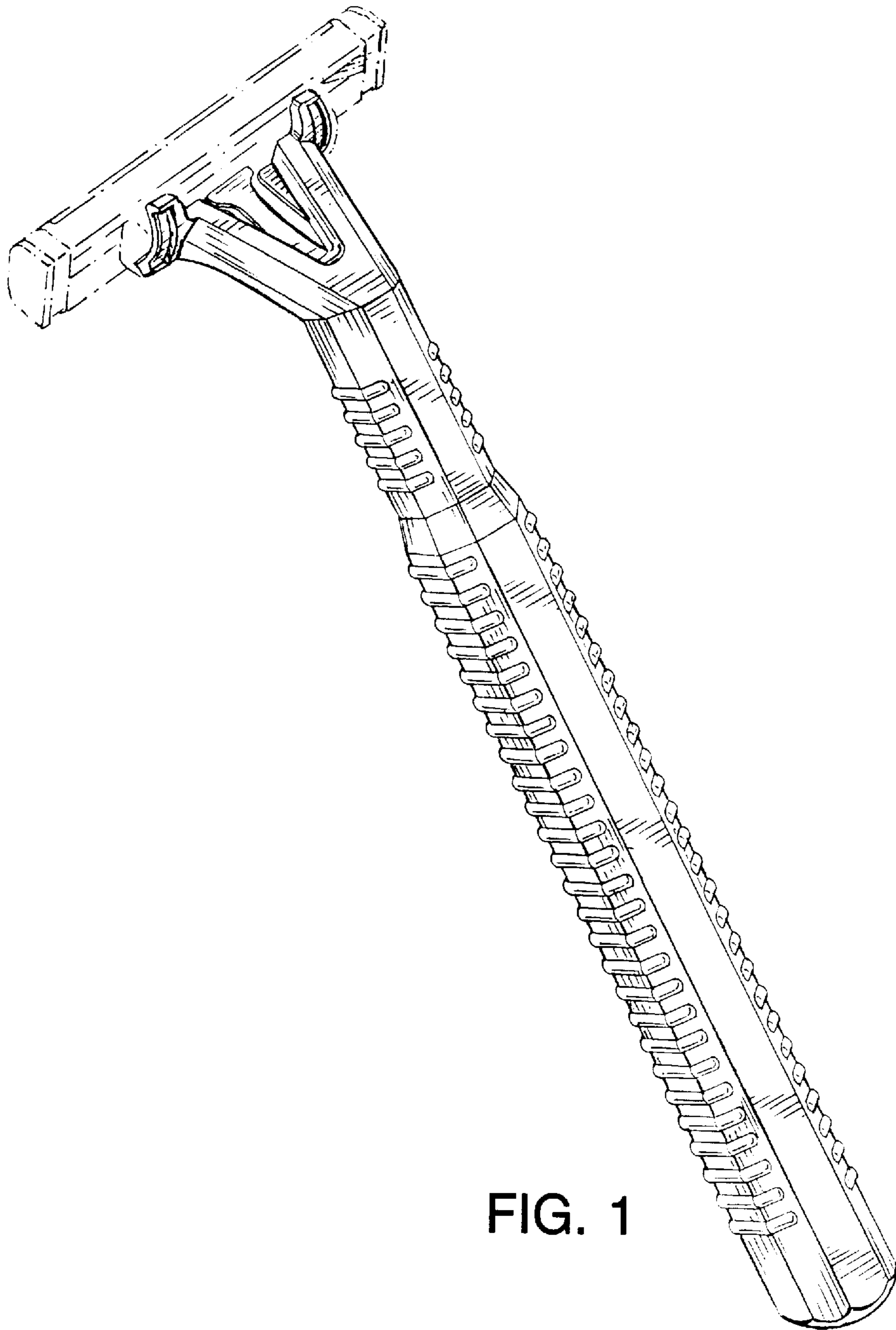

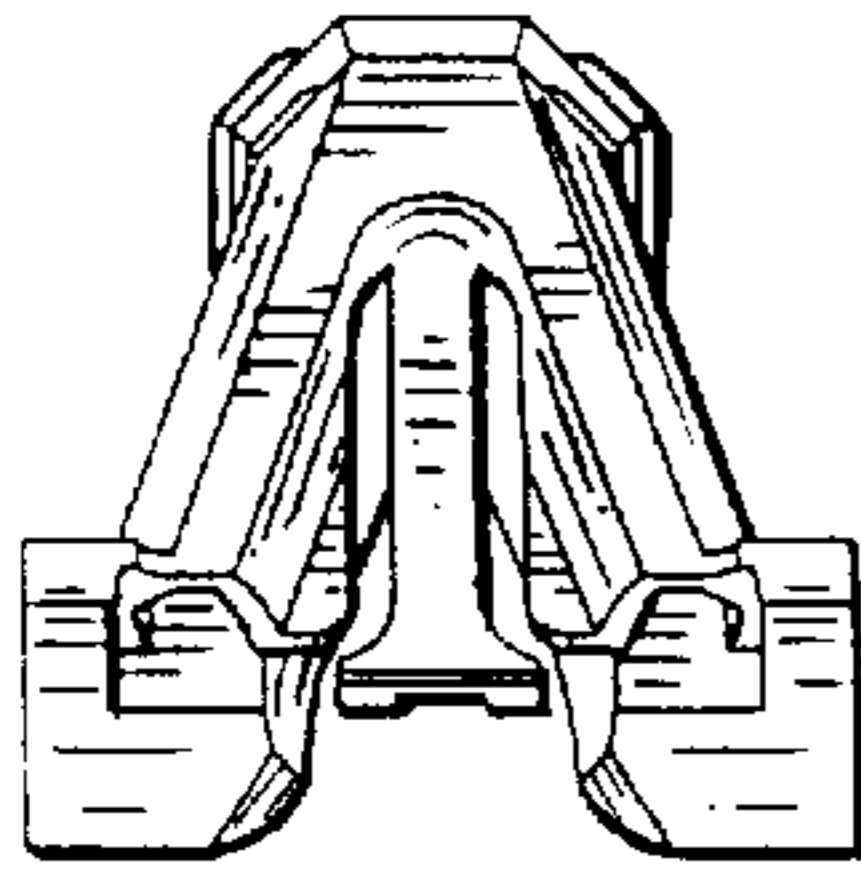

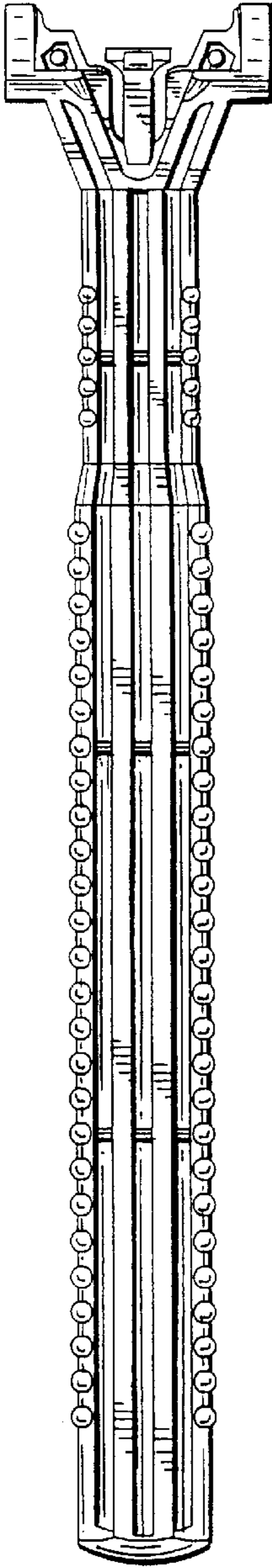

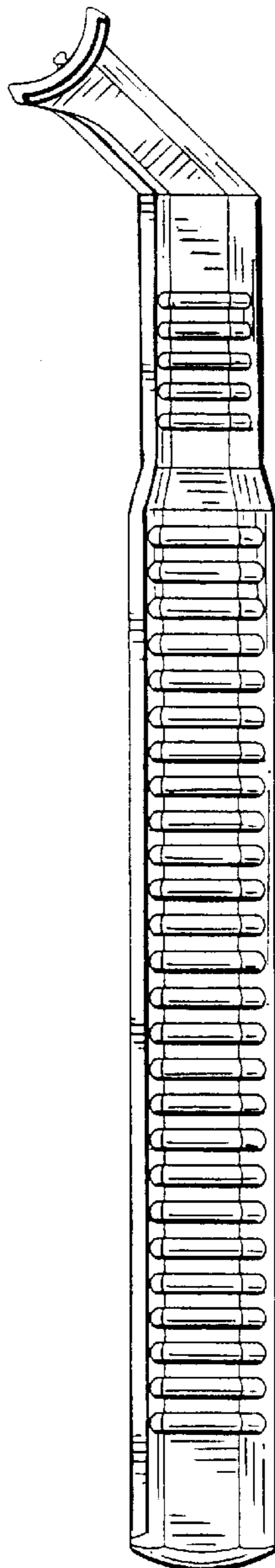

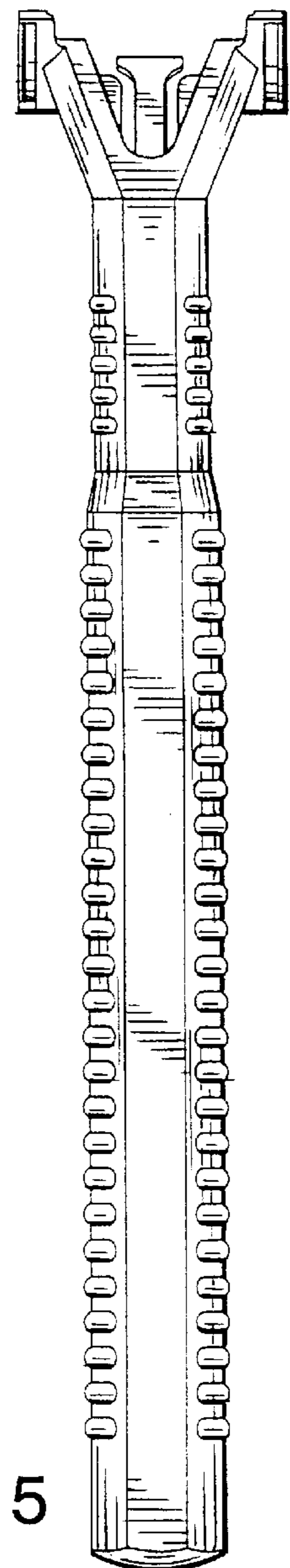
