[57] **CLAIM**

The ornamental design for a portion of a shoe outsole, as shown and described.

DESCRIPTION

FIG. 1 is a bottom perspective view of a portion of a shoe outsole showing my new design;
FIG. 2 is a bottom plan view thereof;
FIG. 3 is a cross section taken through line 3—3 of FIG. 2;
FIG. 4 is a cross section taken through line 4—4 of FIG. 2;
and,
FIG. 5 is a cross section taken through line 5—5 of FIG. 2. The broken line showing of the oval elements and the remainder of the shoe is for illustrative purposes and forms no part of the claimed design.

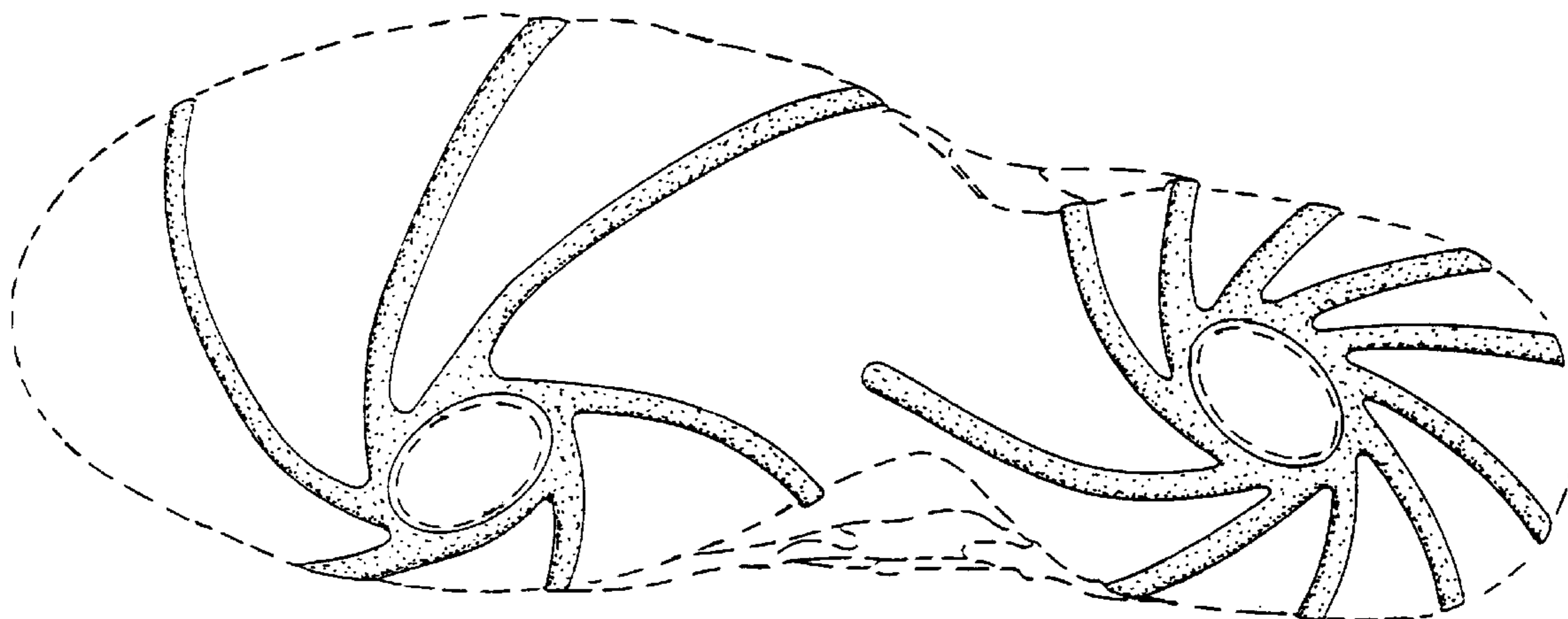

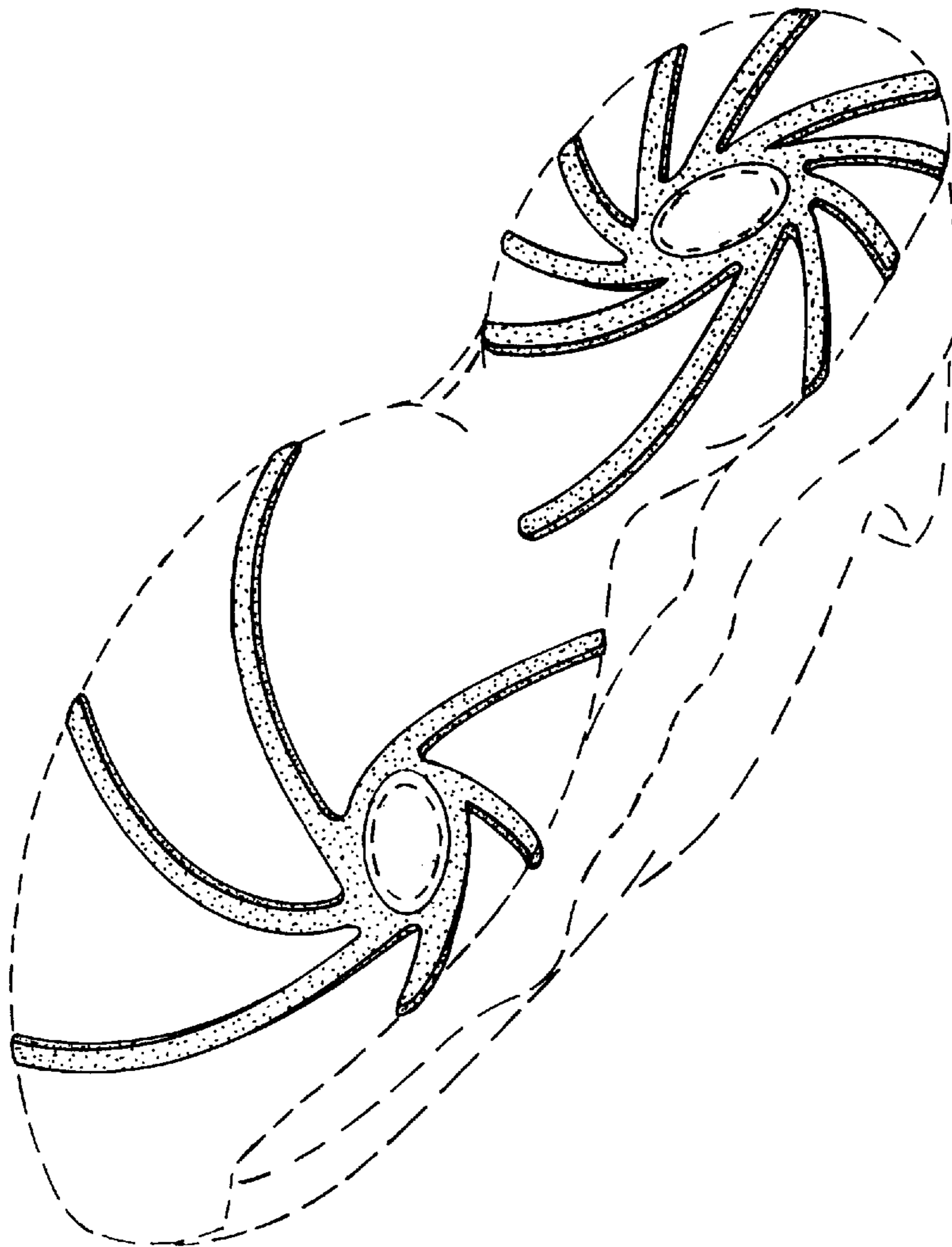
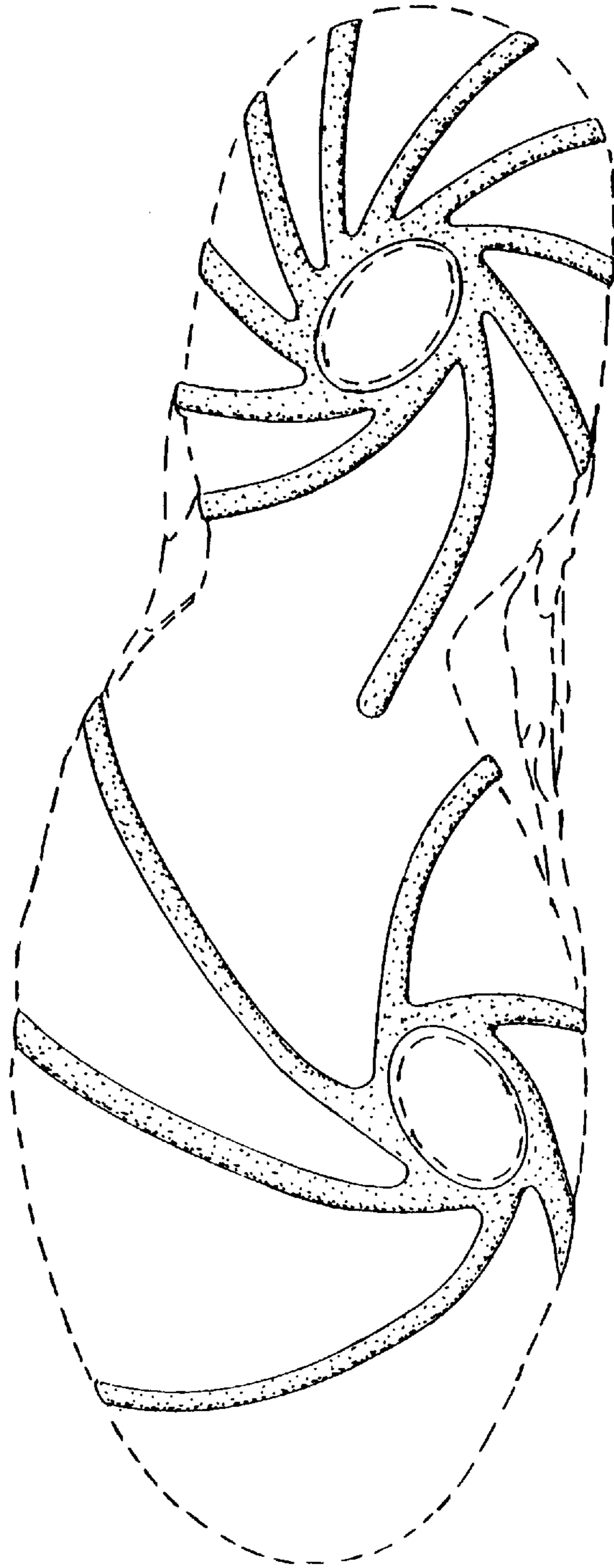
