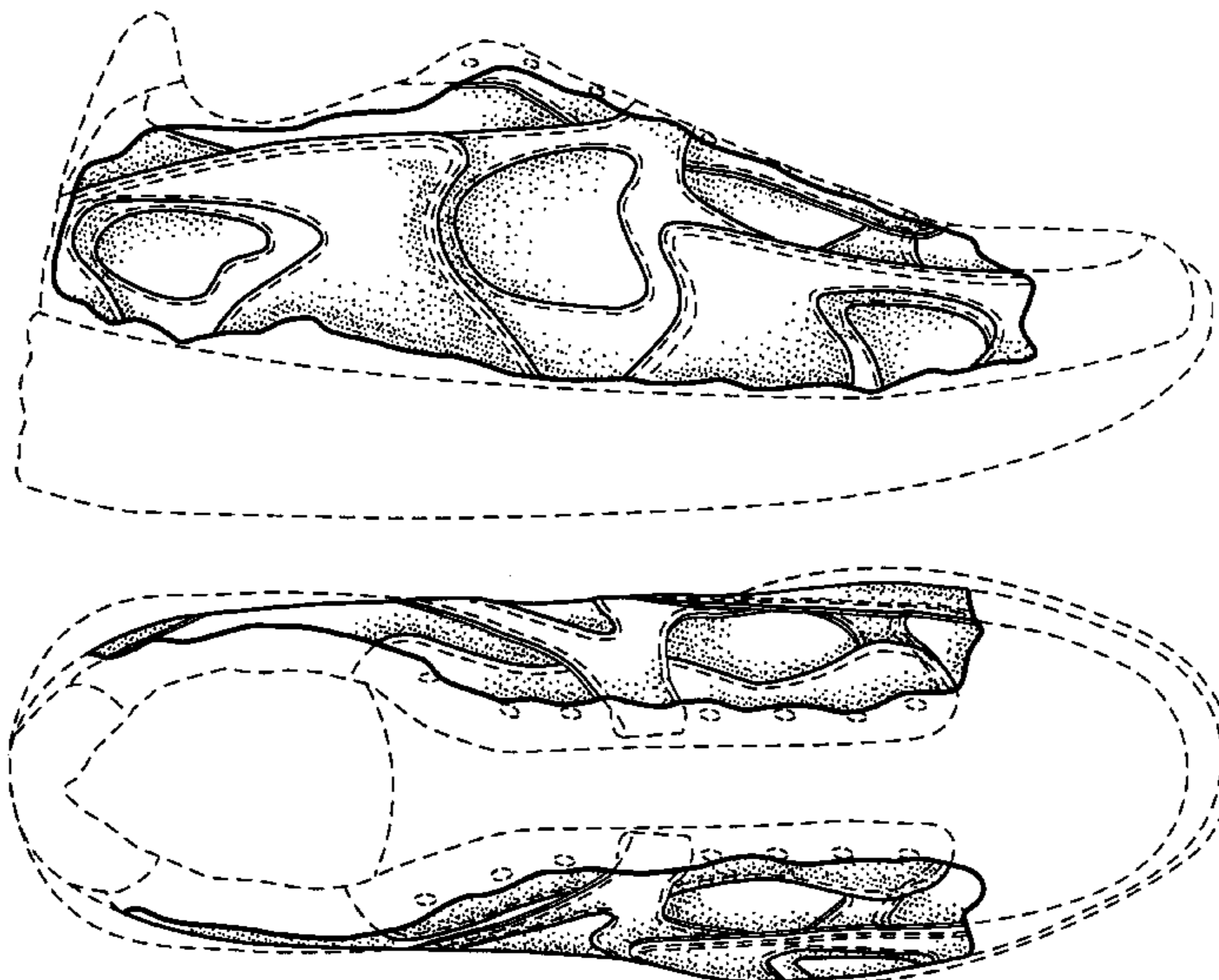
[57] **CLAIM**

The ornamental design for a side element of a shoe upper, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a side element of a shoe upper showing my new design;  
FIG. 2 is a right side elevational view thereof;  
FIG. 3 is a left side elevational view thereof;  
FIG. 4 is a front elevational view thereof;  
FIG. 5 is a rear elevational view thereof; and,  
FIG. 6 is a top plan view thereof.  
The broken line showing of a shoe sole and the remaining portion of the shoe upper shown in FIGS. 1-7 is for illustrative purposes only and forms no part of the claimed design.

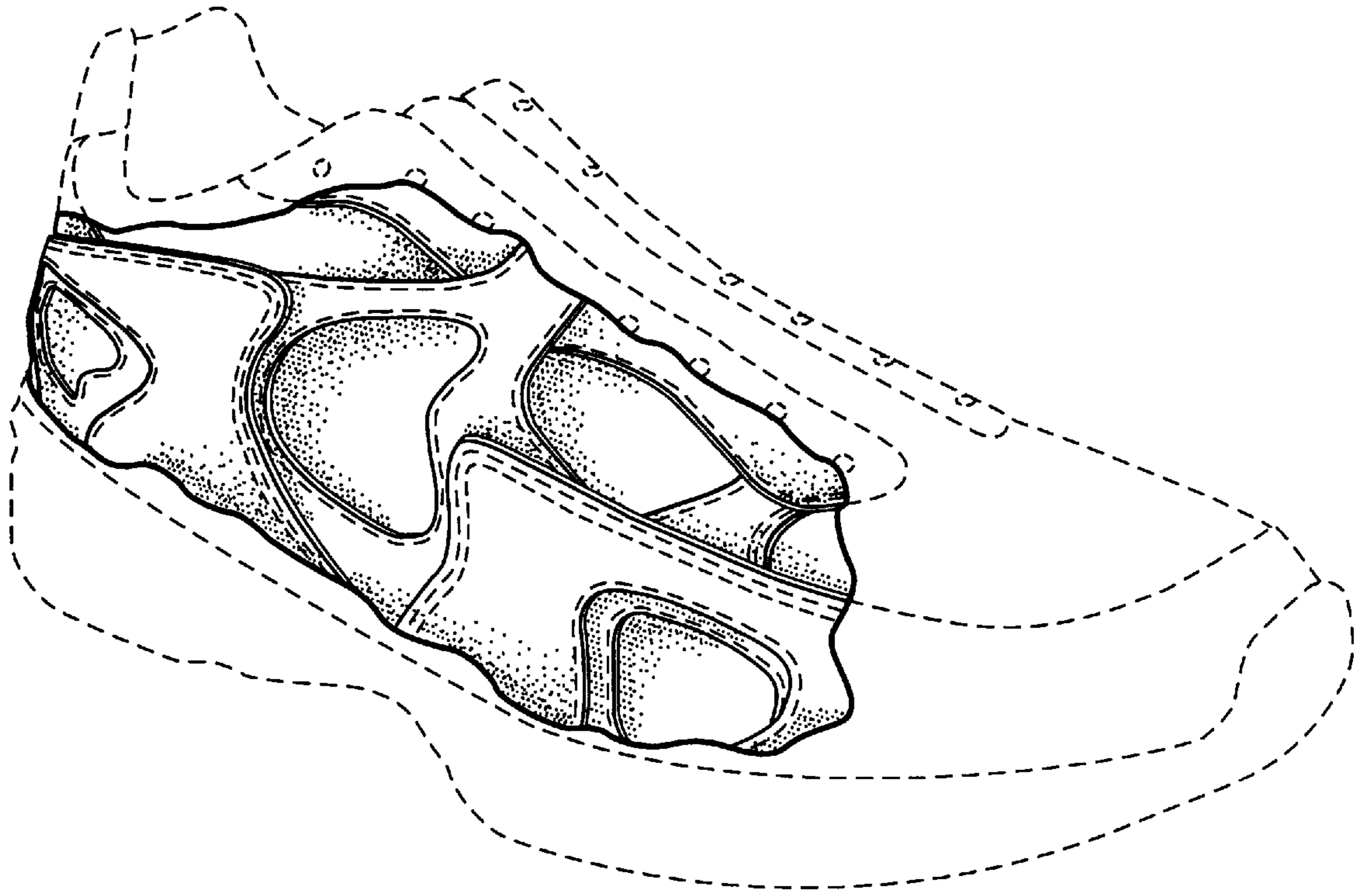

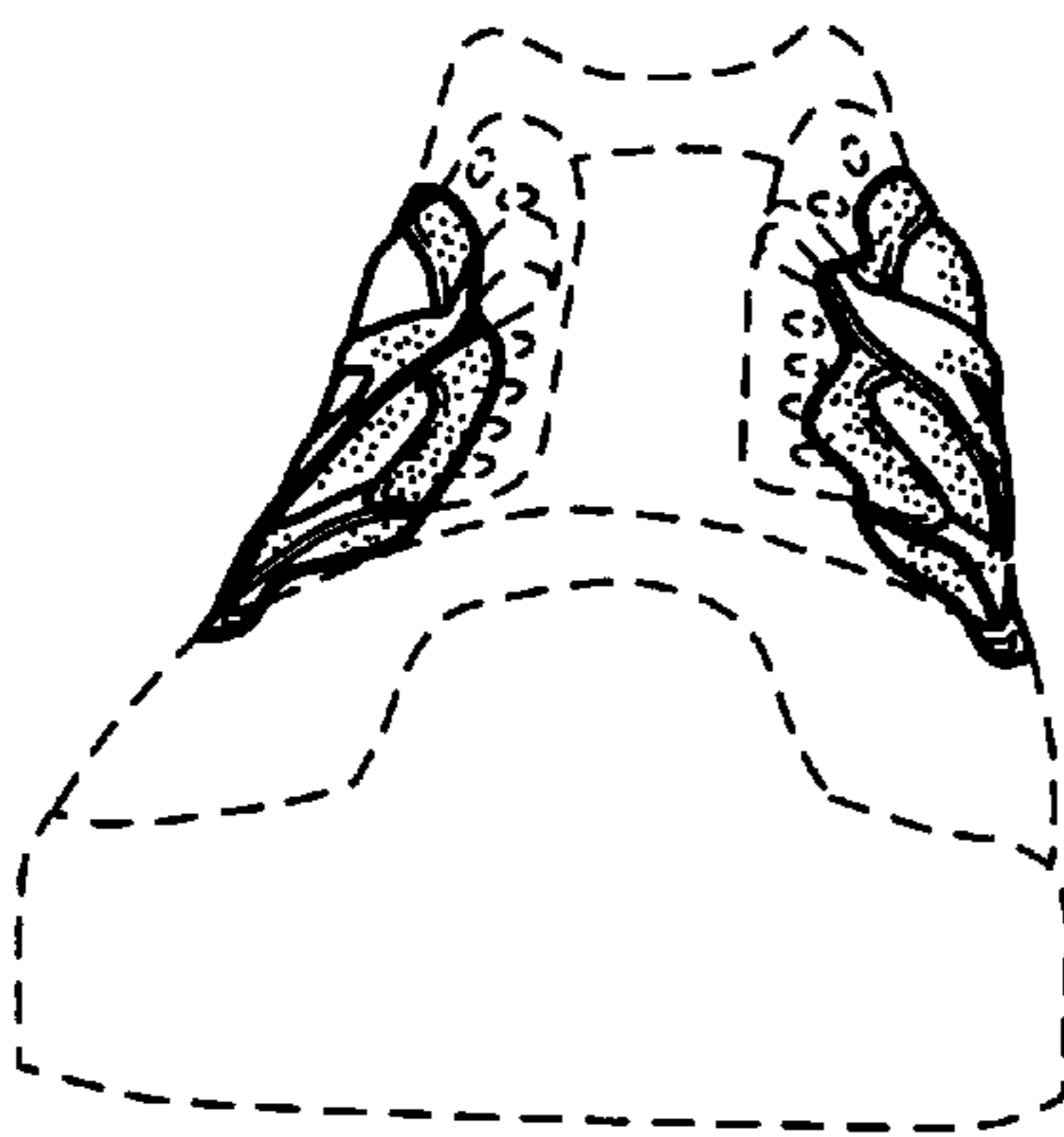

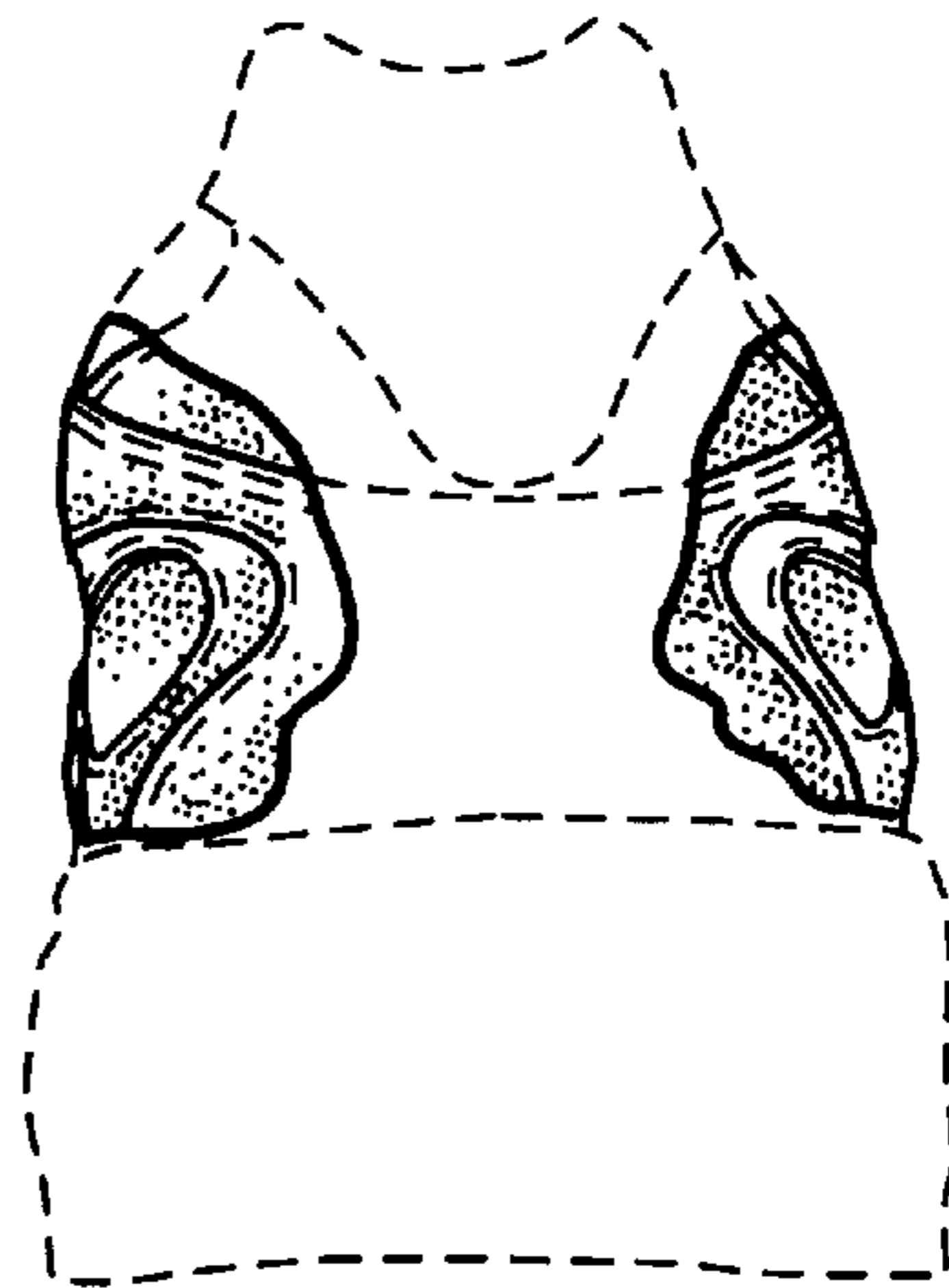

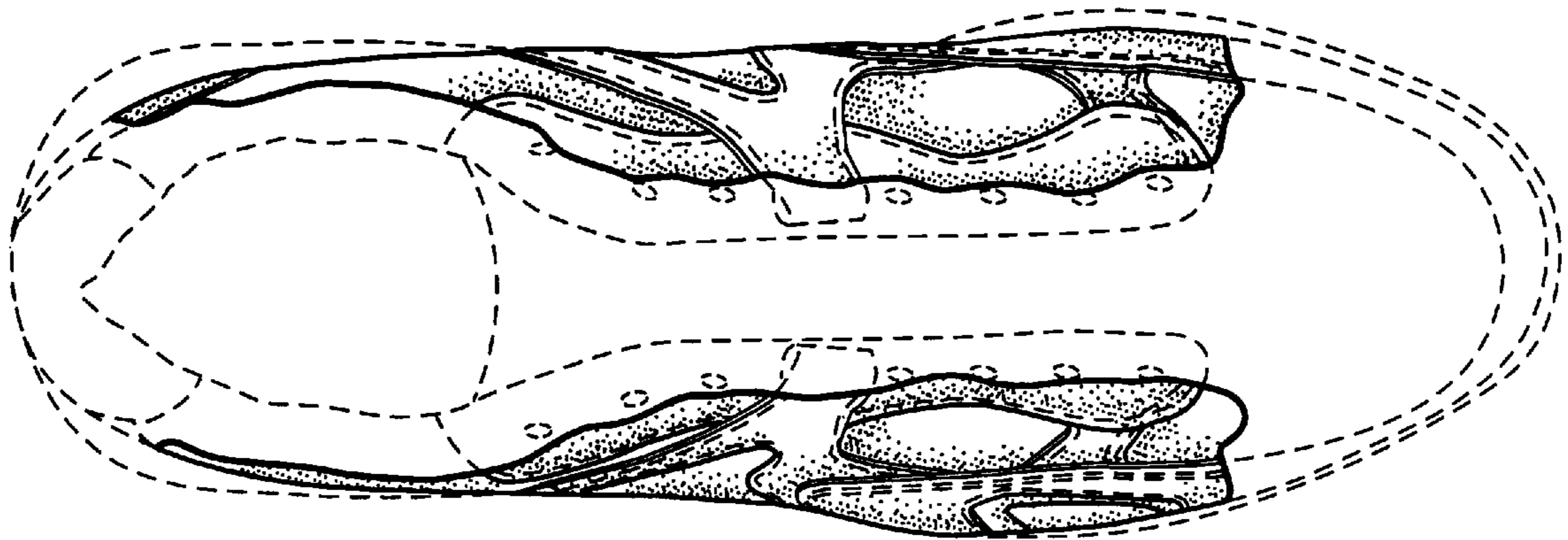
