DESCRIPTION

FIG. 2 is a perspective view thereof;

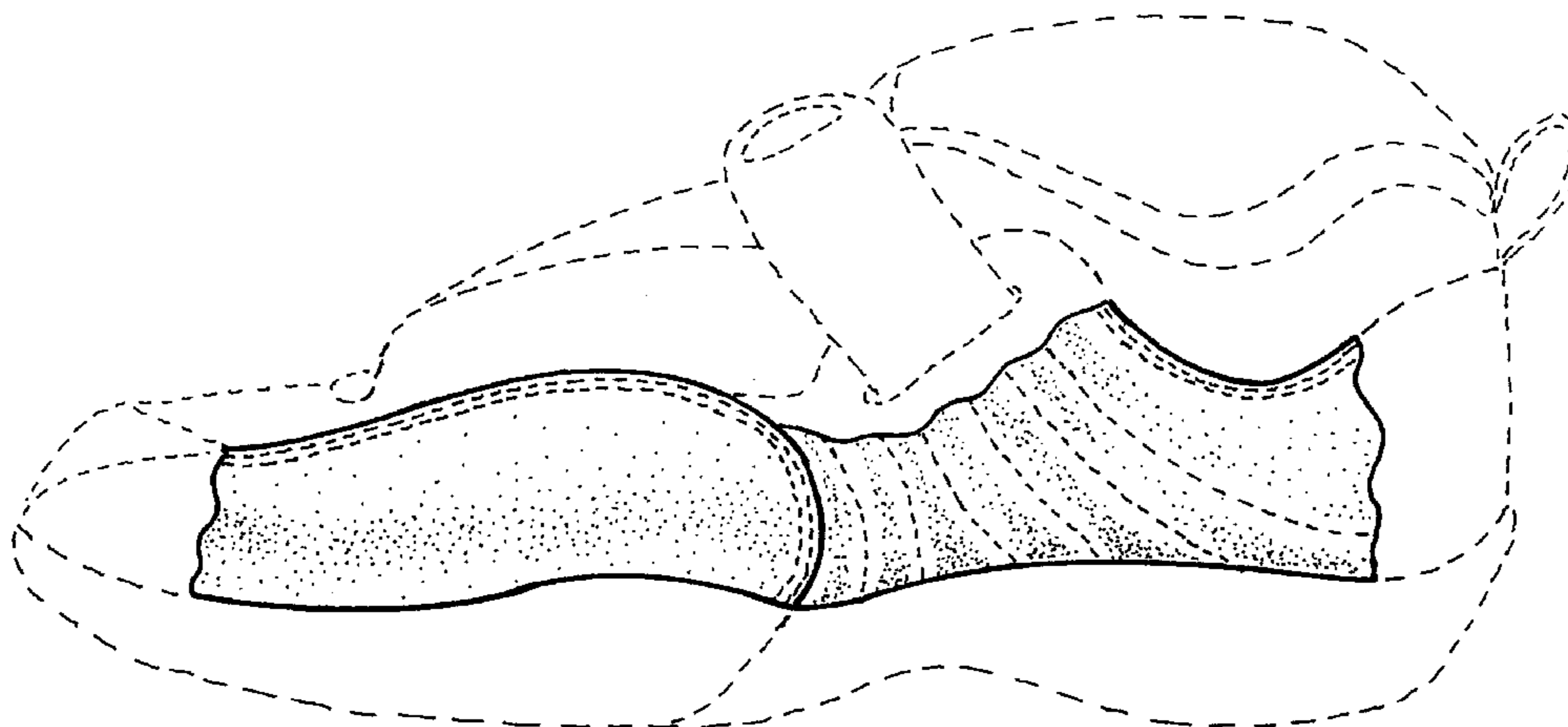
FIG. 3 is a rear elevational view thereof;

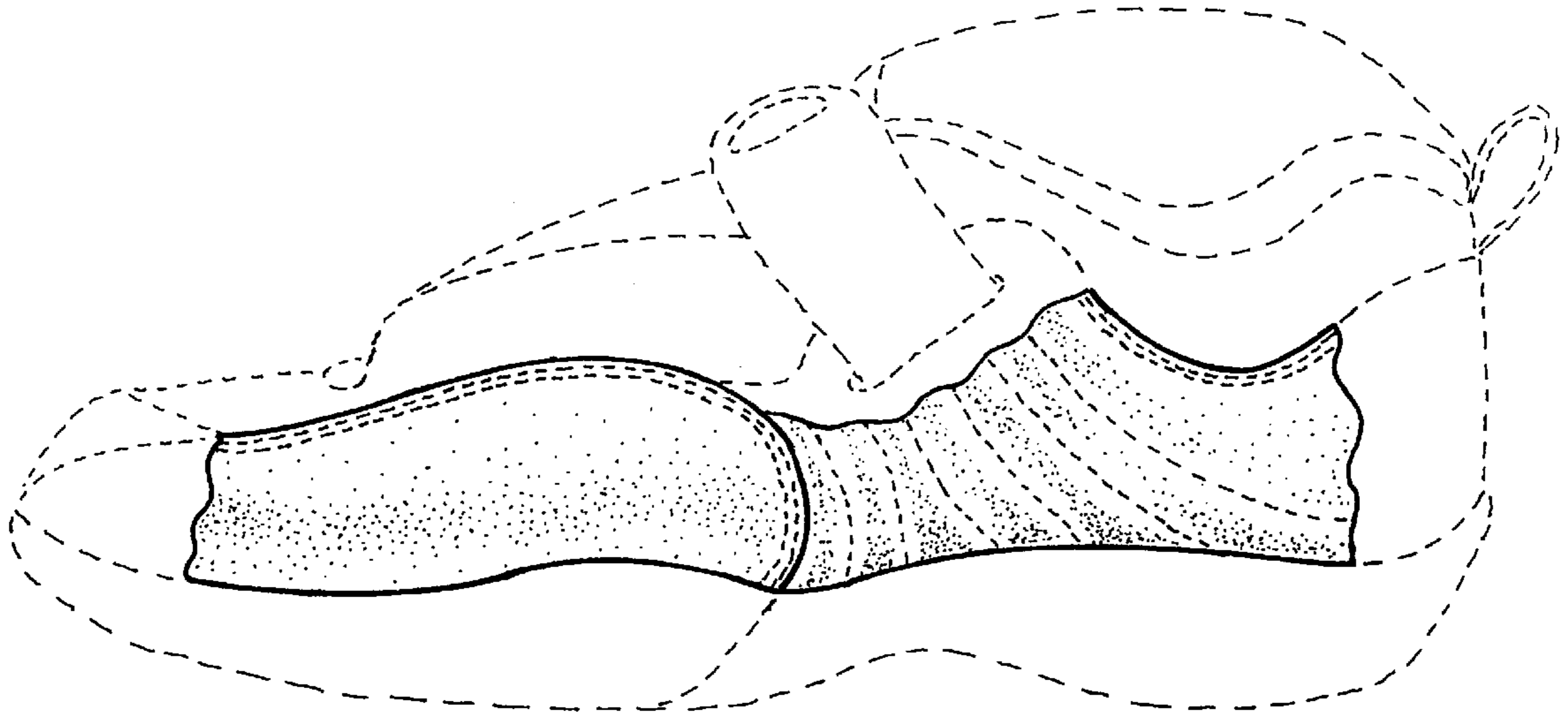

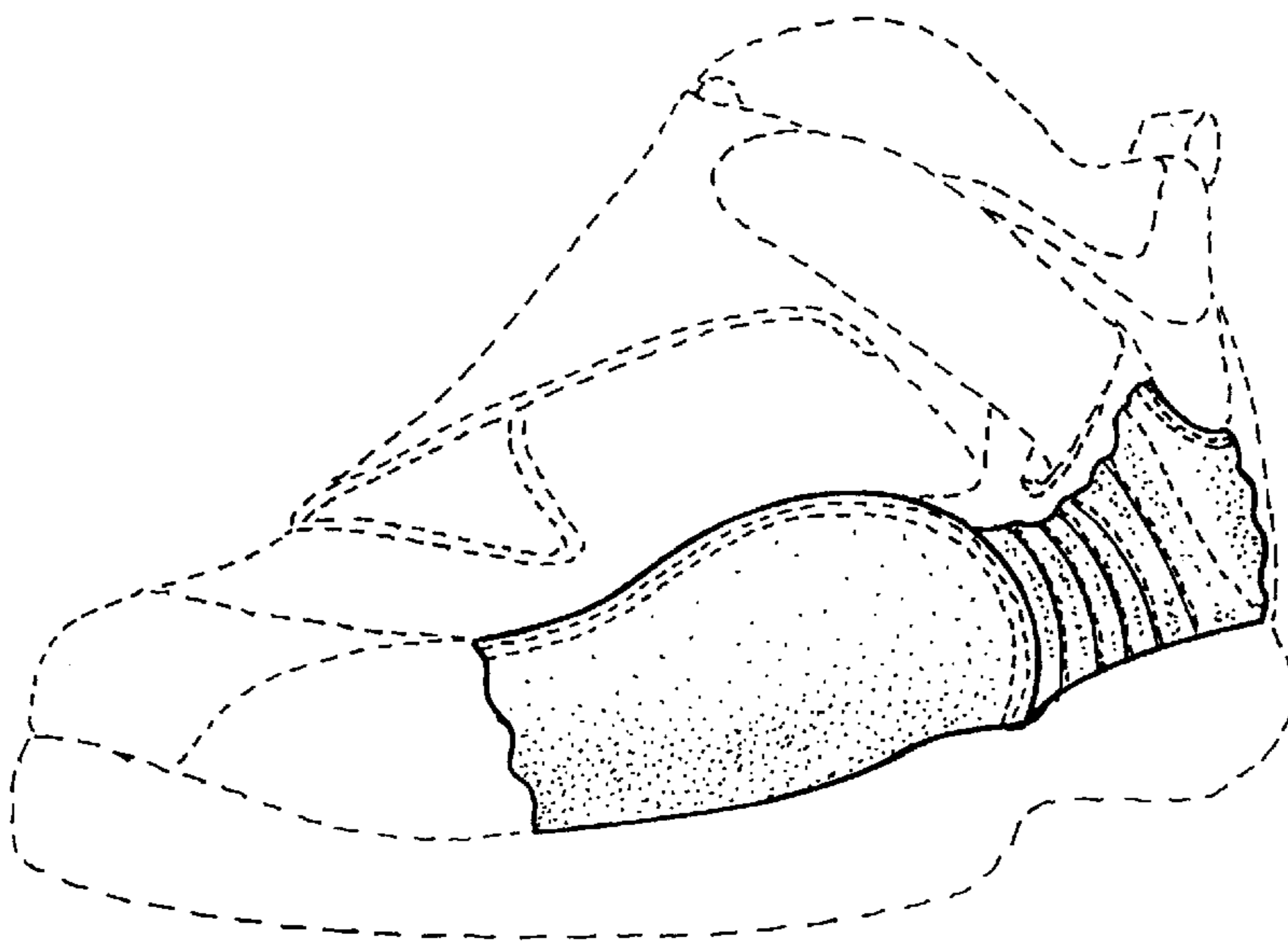

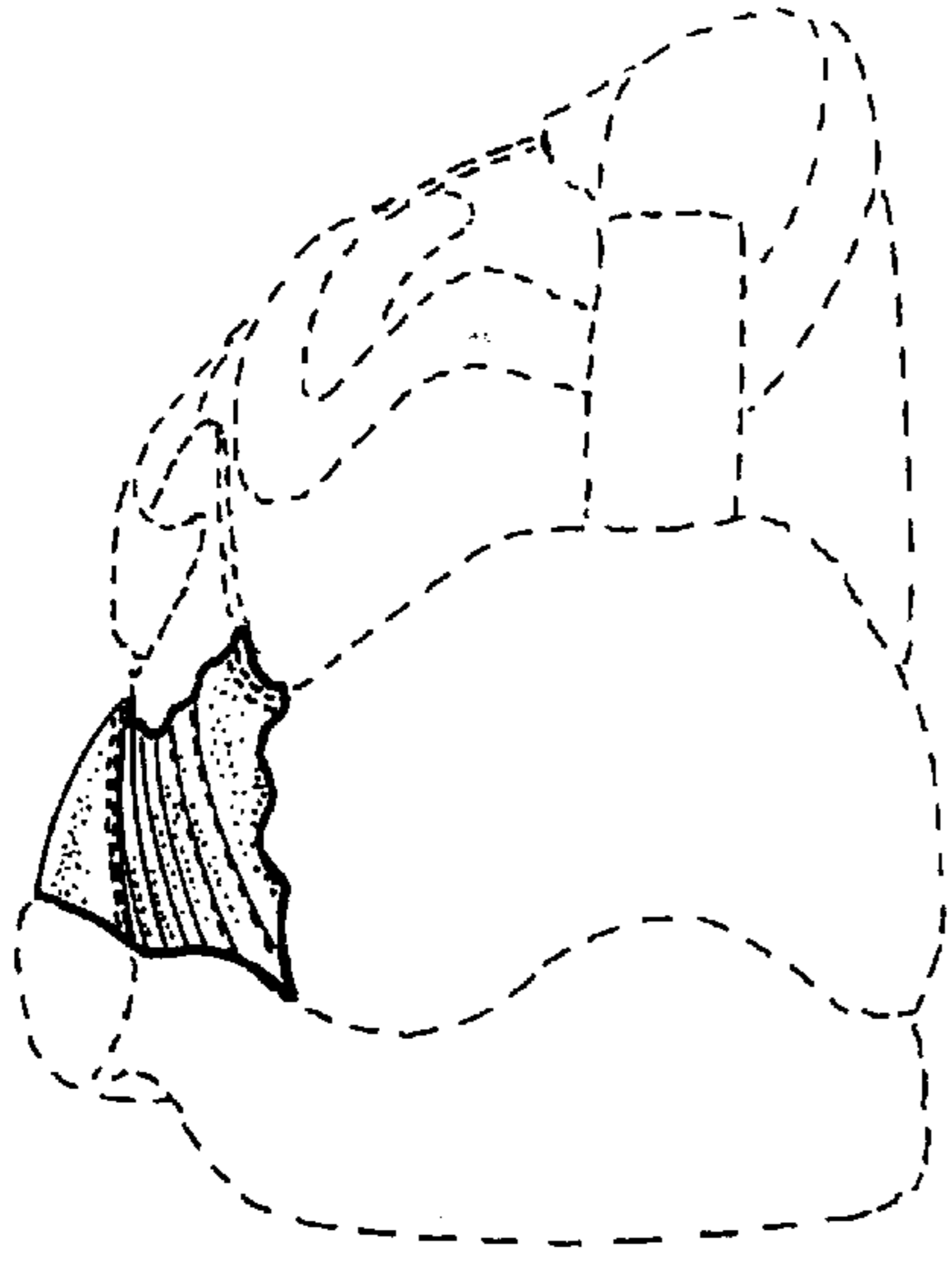

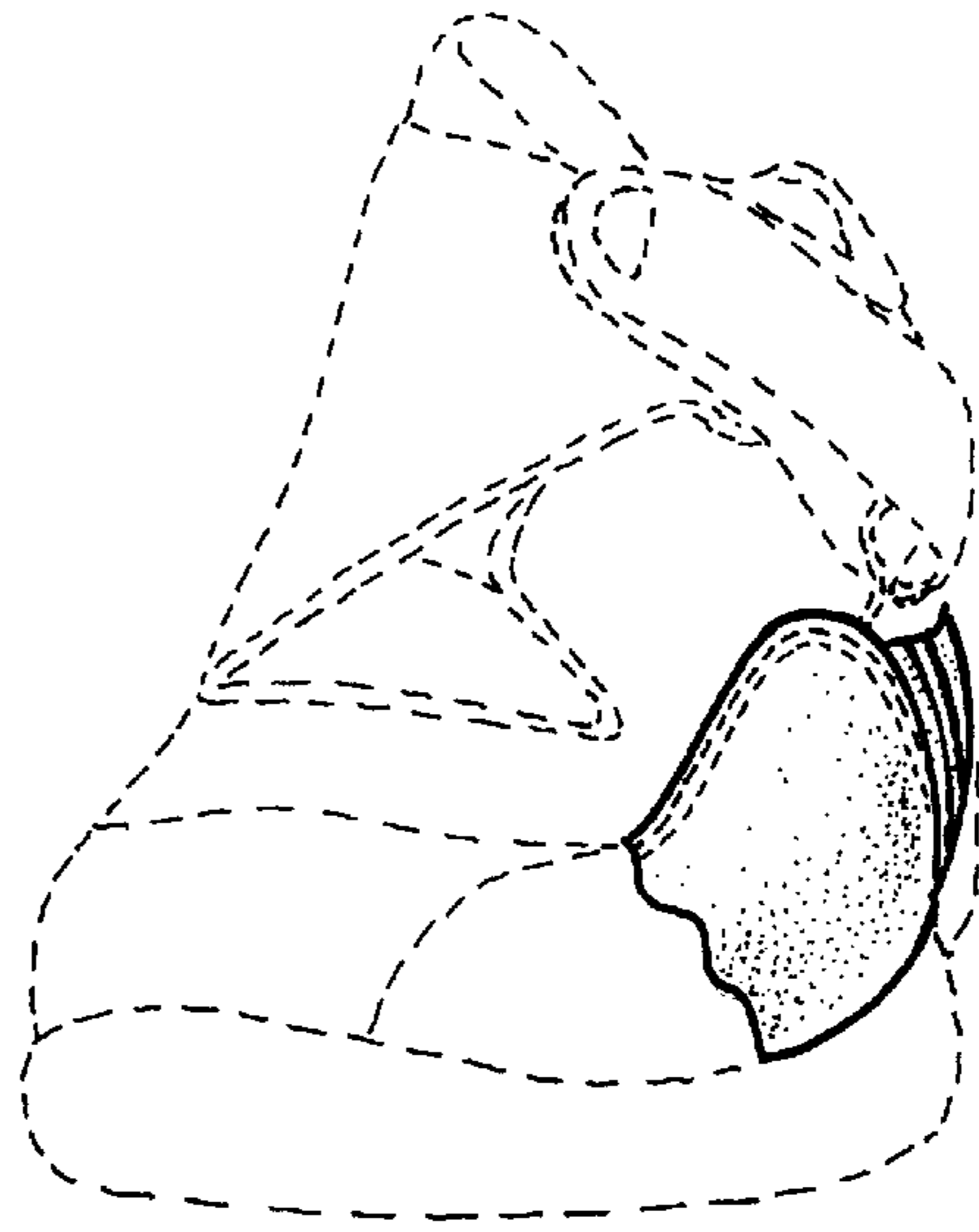

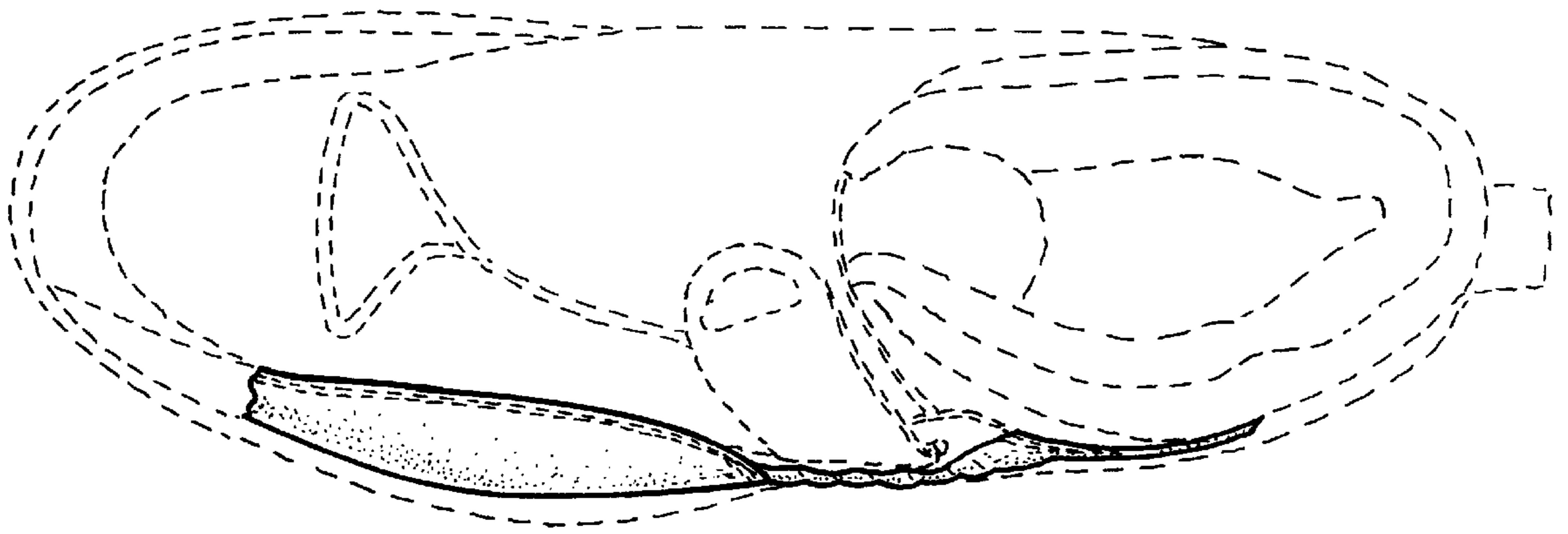
