The ornamental design for a front section of a portable radio communication device, as shown and described.

DESCRIPTION

FIG. 1 is a right, front, bottom perspective view of a front section of a portable radio communication device showing our new design;

FIG. 2 is a front view thereof;

FIG. 3 is a left elevational view thereof;

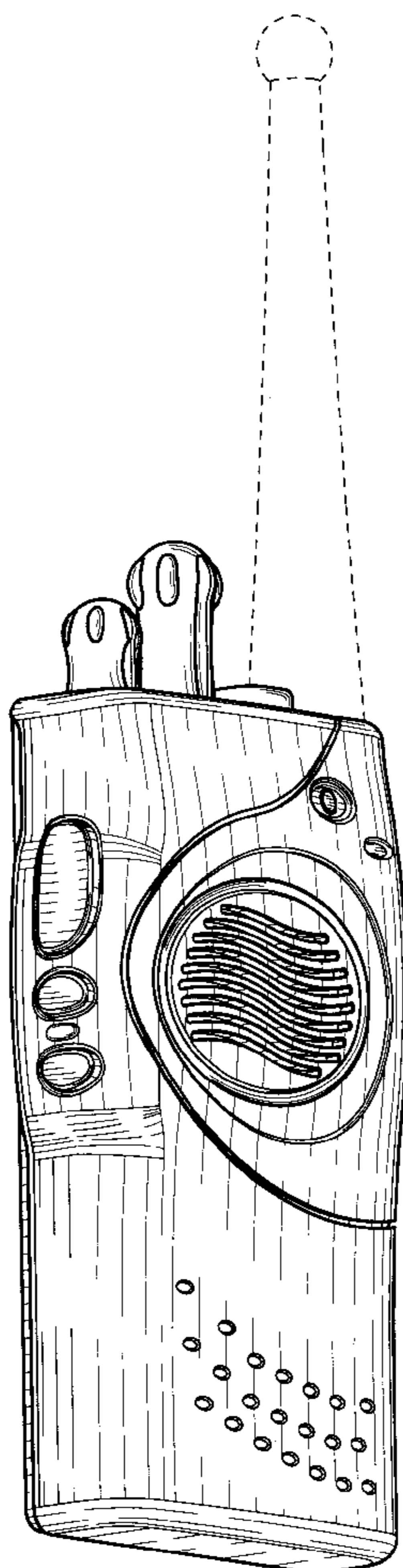
FIG. 4 is a right elevational view thereof;

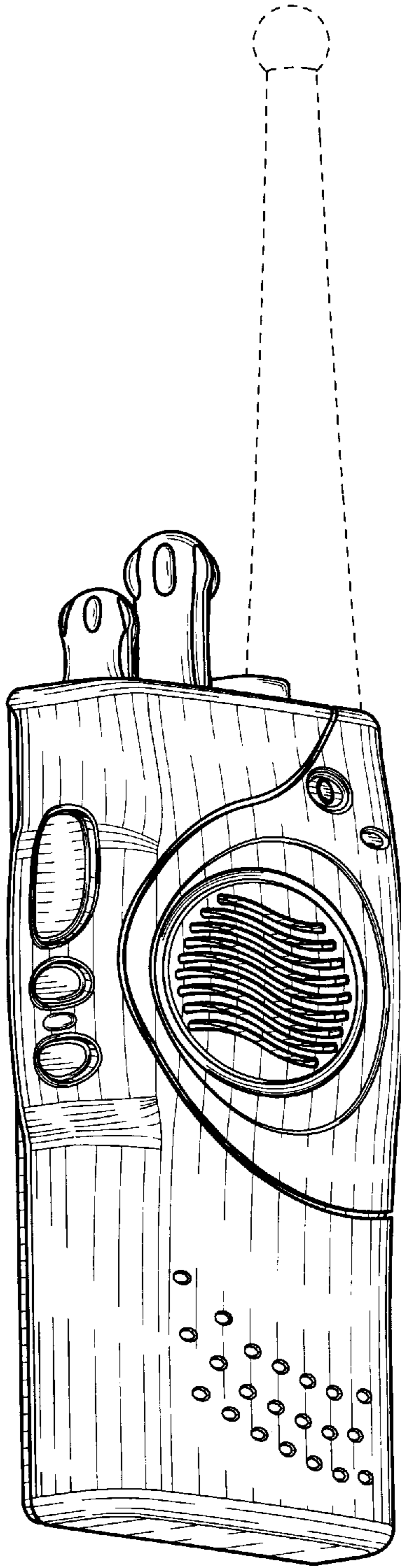

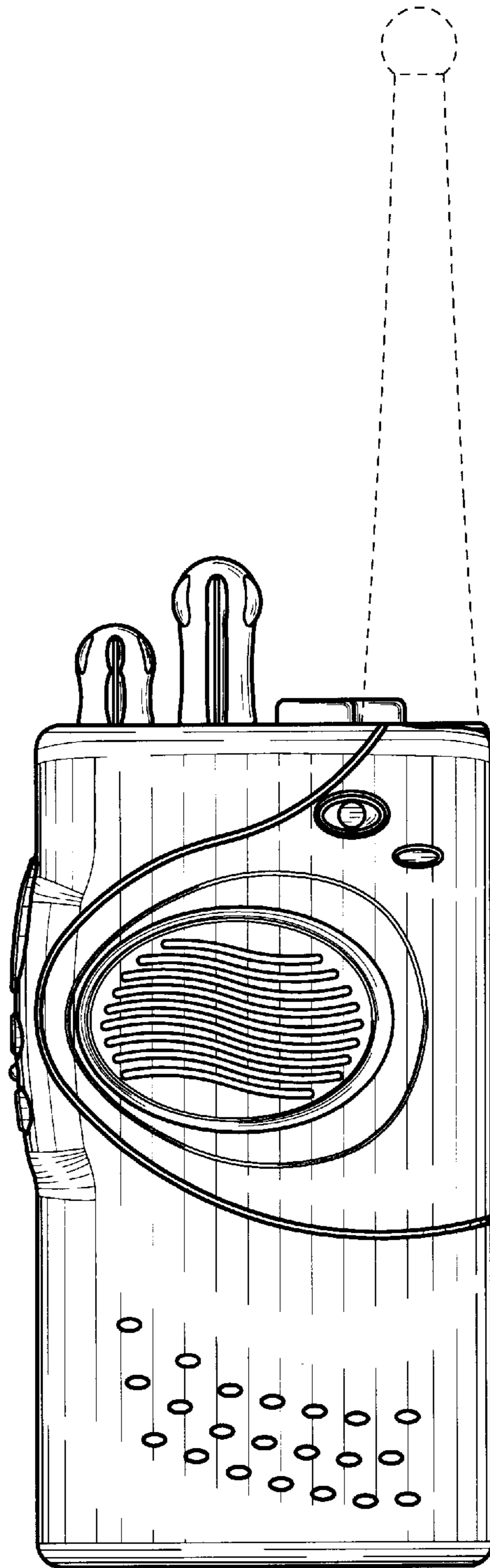

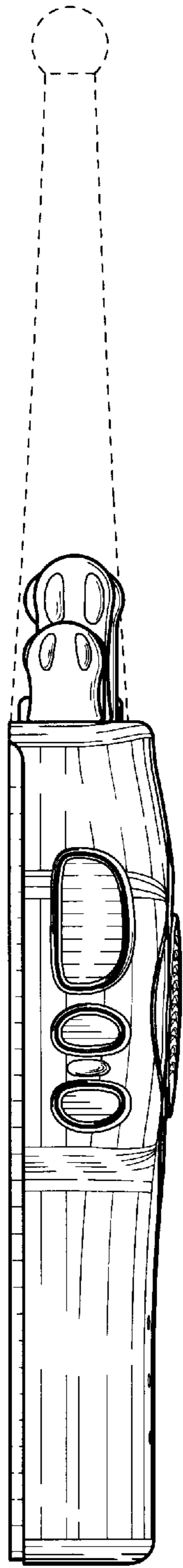

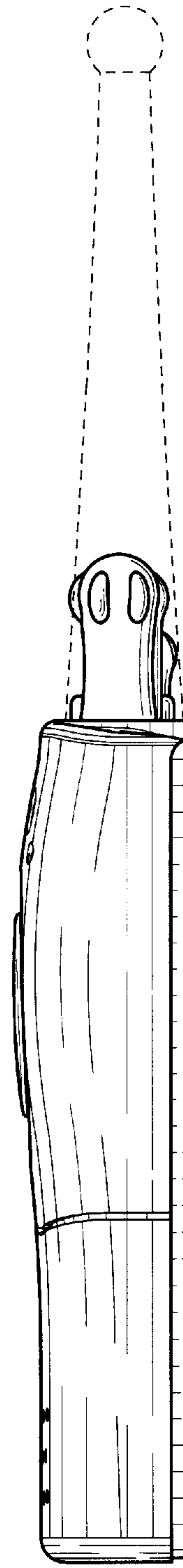

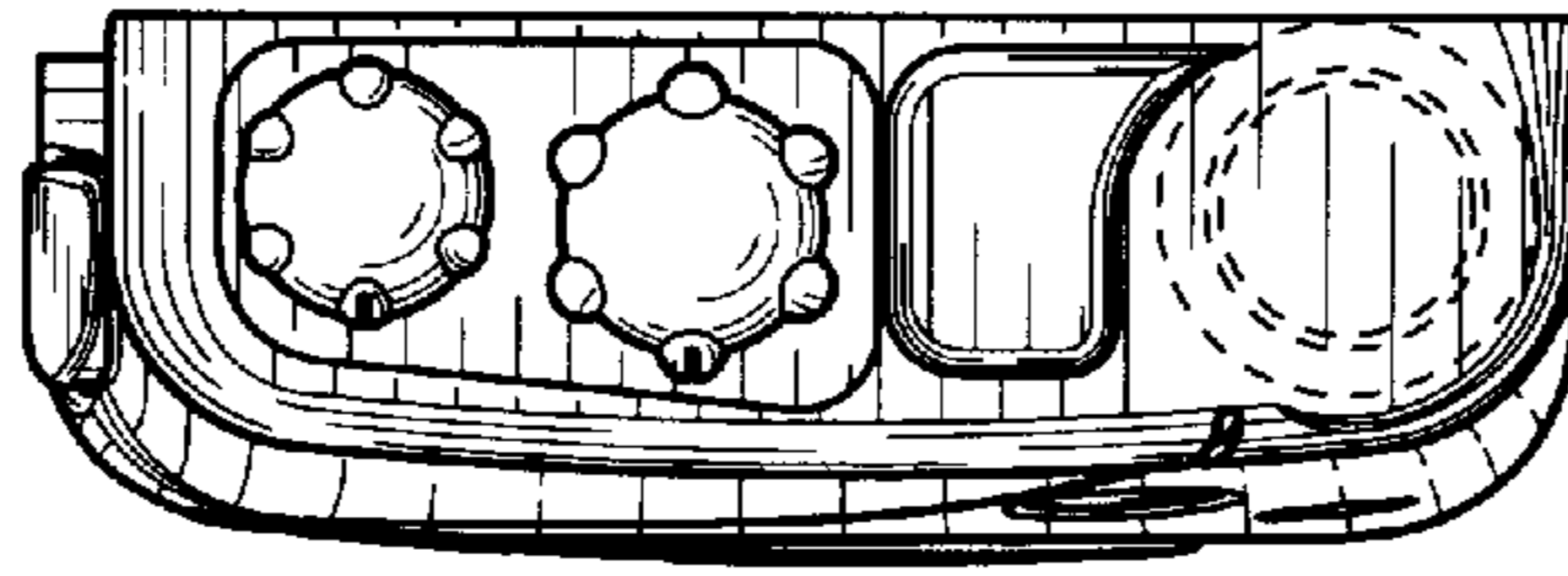

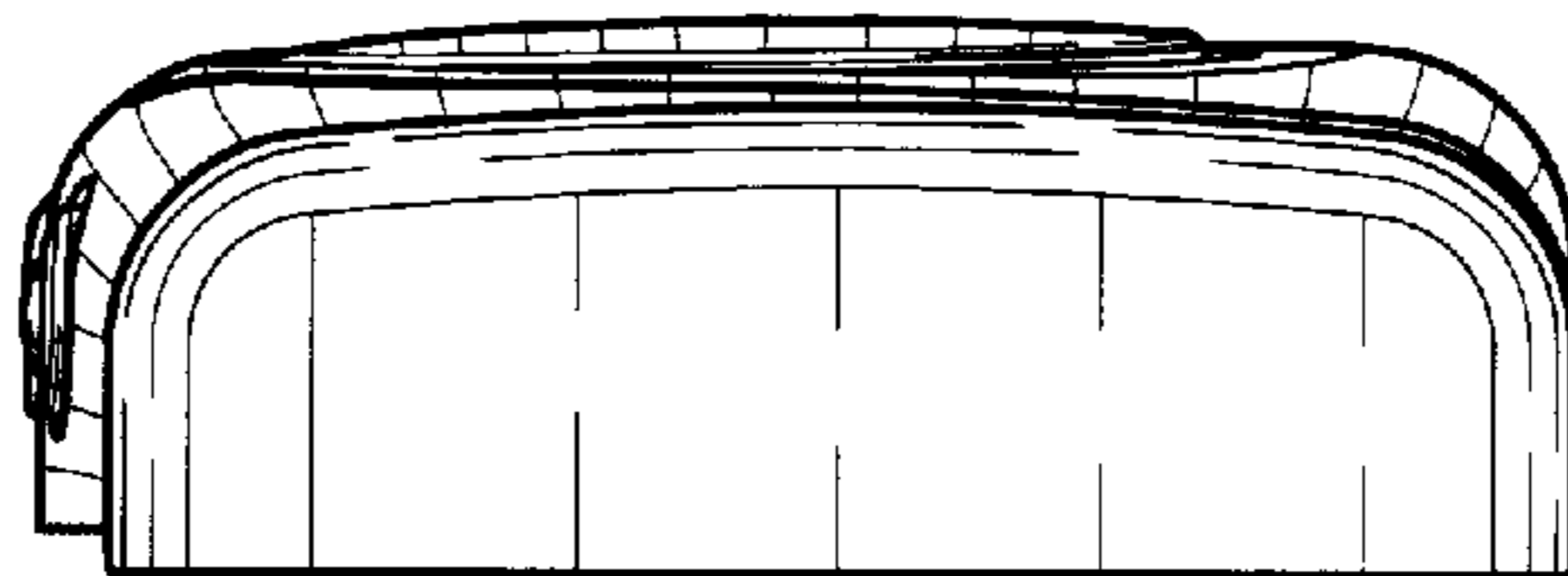
