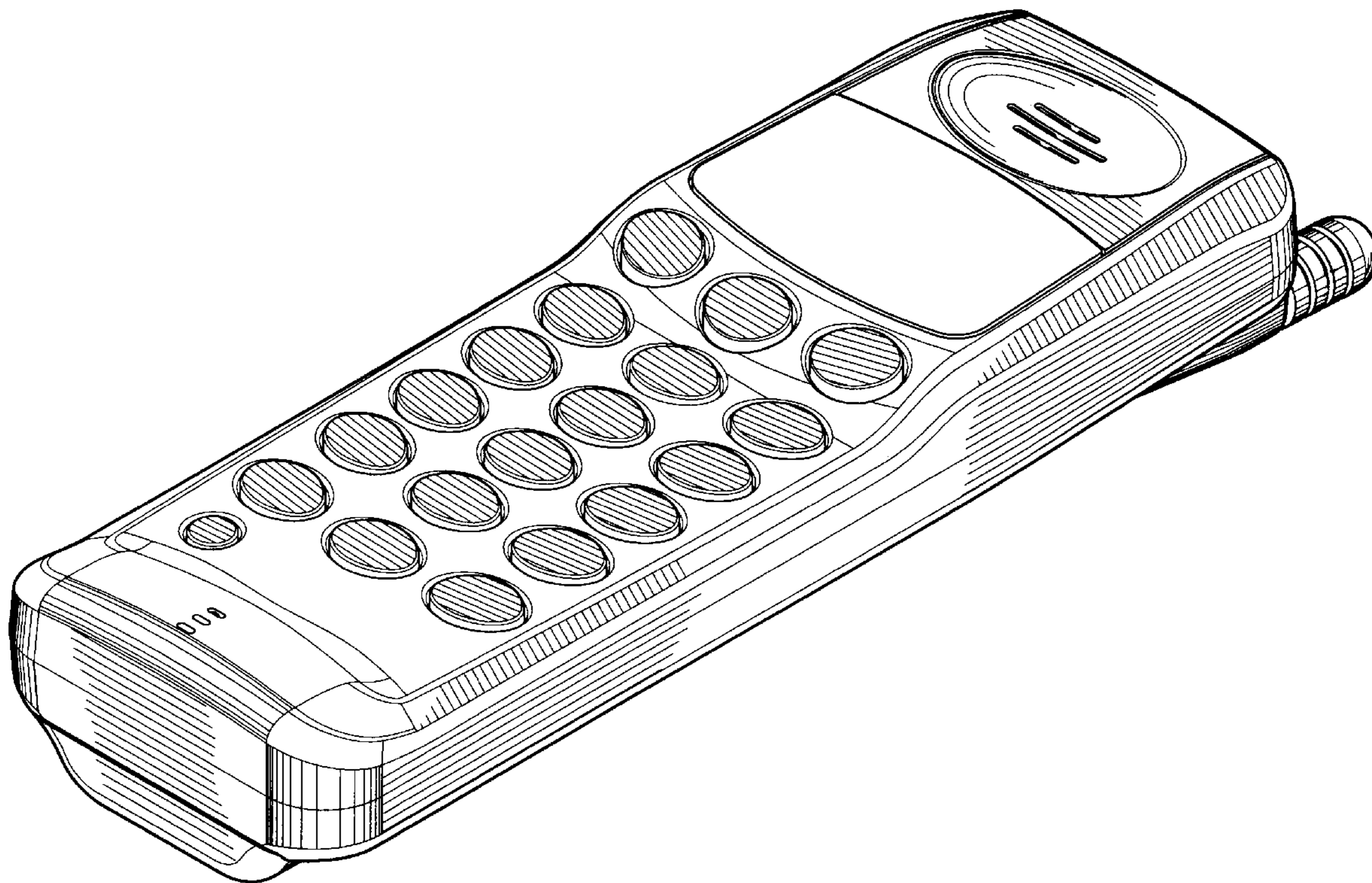

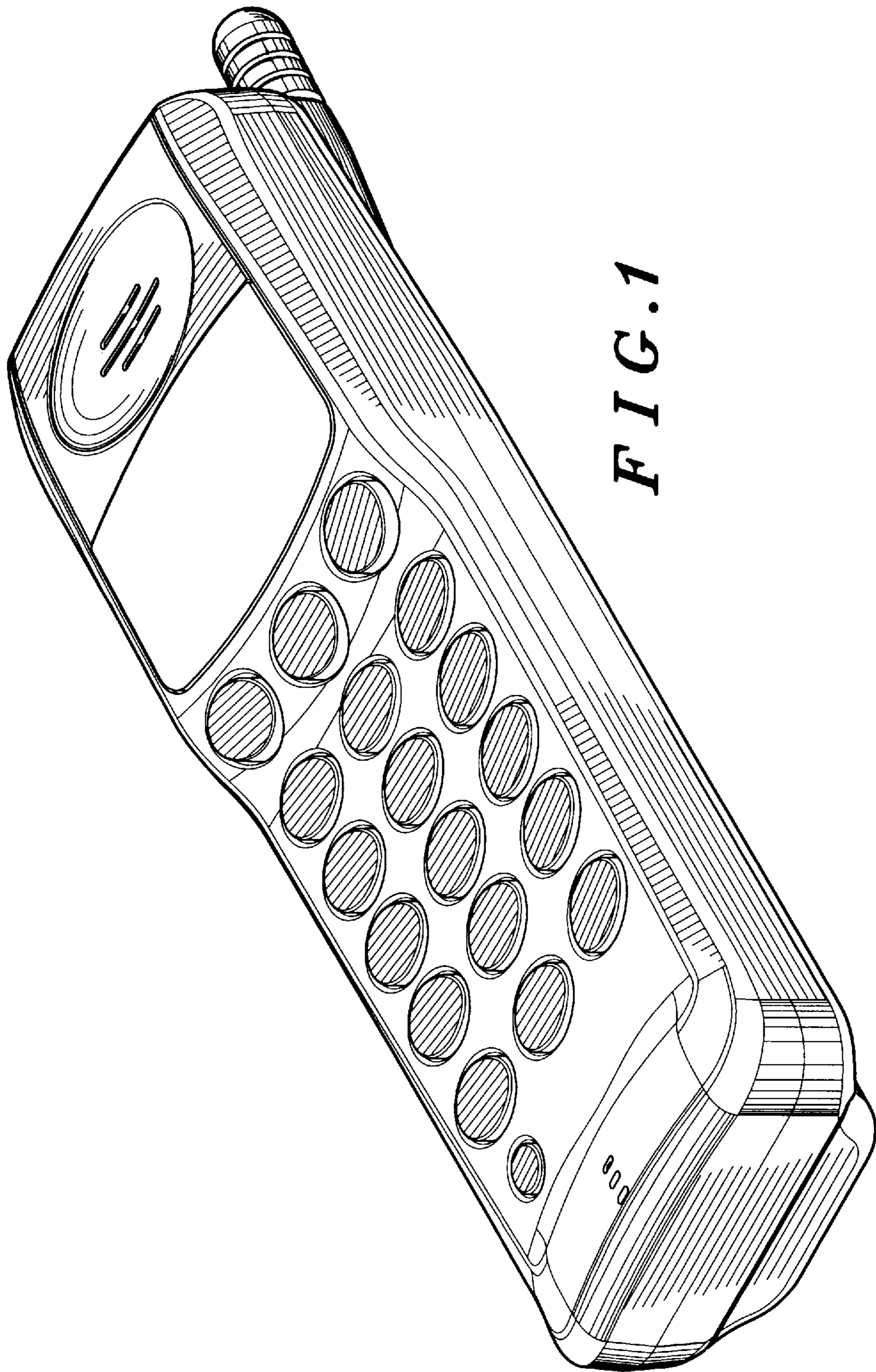
The ornamental design for the radiotelephone housing, as shown and described.

DESCRIPTION

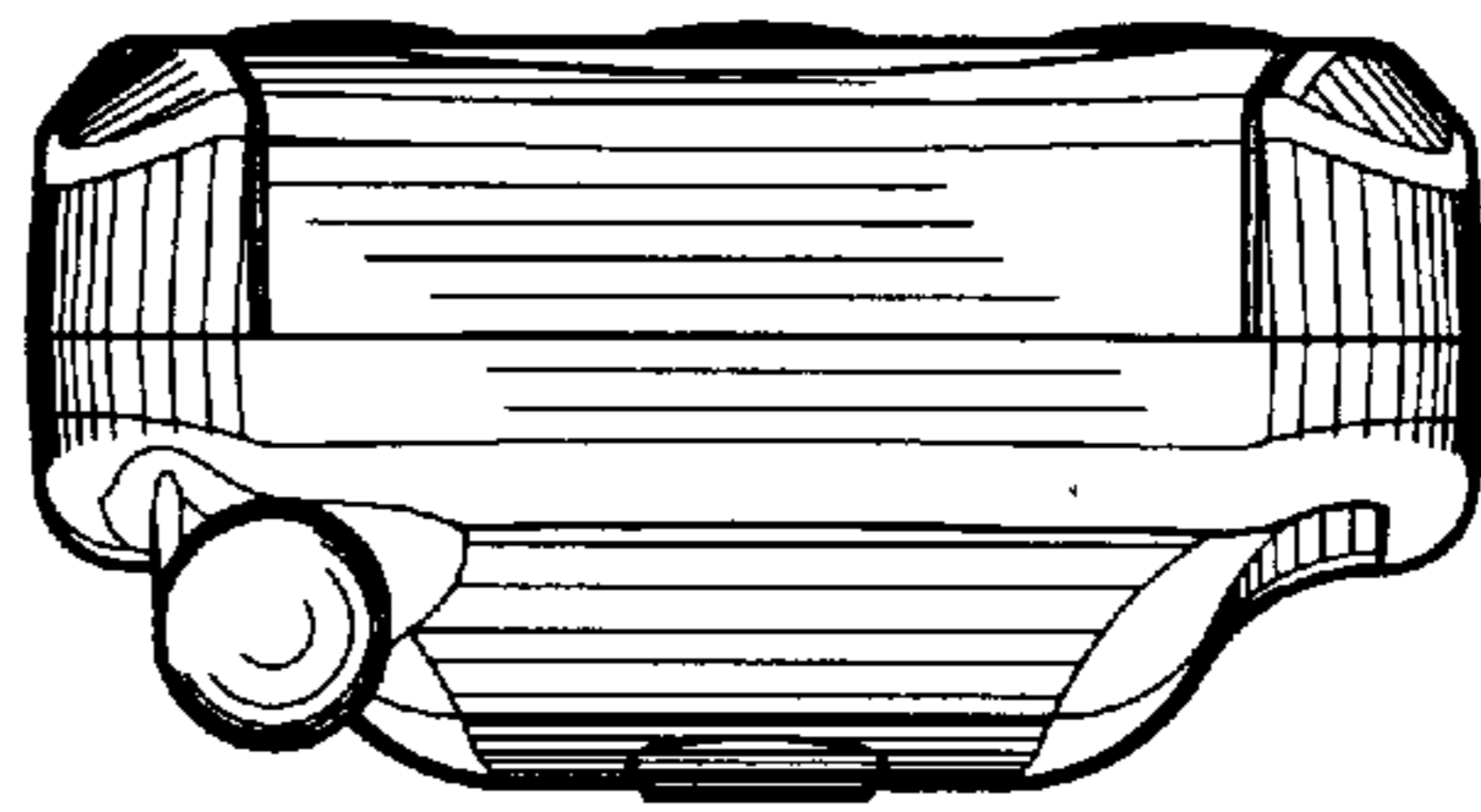

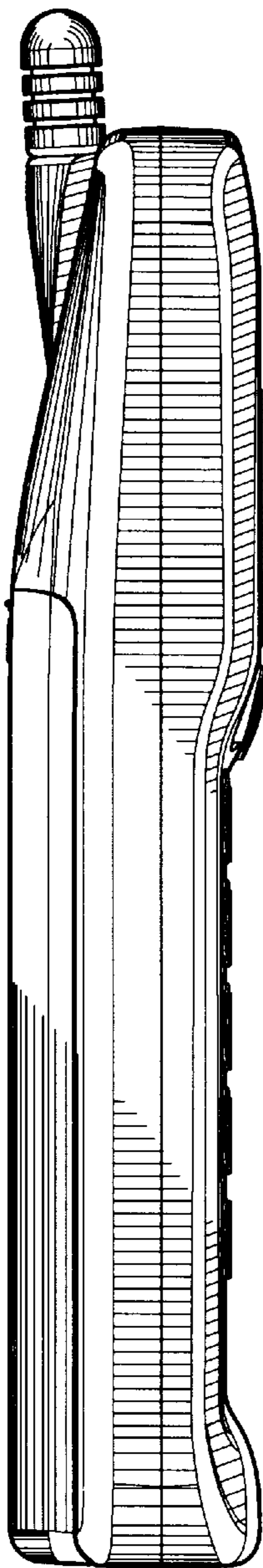

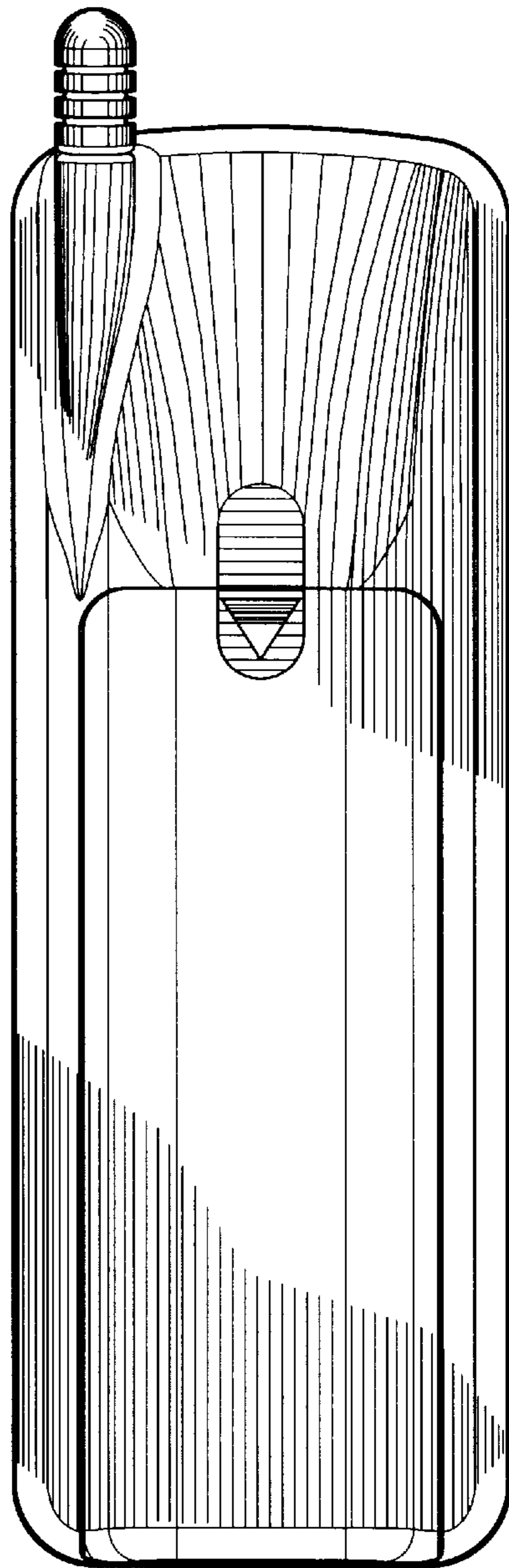
