[57] **CLAIM**

The ornamental design for a lavatory, as shown and described.

**DESCRIPTION**

FIG. 1 is a left, top perspective view of a lavatory embodying our new design;

FIG. 2 is a left, top, front perspective view thereof;

FIG. 3 is a top plan view thereof;

FIG. 4 is a bottom plan view thereof;

FIG. 5 is a front elevational view thereof;

FIG. 6 is a rear elevational view thereof;

FIG. 7 is a right side elevational view thereof, the left side elevational view being a mirror image of the right side shown;

FIG. 8 is a cross-sectional view taken along line 8-8 of FIG. 3;

FIG. 9 is a cross-sectional view taken along line 9-9 of FIG. 3; and,

FIG. 10 is a cross-sectional view taken along line 10-10 of FIG. 3.

The characteristic feature of our design resides in the internal sloped flange changing the verticality of its slope around the basin.

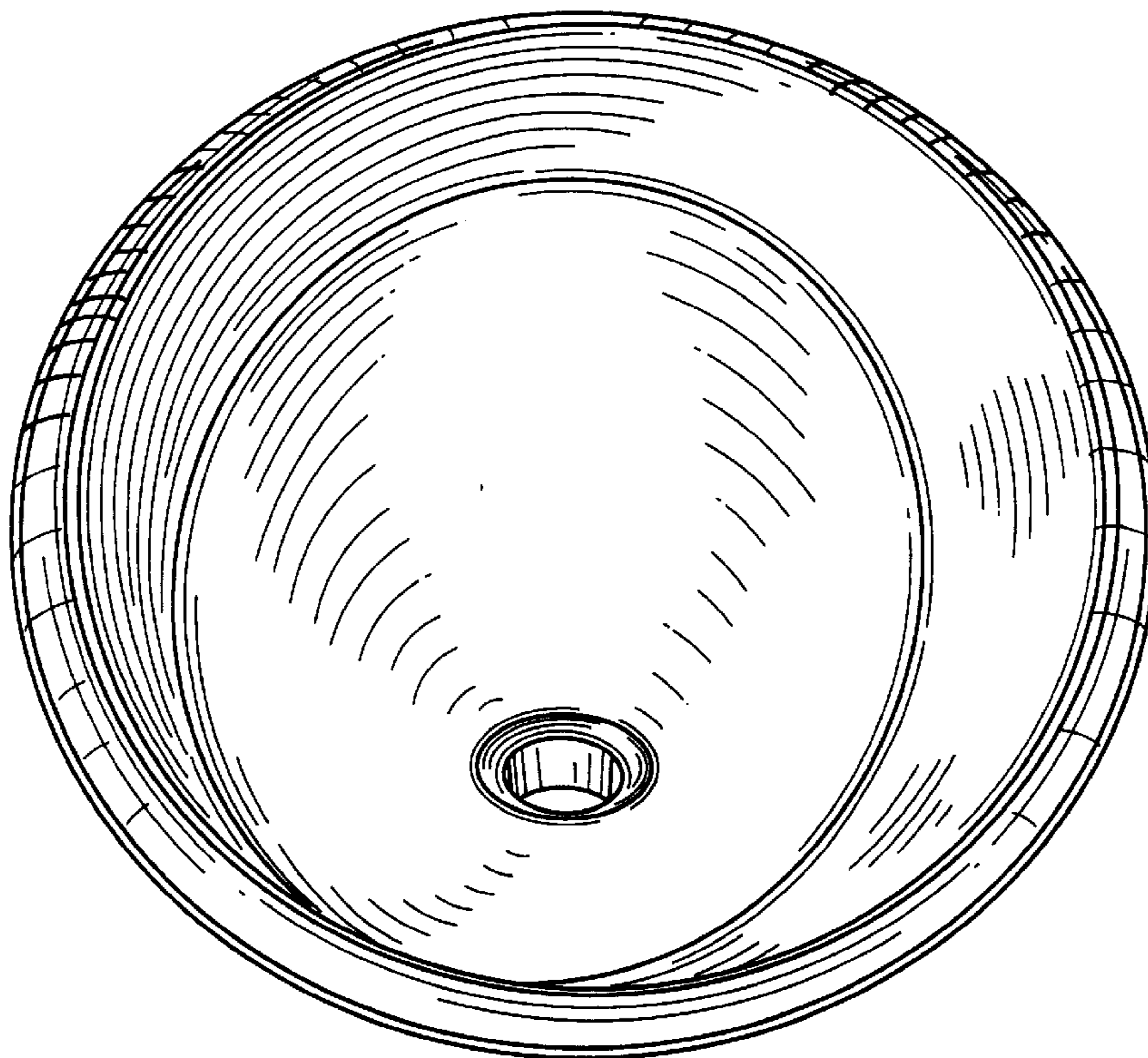

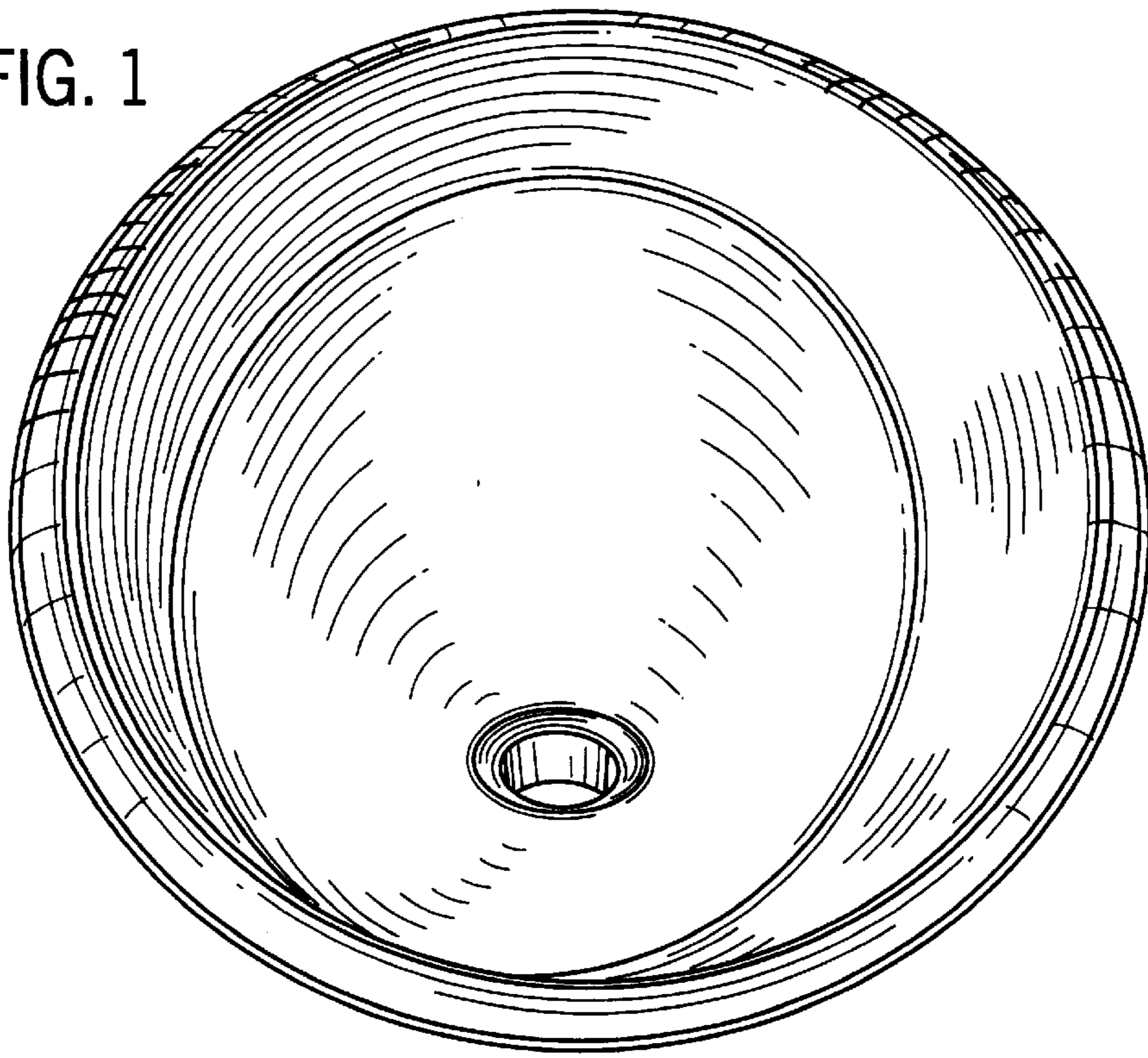

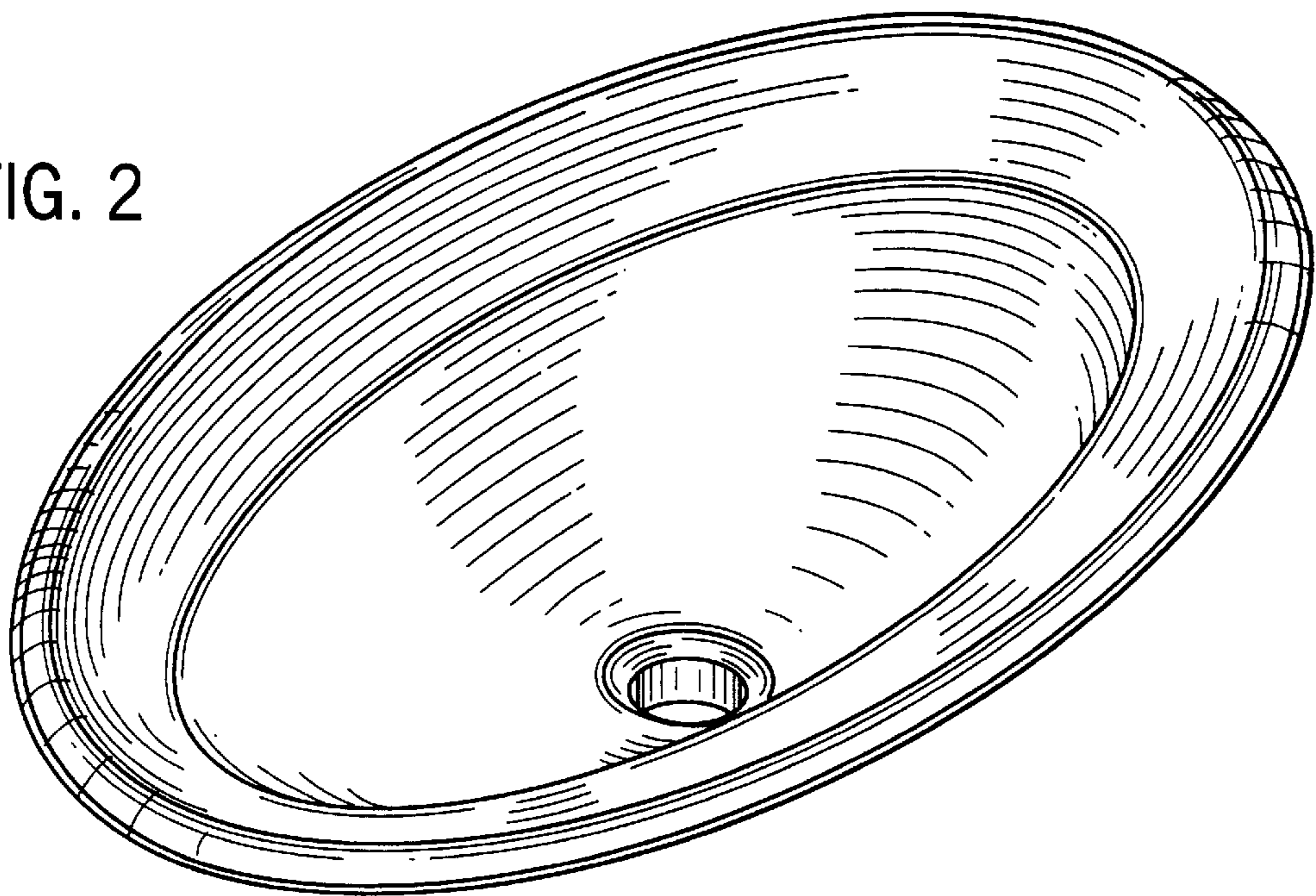

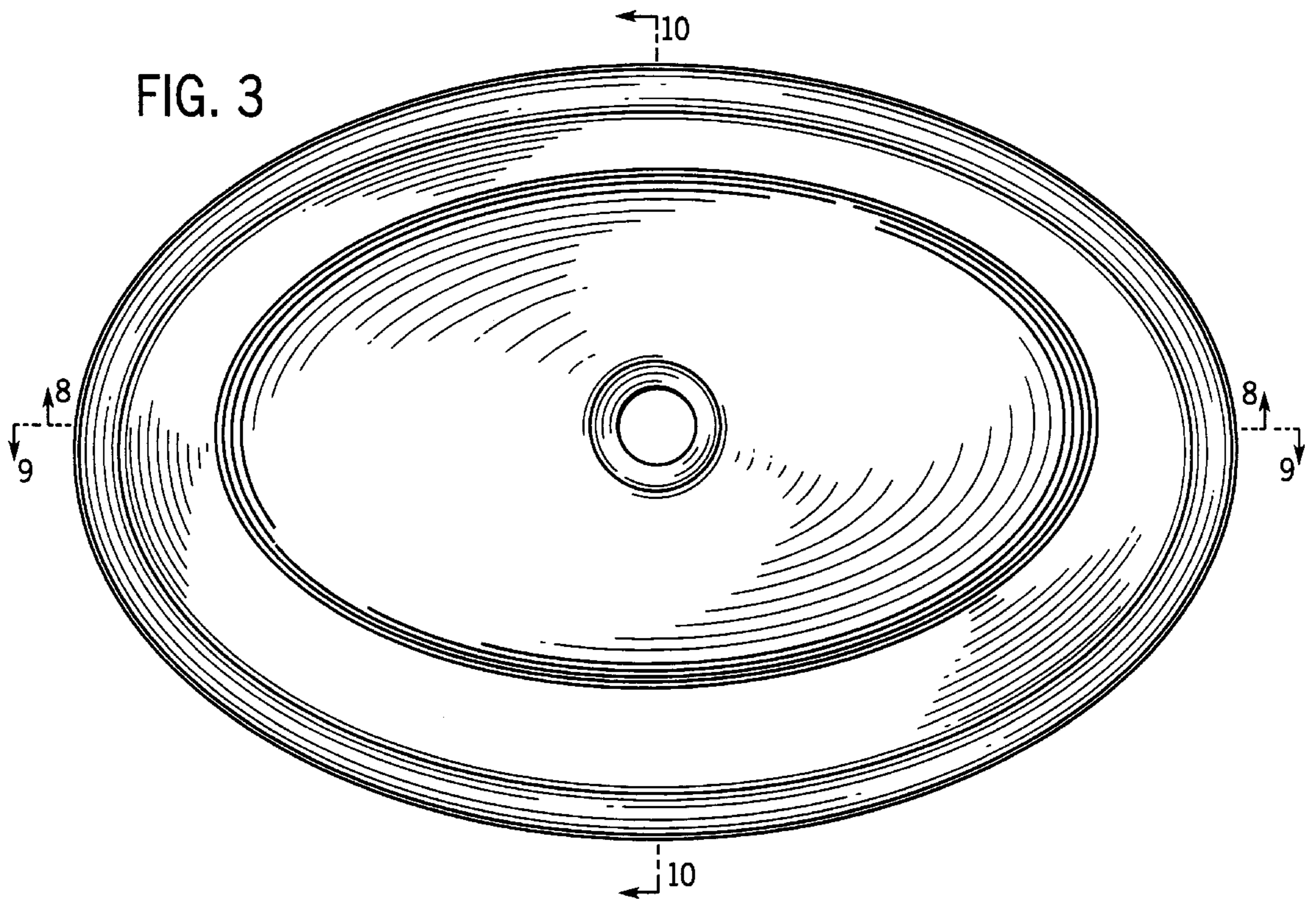

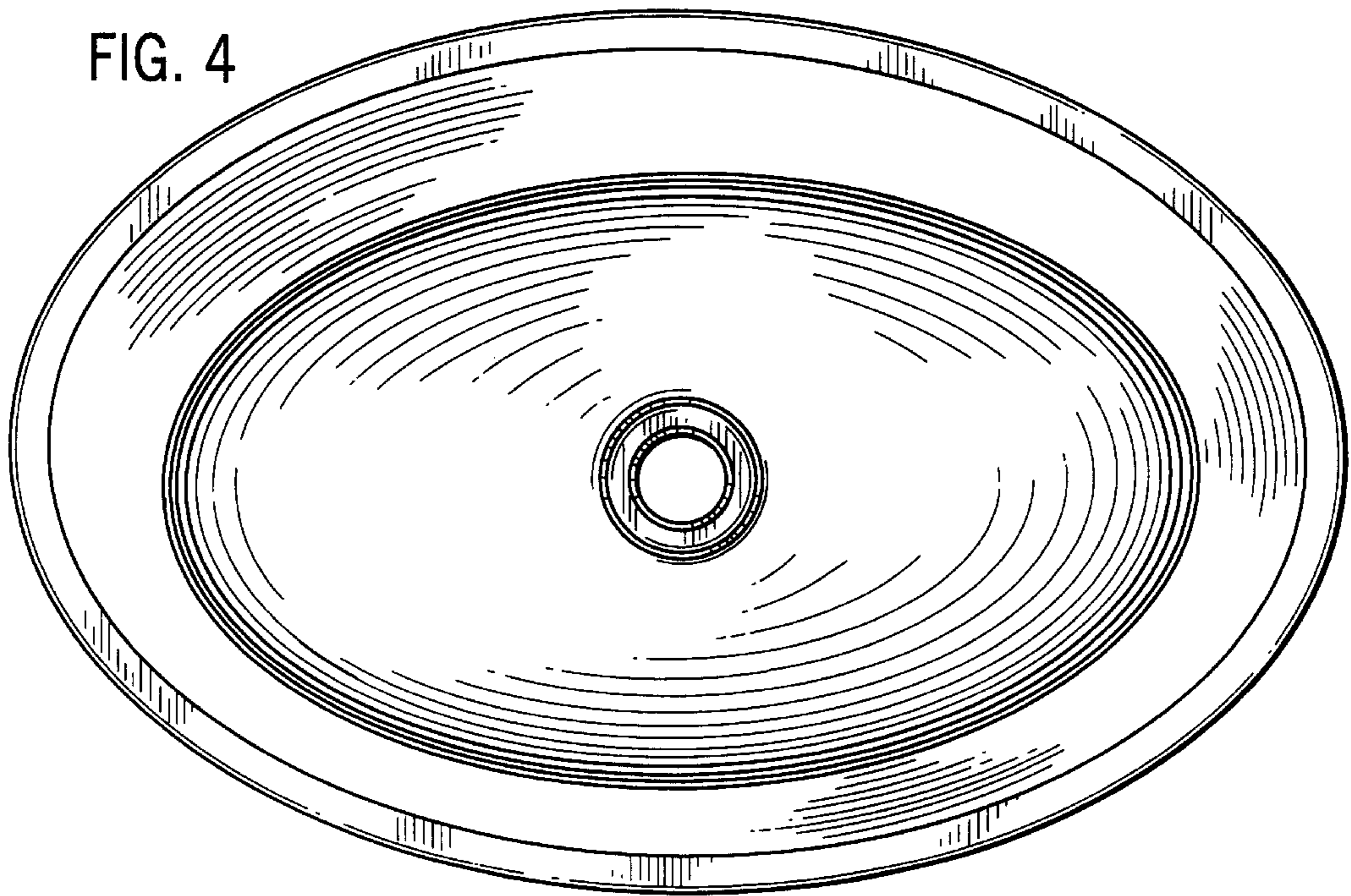

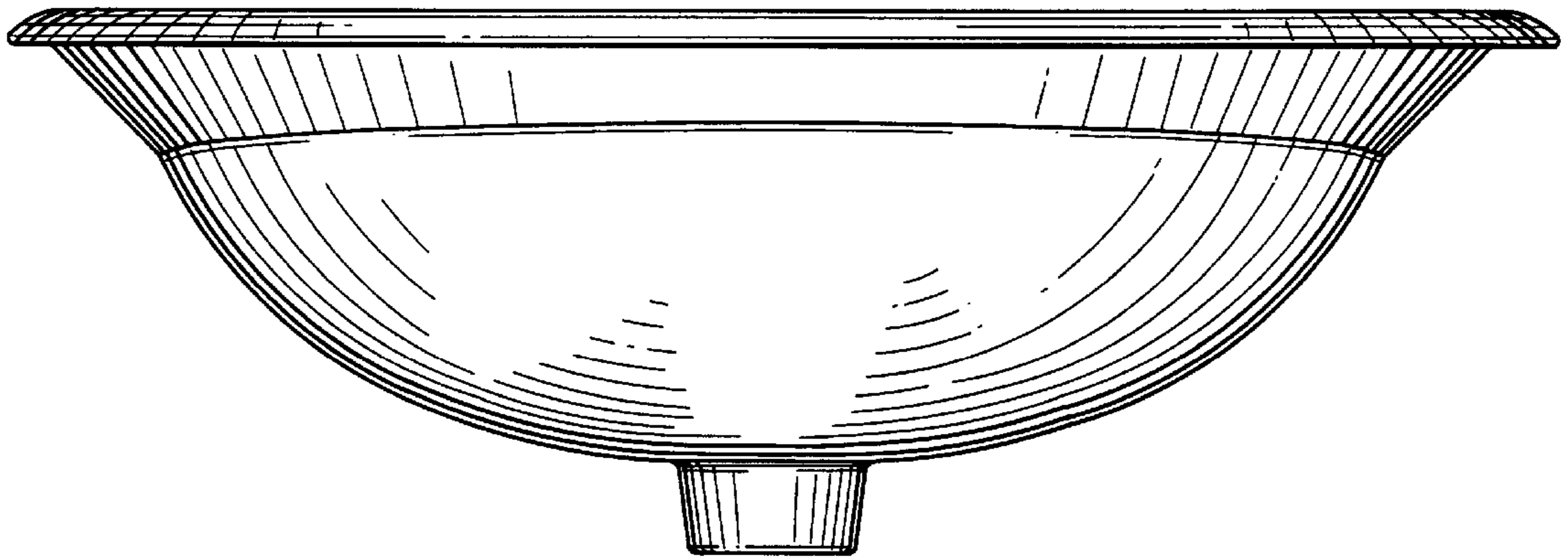

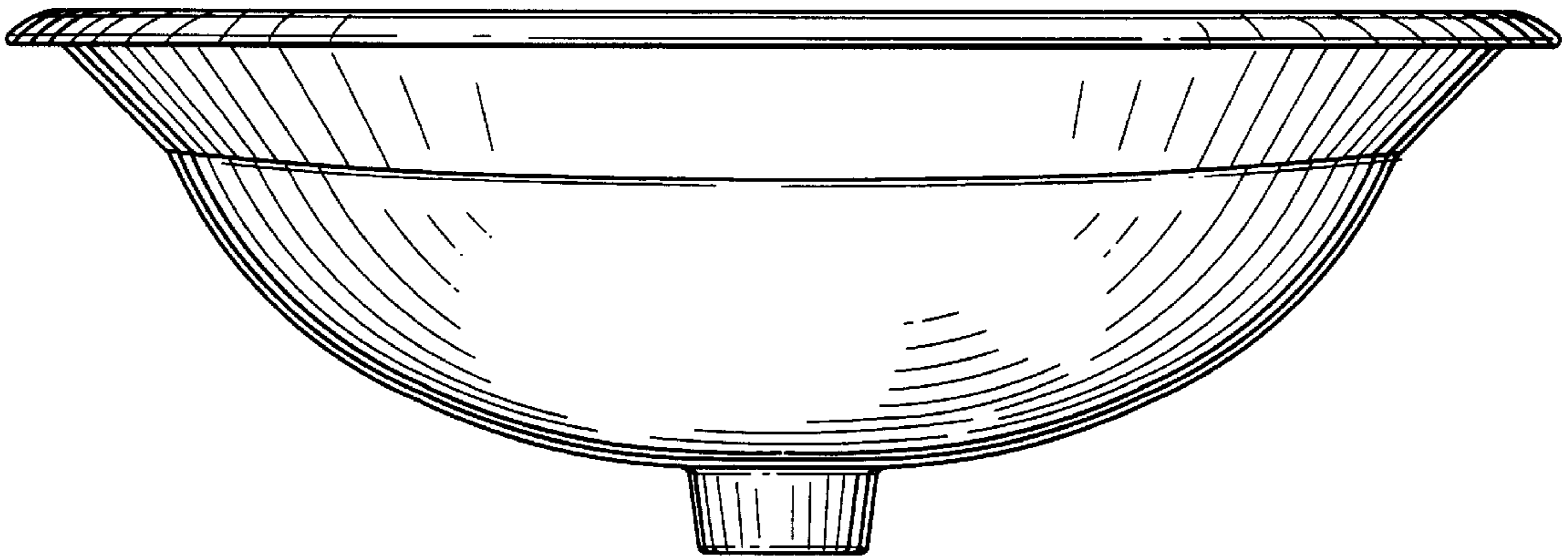

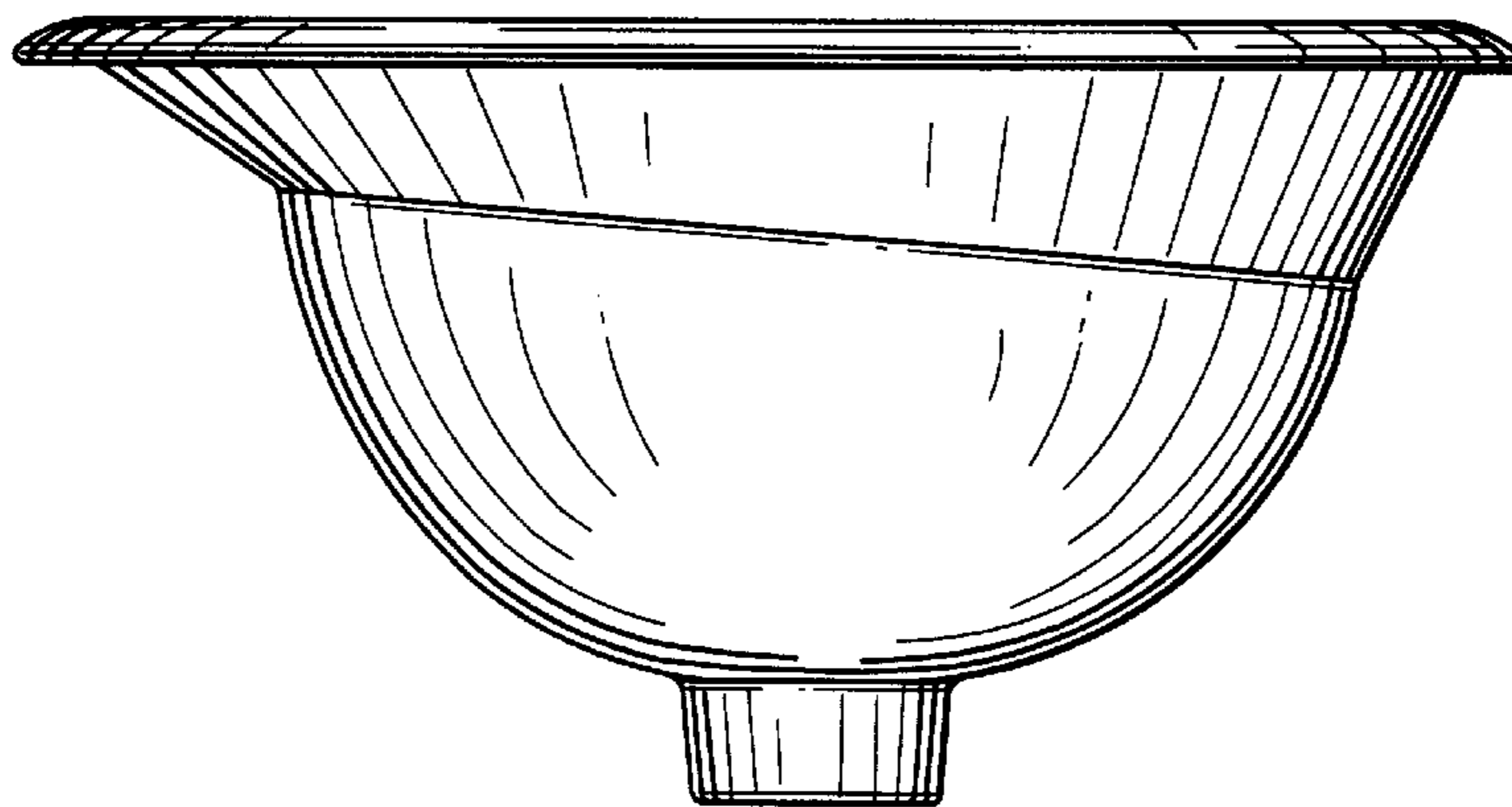

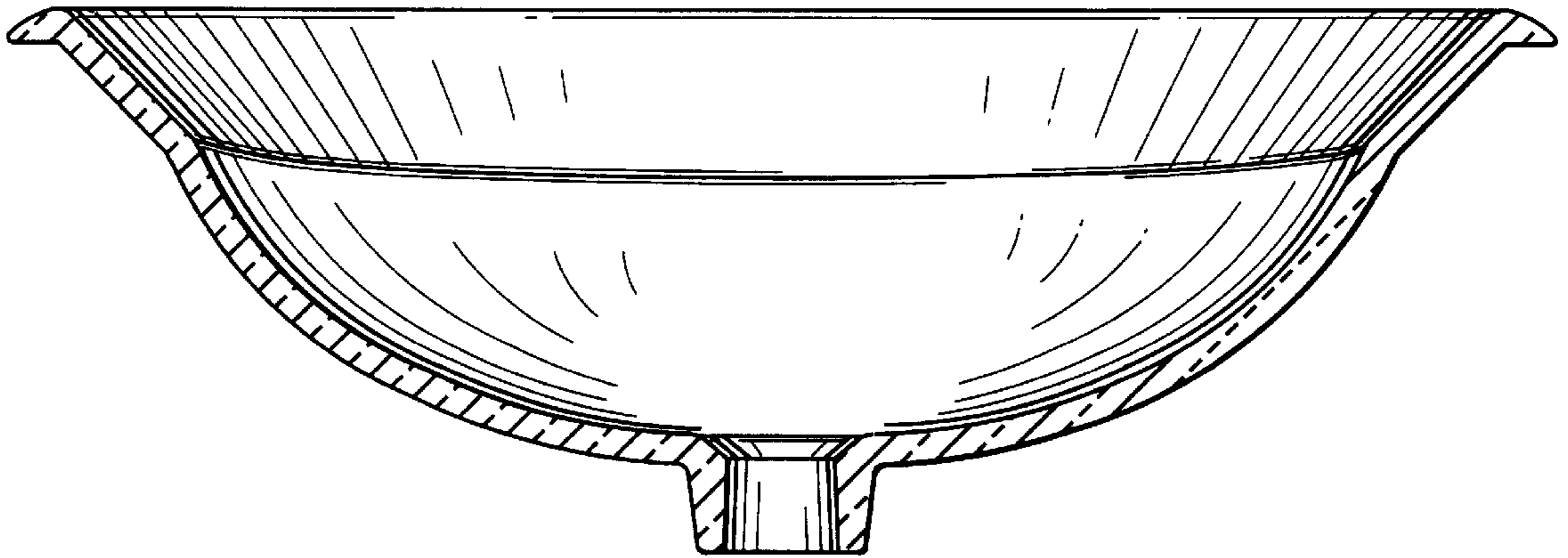

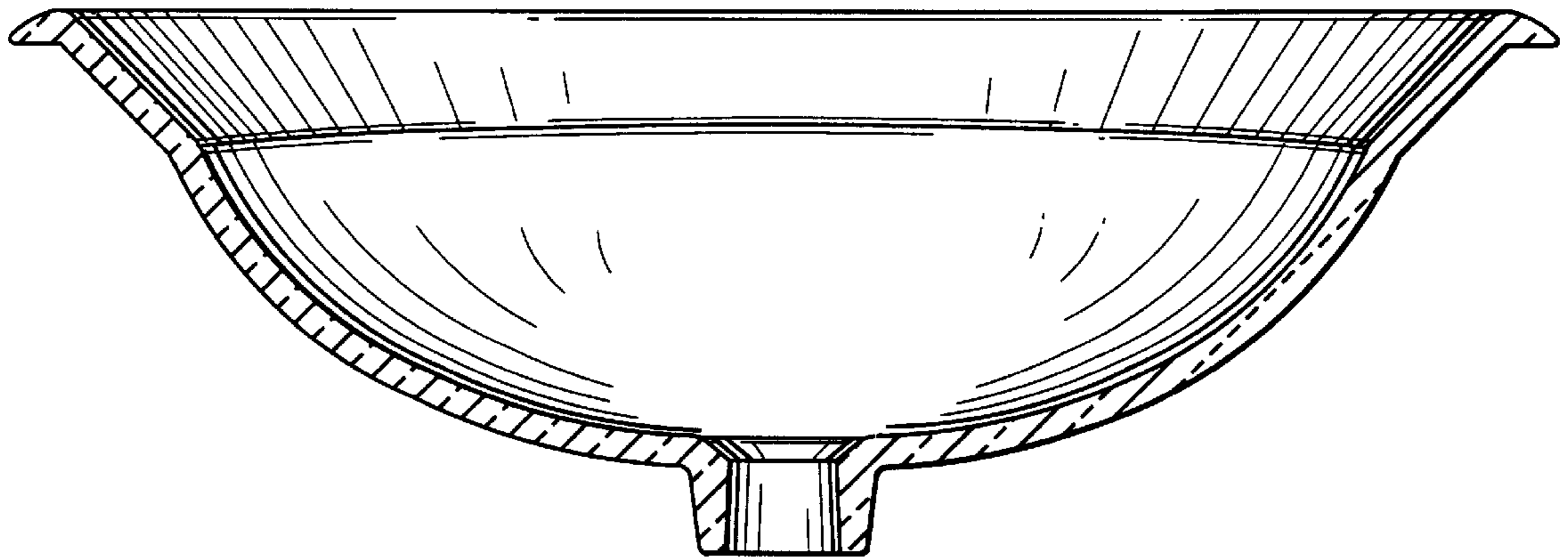
